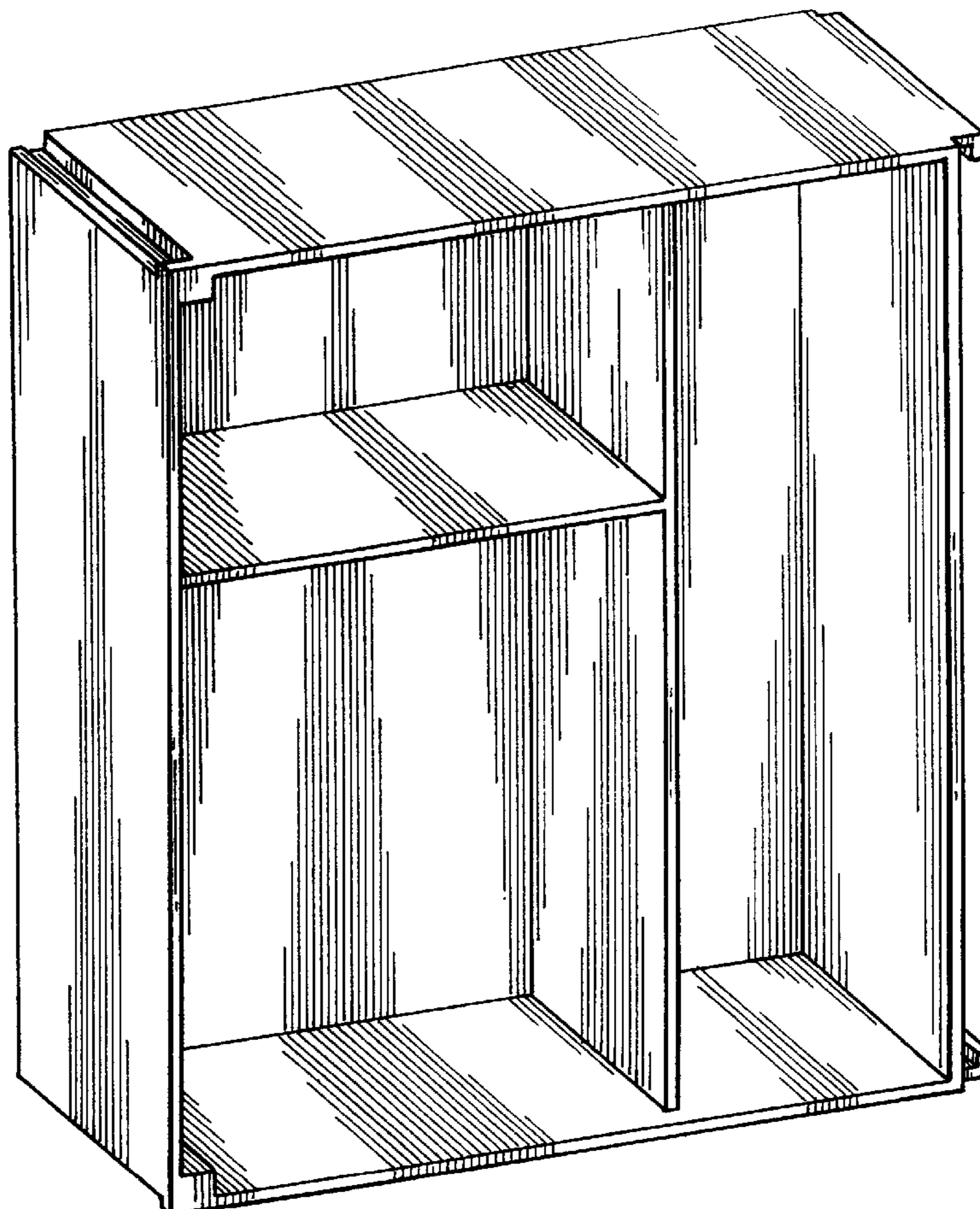

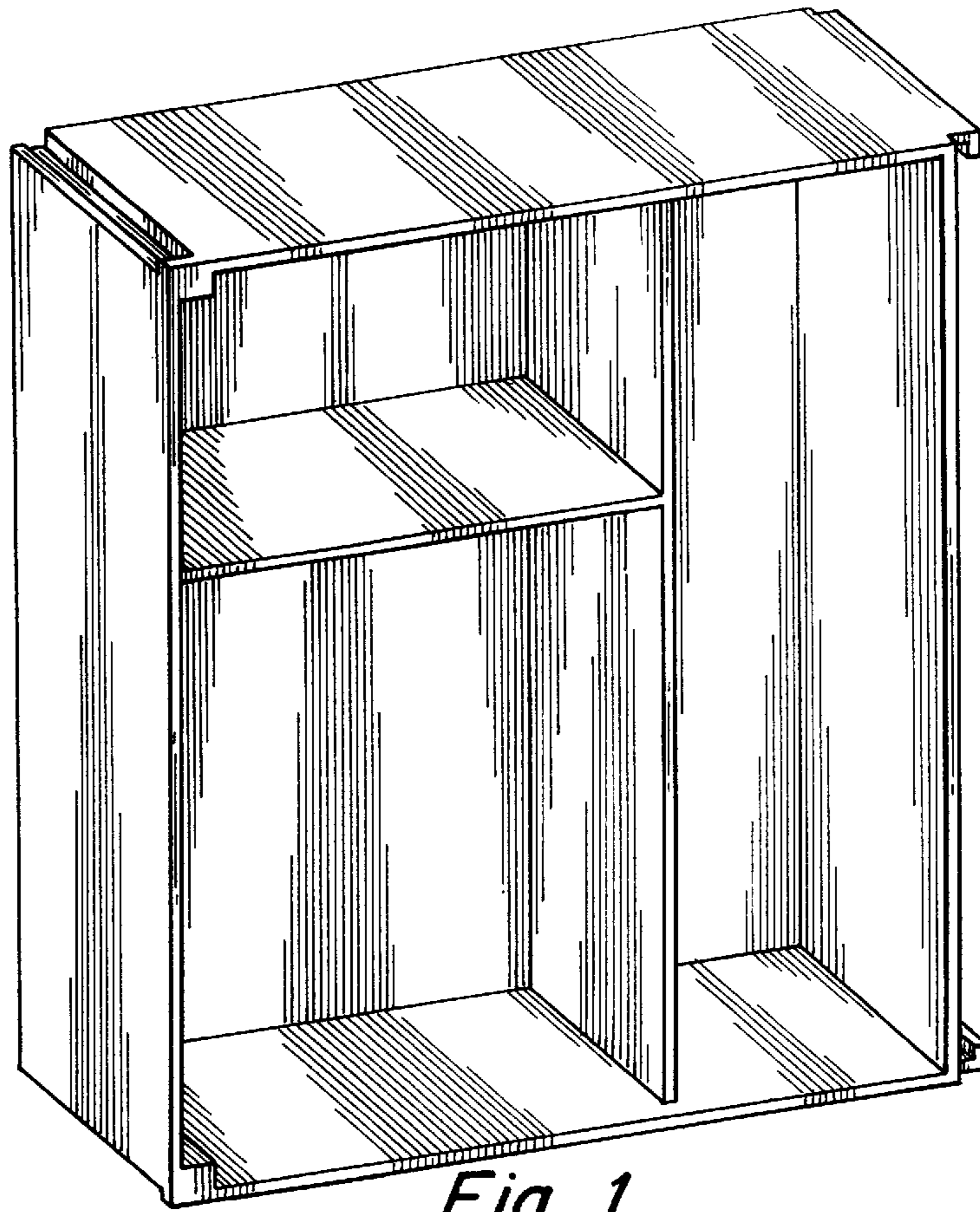
The ornamental design for an organizer rack, as shown and described.

**DESCRIPTION**

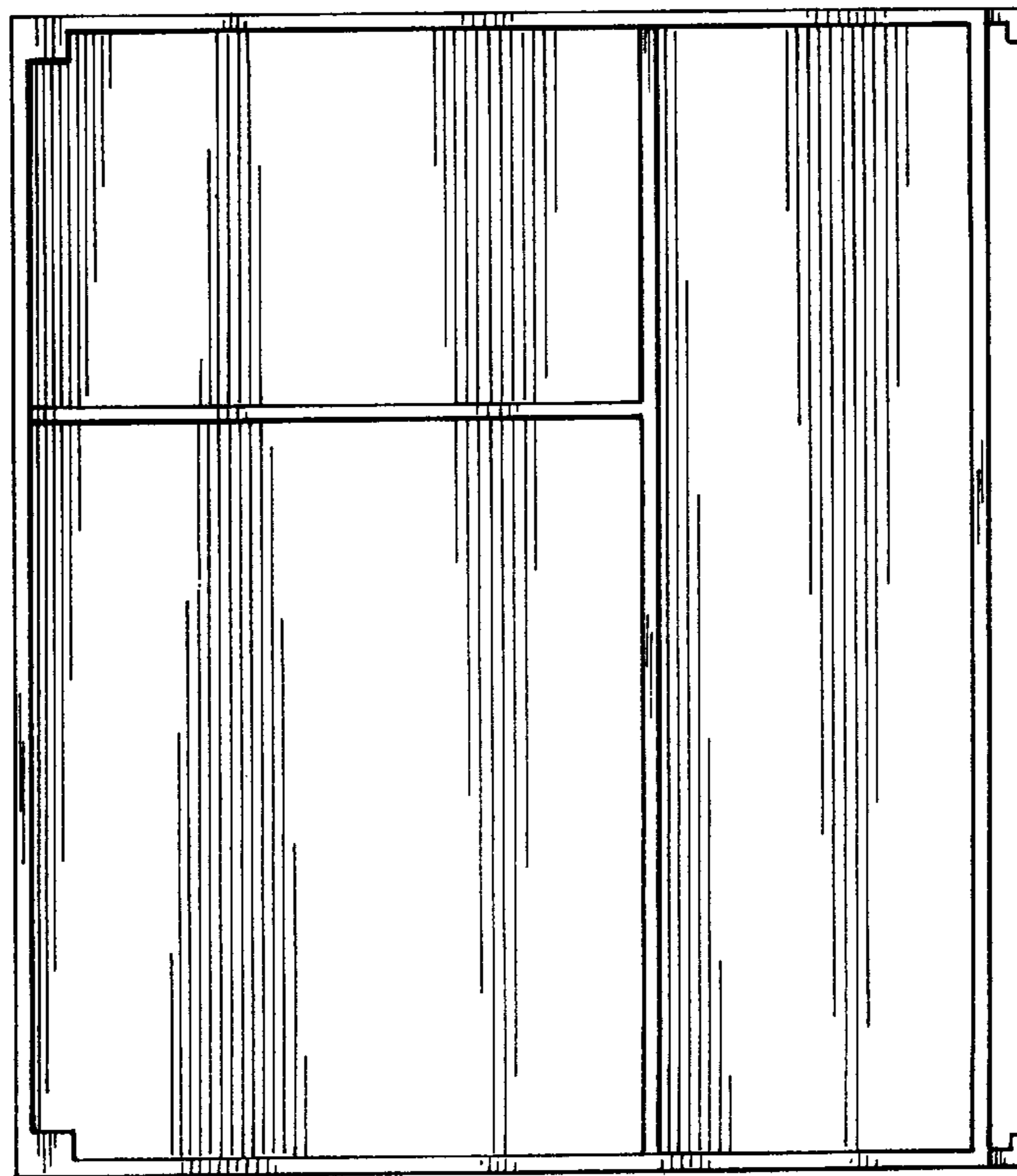
FIG. 1 is a top, front, left-side perspective view of an organizer rack showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a top plan view thereof; the bottom plan view being a mirror image thereof.

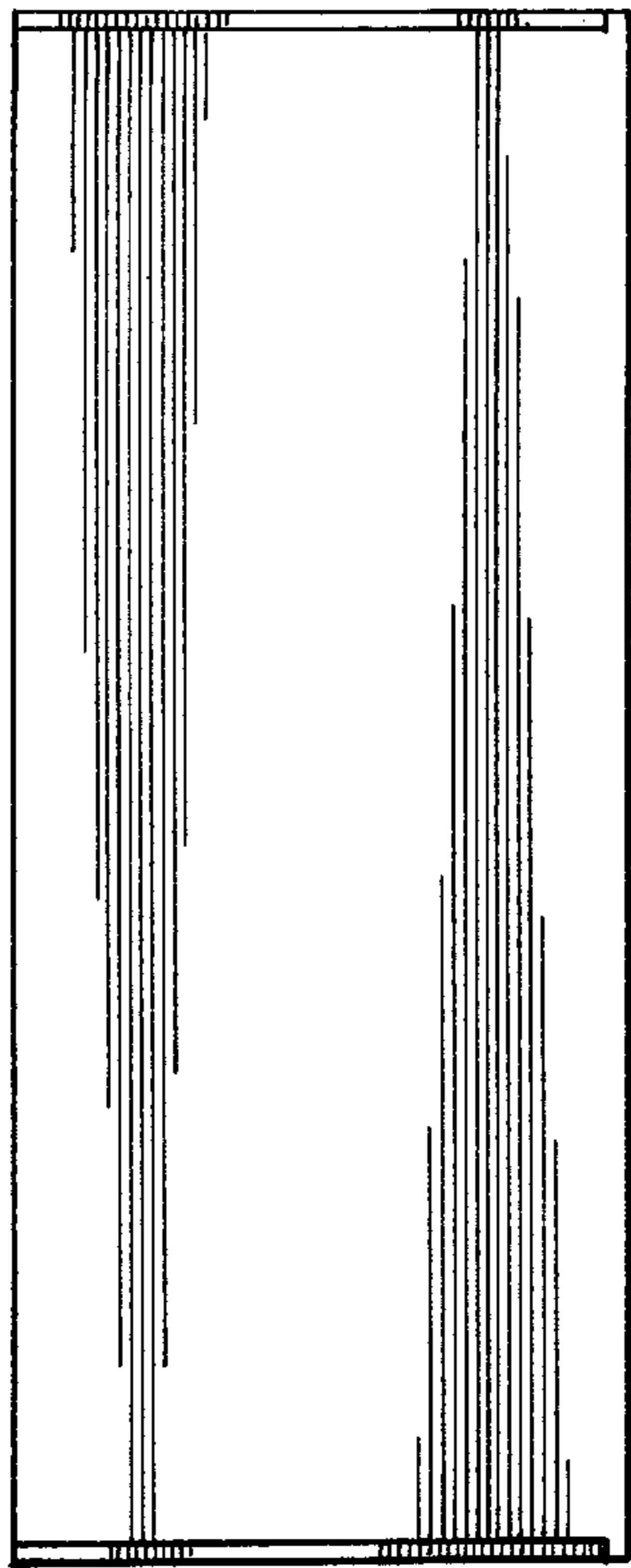




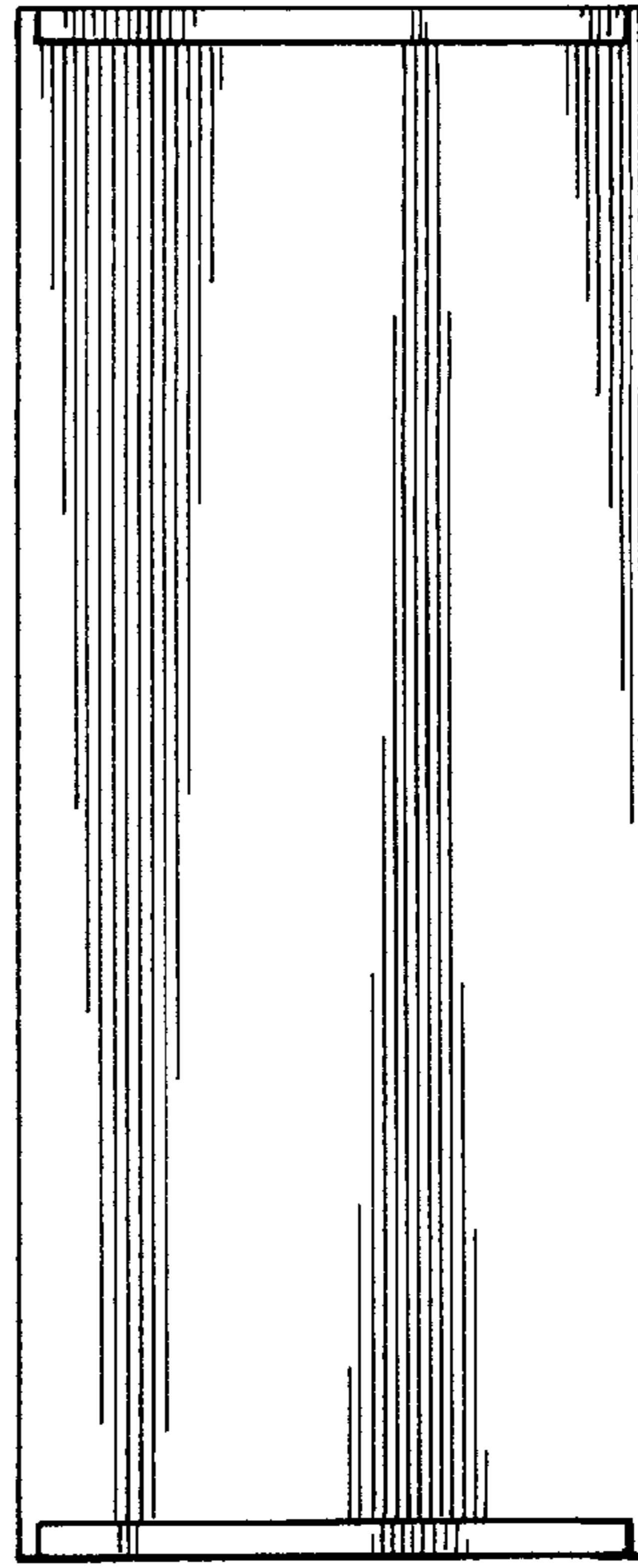

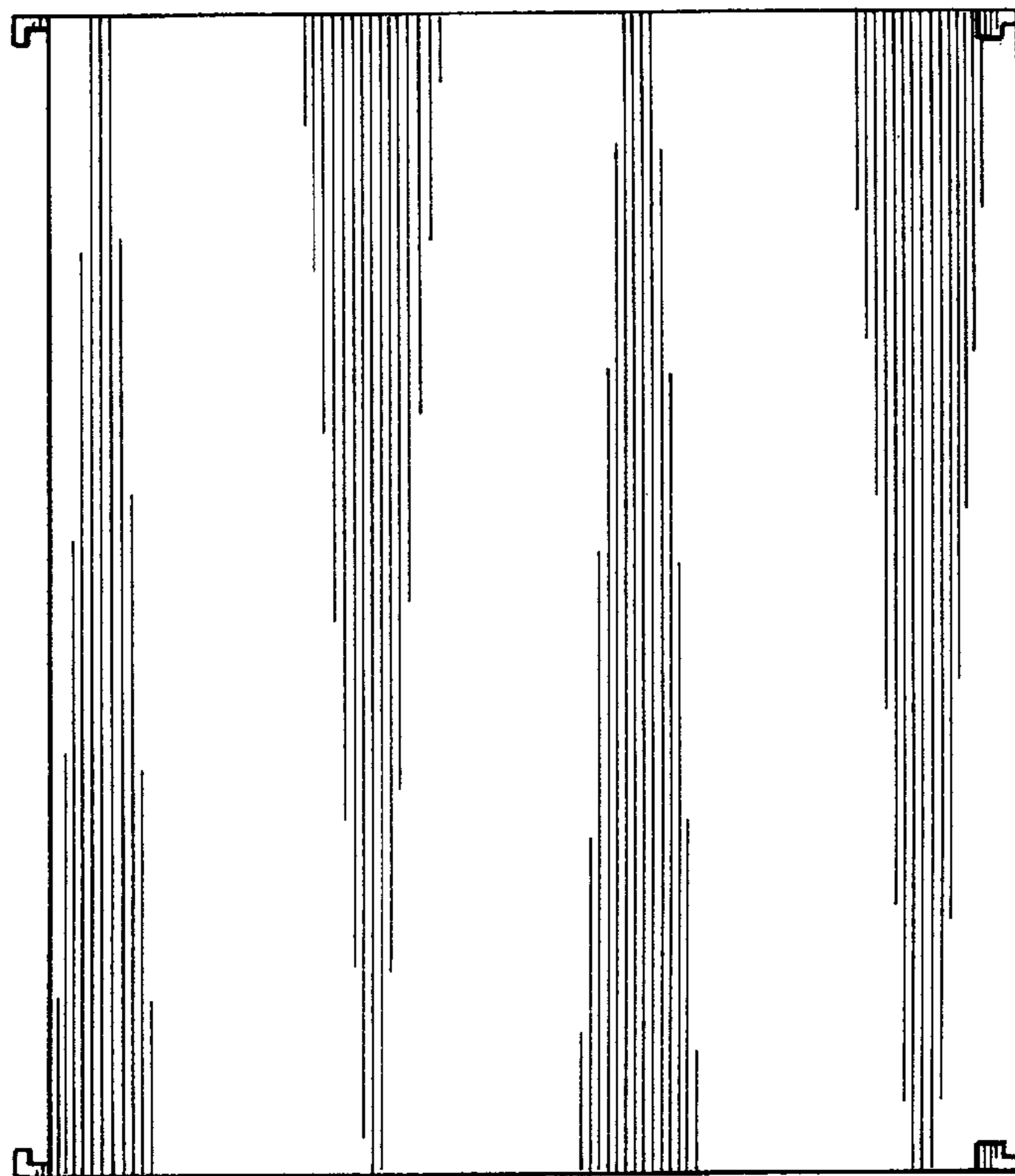

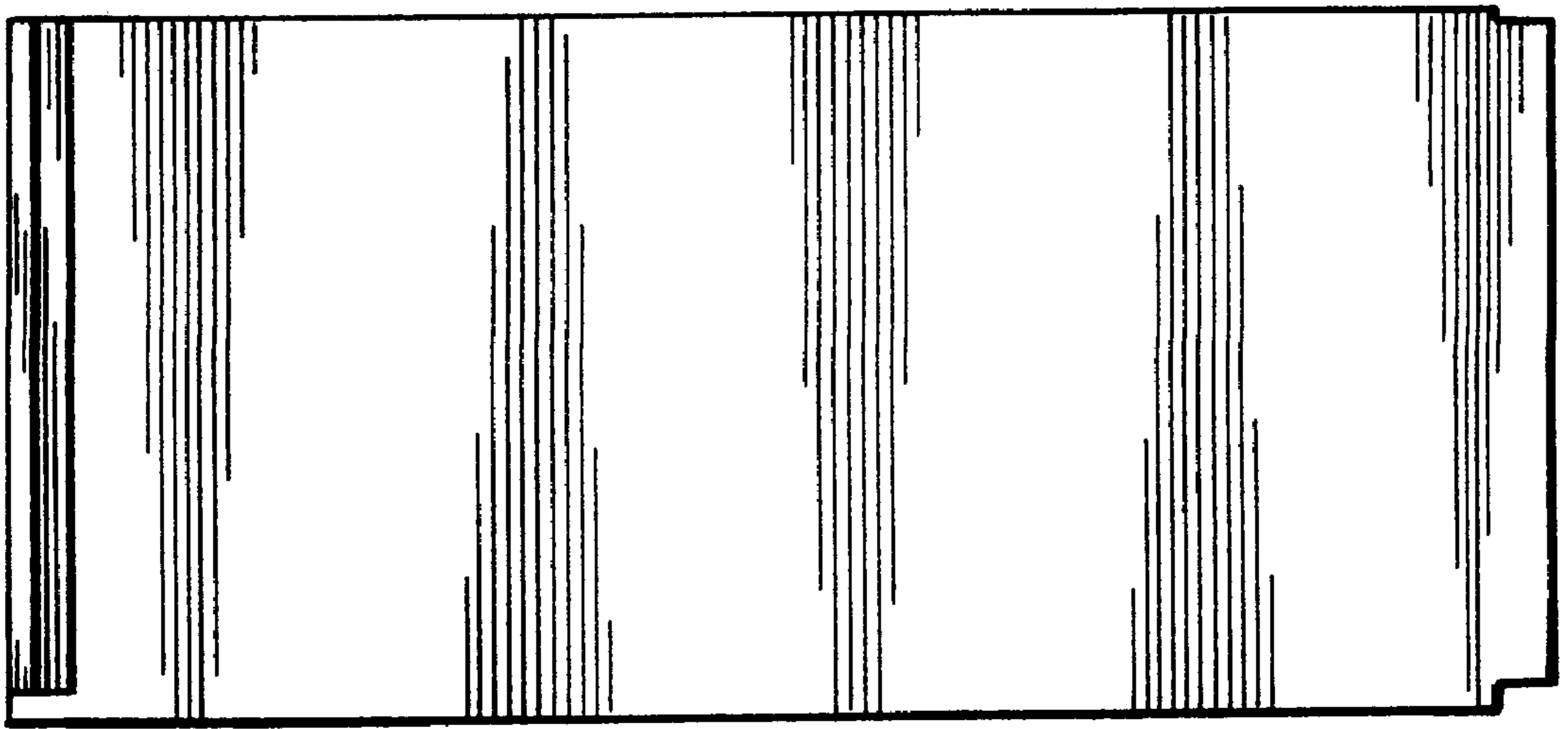
