The ornamental design for a packaging for food products such as confectionery products, as shown and described.

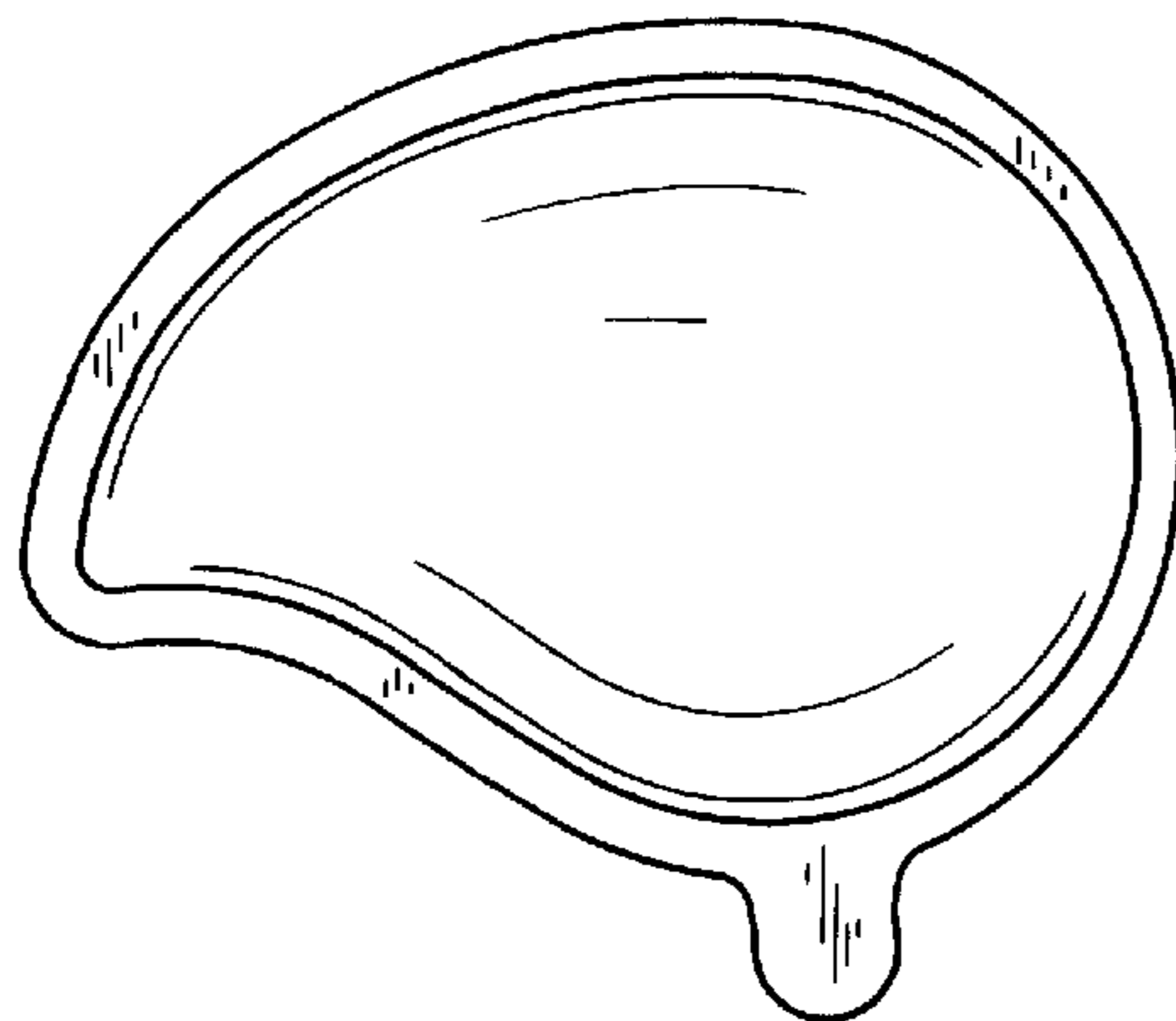

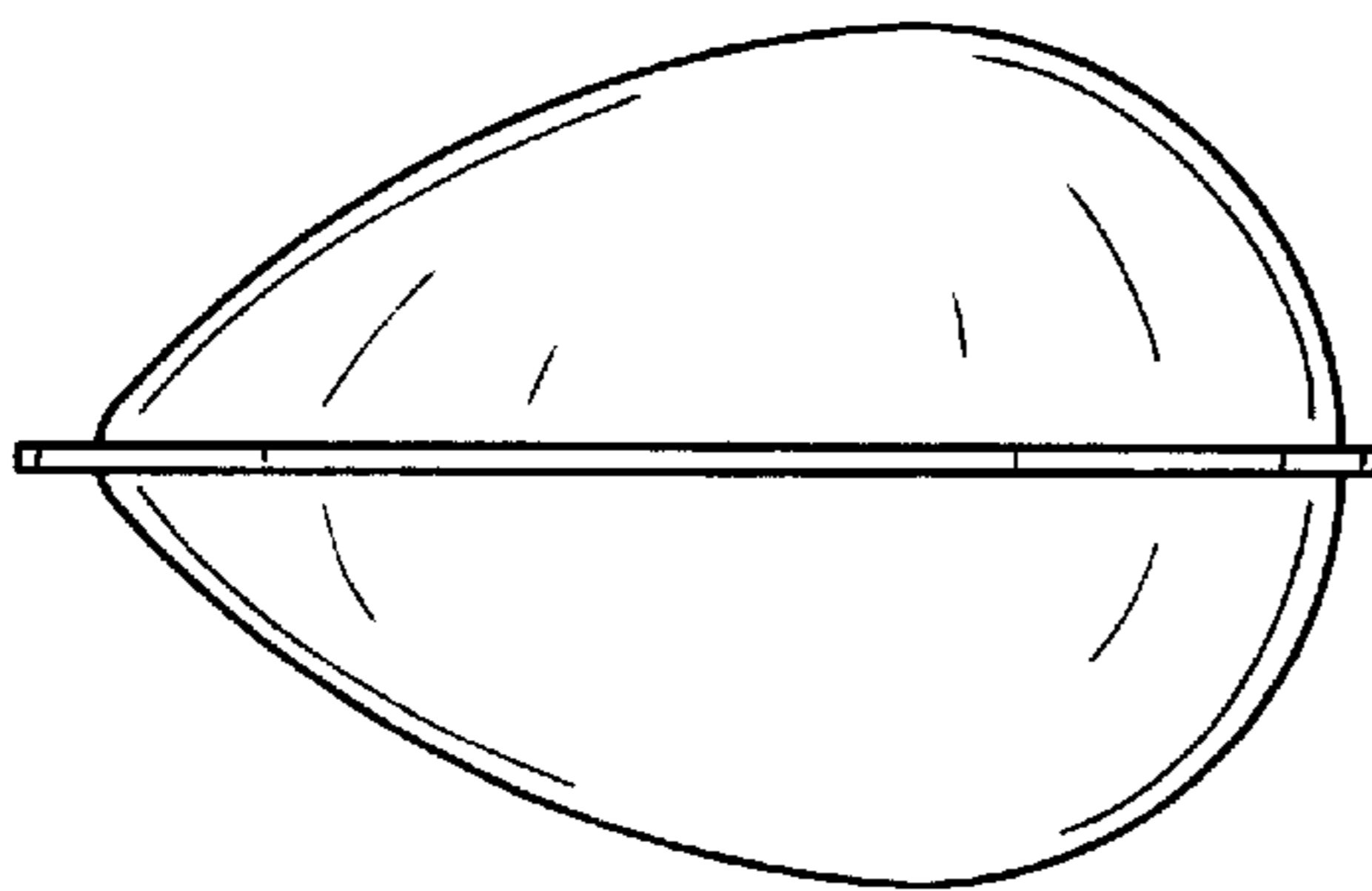

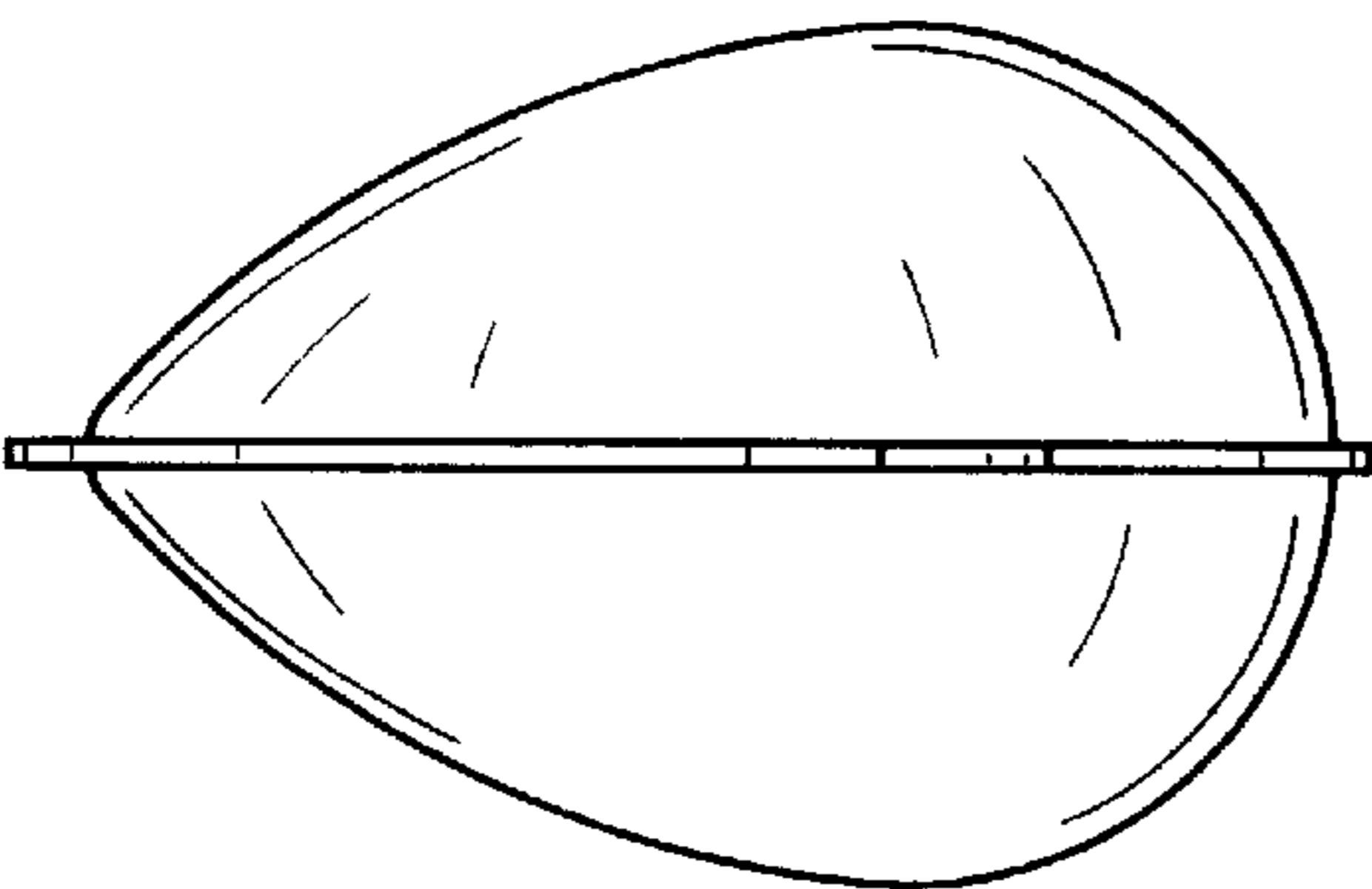

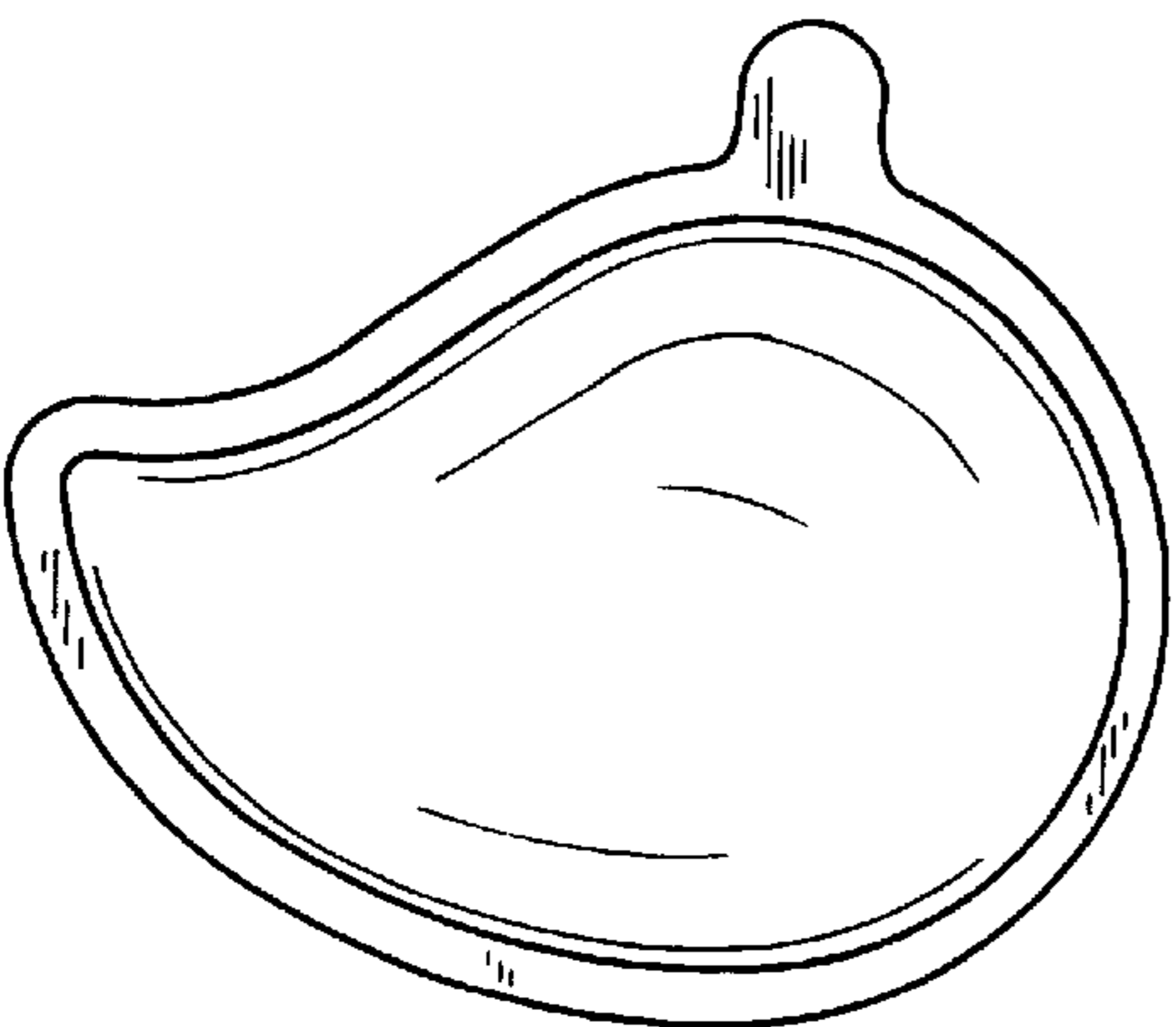

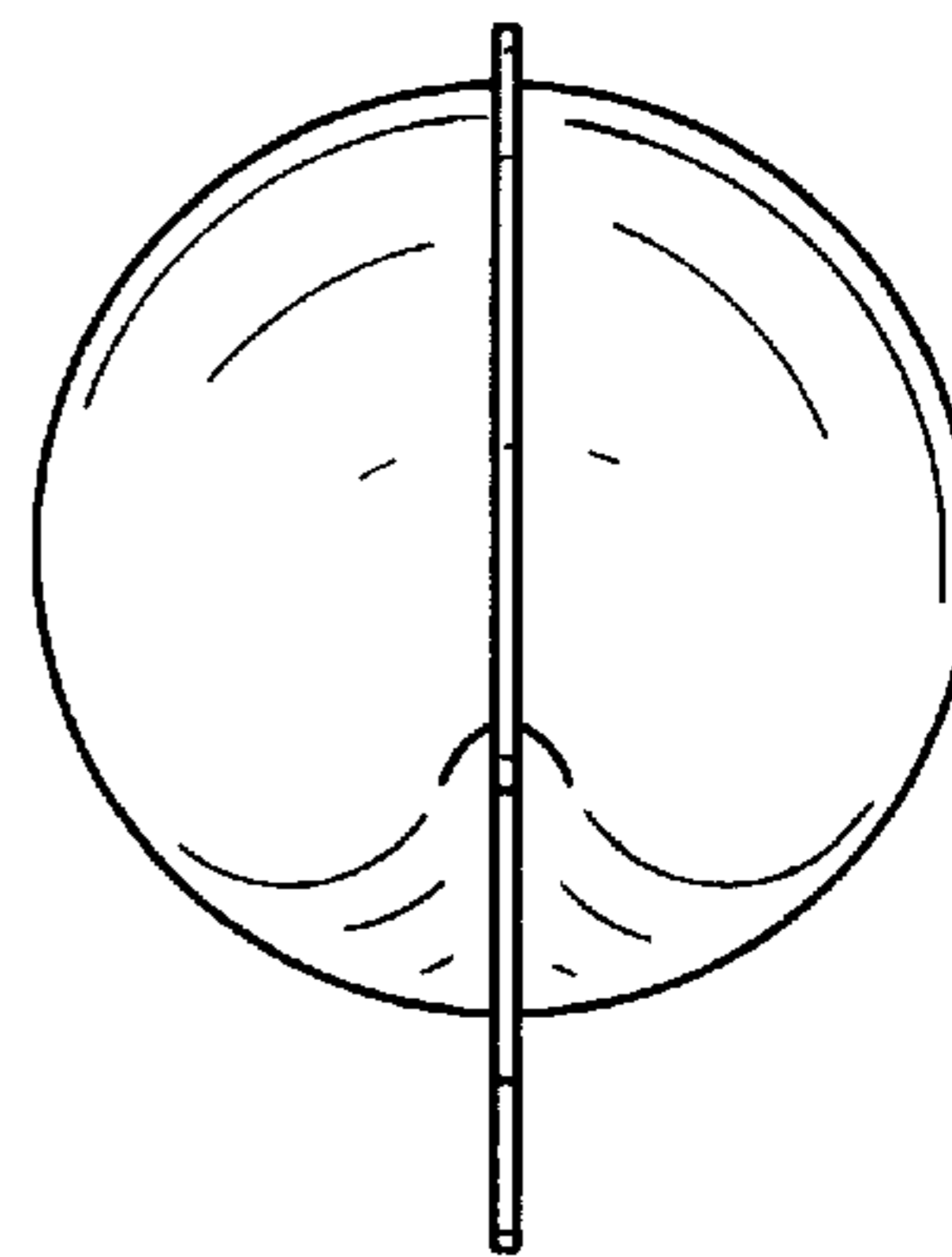
