(57) **CLAIM**

The ornamental design for a container having a recessed cap, as shown.

DESCRIPTION

FIG. 1 shows a perspective view of a container having a recessed cap incorporating our design.

FIG. 2 shows a front view of the container having a recessed cap shown in FIG. 1.

FIG. 3 shows a top view of the container having a recessed cap shown in FIG. 1.

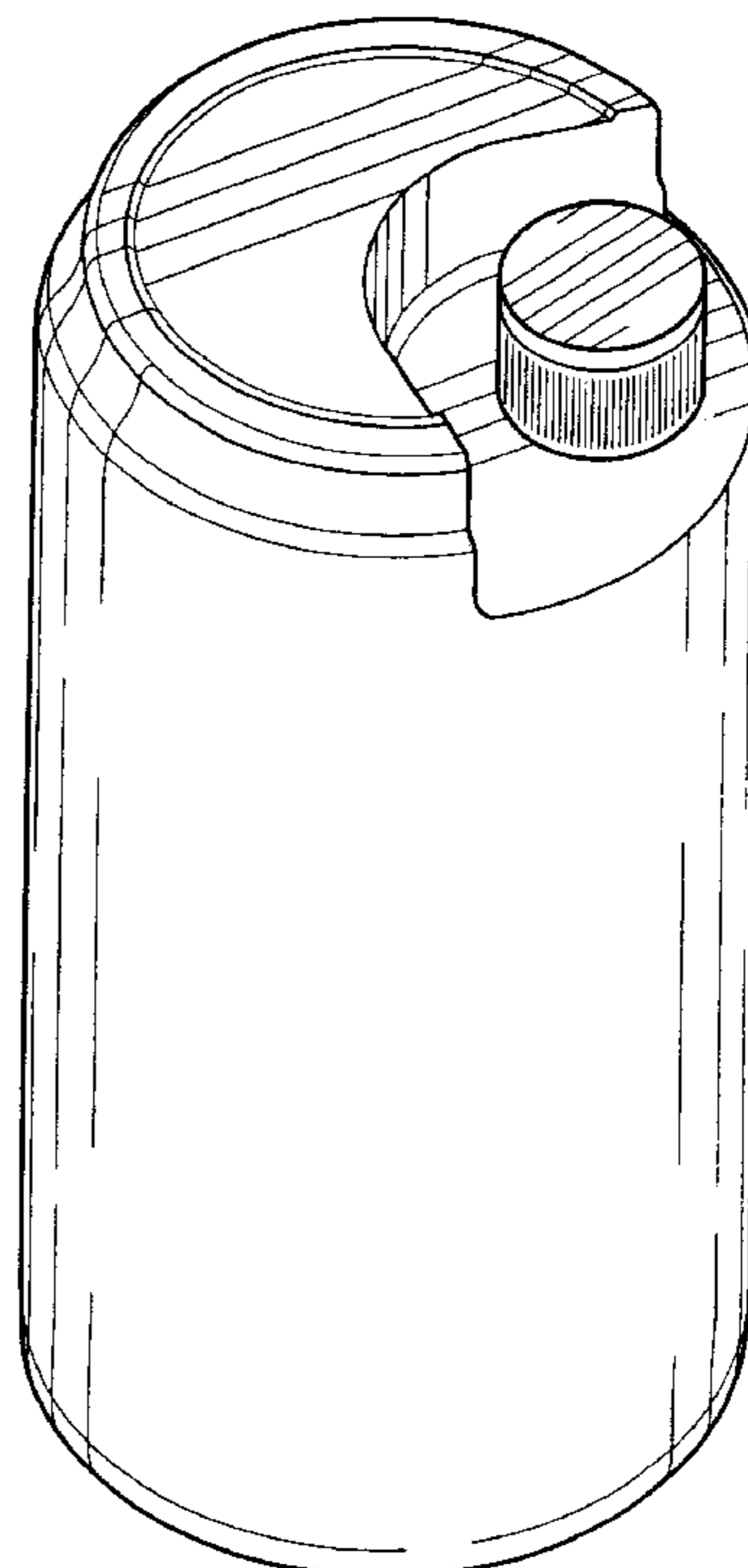
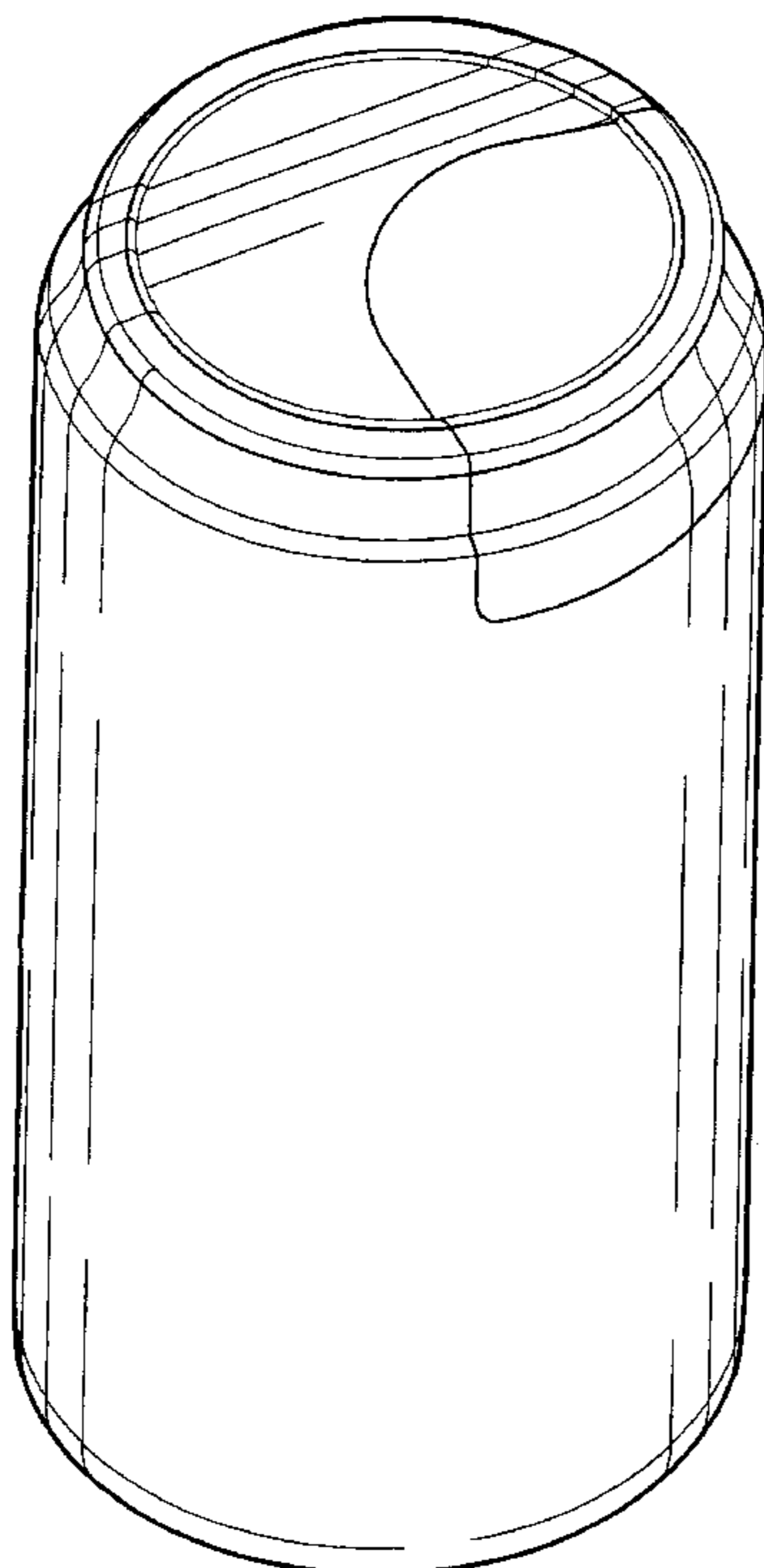
FIG. 4 shows a bottom view of the container having a recessed cap shown in FIG. 1.

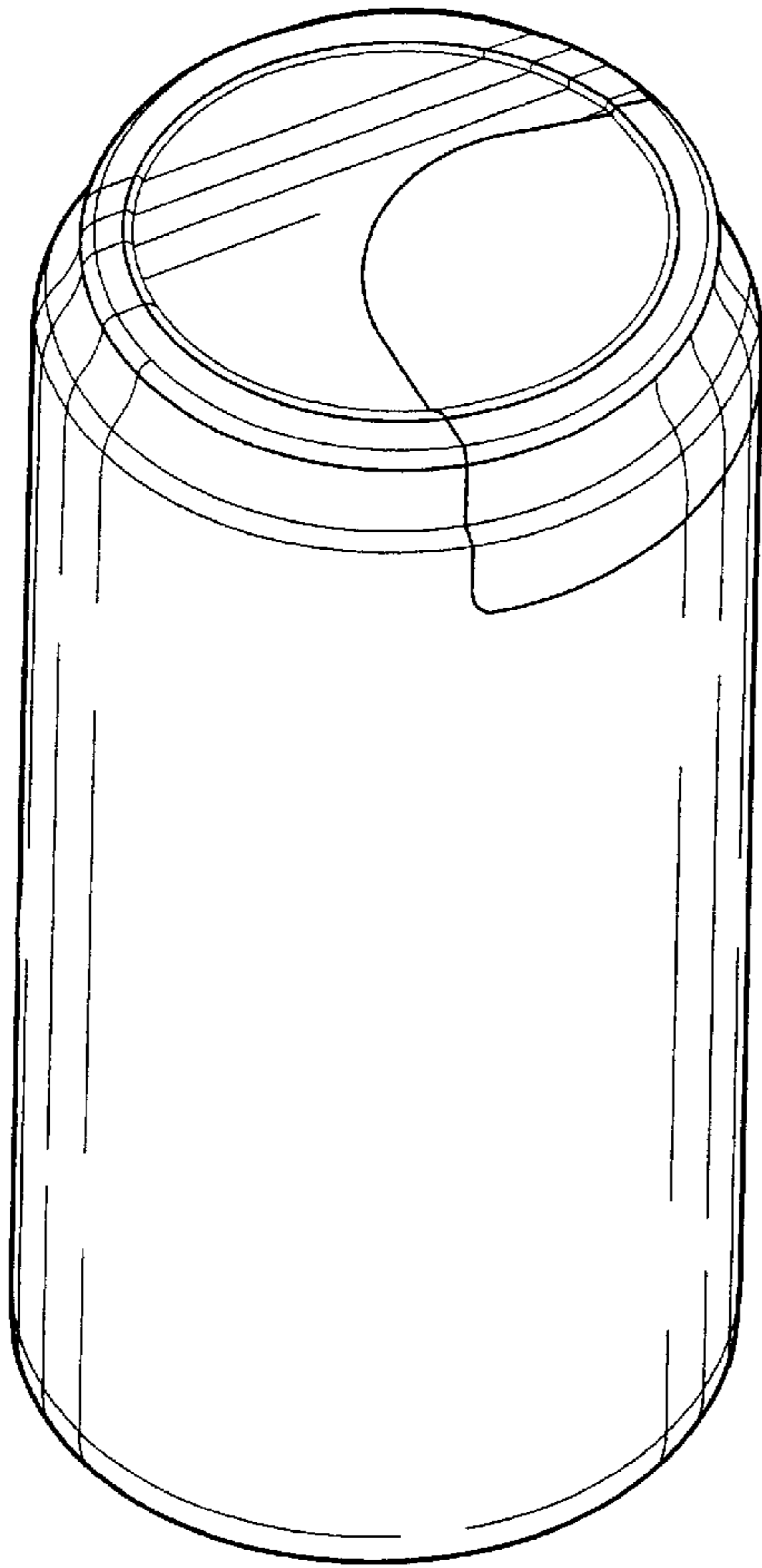

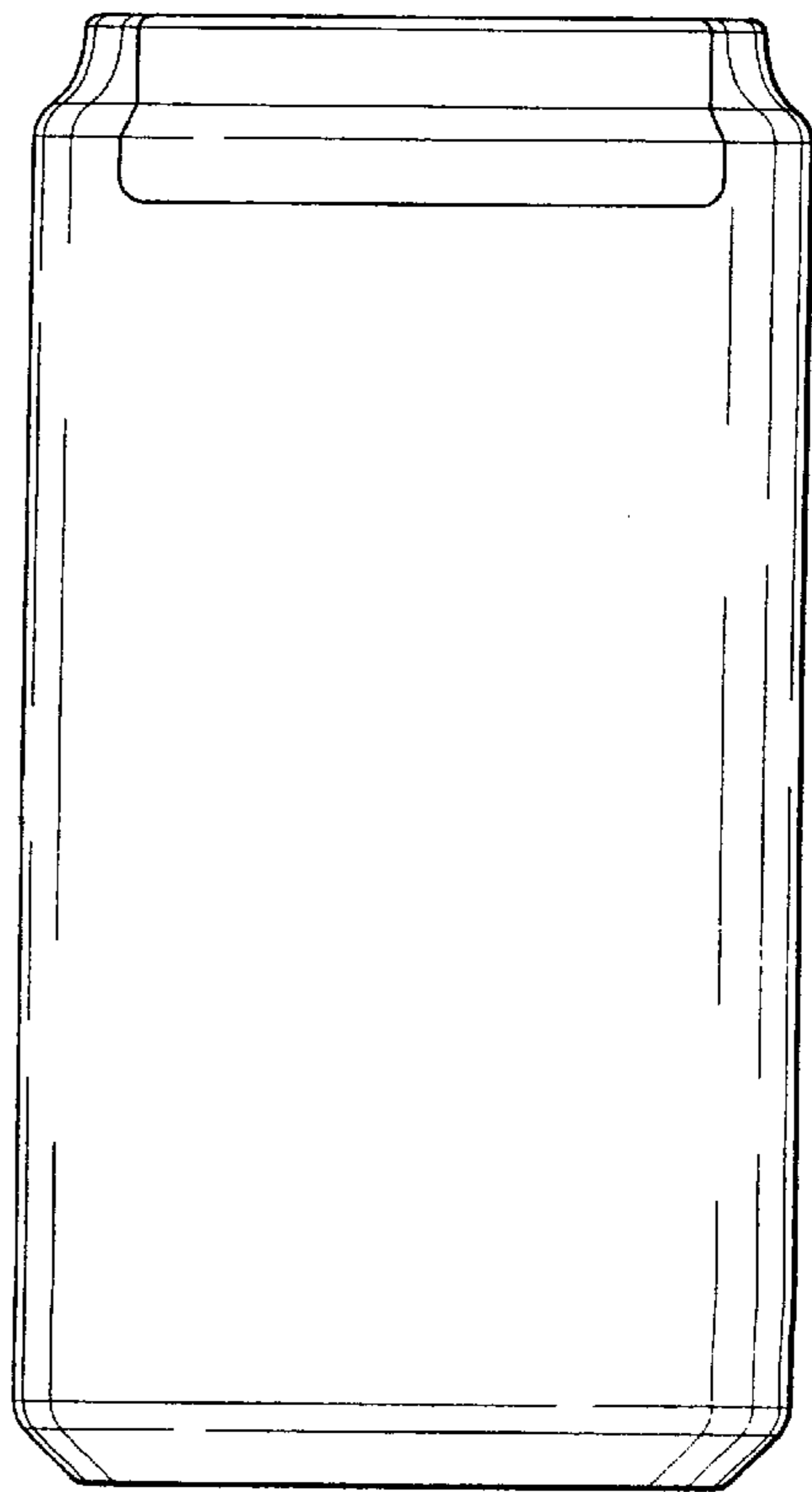

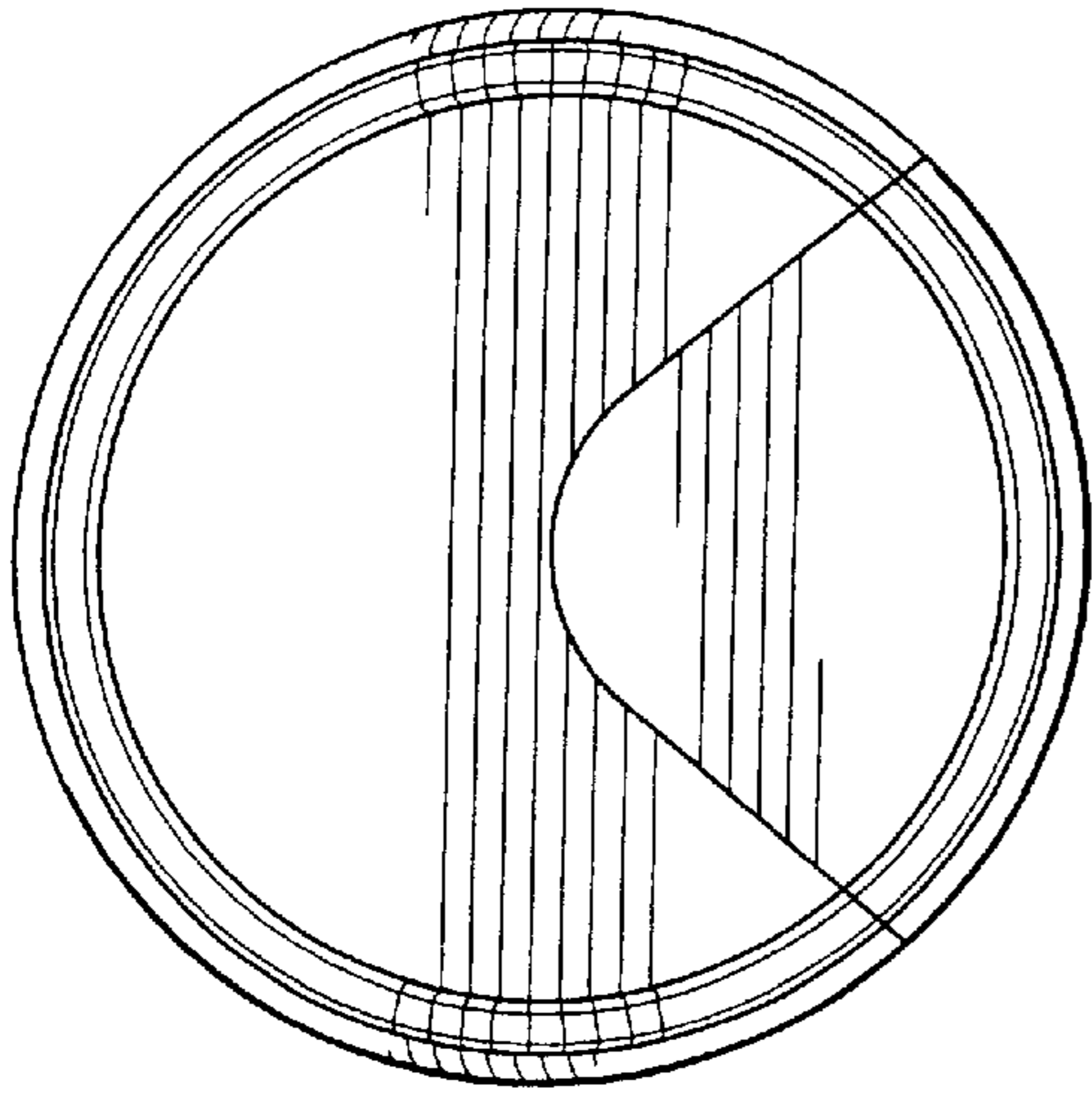

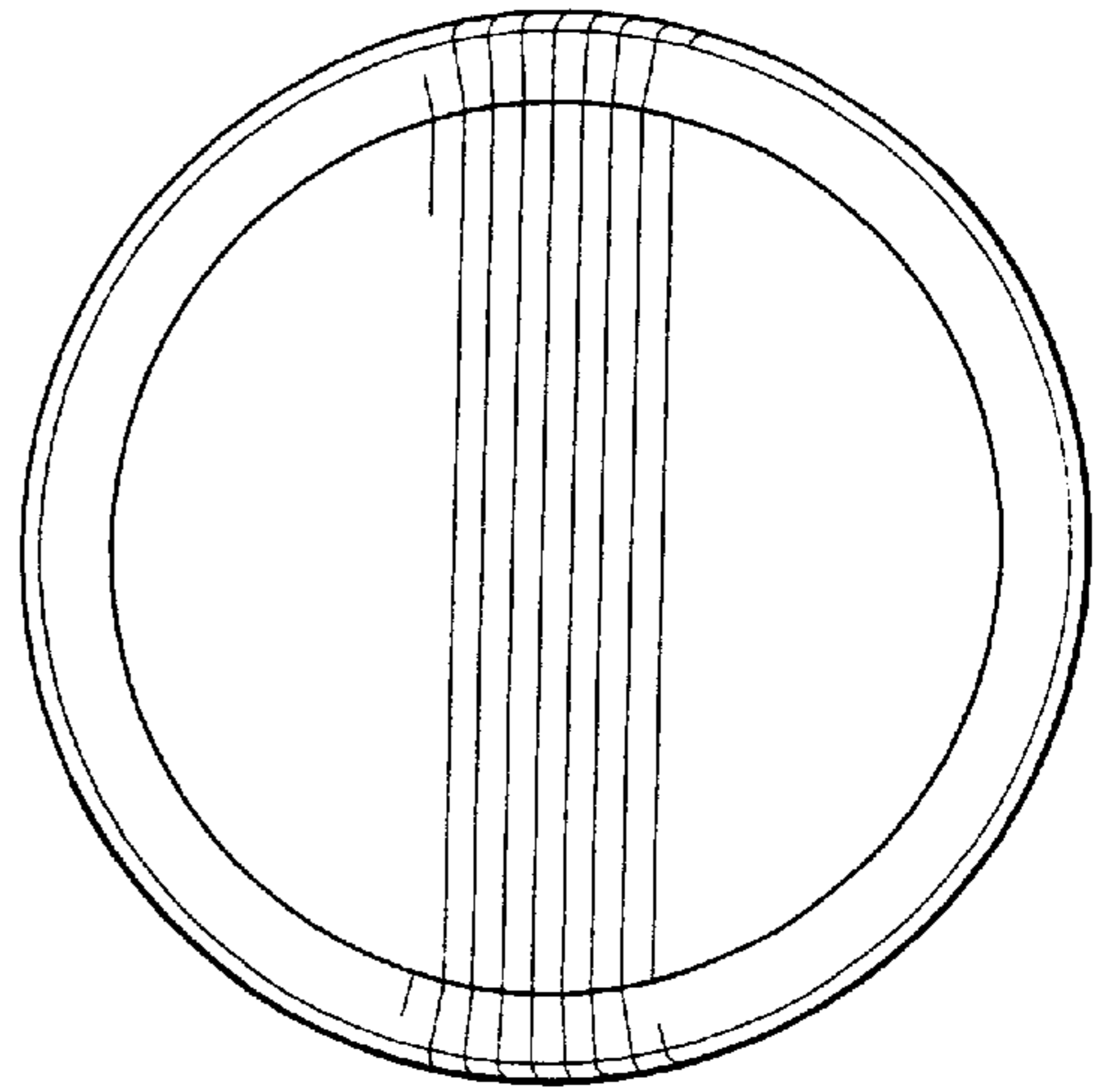

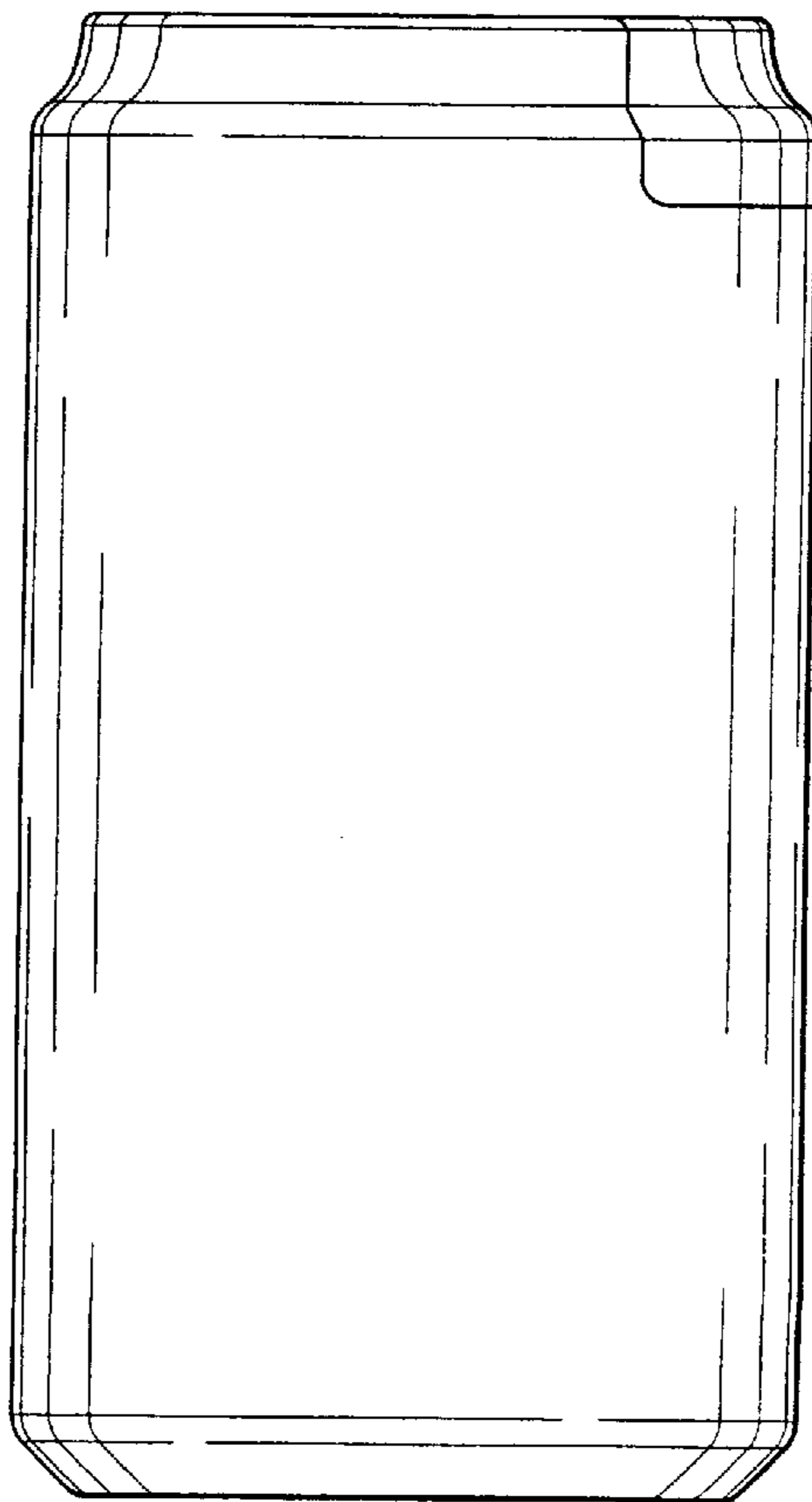

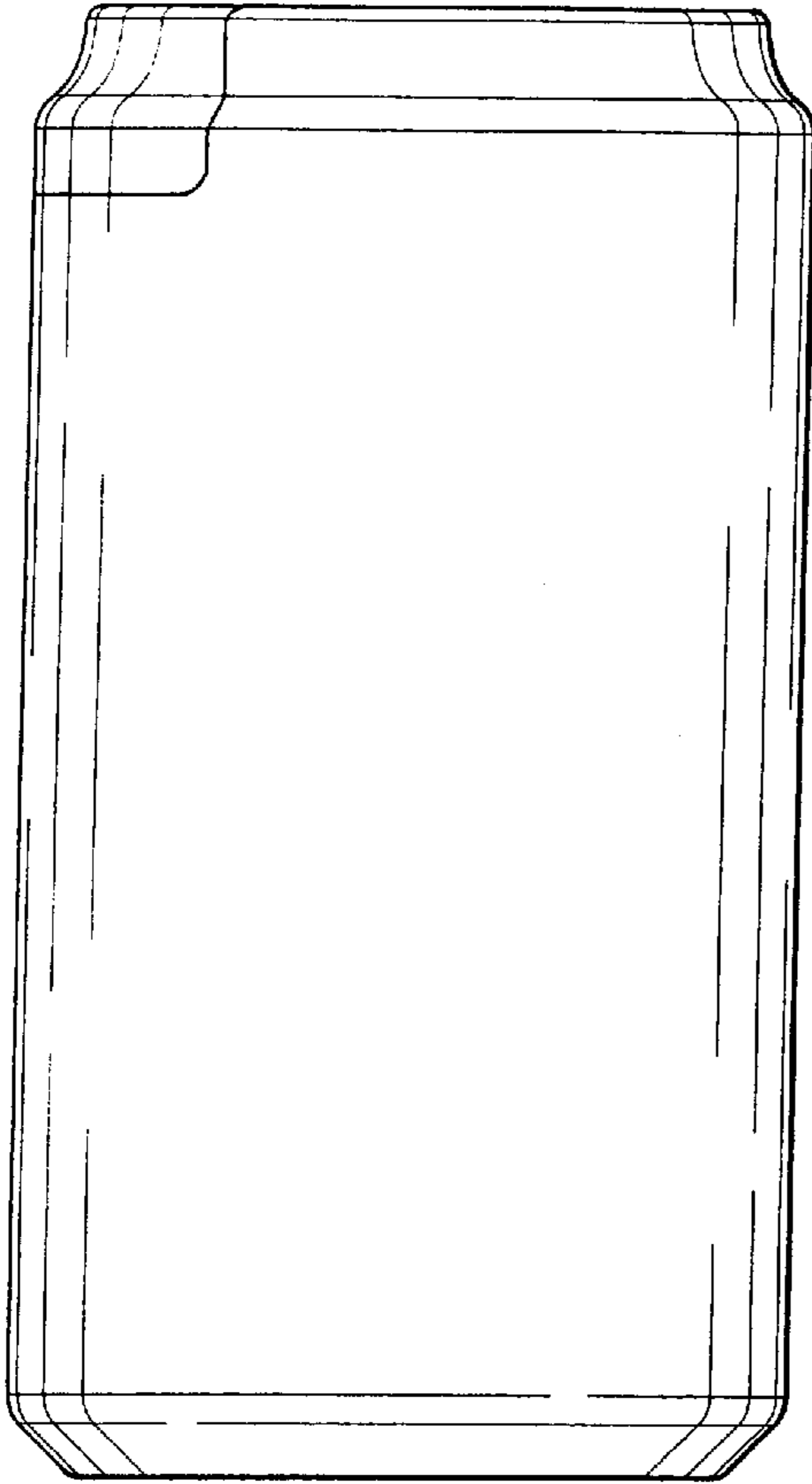

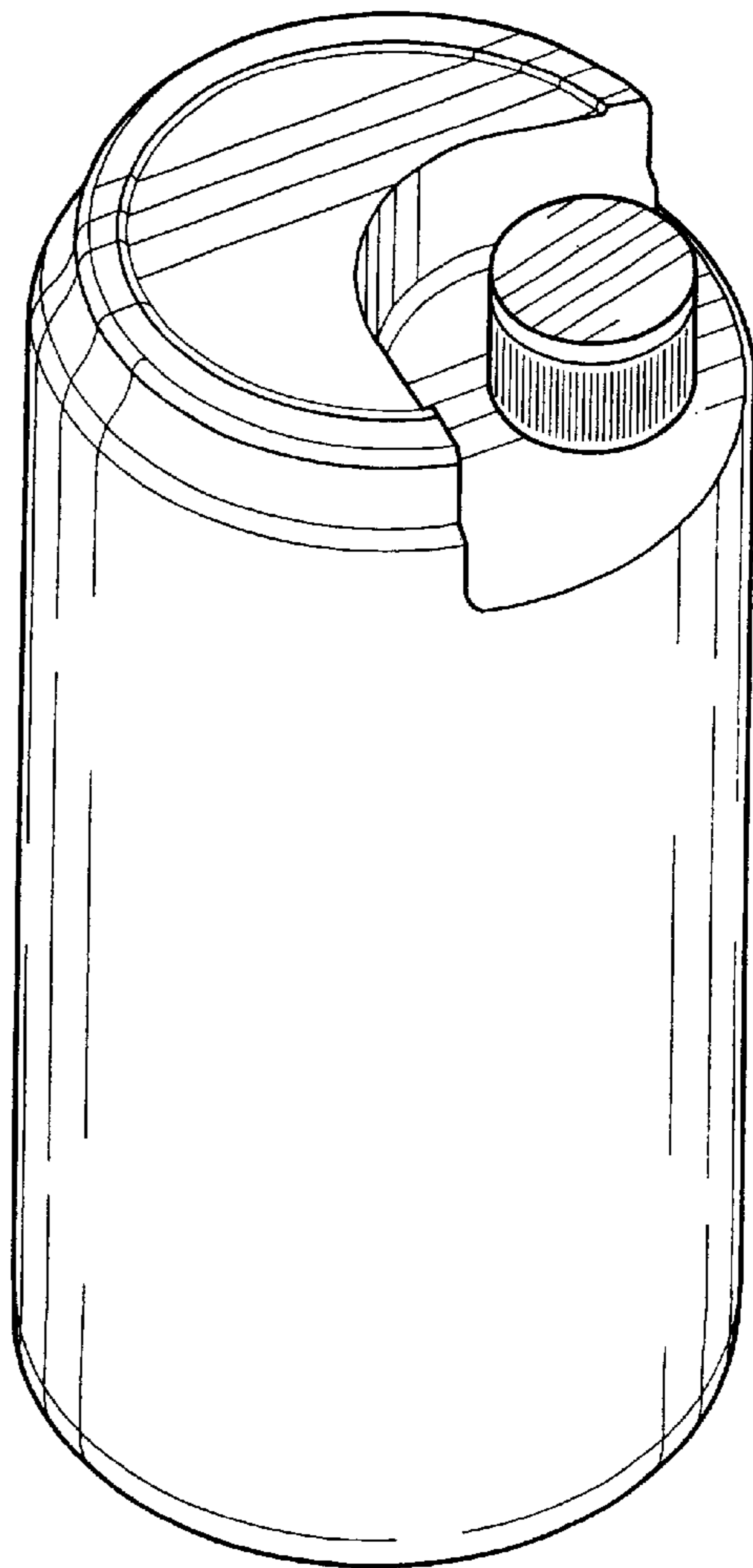
