The ornamental design for an automotive instrument panel,
as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an automotive instrument panel, showing our new design;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is an enlarged cross-sectional view thereof, taken along line 7—7 in FIG. 1;
 FIG. 8 is a front, top and left side perspective view thereof;
 and,
 FIG. 9 is a reduced front, top and left side perspective view thereof, shown in its position of use.
 The broken lines shown in FIG. 9 are for illustrative purposes only and form no part of the claimed invention.

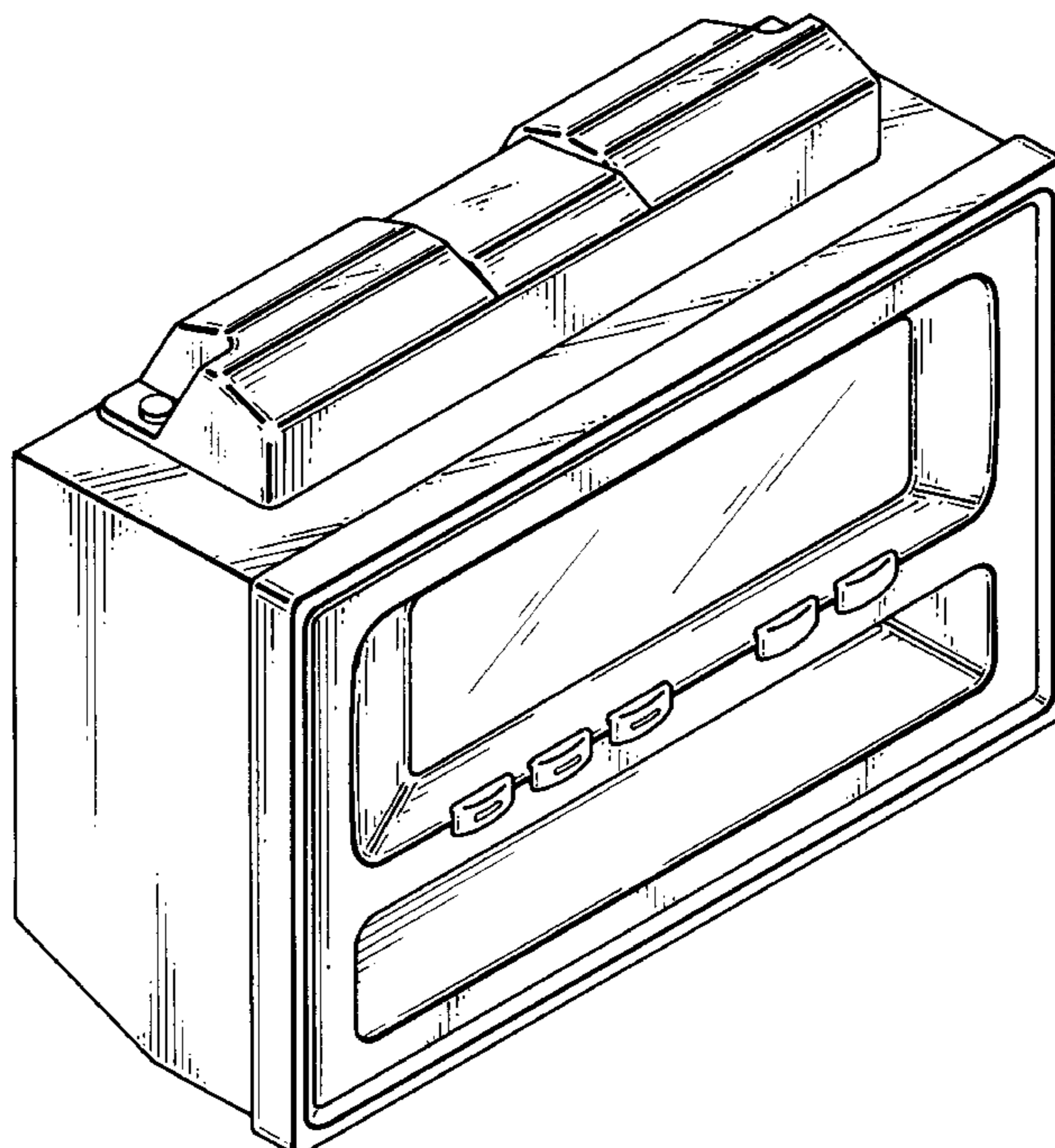

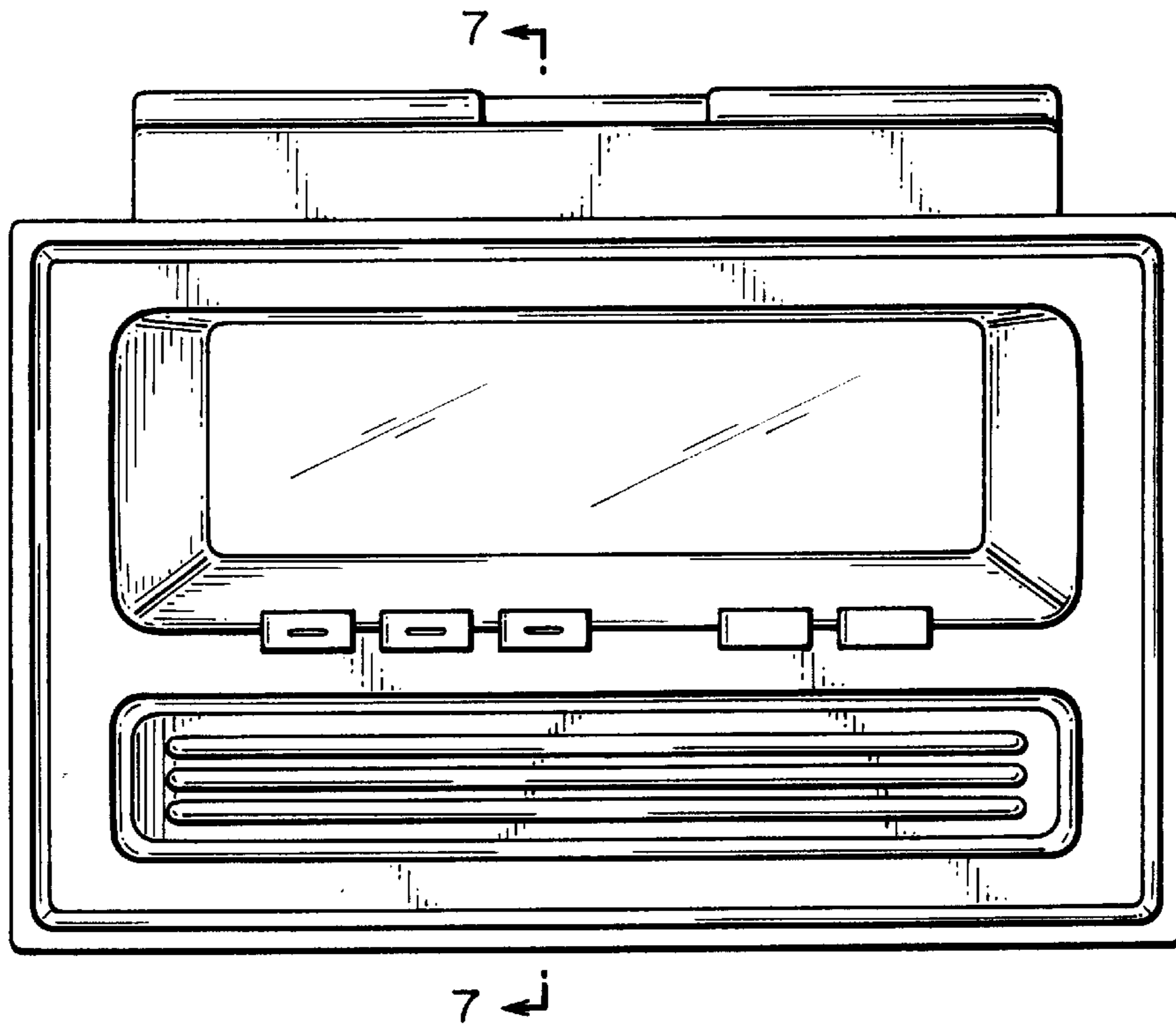

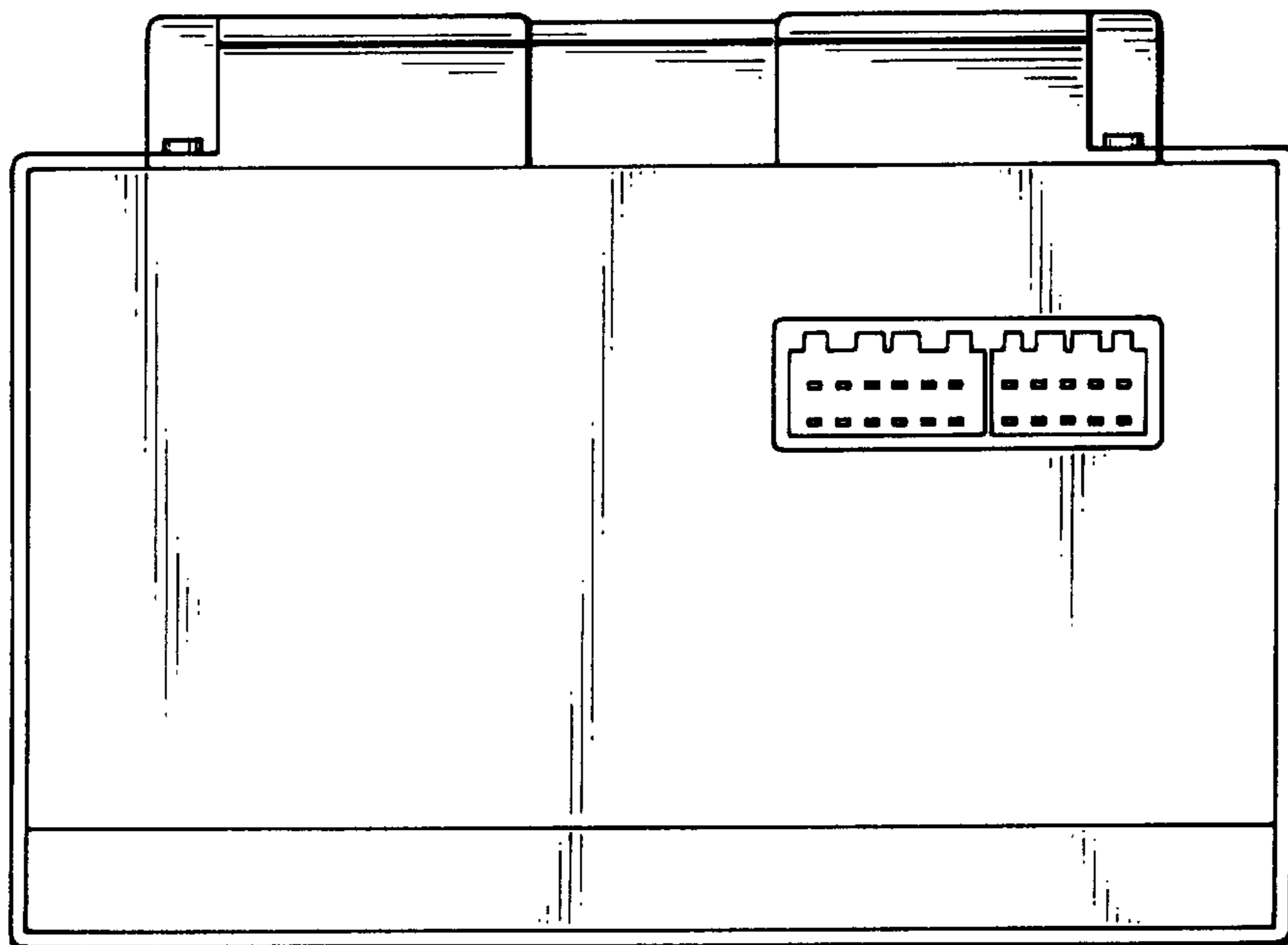

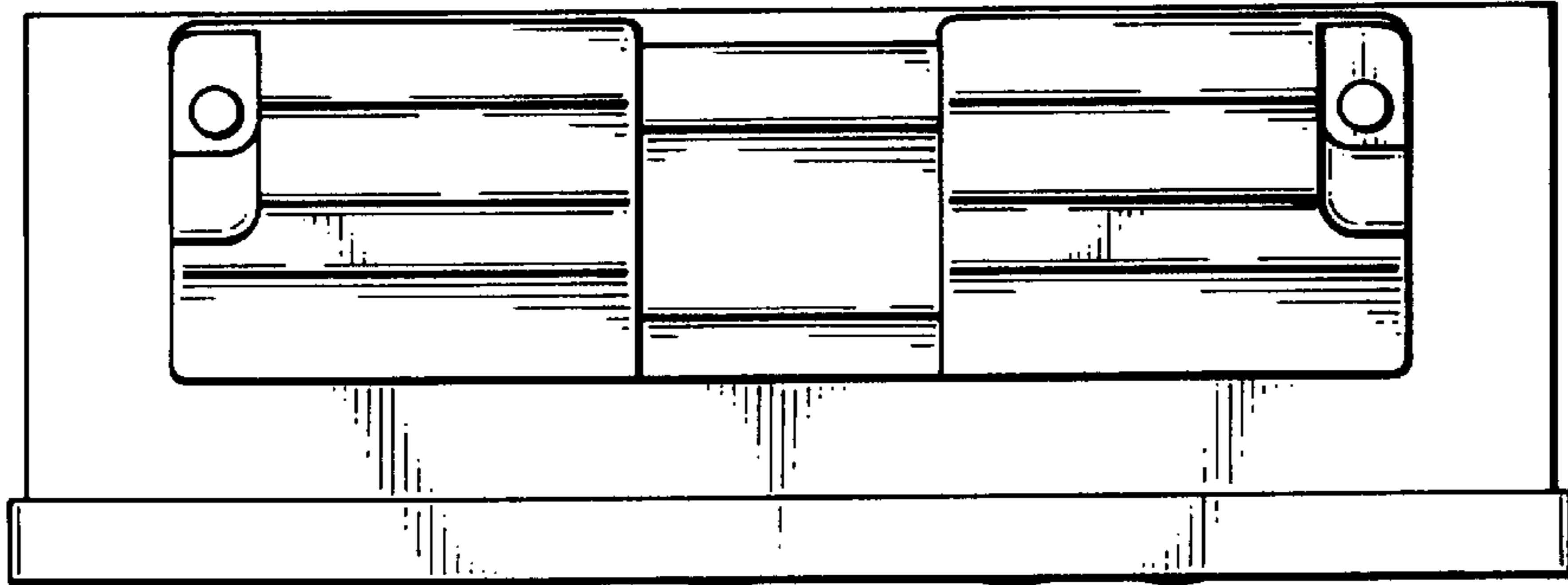

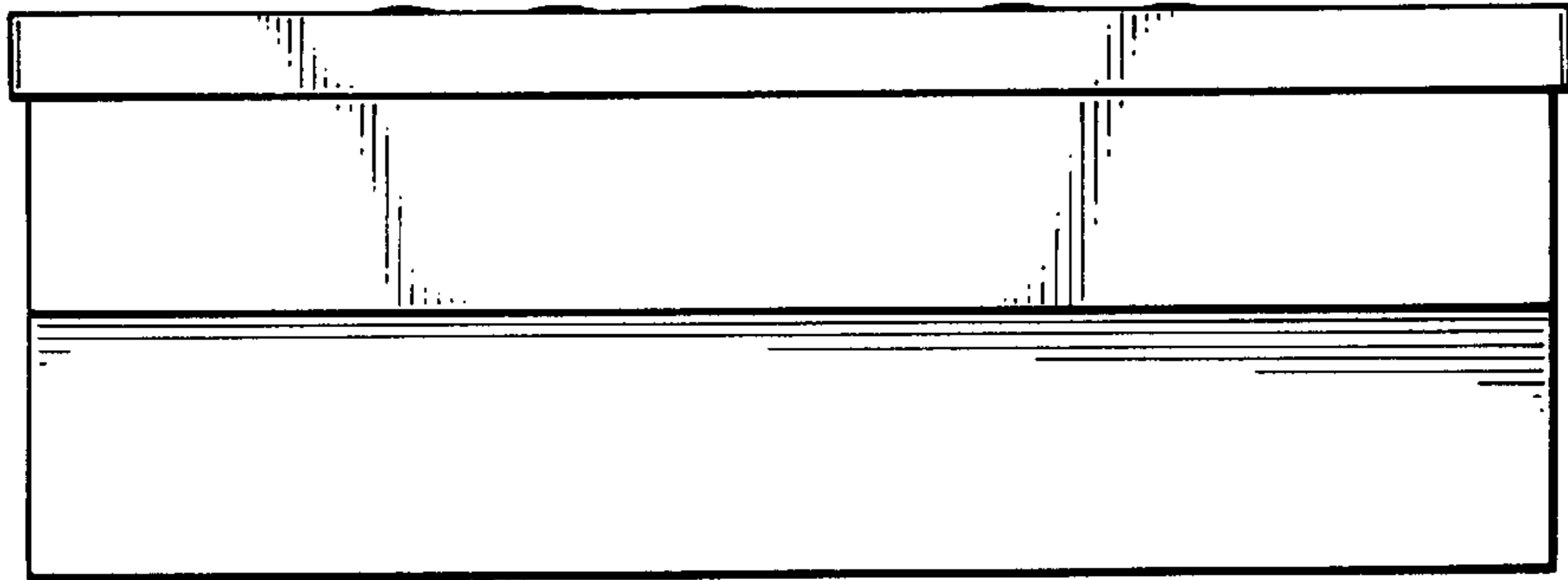

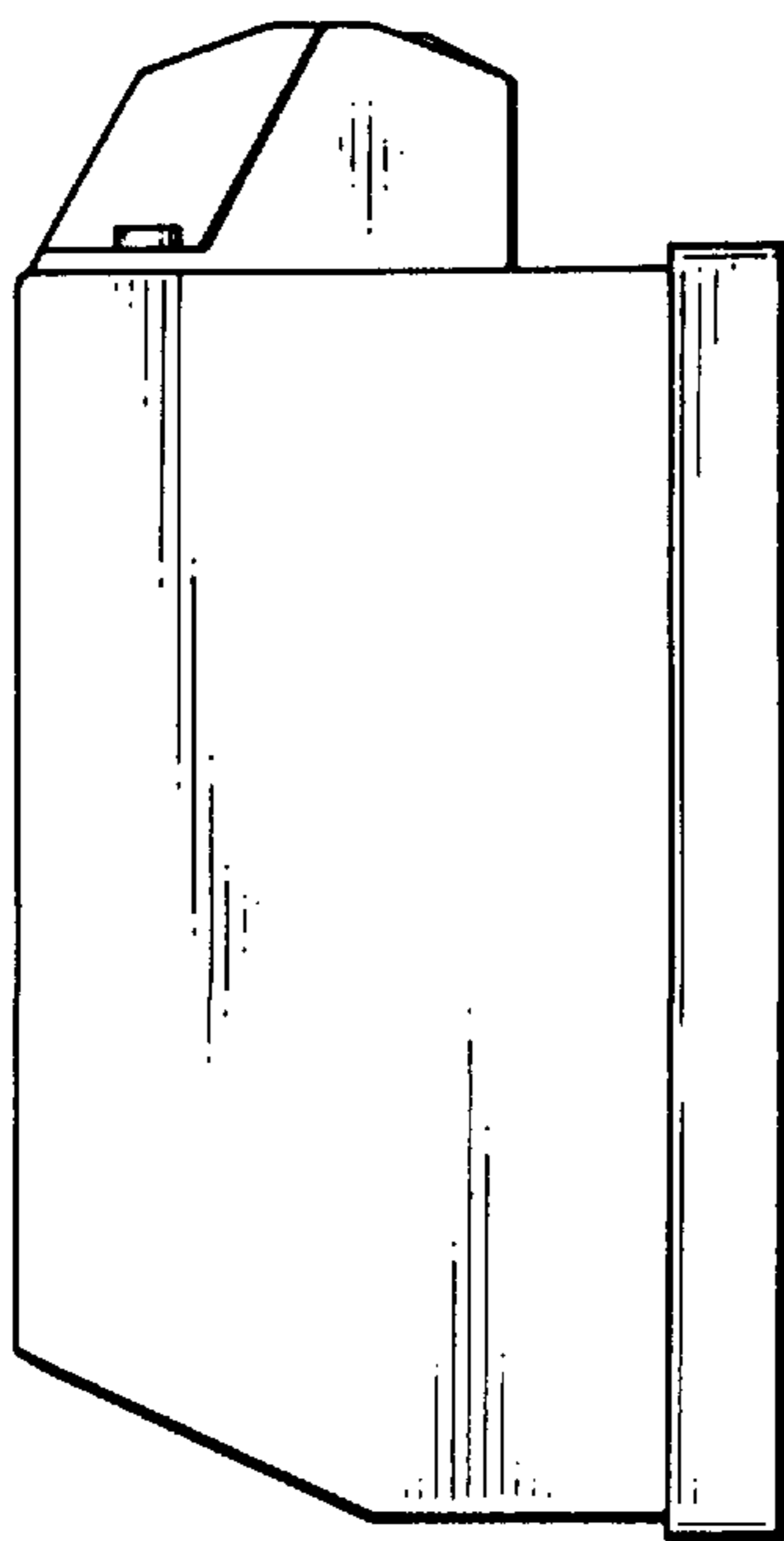

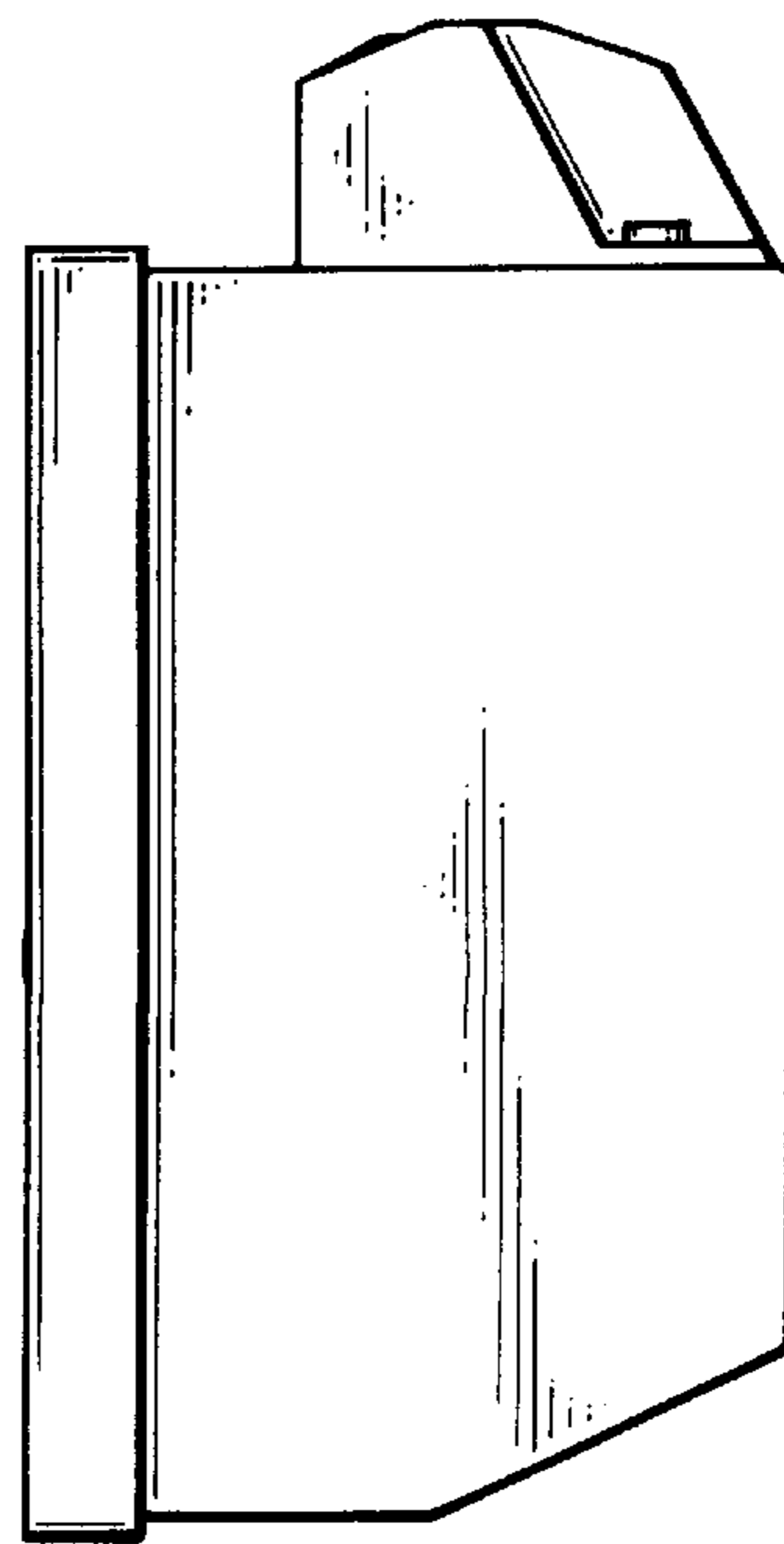

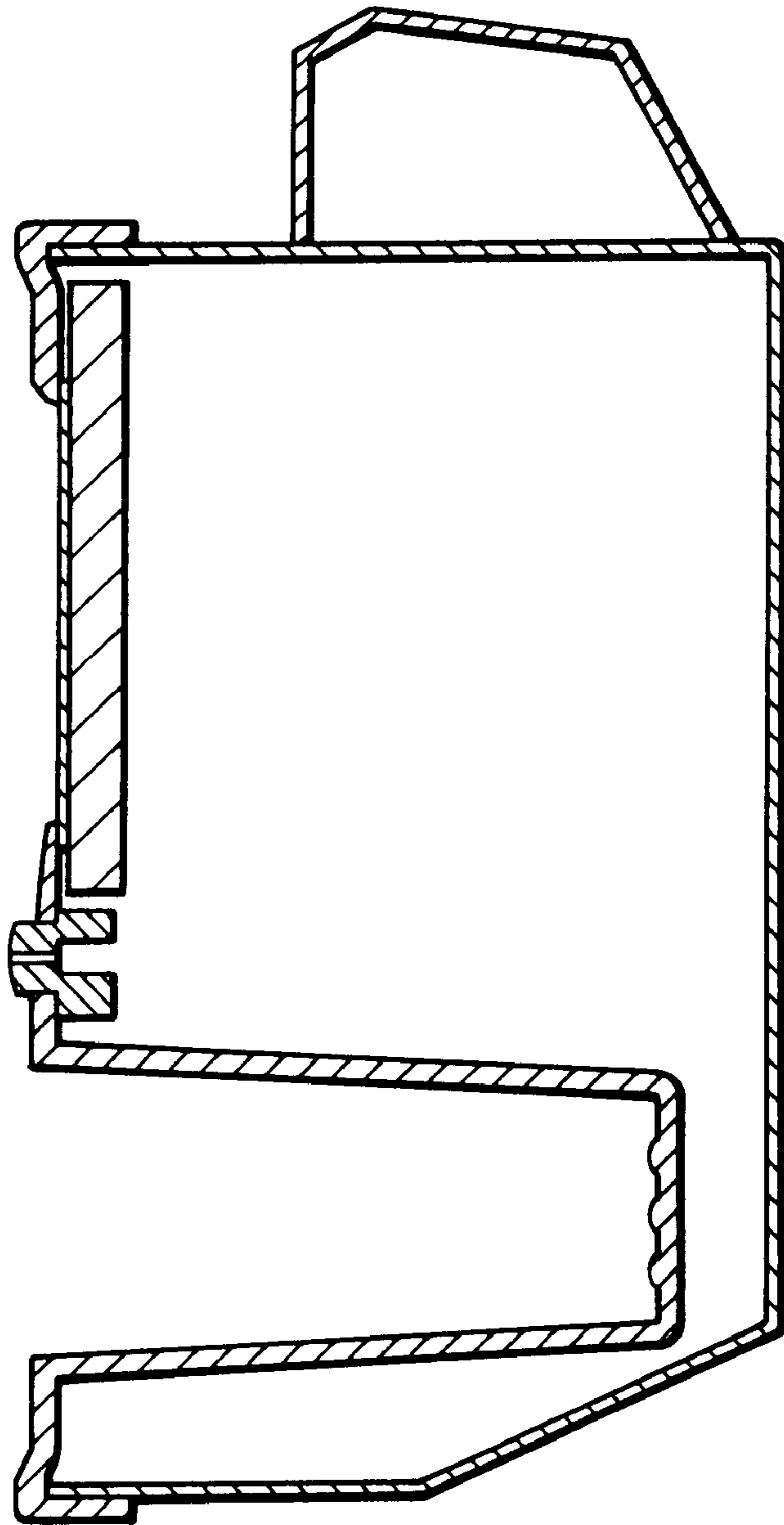

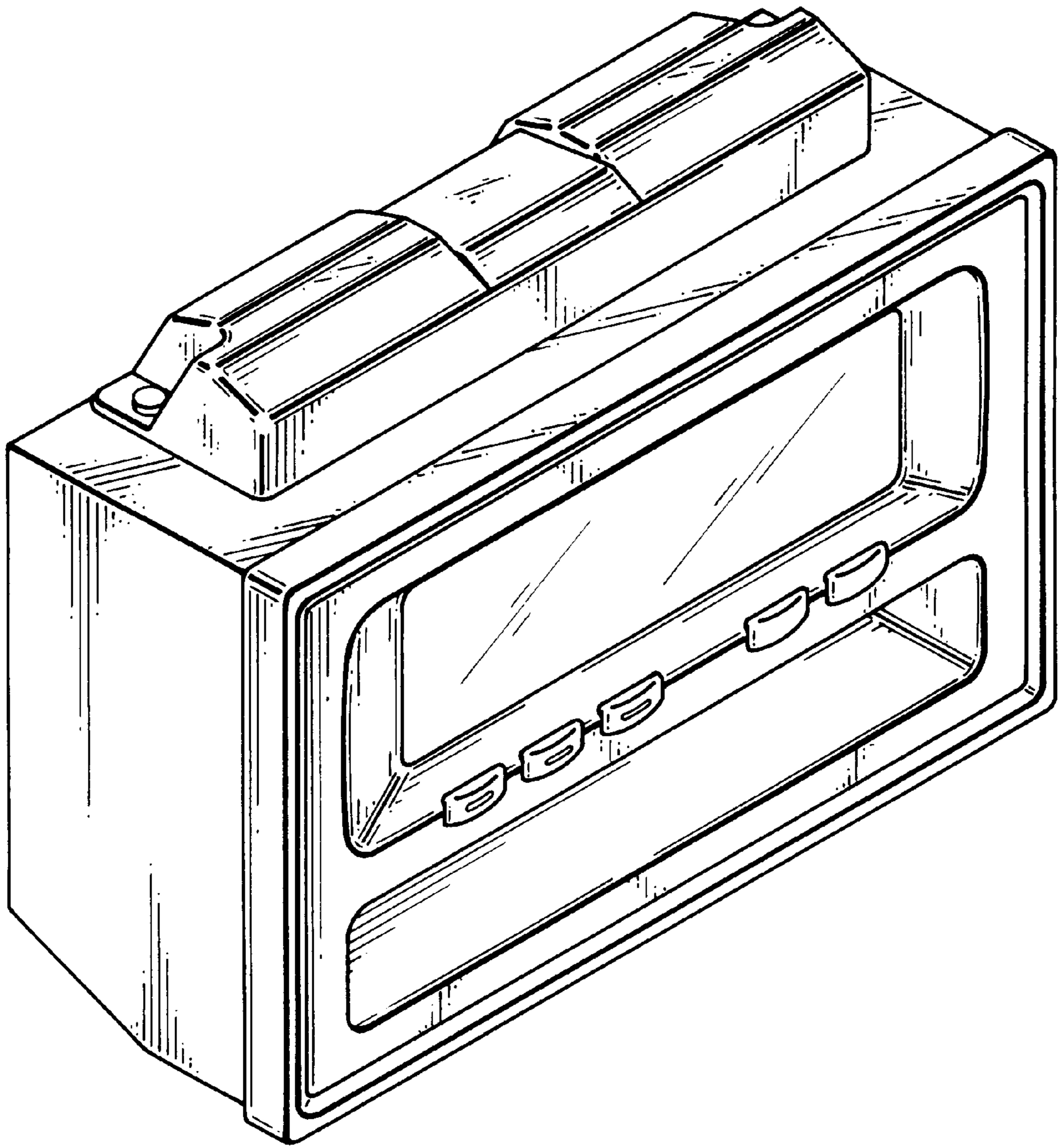
