The ornamental design for a pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of a pen showing my new design;  
FIG. 2 is a right side elevational view;  
FIG. 3 is a front elevational view;  
FIG. 4 is a left side elevational view;  
FIG. 5 is a side view of the pen without cap;  
FIG. 6 is a front view of the pen without cap;  
FIG. 7 is a bottom plan view; and,  
FIG. 8 is a top plan view thereof.
