DESCRIPTION

FIG. 3 is a left side elevation view of the canopy of Applicants' invention.

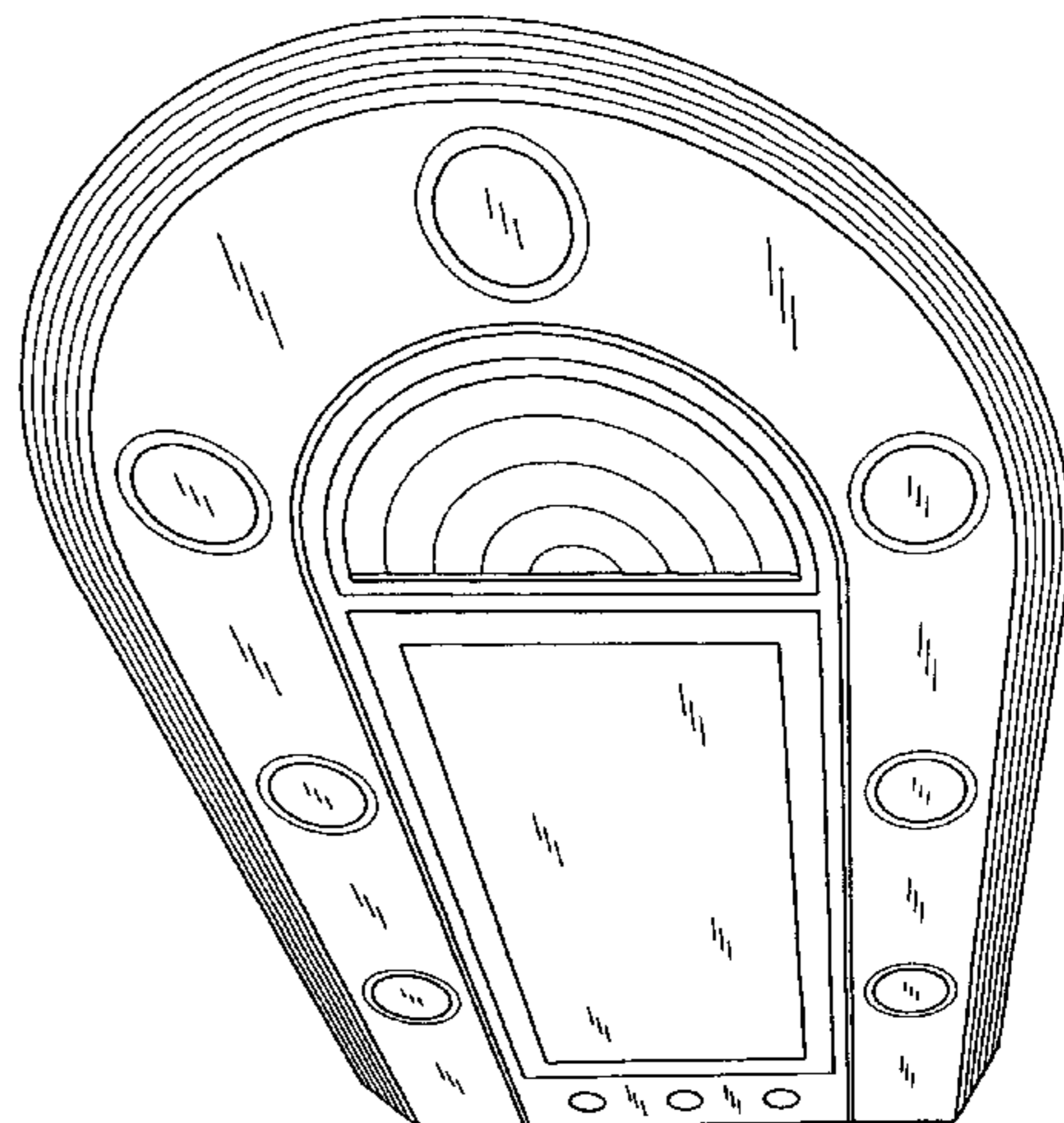
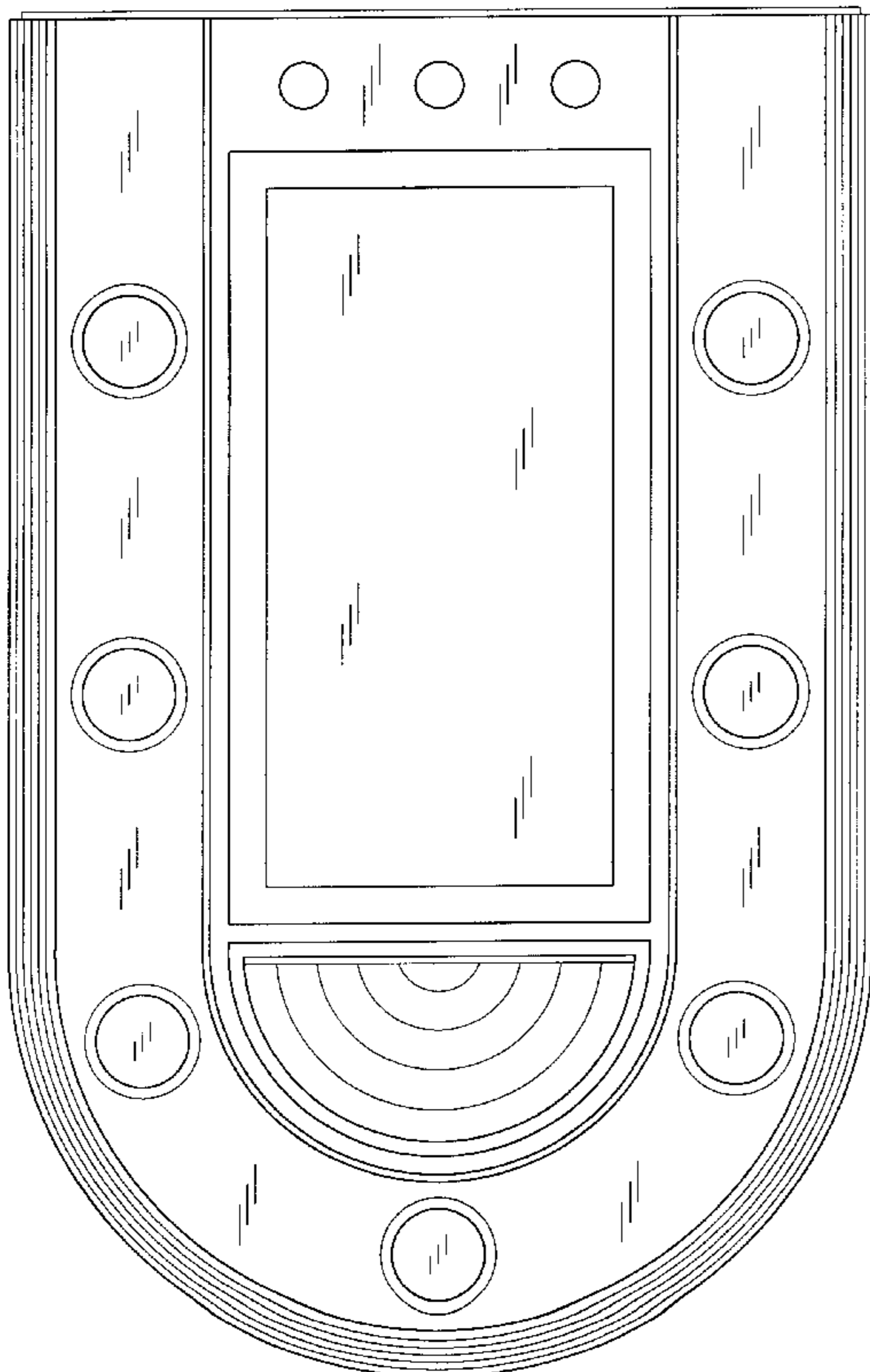
FIG. 4 is a front end elevation view of the canopy of Applicants' invention.

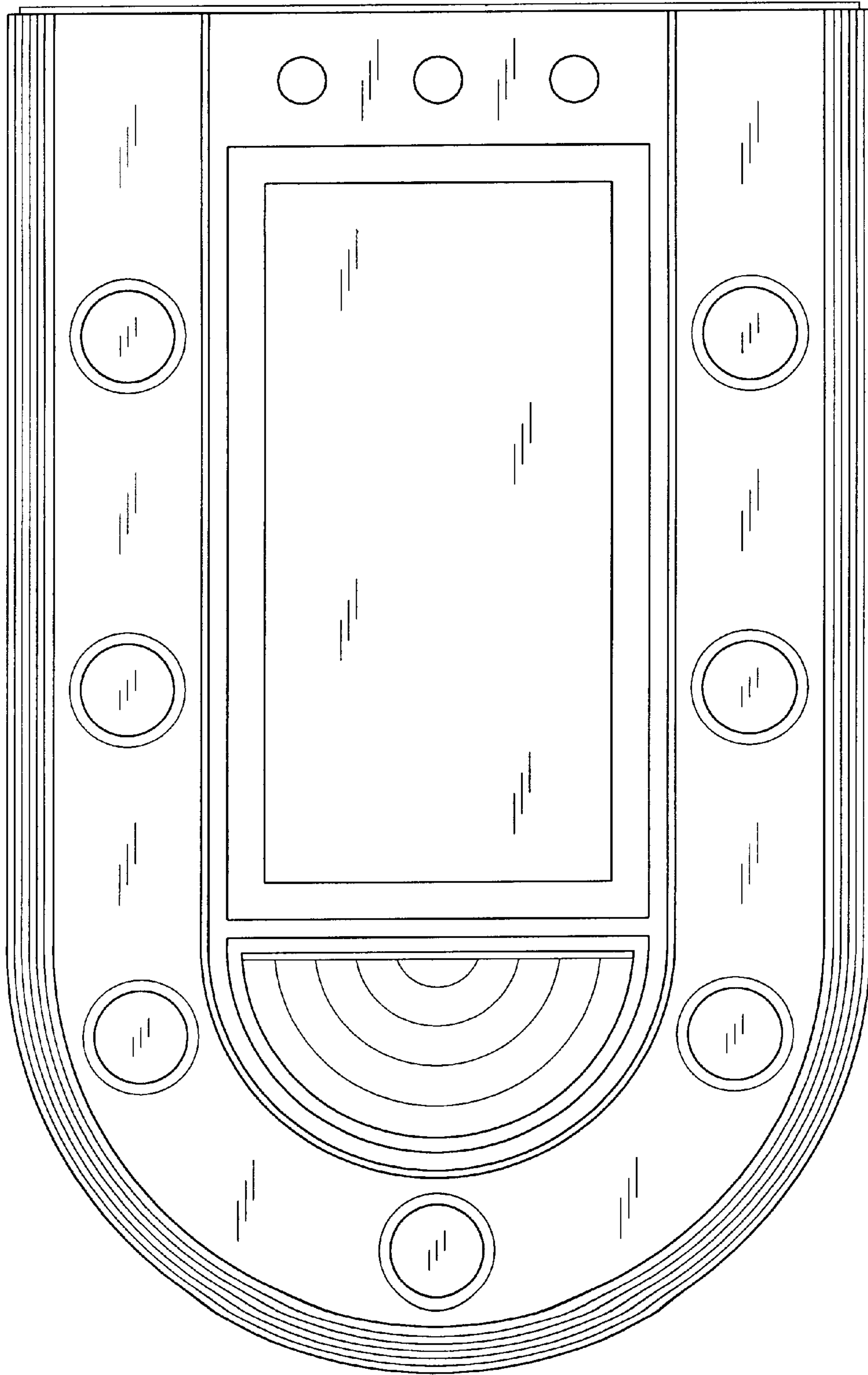

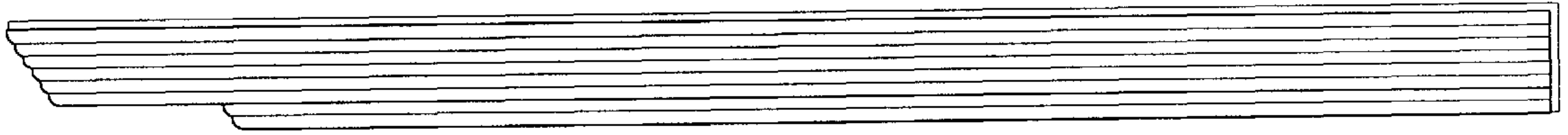

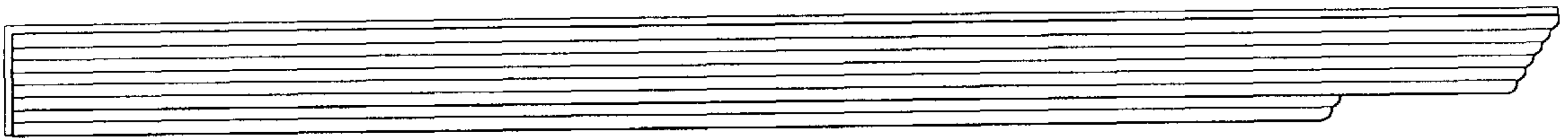

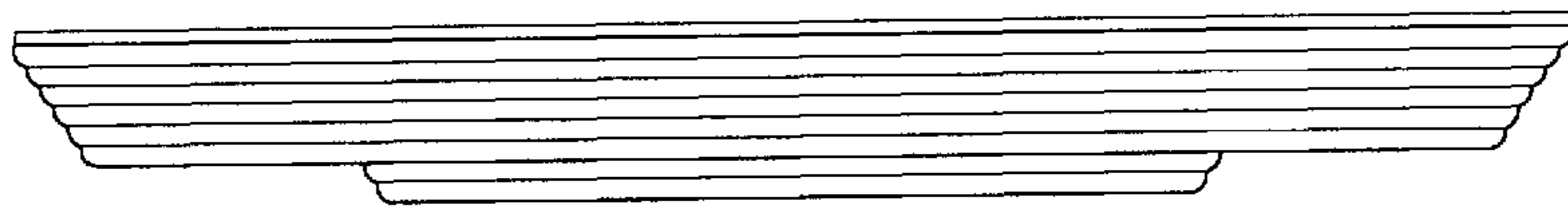

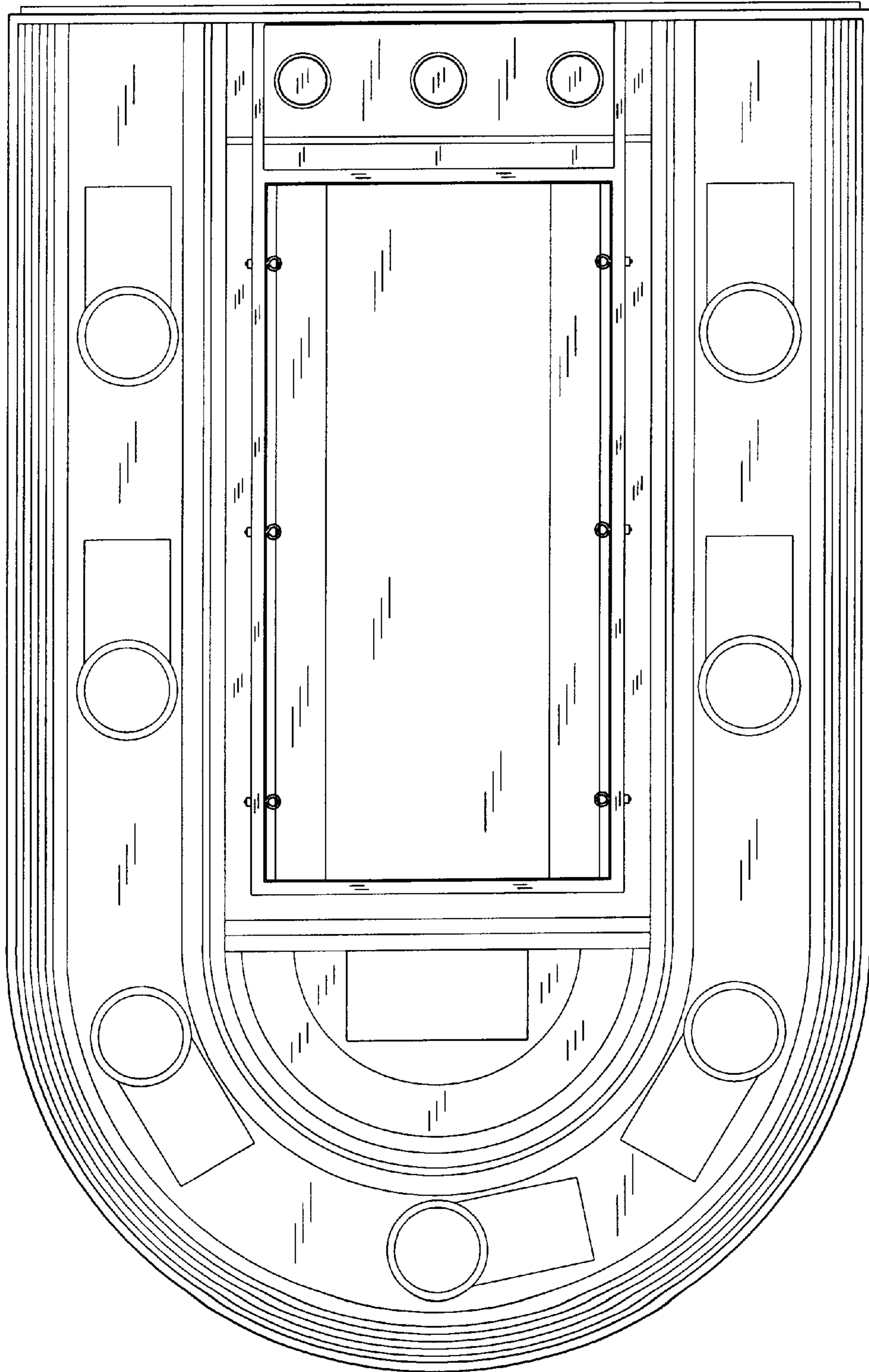

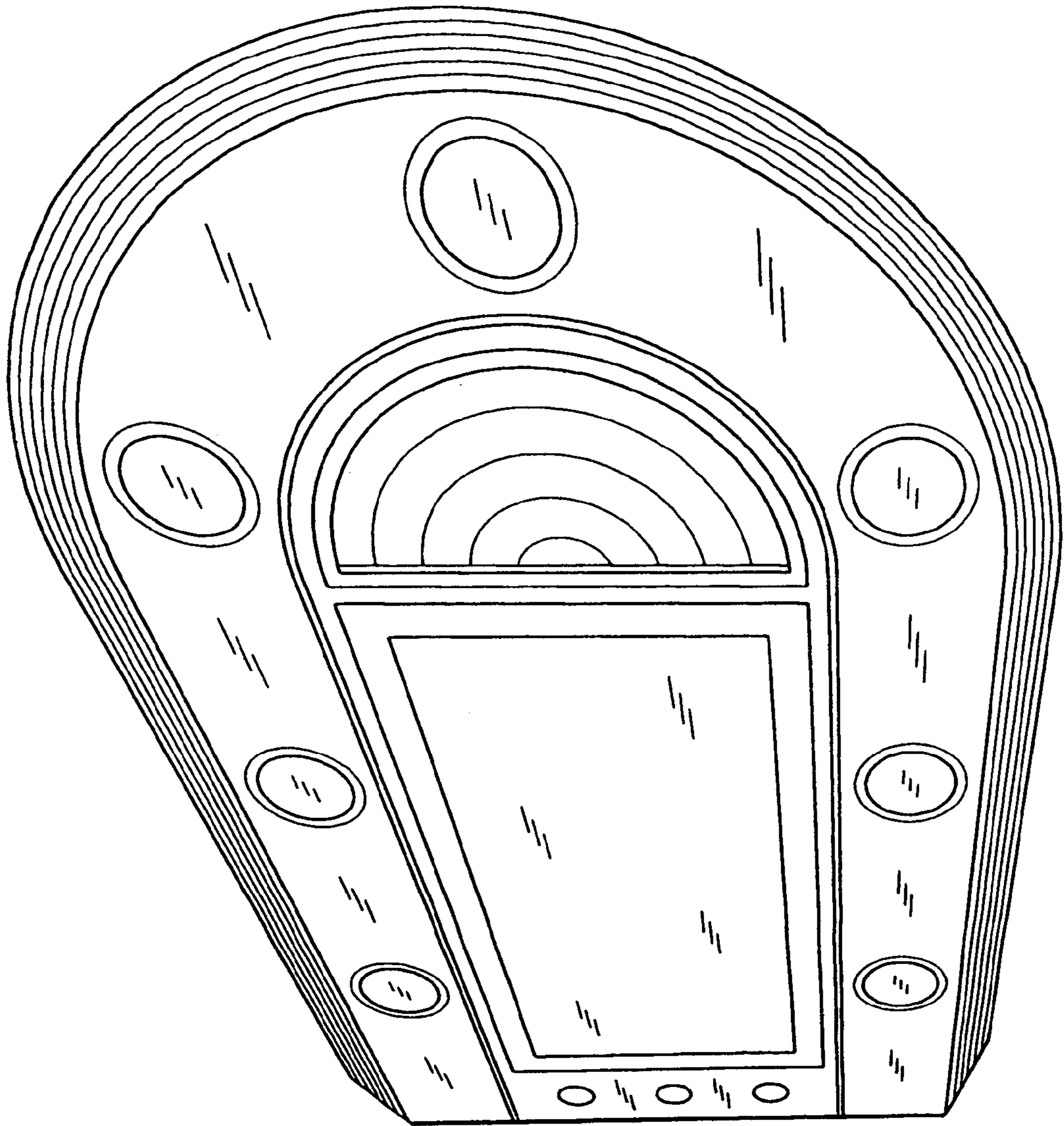
