**DESCRIPTION**

FIG. 1 is a left front perspective view of a seat showing my new design;

FIG. 6 is a right rear perspective view thereof;

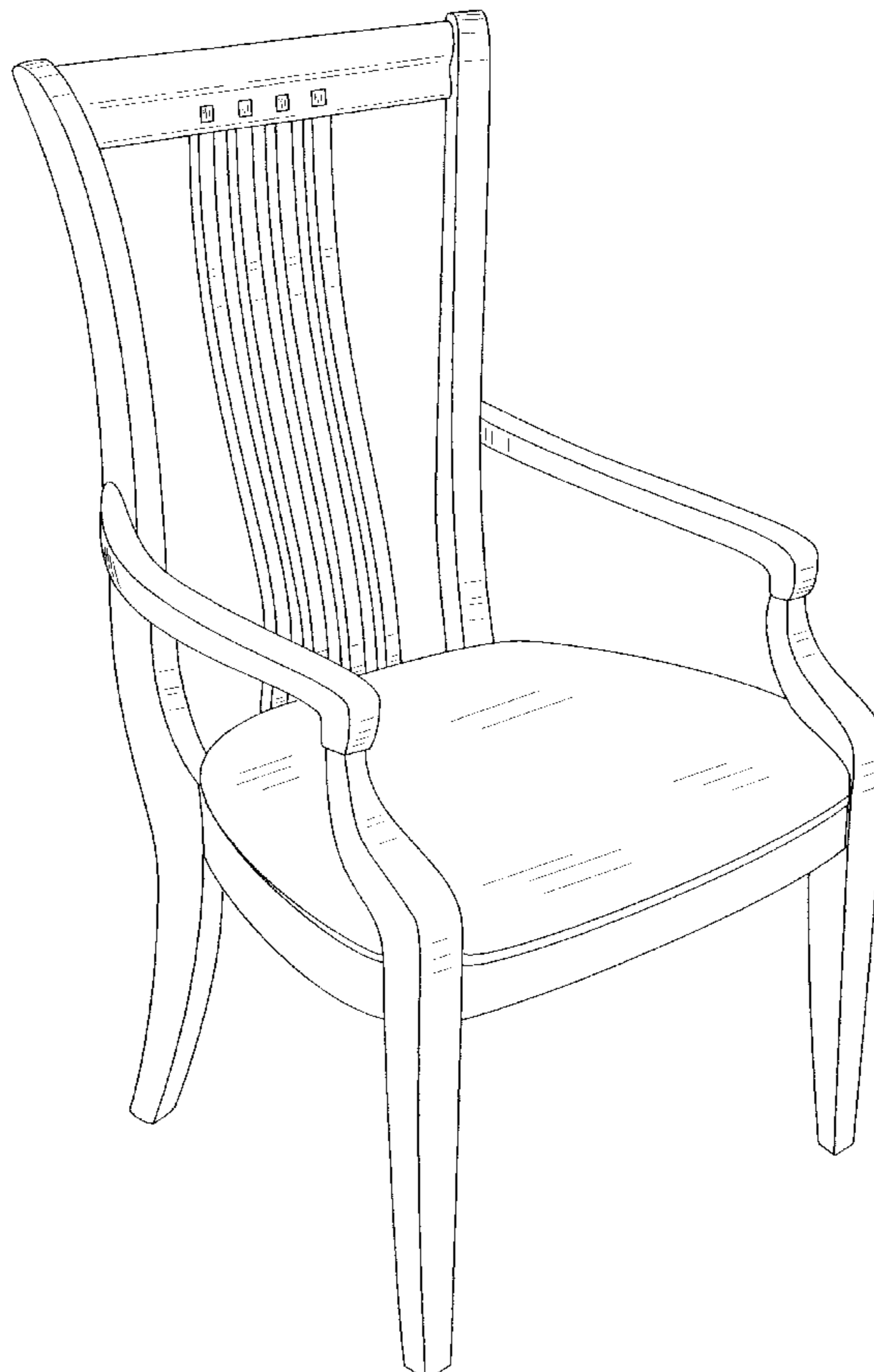
FIG. 7 is a left front perspective view of an alternate embodiment of my new design;

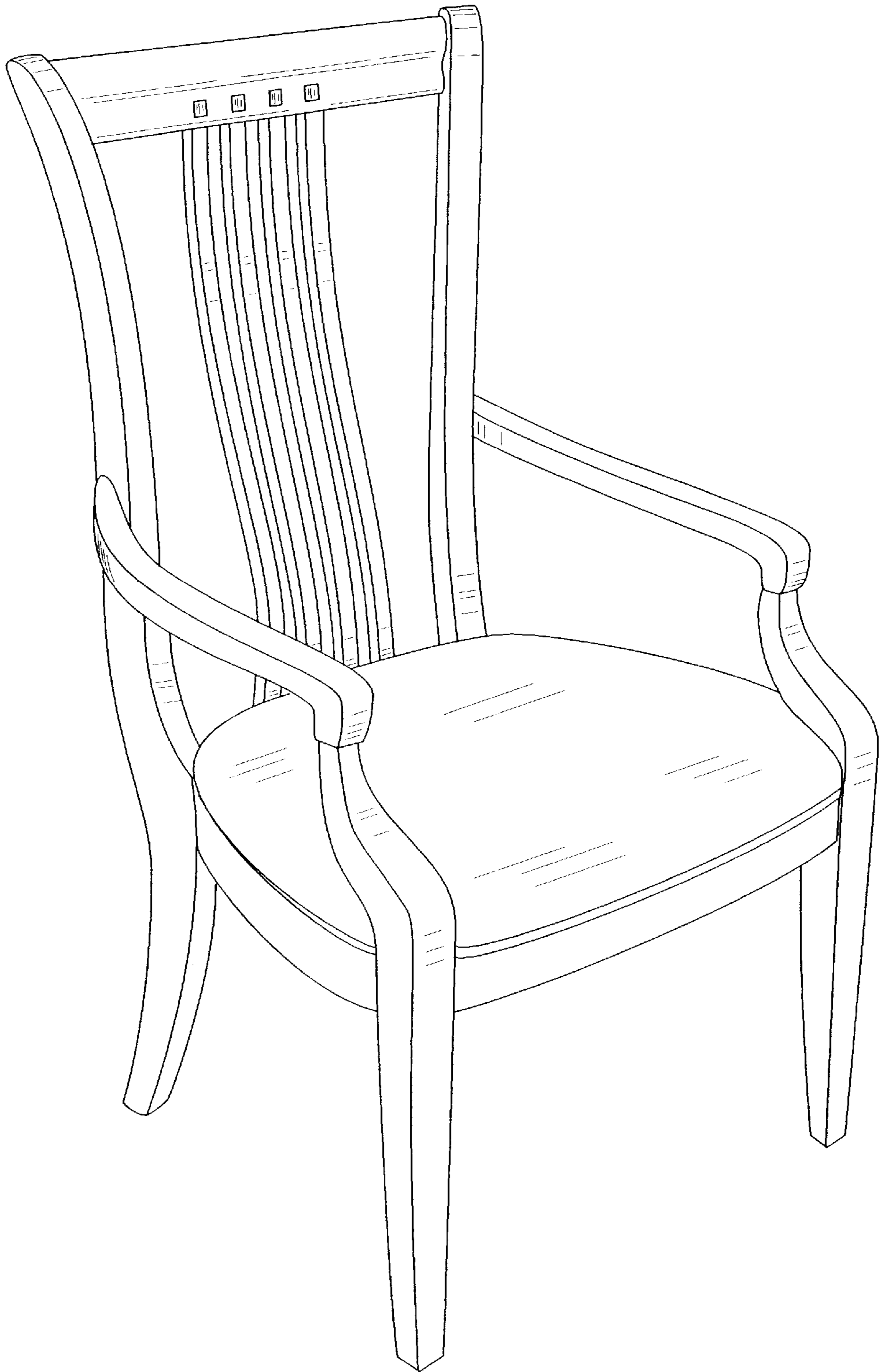

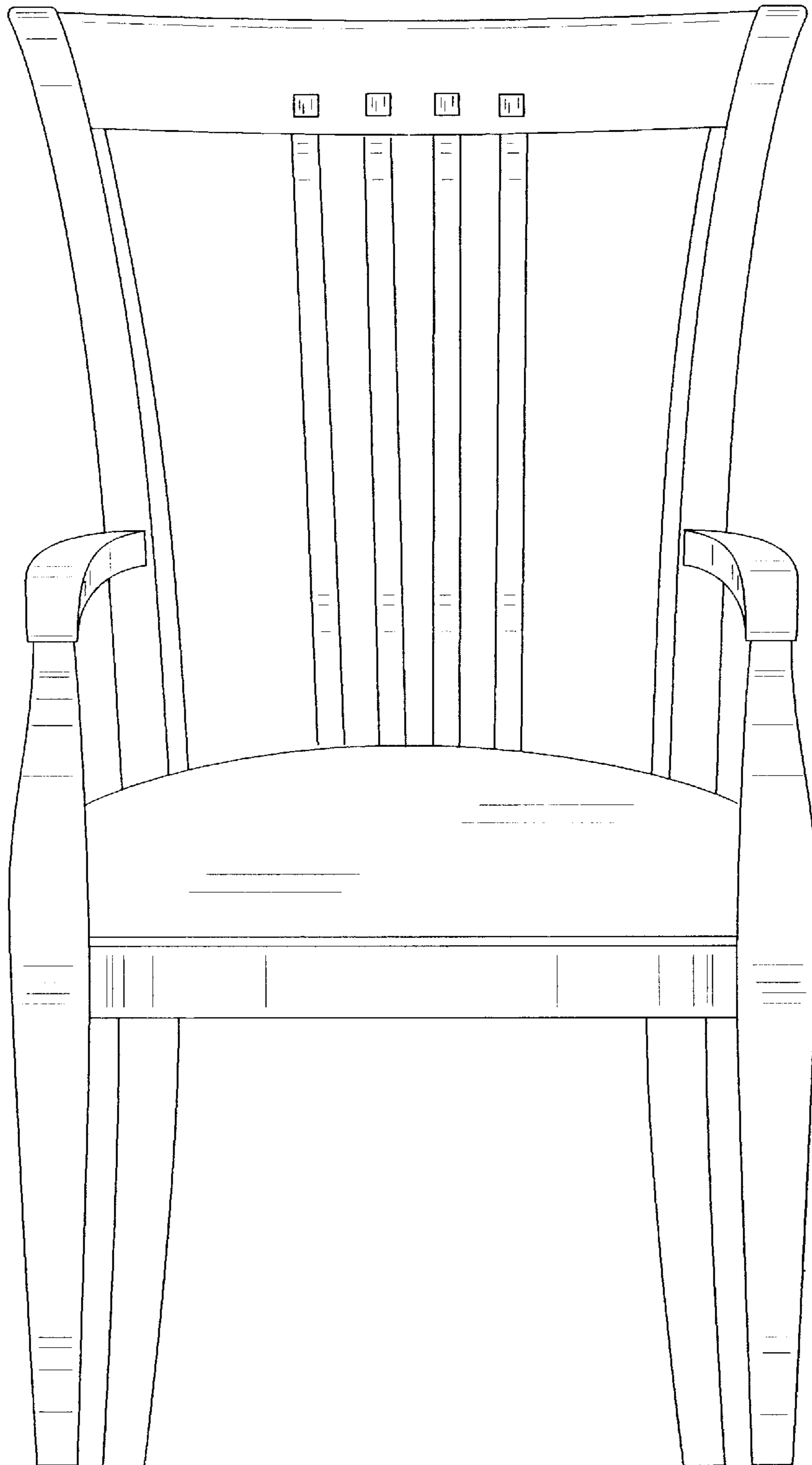

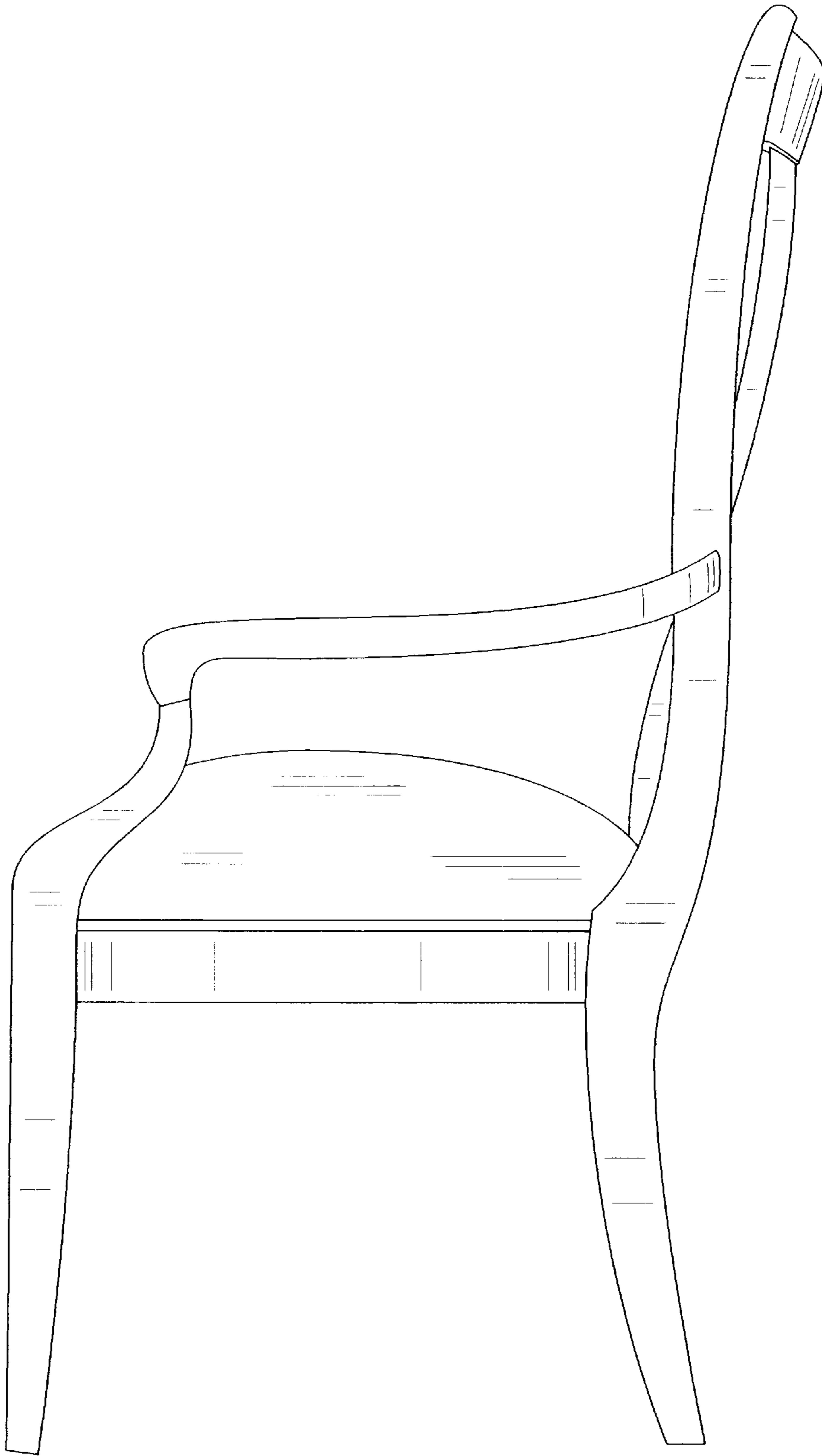

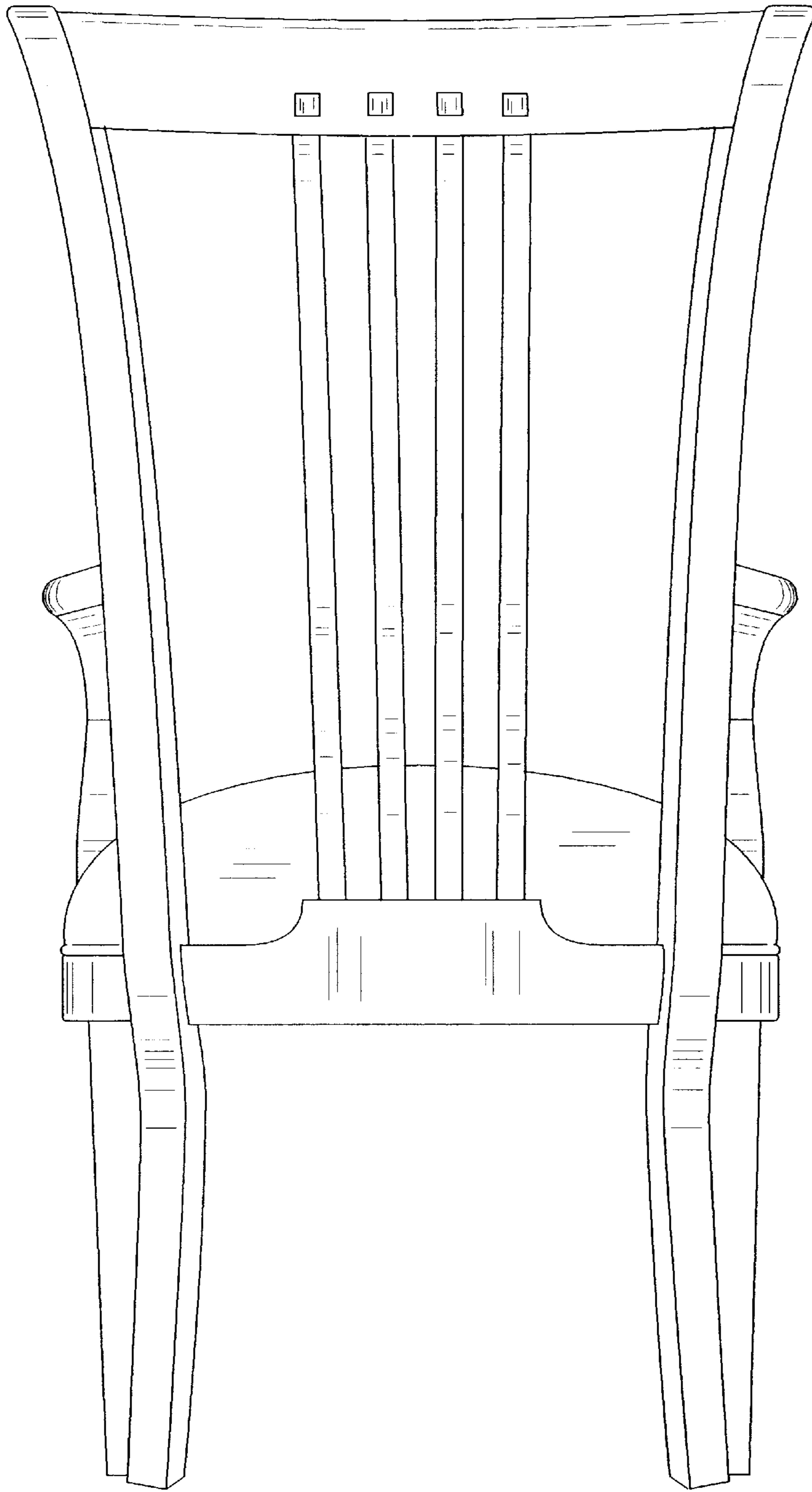

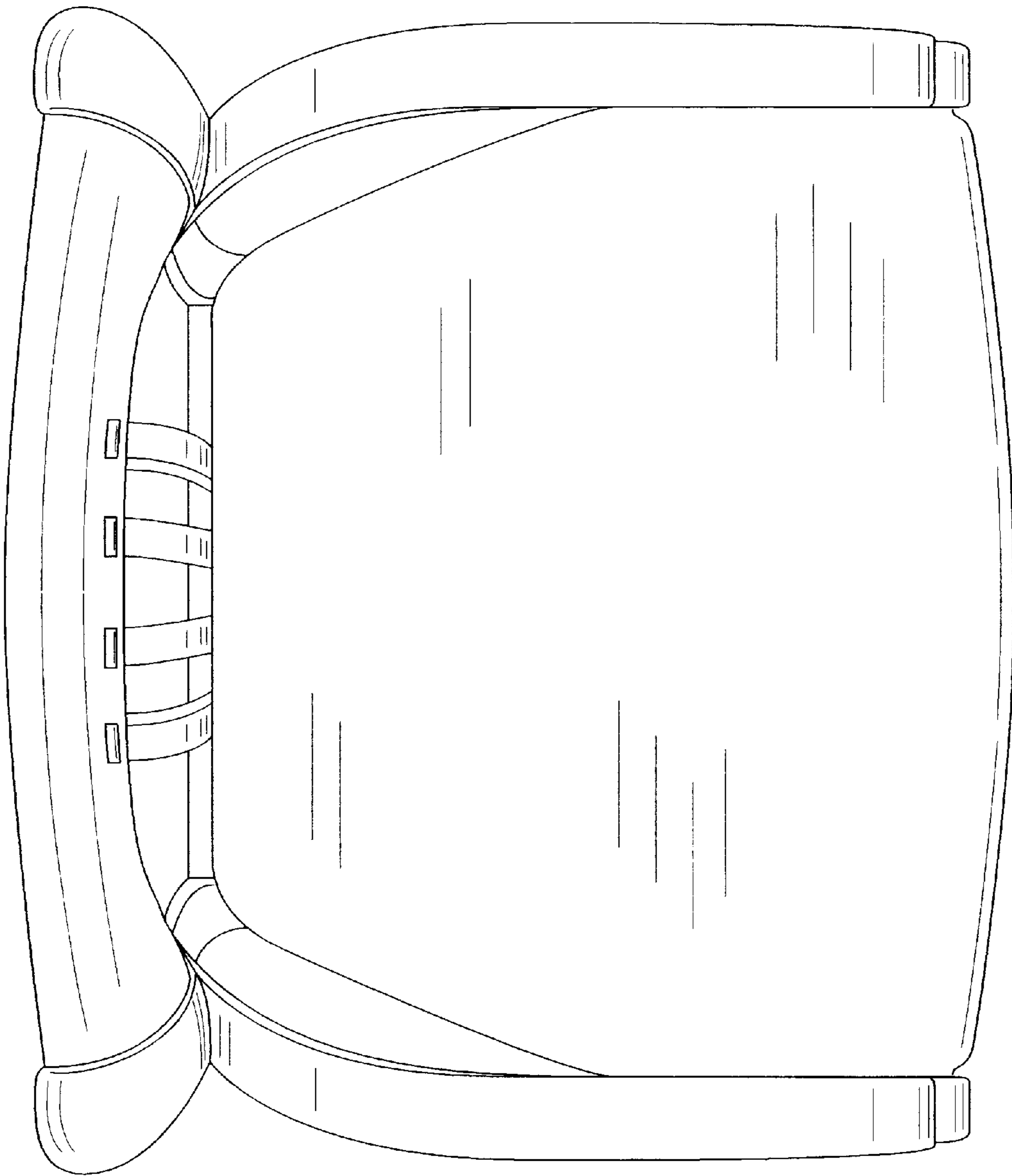

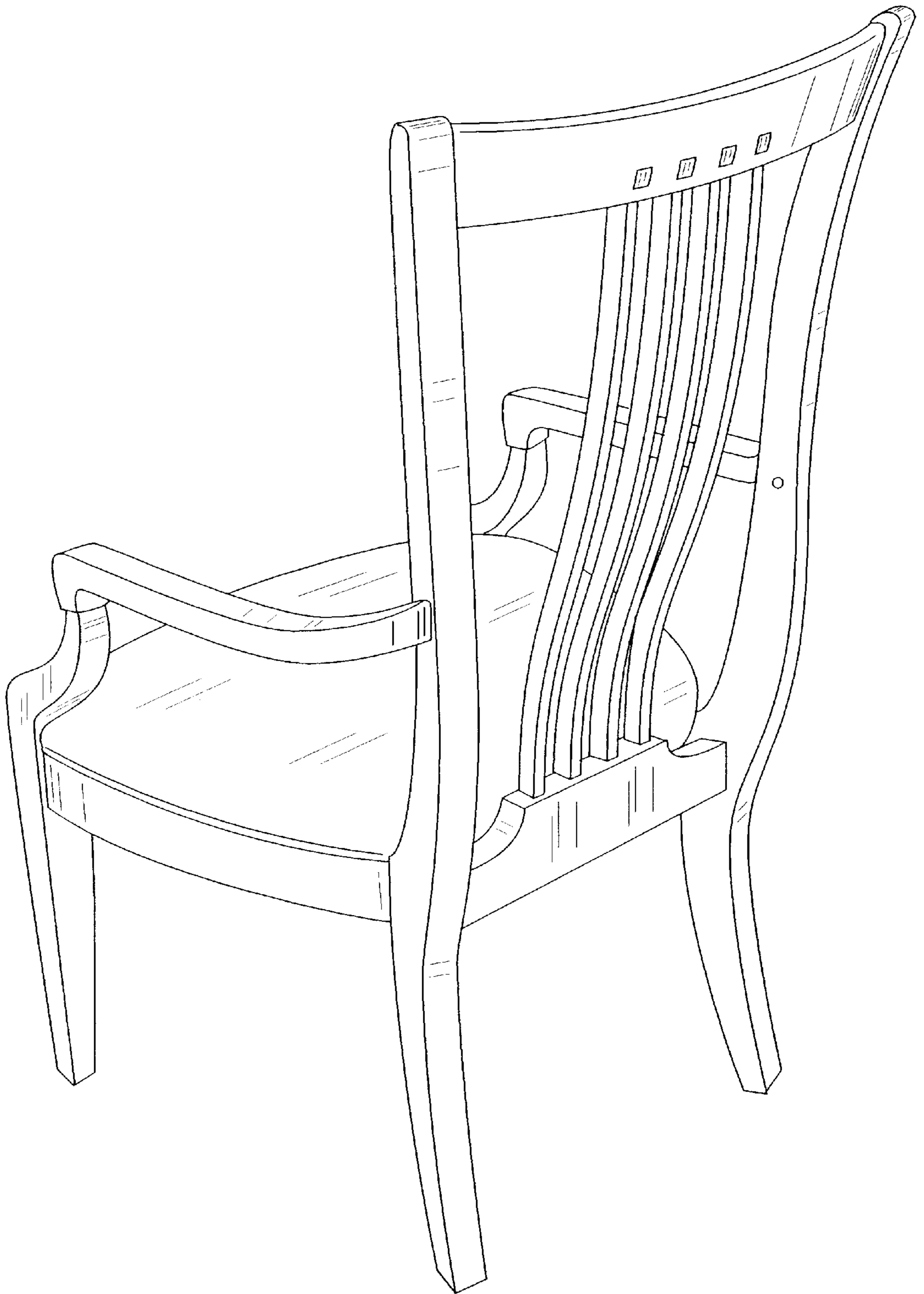

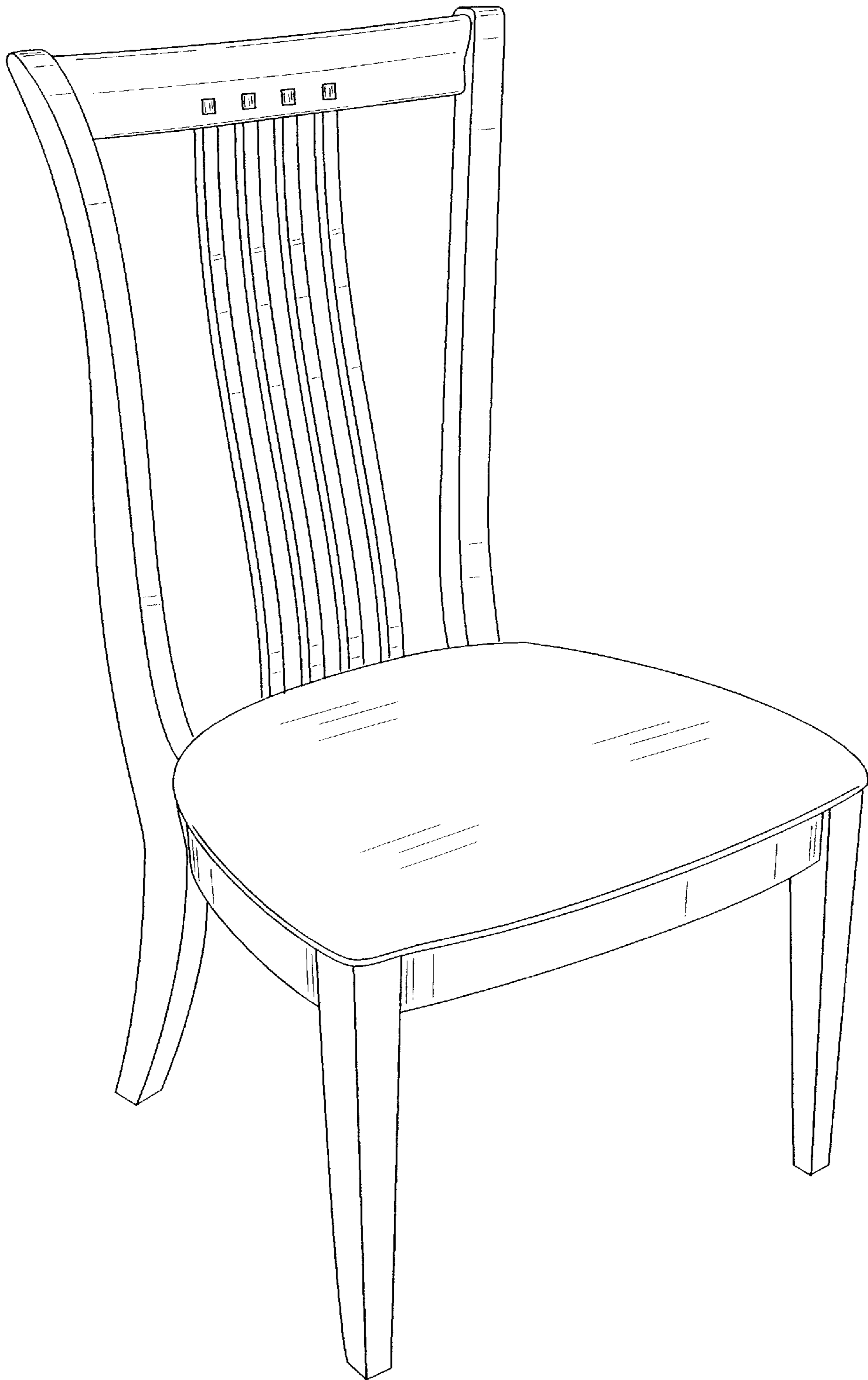

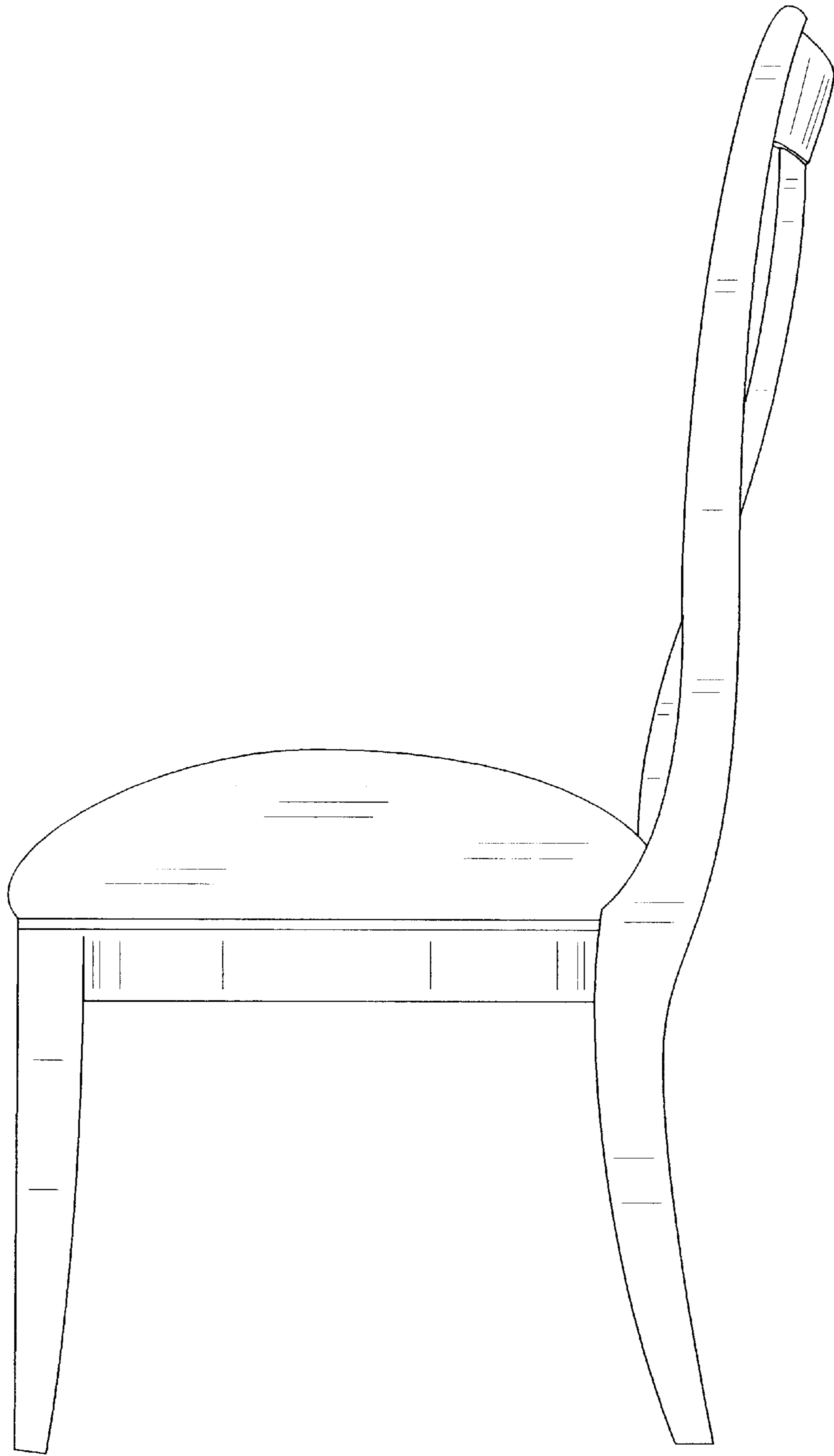

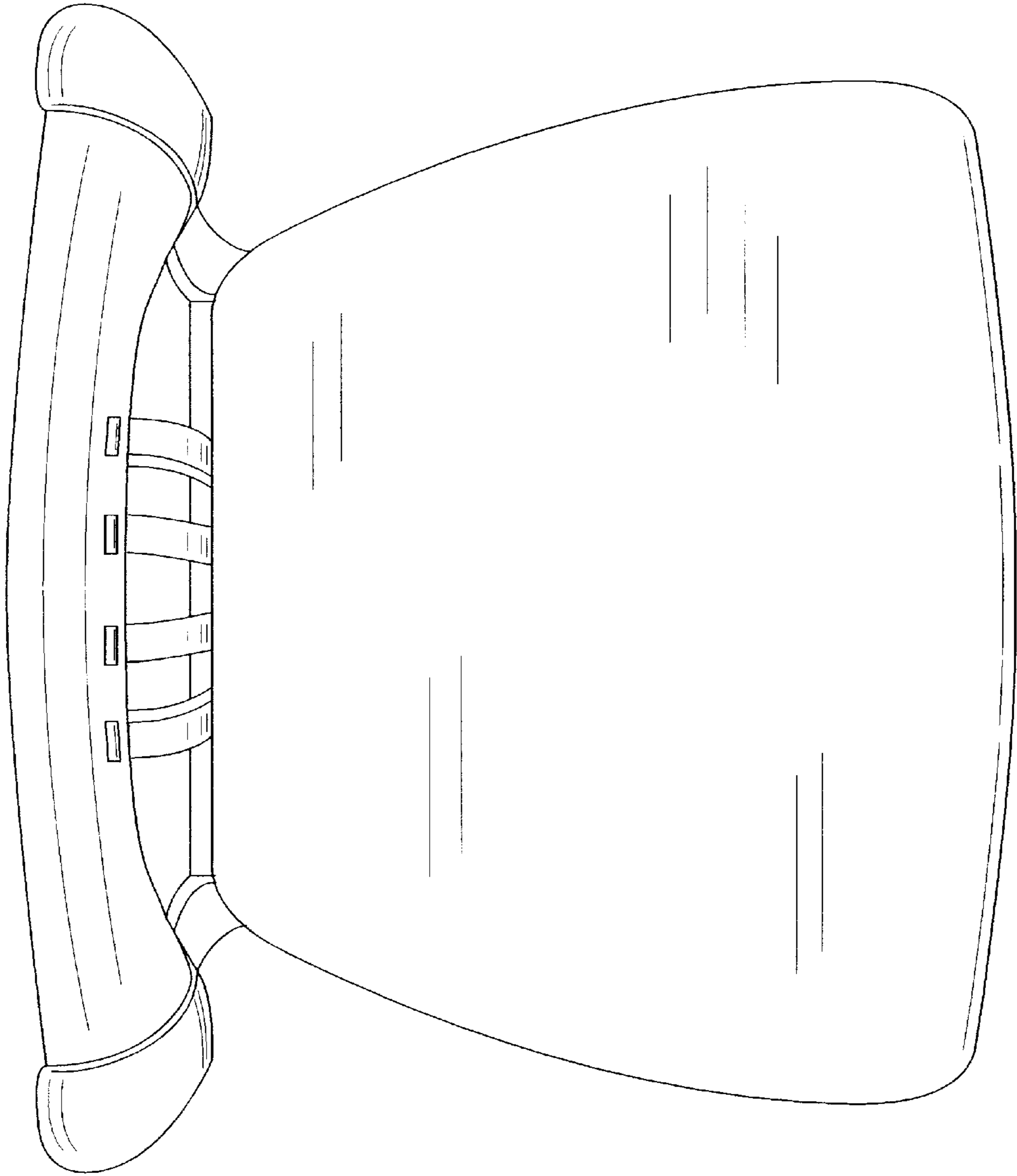
