FIG. 3 is a front elevation view of the seating product.

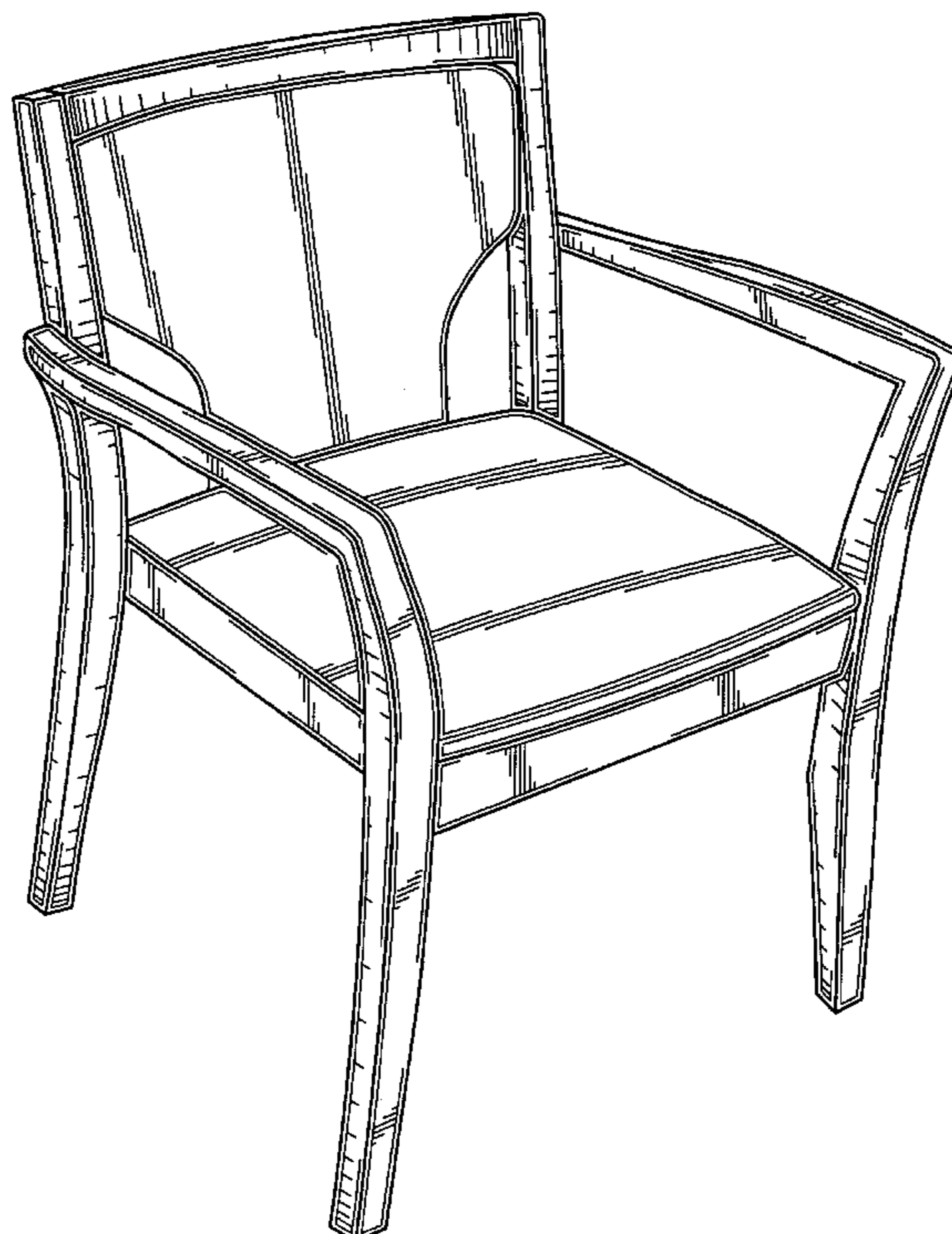
FIG. 4 is a left elevation view of the seating product.

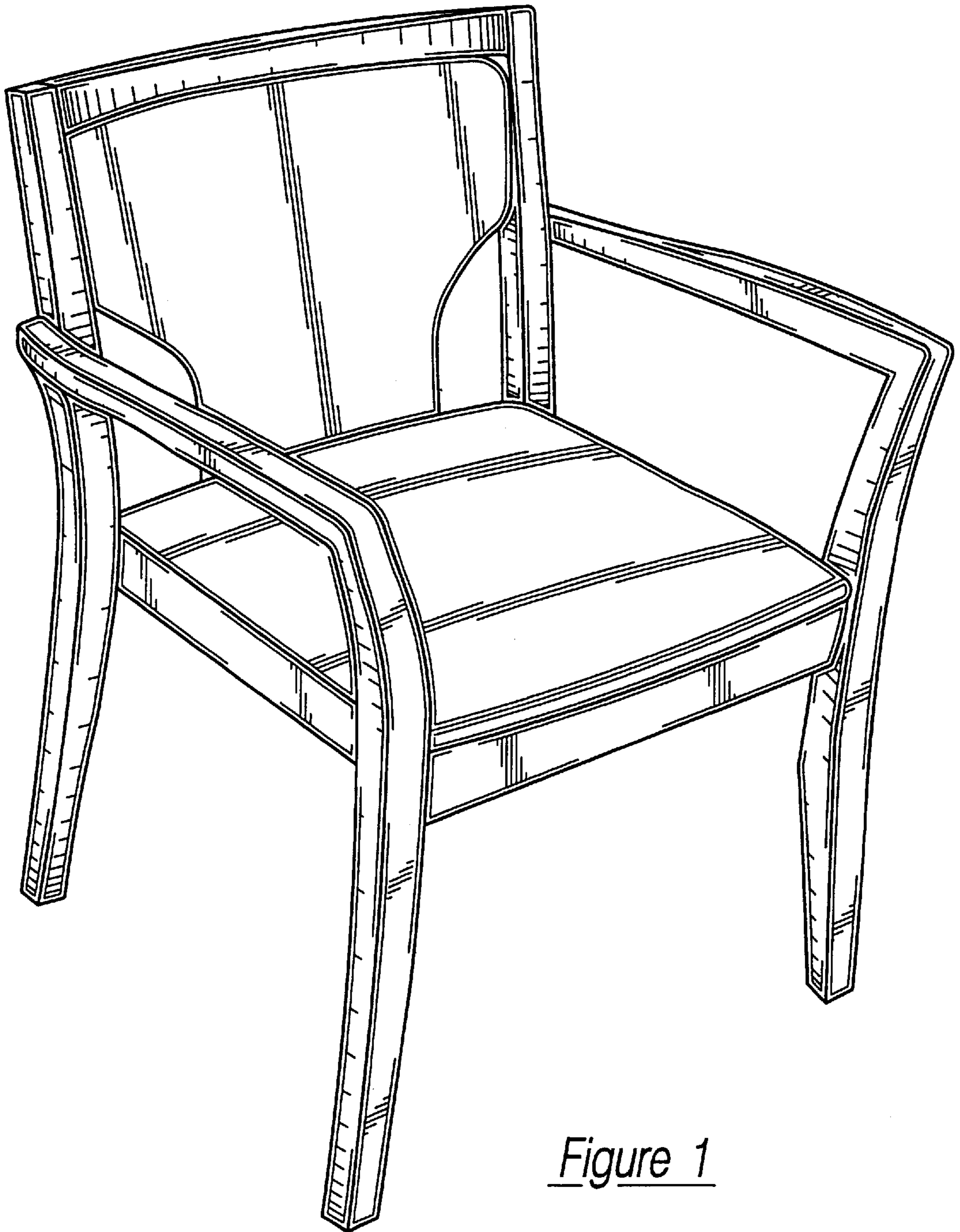

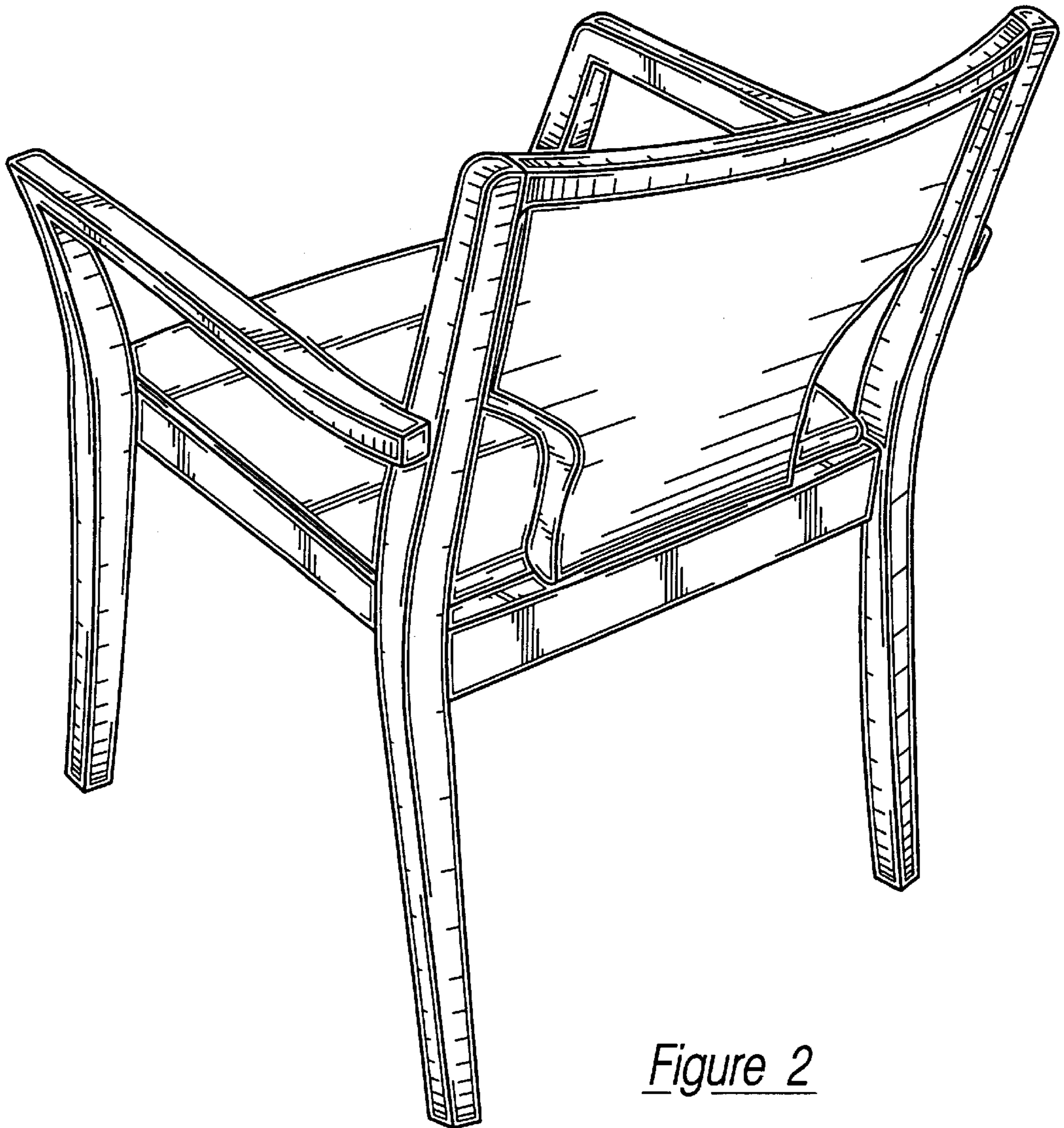

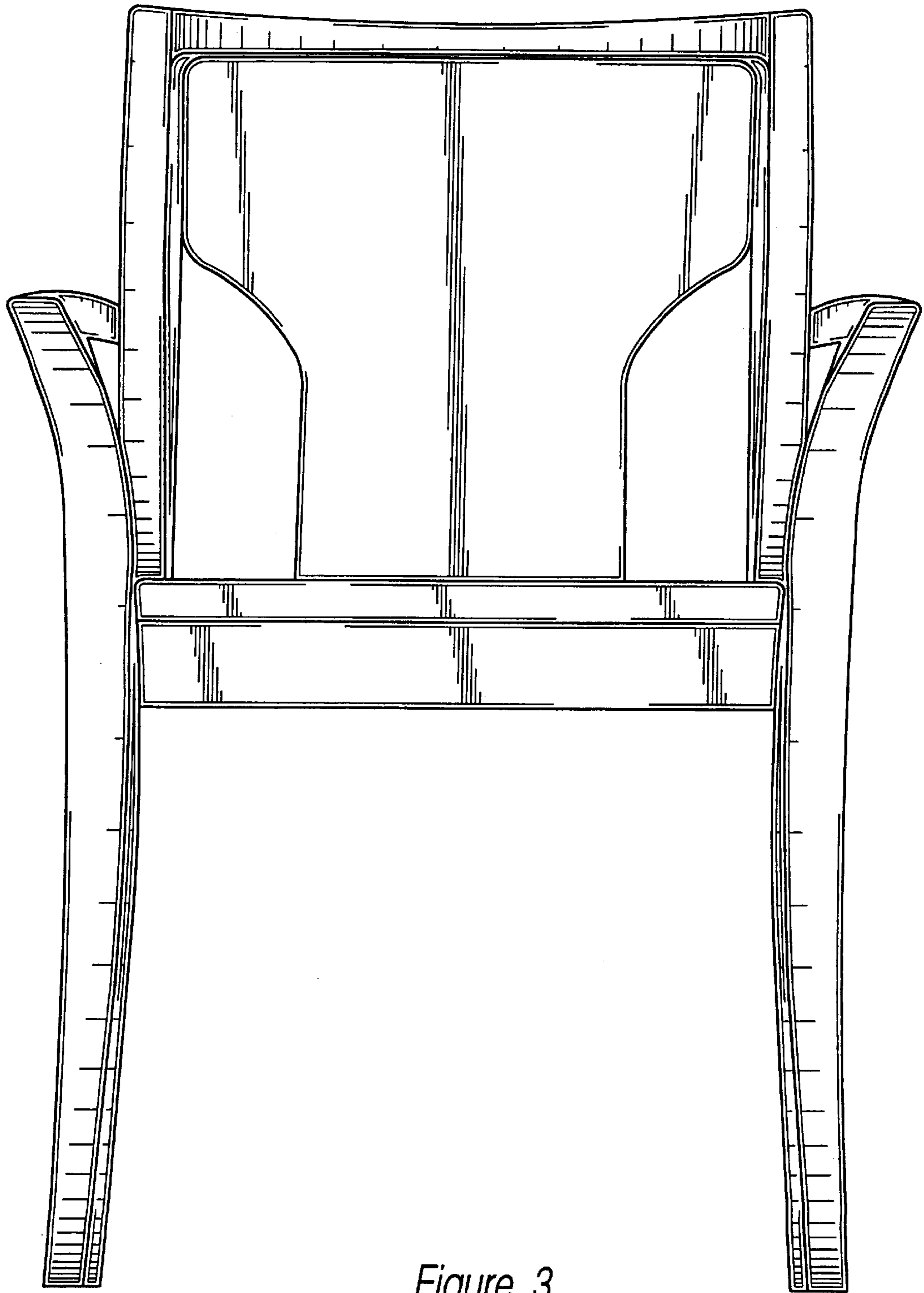

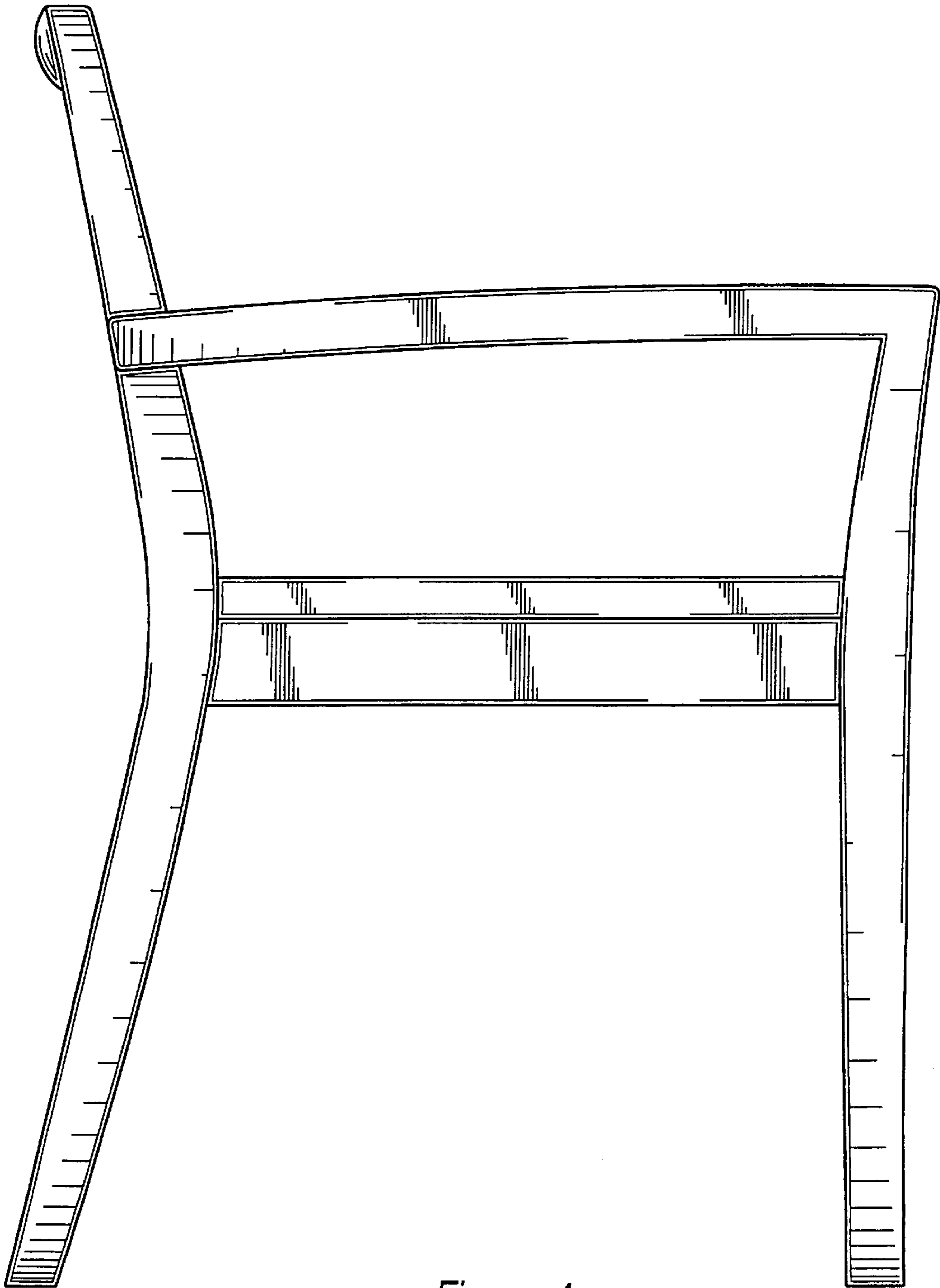

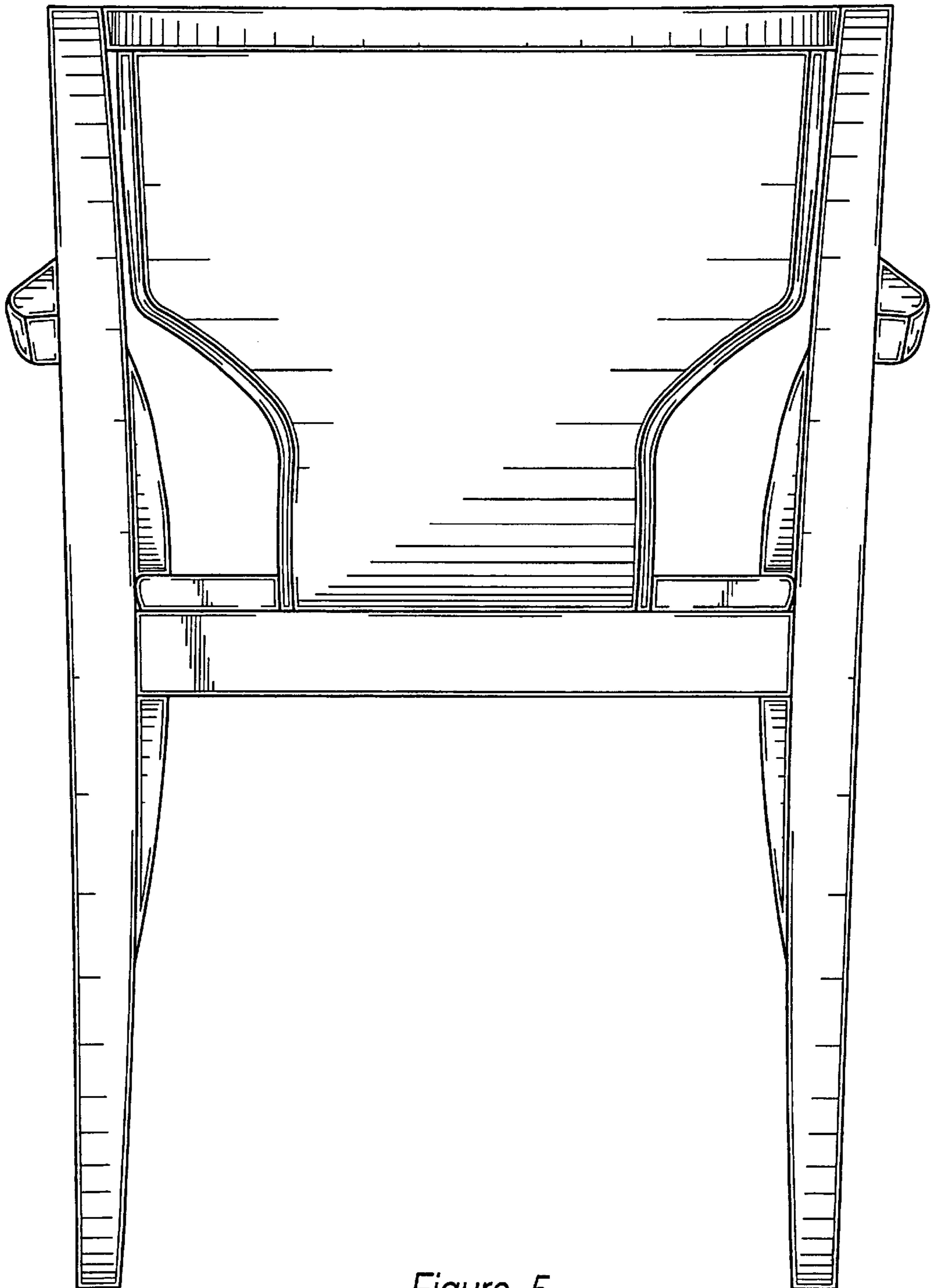

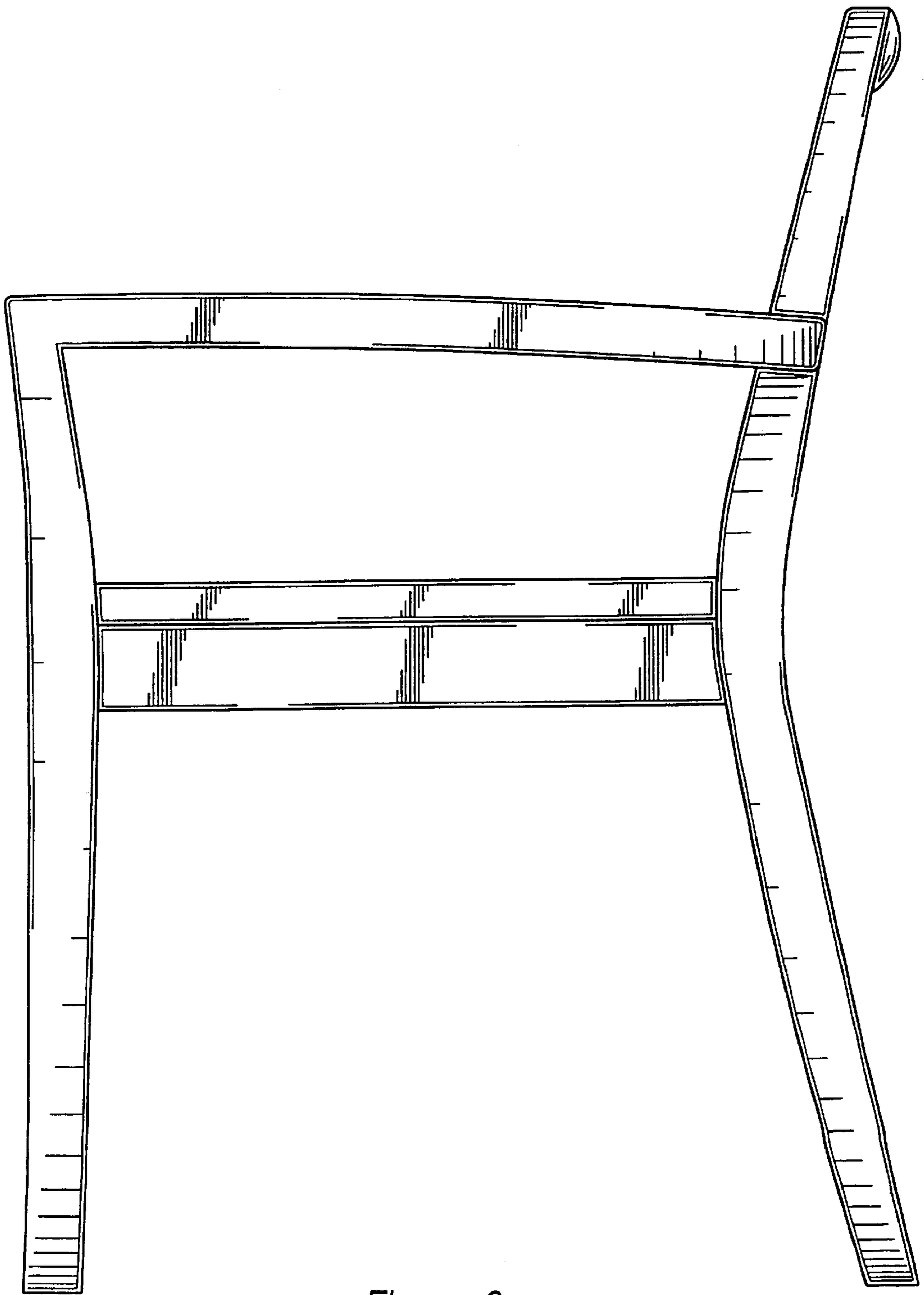

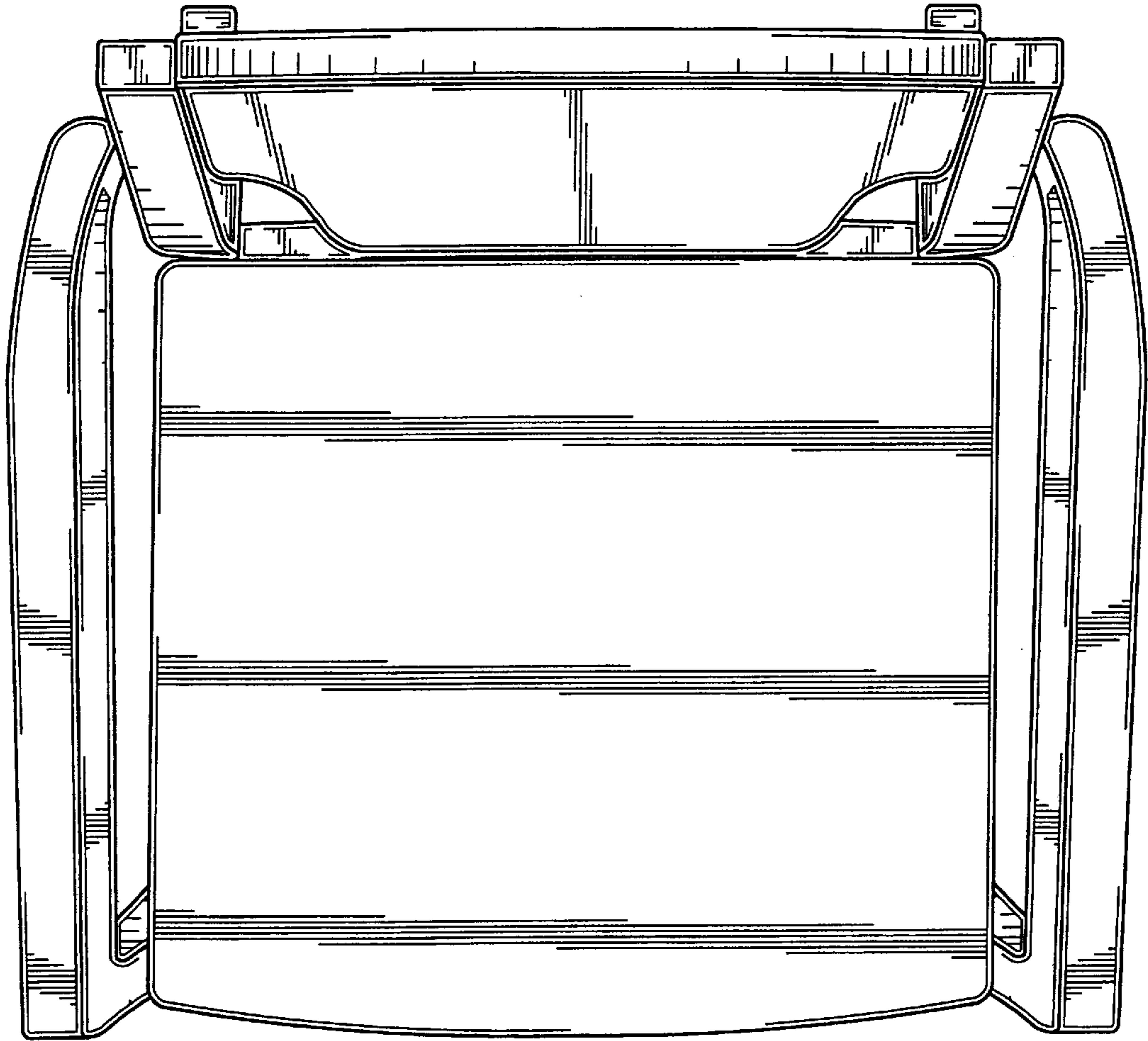
