FIG. 20 is a top view thereof;

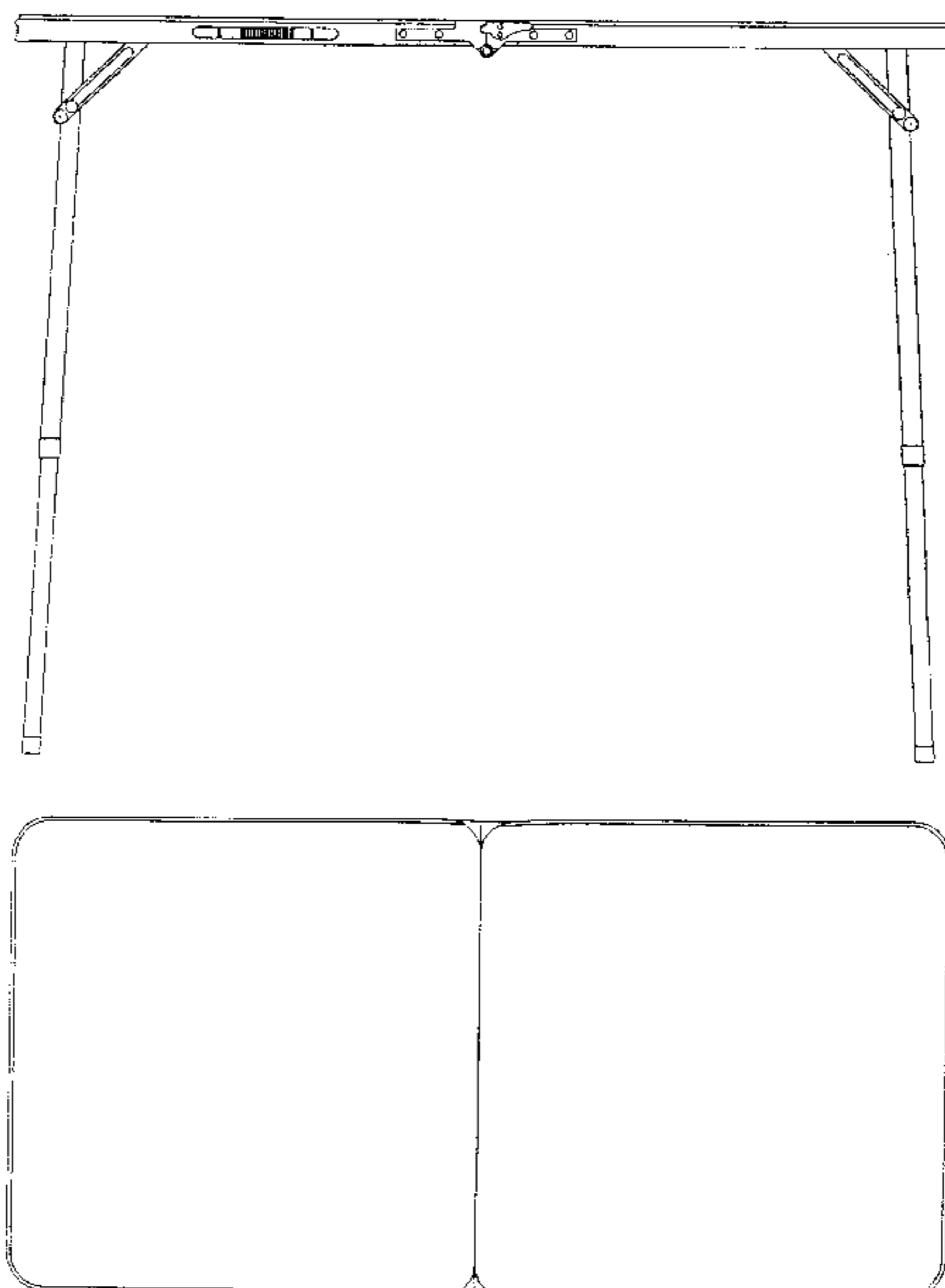
FIG. 21 is a left side view thereof;

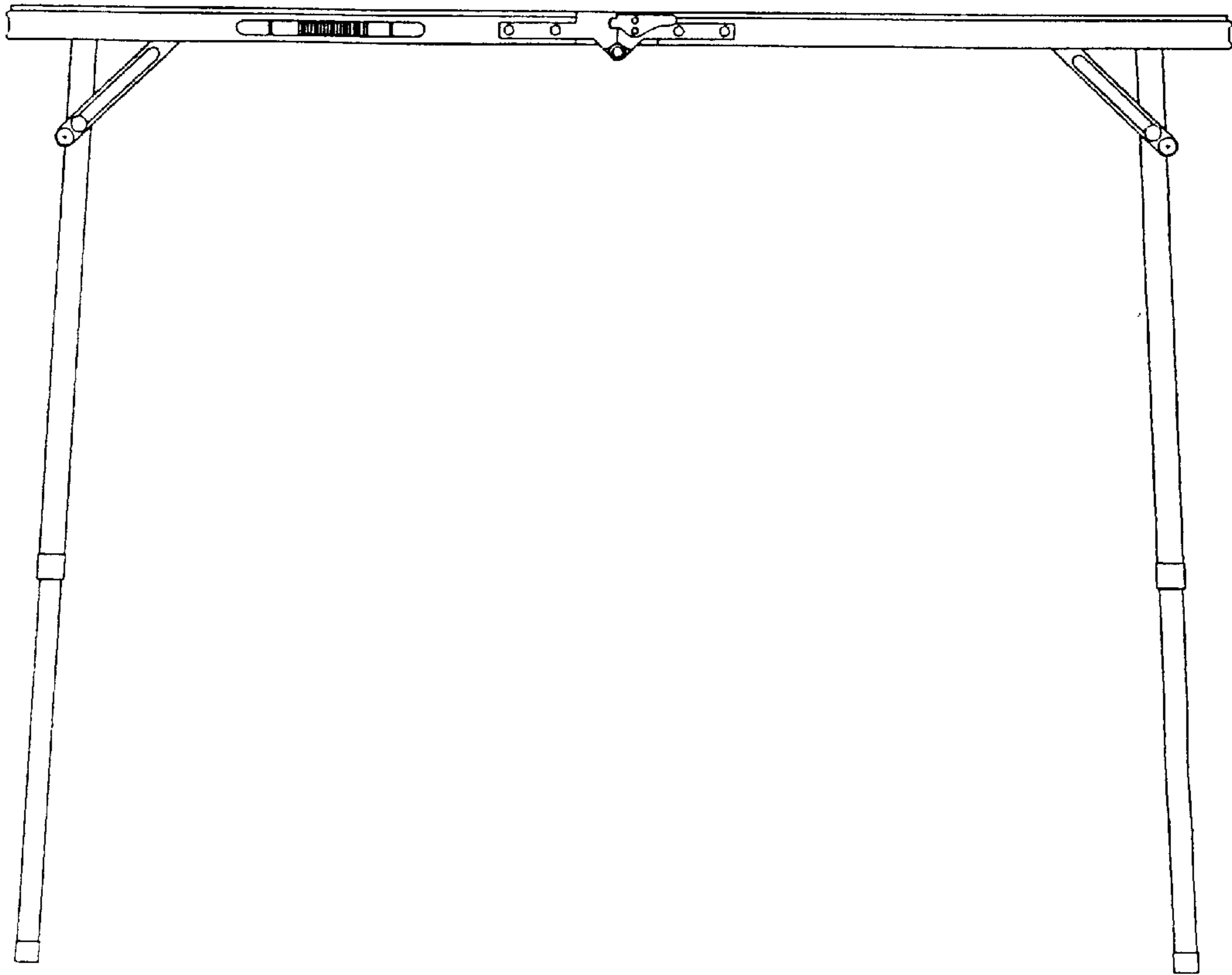

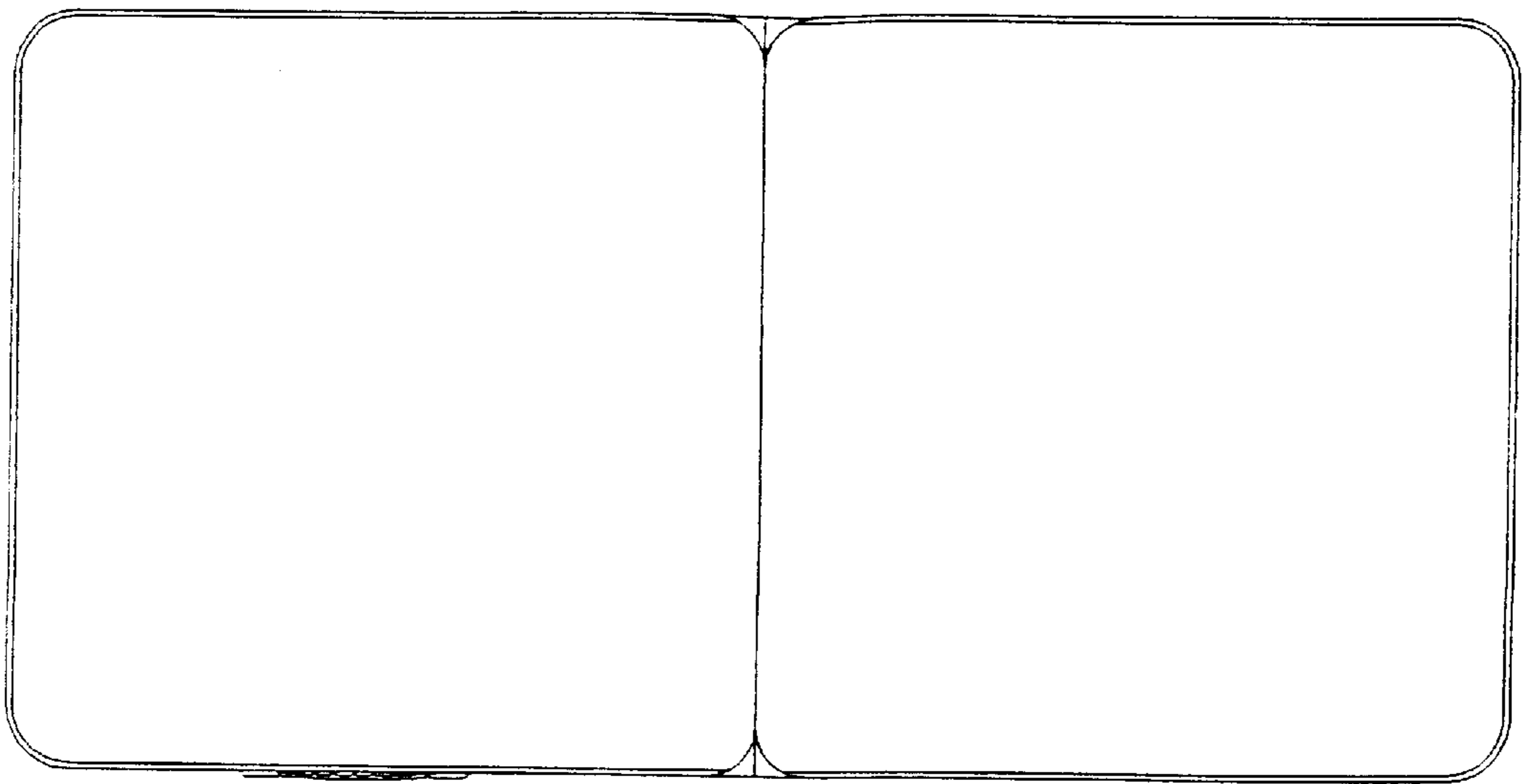

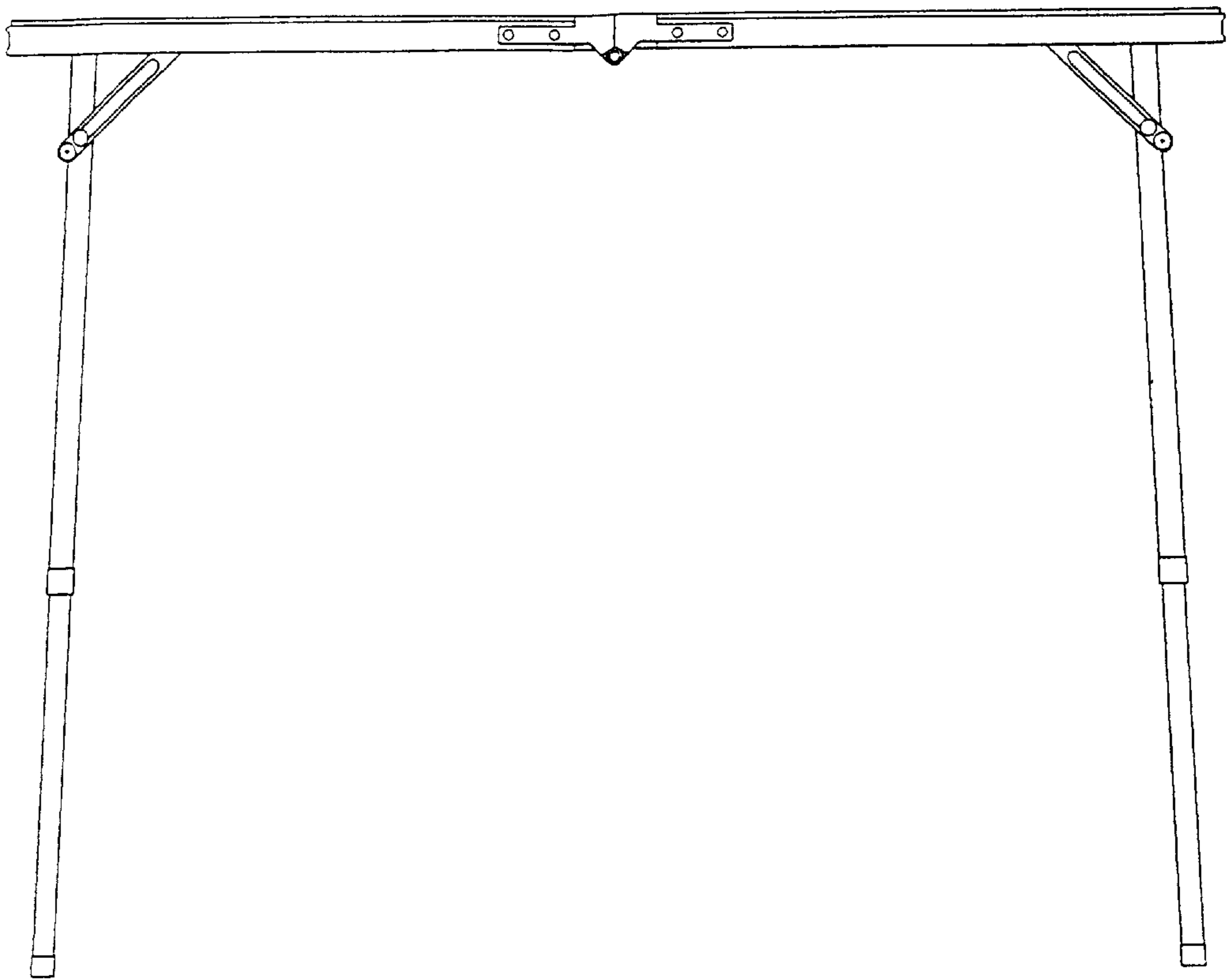

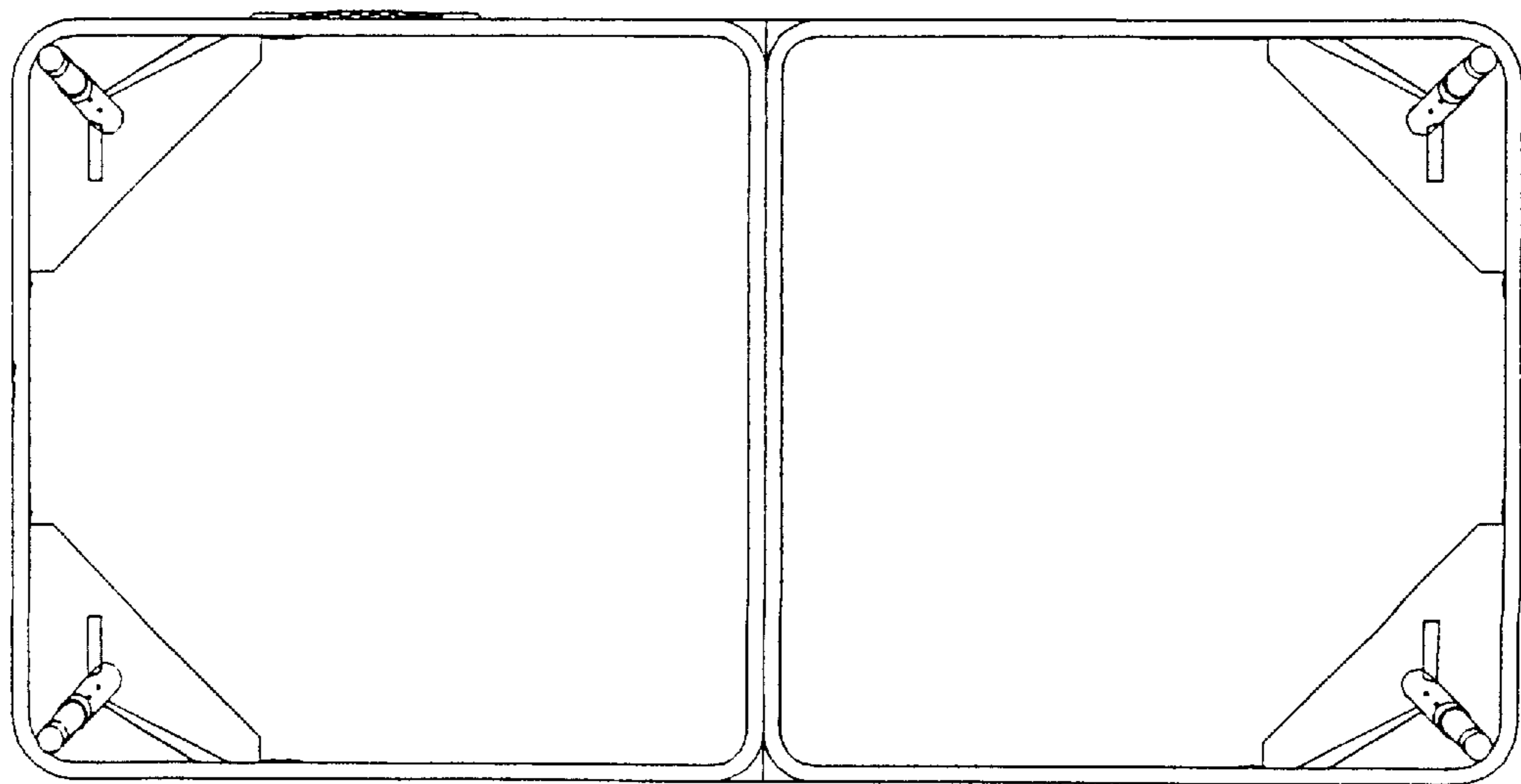

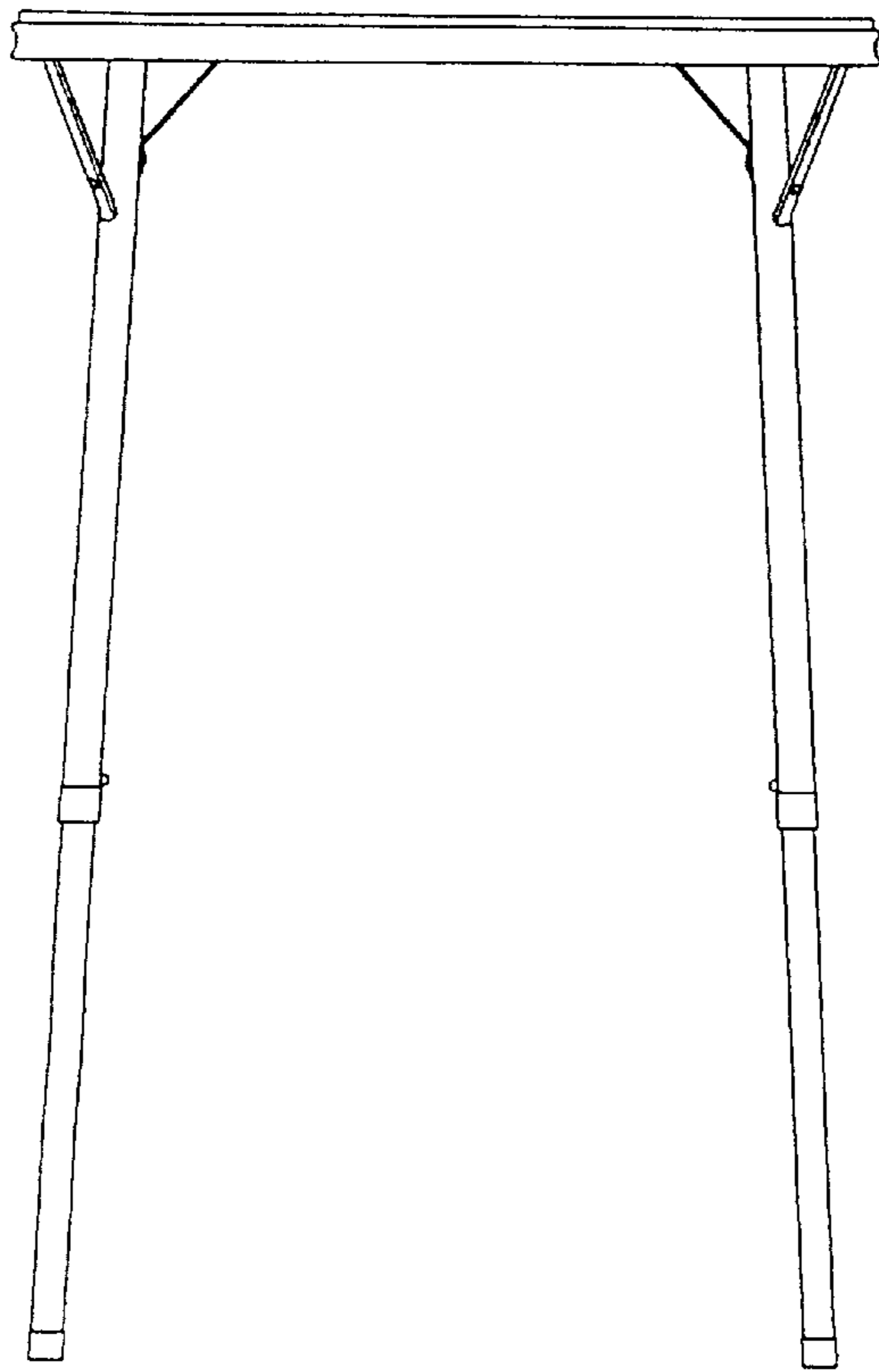

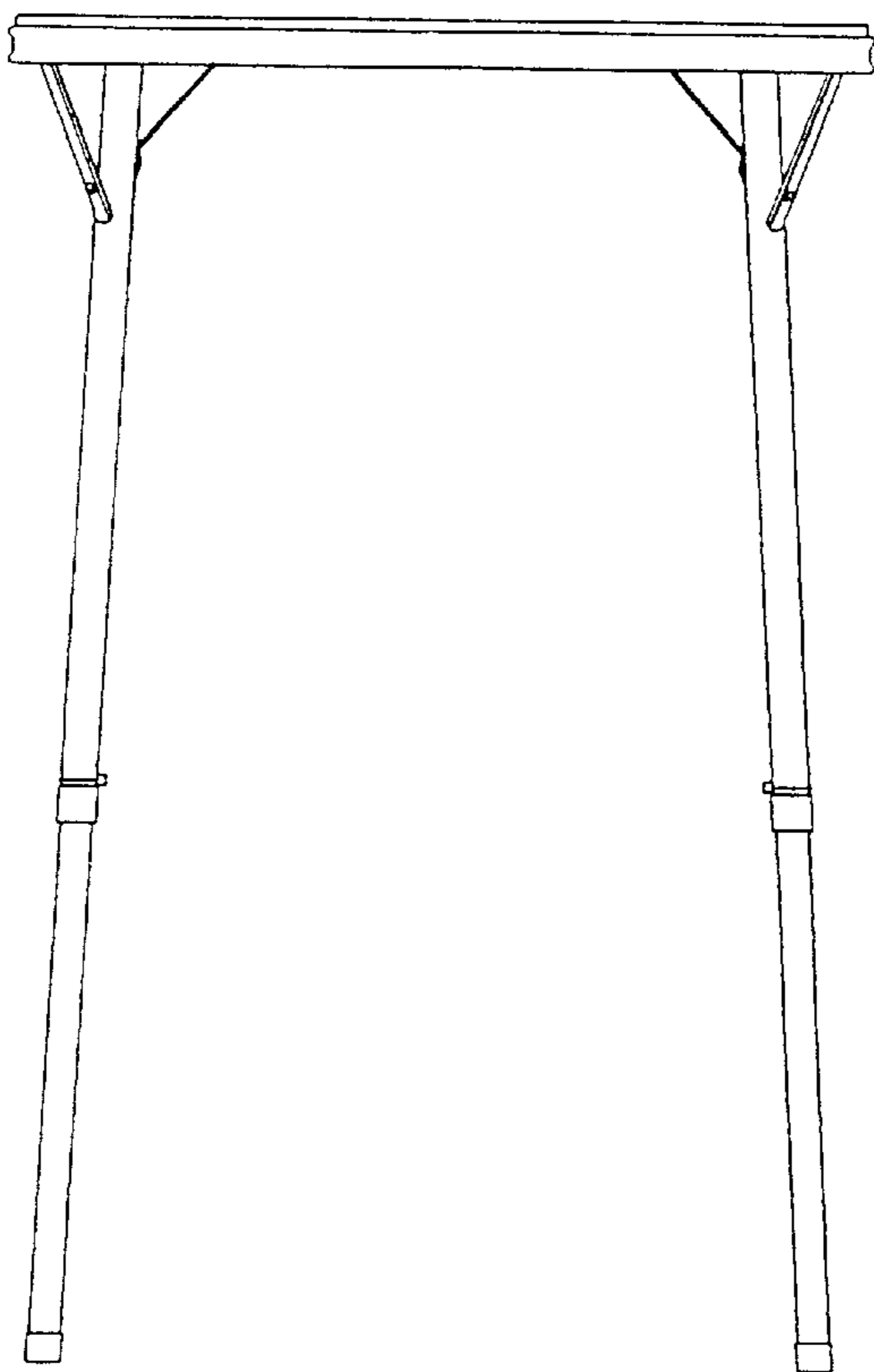

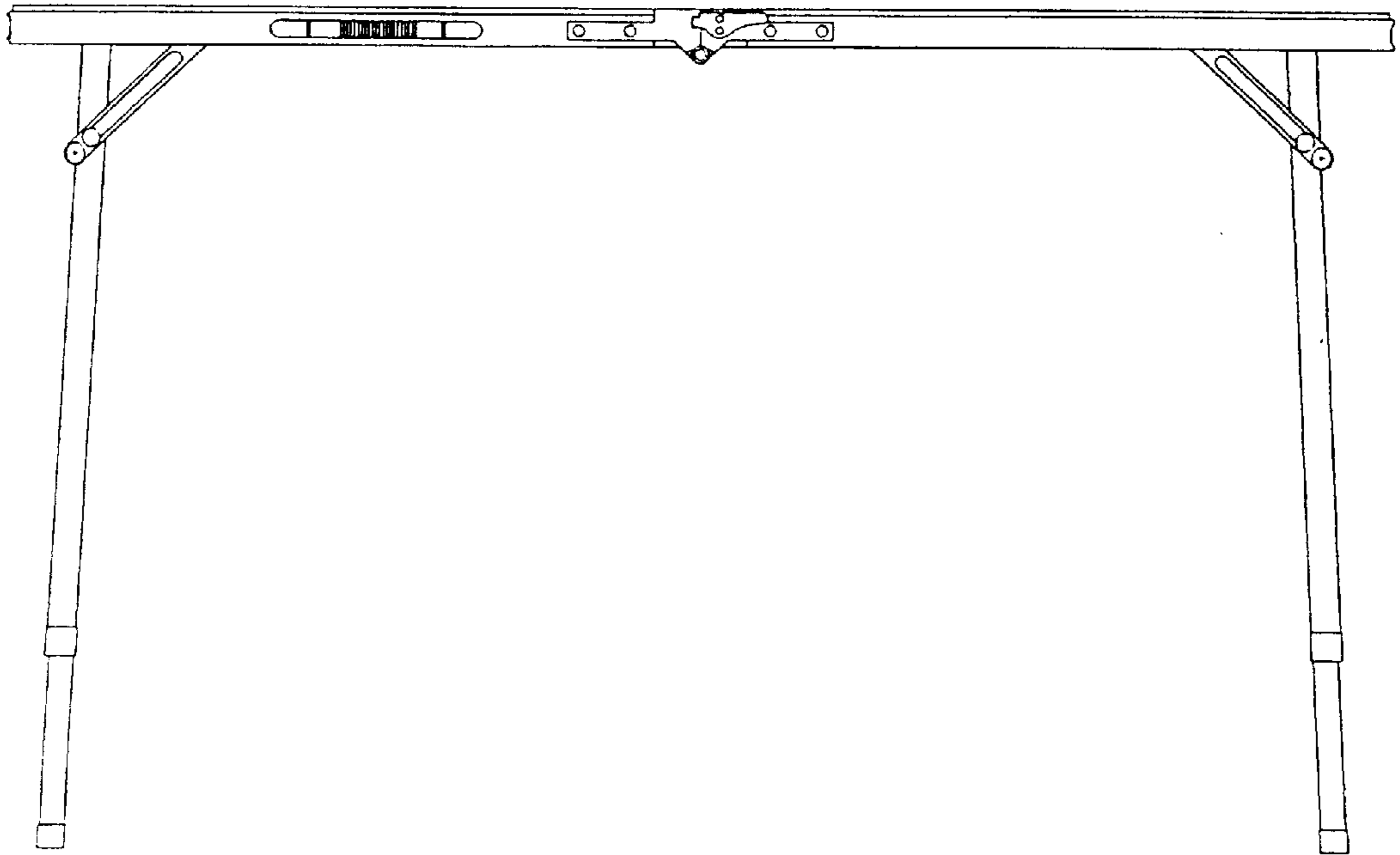

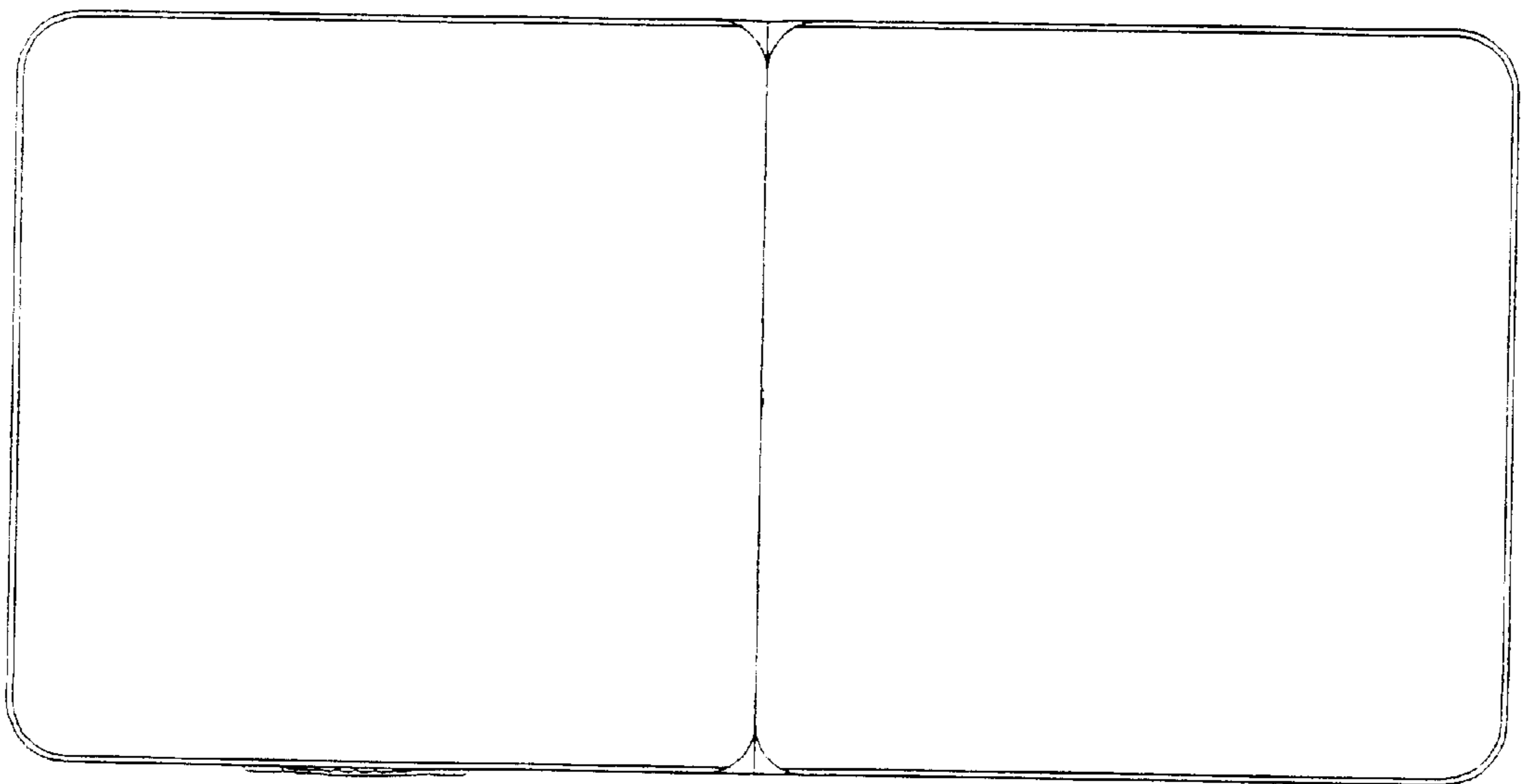

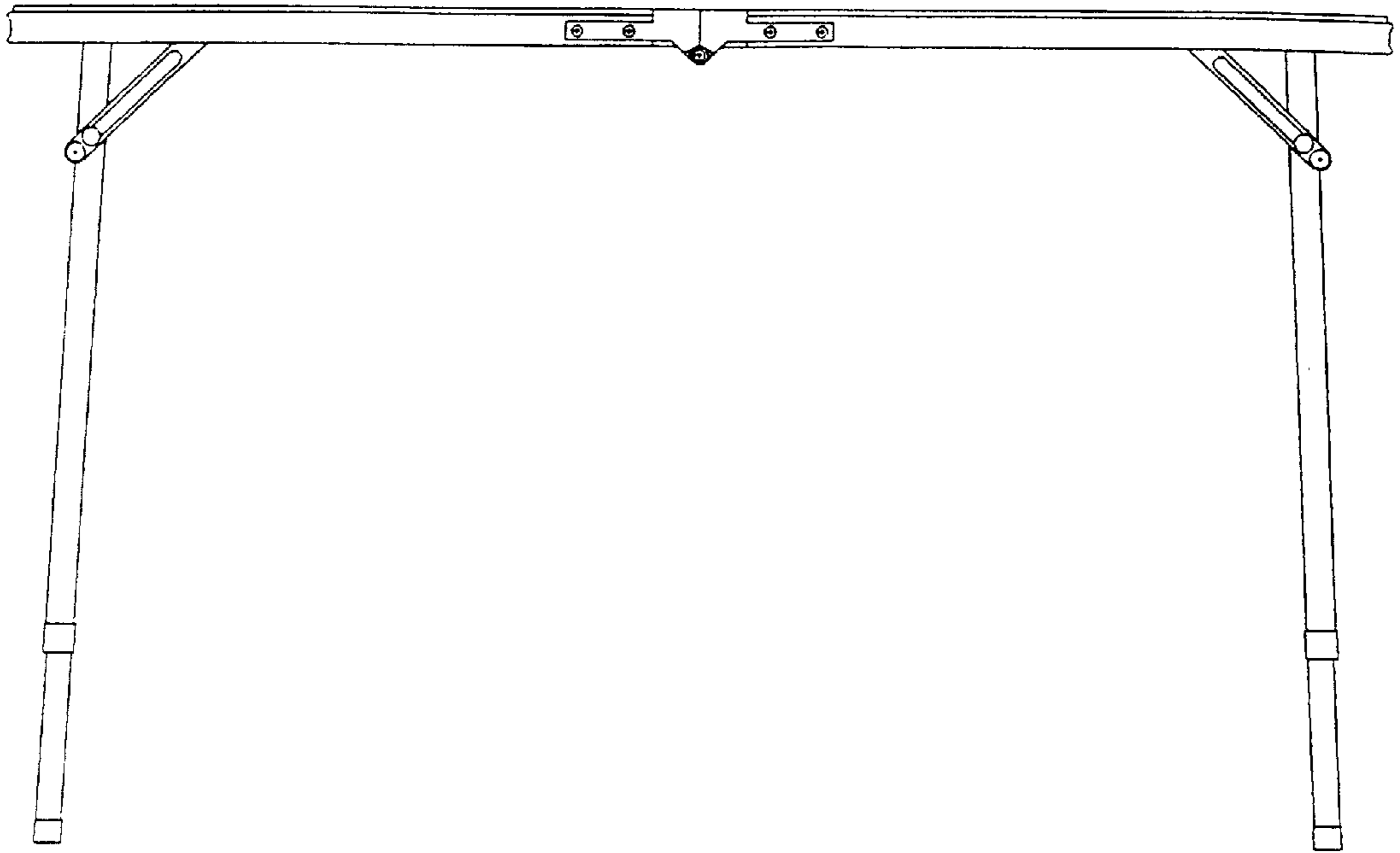

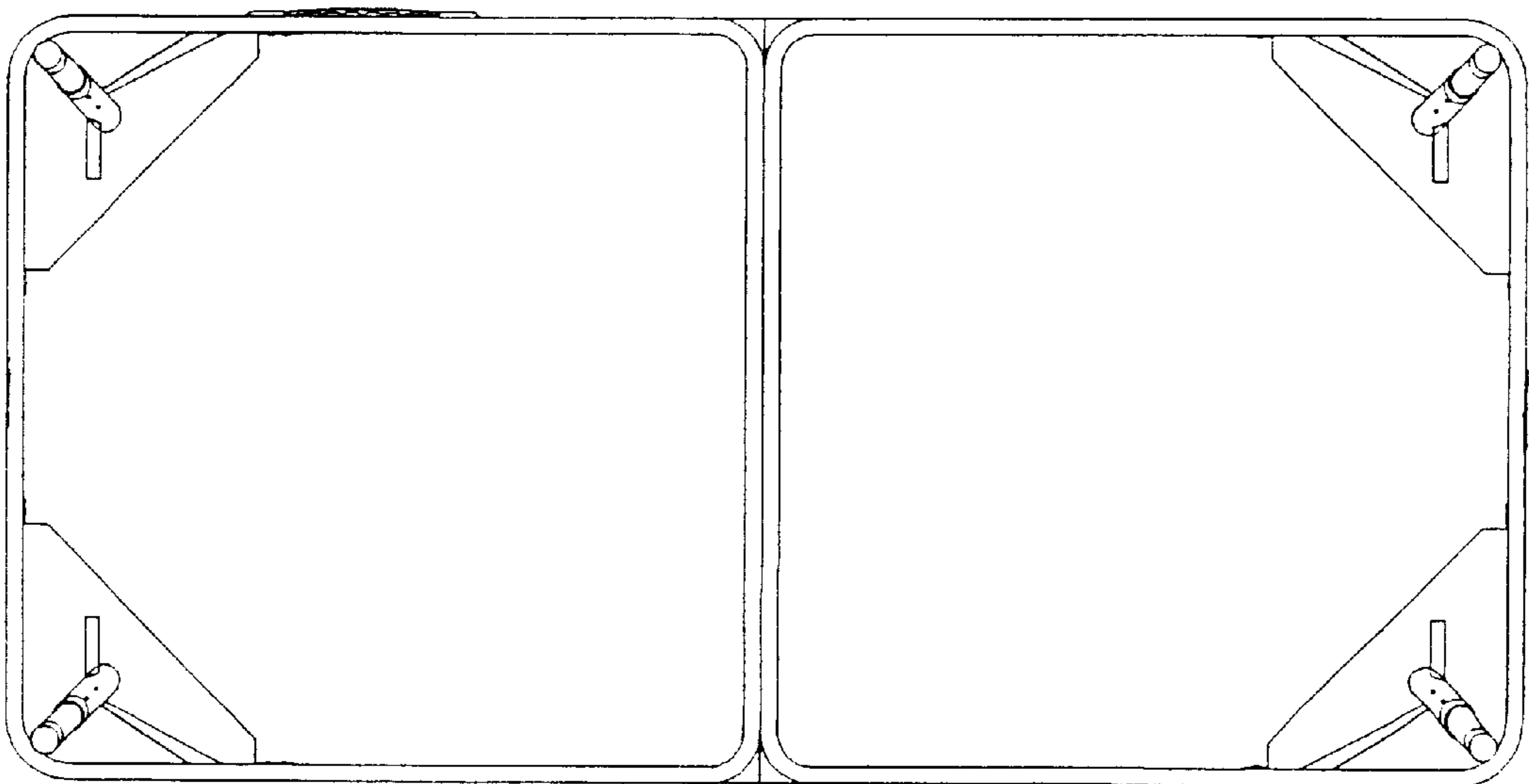

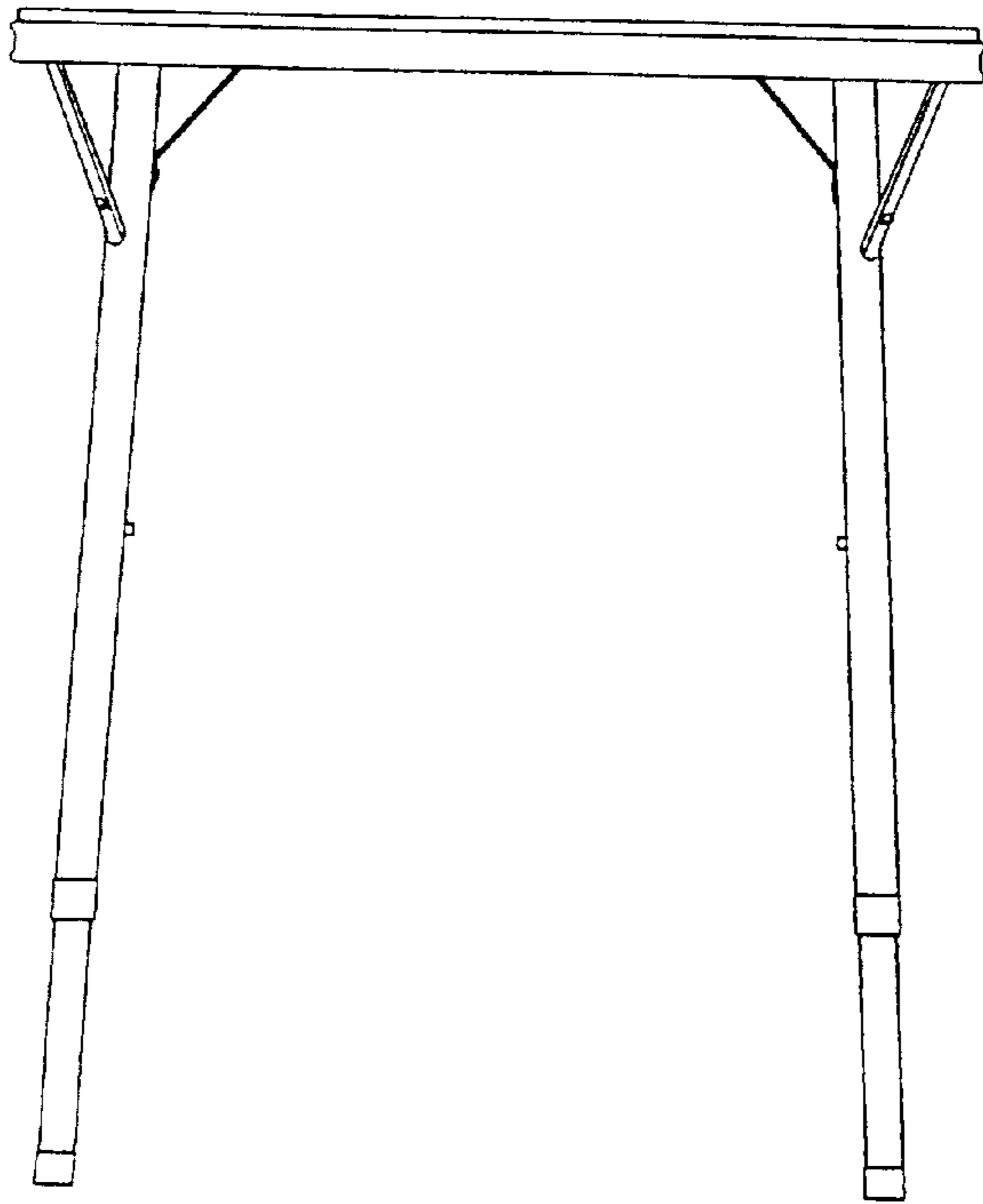

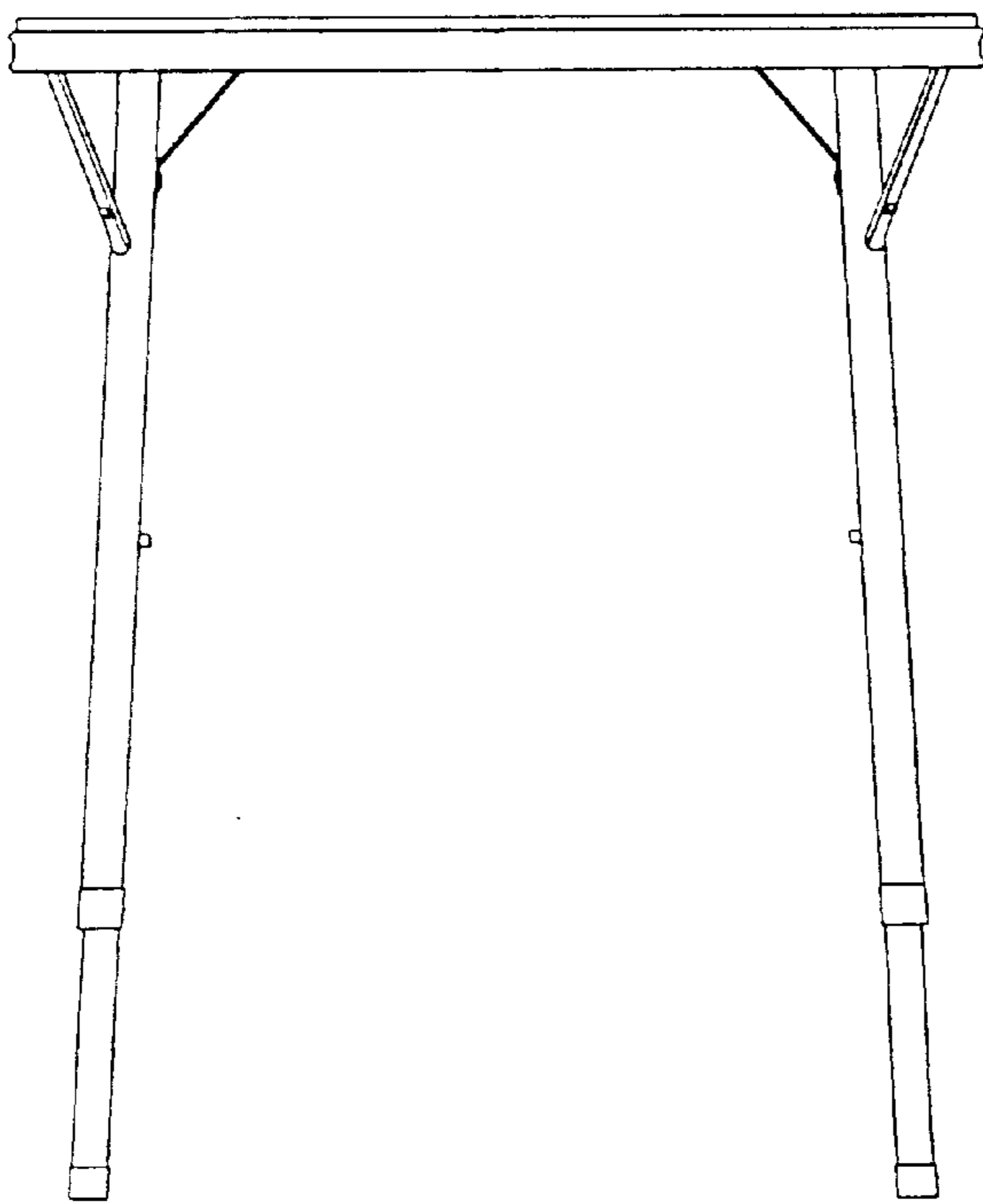

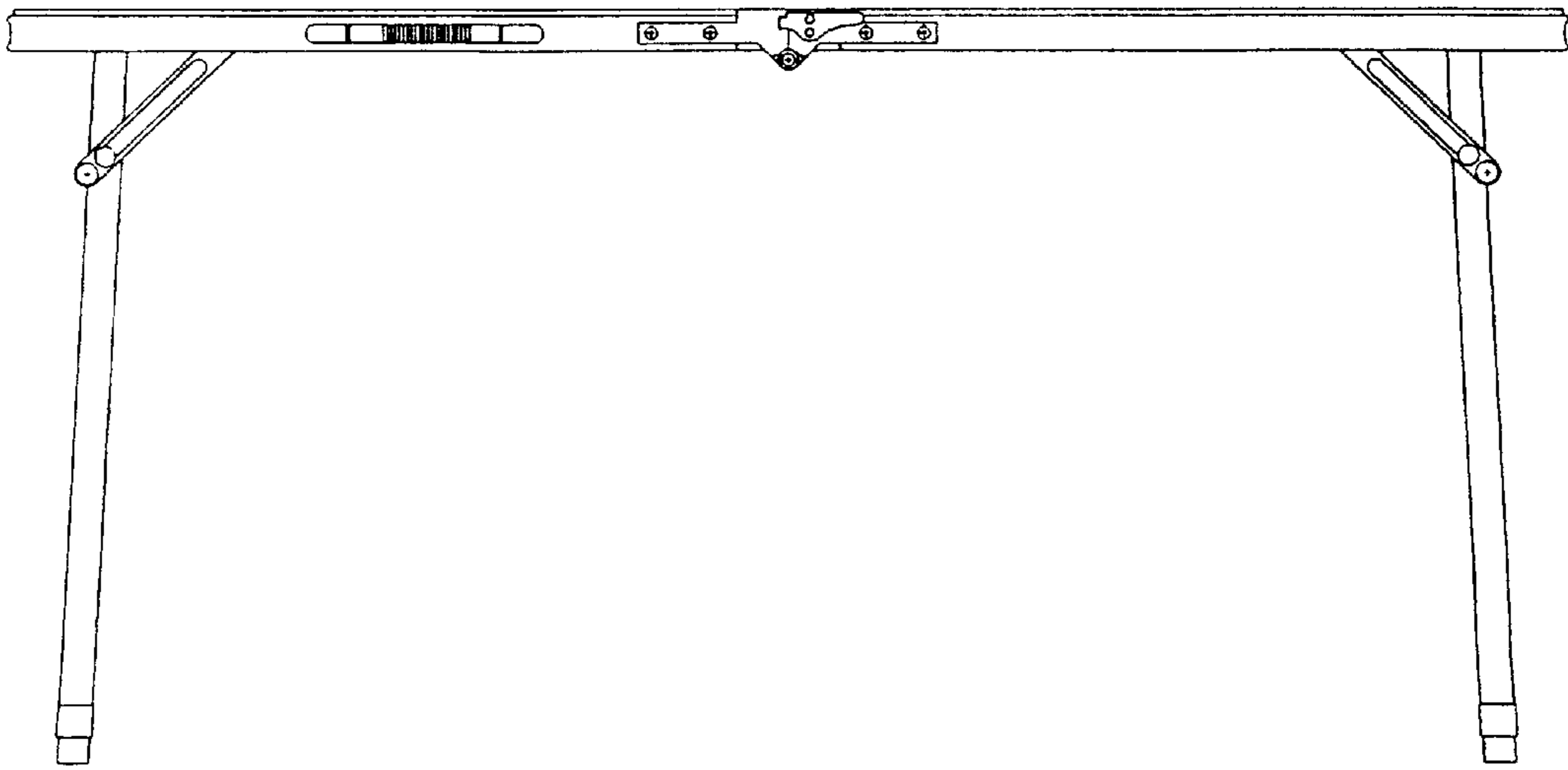

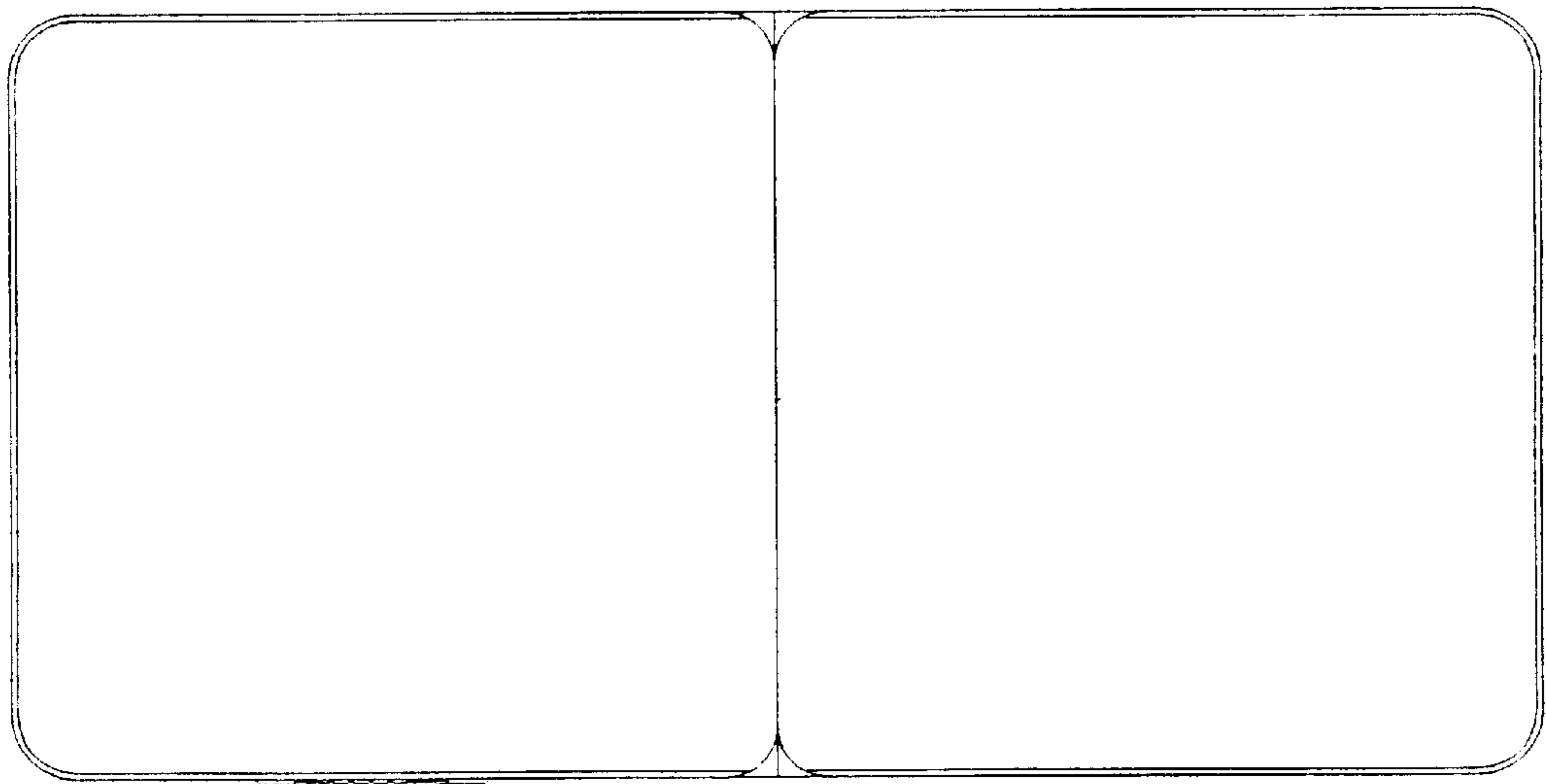

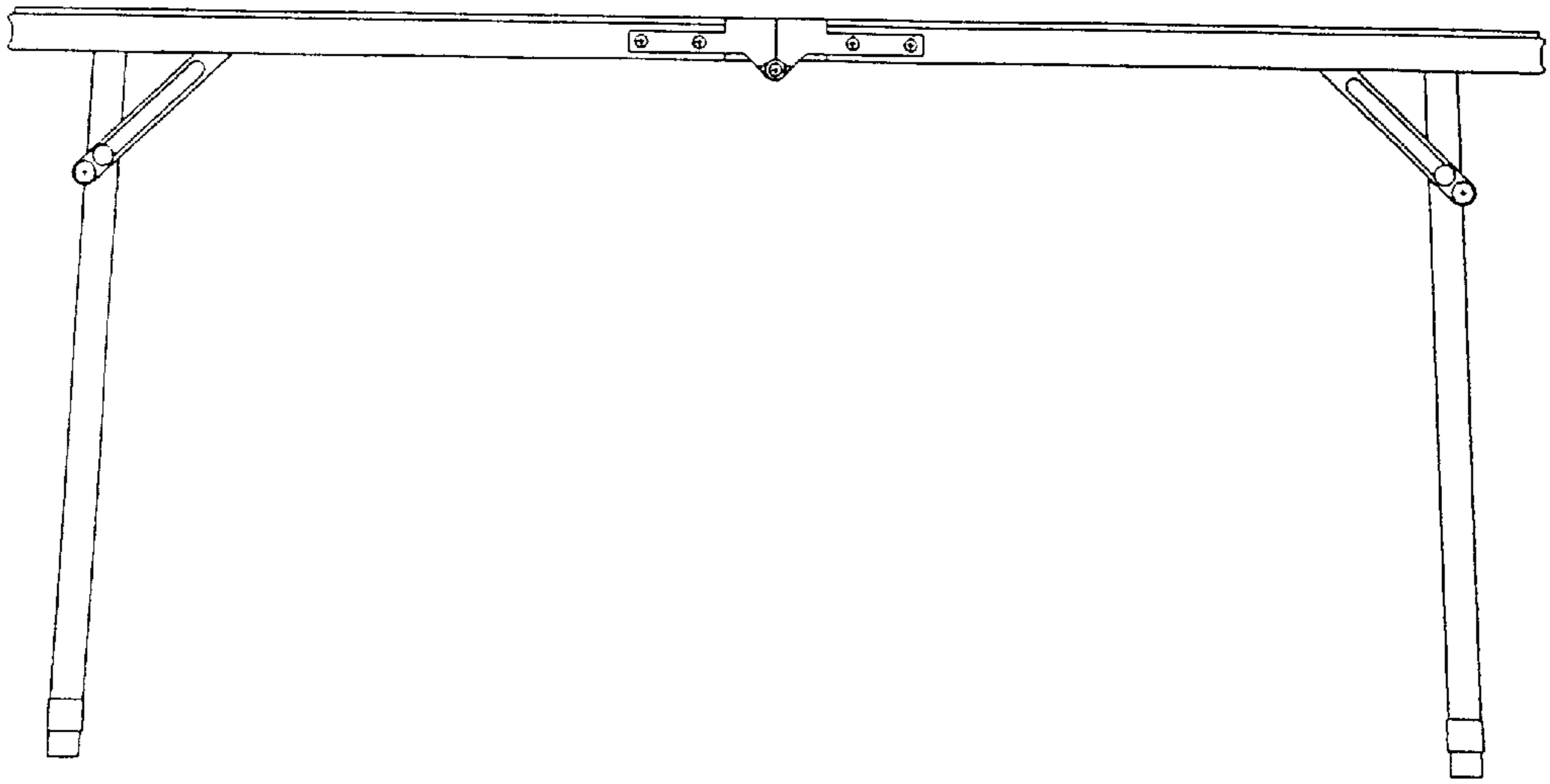

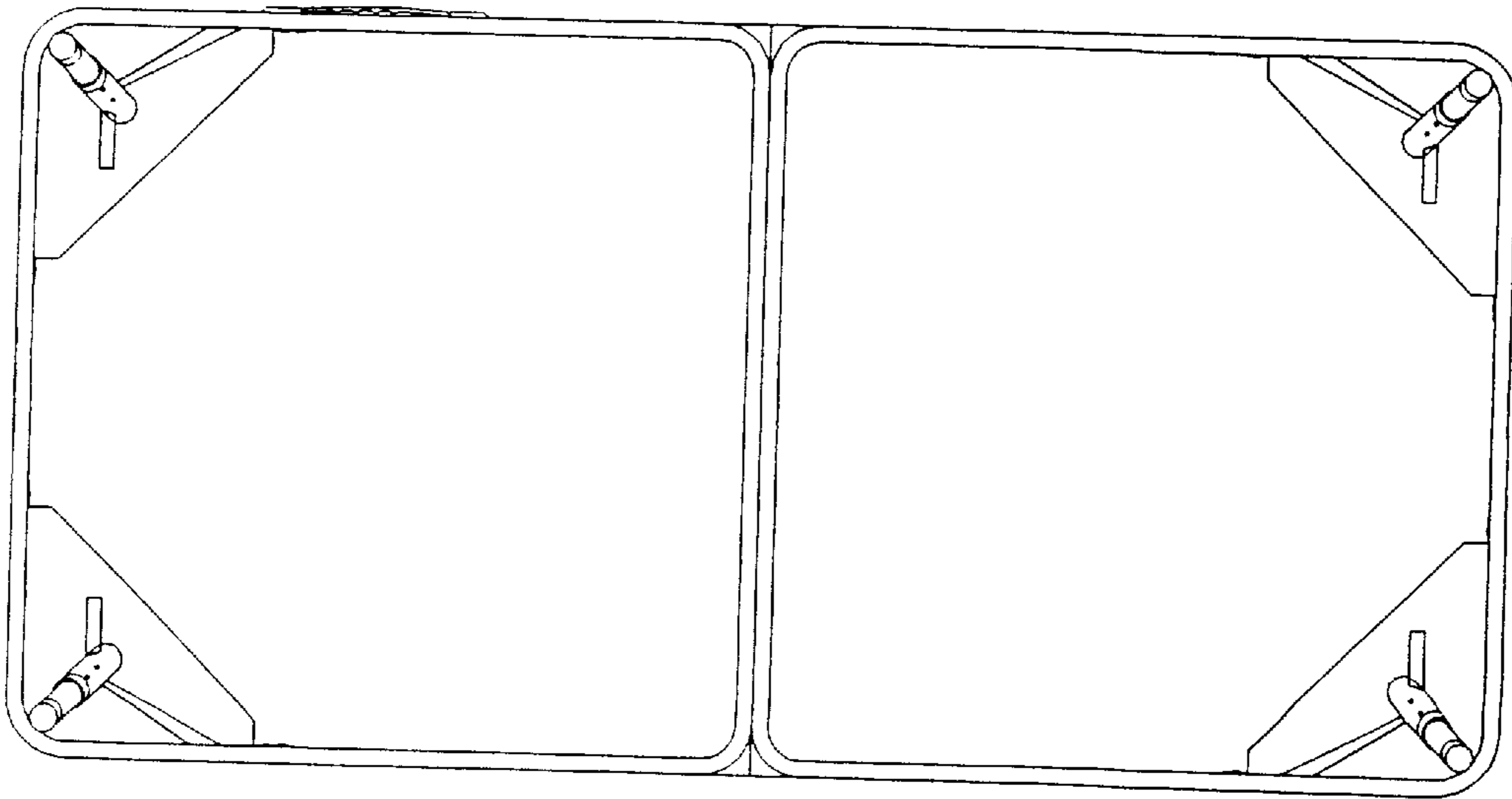

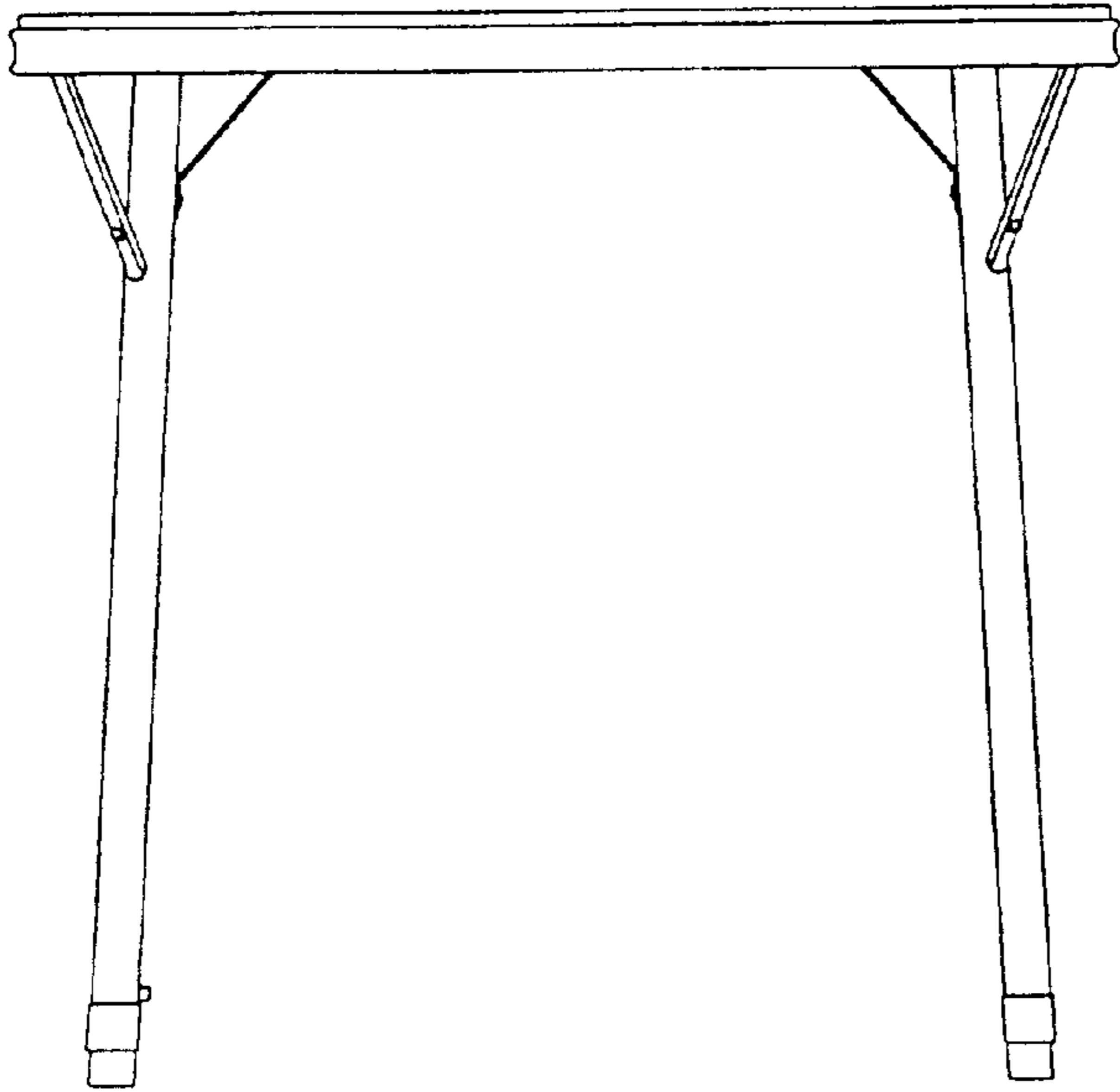

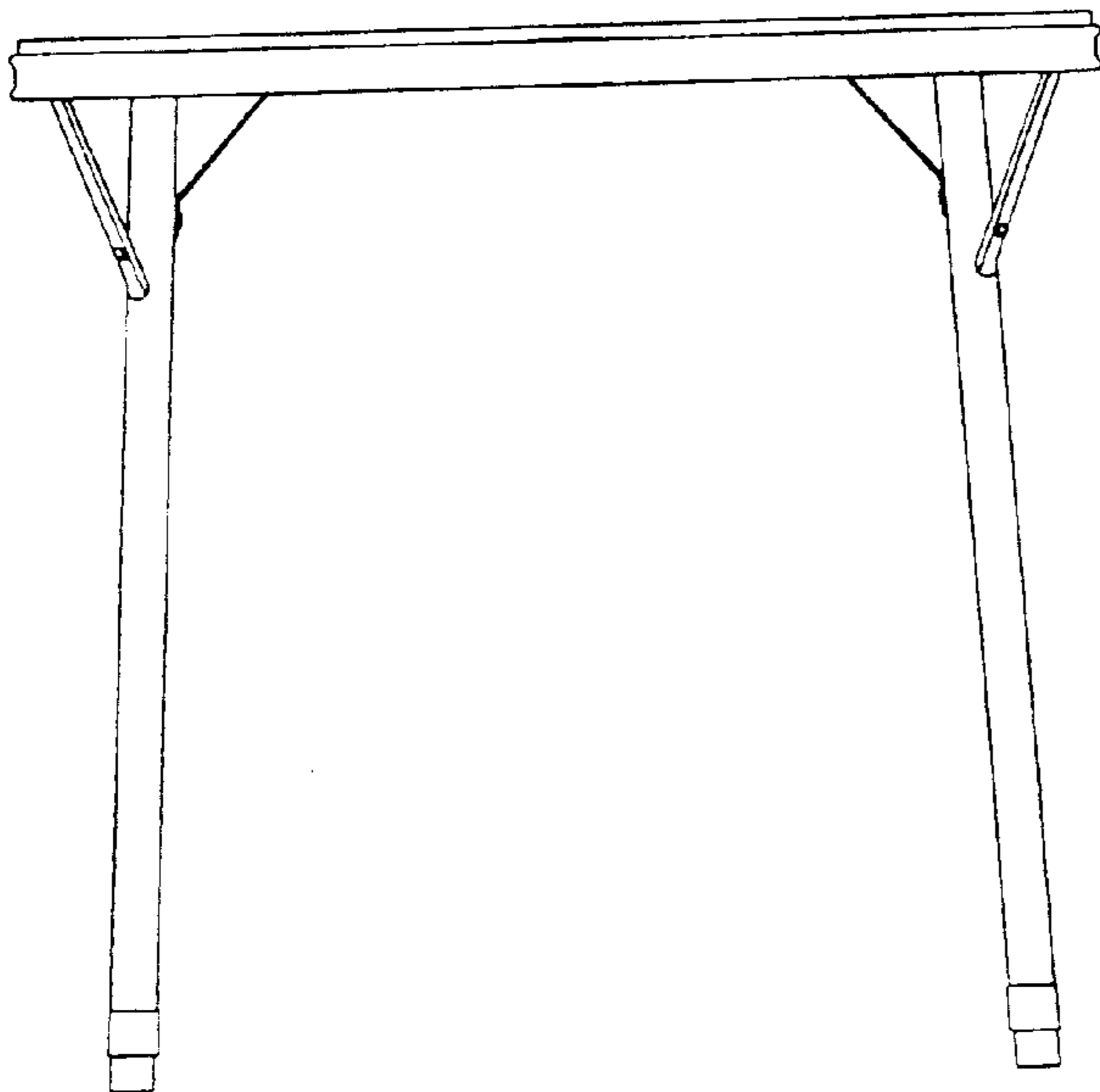

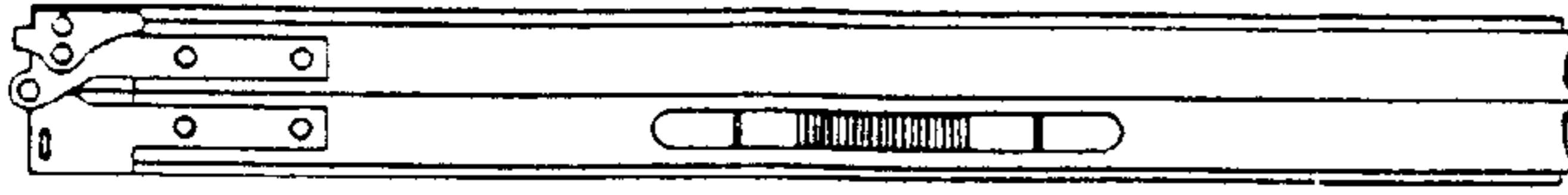

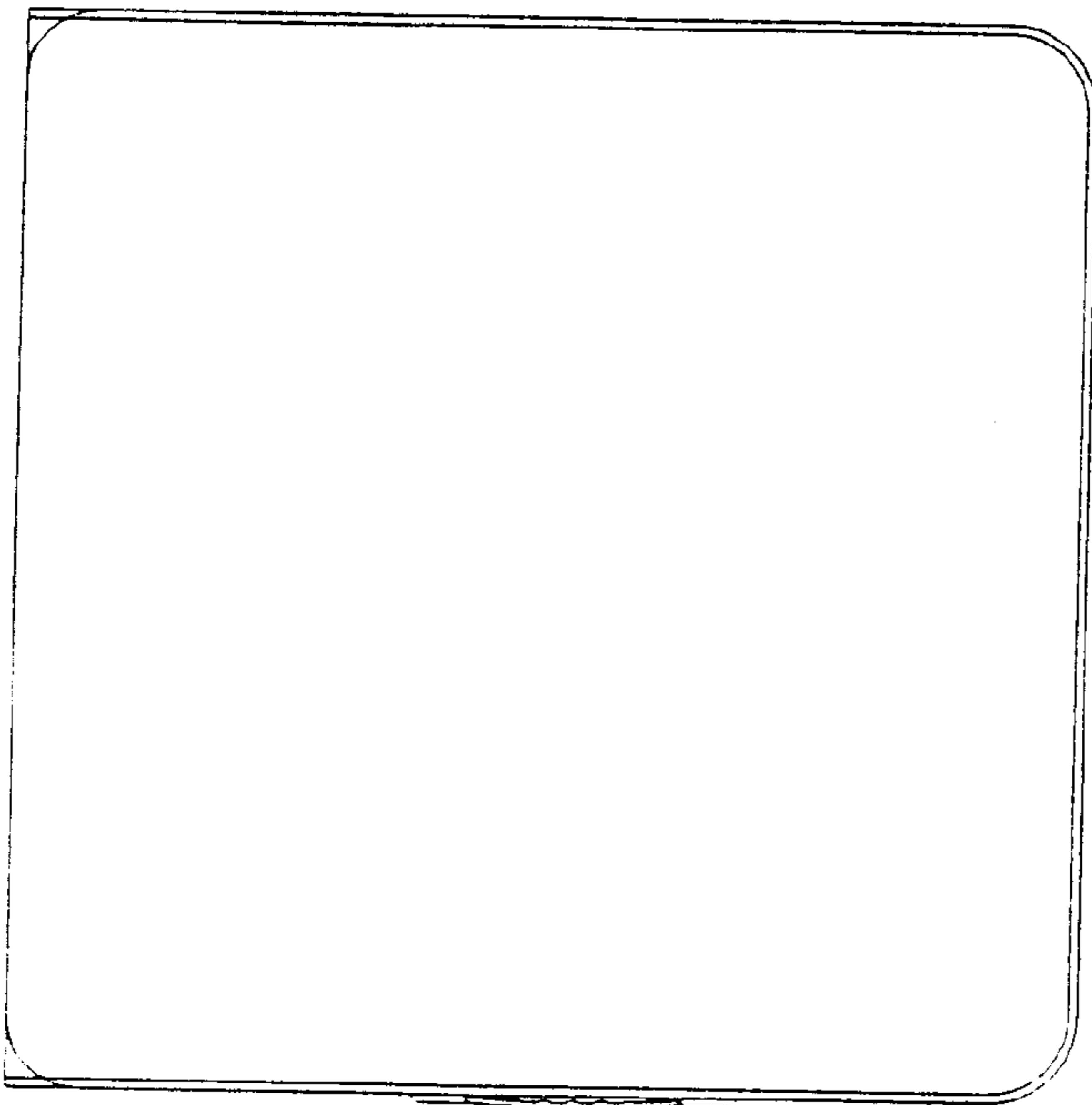

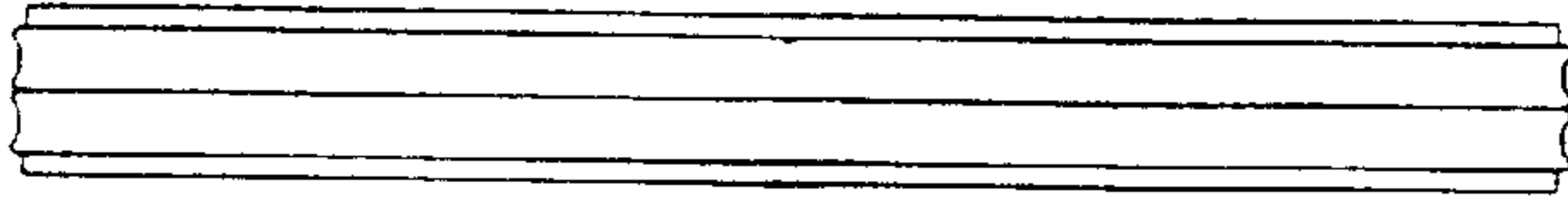

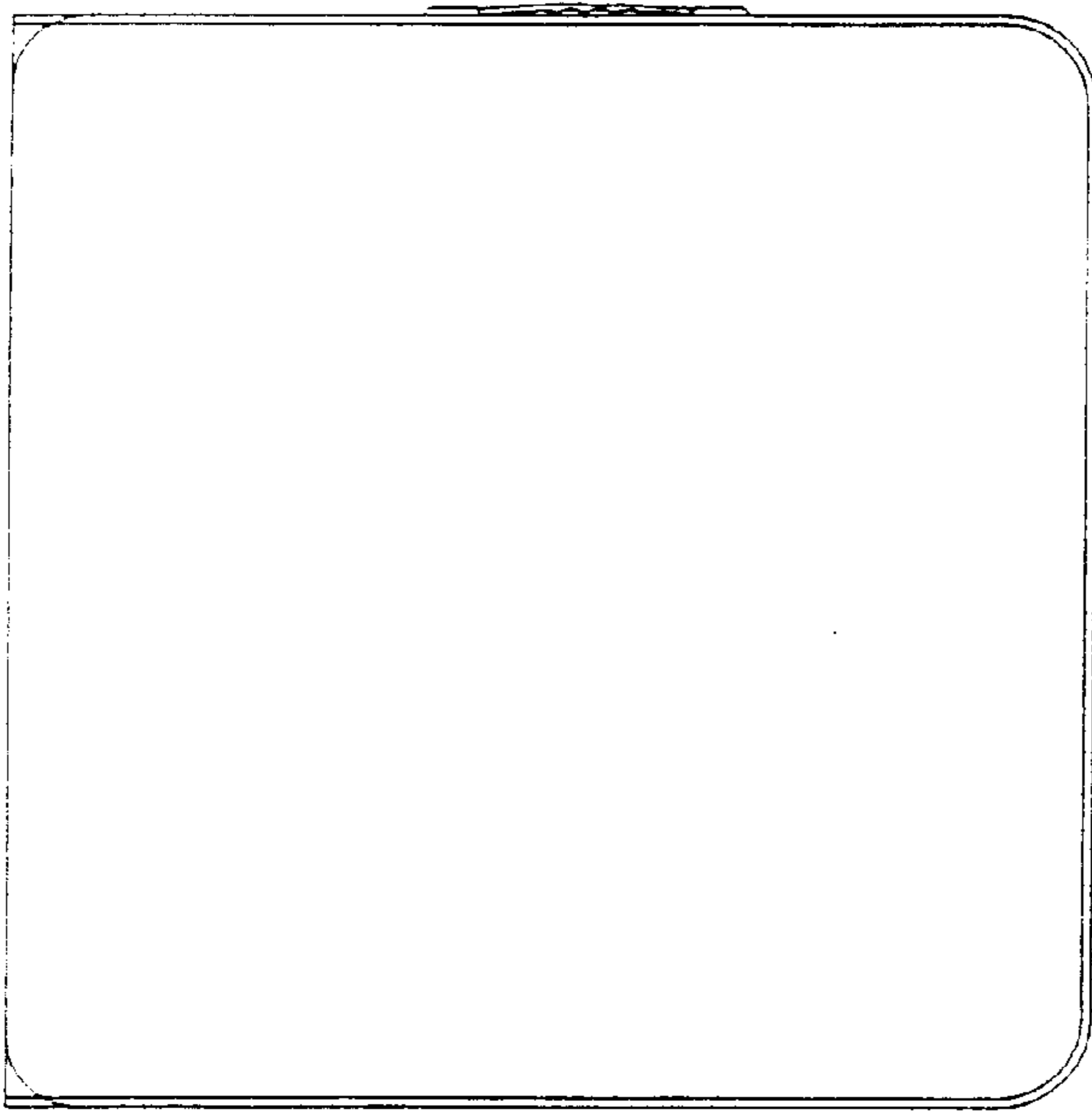

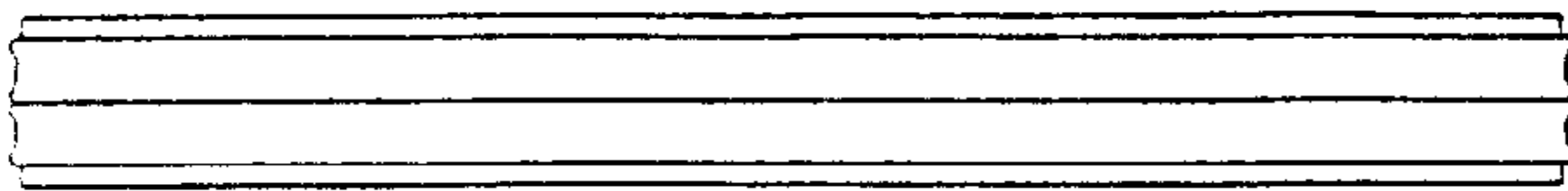
