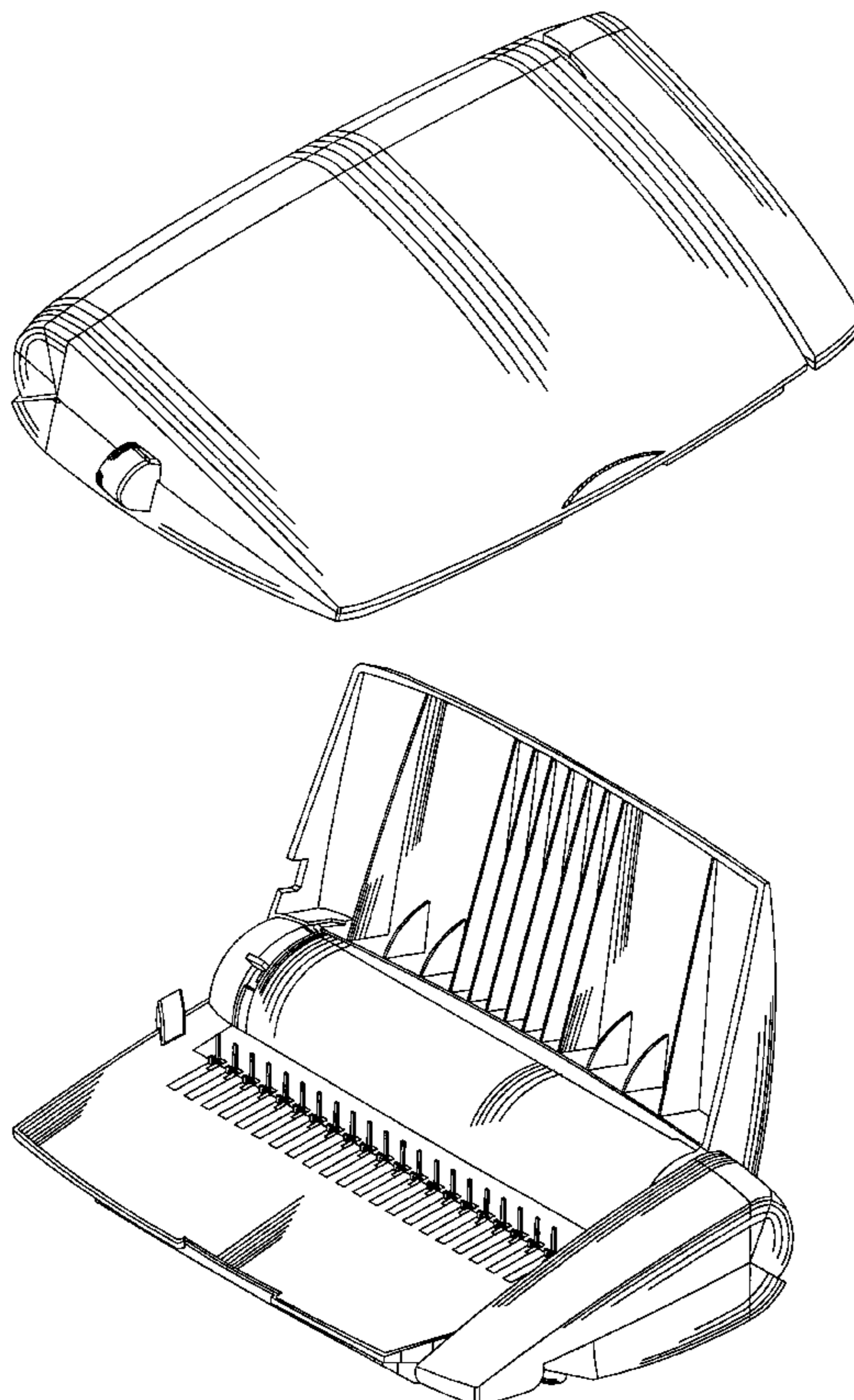
(57) **CLAIM**

The ornamental design for a punching and binding machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the punching and binding machine shown in closed position;  
FIG. 2 is a perspective view of the punching and binding machine shown in open position;  
FIG. 3 is a first side view of the punching and binding machine of FIG. 2;  
FIG. 4 is a second side view of the punching and binding machine of FIG. 2;  
FIG. 5 is a back view of the punching and binding machine of FIG. 2;  
FIG. 6 is a front view of the punching and binding machine of FIG. 2;  
FIG. 7 is a bottom view of the punching and binding machine of FIG. 2; and,

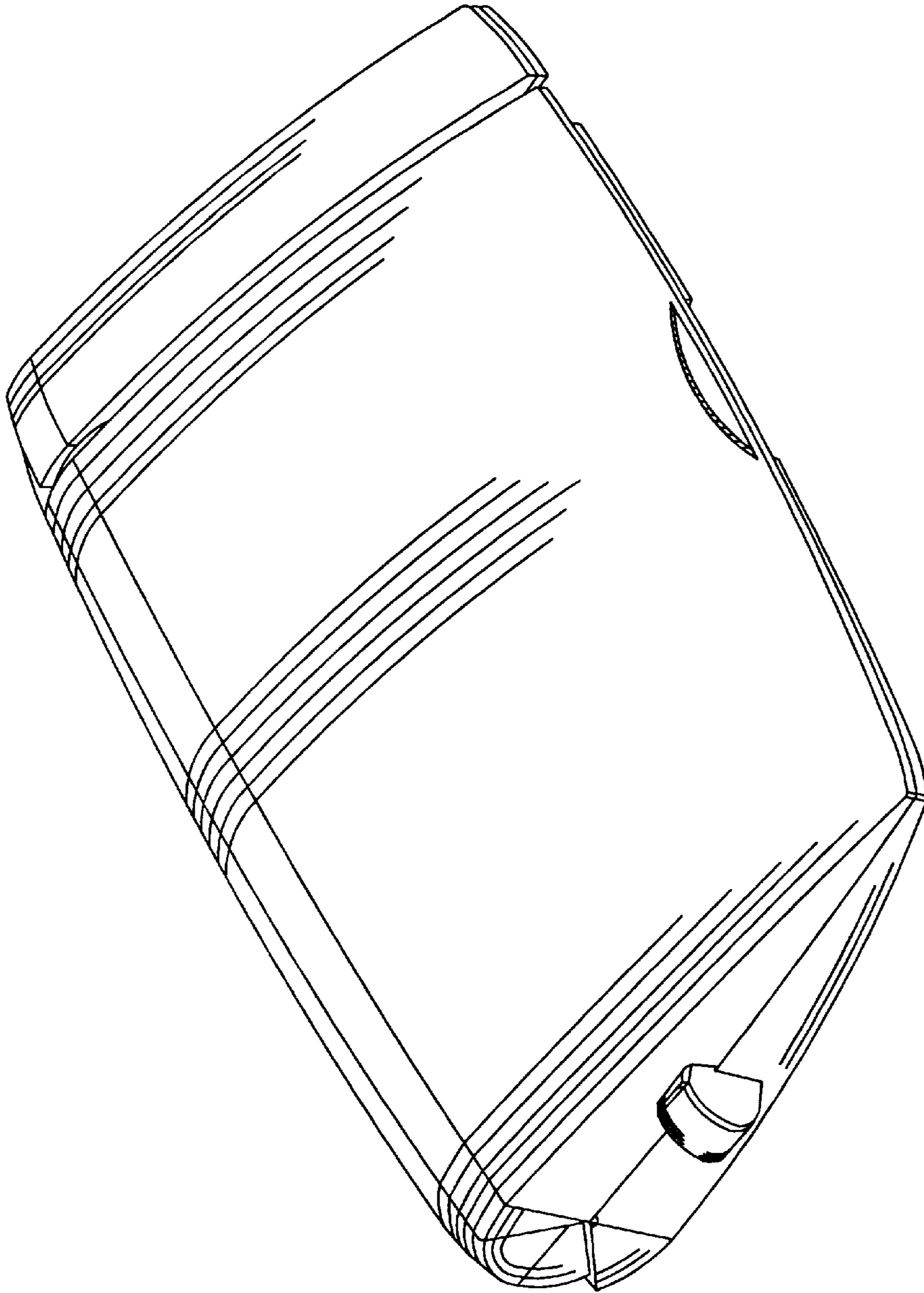

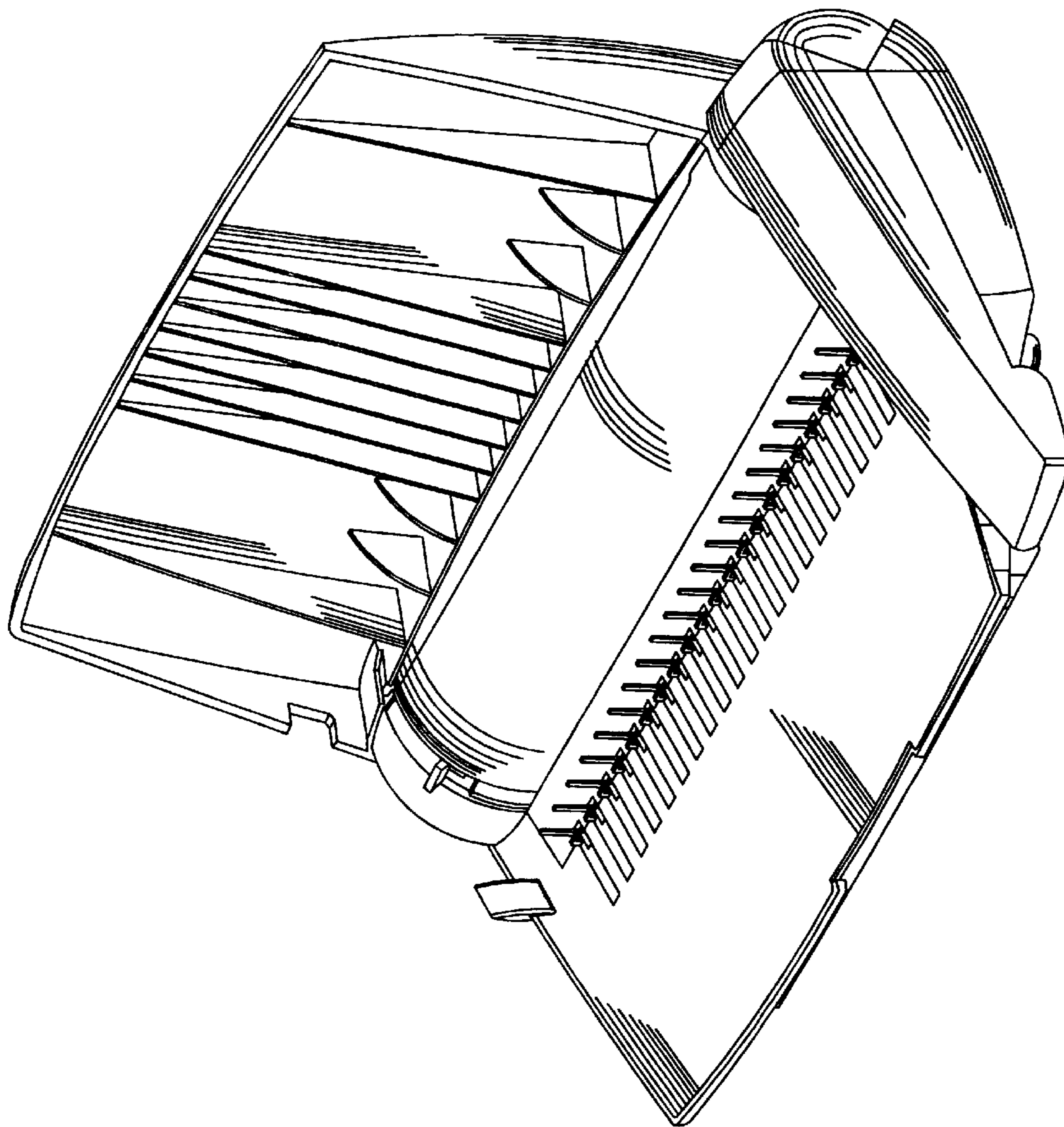

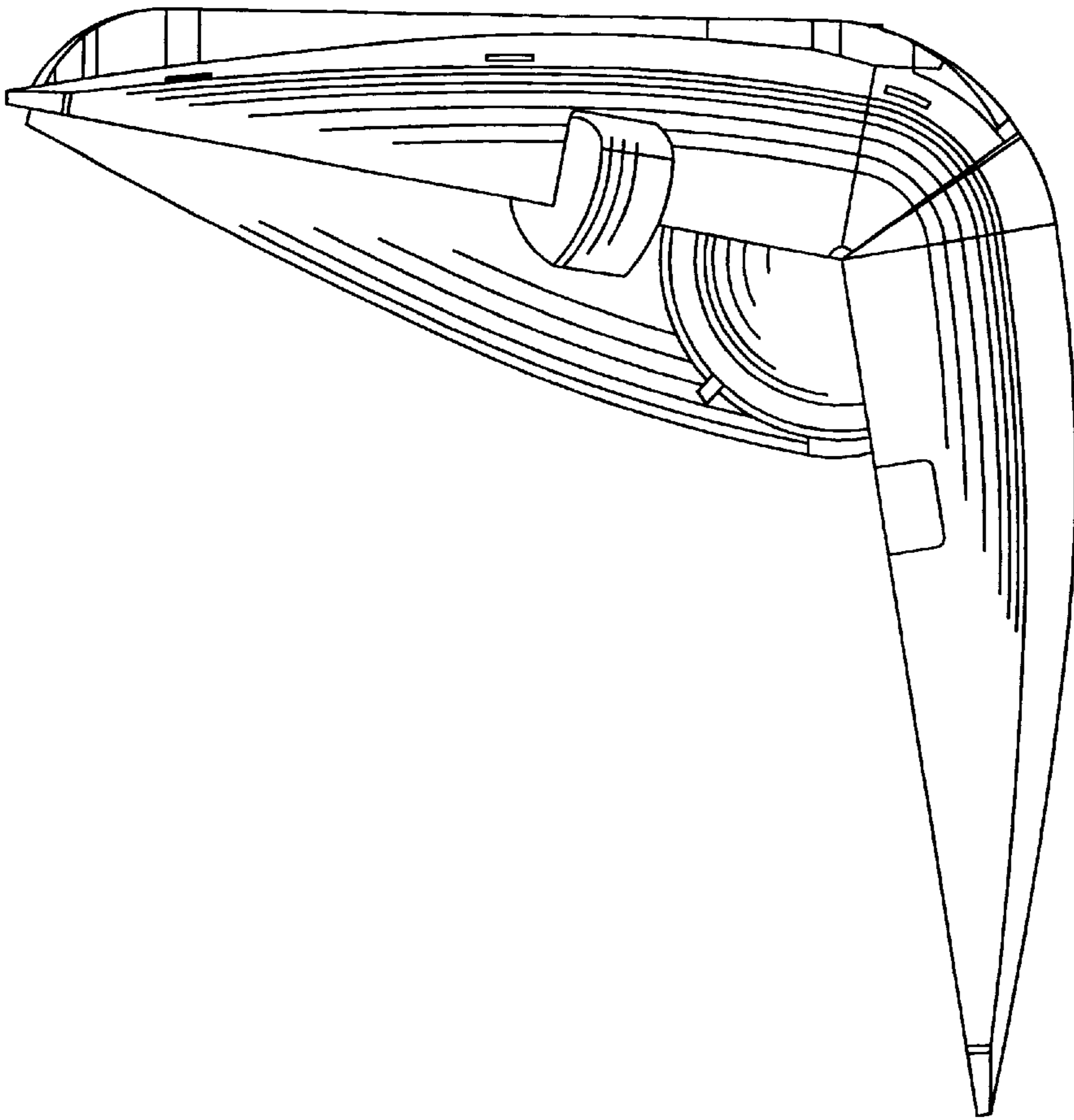

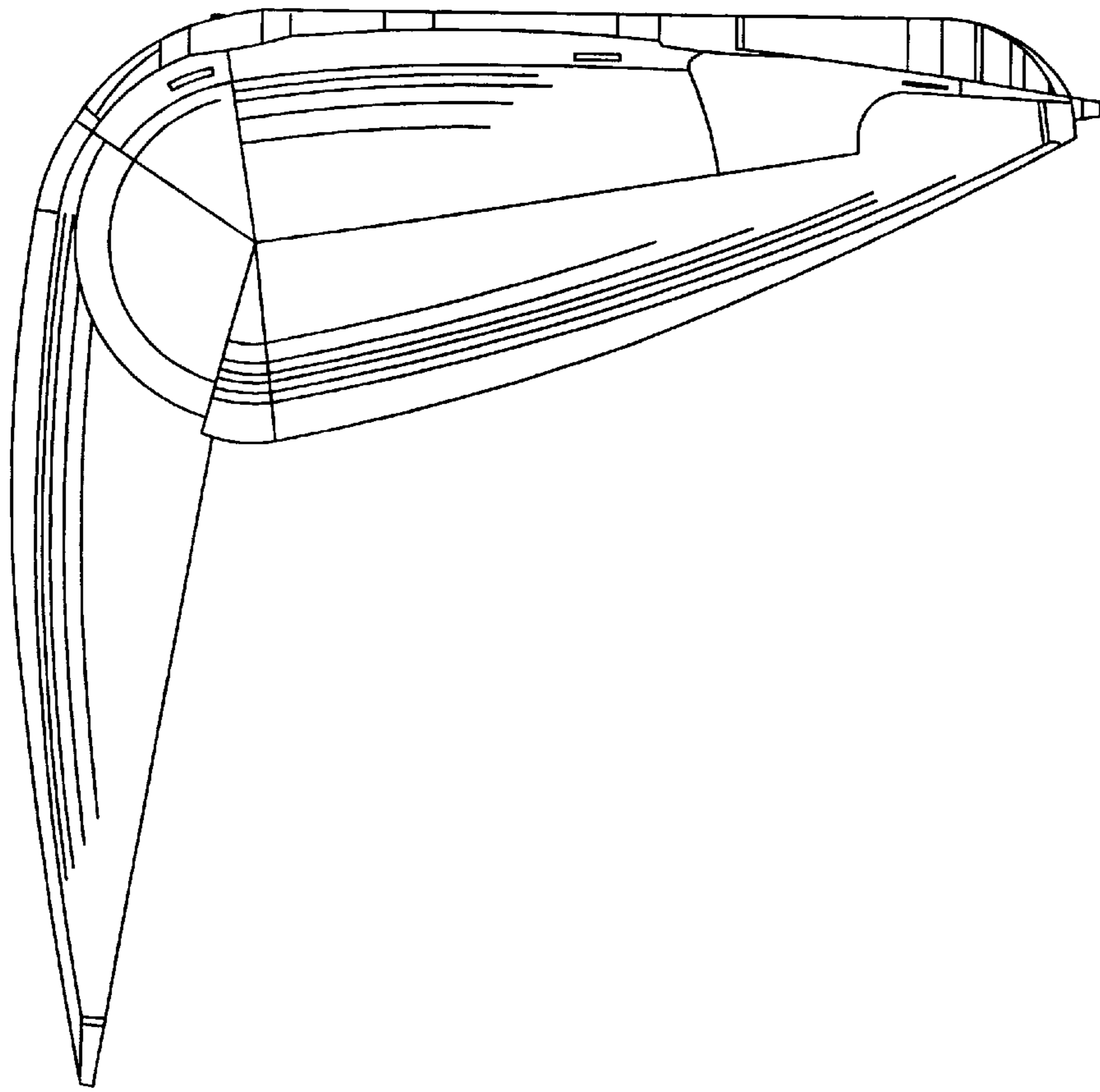

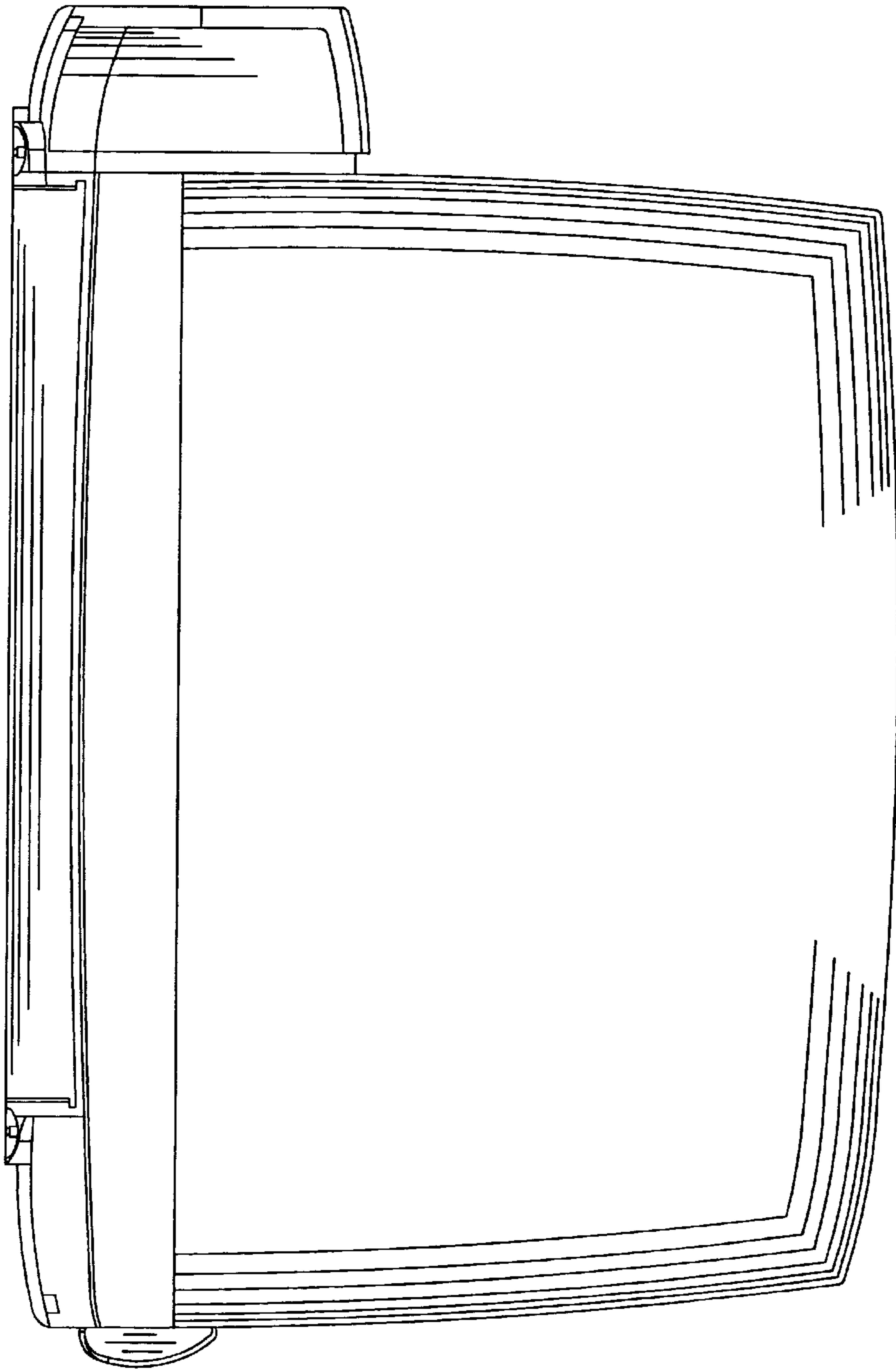

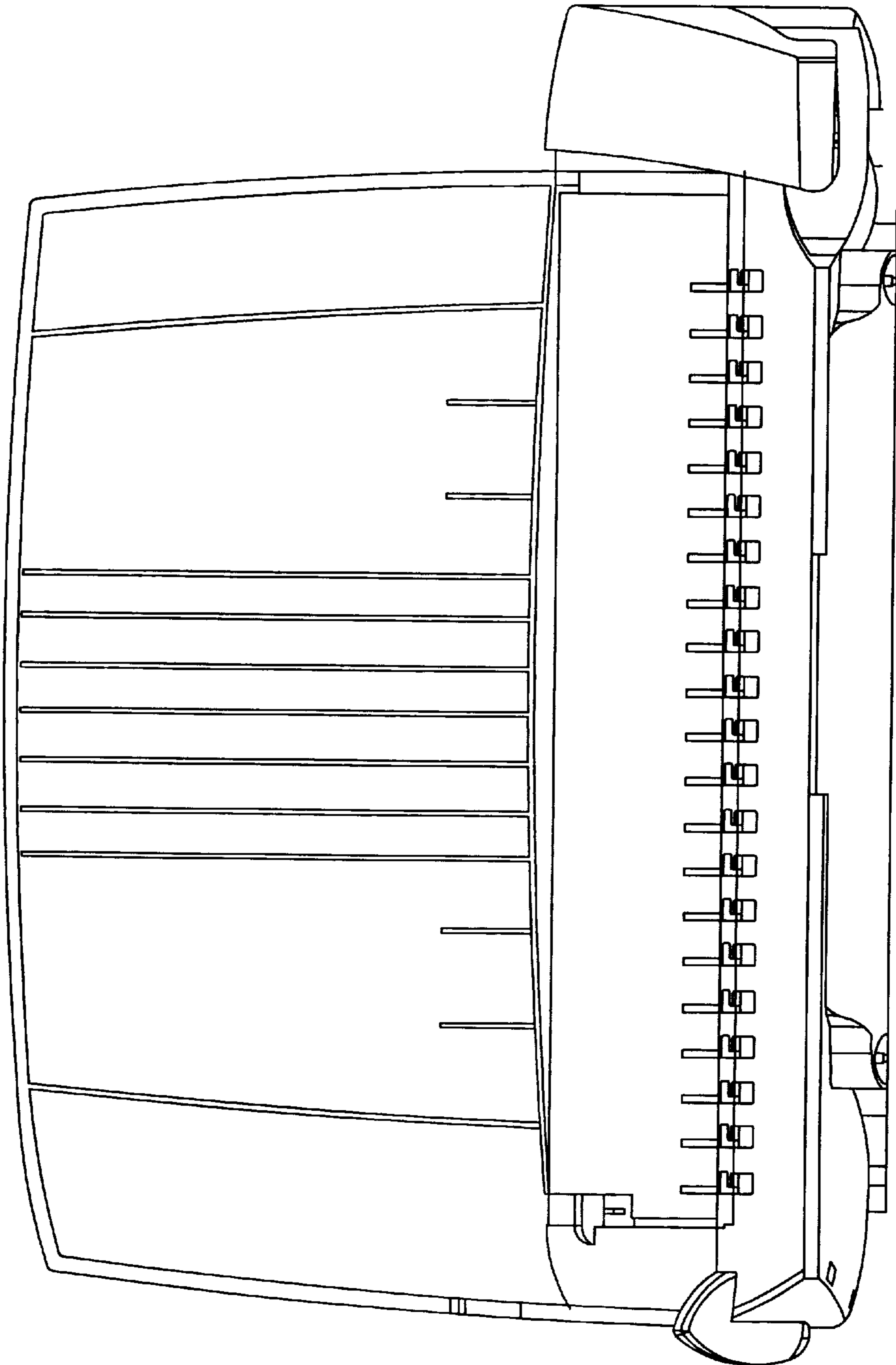

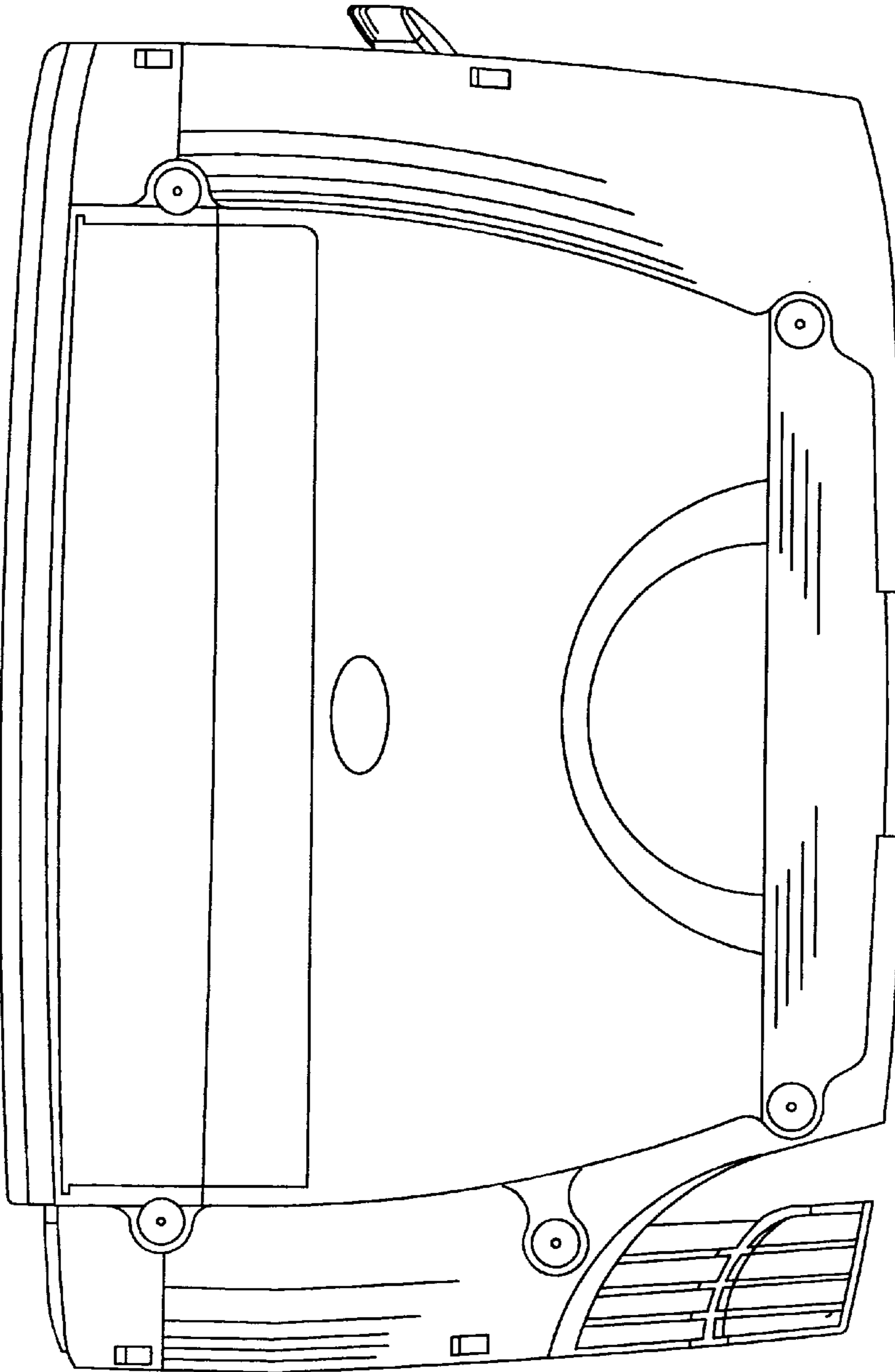

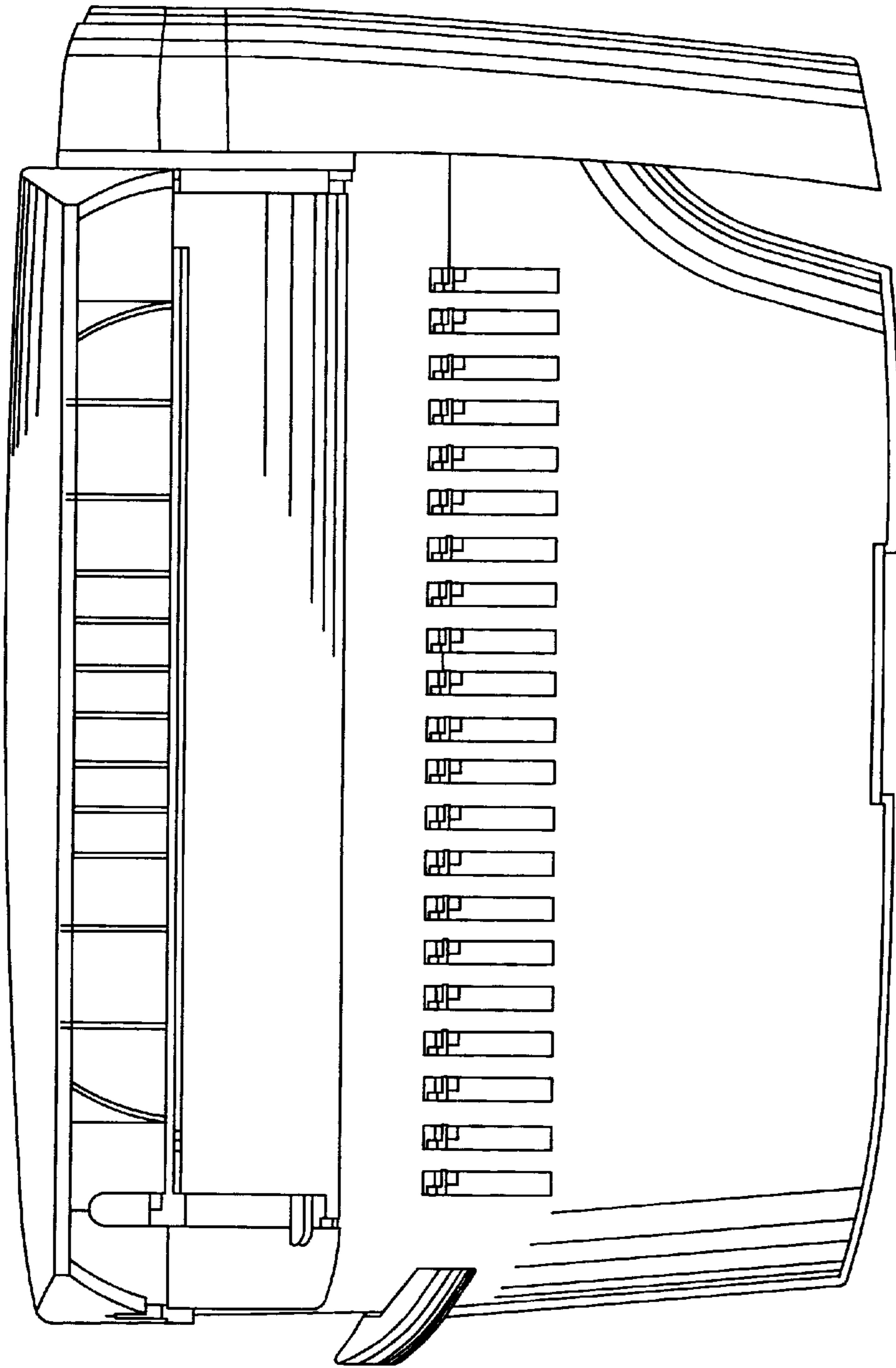
