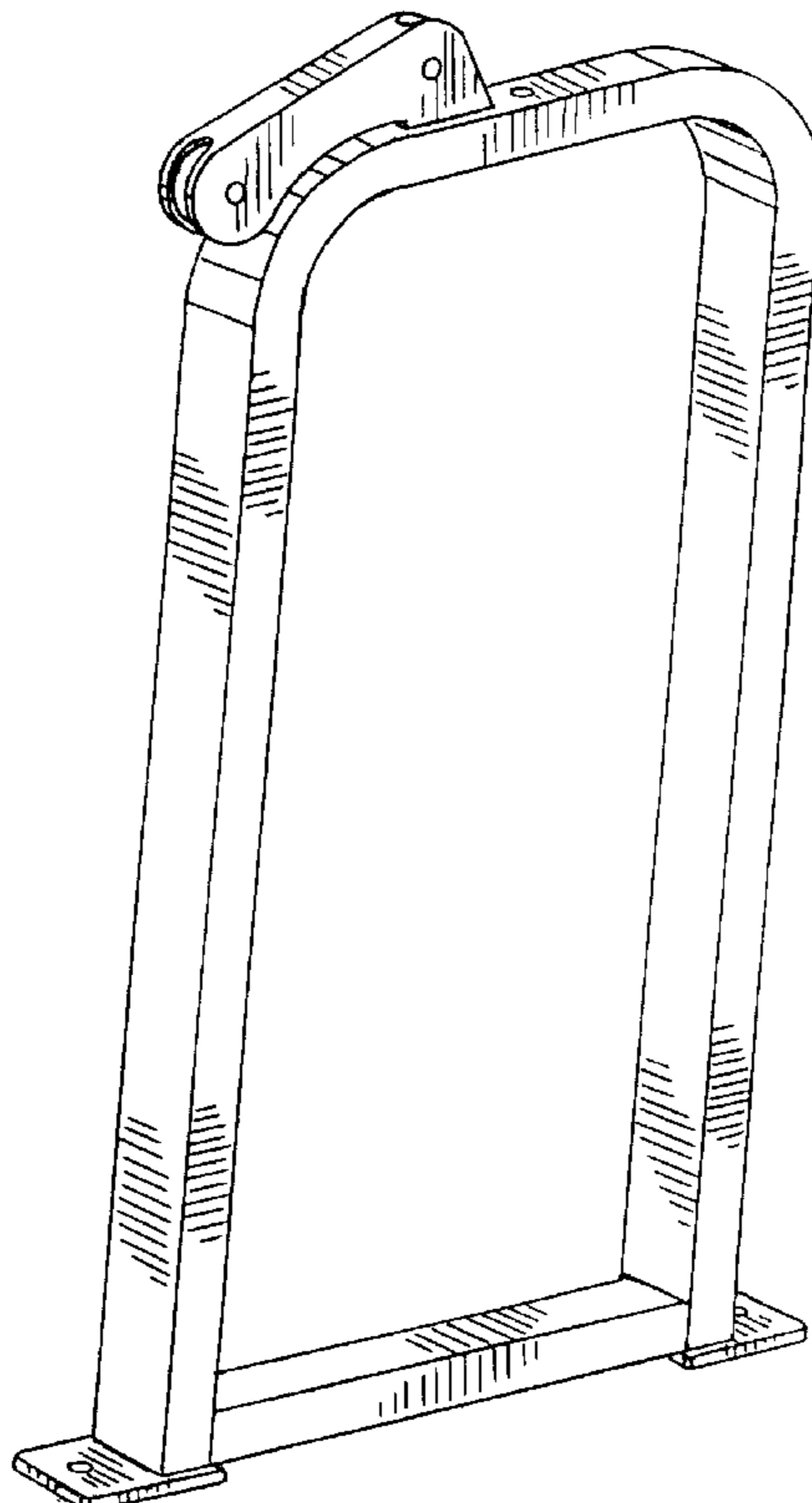
DESCRIPTION

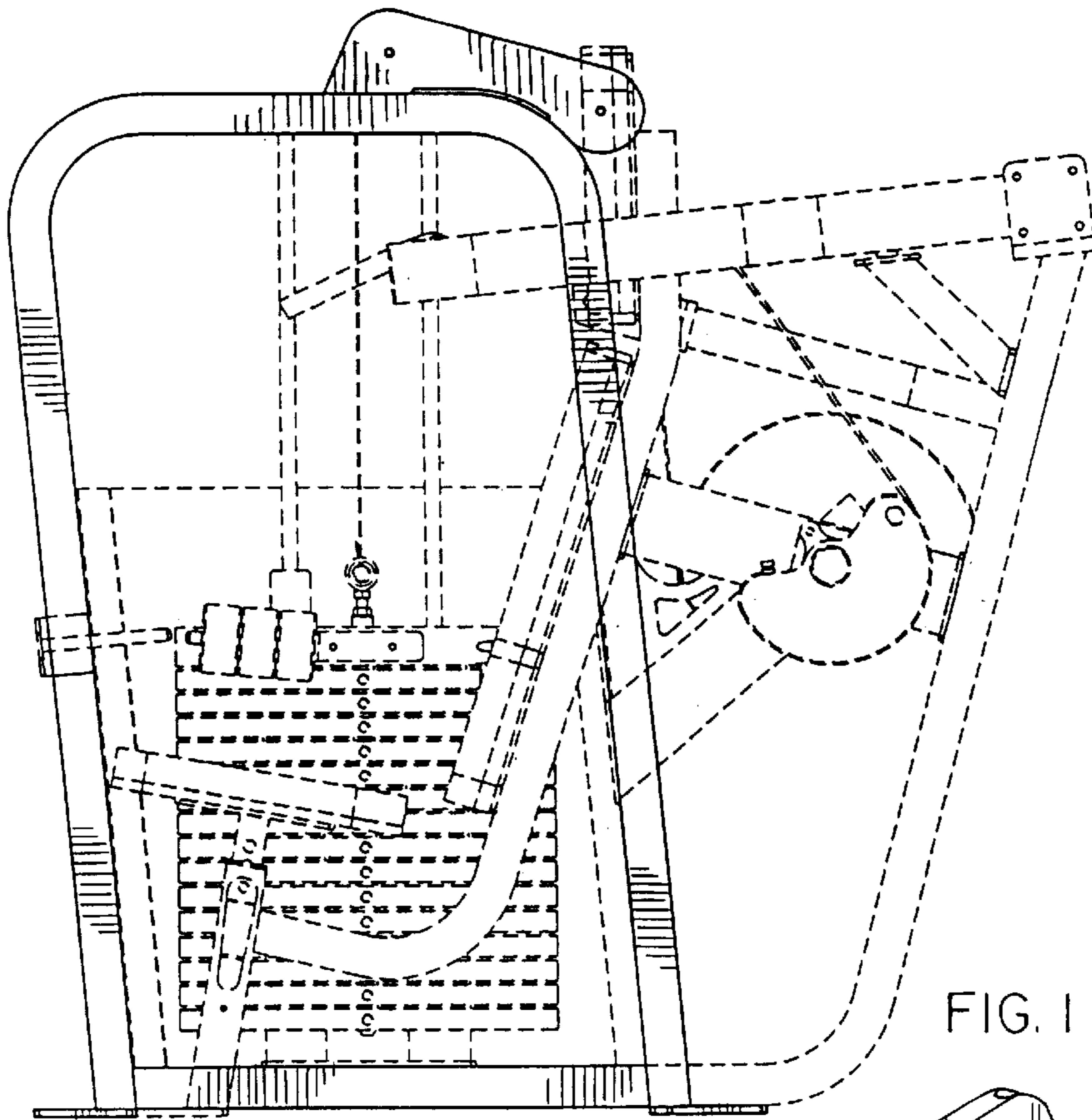

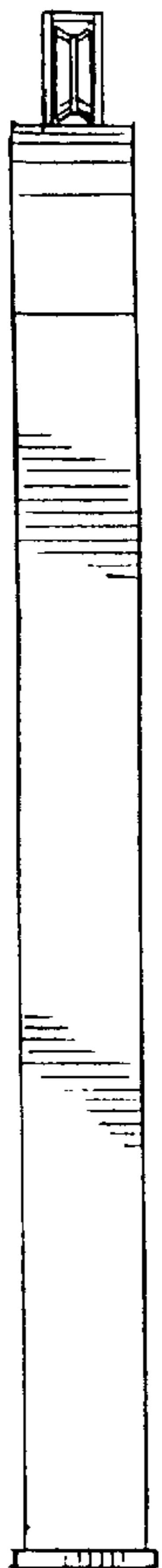

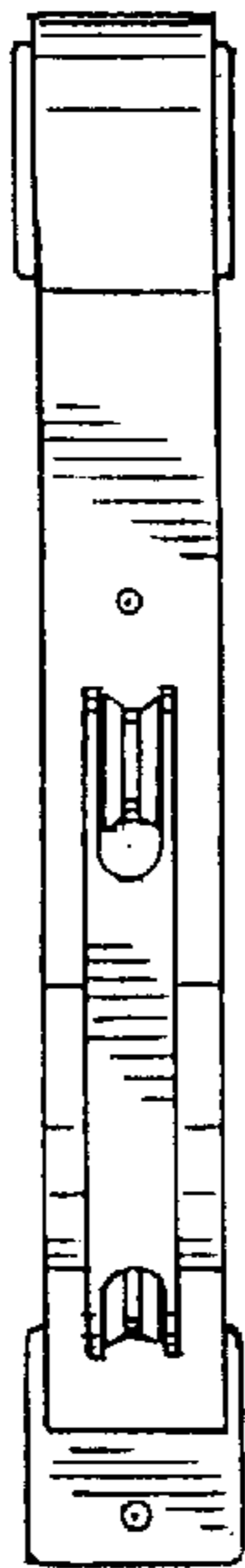

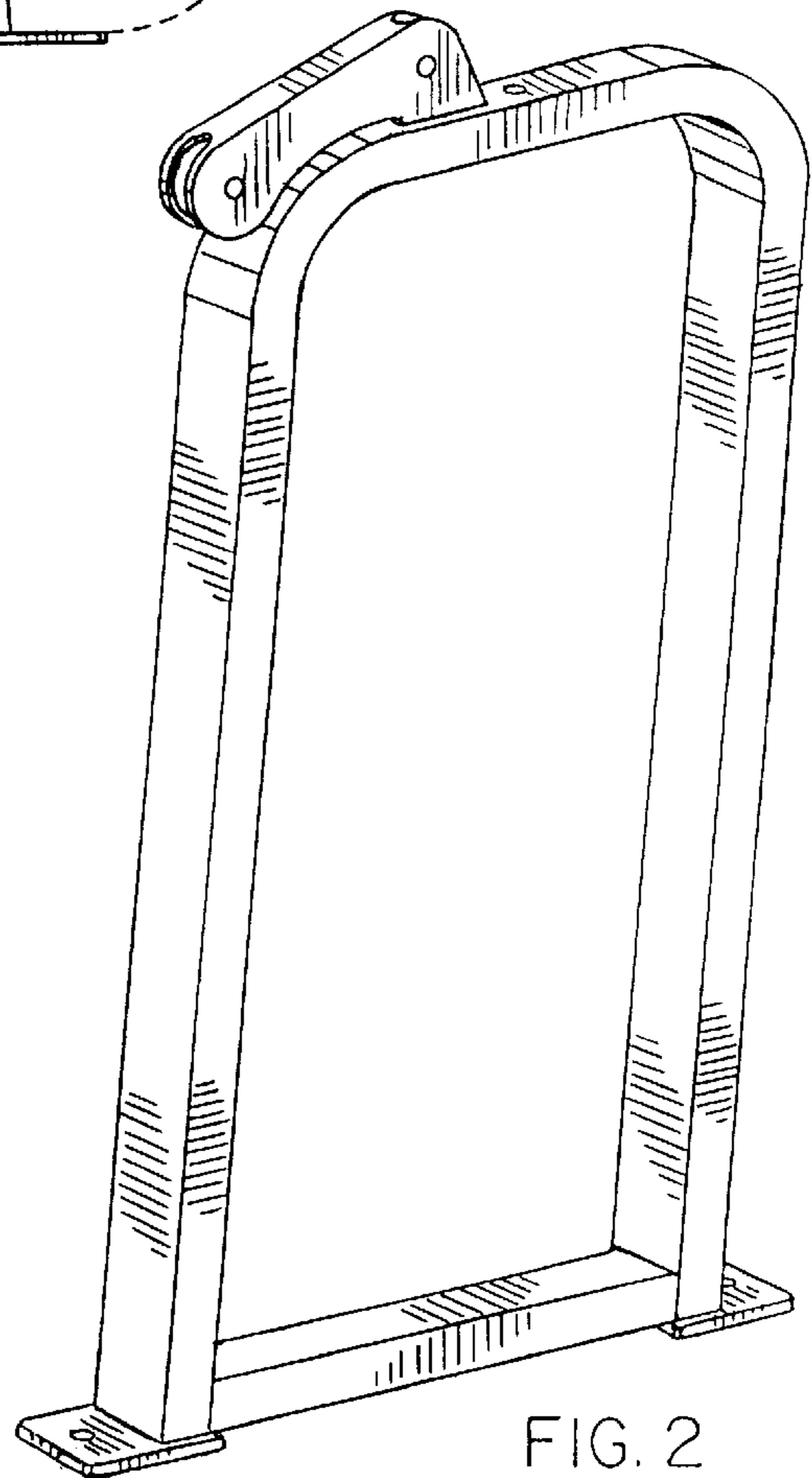
