(57) **CLAIM**

The ornamental design for a resin building, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a resin building showing my new design;

FIG. 13 is a right side view thereof;

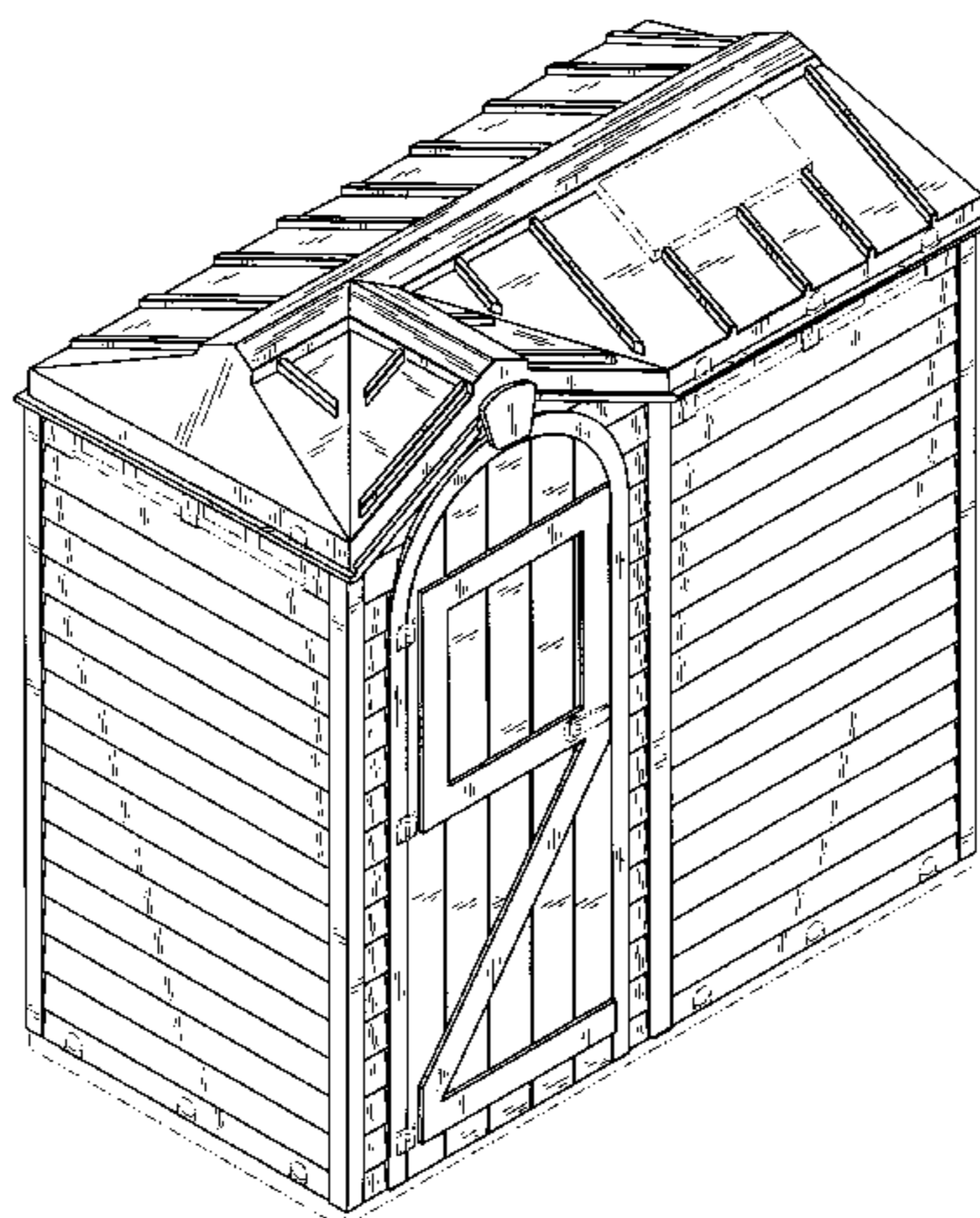
FIG. 14 is a back view thereof;

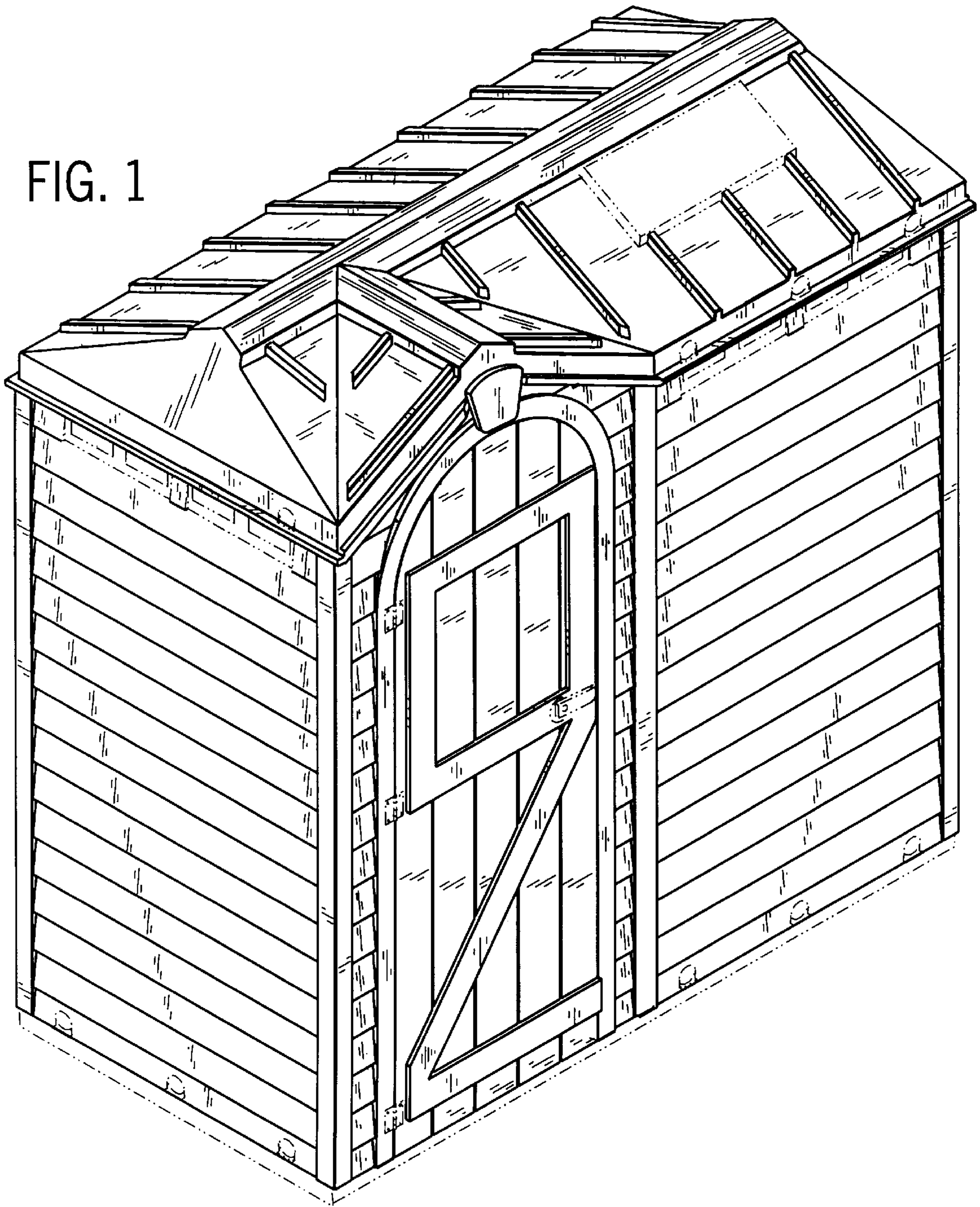

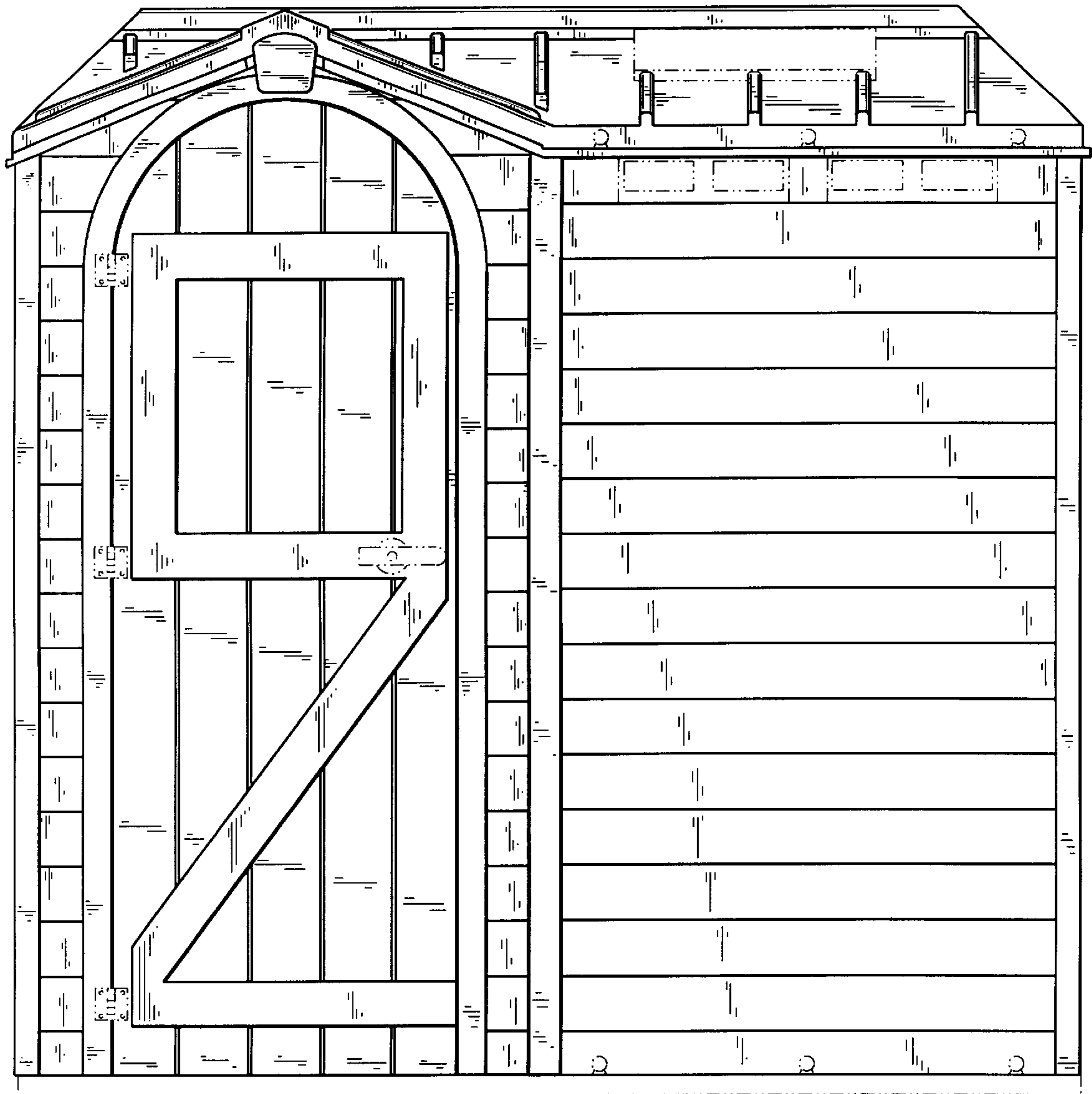

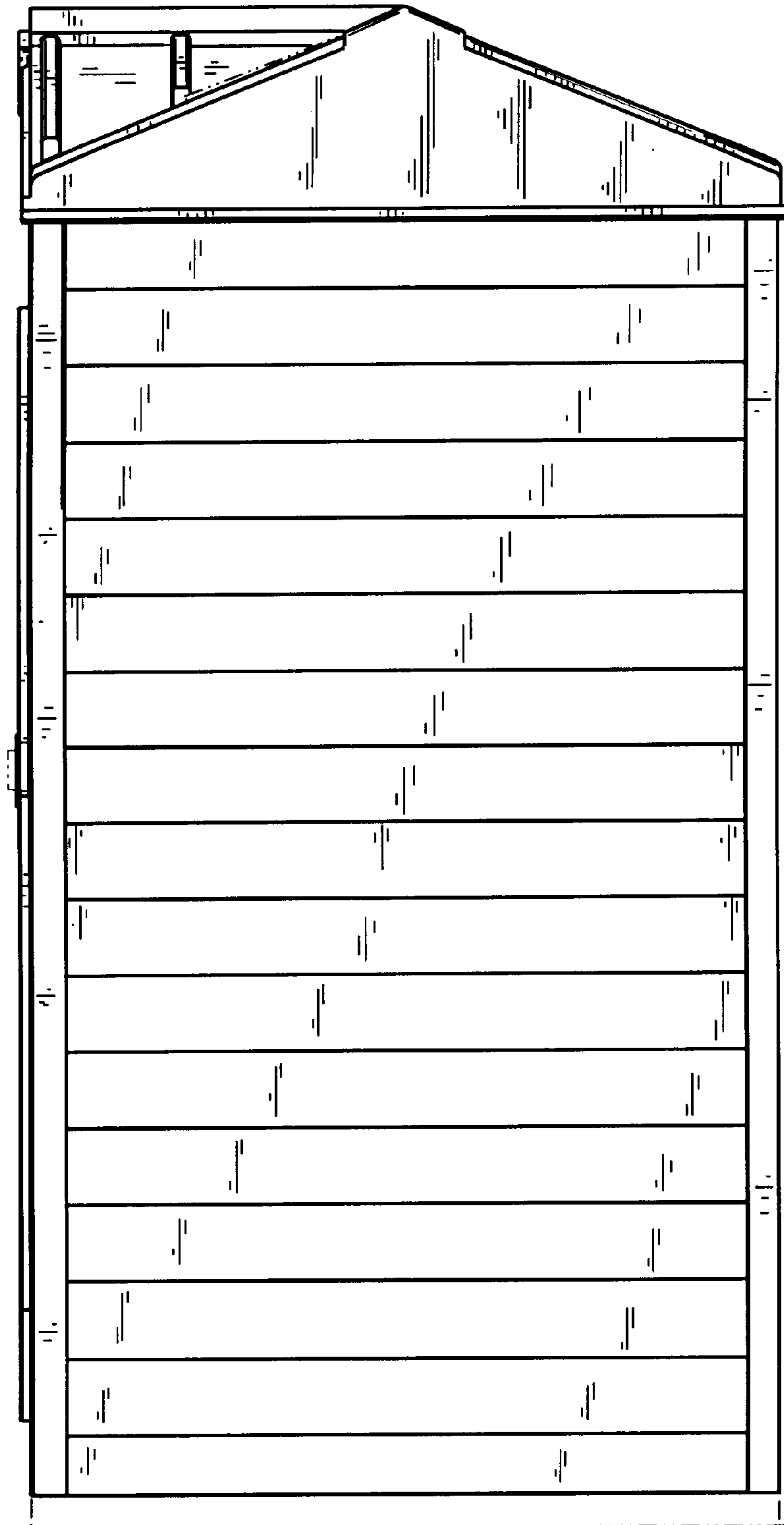

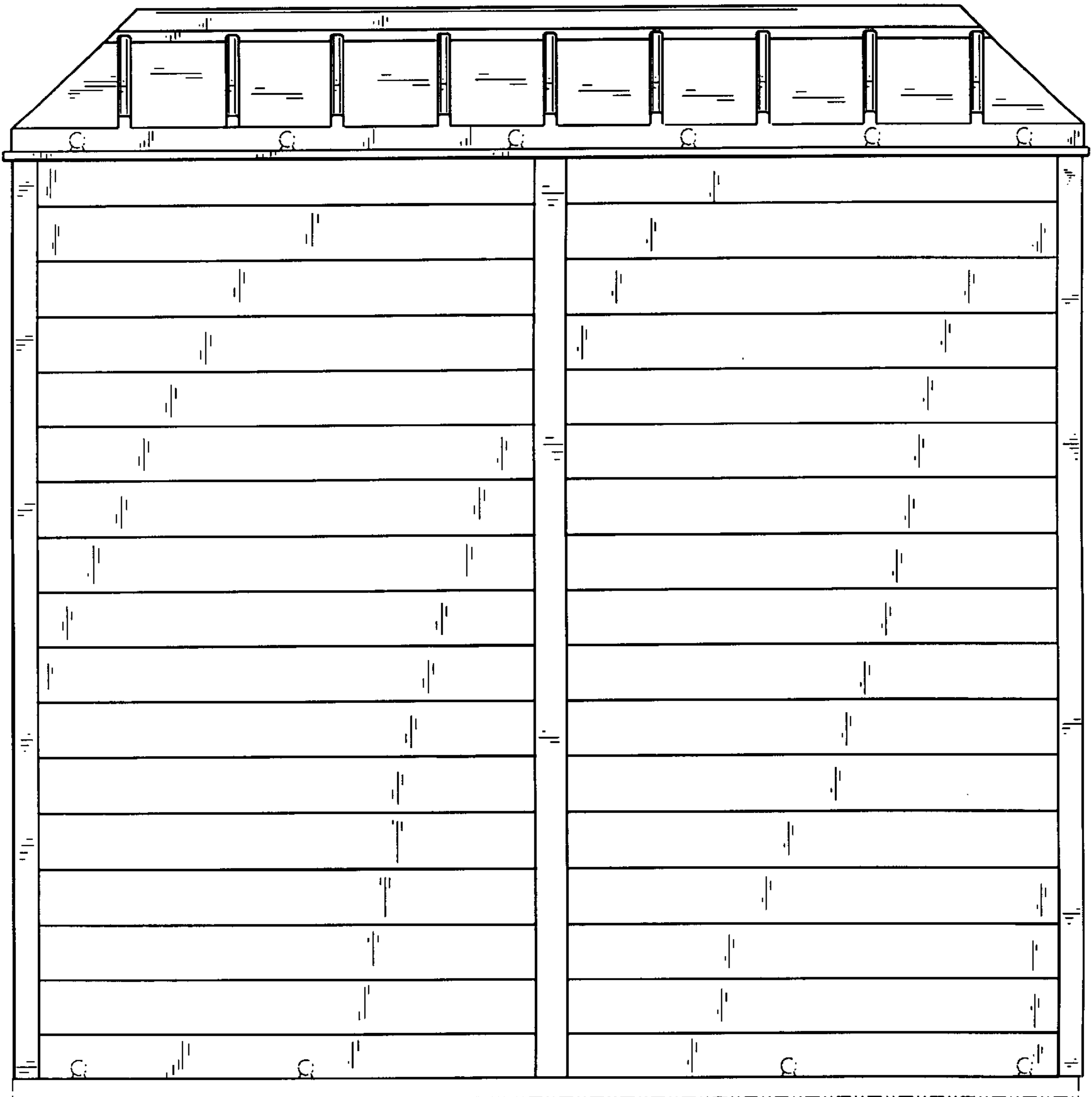

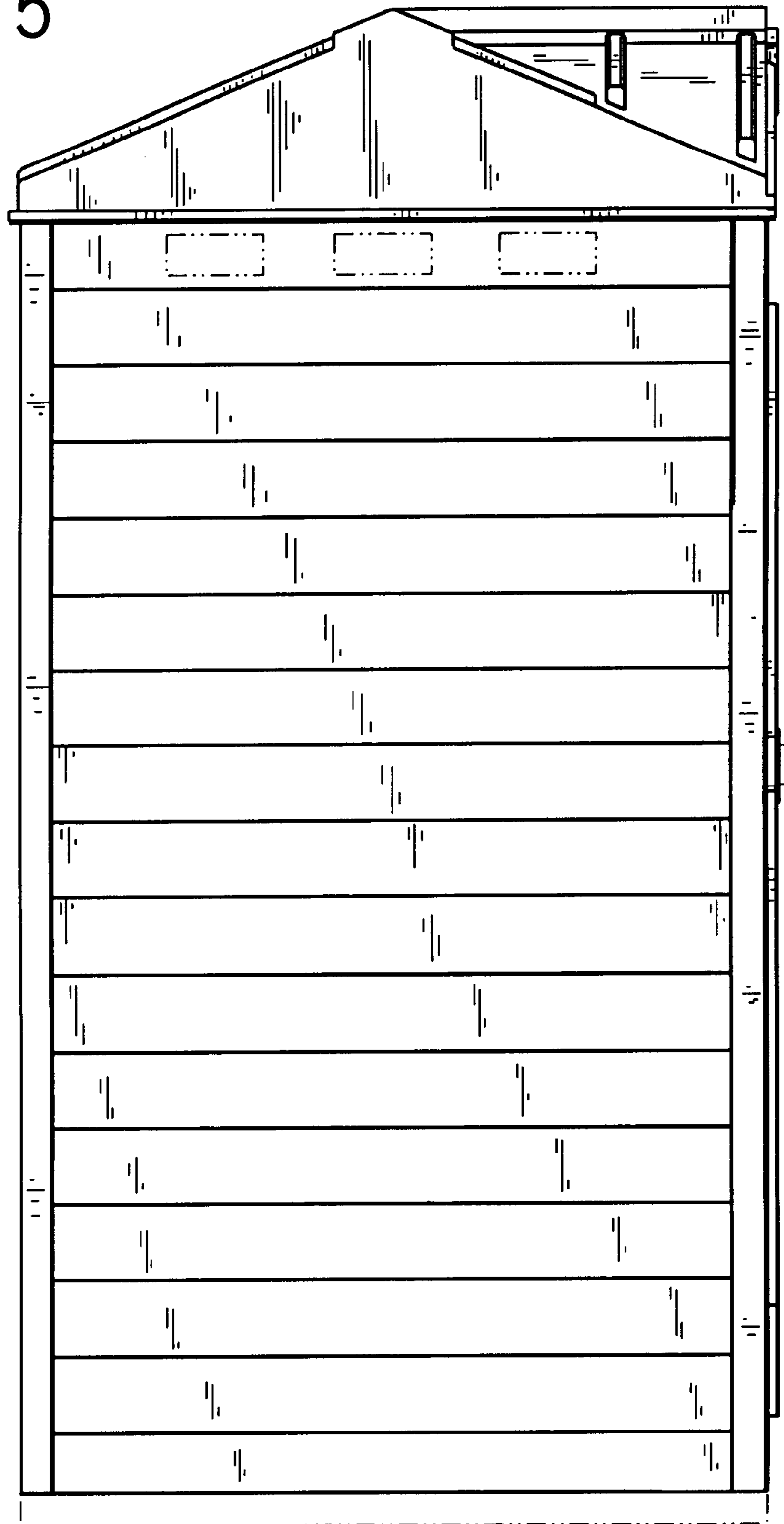

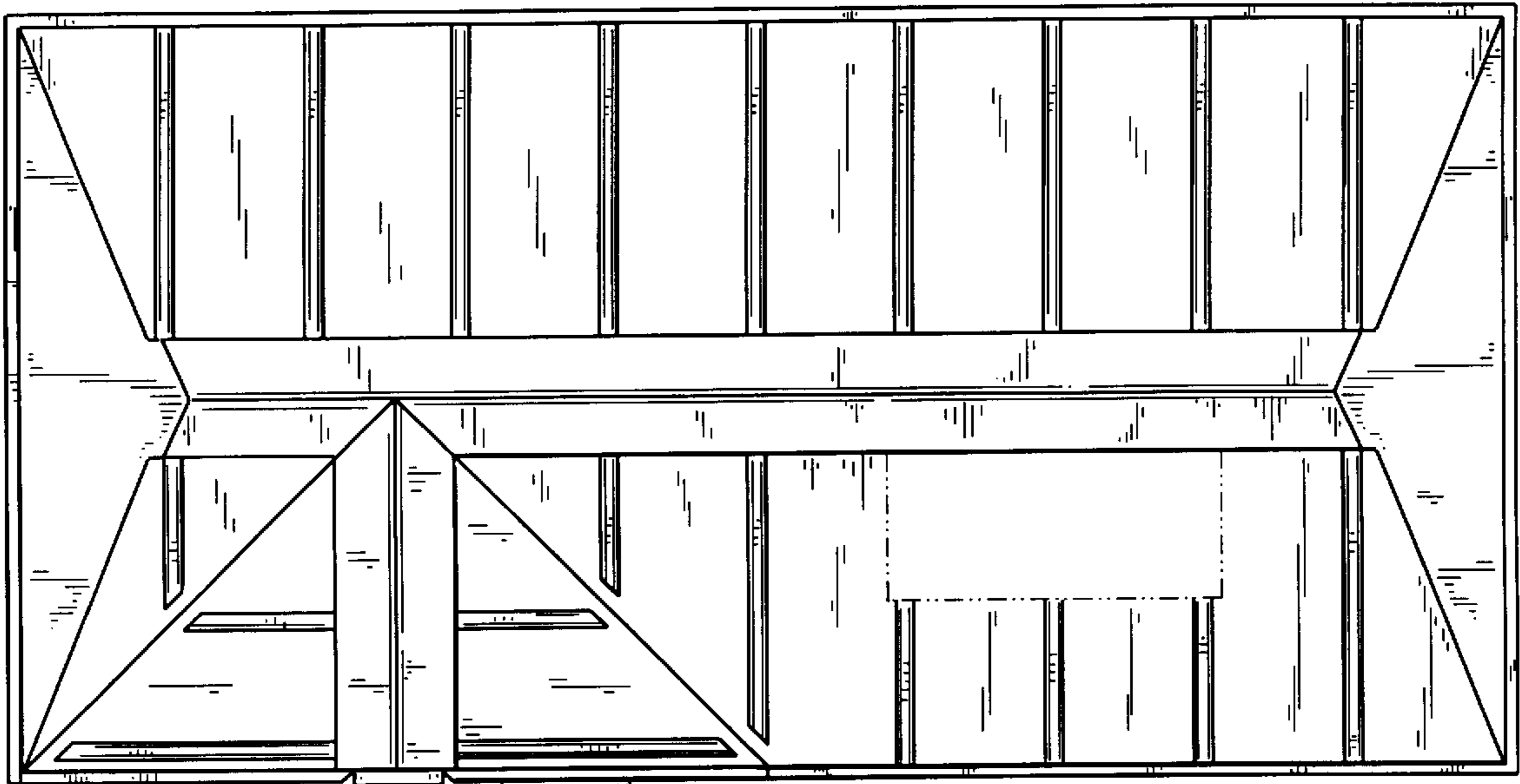

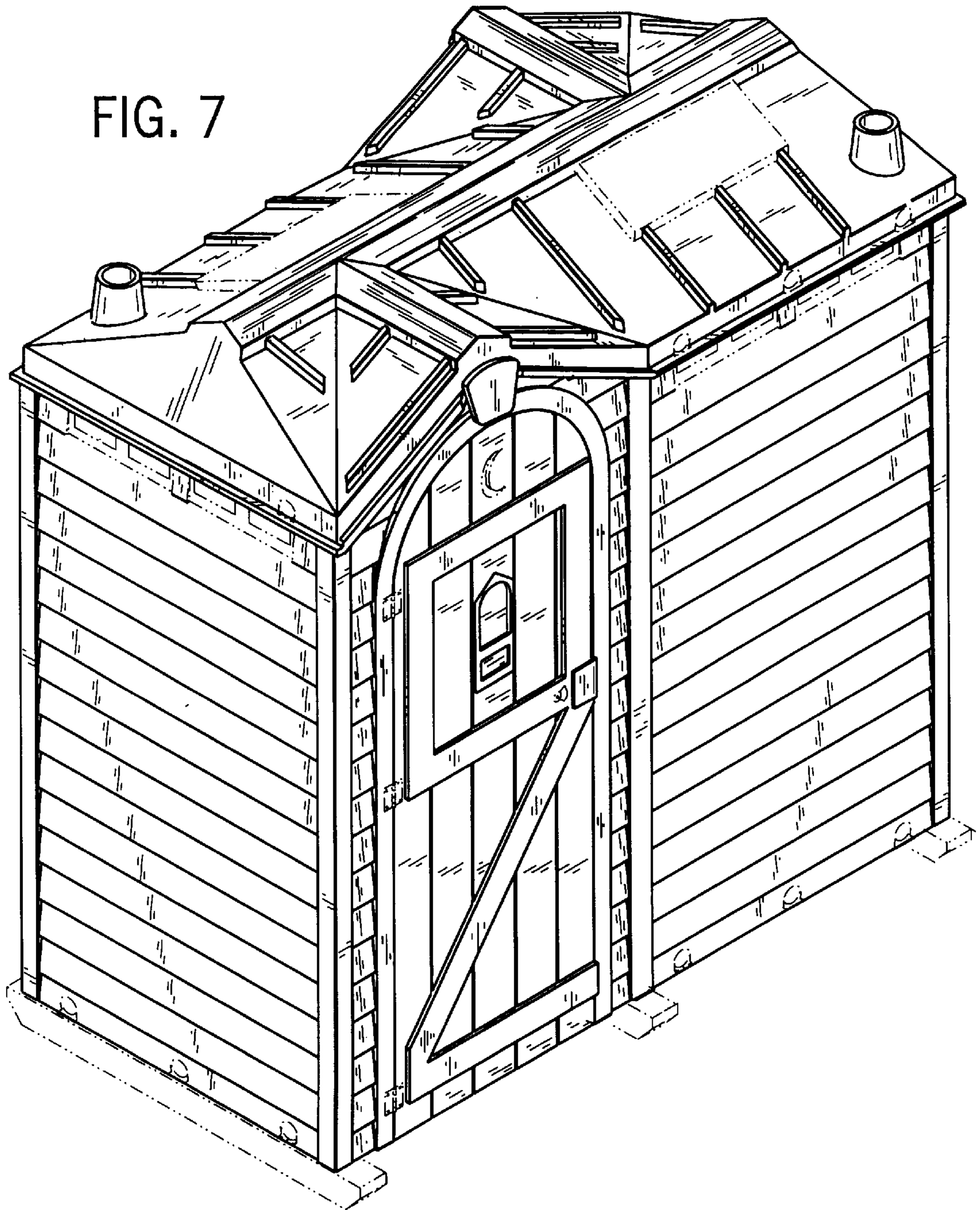

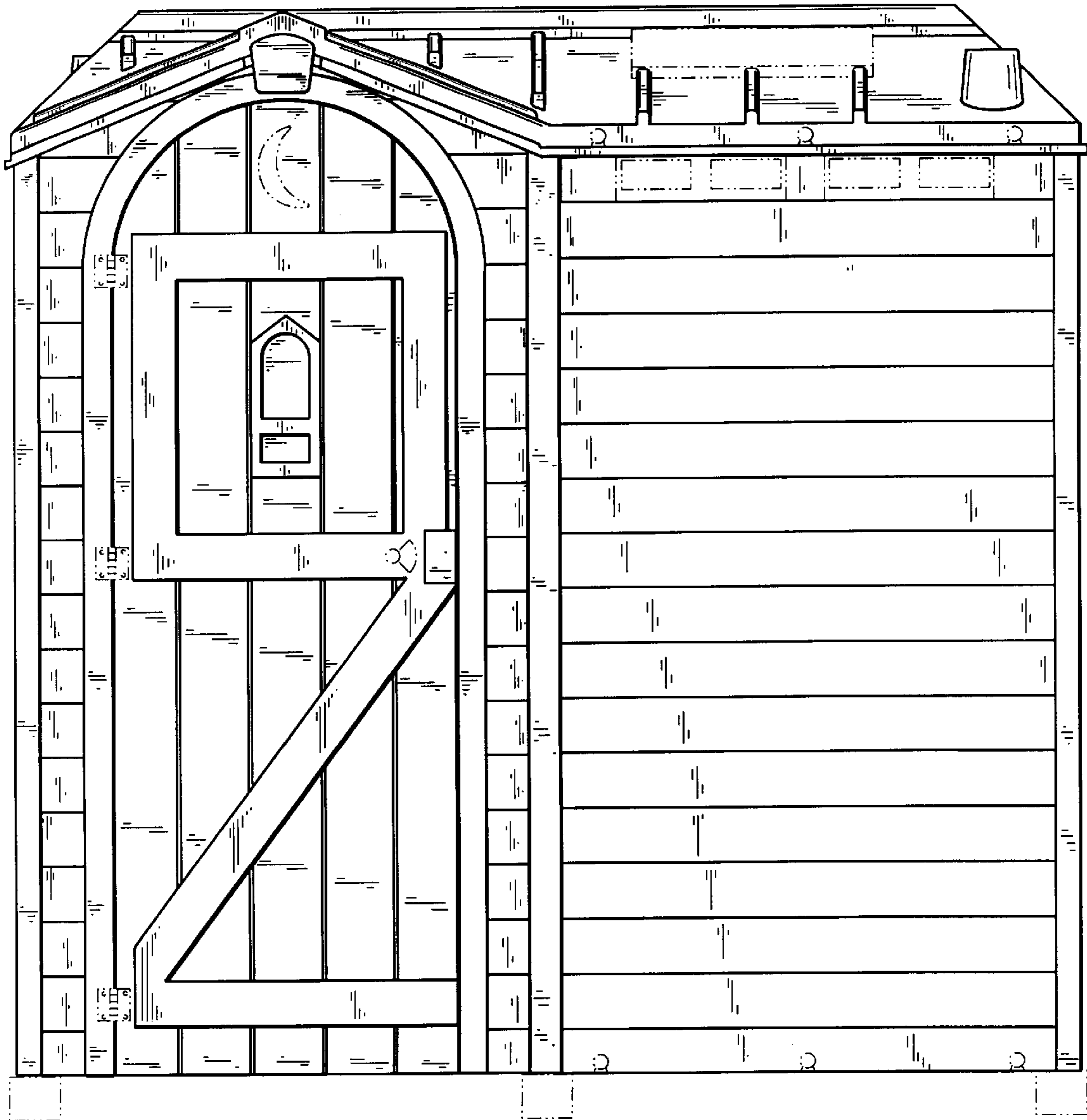

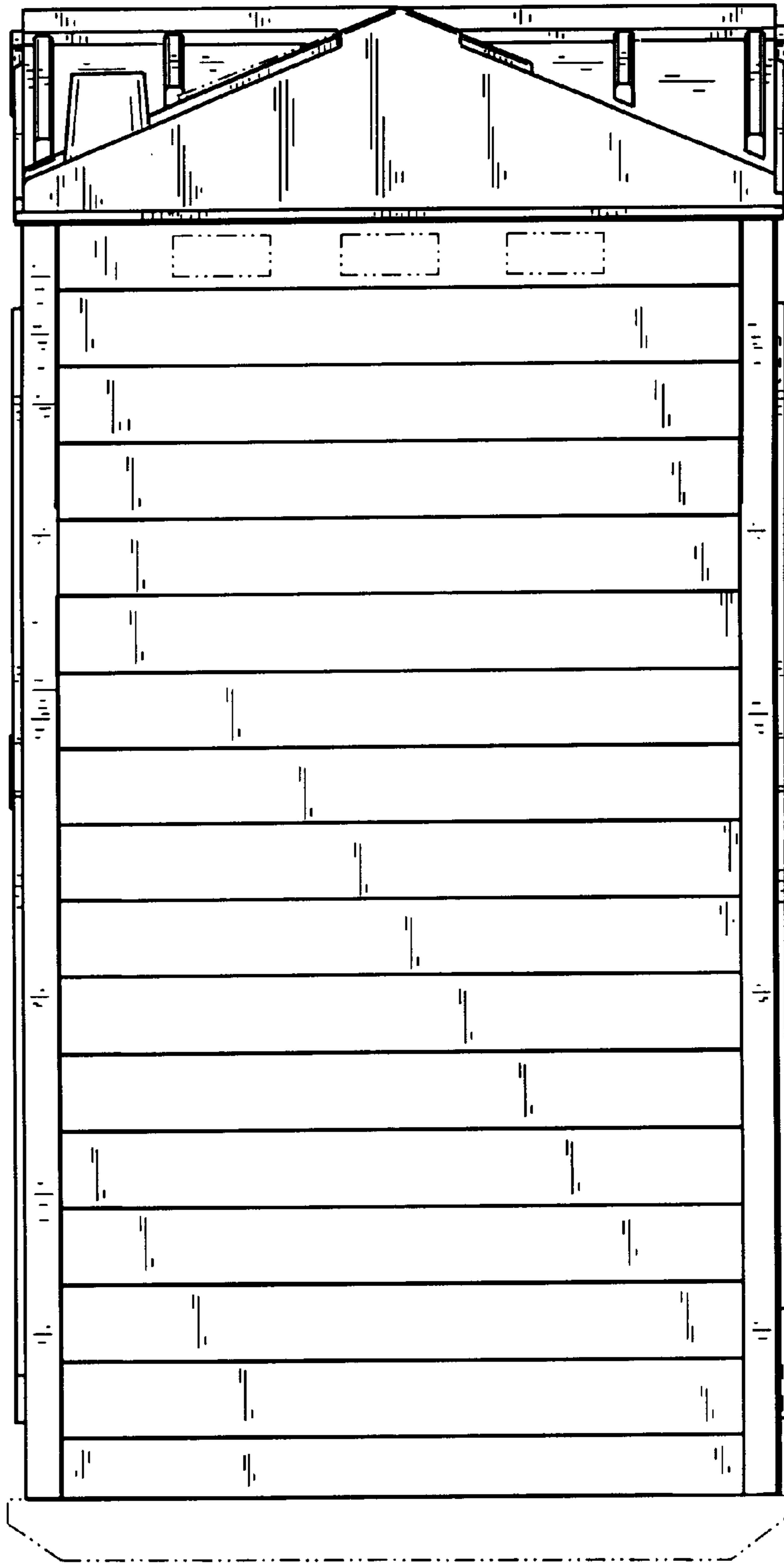

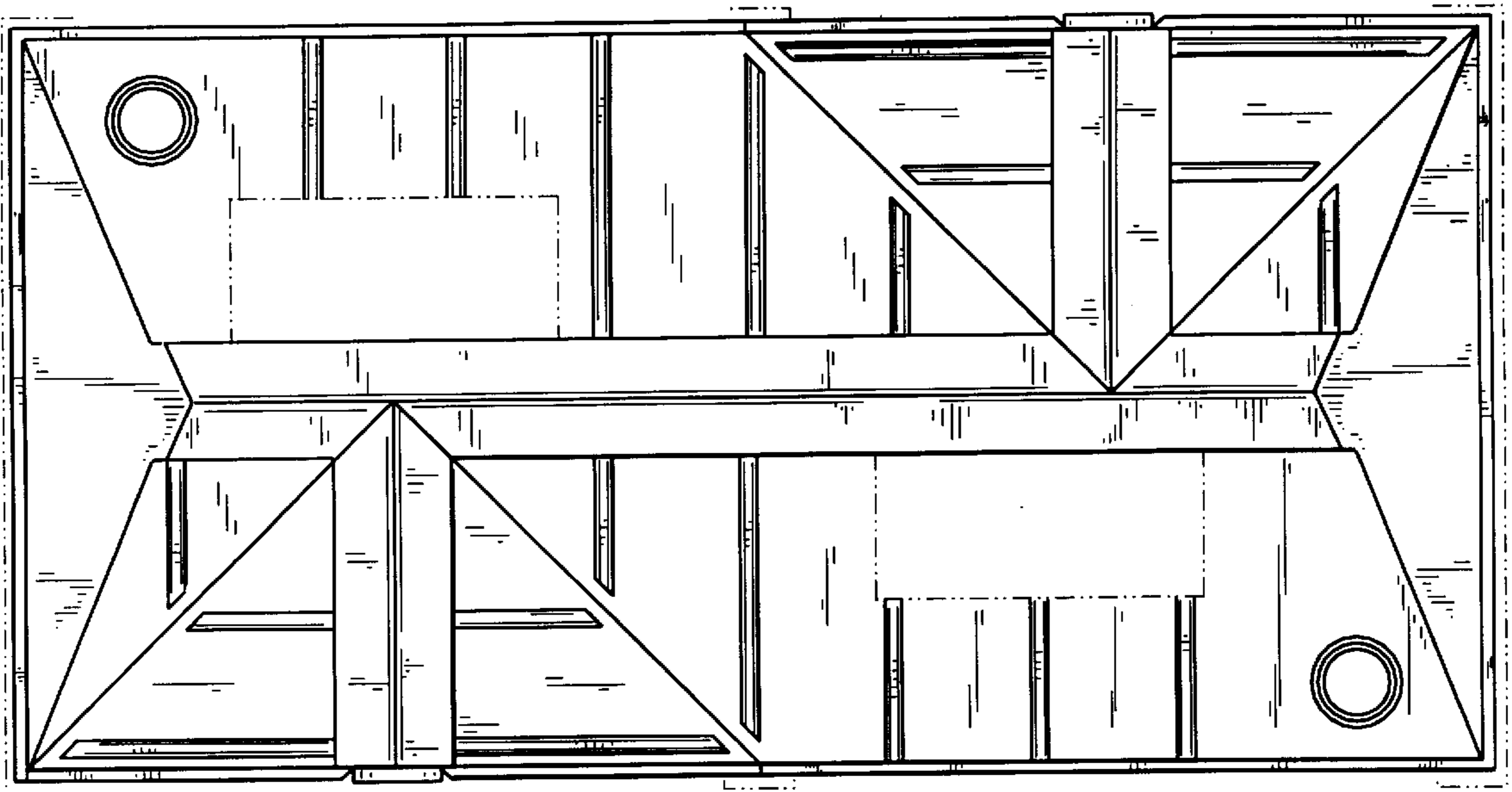

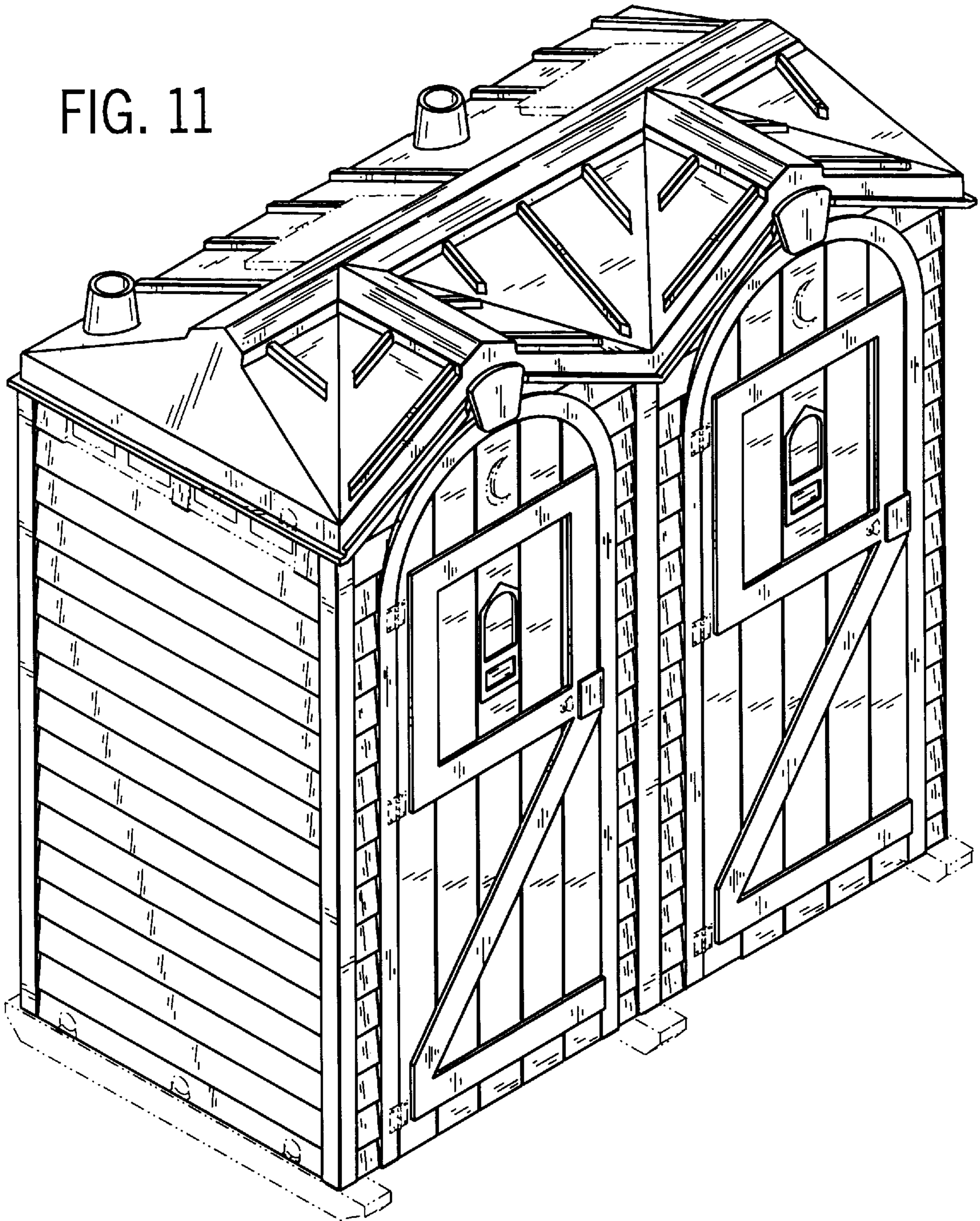

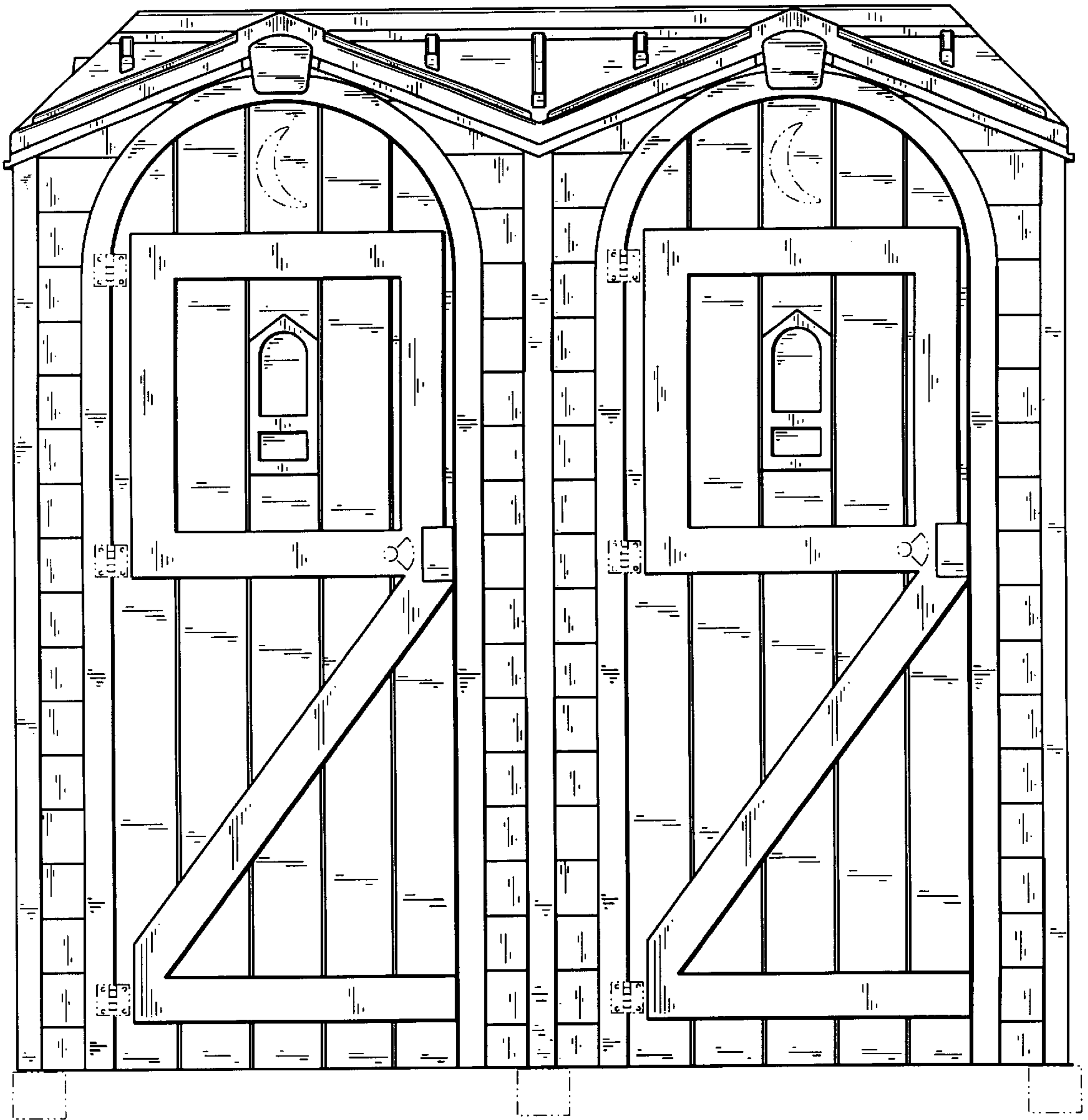

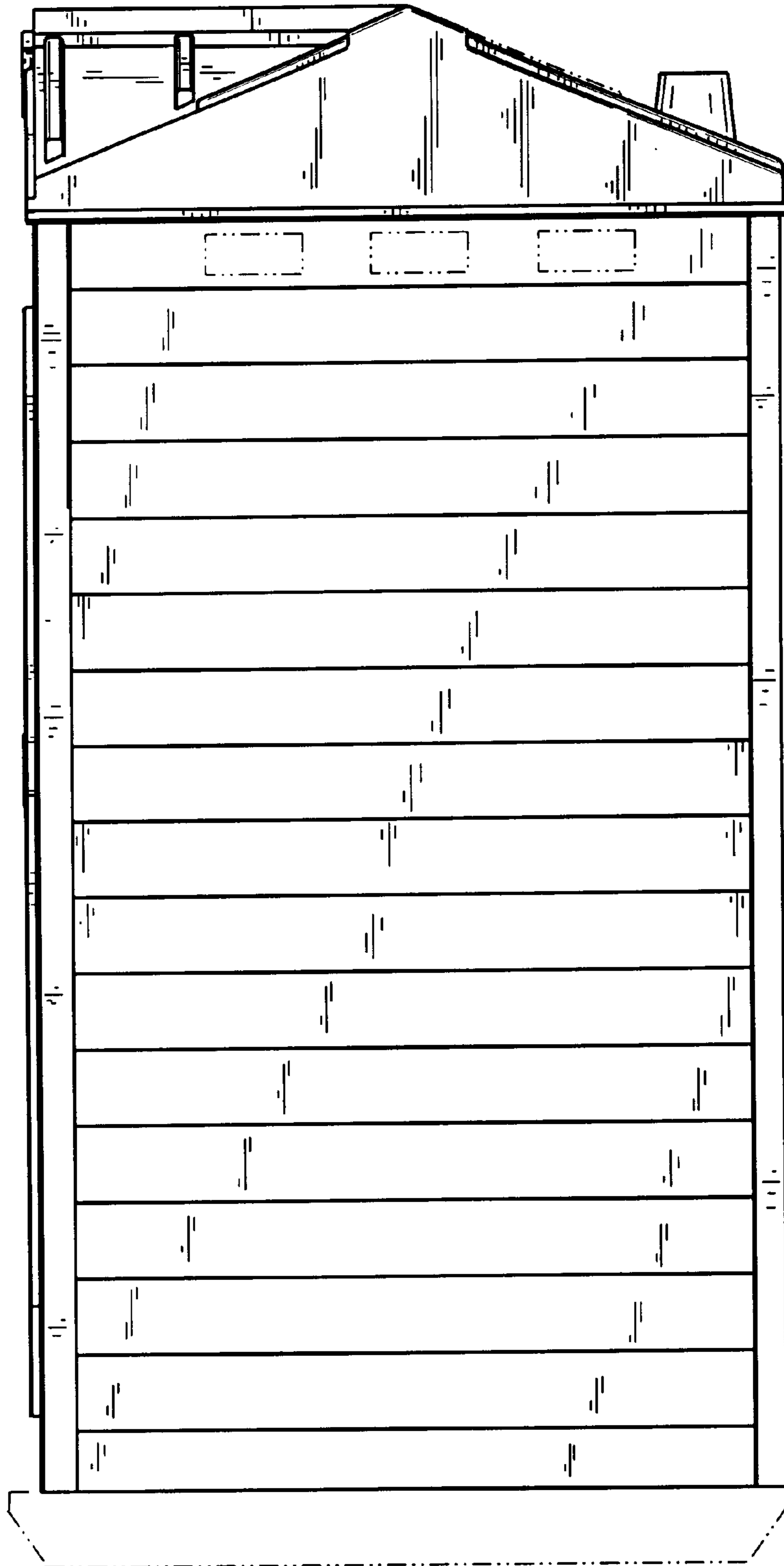

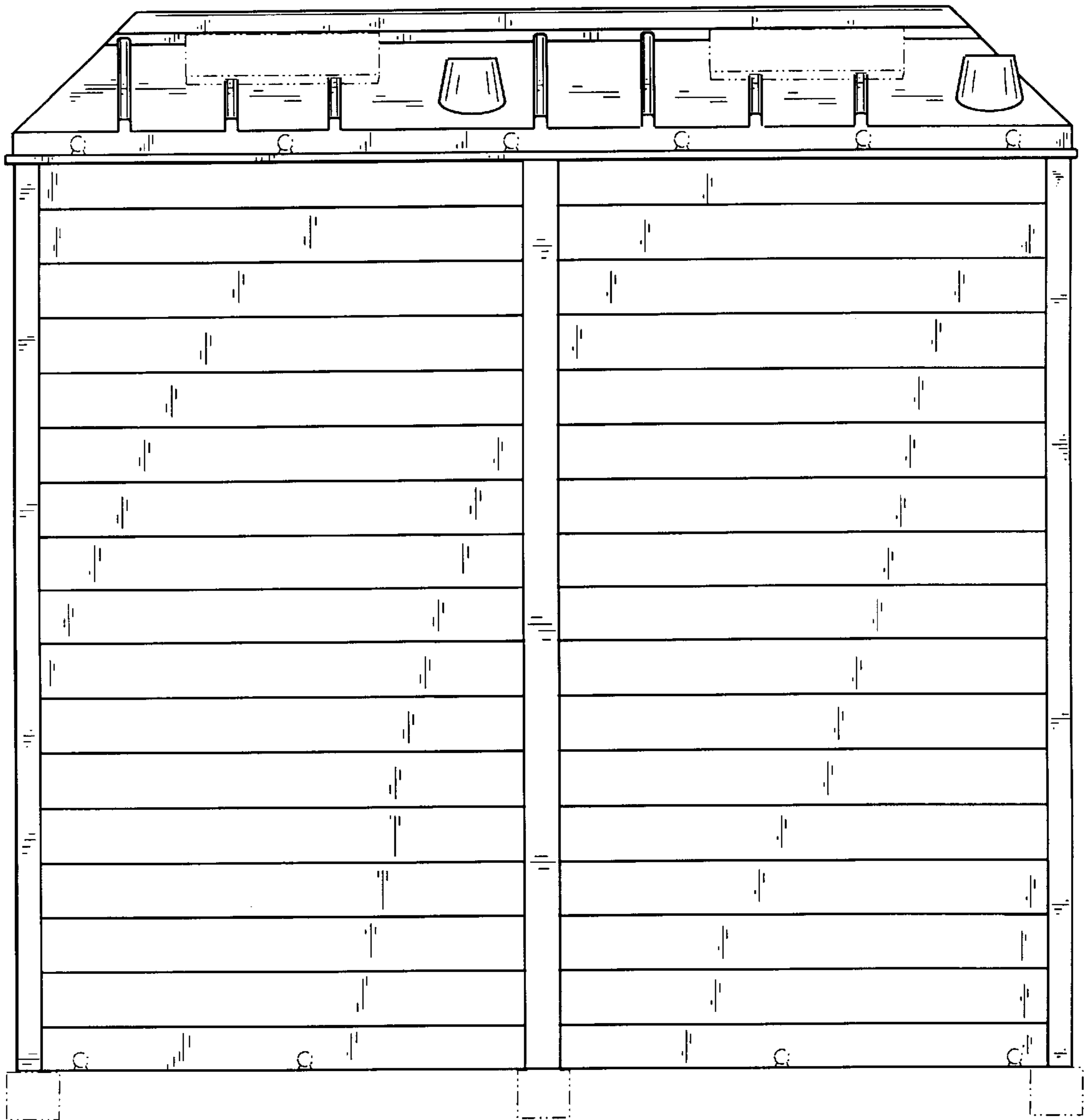

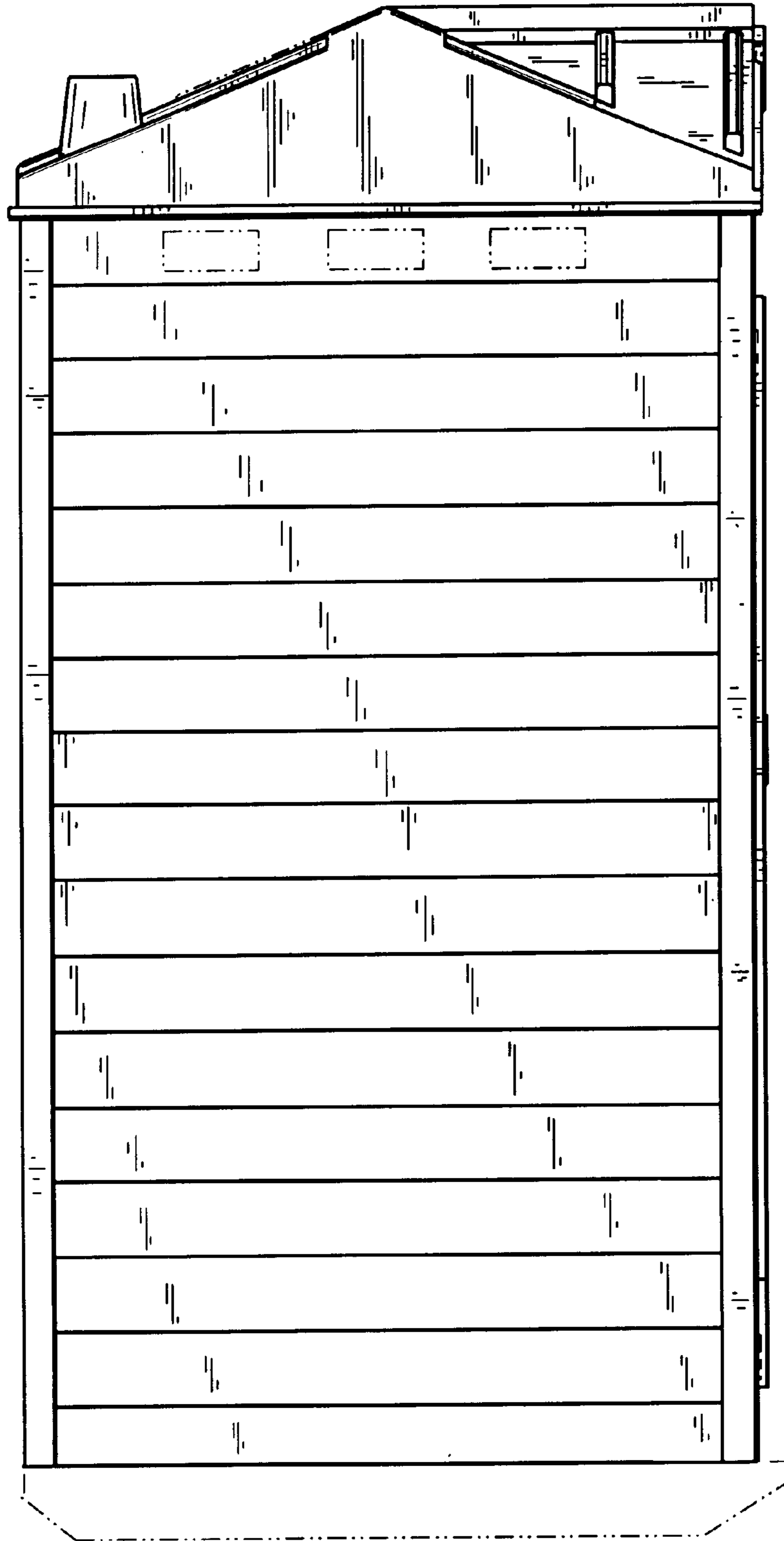
