The ornamental design for a hair accessory, as shown and described.

DESCRIPTION

FIG. 1 is a top and right side perspective view of the hair accessory of the invention;
FIG. 2 is a partial end view thereof shown for ease of illustration, the opposite end view is a mirror image;
FIG. 3 is a top view thereof; and,
FIG. 4 is a partial front view of FIG. 2, shown for ease of illustration, the rear is a mirror image.

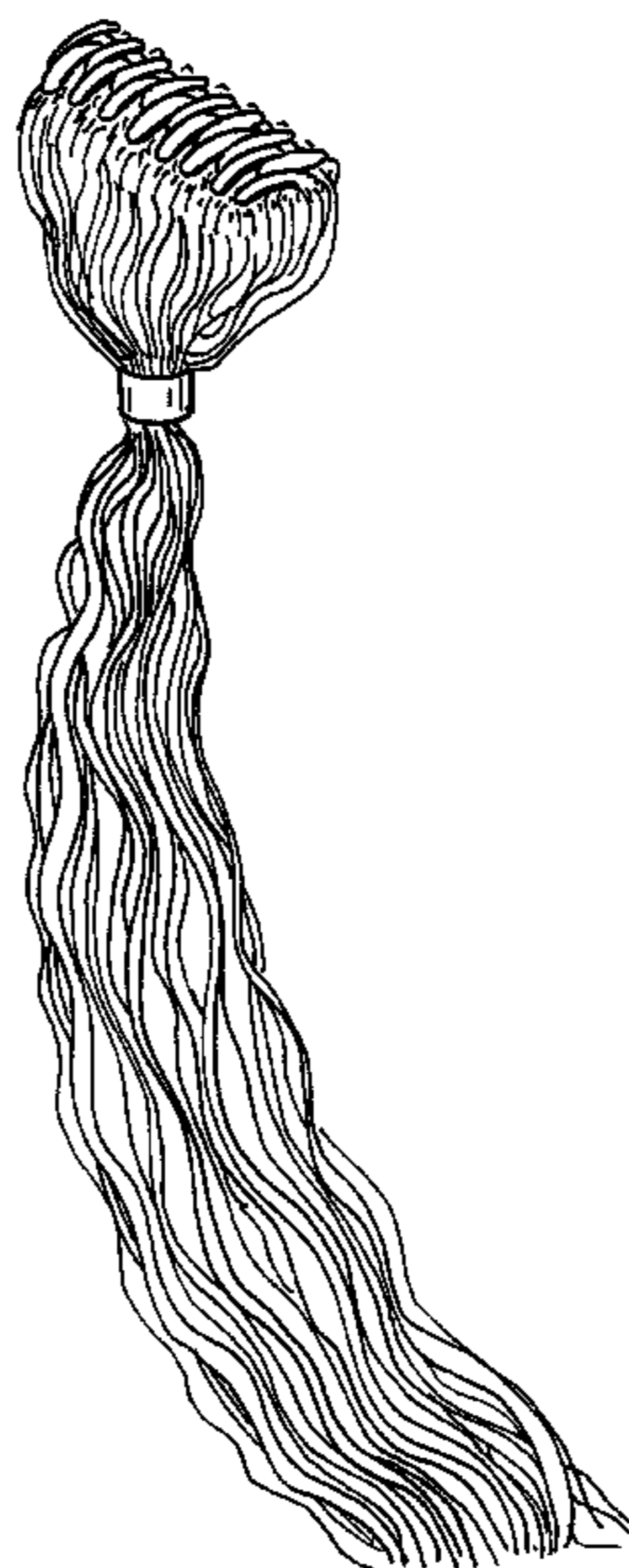

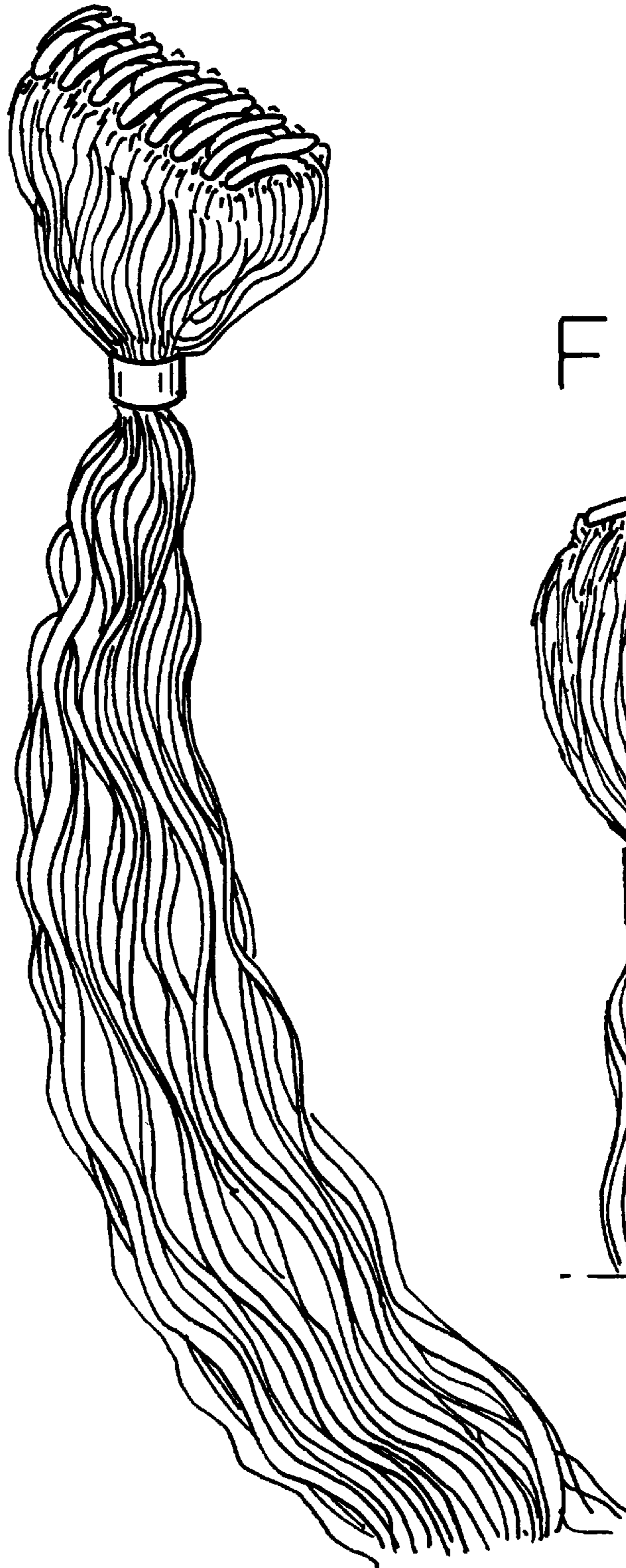

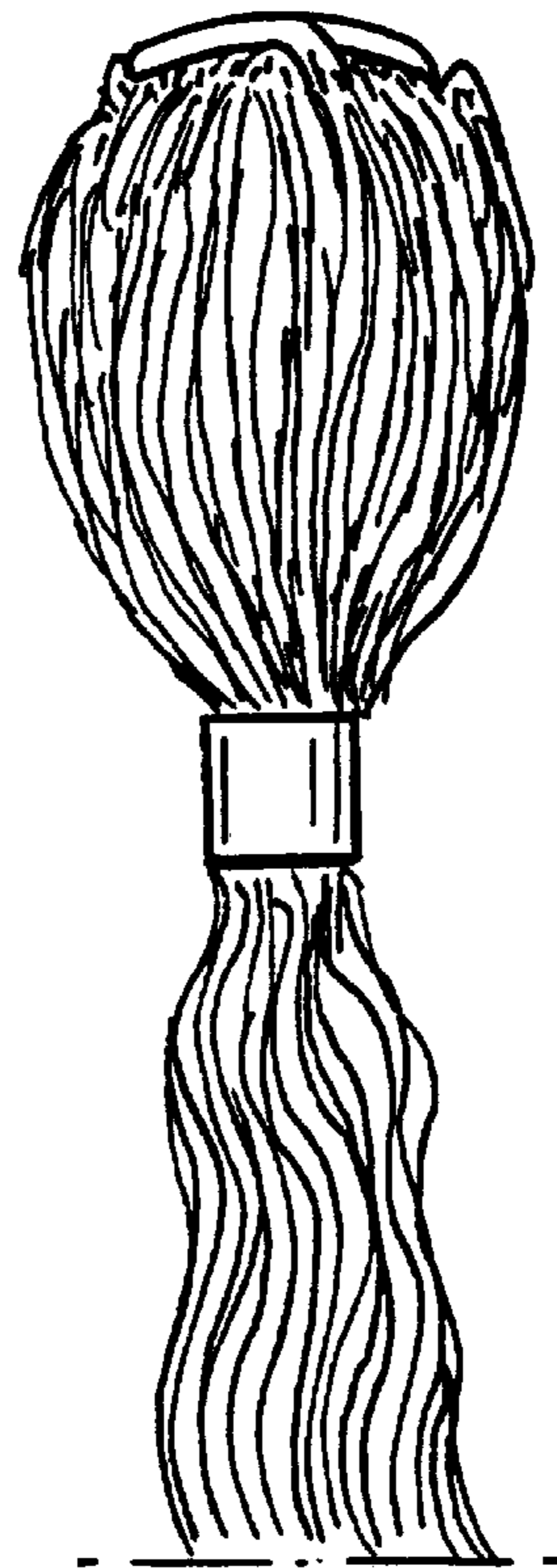

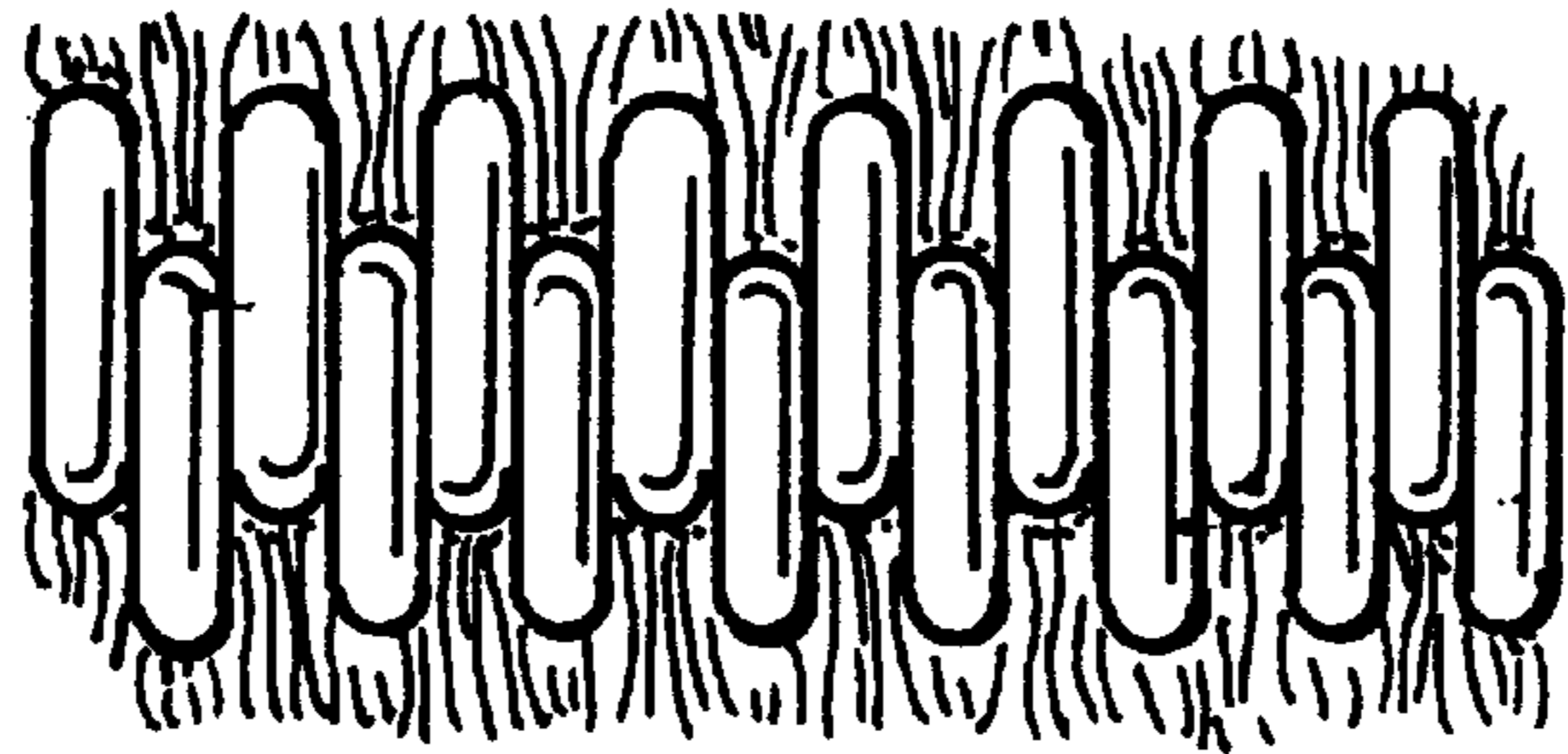
