(57) **CLAIM**

The ornamental design for a portion of a disk holder, as shown and described.

DESCRIPTION

The entire disclosure of UK Design Registration No. GB2084369, filed Jun. 24, 1999, is incorporated herein by reference.

FIG. 1 is a perspective view of a portion of a disk holder showing our new design, the broken lines showing a closed digital video disc (DVD) box being illustrative of the environment, and forming no part of the claimed design; FIG. 2 is a perspective view thereof; the unclaimed box shown in a partially open position; FIG. 3 is an inside elevational view thereof; the unclaimed box shown in a fully open position; FIG. 4 is a front view of the disk holder of FIG. 1; FIG. 5 is a rear view of the disk holder of FIG. 1; and, FIGS. 6 and 7 are side views of the disk holder of FIG. 1. The broken lines are provided in the drawings merely for illustrating an environment in which the invention may be used. The broken lines do not form part of the design sought to be patented.

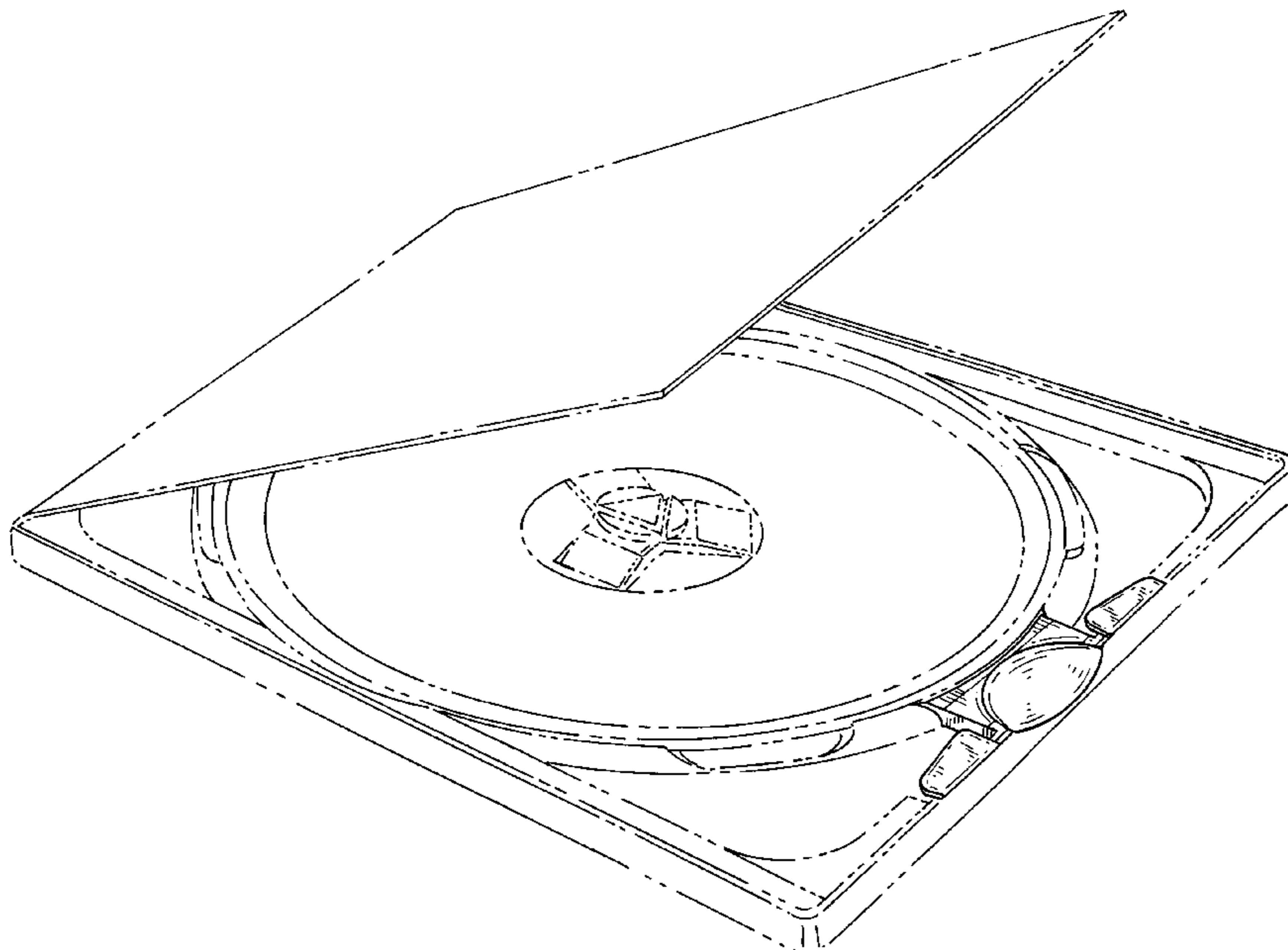
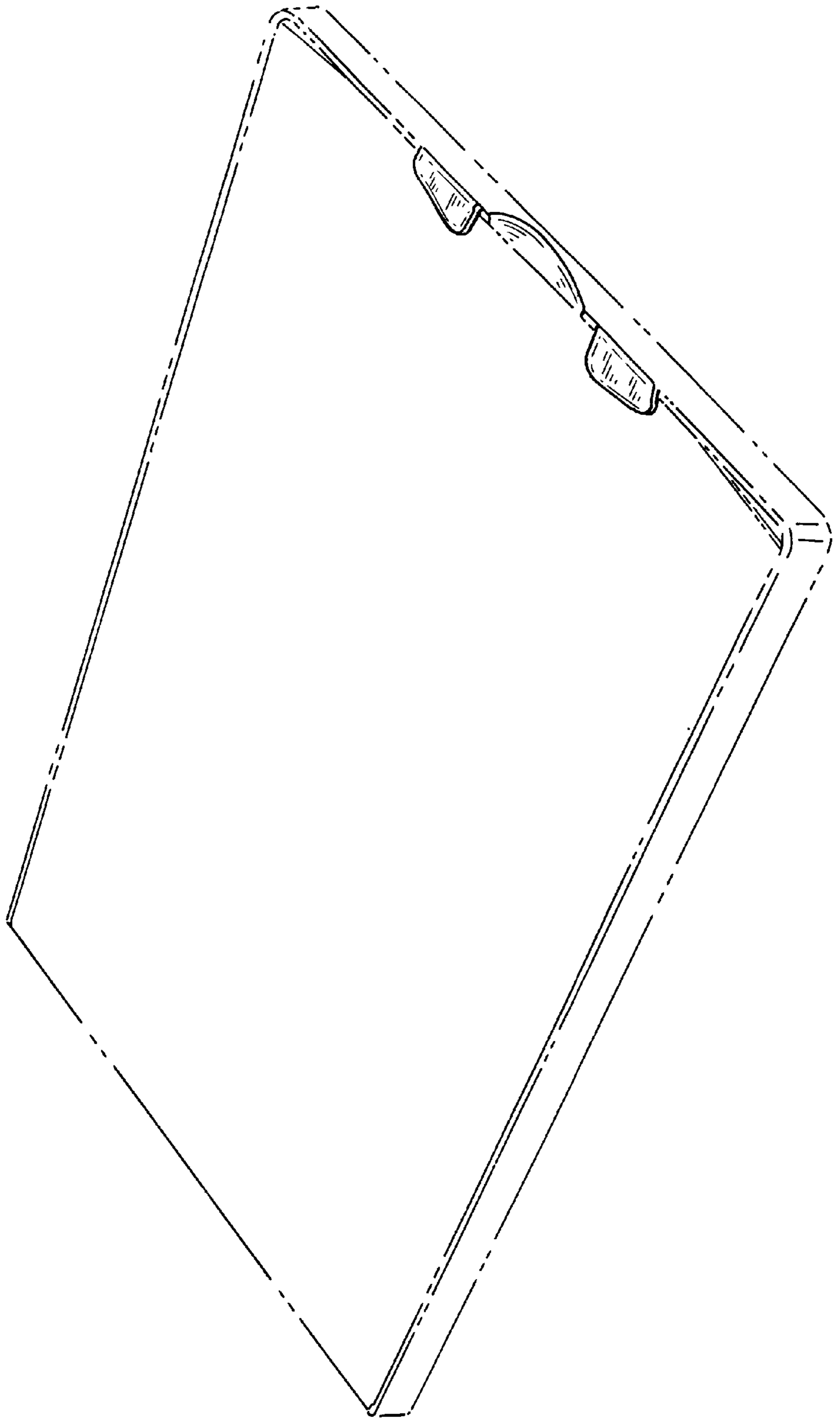

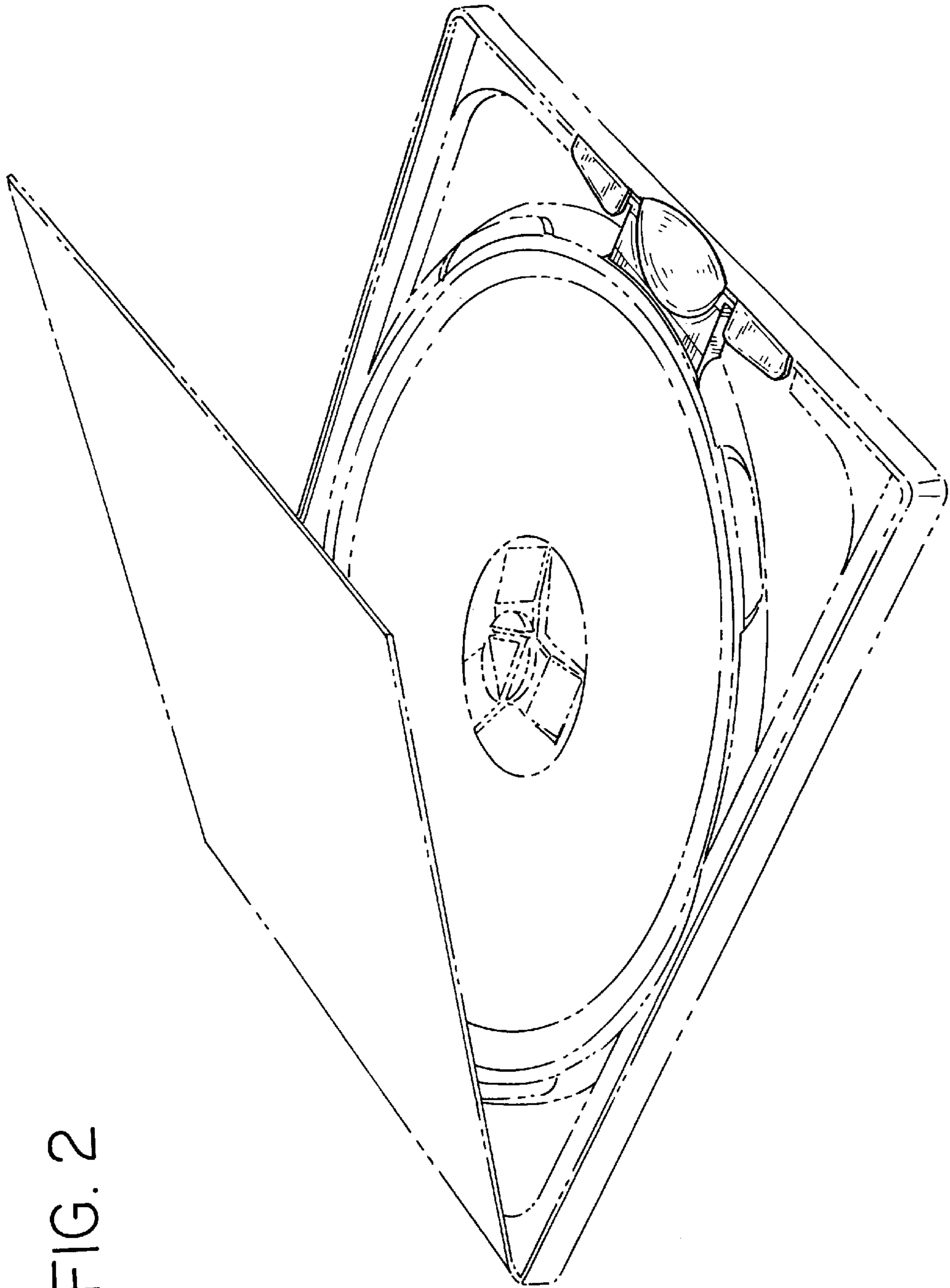

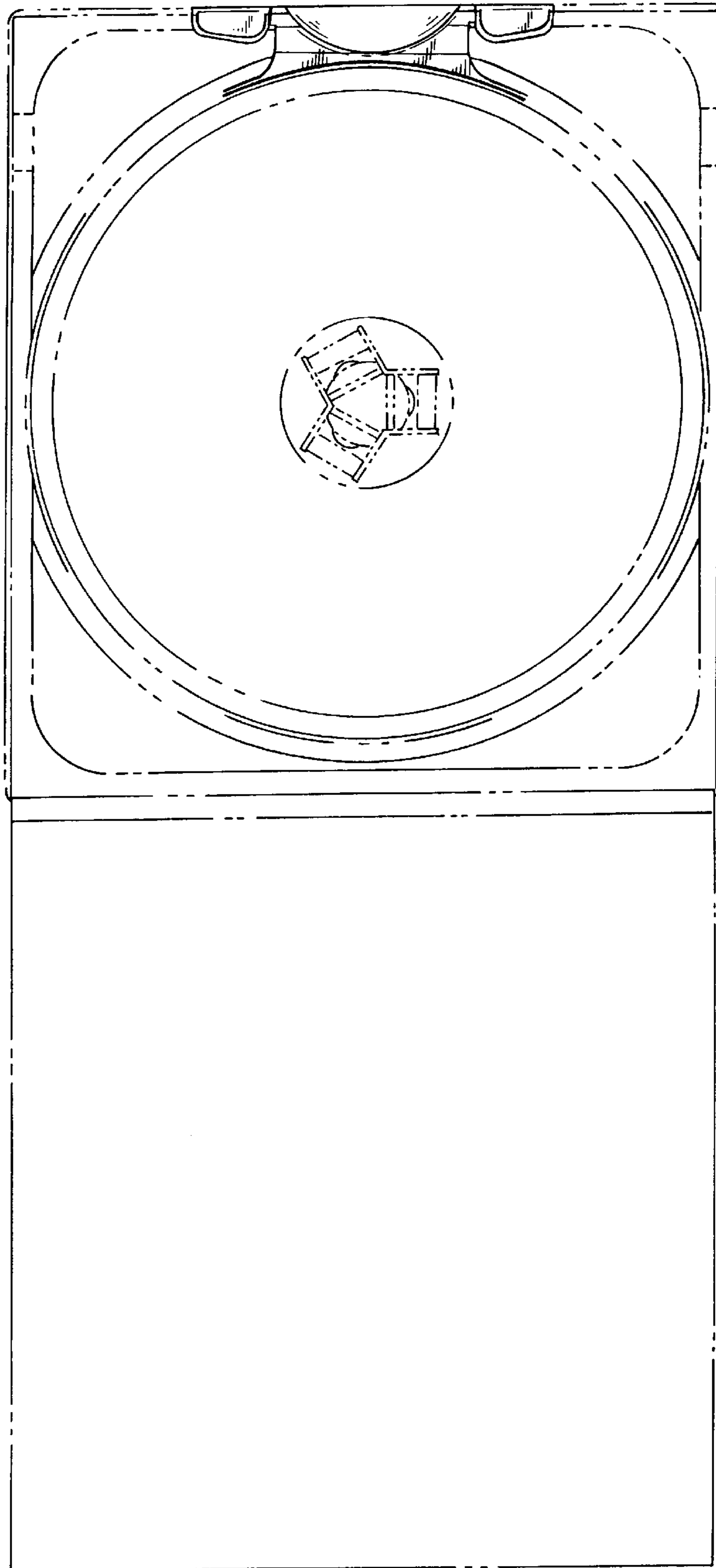

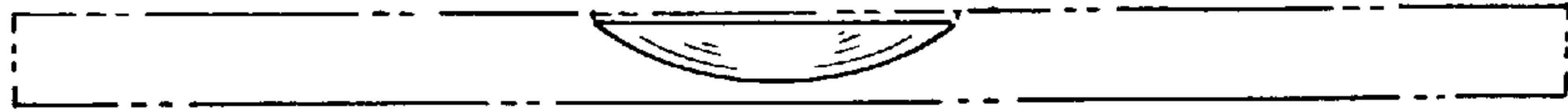

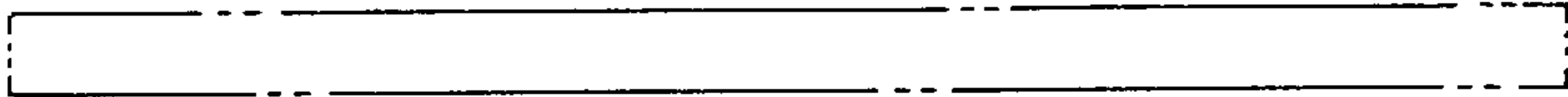
