The ornamental design for a truck body, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a truck body according to the invention. The opposite side elevational view is a mirror image of the view shown in FIG. 1.

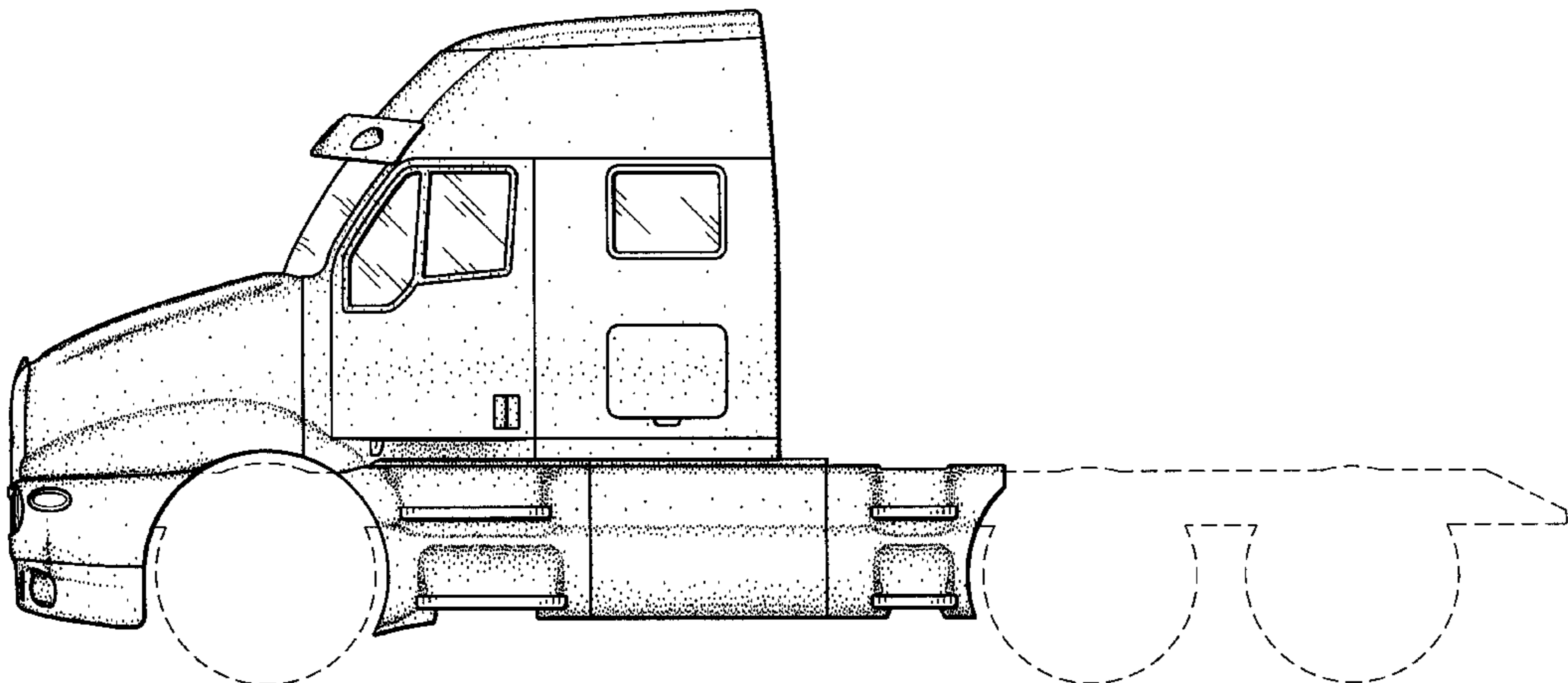
FIG. 2 is a top view of the truck body of FIG. 1.

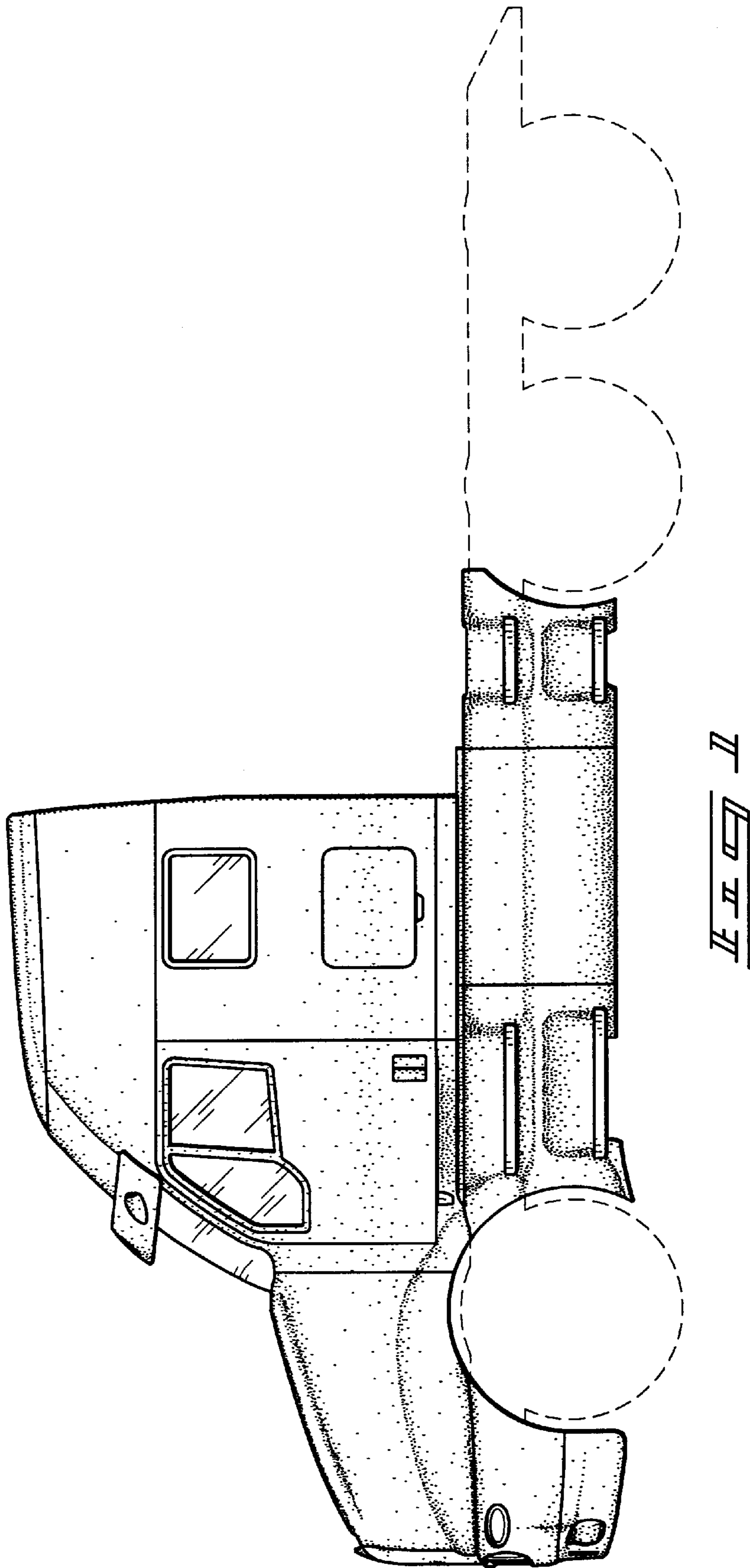

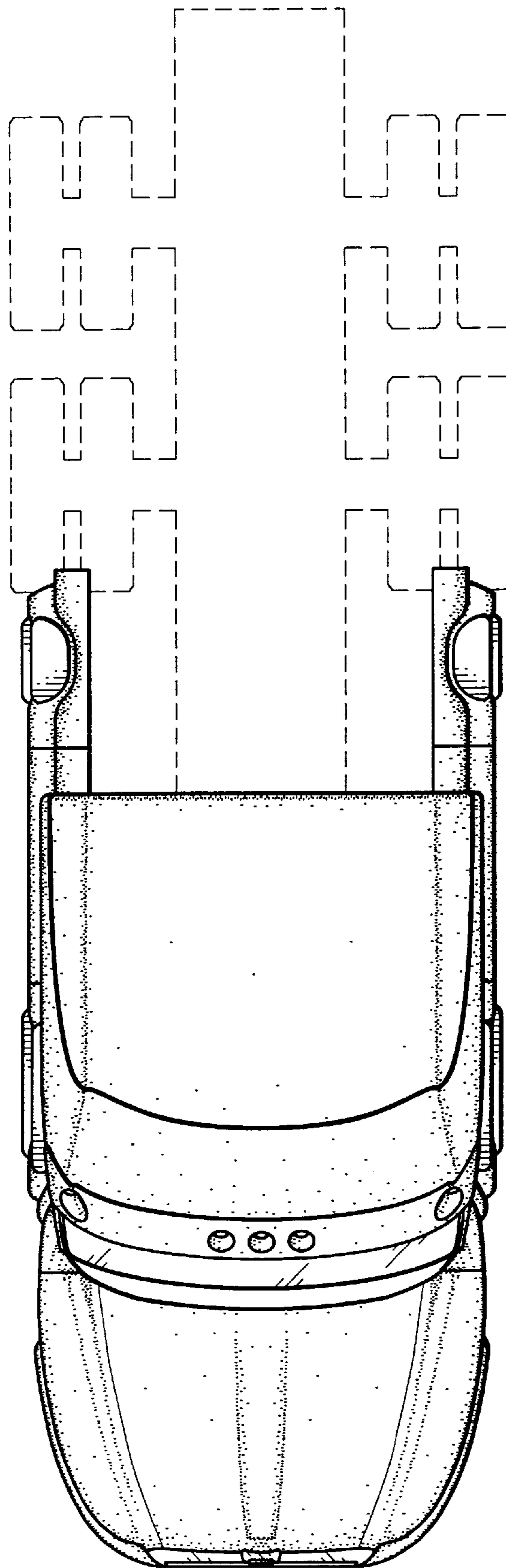
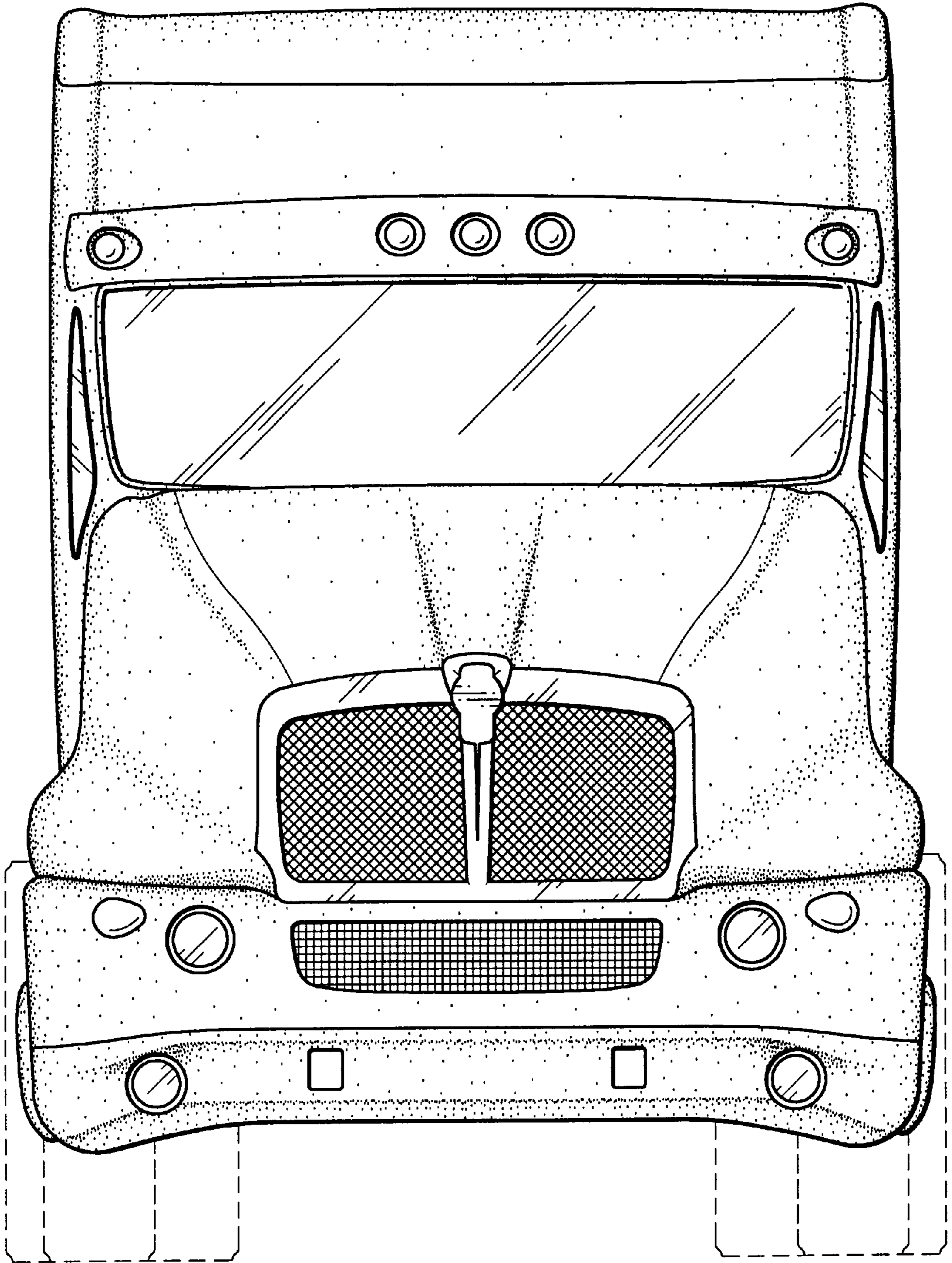

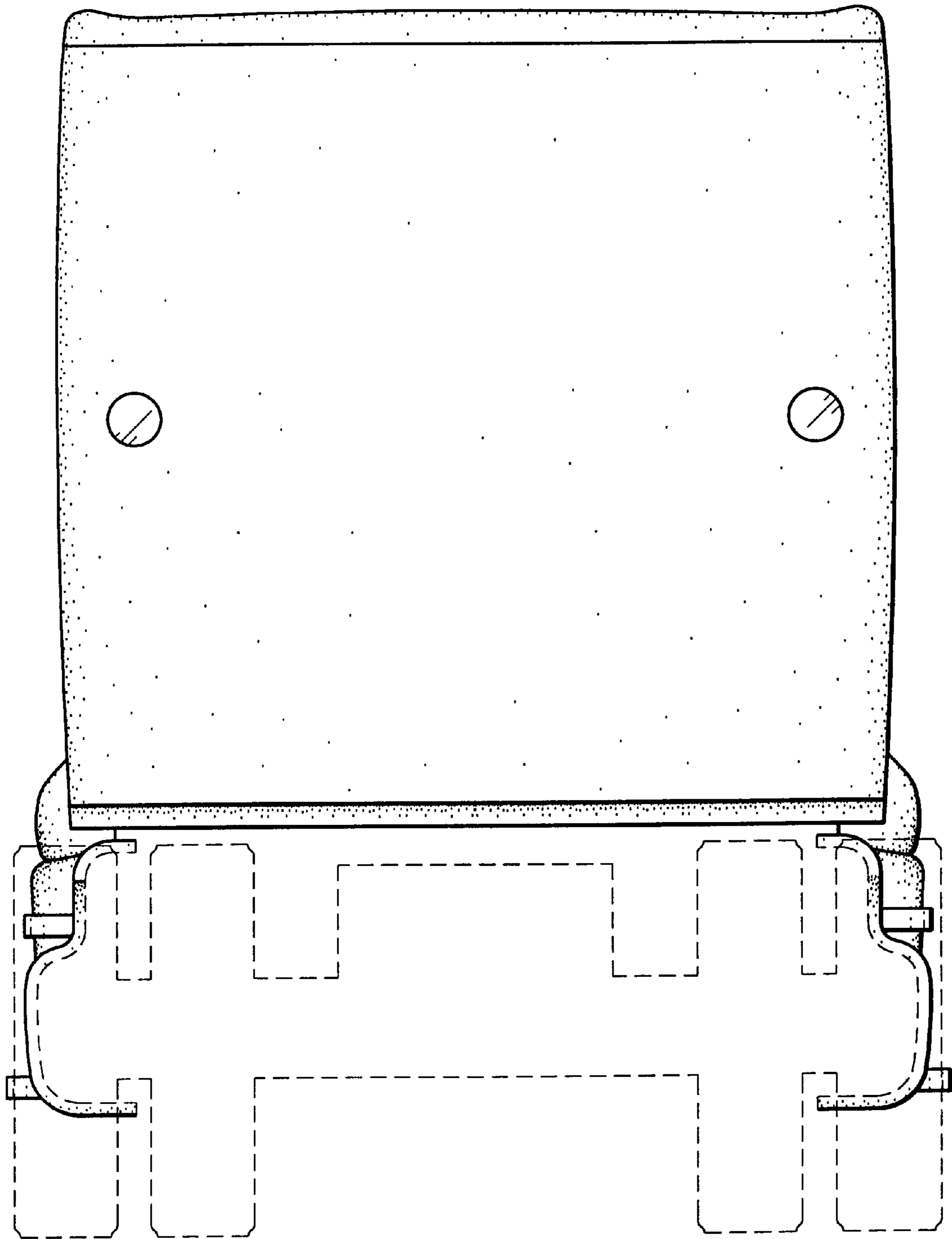
