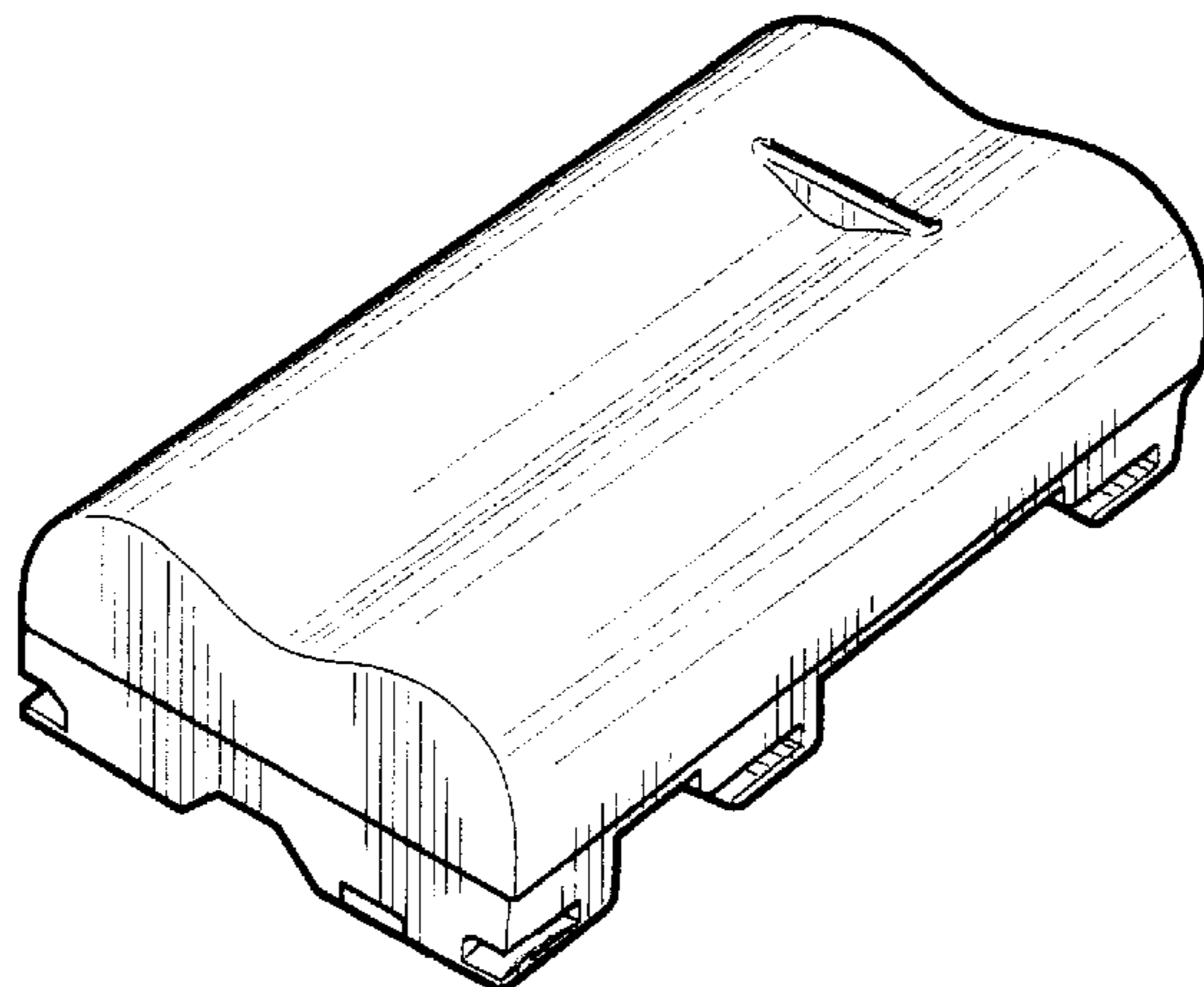

DESCRIPTION

FIG. 1 is a perspective view showing the front, top, and a first side of the battery pack of the present invention; FIG. 2 is a perspective view showing the bottom, front, and a second side of the battery pack casing of the present invention; FIG. 3 is a view of the front of the battery pack casing of the present invention; FIG. 4 is a view of the rear of the battery pack casing of the present invention; FIG. 5 is a view of the top of the battery pack casing according to the present invention; FIG. 6 is a view of the bottom of the battery pack casing according to the present invention; FIG. 7 is a view showing the first side of the battery pack casing of the present invention; and, FIG. 8 is a view showing the second side of the battery pack casing according to the present invention.

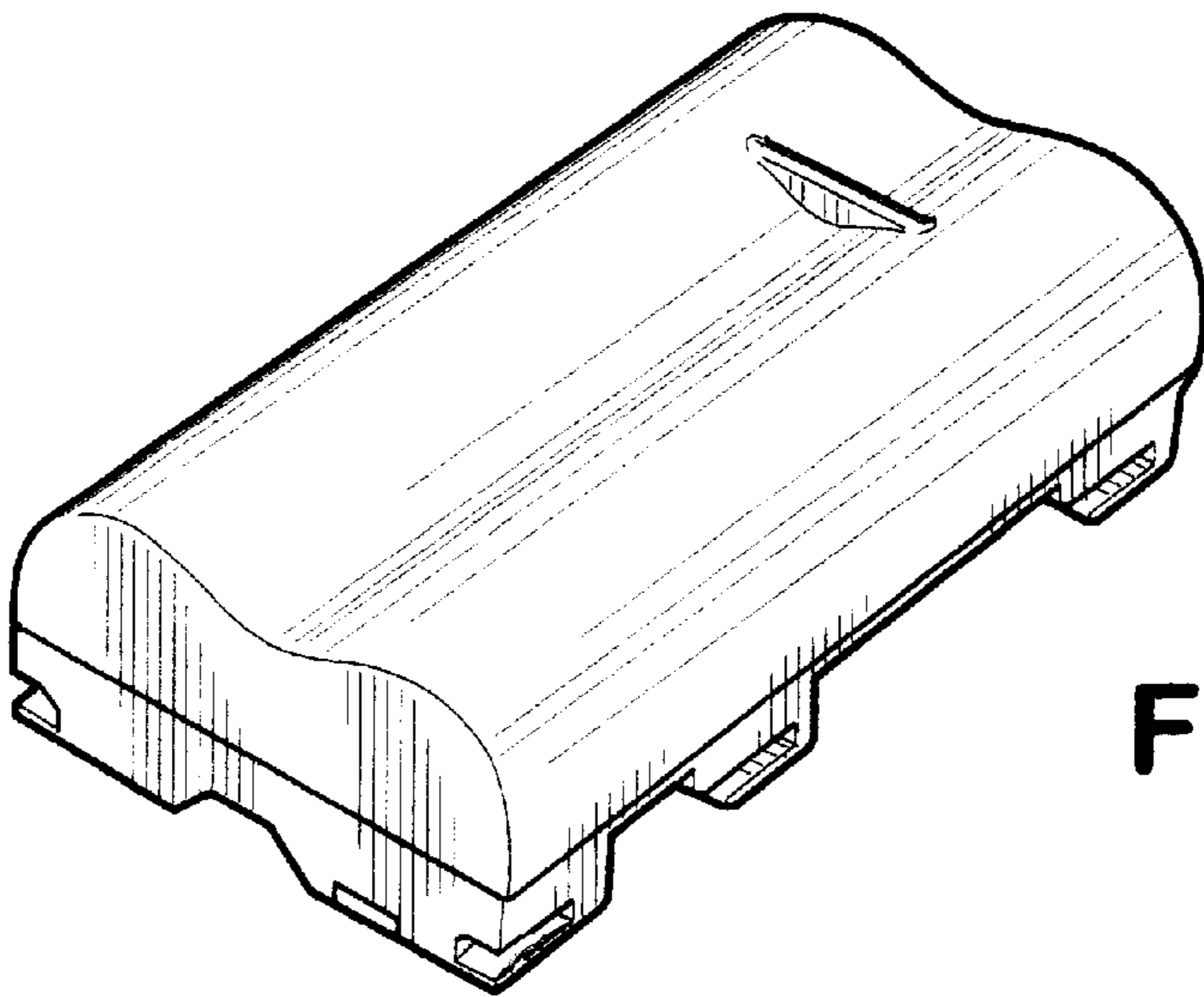

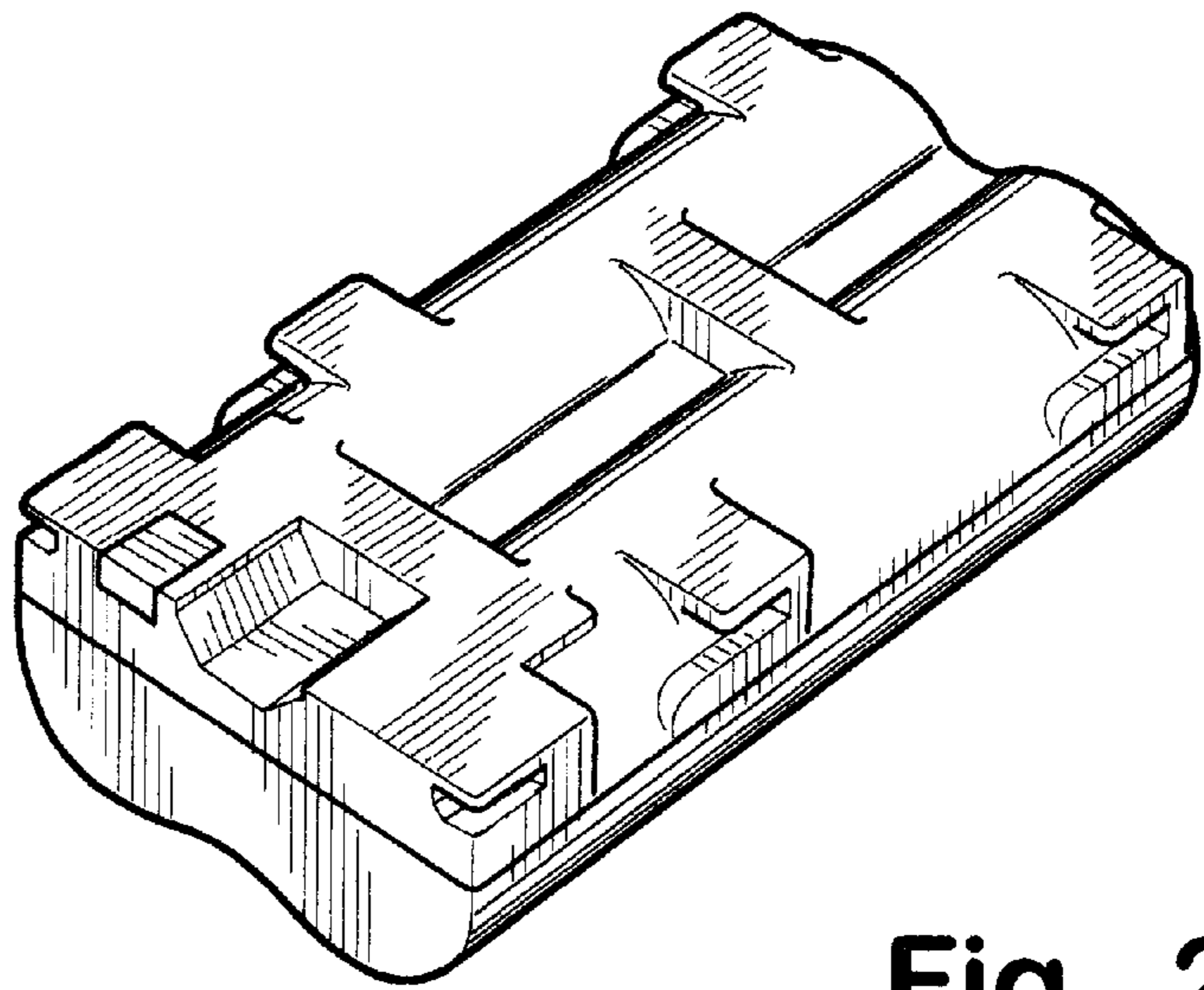

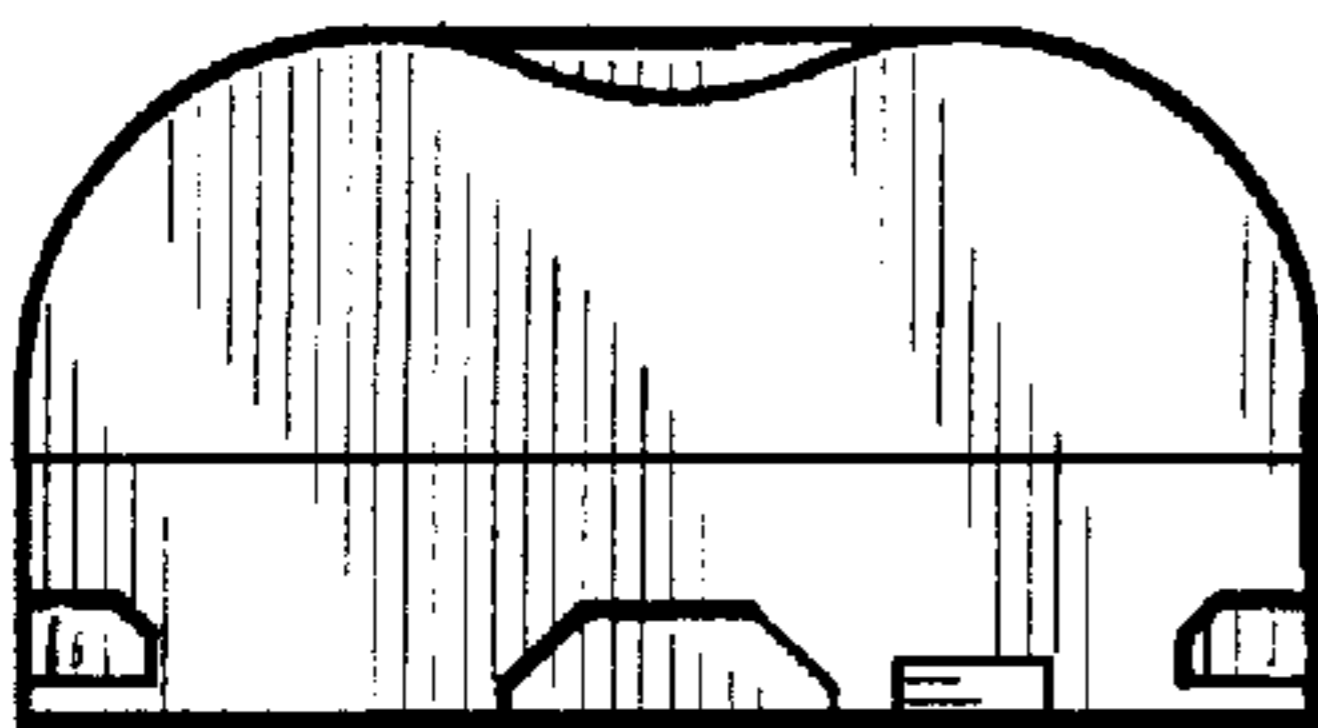

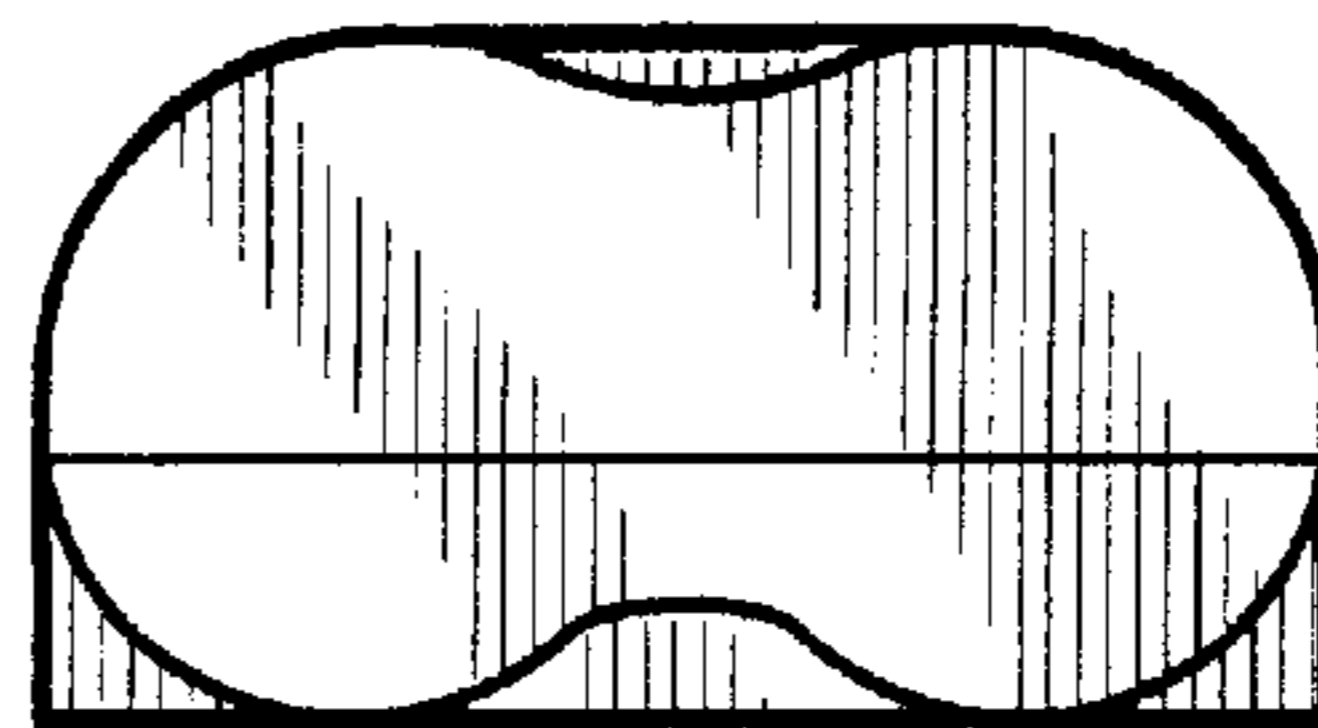

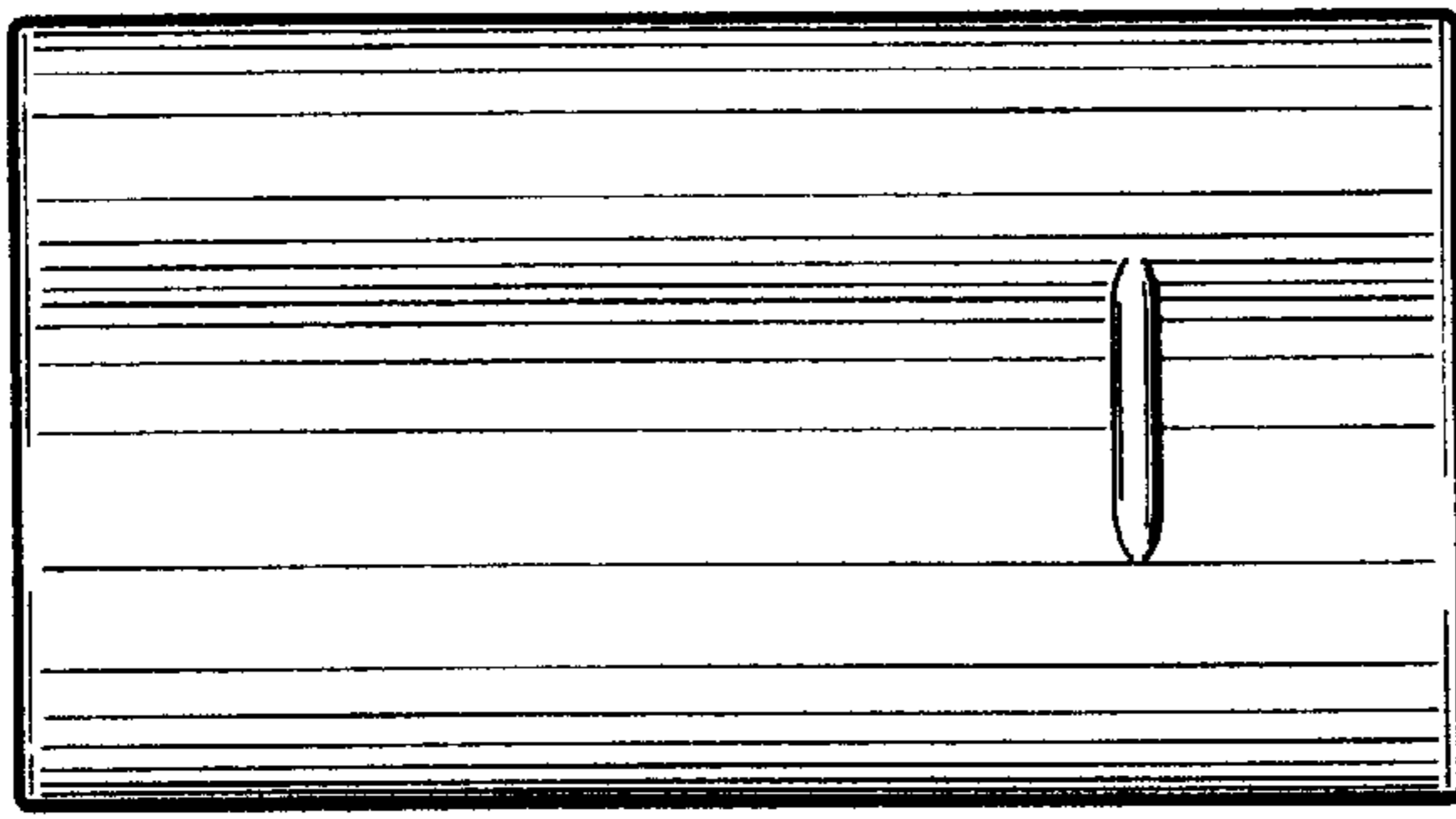

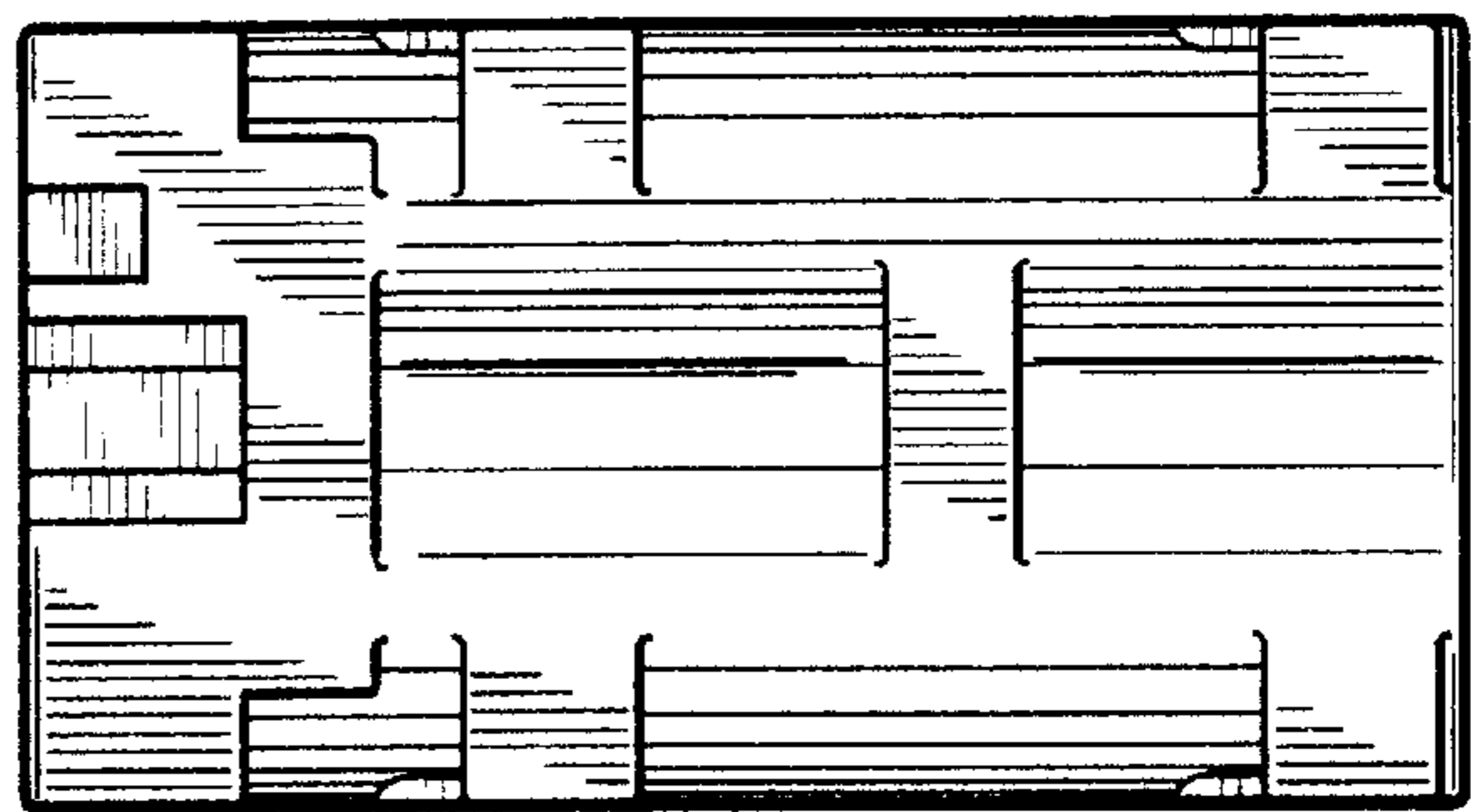

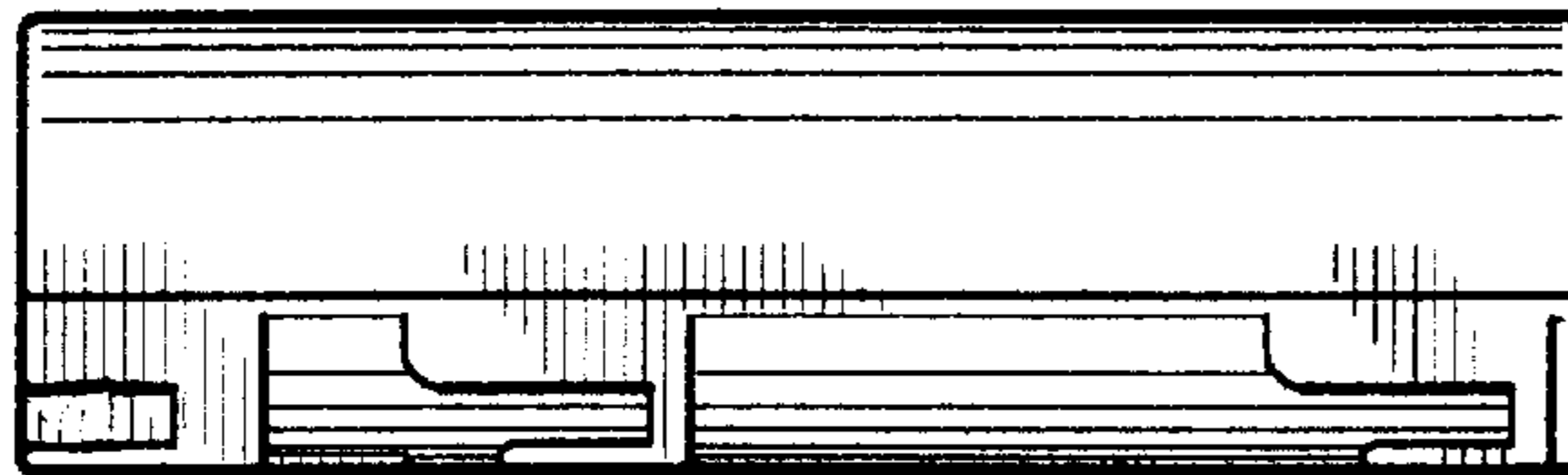

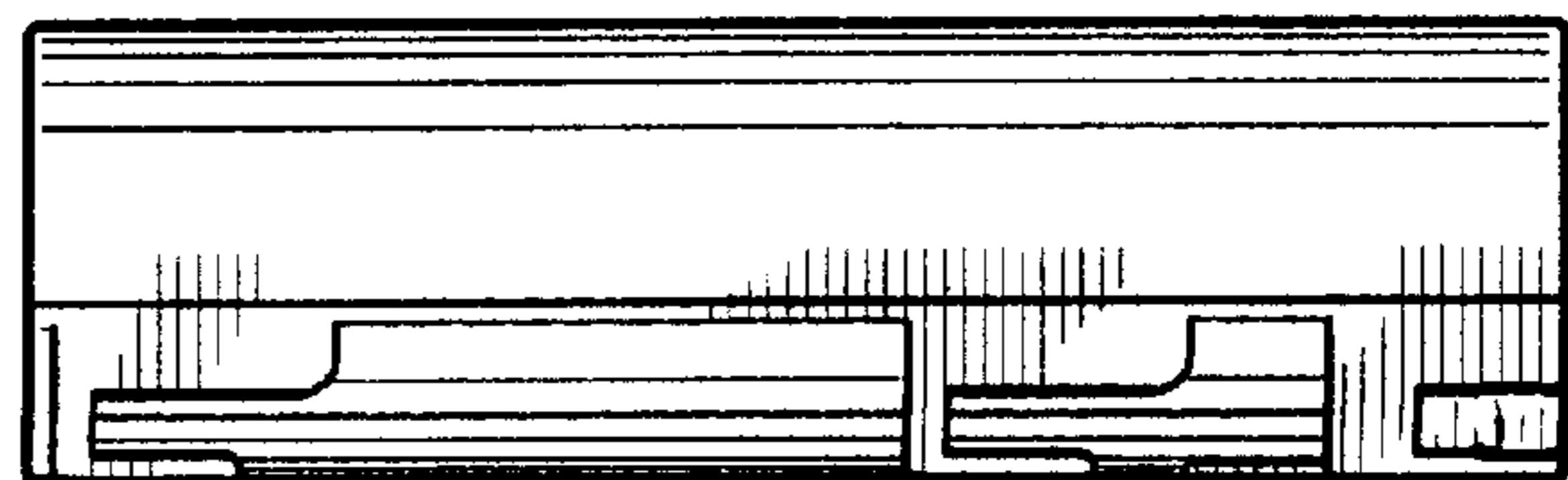
