(57) **CLAIM**

The ornamental design for a modular panel, as shown.

**DESCRIPTION**

FIG. 1 is an isometric view of the modular panel.

FIG. 2 is a front view of the modular panel of FIG. 1.

FIG. 3 is a top view of the modular panel of FIG. 1.

FIG. 4 is a side view of one side of the modular panel of FIG. 1.

FIG. 5 is a side view of the other side of the modular panel of FIG. 1.

FIG. 6 is a bottom view of the modular panel of FIG. 1.

FIG. 7 is an isometric view of a second alternate embodiment of the modular panel.

FIG. 8 is a front view of the modular panel of FIG. 7.

FIG. 9 is a top view of the modular panel of FIG. 7.

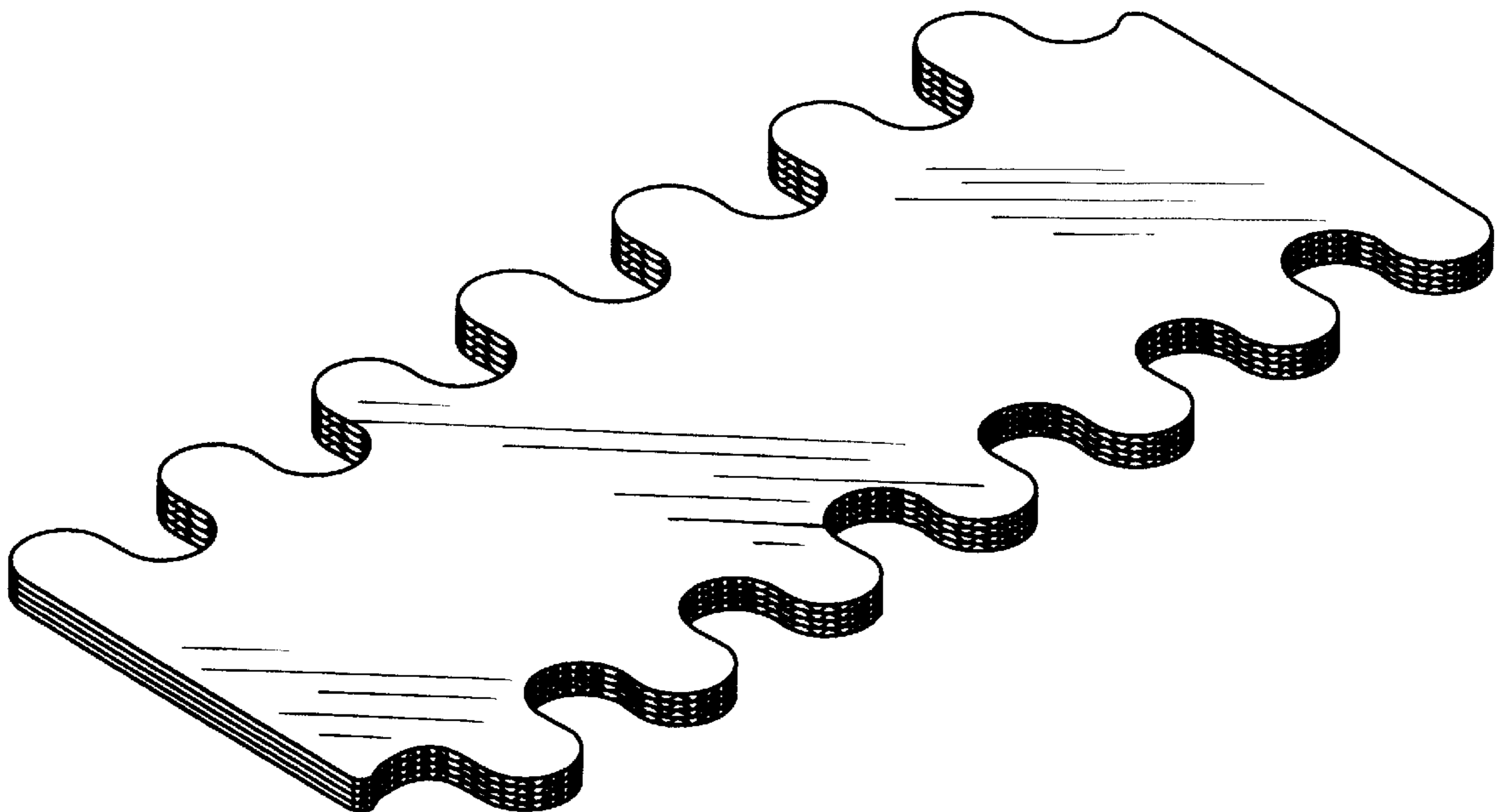
FIG. 10 is a side view of one side of the modular panel of FIG. 7.

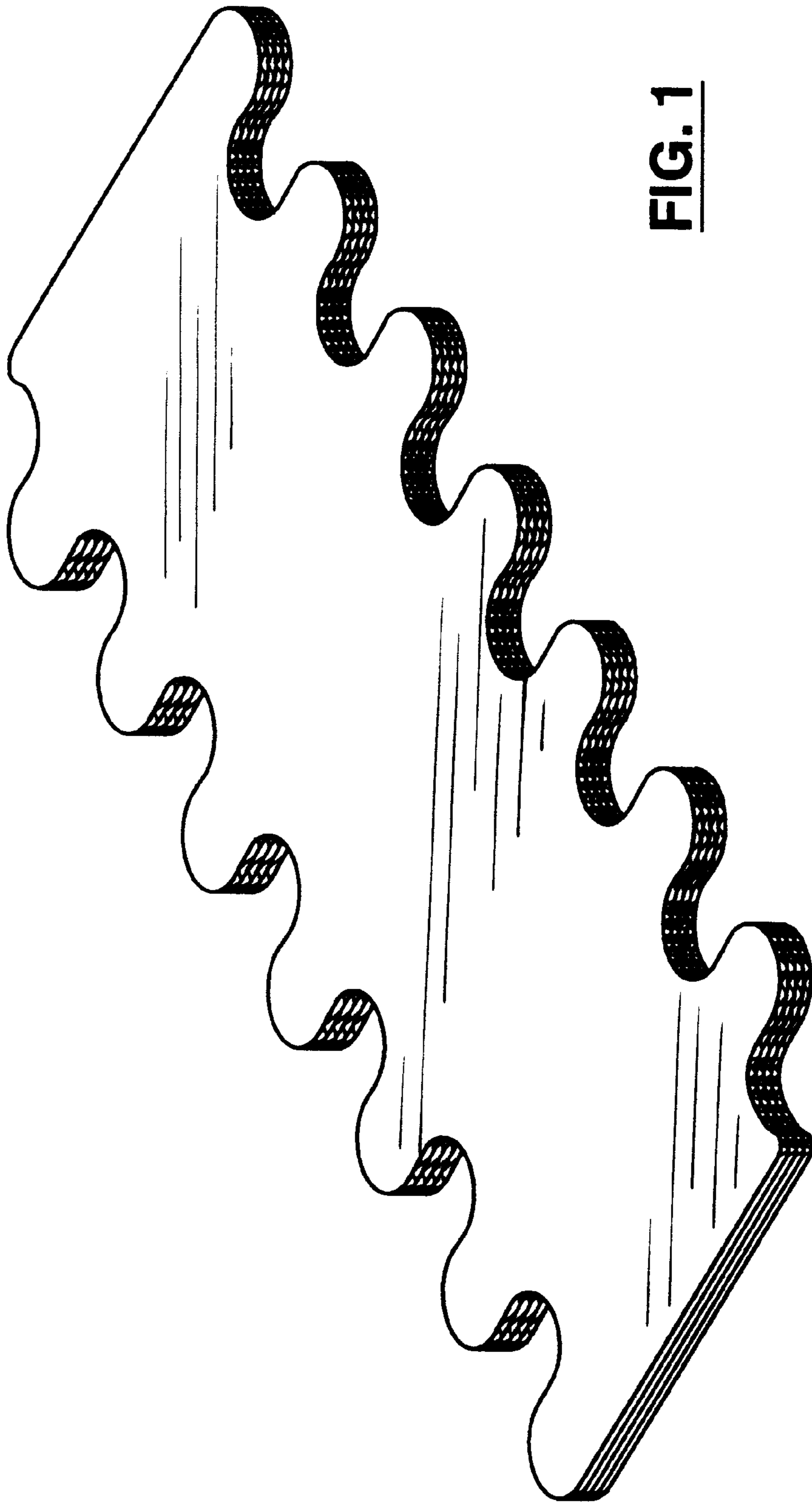
FIG. 11 is a side view of the other side of the modular panel of FIG. 7; and,

FIG. 12 is a bottom view of the modular panel of FIG. 7.

The characteristic feature of the design resides in the edge surface of the modular panel having a plurality of apertures defined by flutes in a multi-layered corrugate.

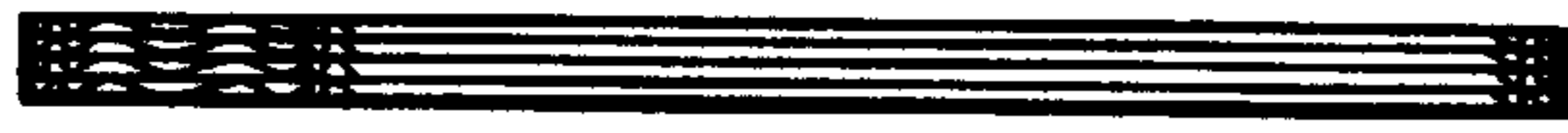

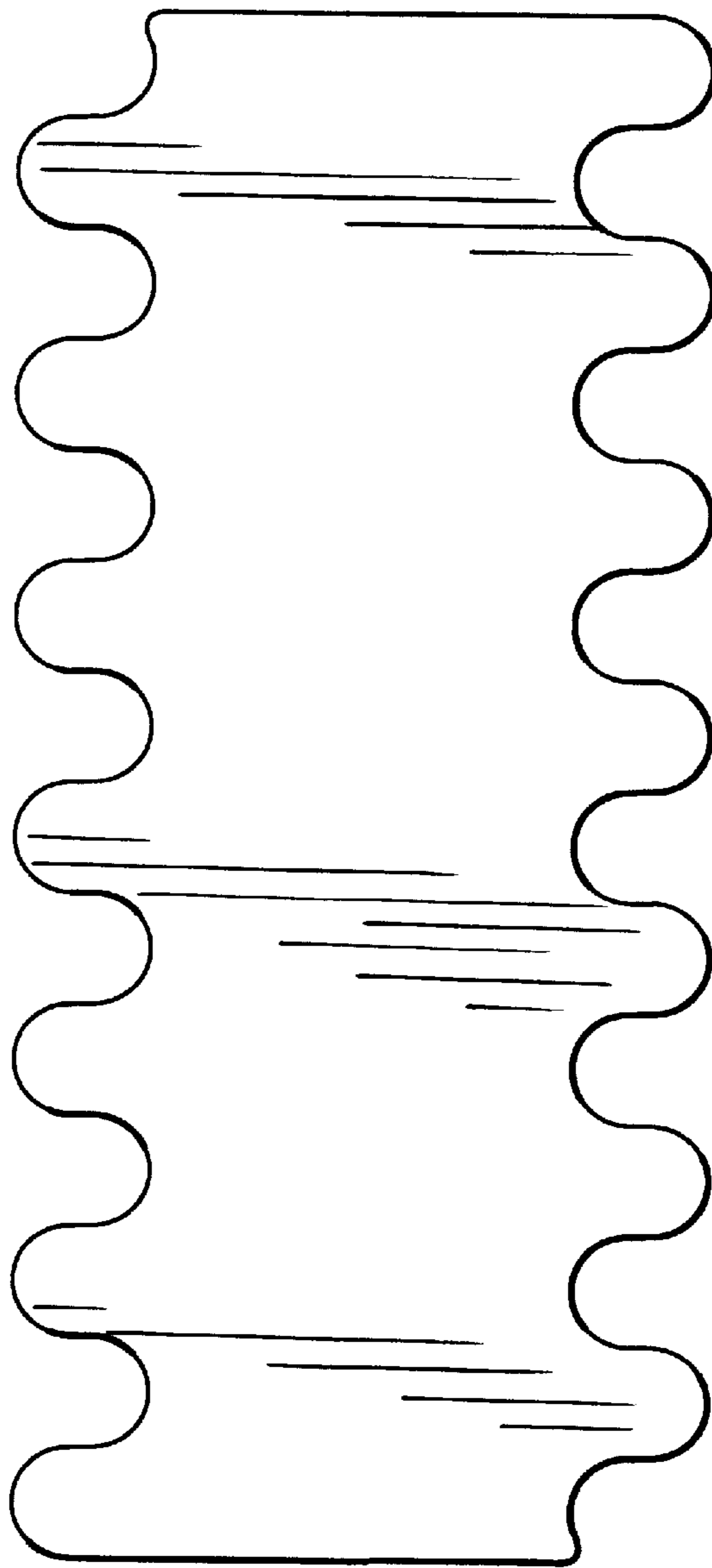

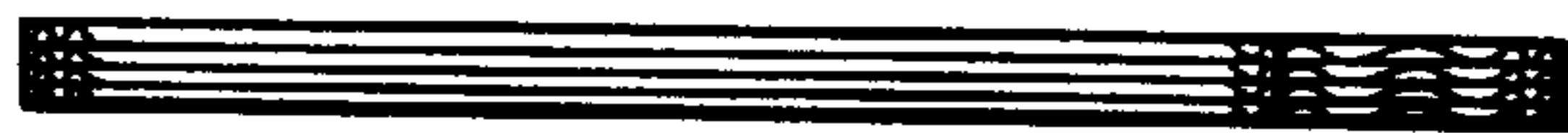

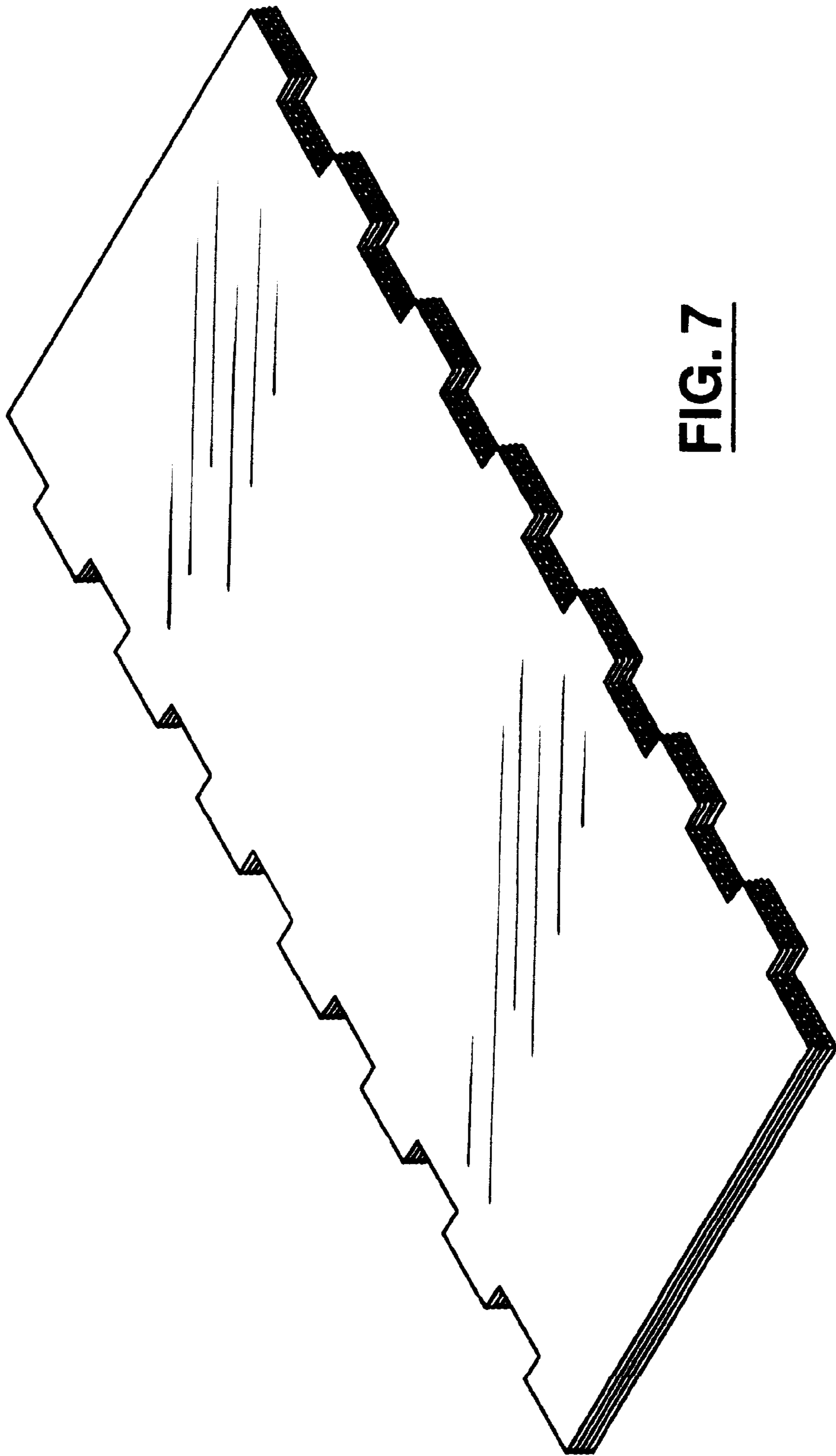

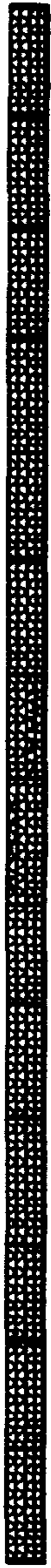

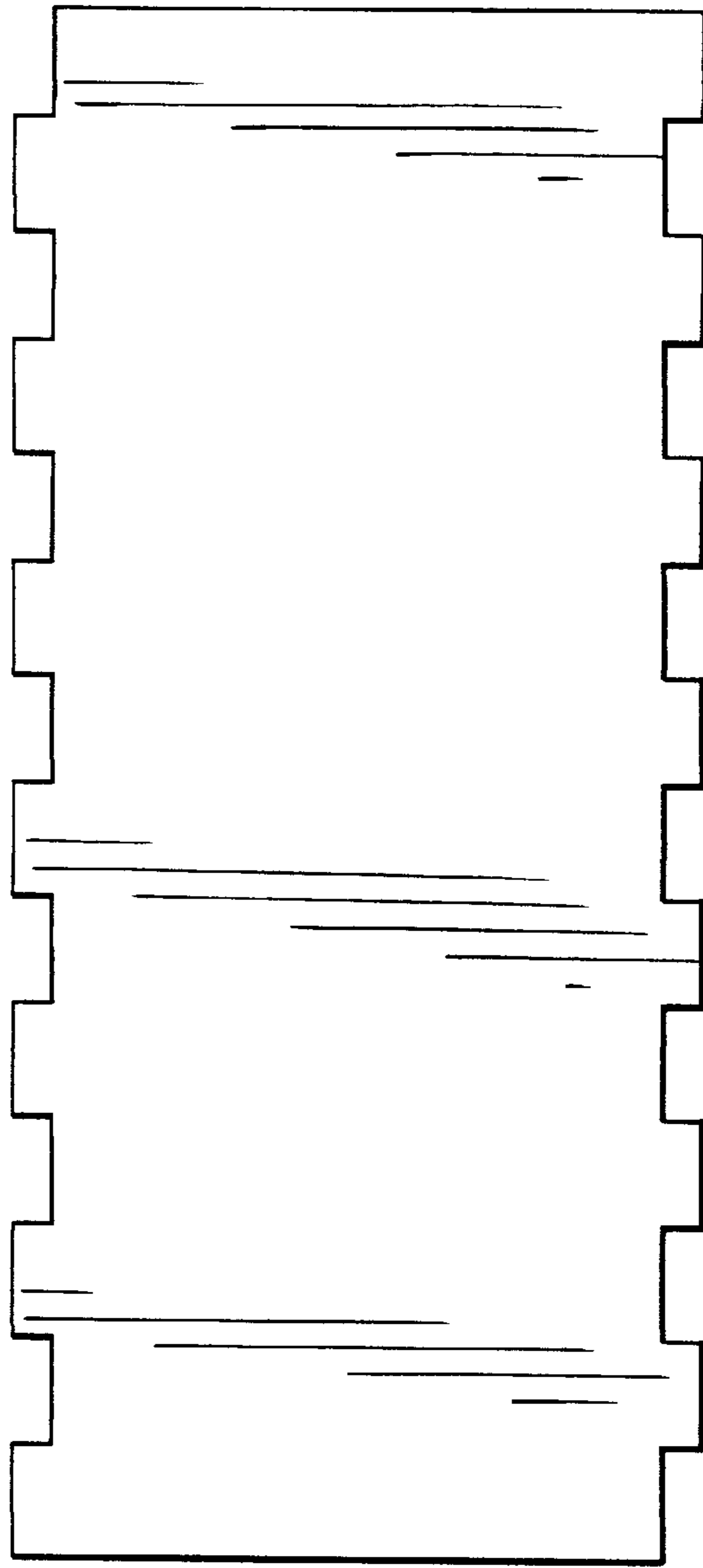
