(57) **CLAIM**

The ornamental design for a protective covering for furniture legs, as shown and described.

DESCRIPTION

FIG. 1 is a diagrammatic perspective view of the protective covering for furniture legs.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a top plan view of the protective covering for furniture legs.

FIG. 5 is a bottom plan view thereof.

FIG. 6 is a right side elevational view thereof; and,

FIG. 7 is a left side elevational view thereof.

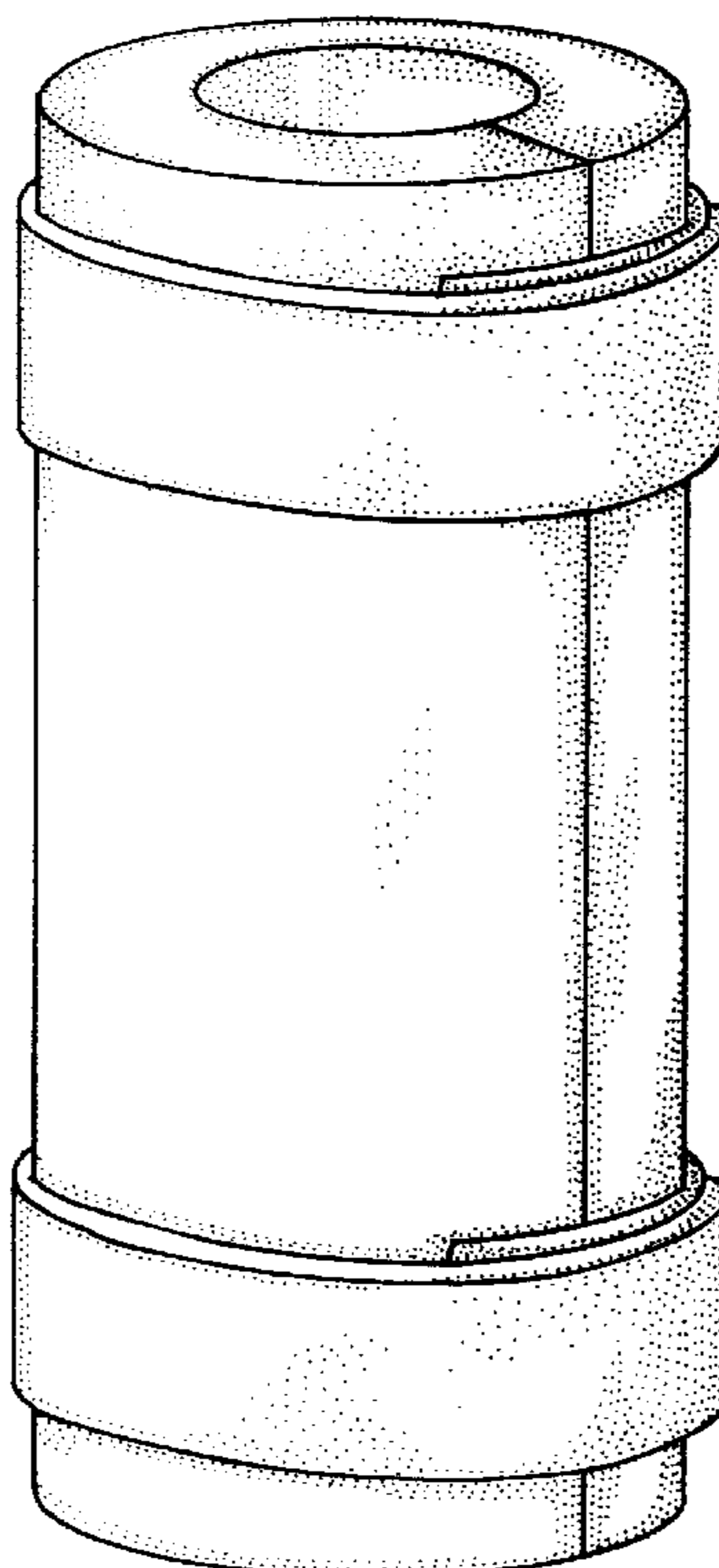

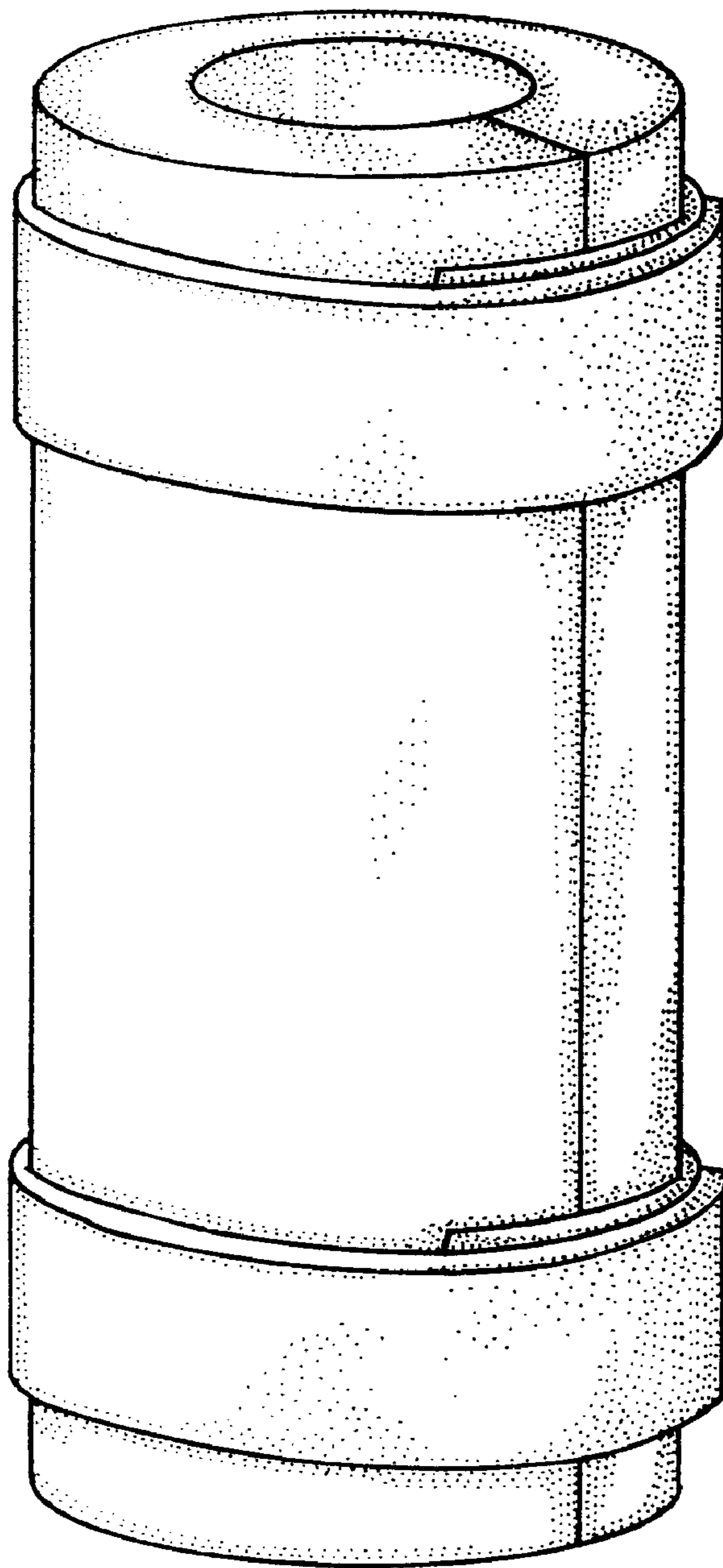

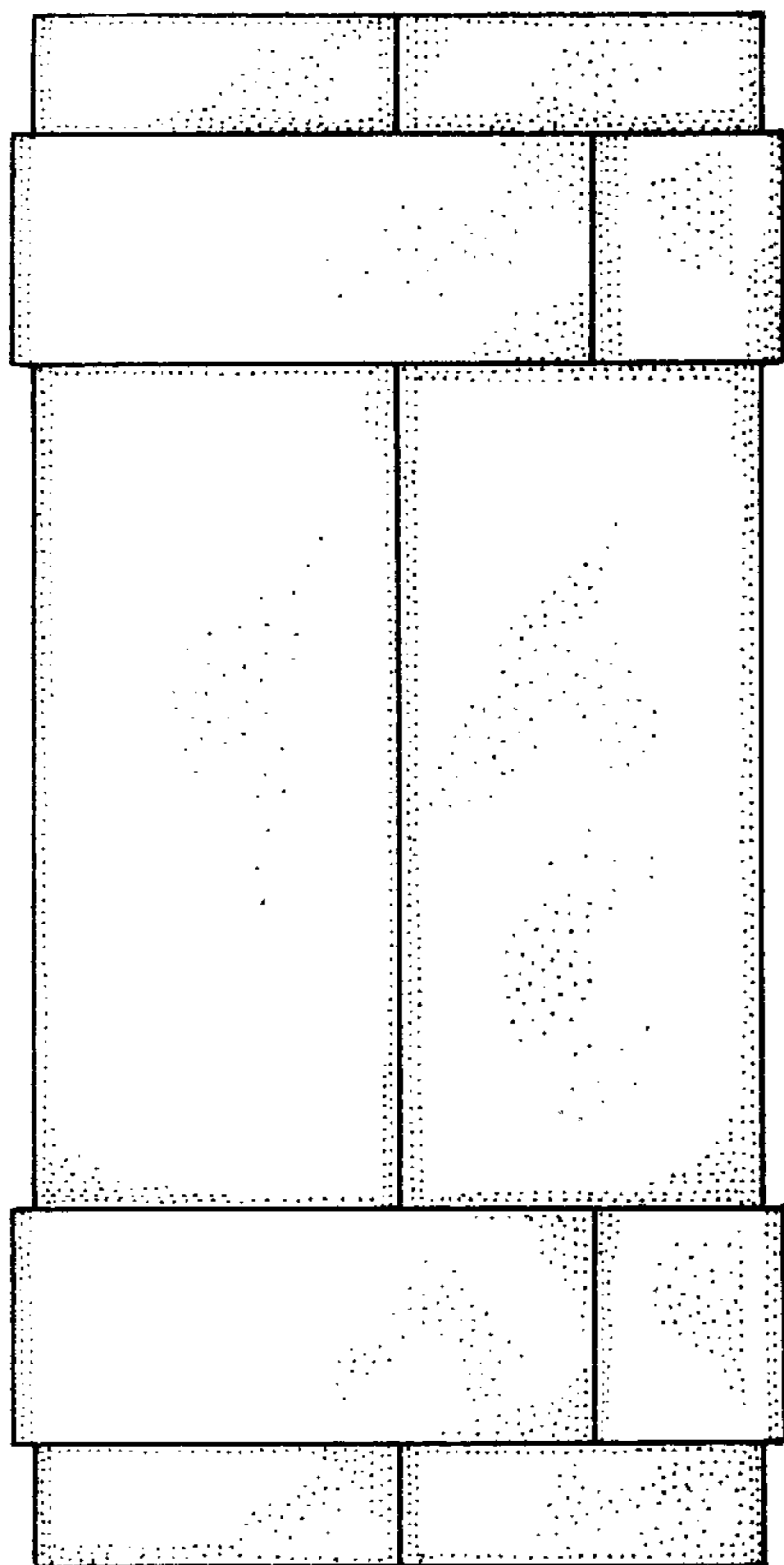

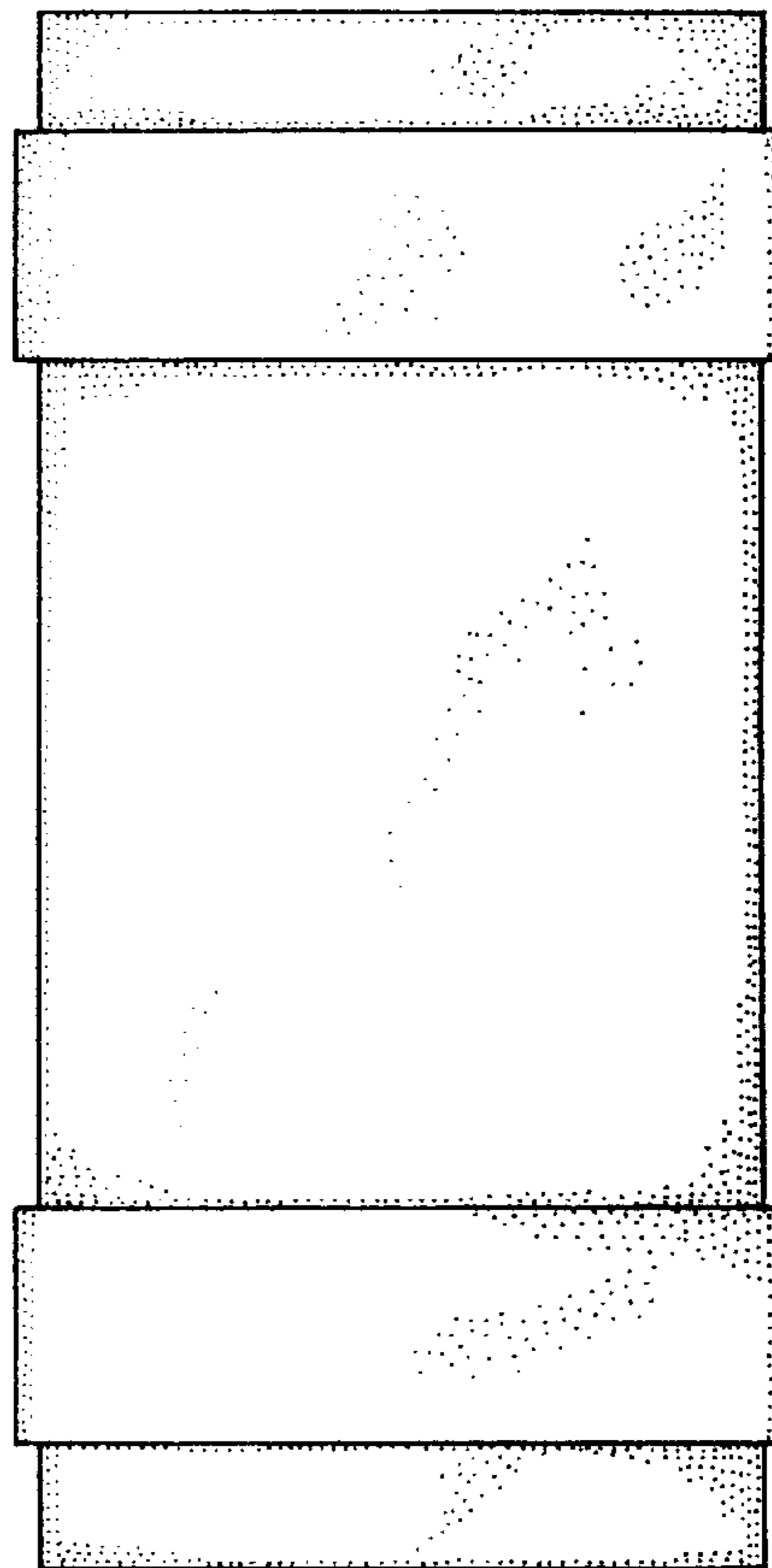

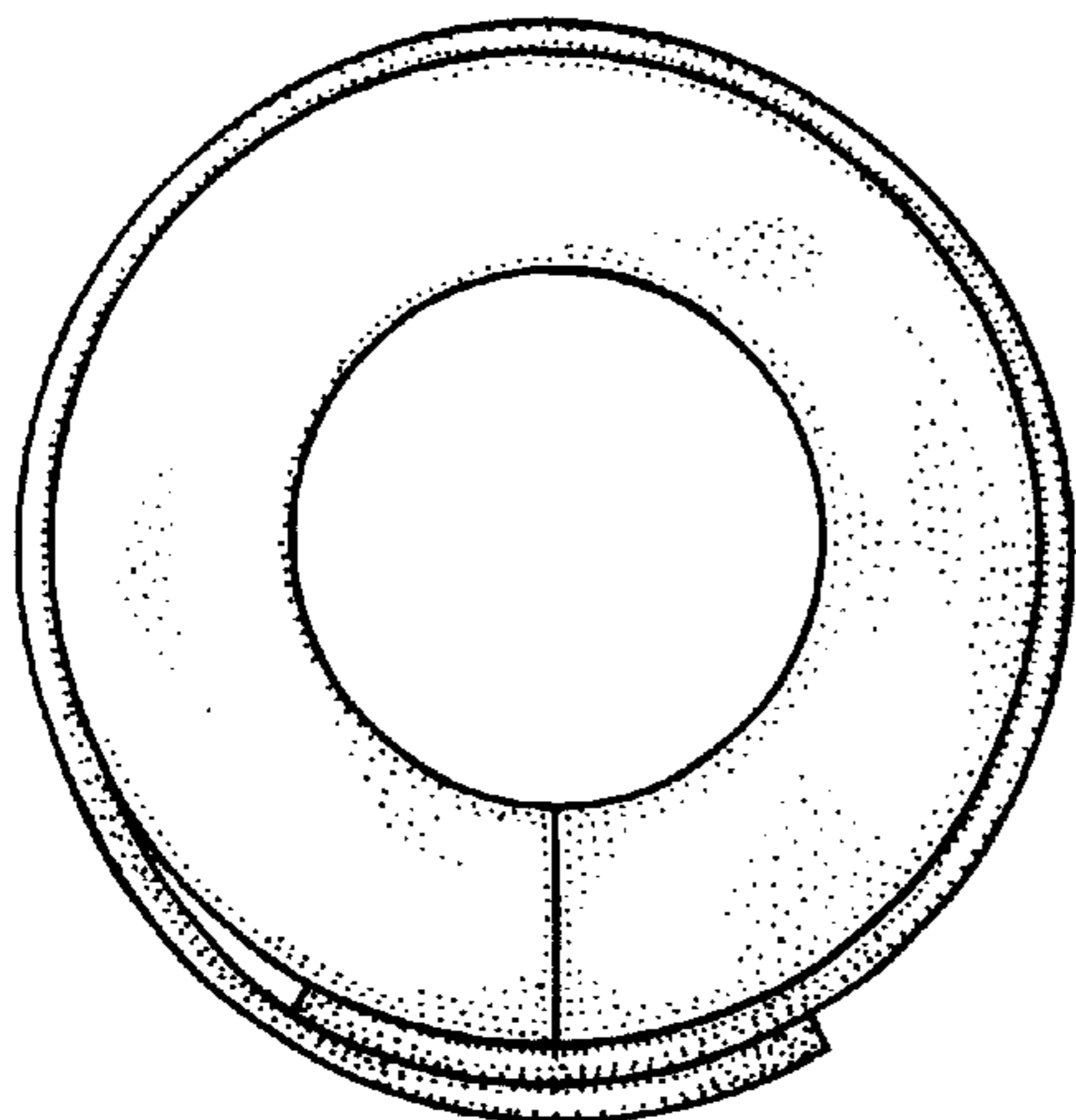

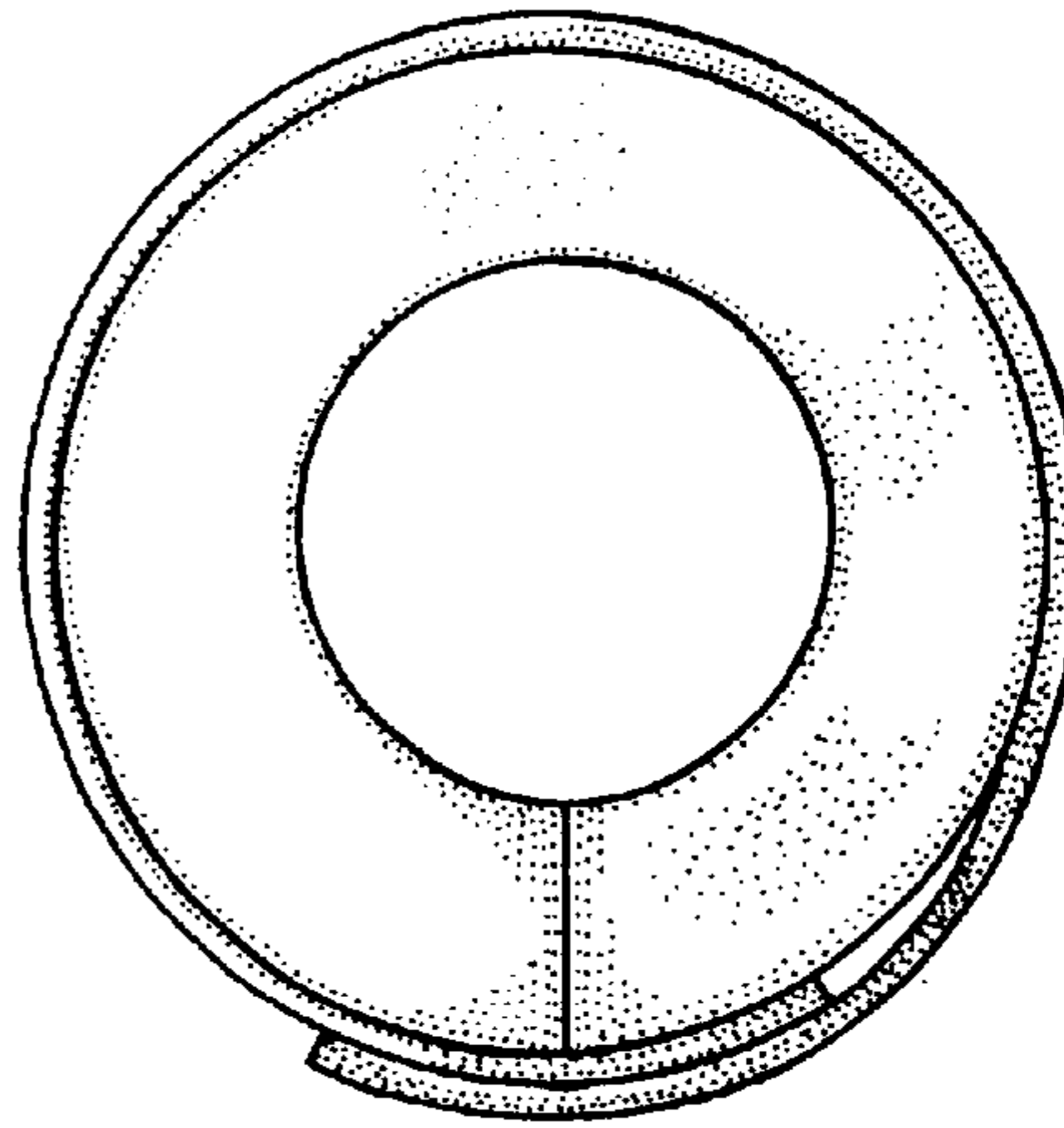

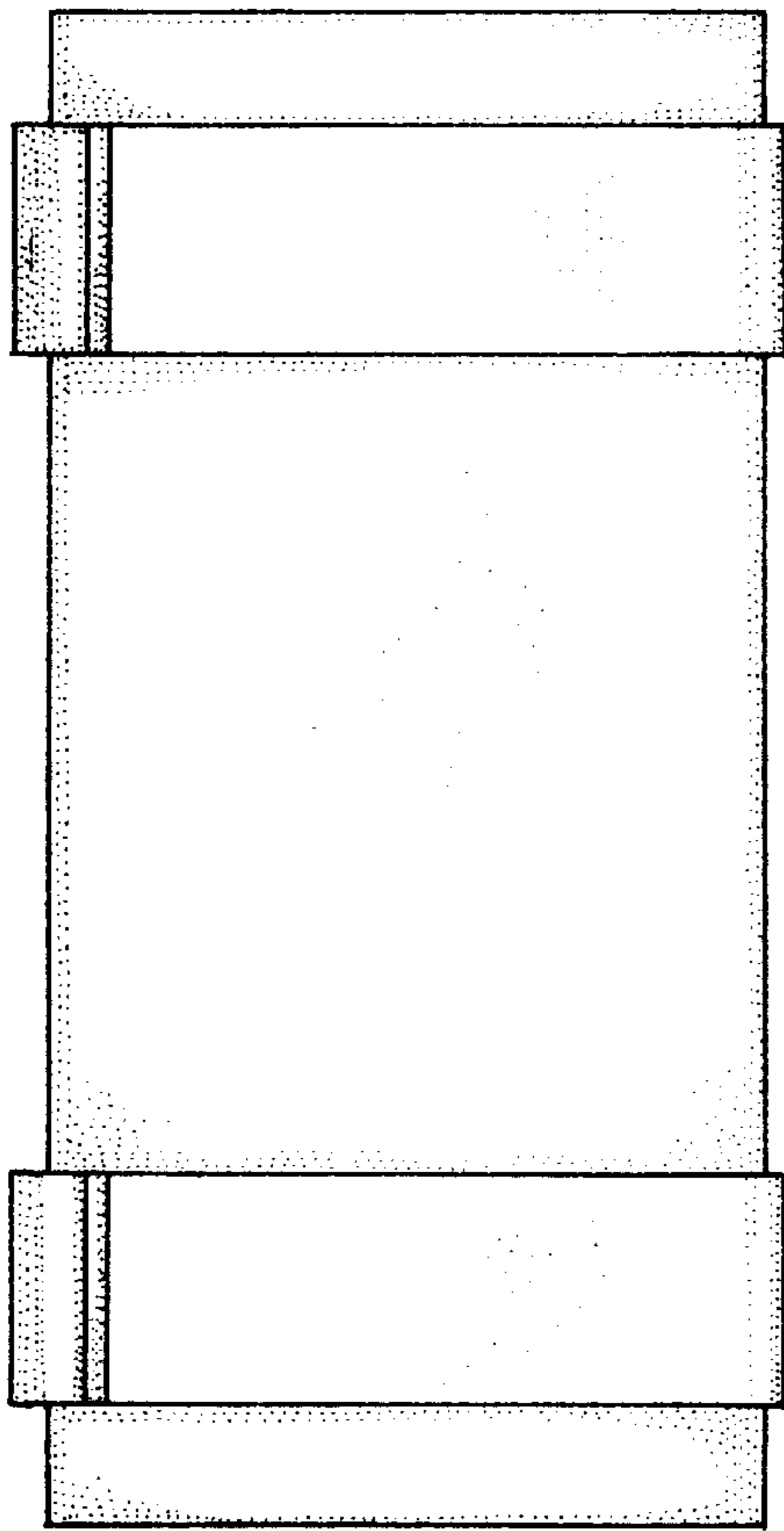
