(57) **CLAIM**

The ornamental design for a condiment dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pepper mill embodiment of the condiment dispenser according to the present invention. FIG. 2 is a front elevational view of the embodiment of the invention shown in FIG. 1.

FIG. 3 is a side view of the embodiment of the invention shown in FIGS. 1 and 2.

FIG. 4 is a top view of the embodiment of the invention shown in FIGS. 1–3.

FIG. 5 is a bottom view of the embodiment of the invention shown in FIGS. 1–4.

FIG. 6 is a perspective view of a salt shaker embodiment of the condiment dispenser according to the invention.

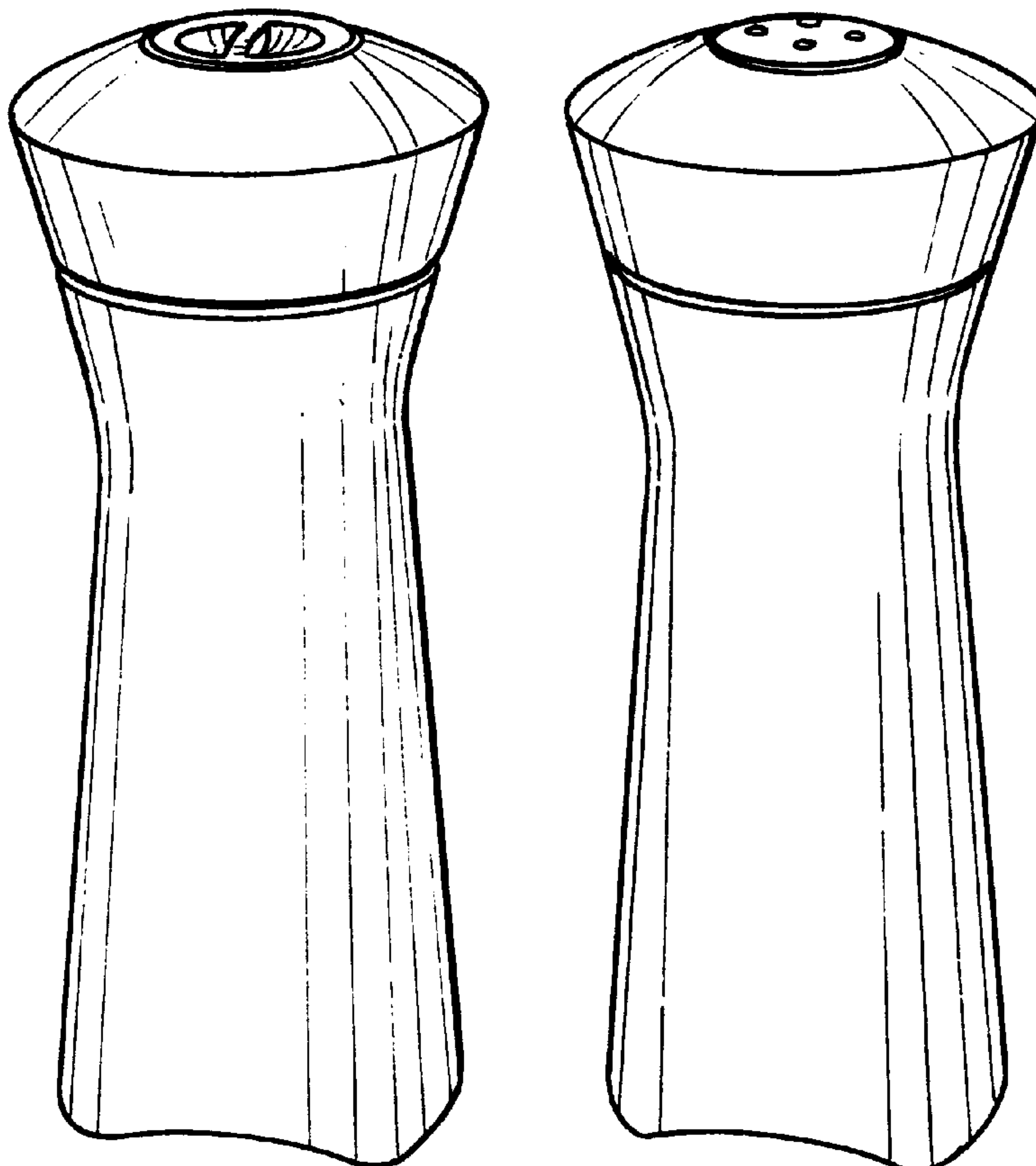
FIG. 7 is a front view of the embodiment of the invention shown in FIG. 6.

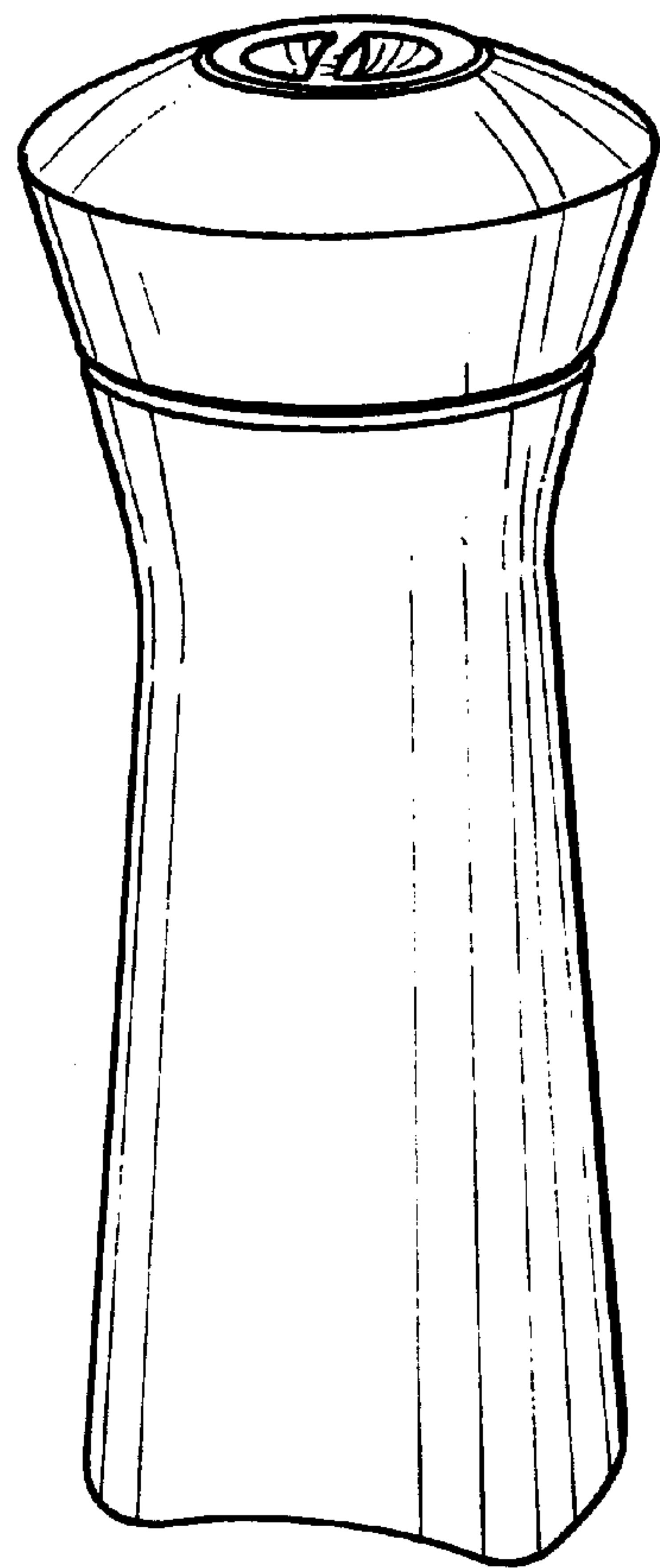

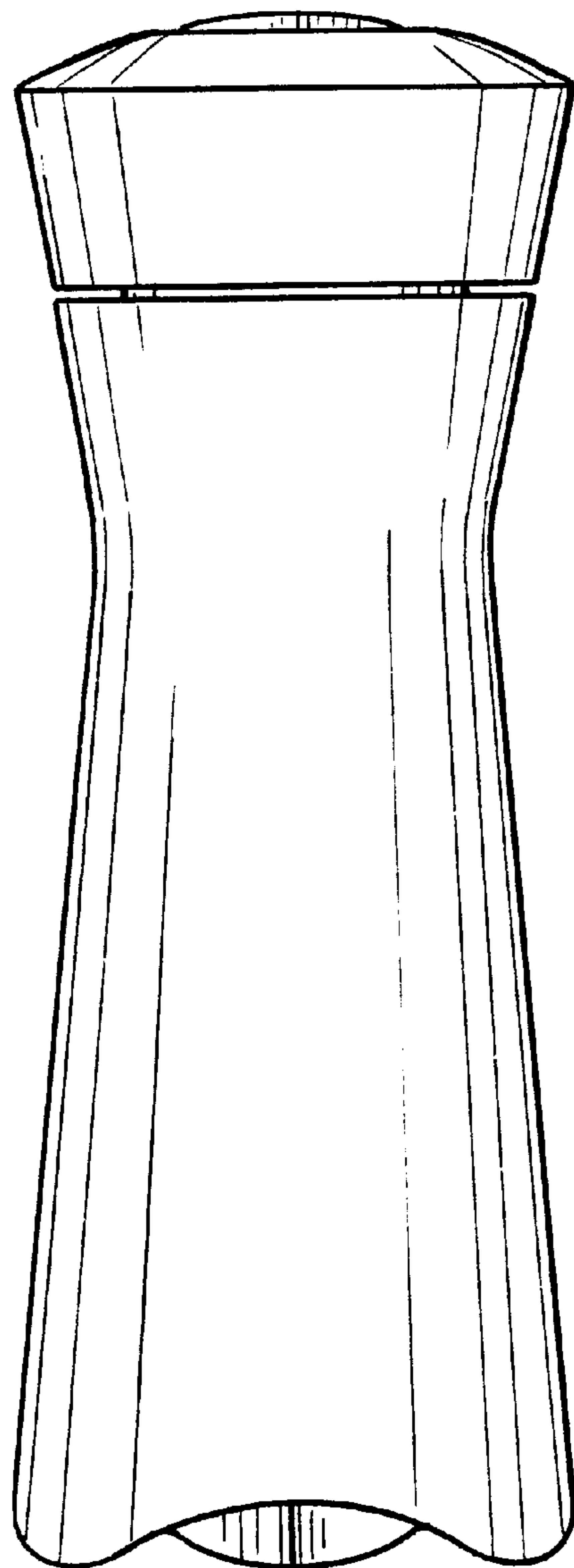

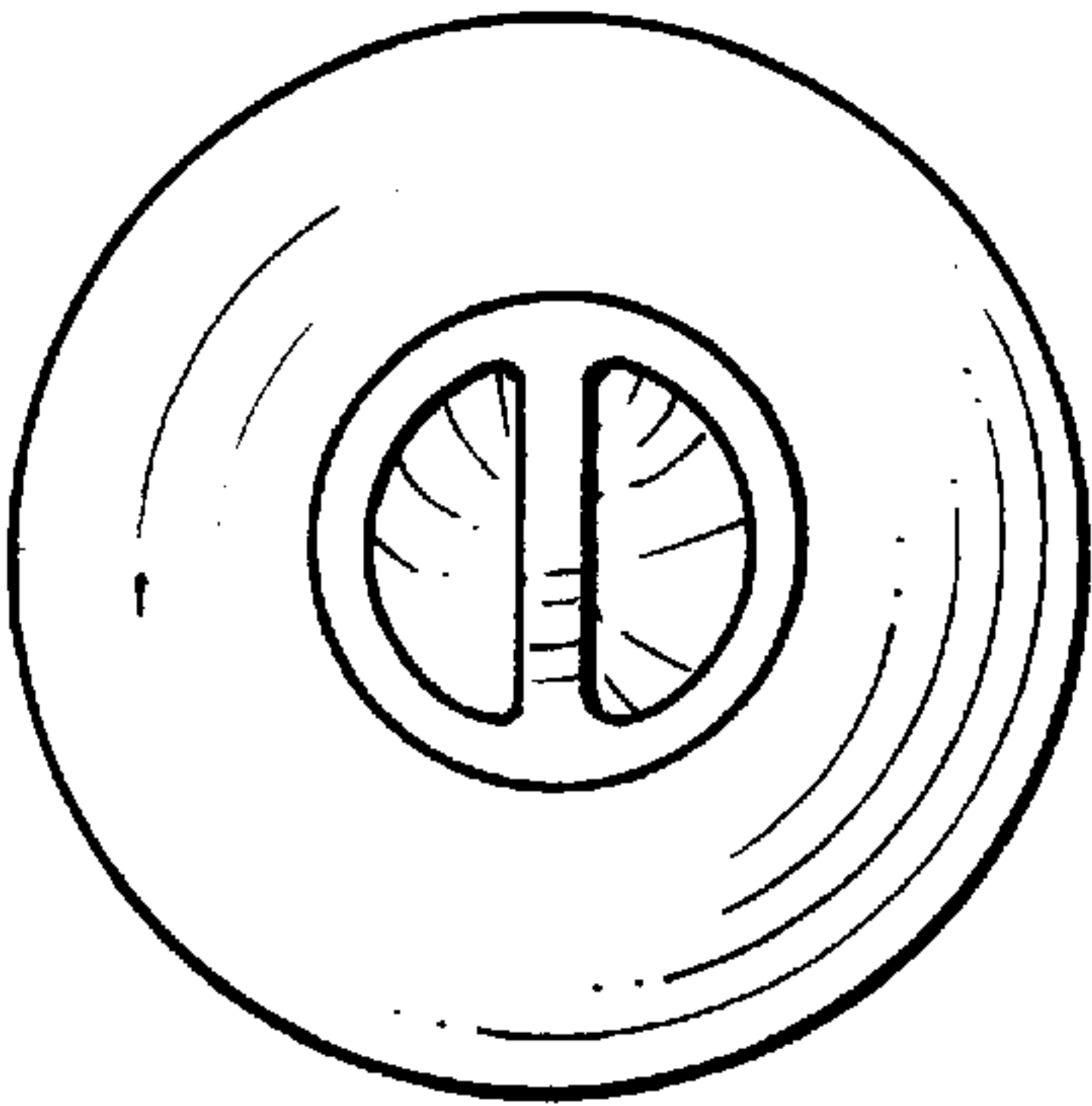

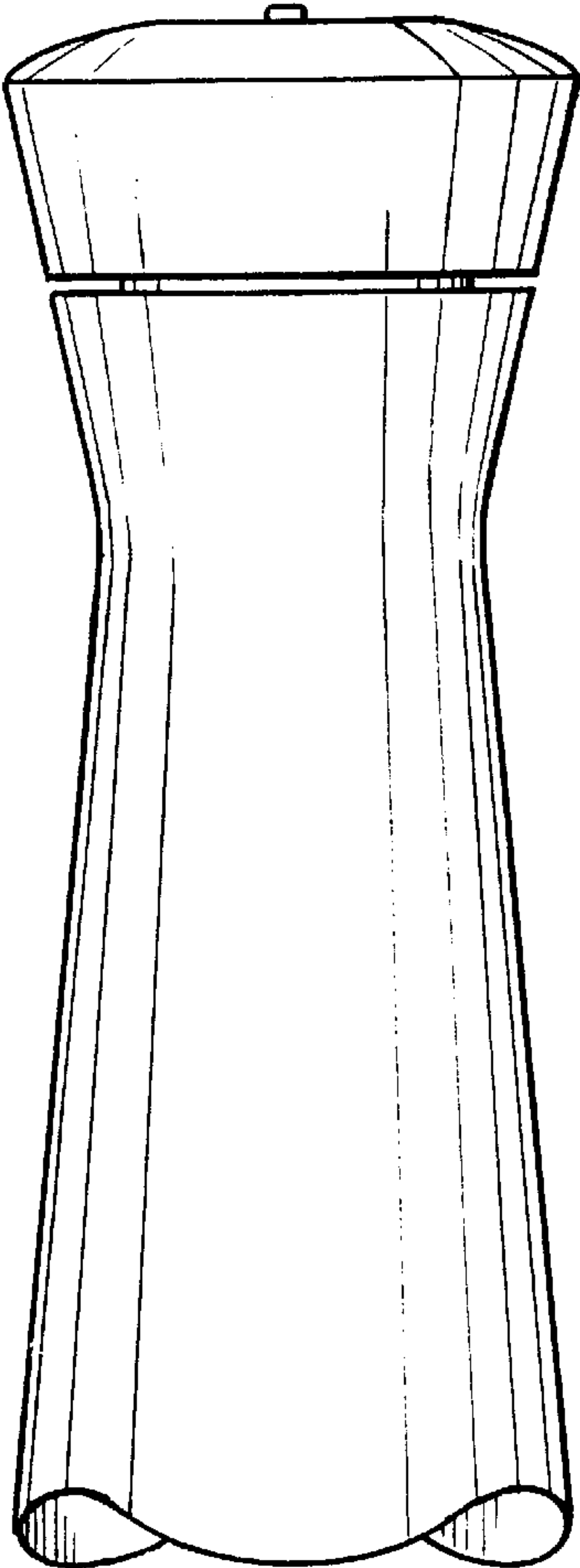
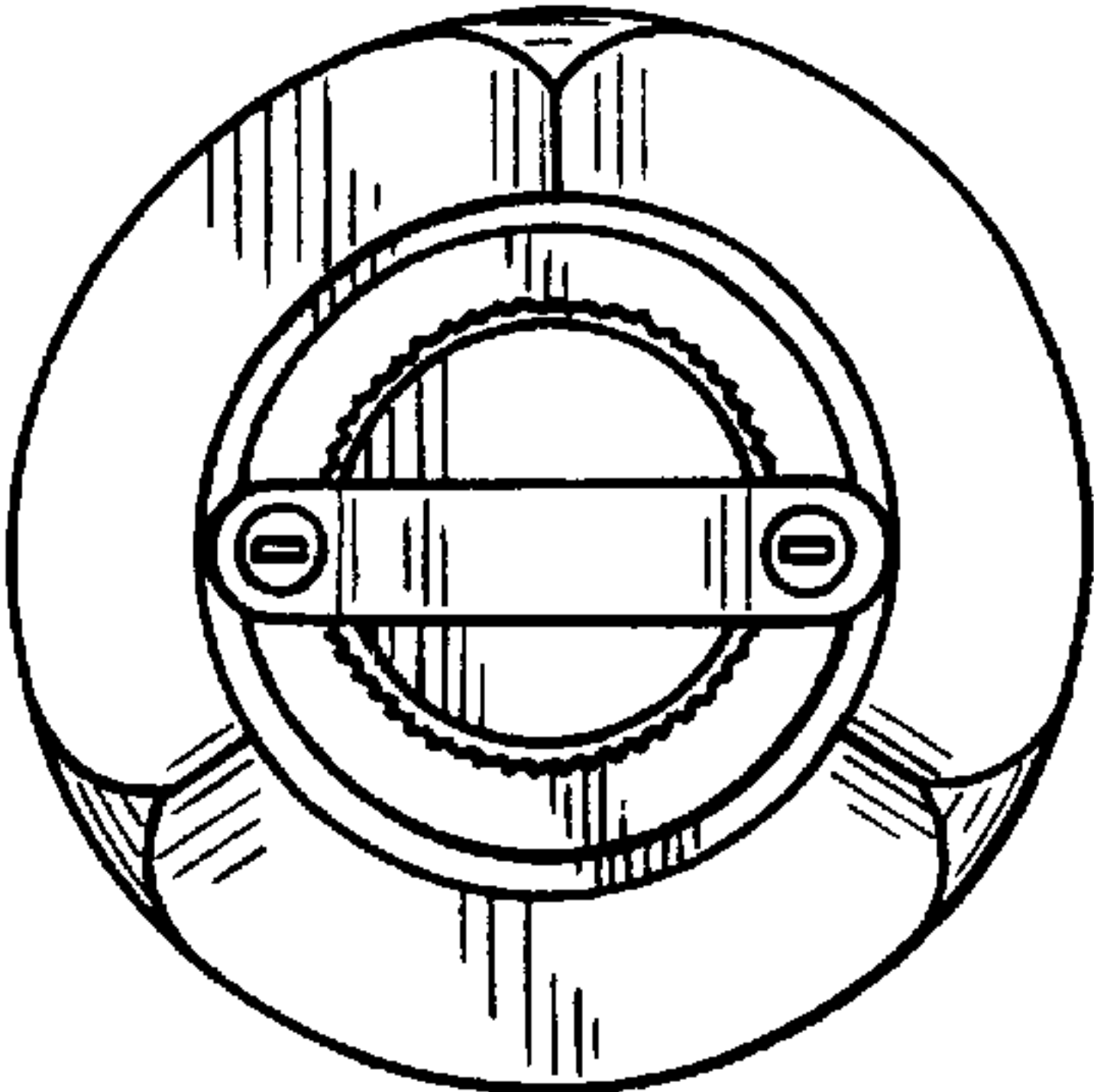

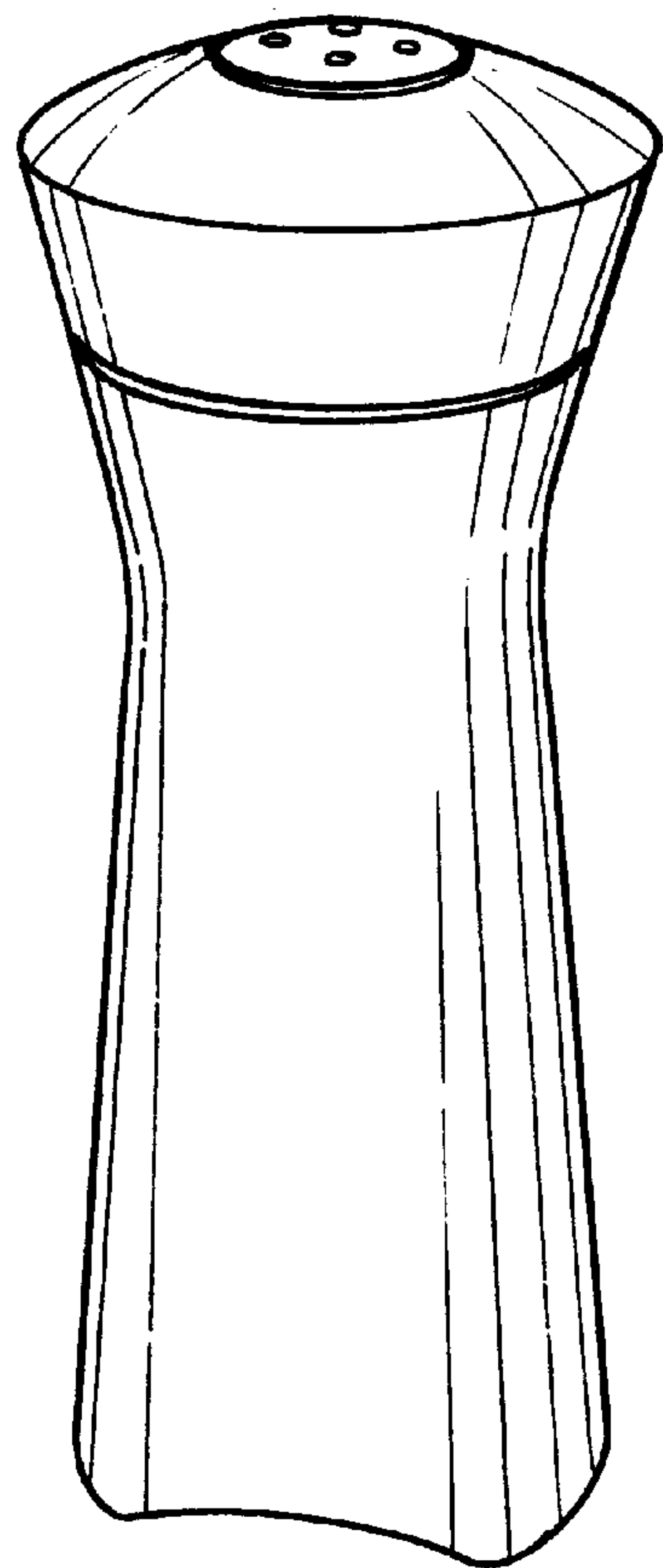

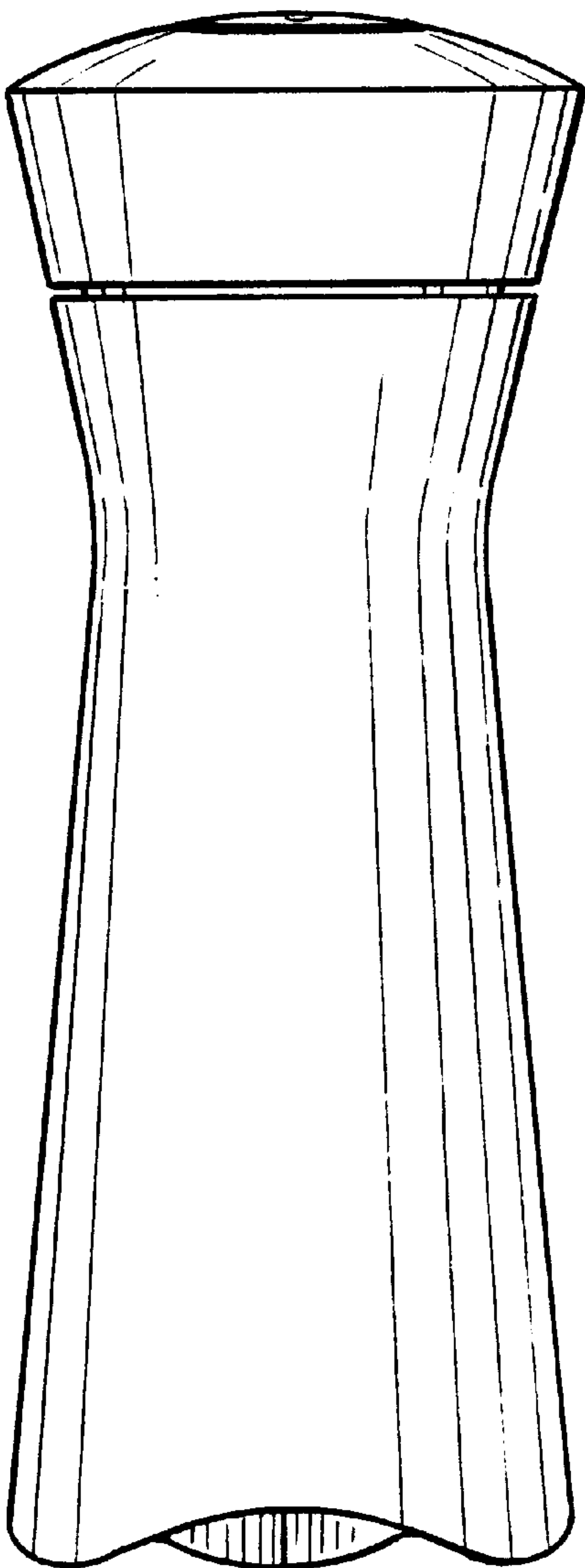

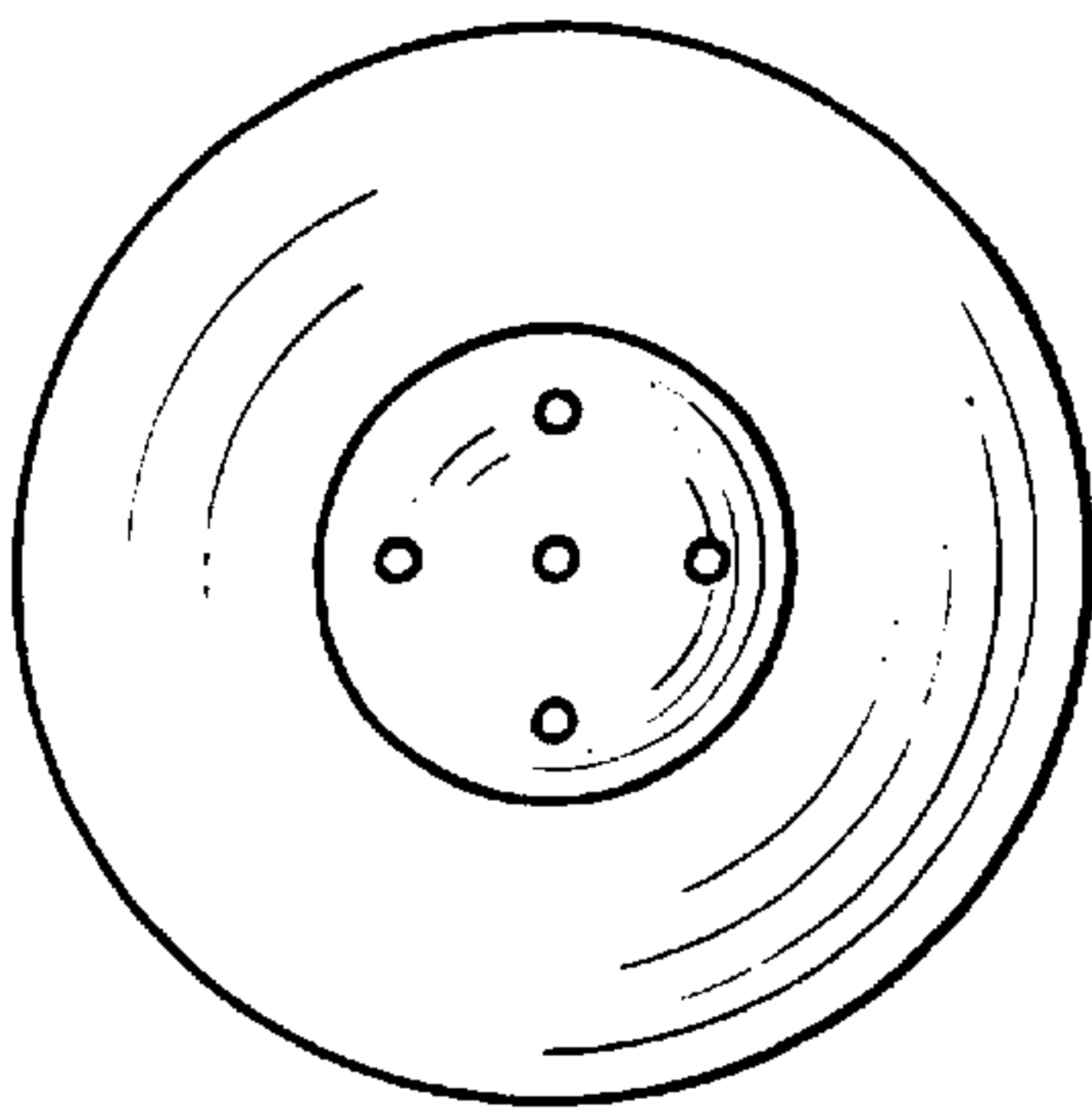

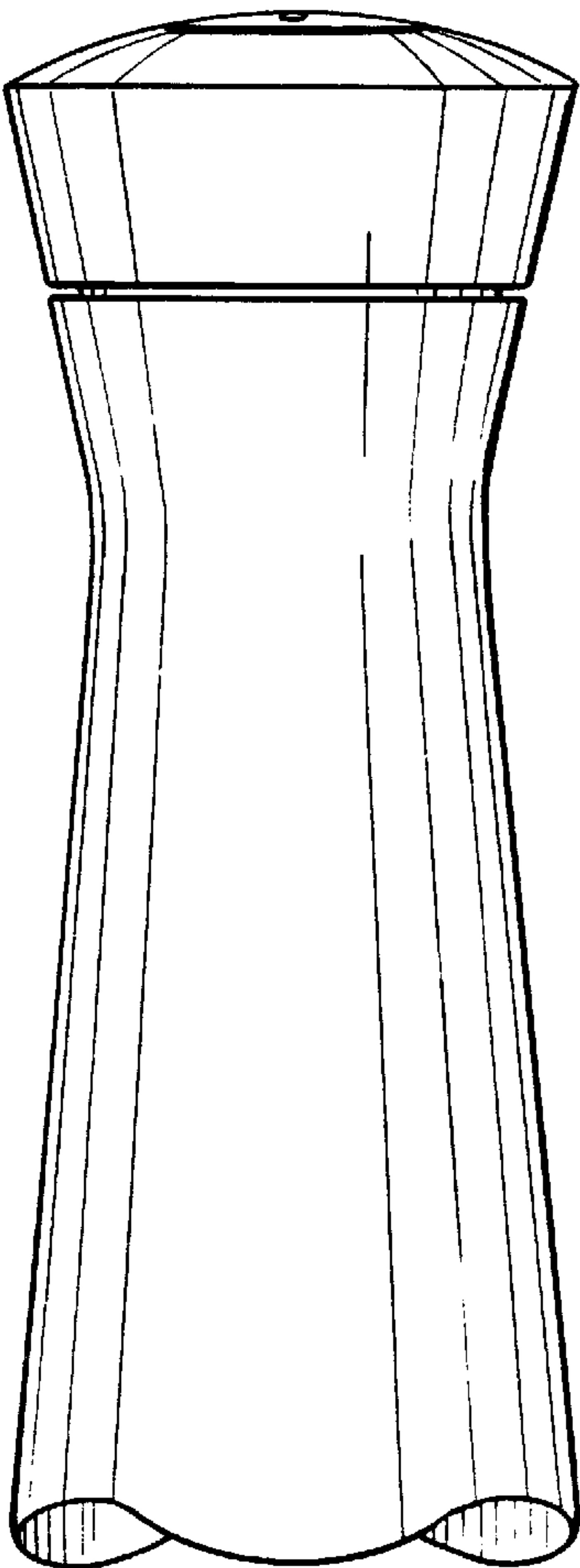
