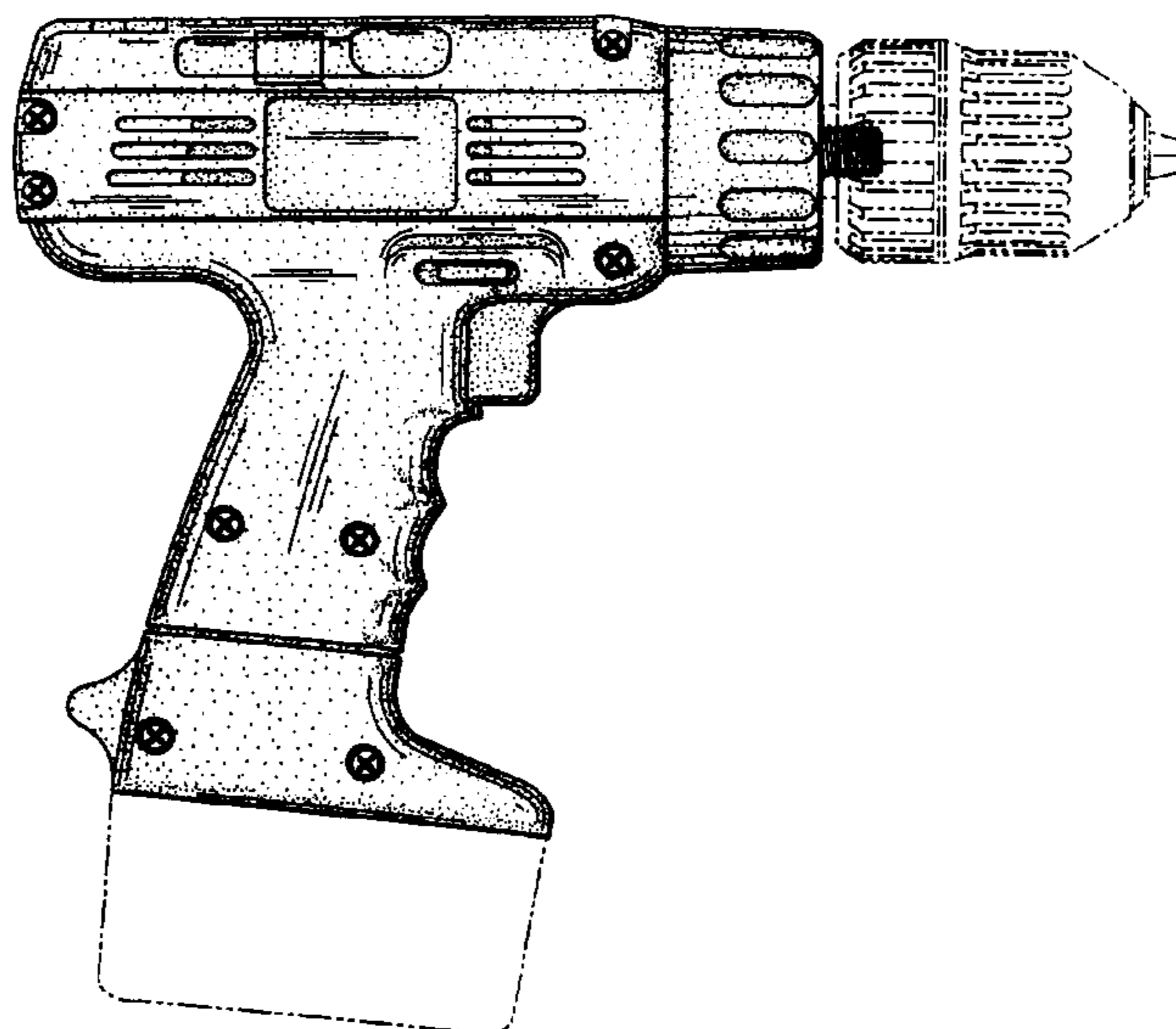

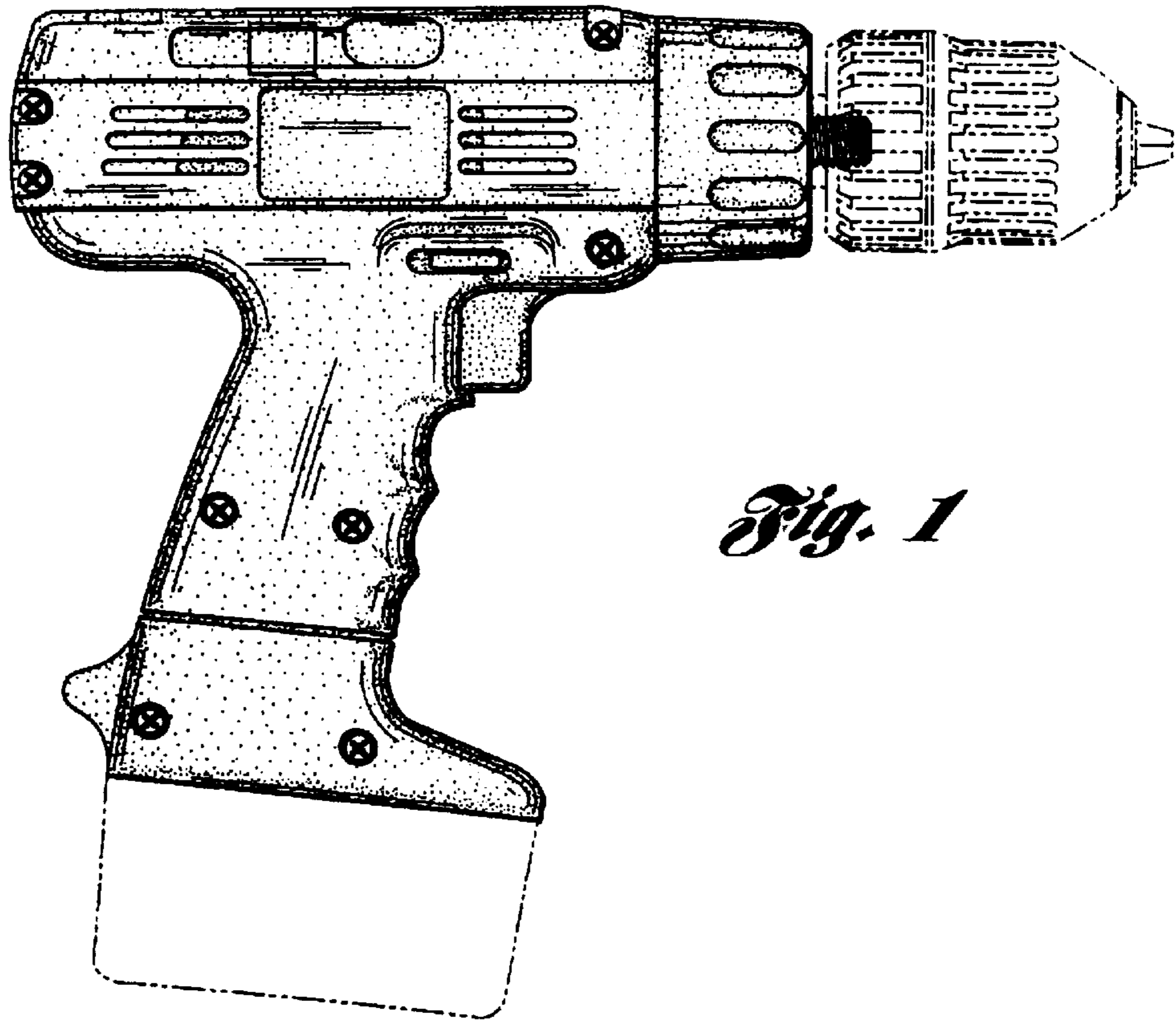
The ornamental design for a cordless electric drill, as shown and described.

**DESCRIPTION**

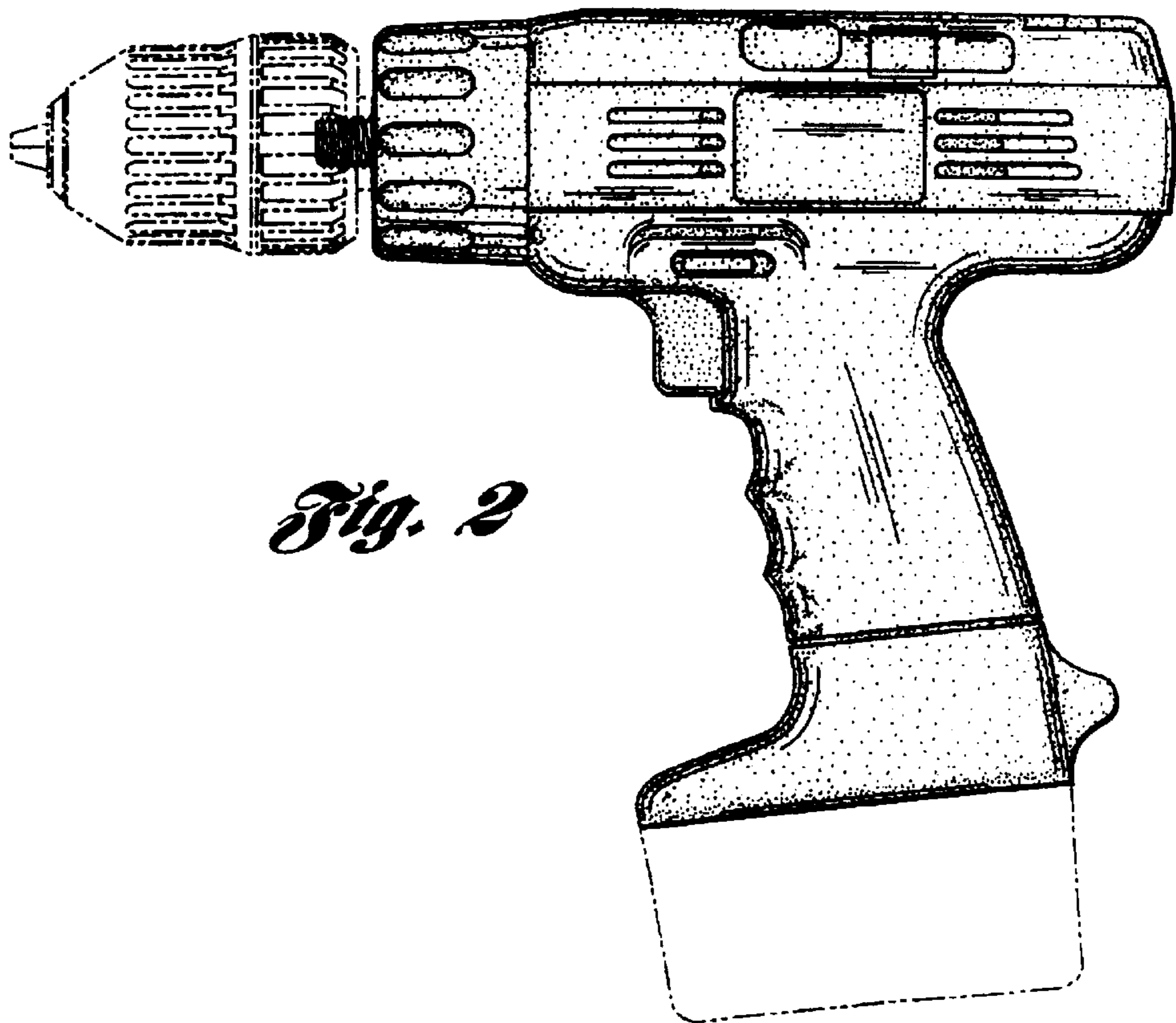
FIG. 1 is a right side elevational view of a cordless electric drill;

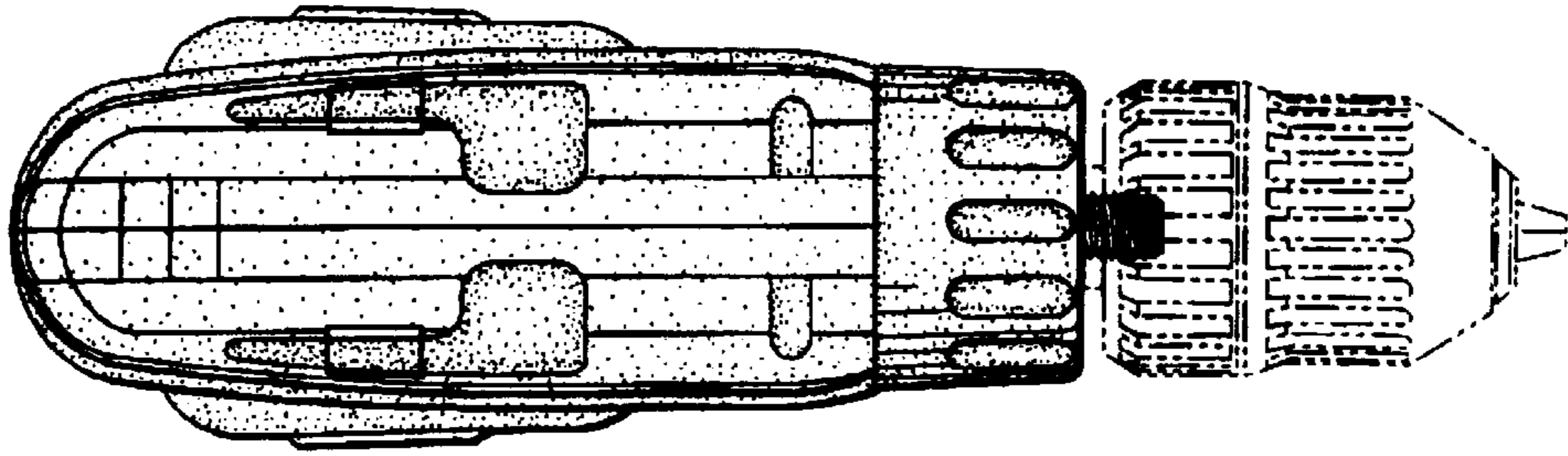




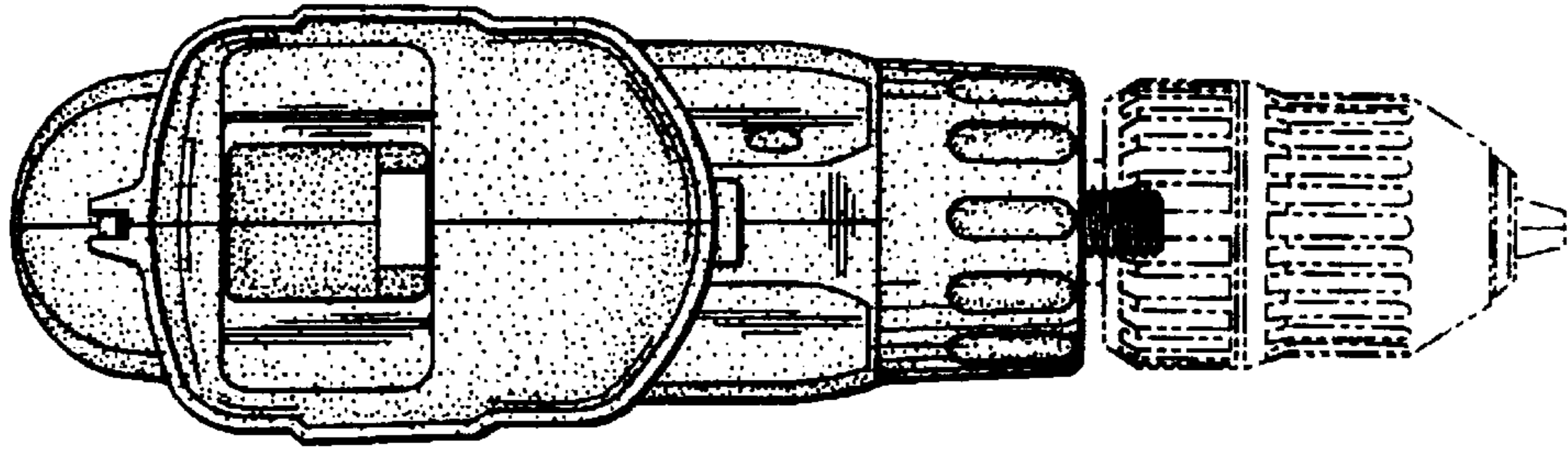

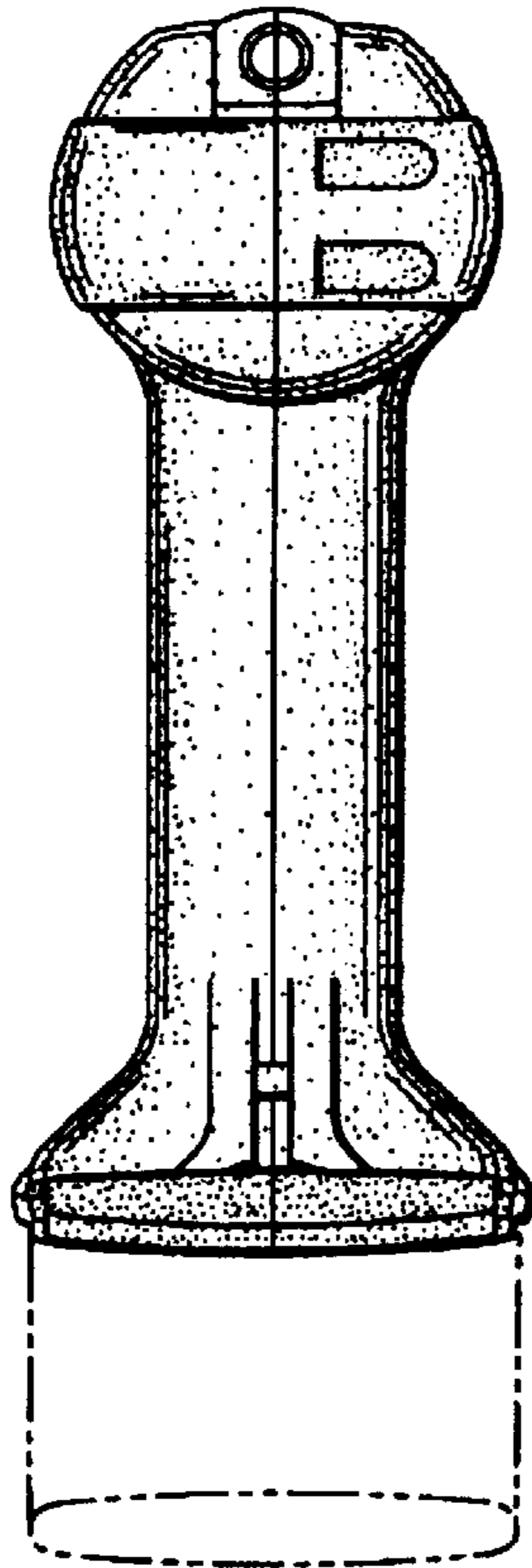

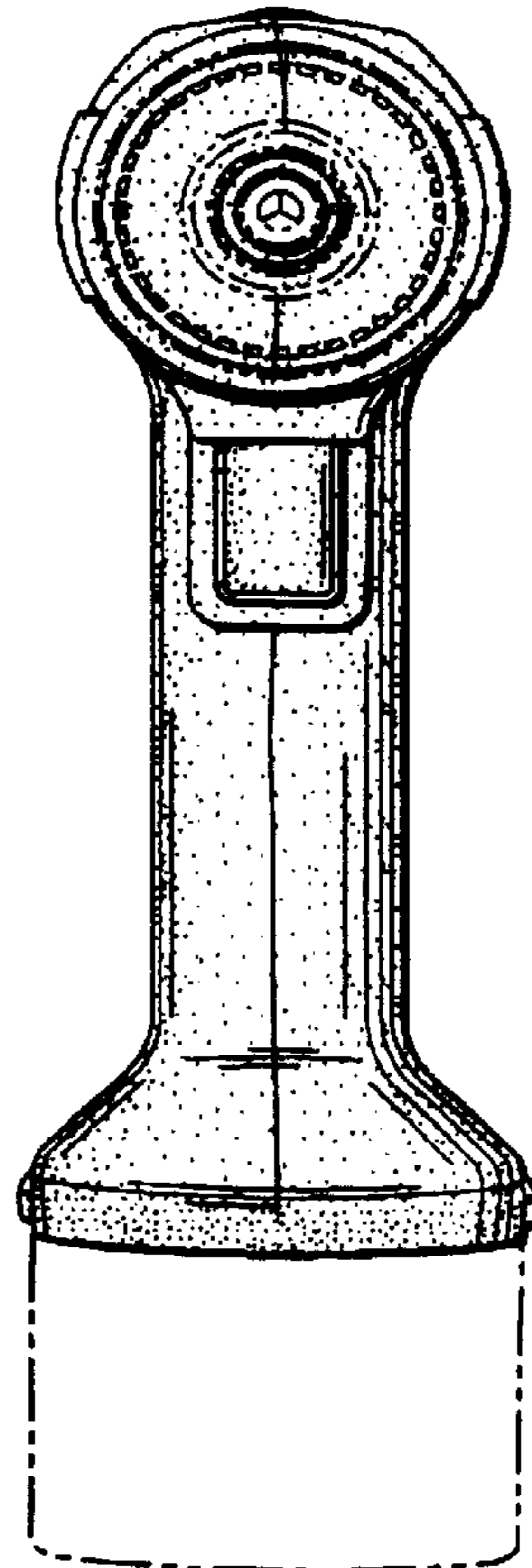
