The ornamental design for a rechargeable impact wrench, as shown and described.

DESCRIPTION

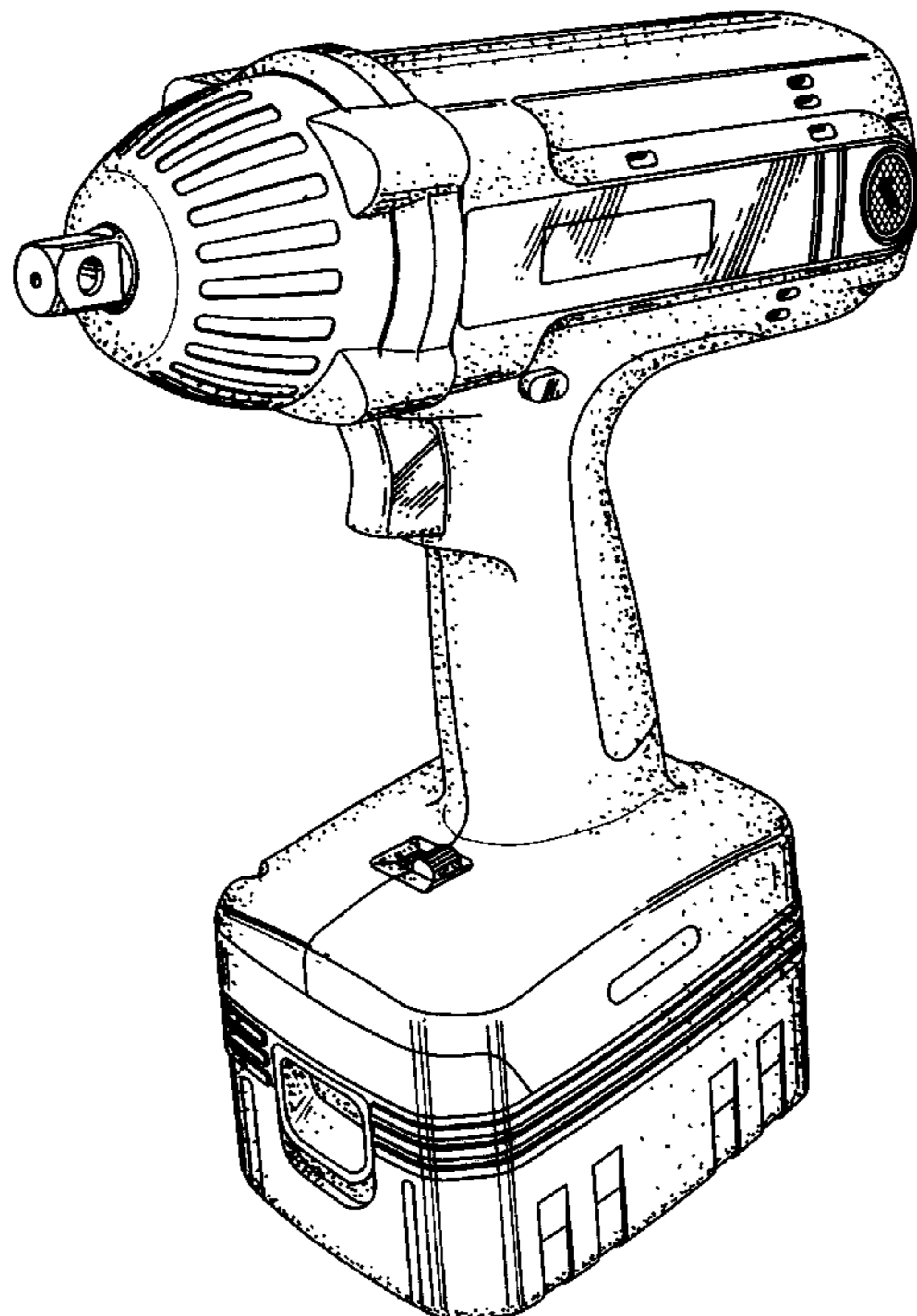

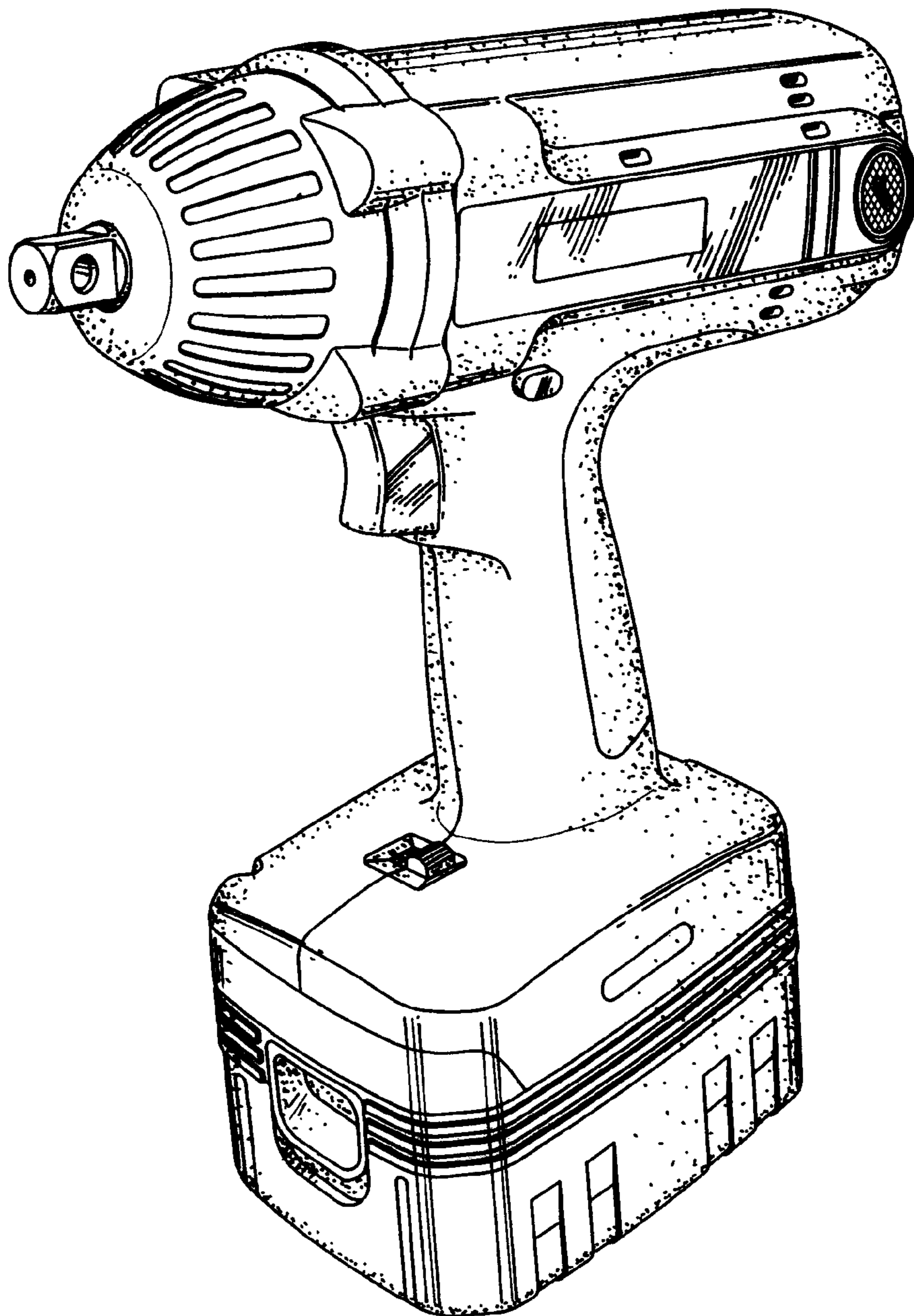

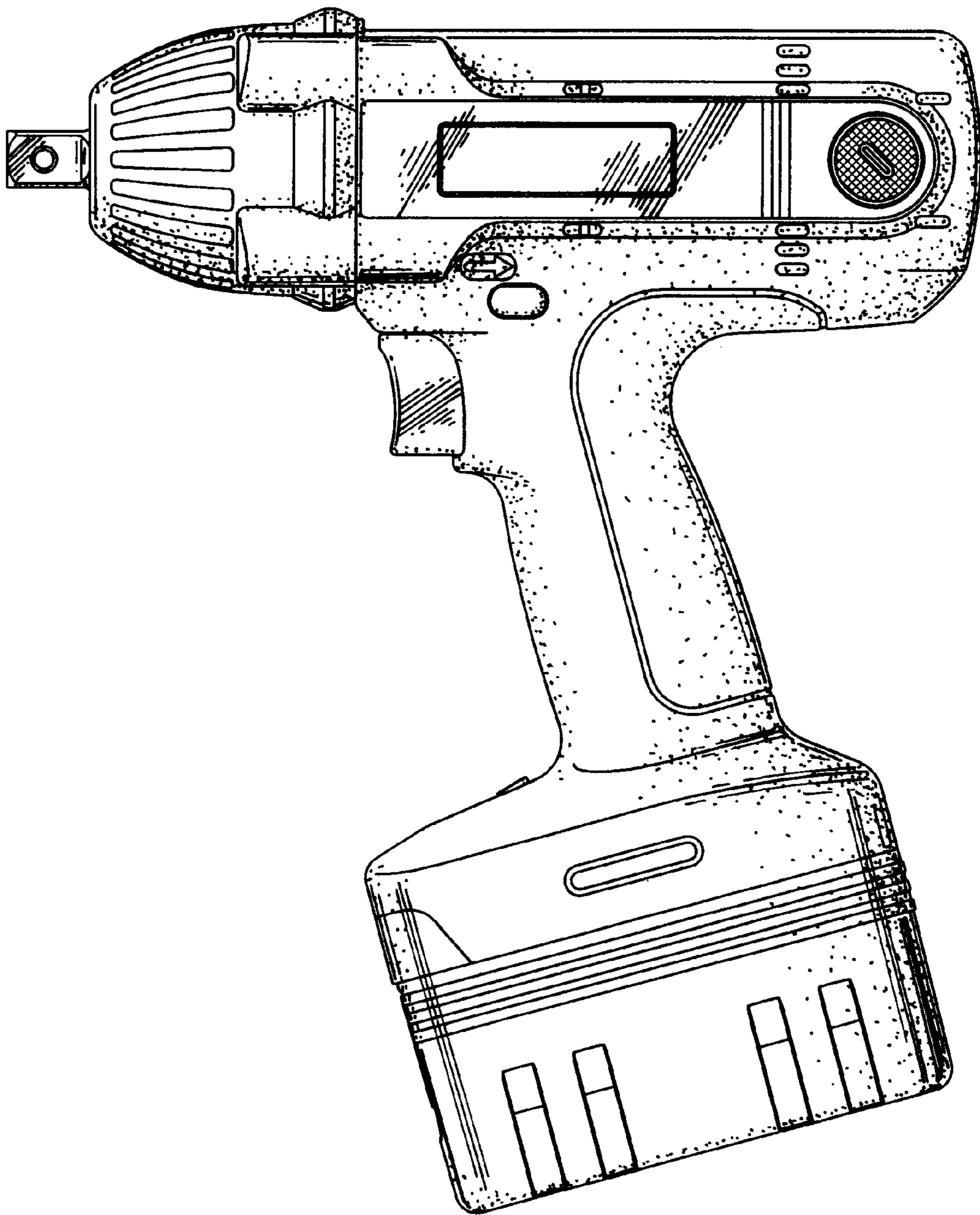

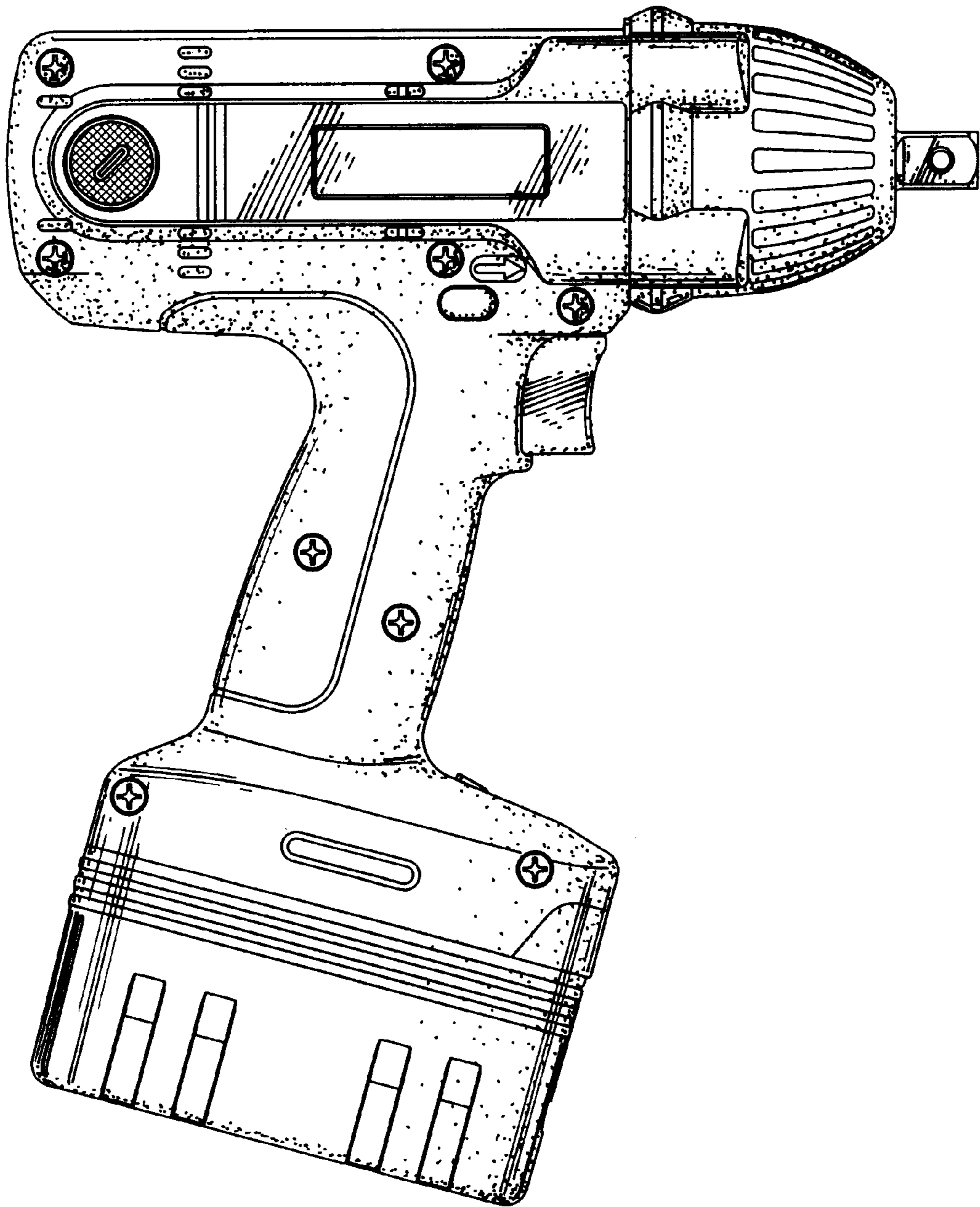

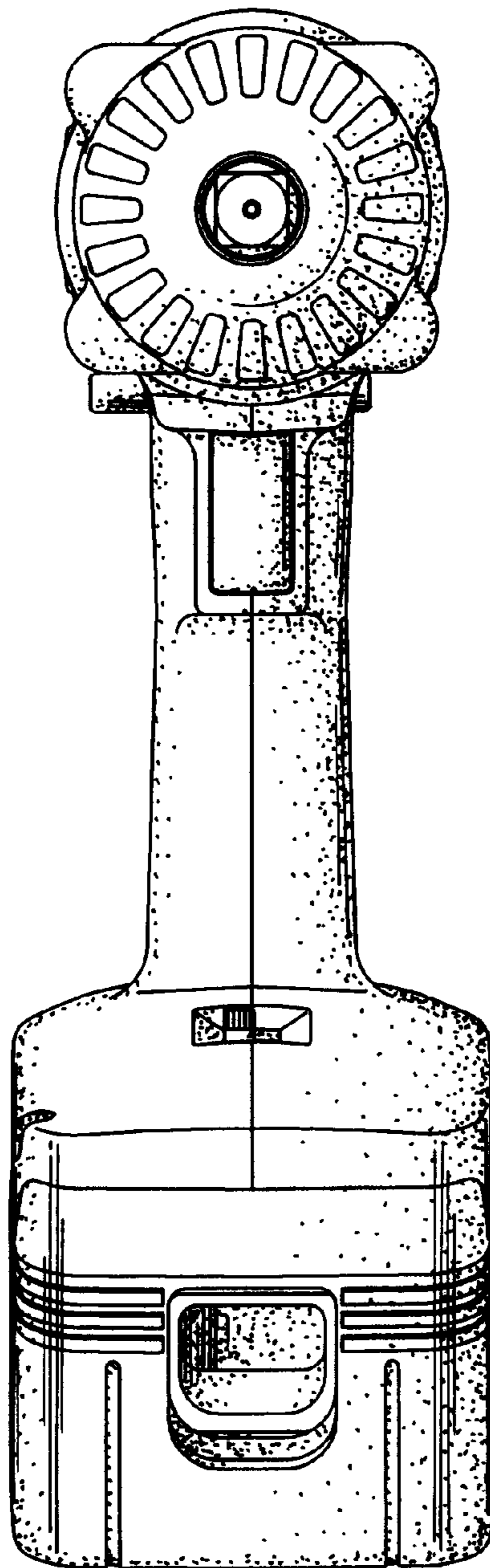

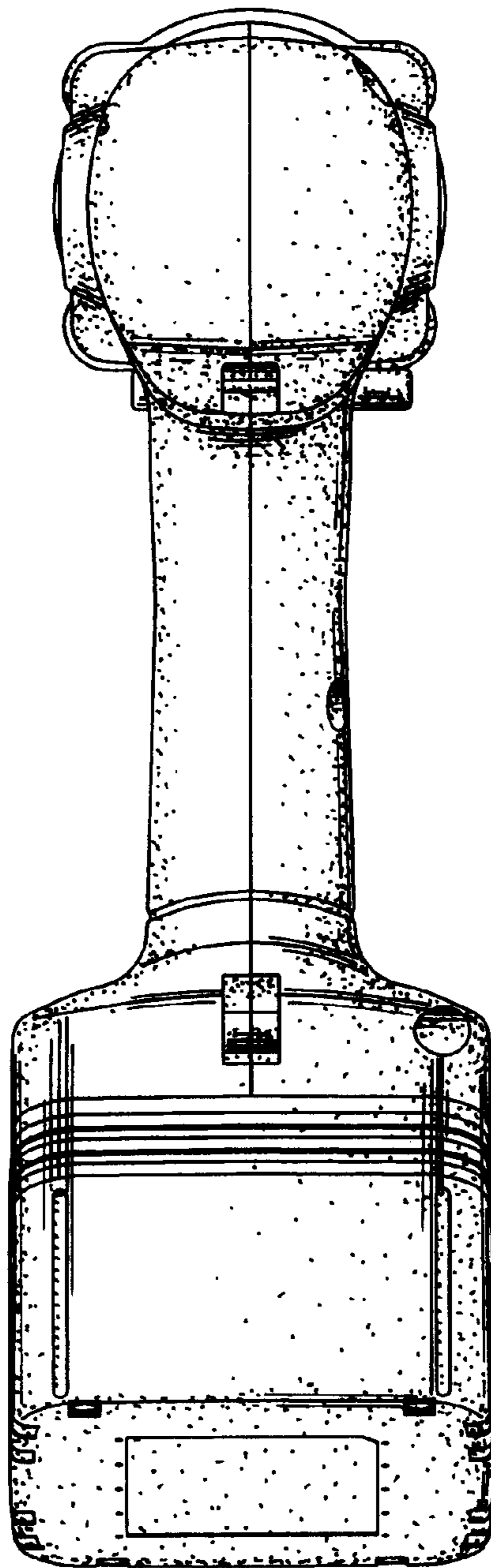

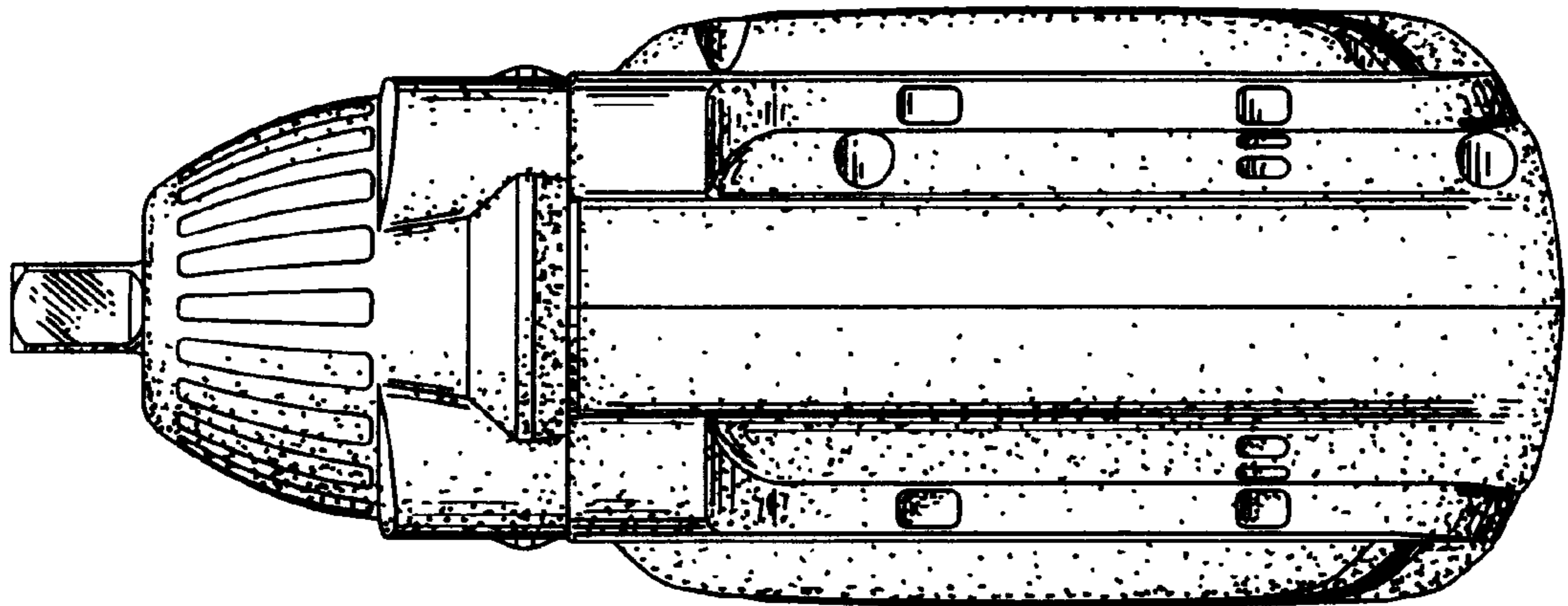
