(57) **CLAIM**

The ornamental design for a spray pump transition collar, as shown and described.

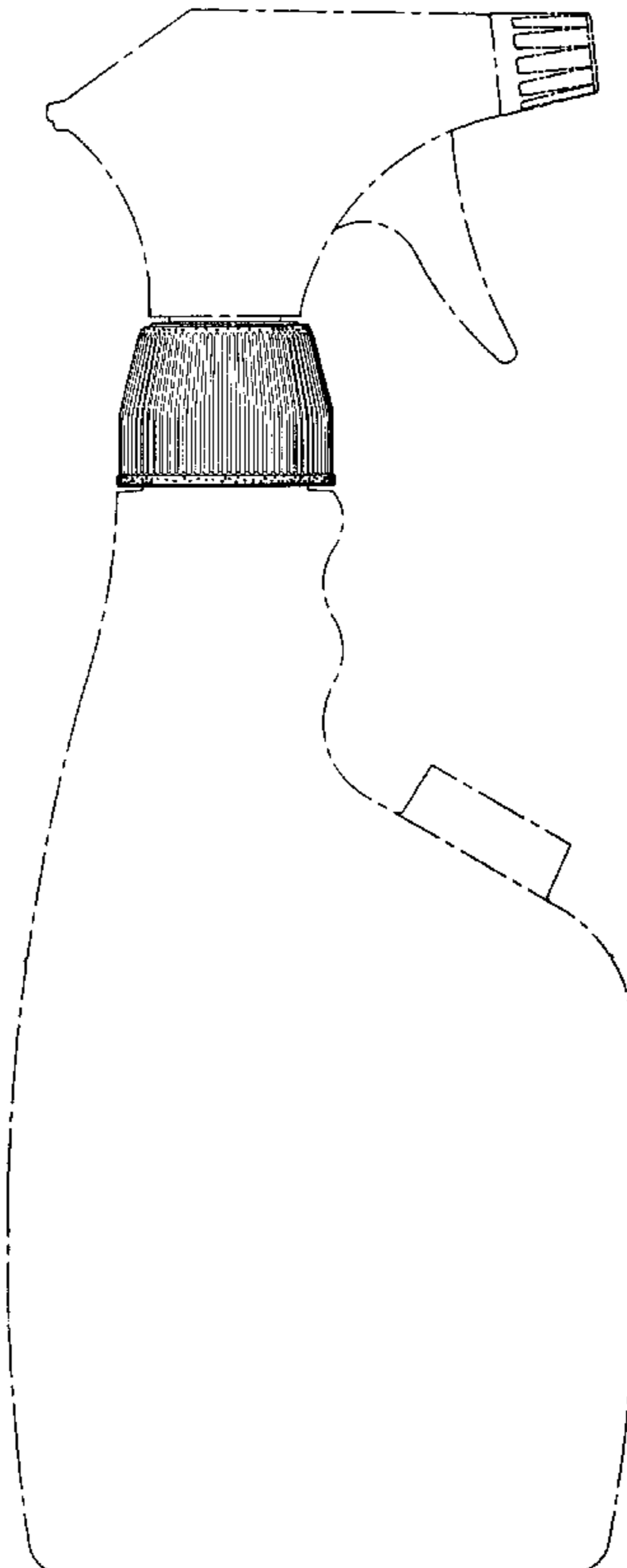
DESCRIPTION

FIG. 1 is a side elevational view of a spray pump transition collar showing our new design, the spray pump and container being shown in broken lines for illustrating the environment in which the collar is used, and forming no part of the claimed design;

FIG. 2 is an enlarged side elevational view of the collar; and, FIG. 3 is a top plan view.

The front, rear and opposite side views are the same as the side view shown. The bottom plan view is not normally seen.

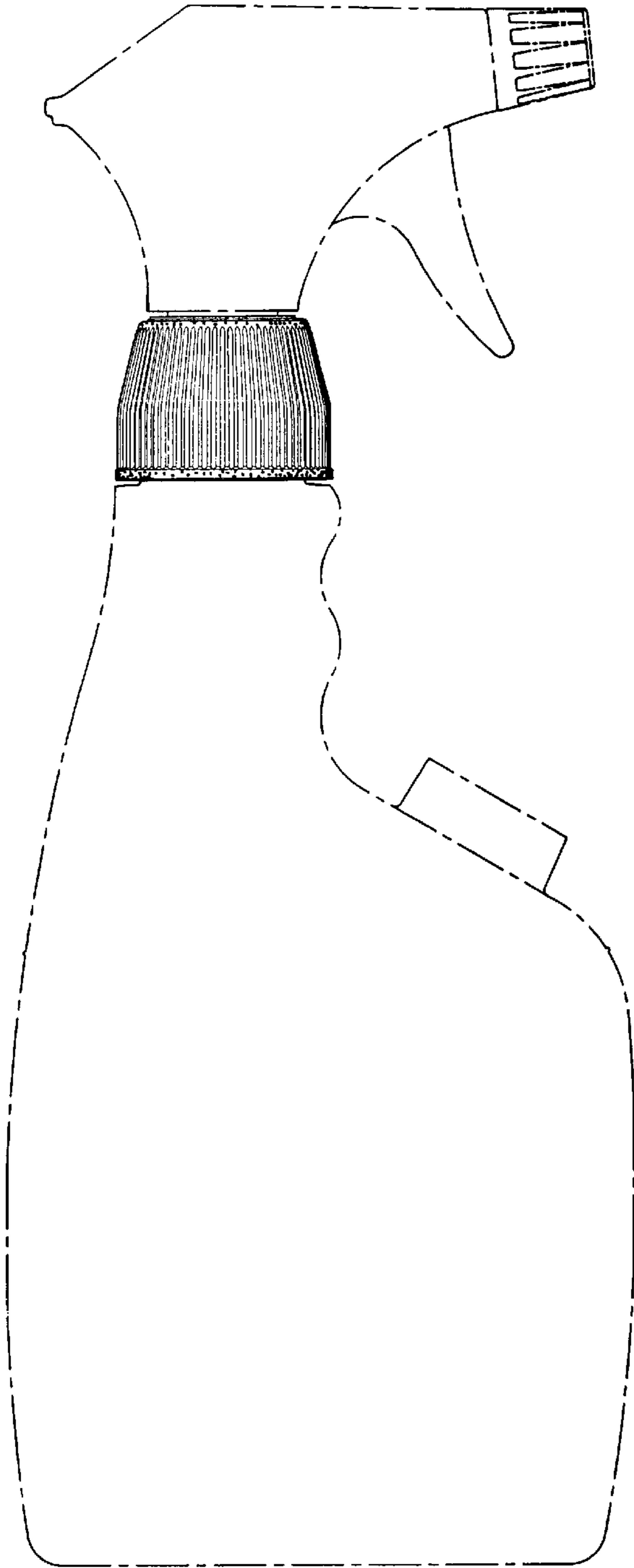

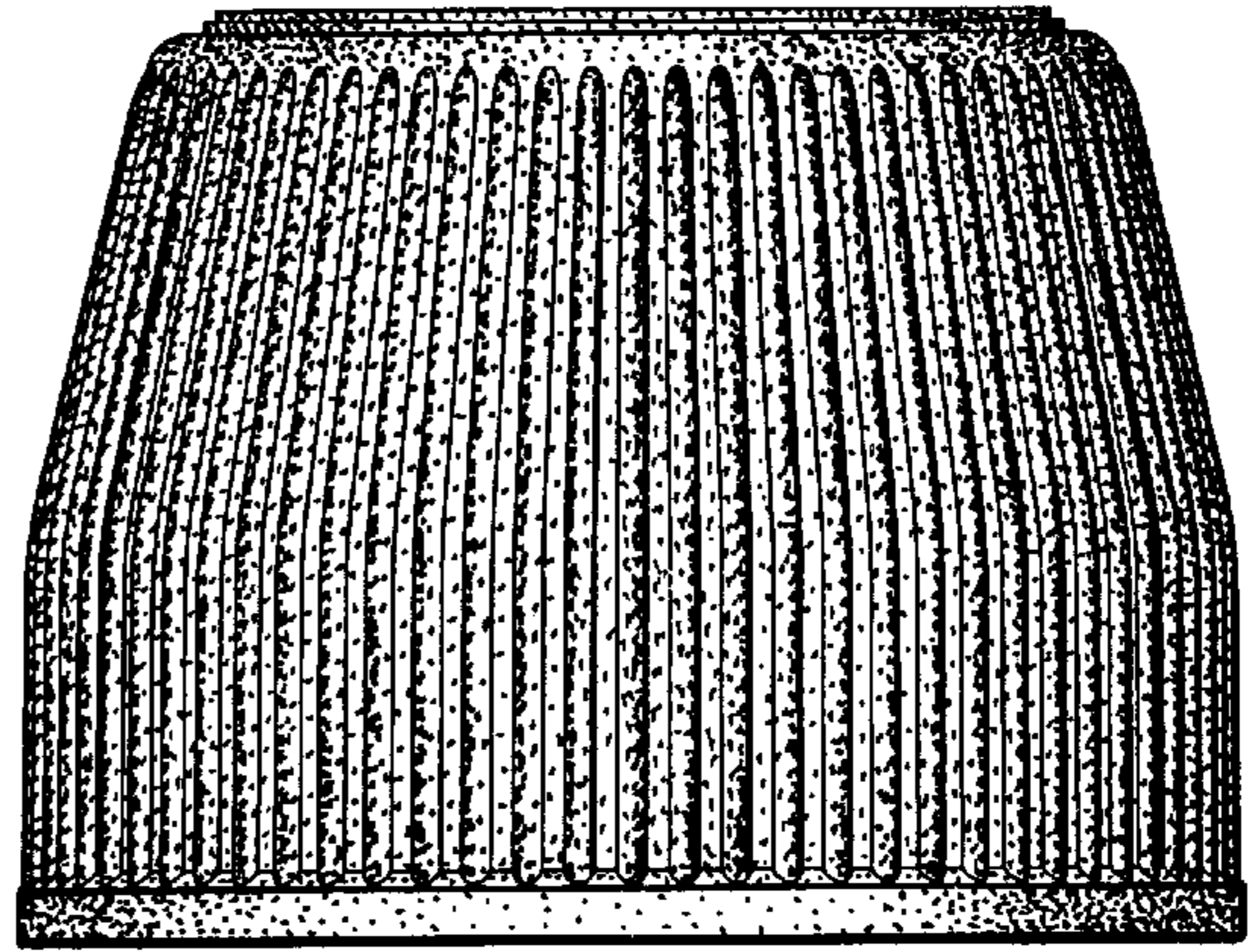

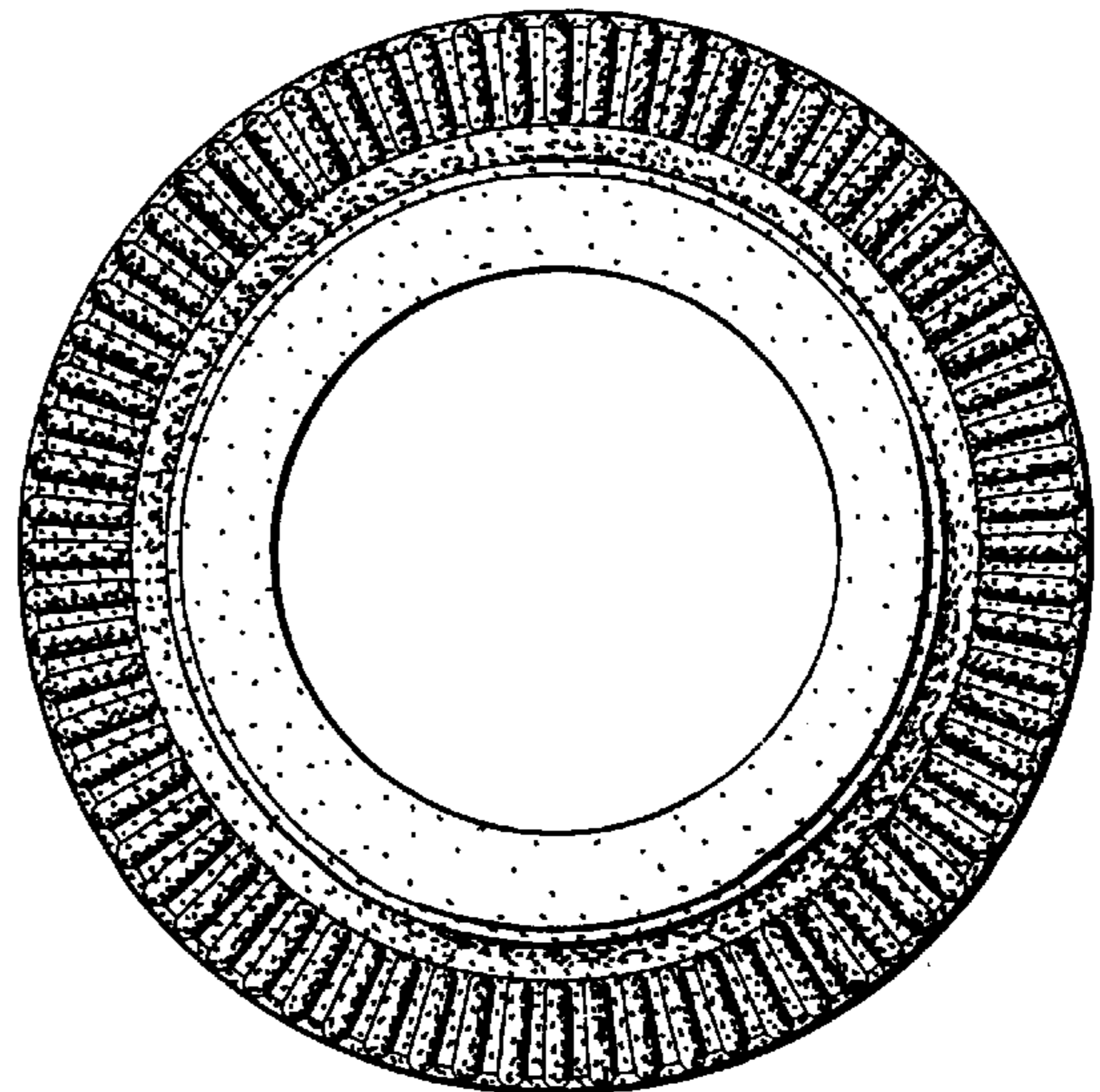
