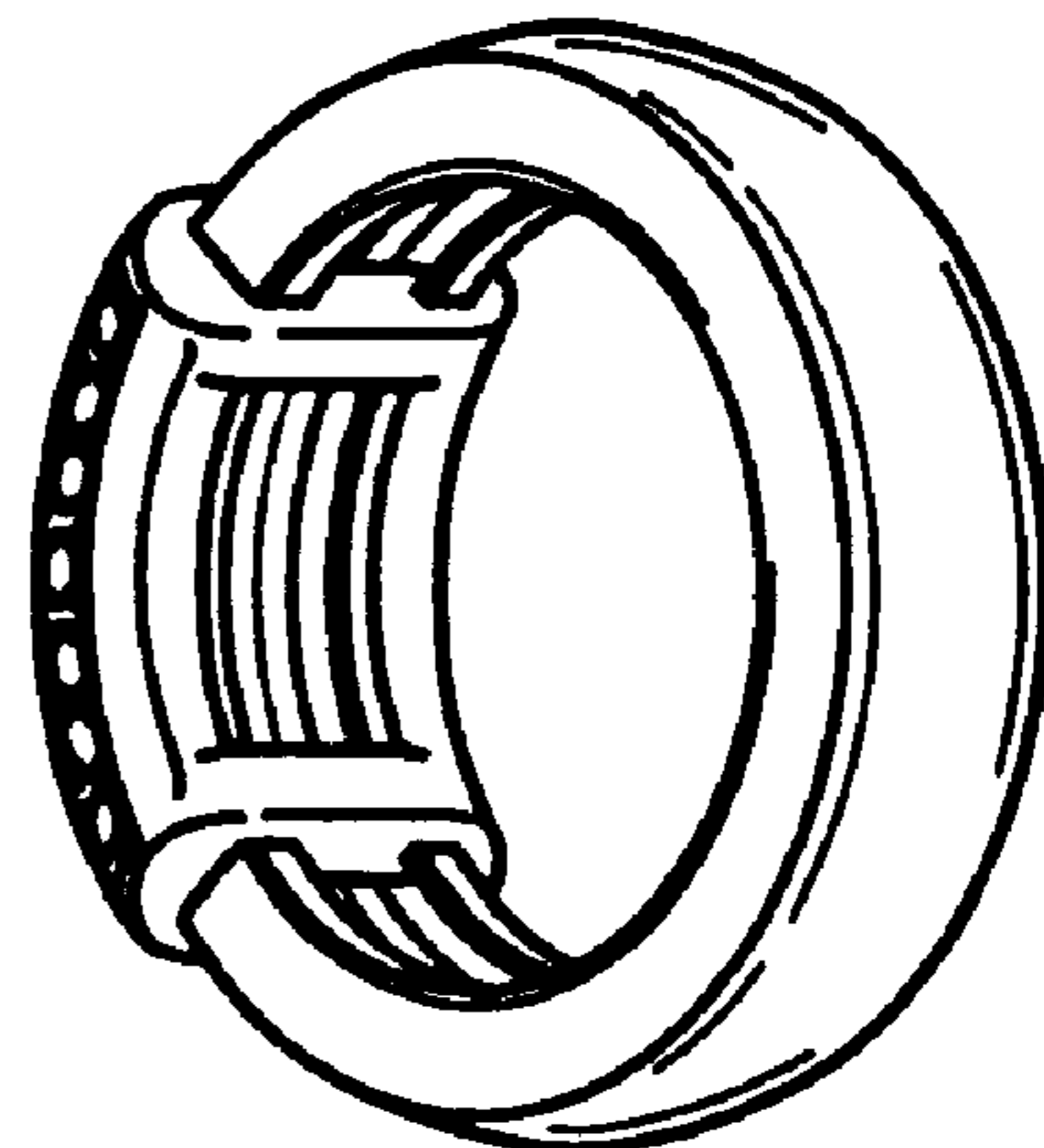
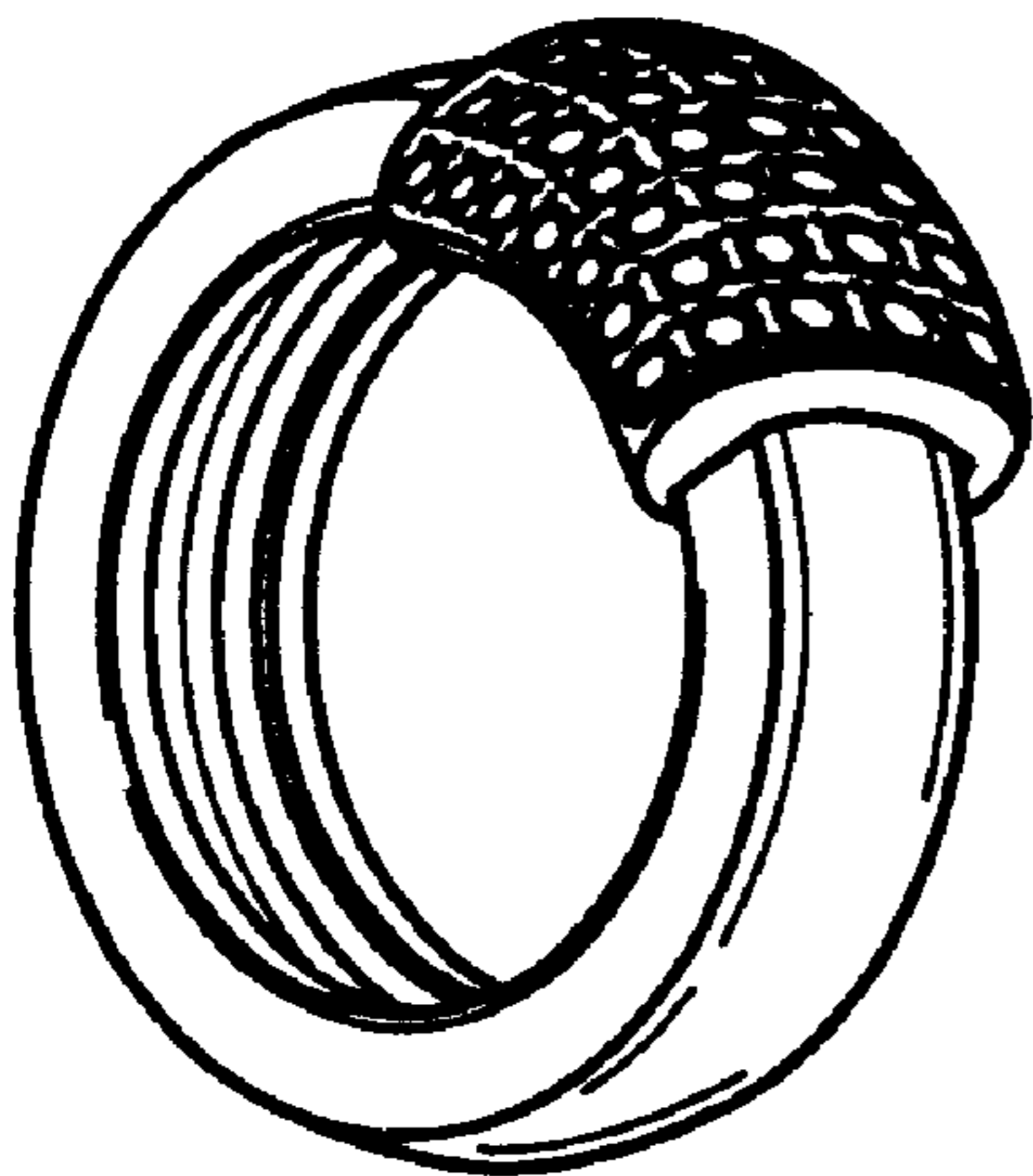
(57) **CLAIM**

The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ring showing my new design;
FIG. 2 is a perspective view showing the inside of the ring;
FIG. 3 is a front elevation of the ring, the rear elevation being identical;
FIG. 4 is a side elevation view of the ring from either side of FIG. 3;
FIG. 5 is a bottom view of the ring; and,
FIG. 6 is a top view of the ring.

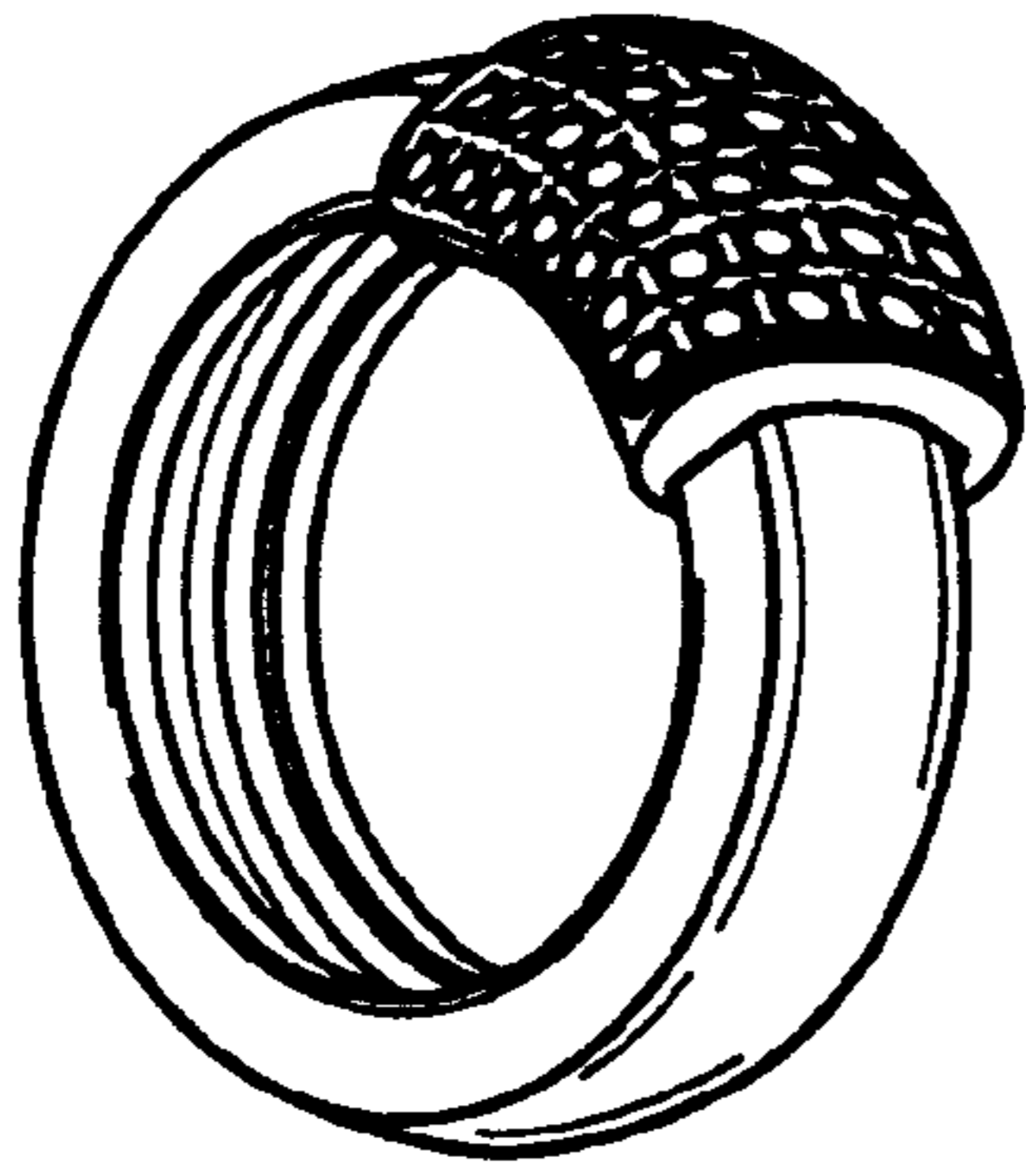

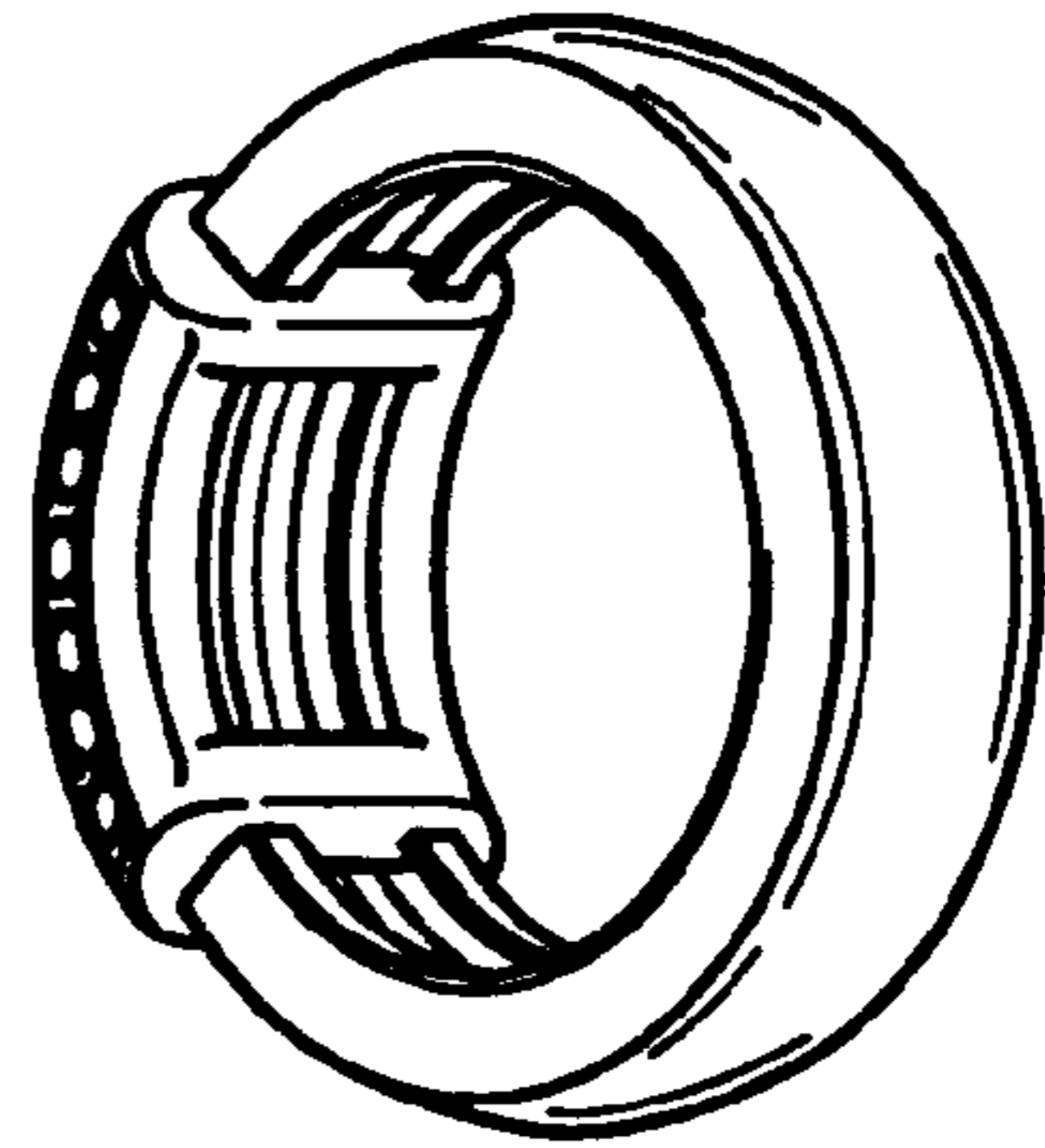

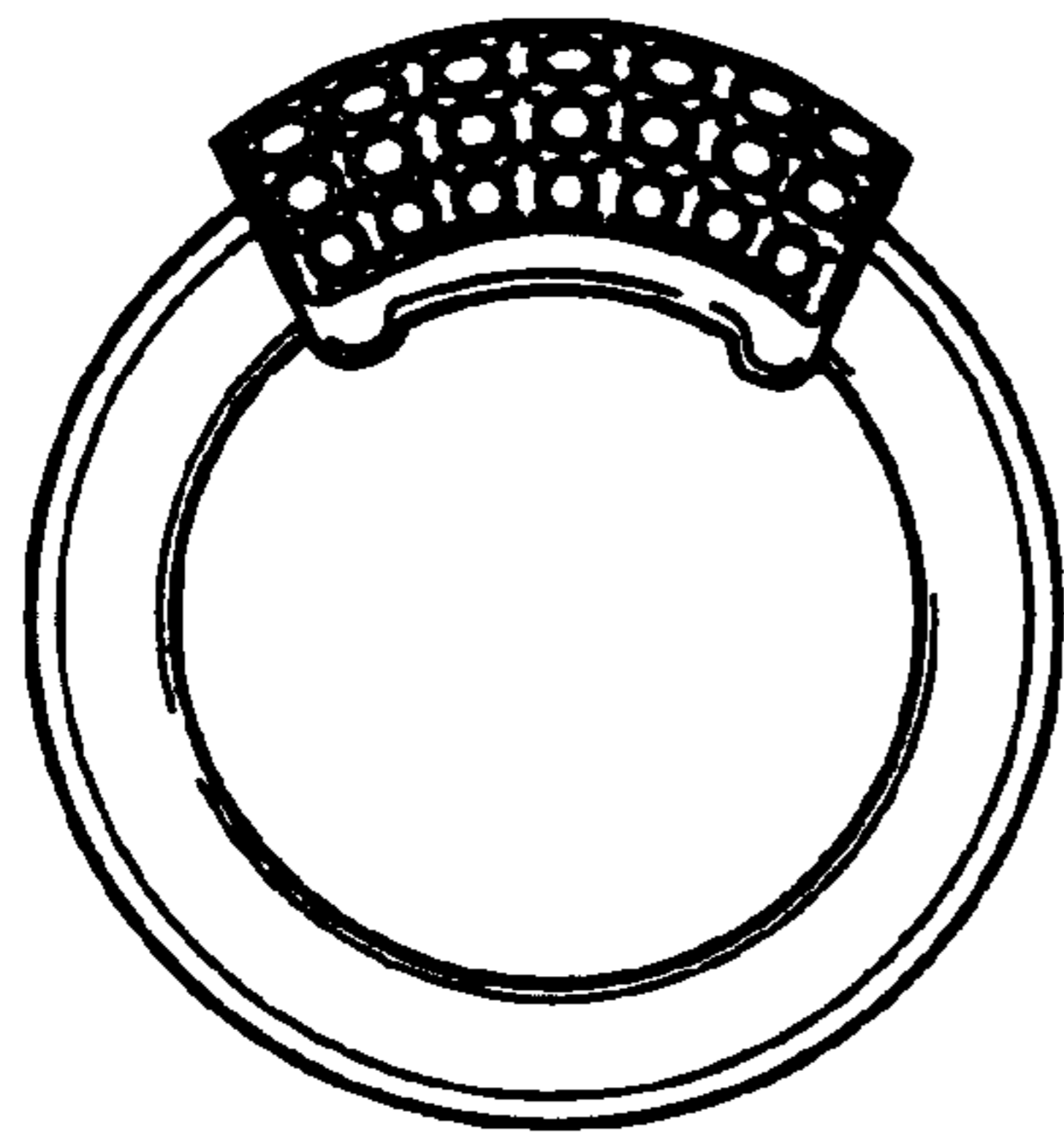

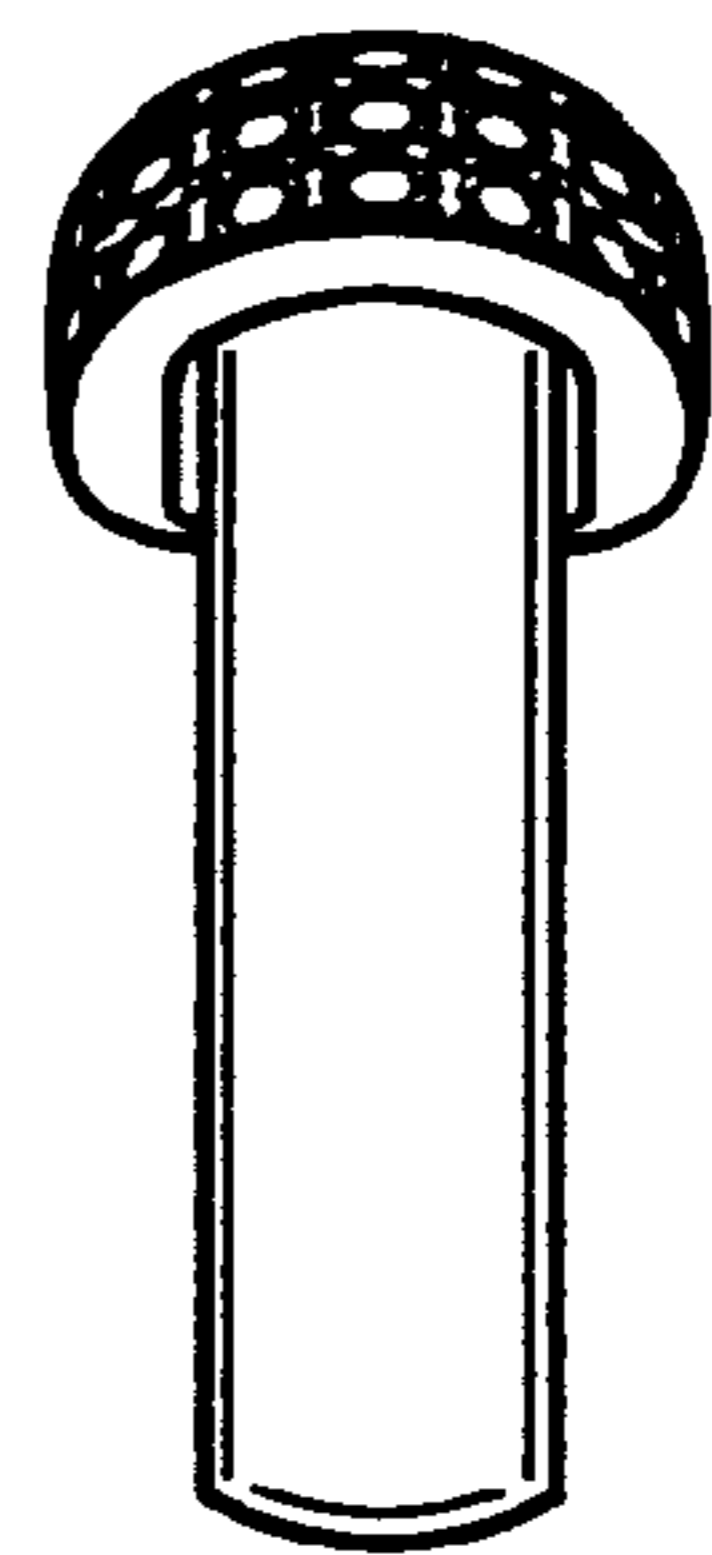

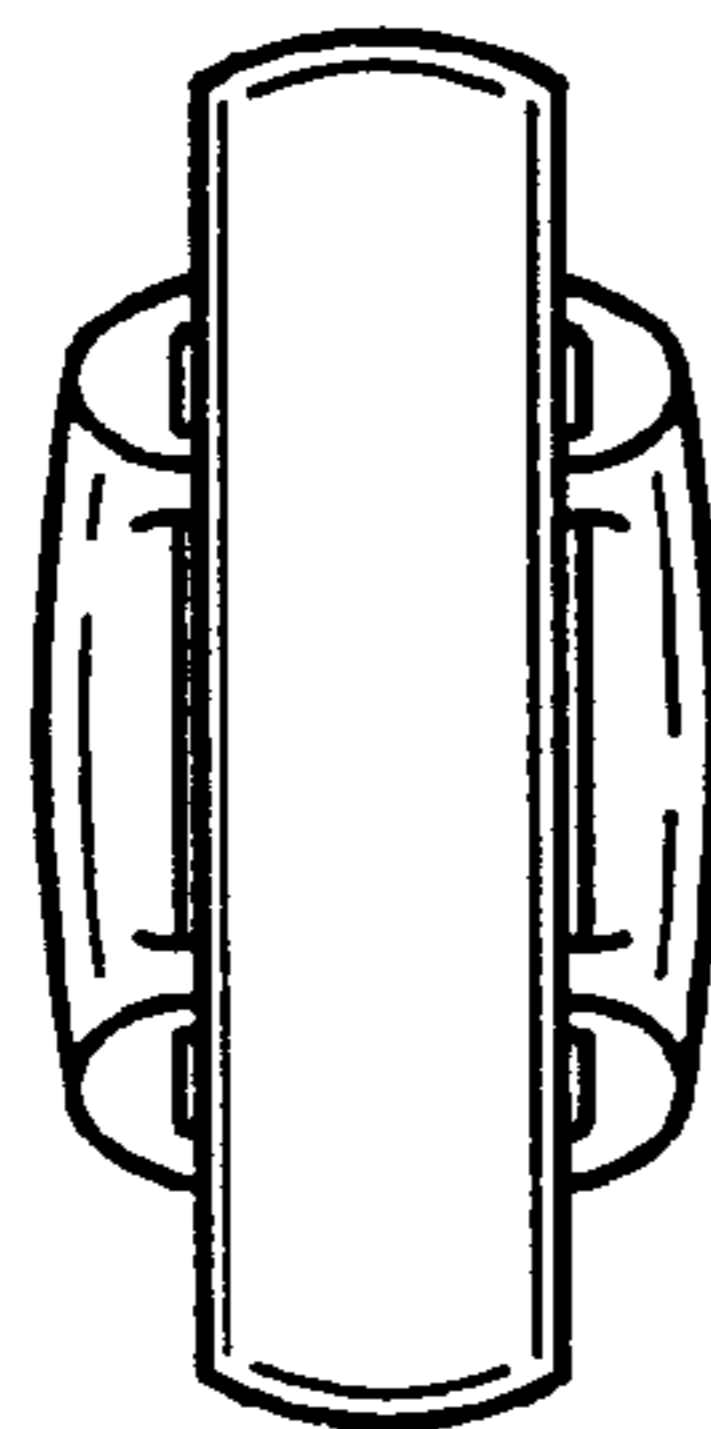

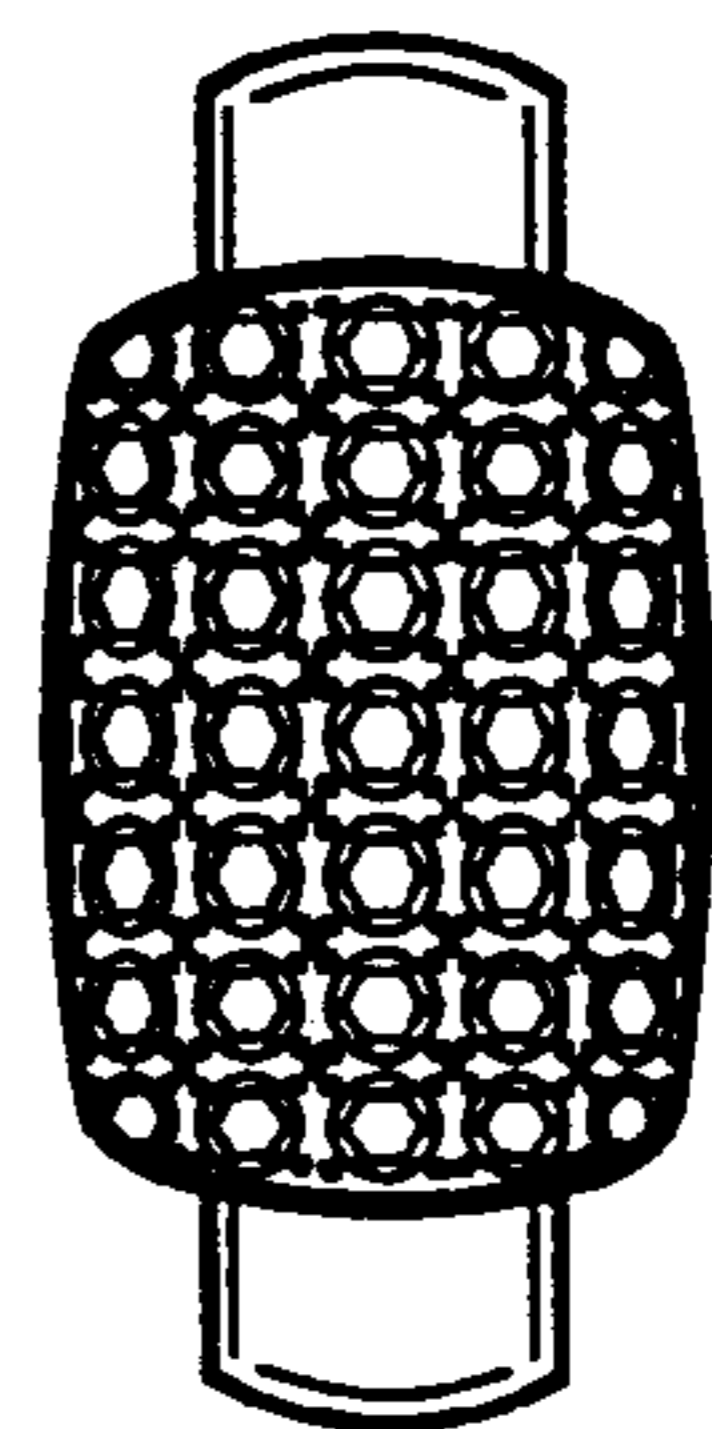
