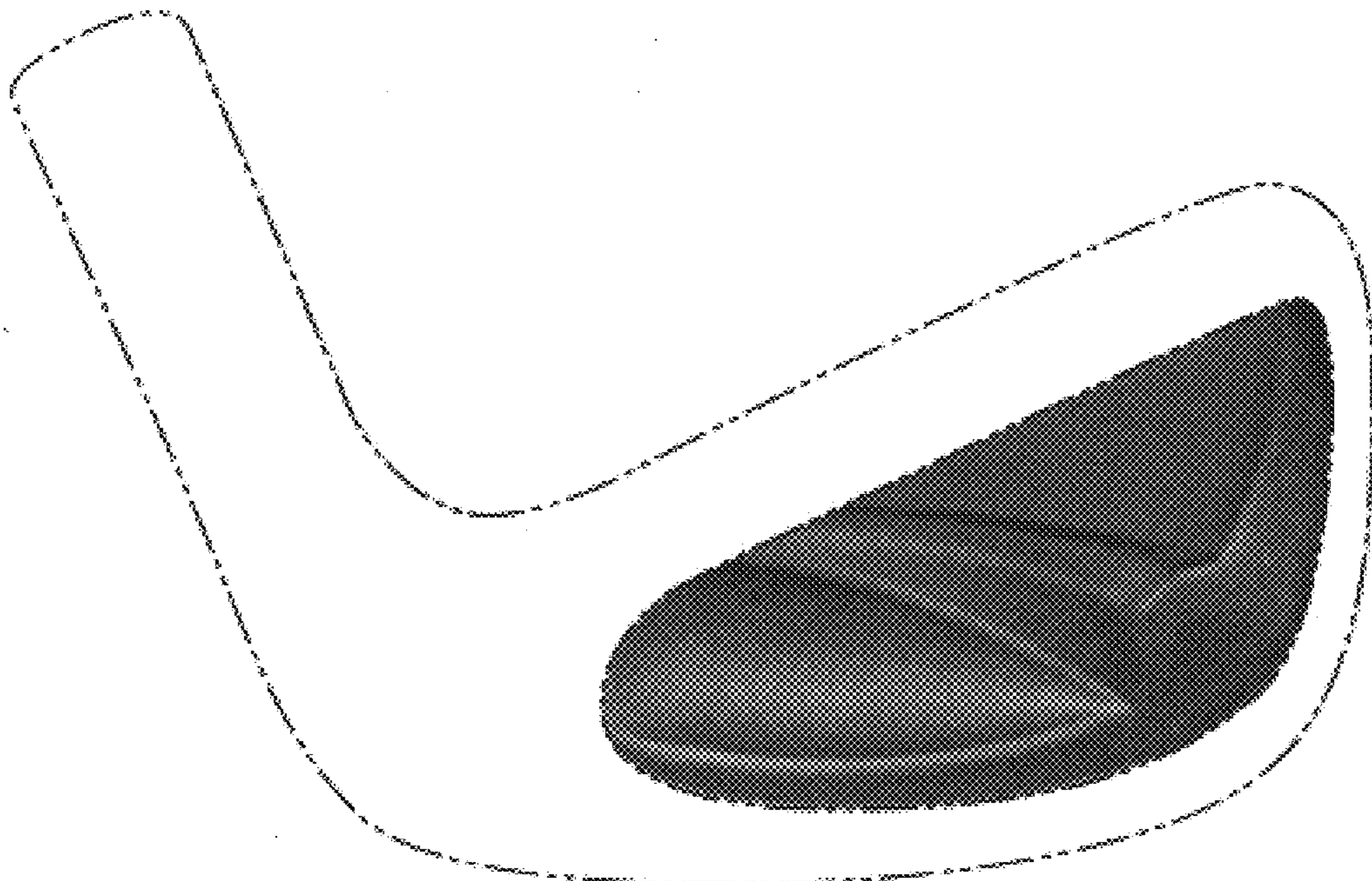
(57) **CLAIM**

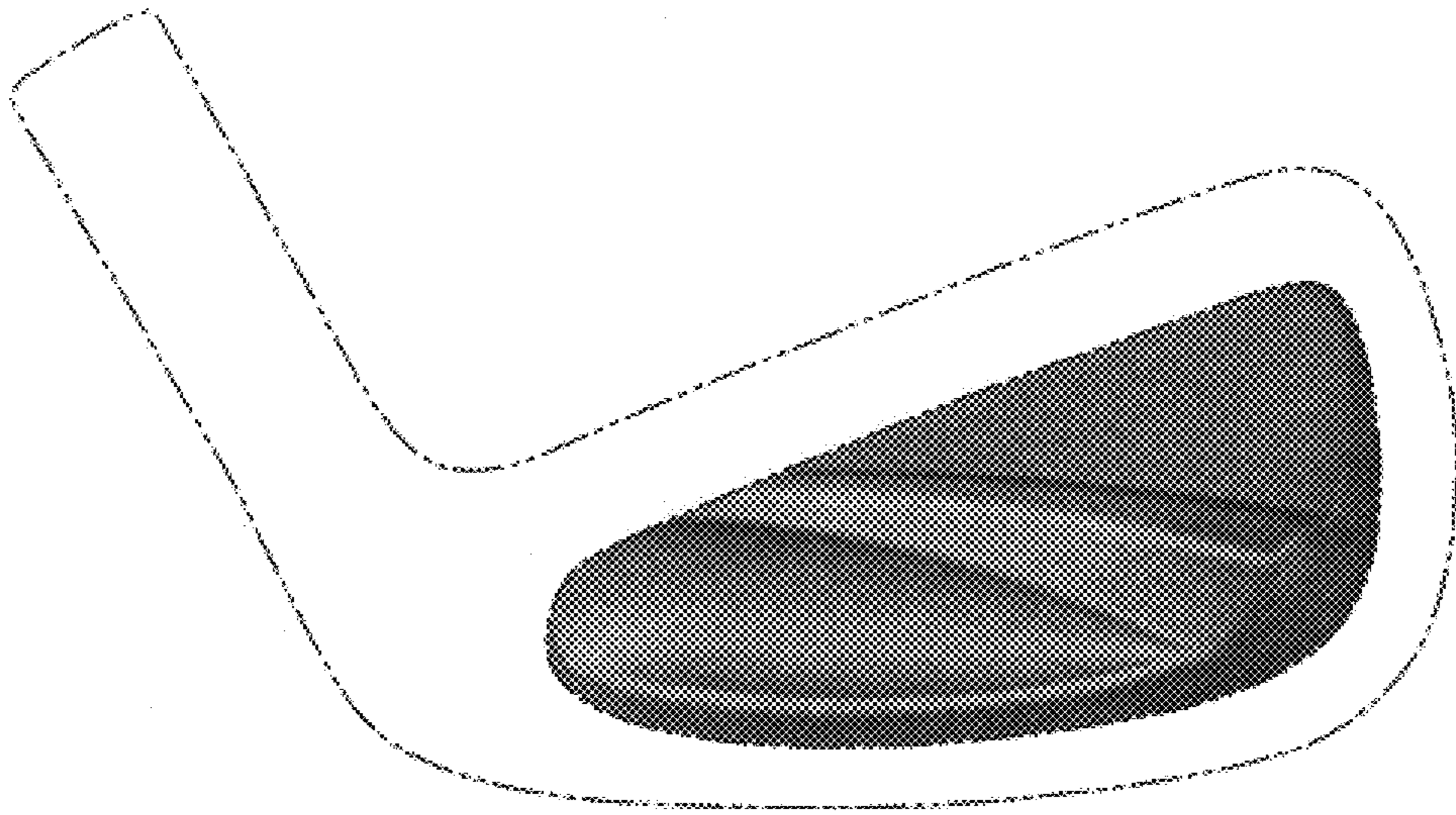
The ornamental design for a golf club cavity, as shown and described.

**DESCRIPTION**

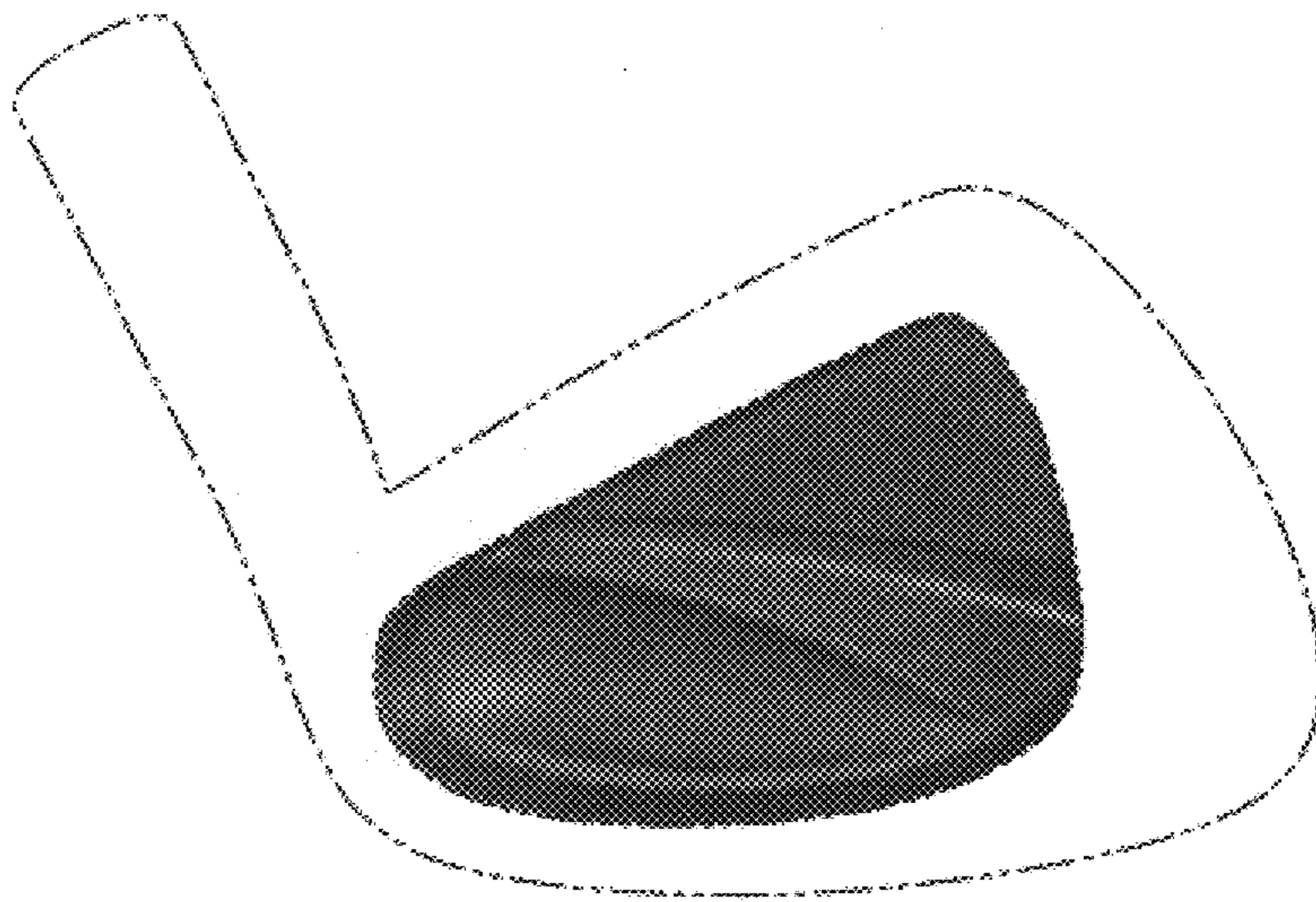
FIG. 1 is a rear view of the golf club cavity;  
FIG. 2 is a rear perspective view, toward the toe side of the gold club head, showing the cavity of FIG. 1;  
FIG. 3 is a rear perspective view, toward the heel side of the golf club head, showing the cavity of FIG. 1;  
FIG. 4 is a rear perspective view, toward the upper heel side of the golf club head, showing the cavity of FIG. 1;  
FIG. 5 is a rear perspective view, toward the upper toe side of the club head, showing the cavity of FIG. 1;  
FIG. 6 is a bottom view of the cavity of FIG. 1;  
FIG. 7 is a toe side perspective view of the cavity of FIG. 1;  
FIG. 8 is a rear perspective view, toward the lower heel side of the golf club head, showing the cavity of FIG. 1; and,  
FIG. 9 is a bottom perspective view of the cavity of FIG. 1.  
The broken lines showing the golf club head in FIGS. 1-9 are for illustrative purposes only and form no part of the claimed design.

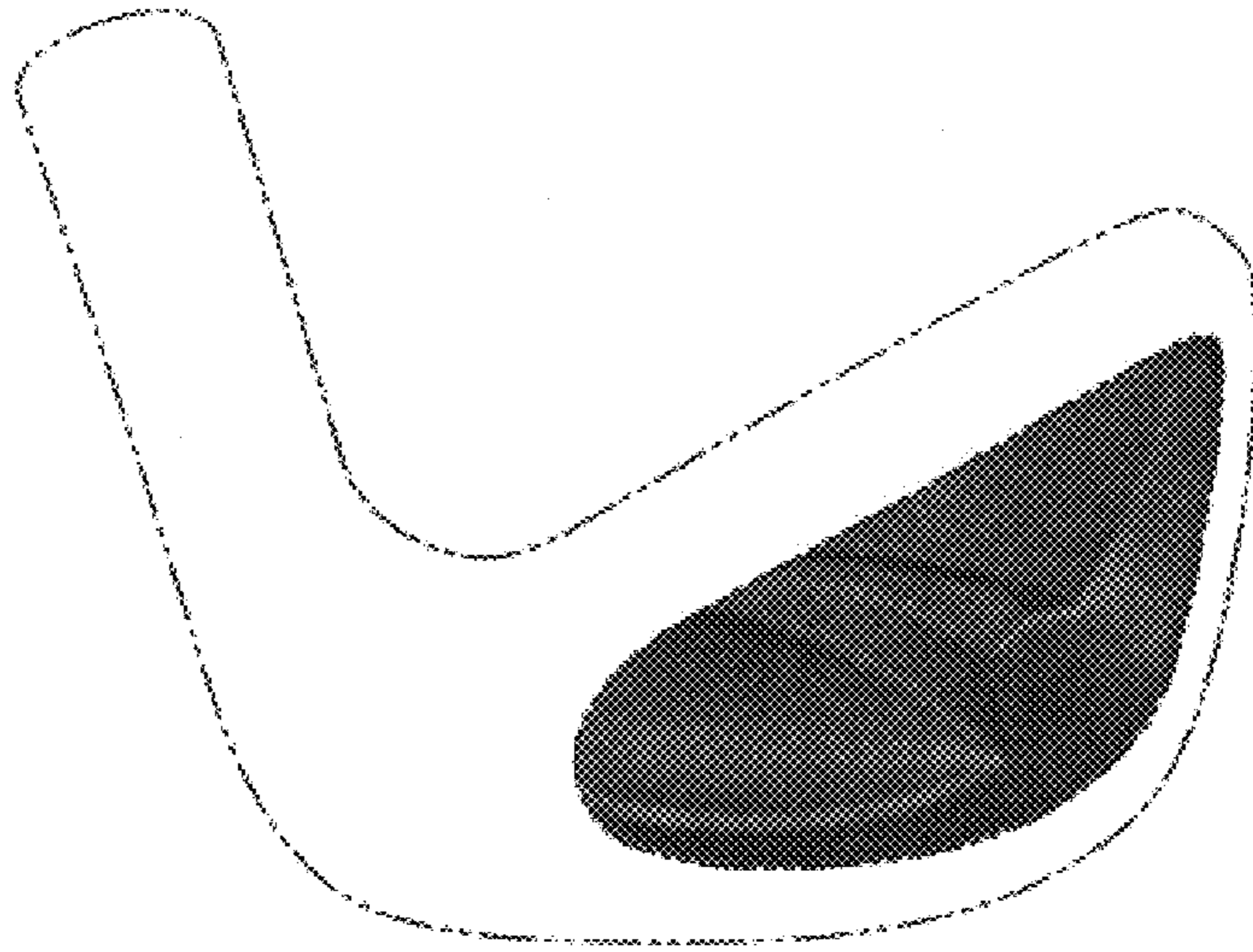




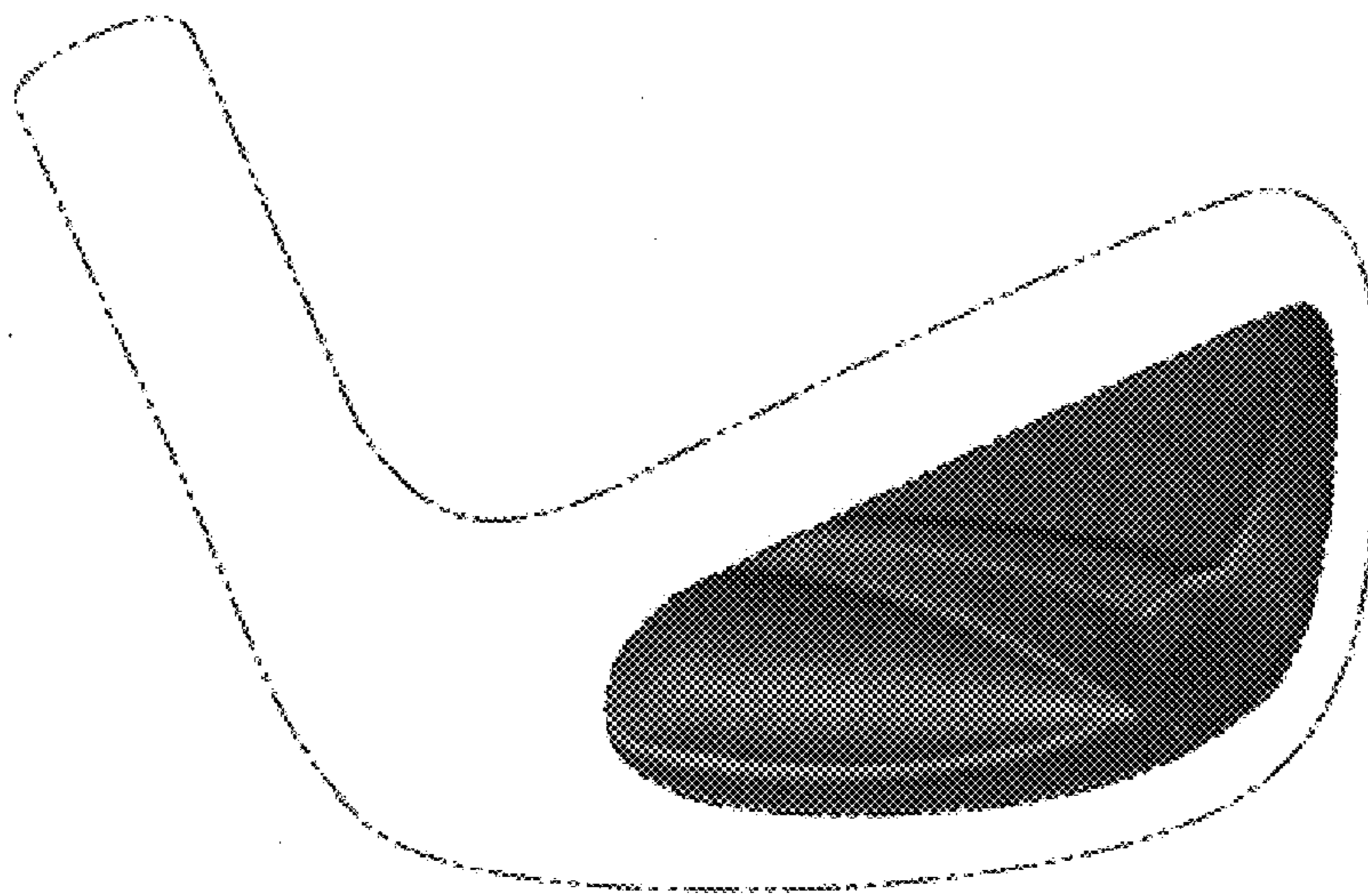

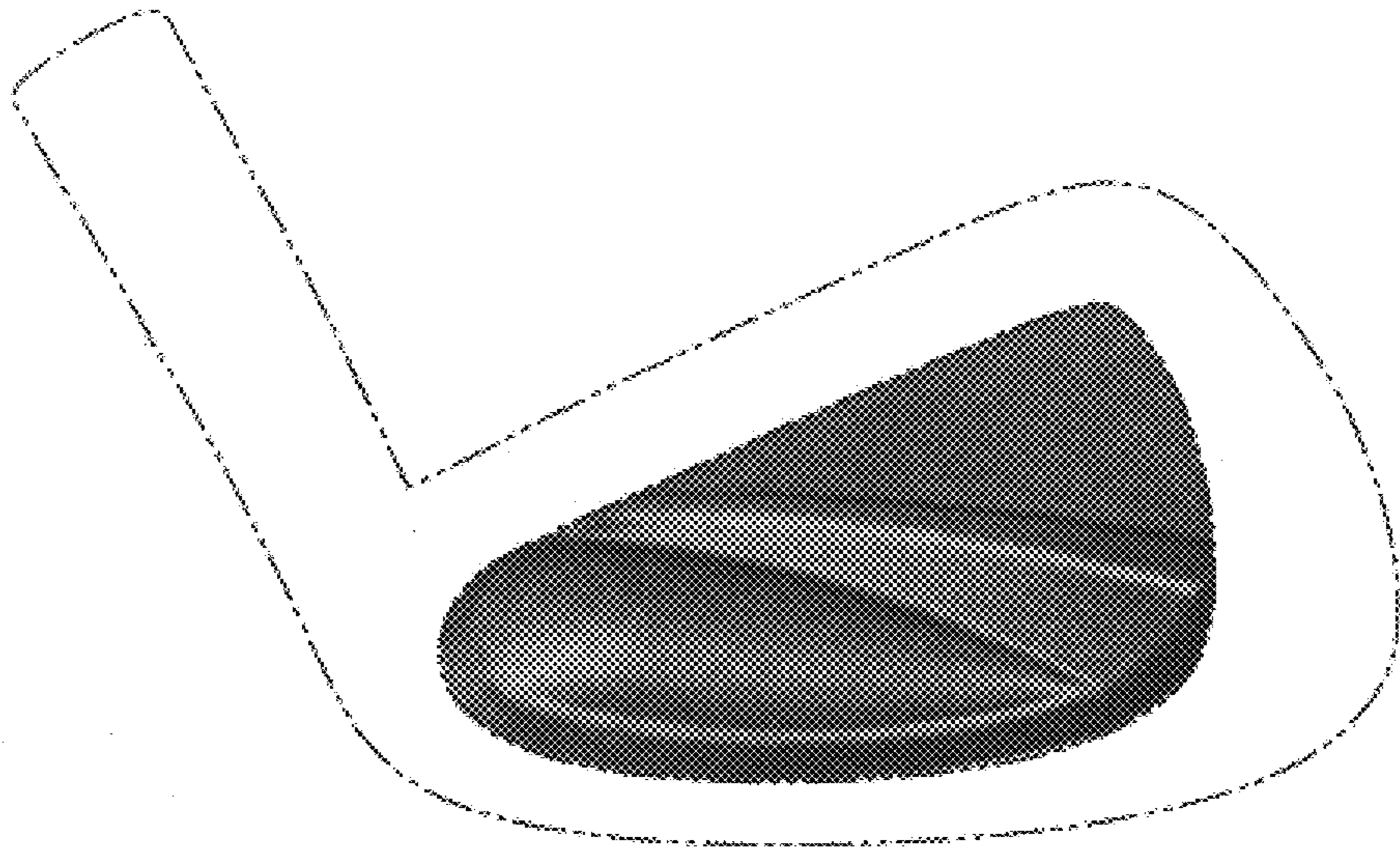

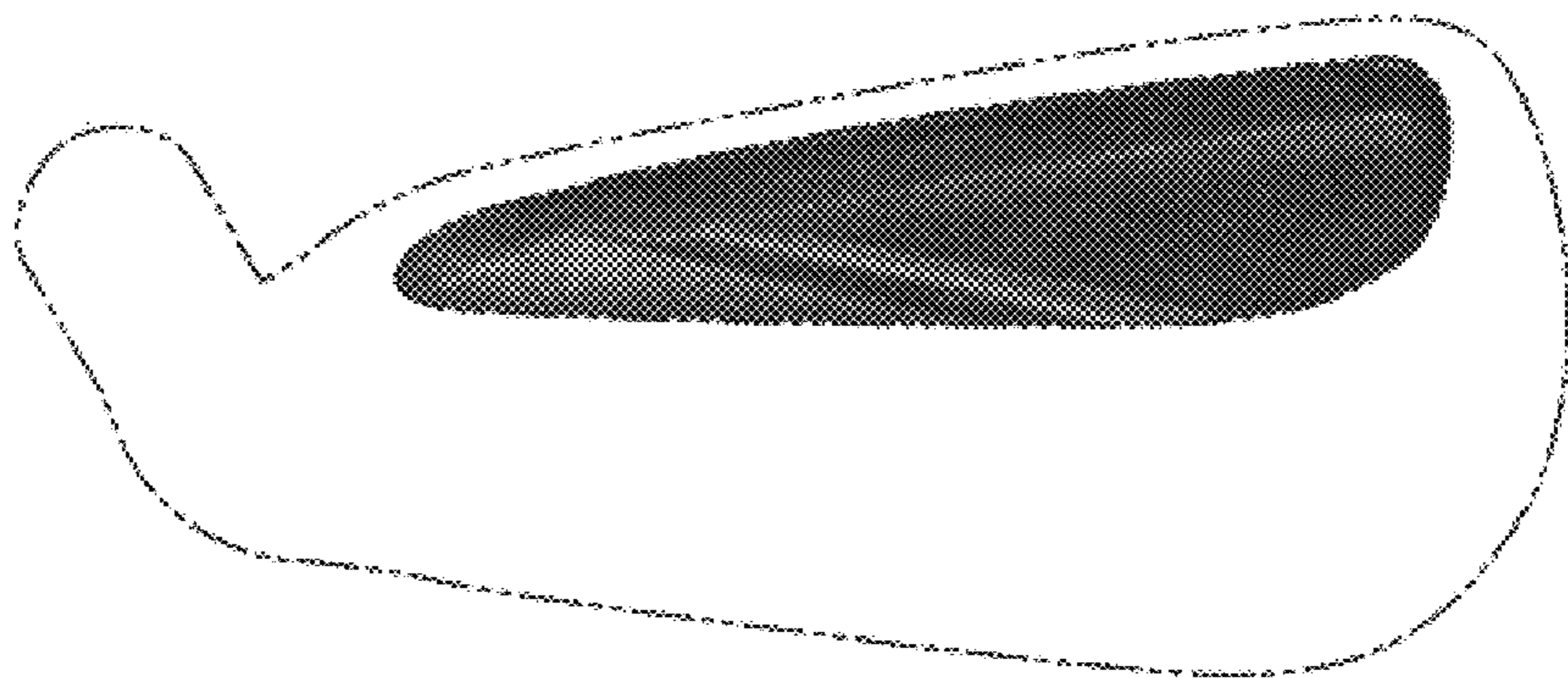

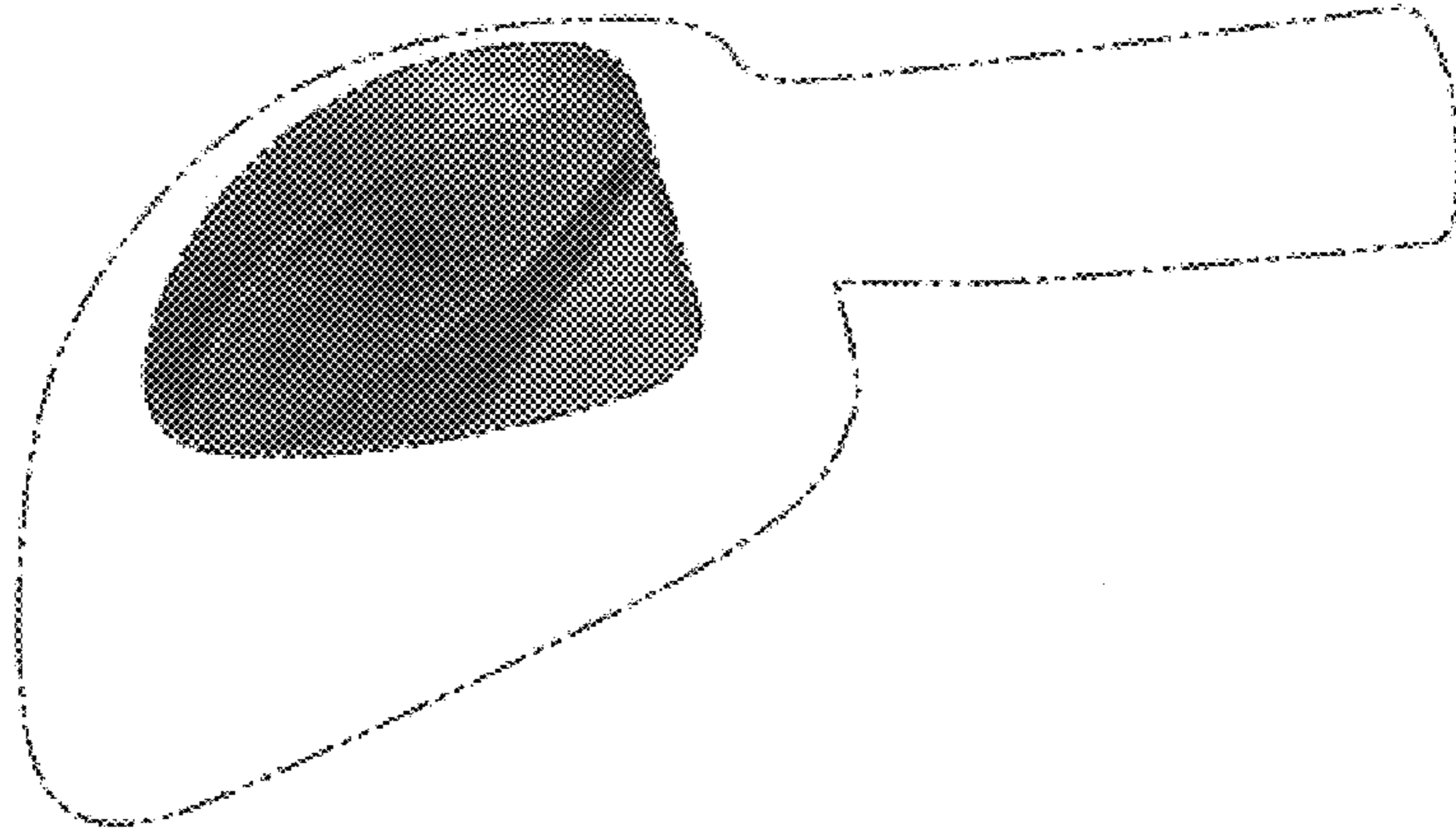

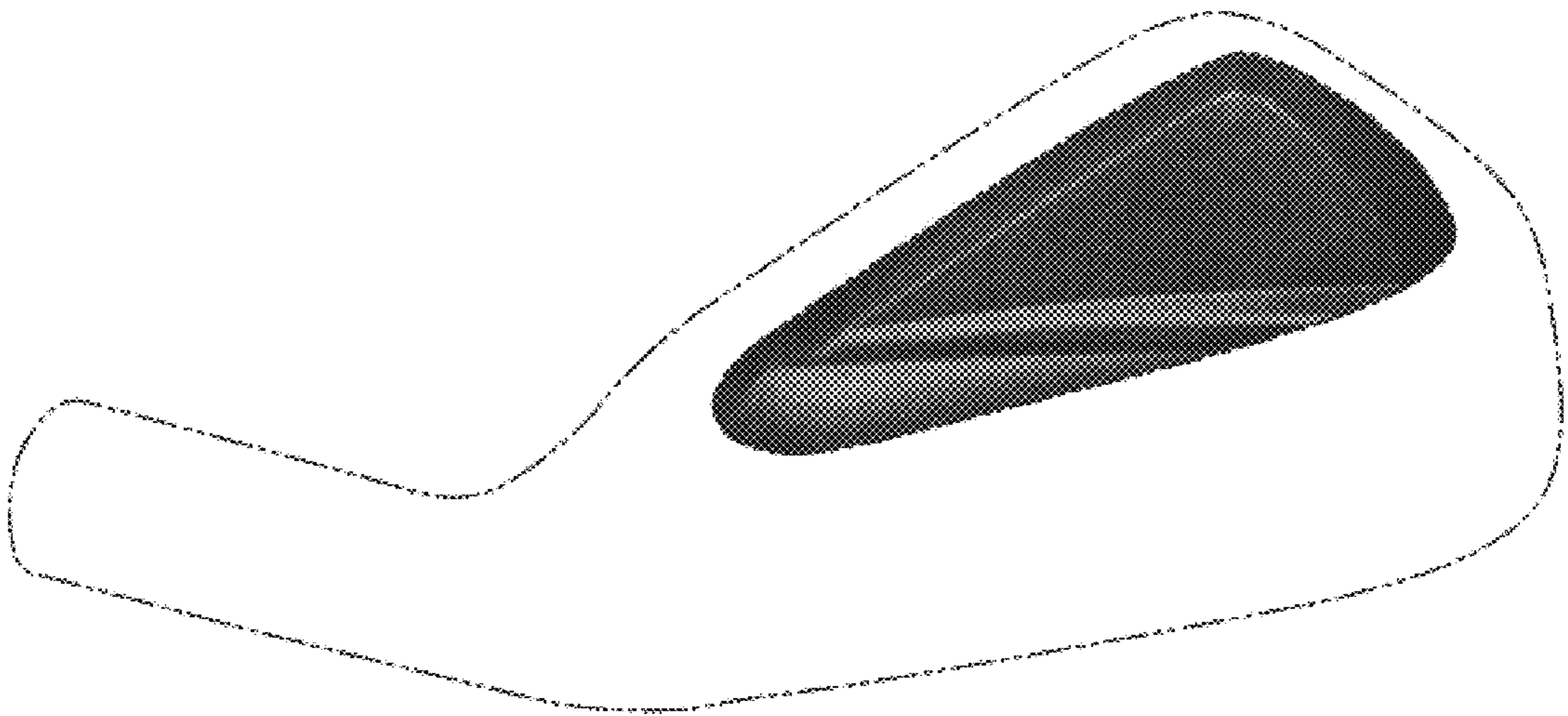

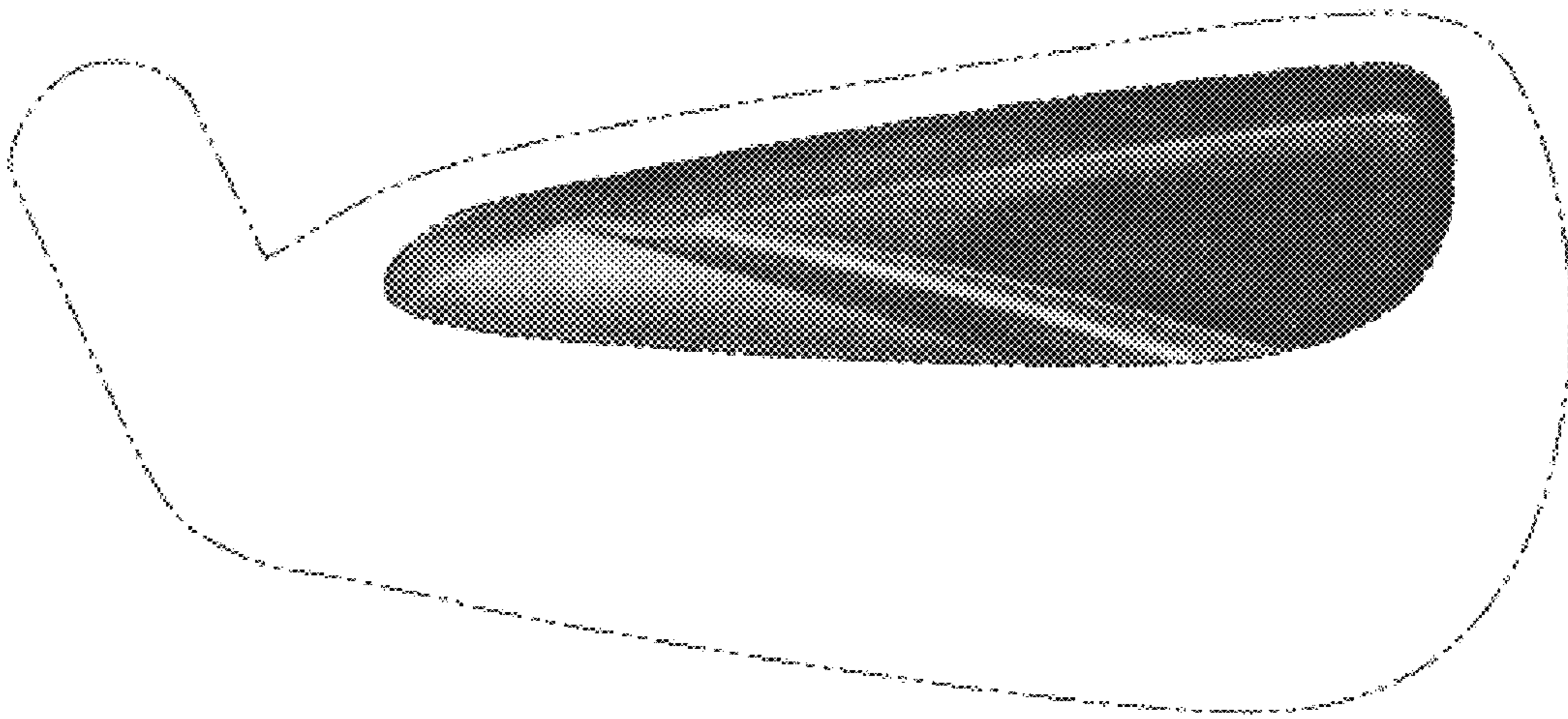
