I claim the ornamental design for equipment storage tray, as shown and described.

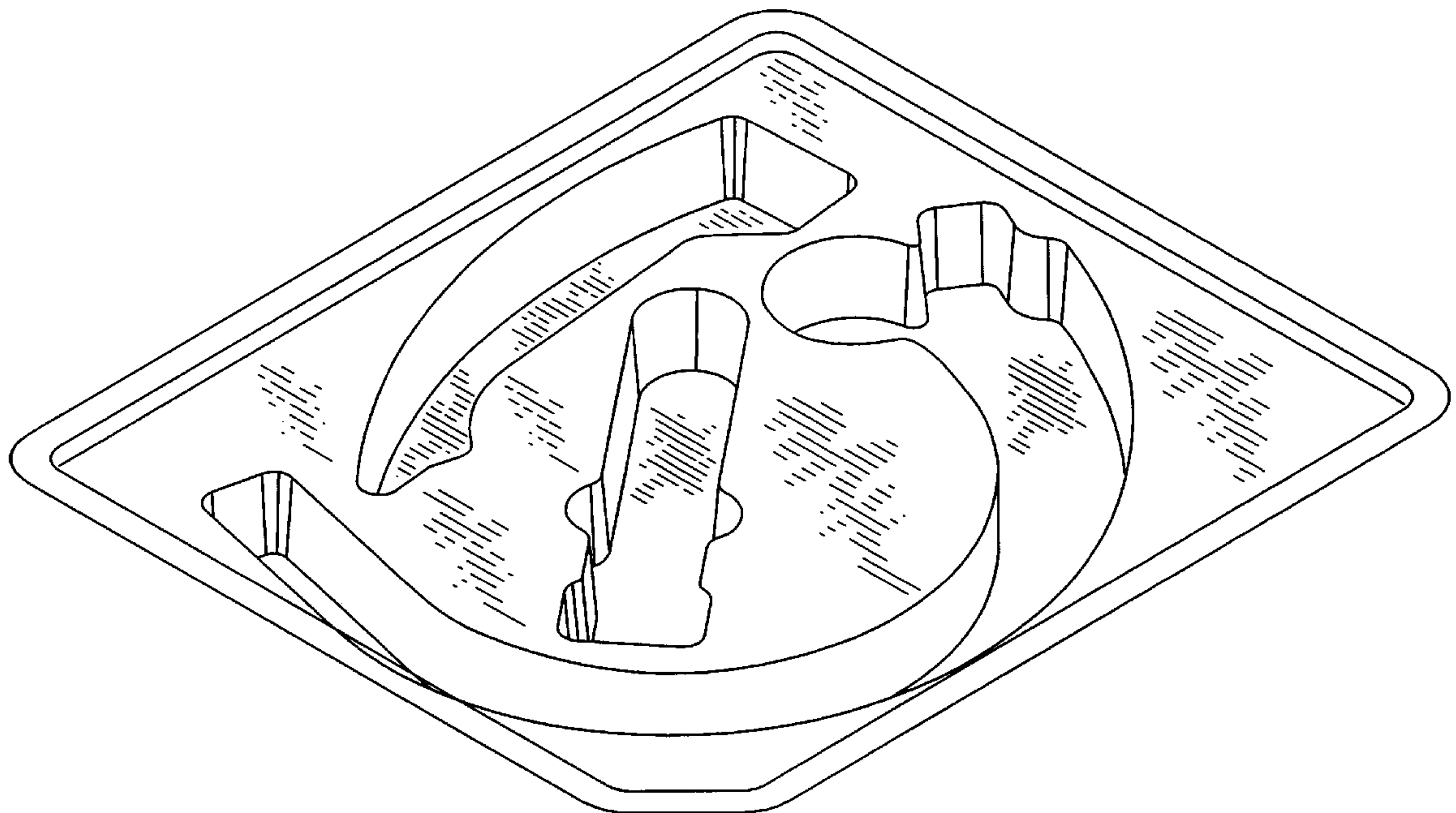

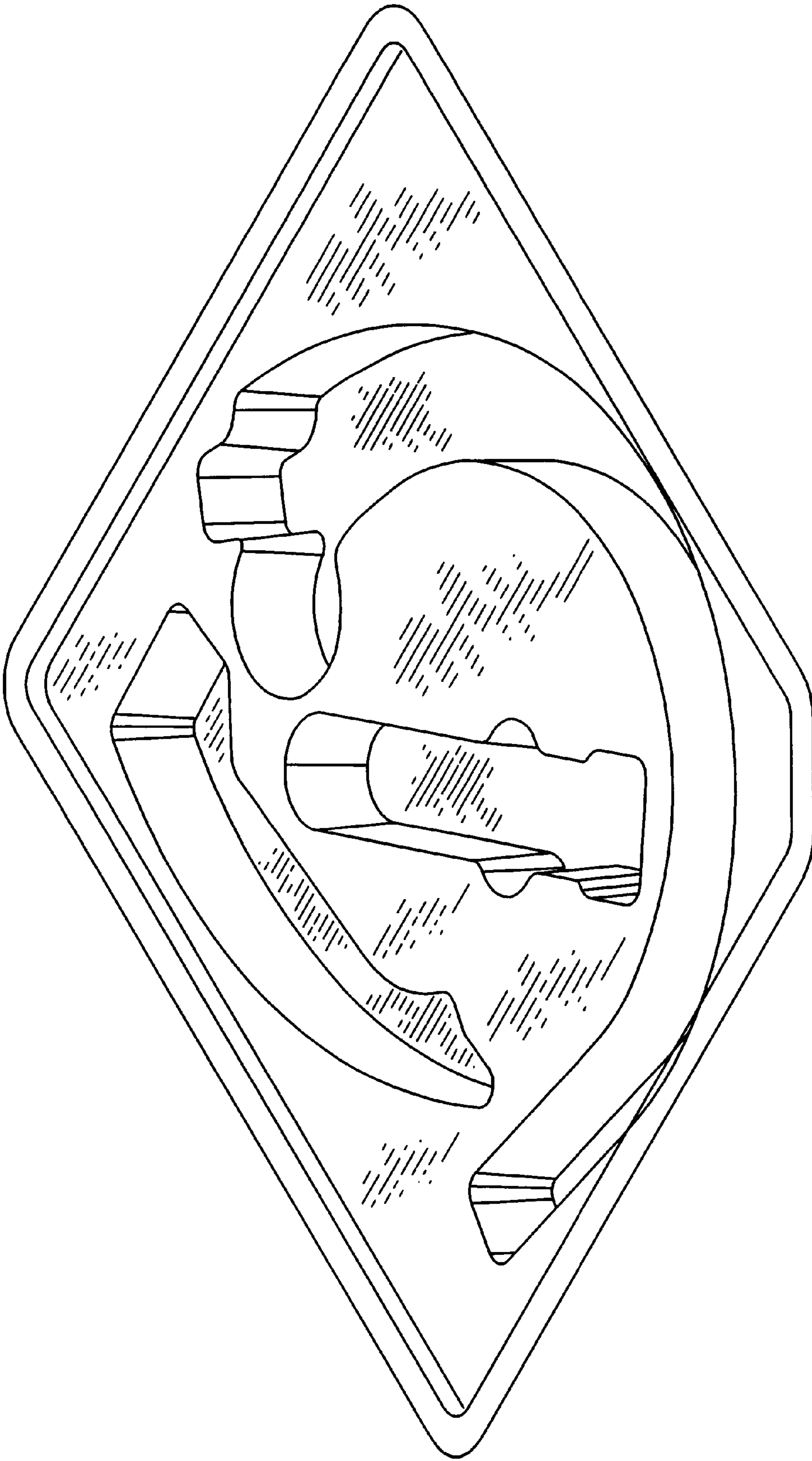

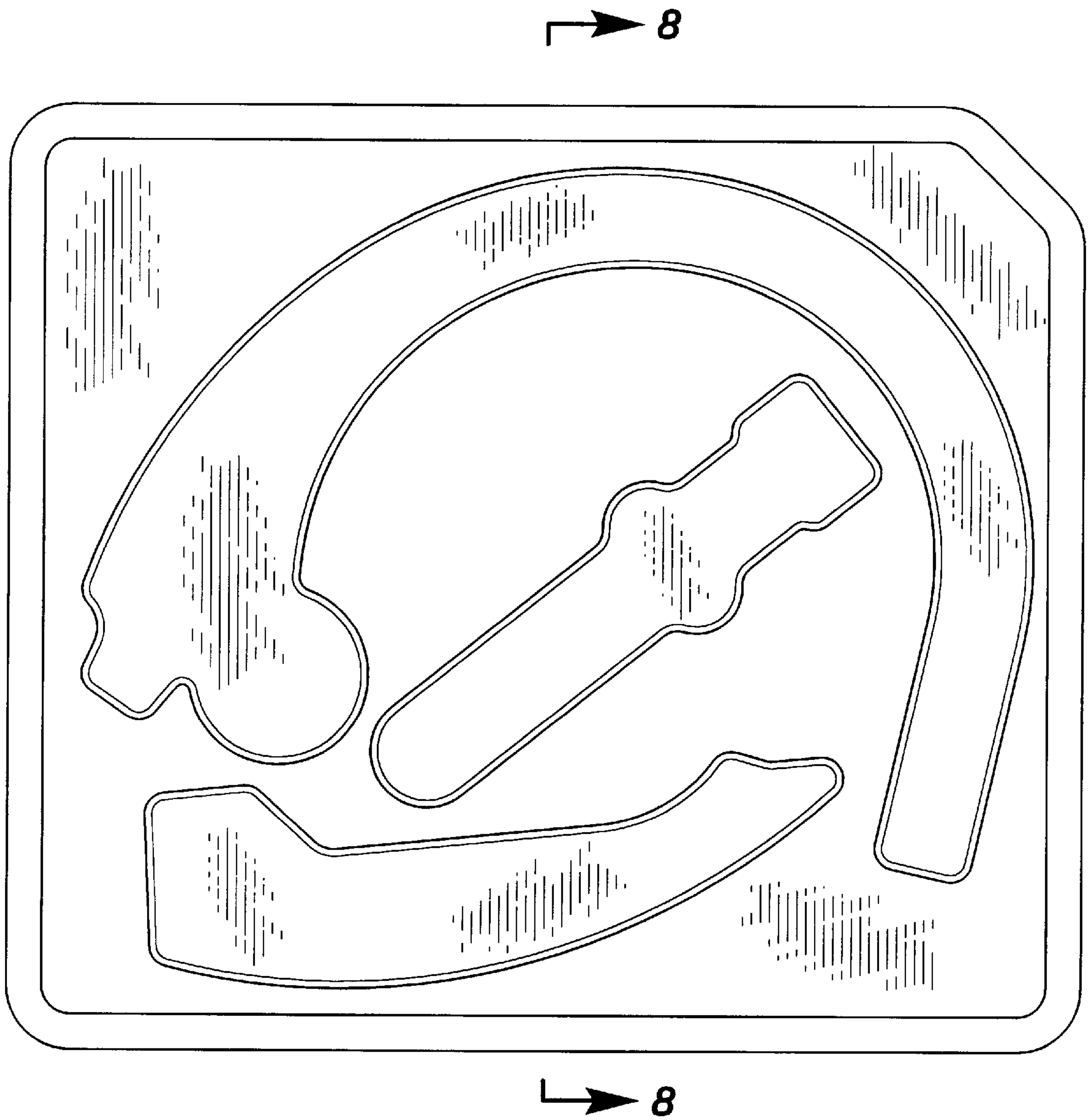

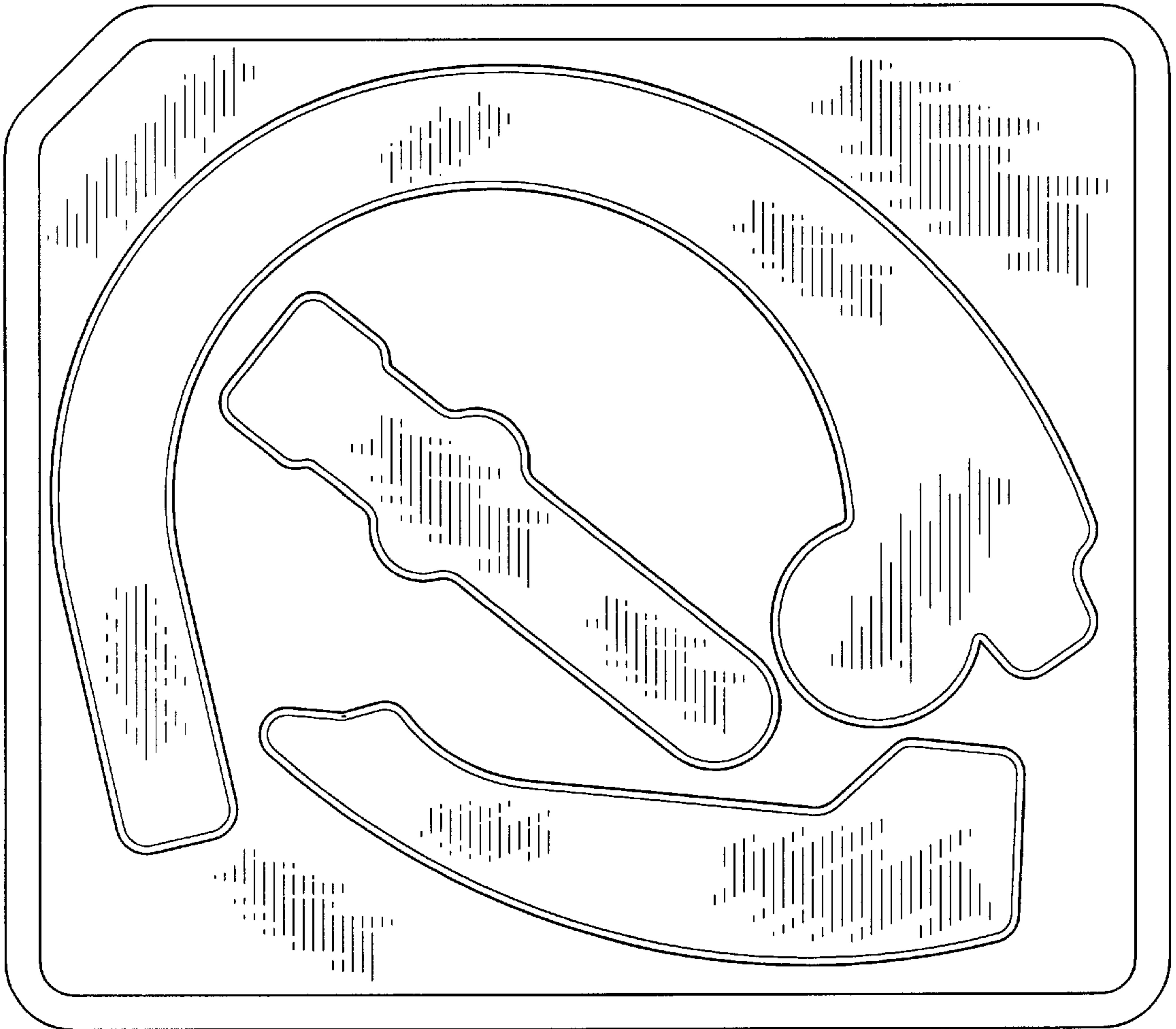

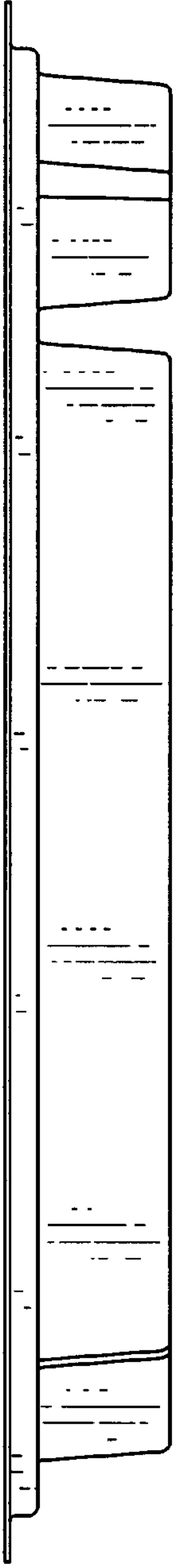

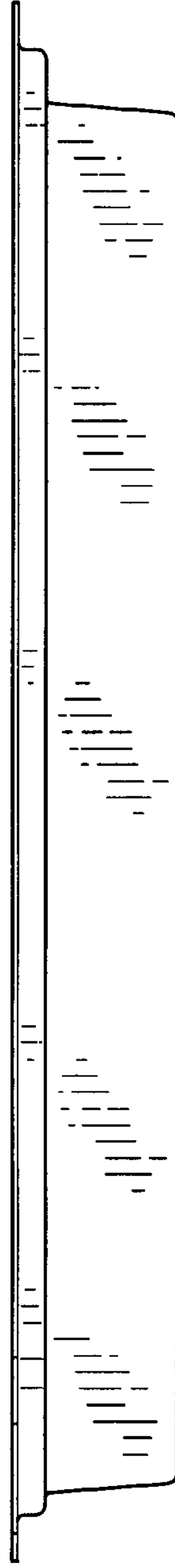

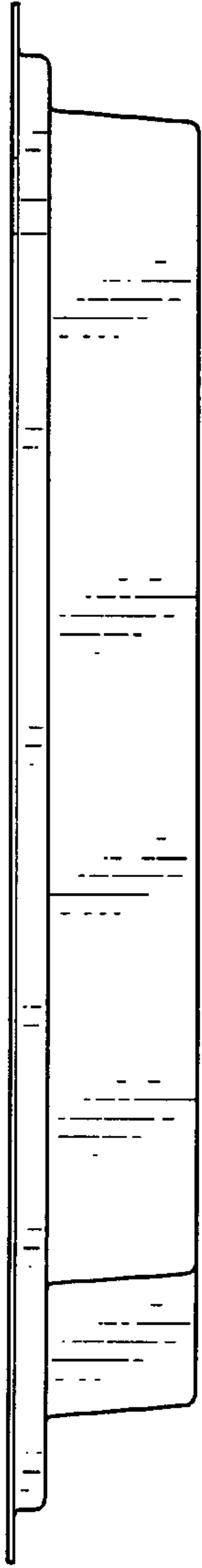

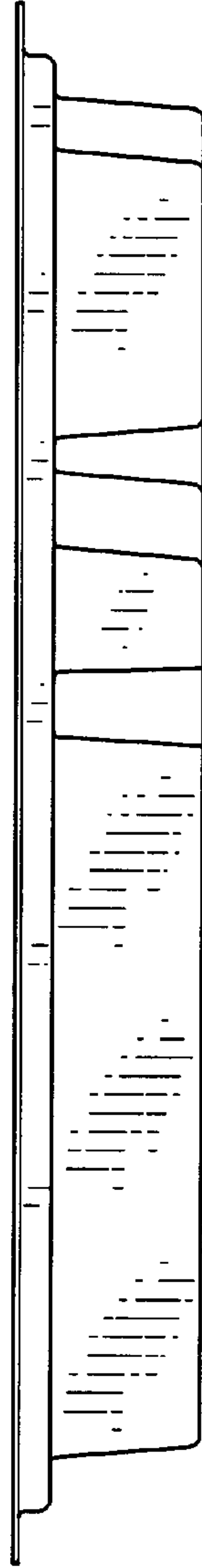

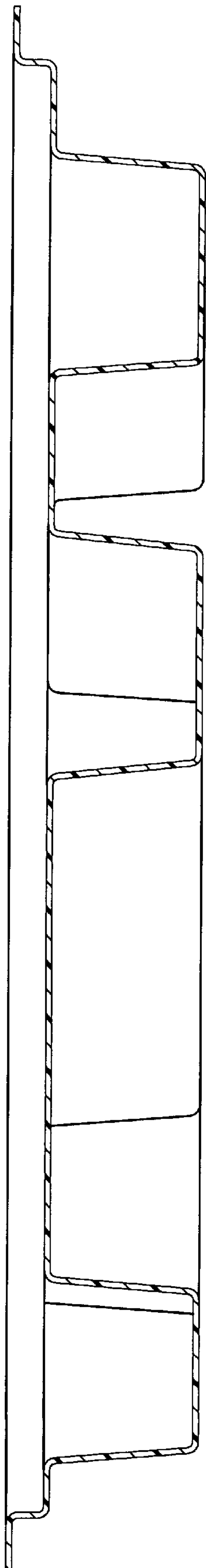
