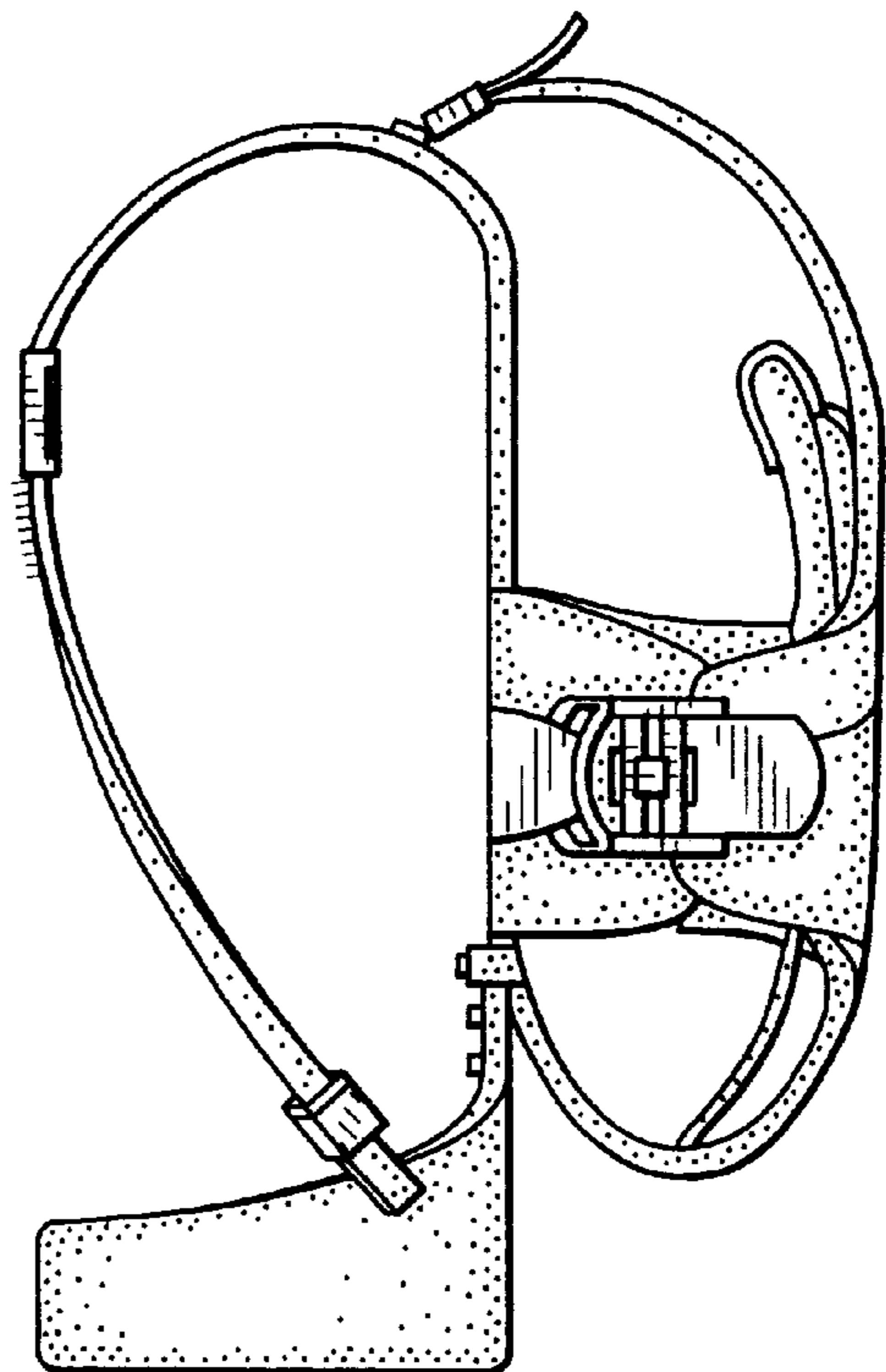
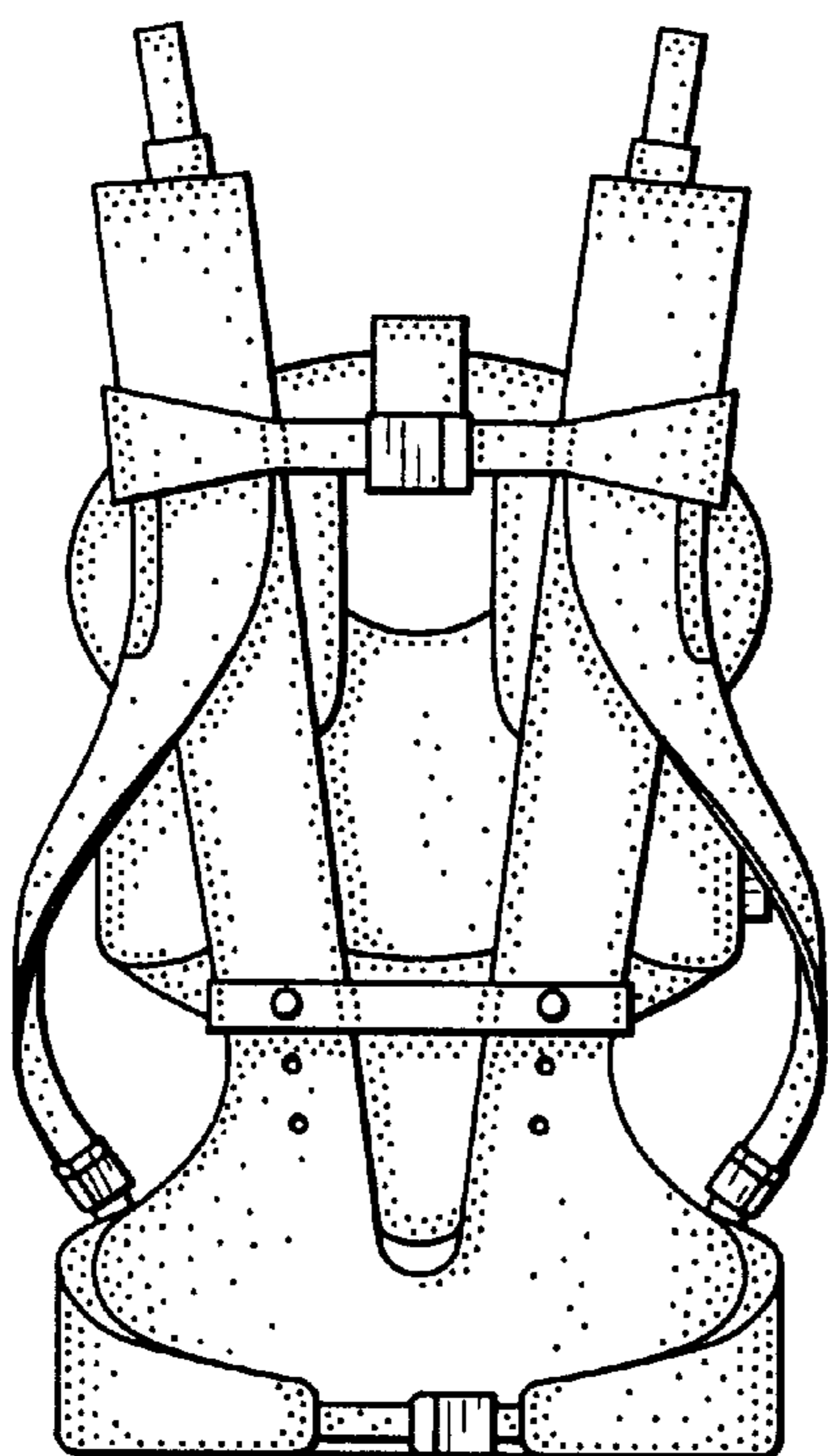
(57) **CLAIM**

The ornamental design for a side entry carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the side entry carrier showing our new design; FIG. 2 is a back elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is top plan view thereof; and, FIG. 6 is a bottom view thereof.

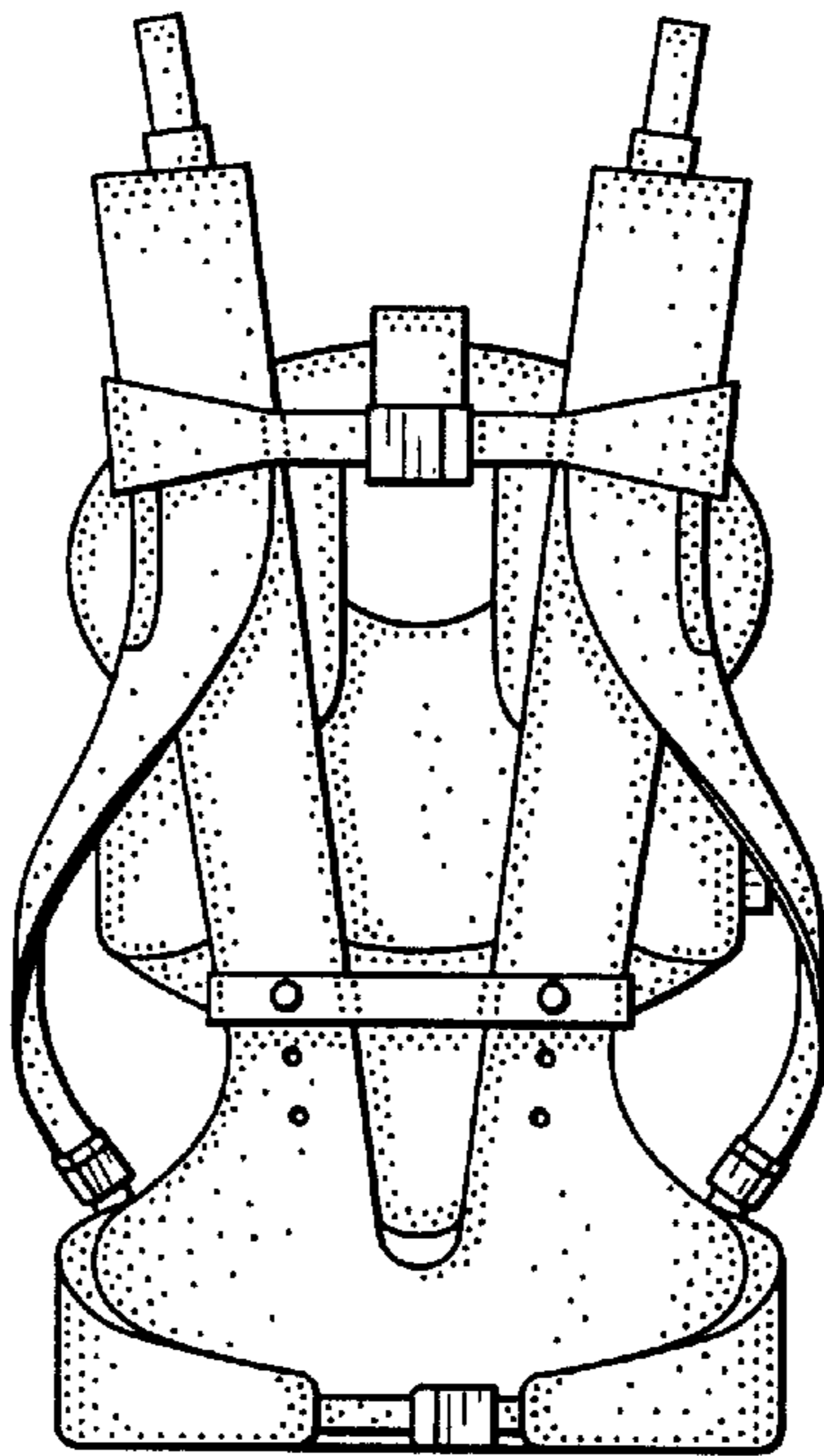

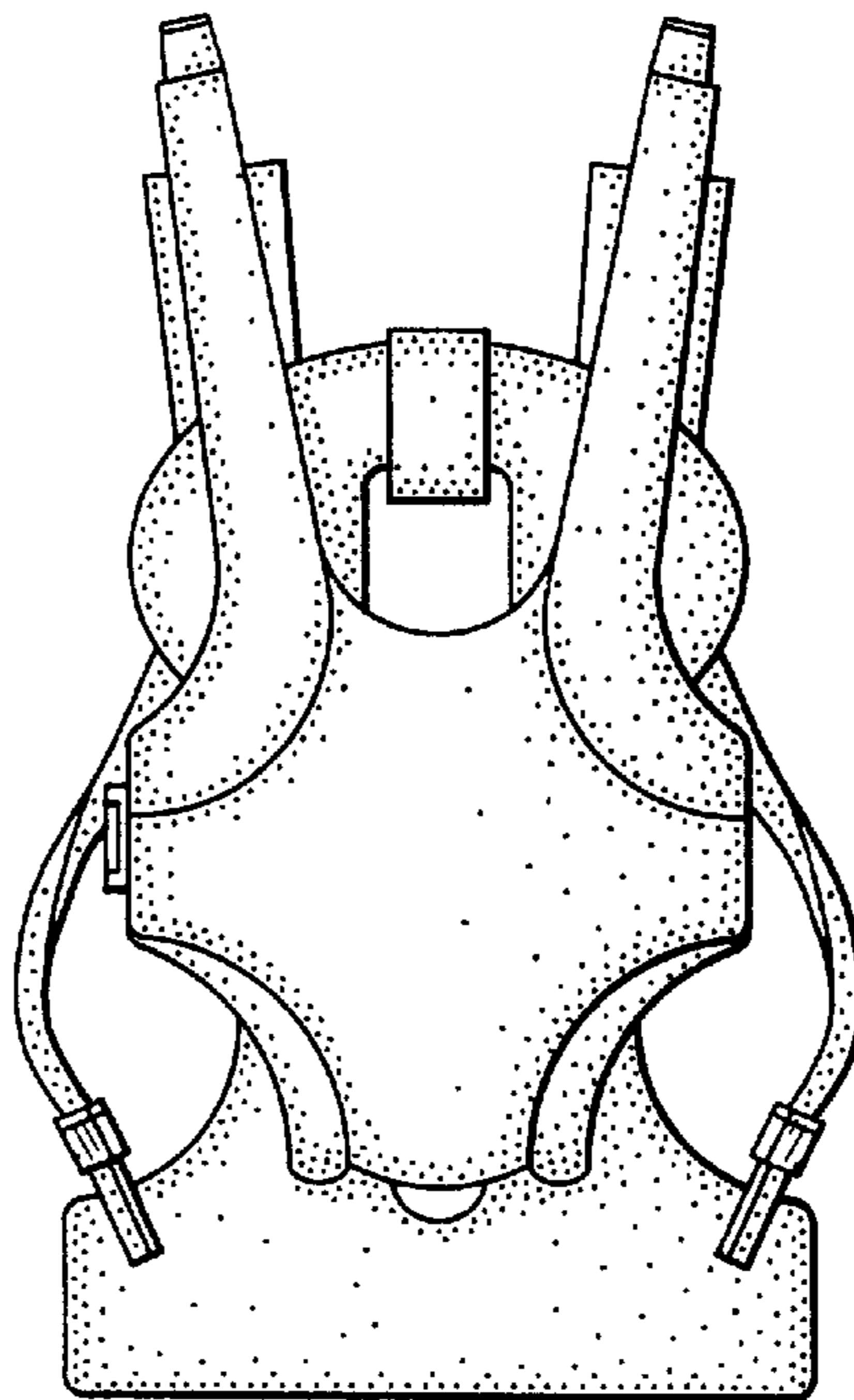

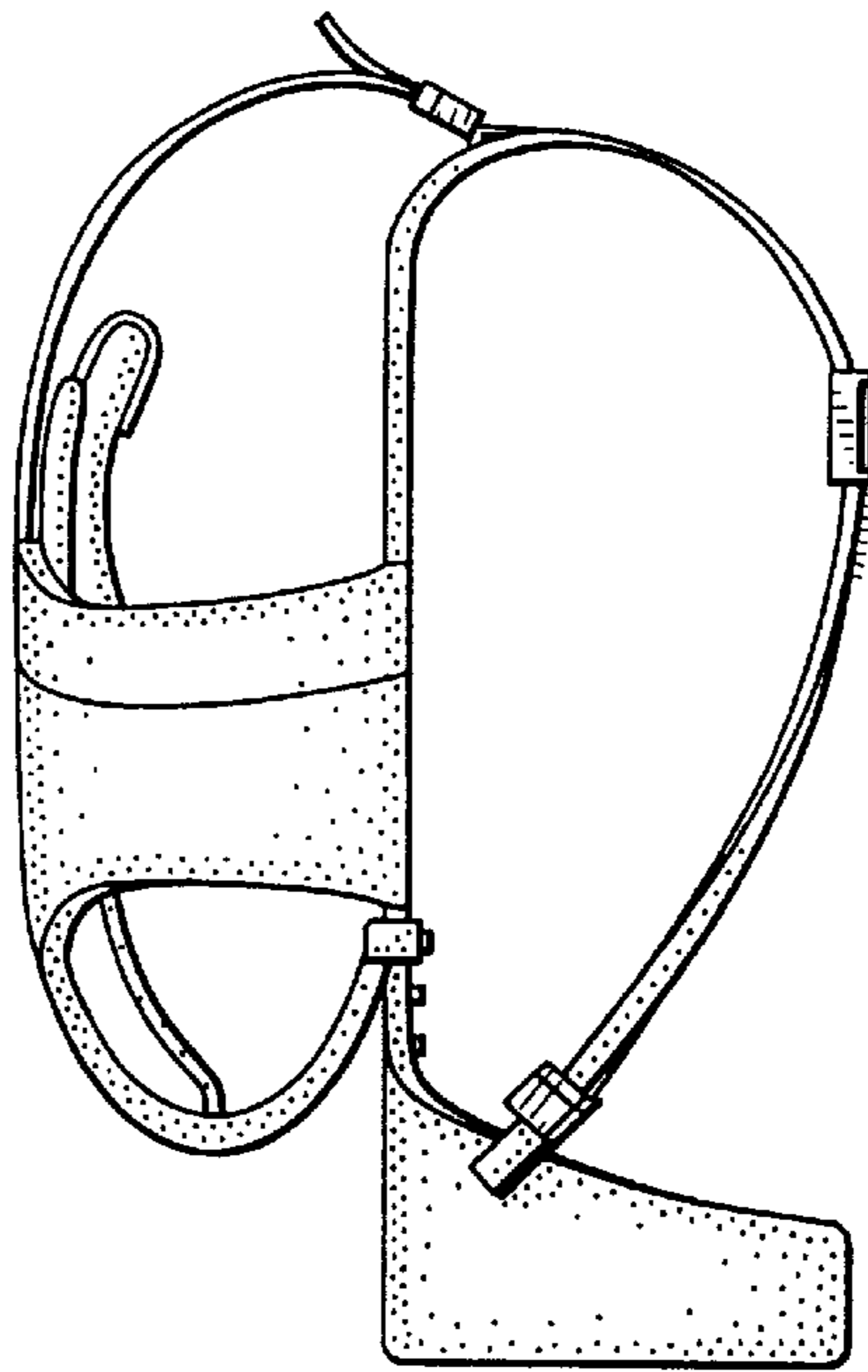

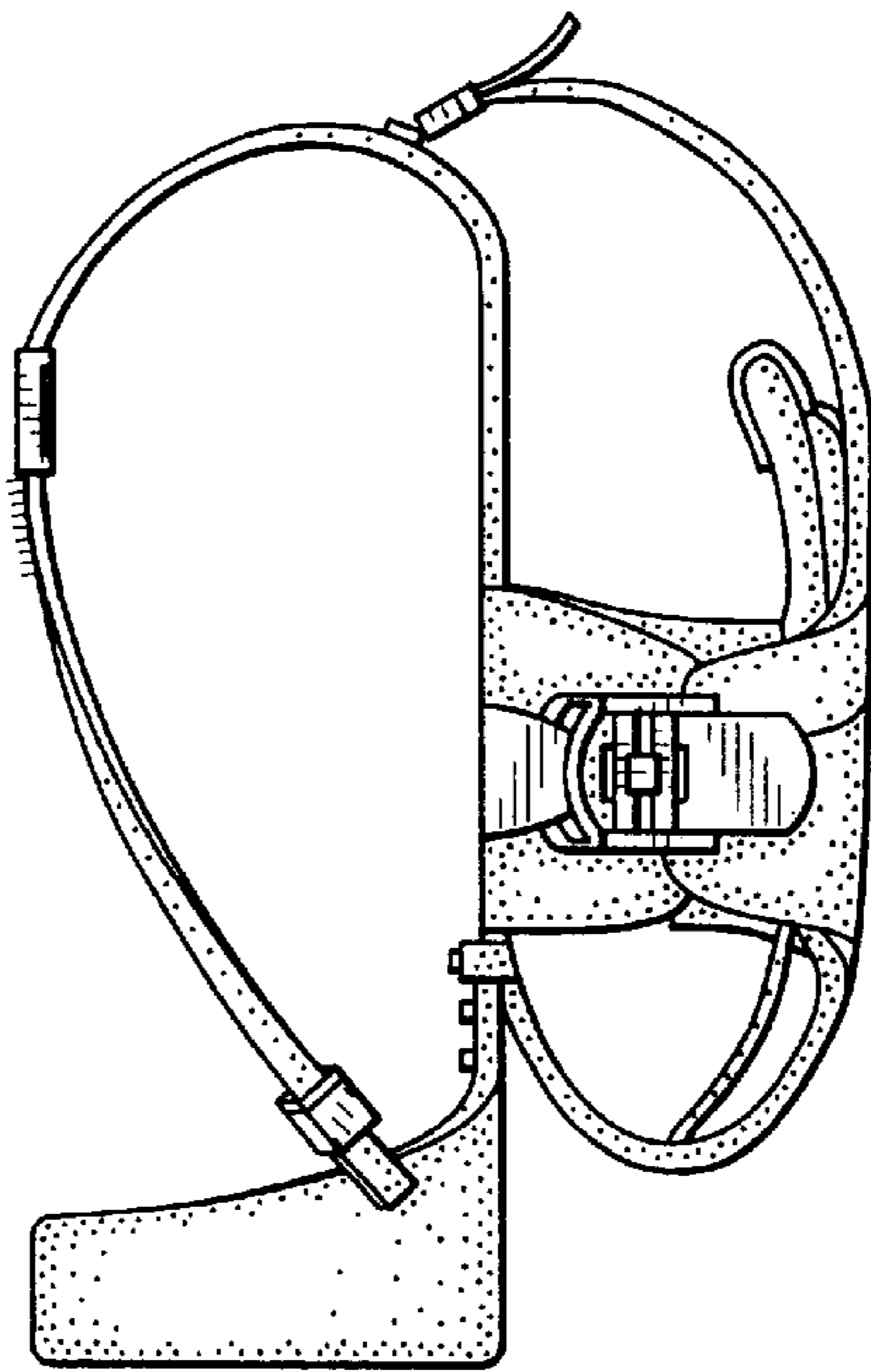

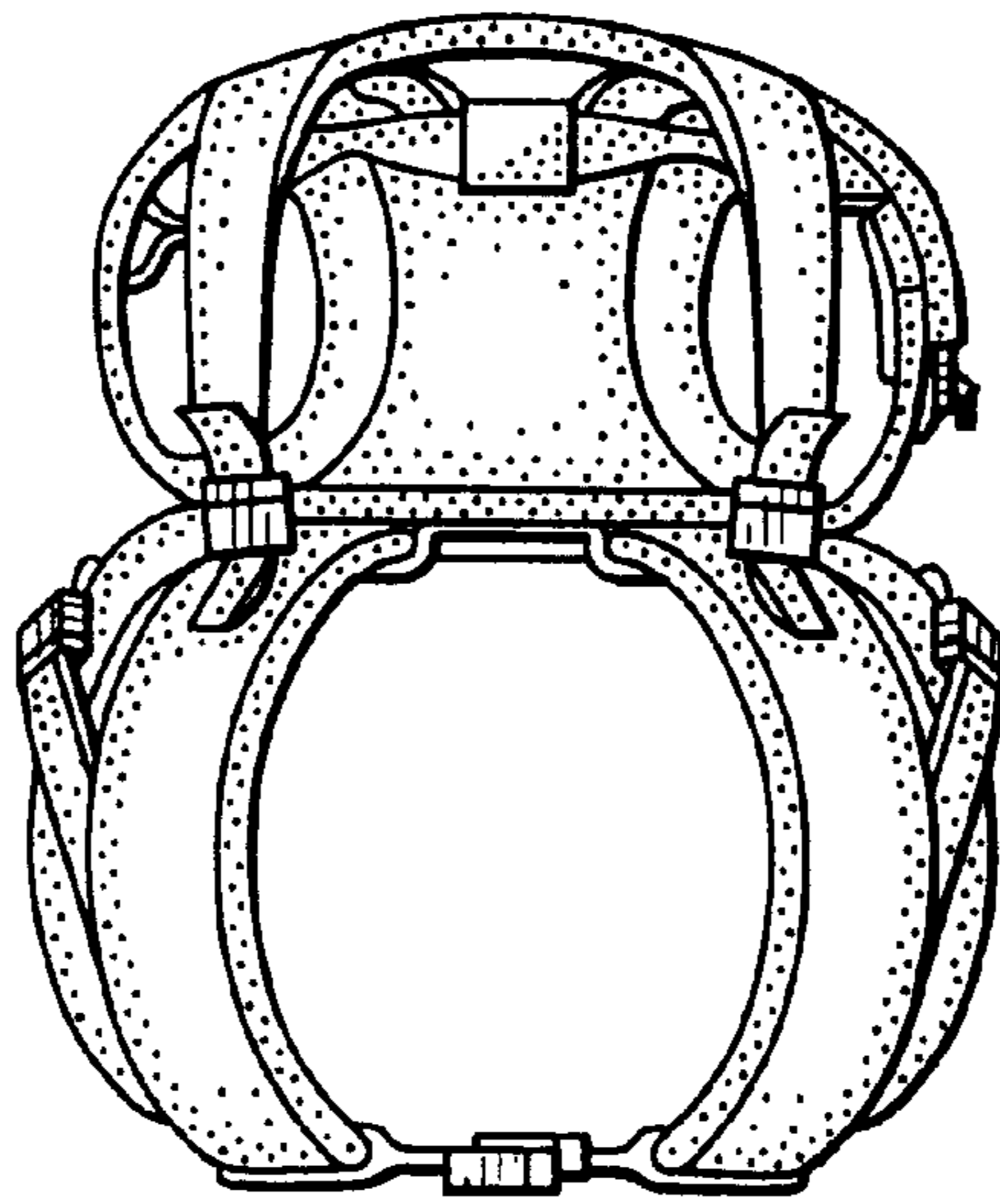

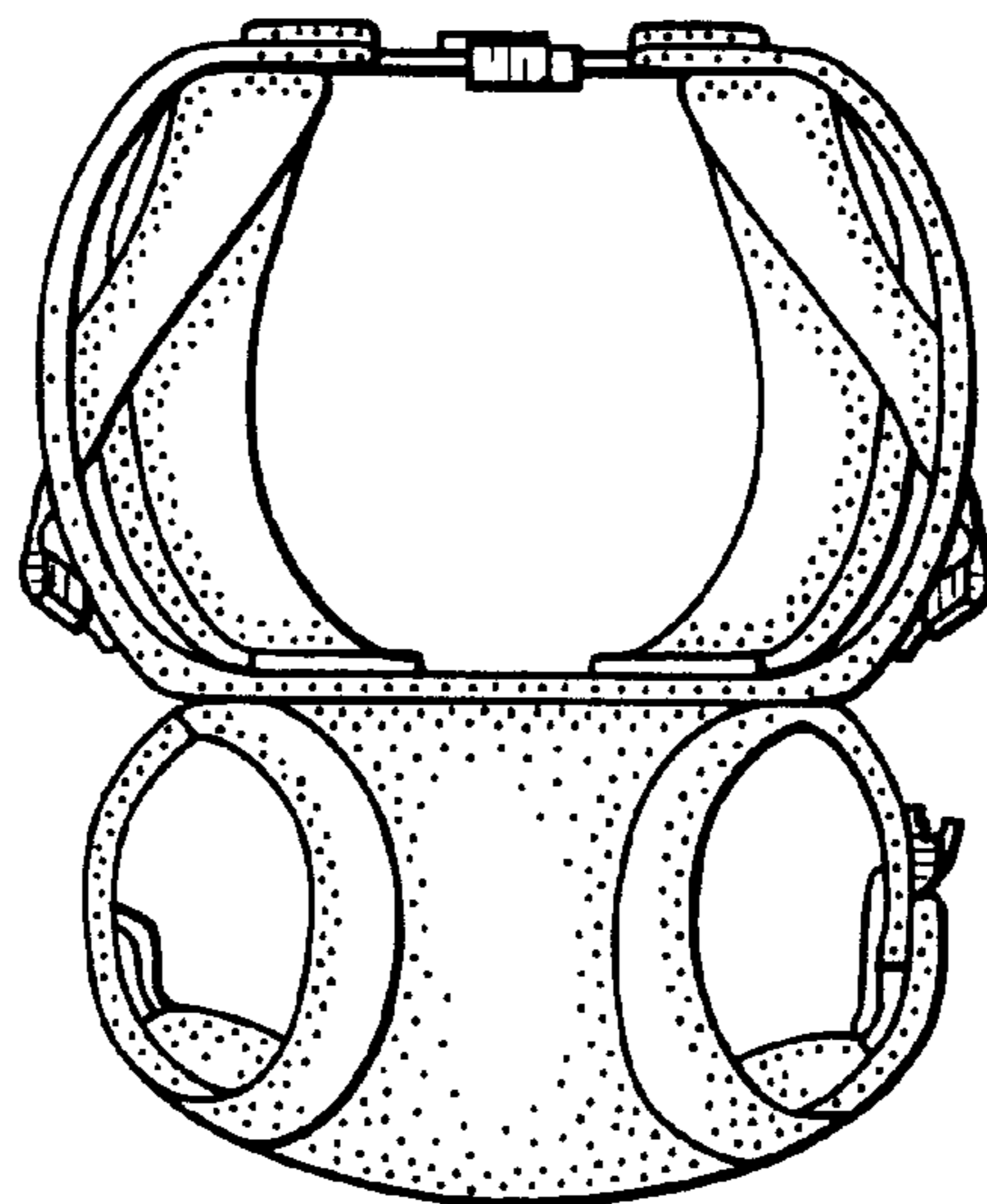
