DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a shelf showing my new design;

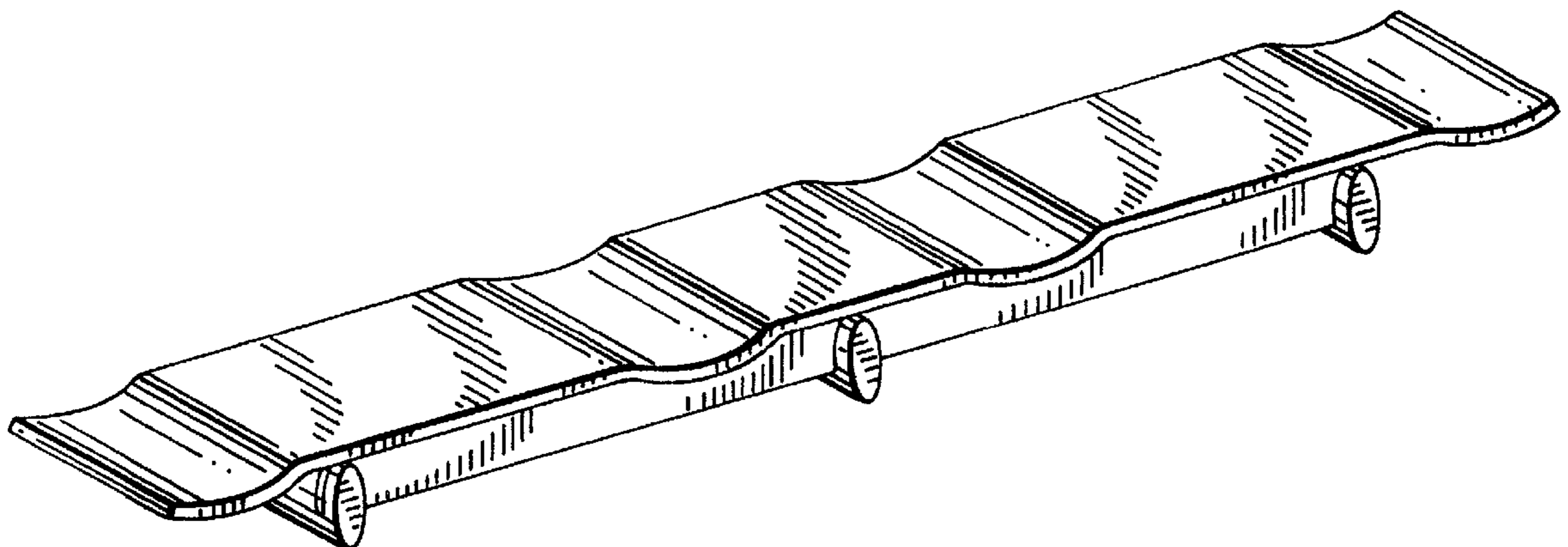
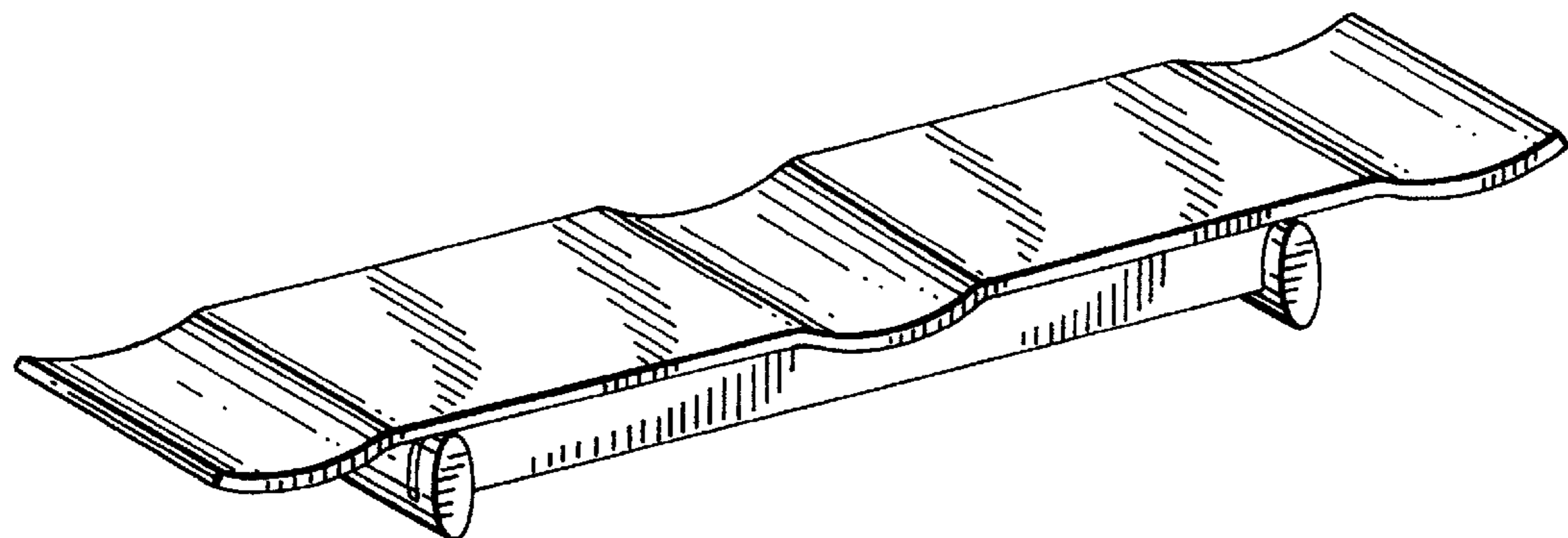

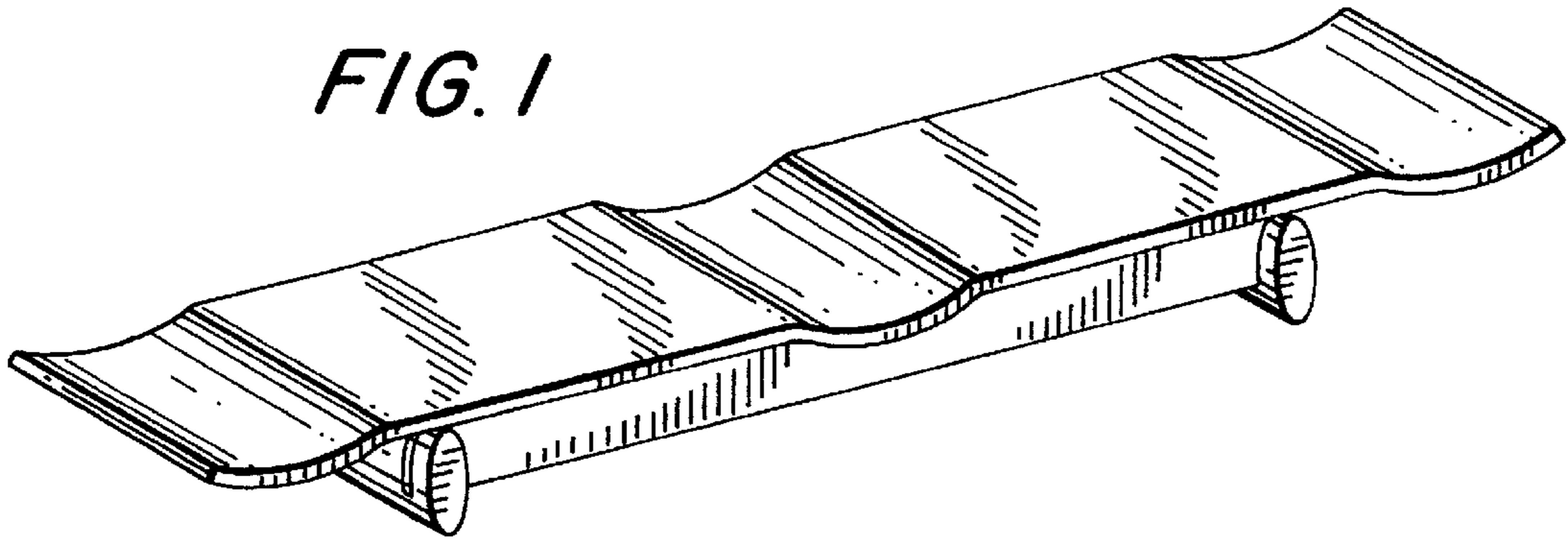

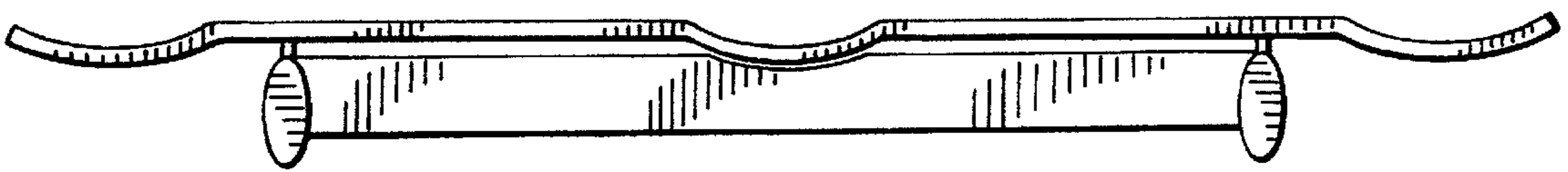

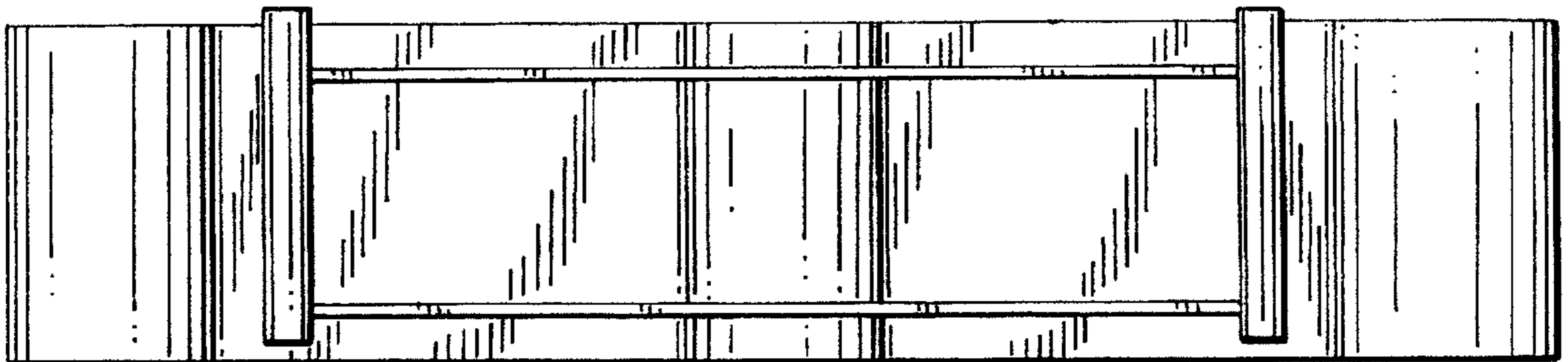

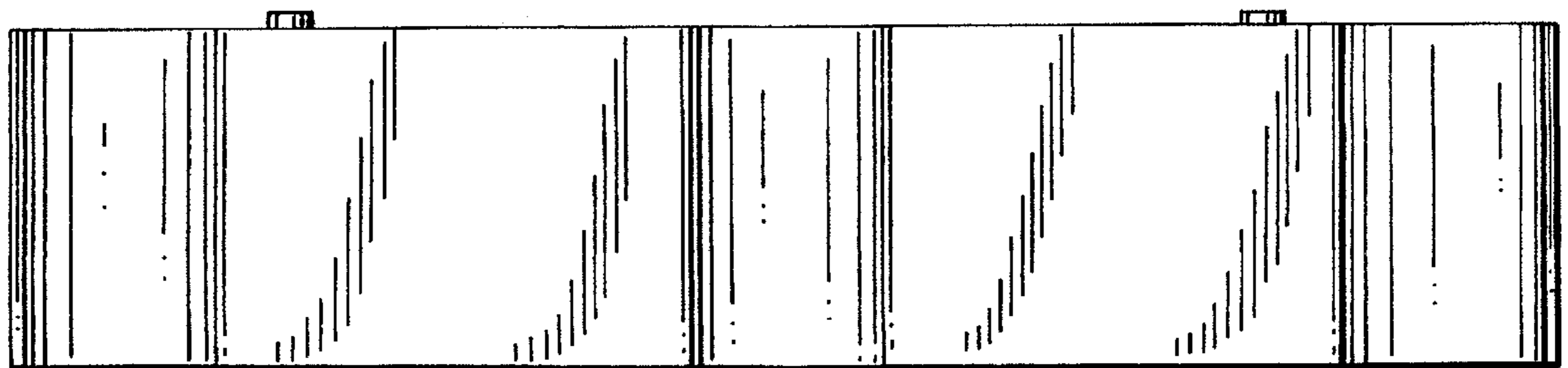

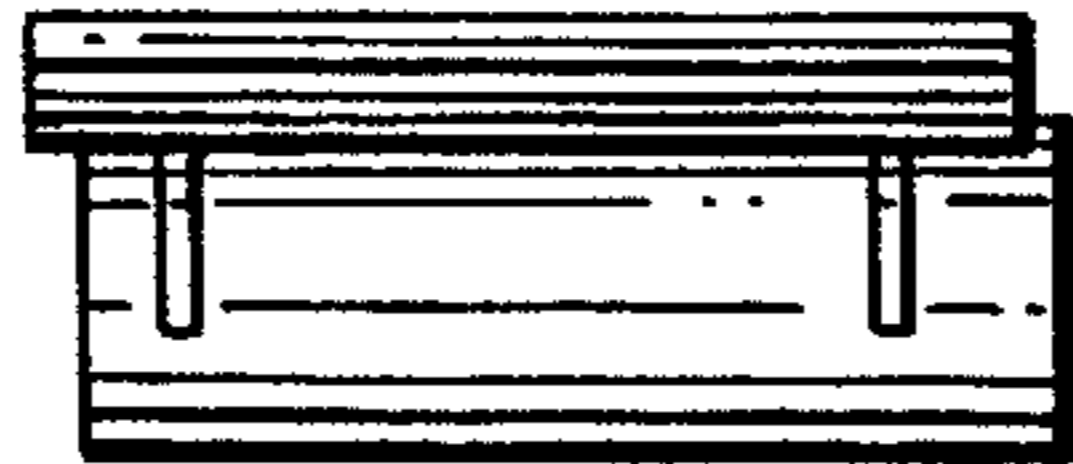

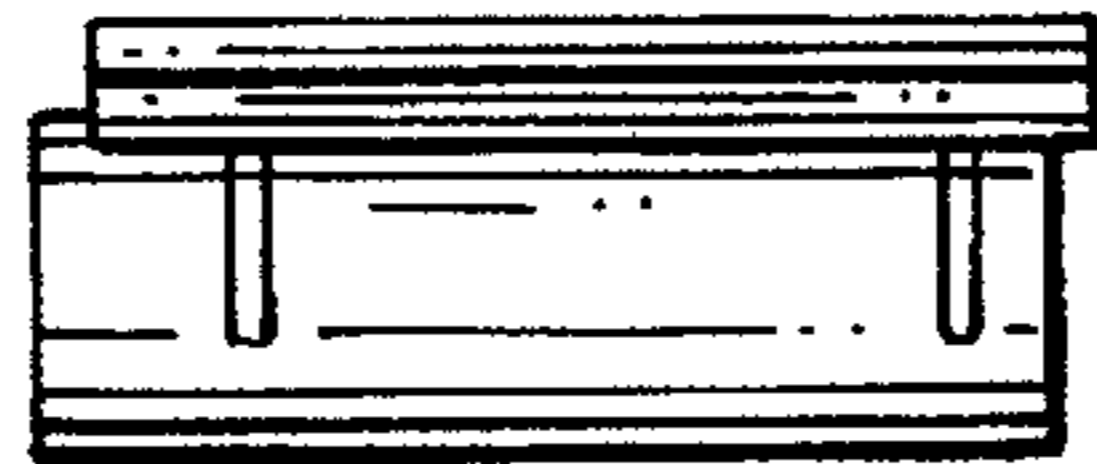
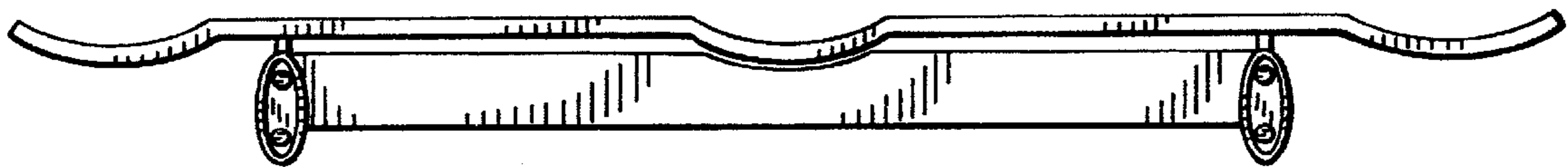

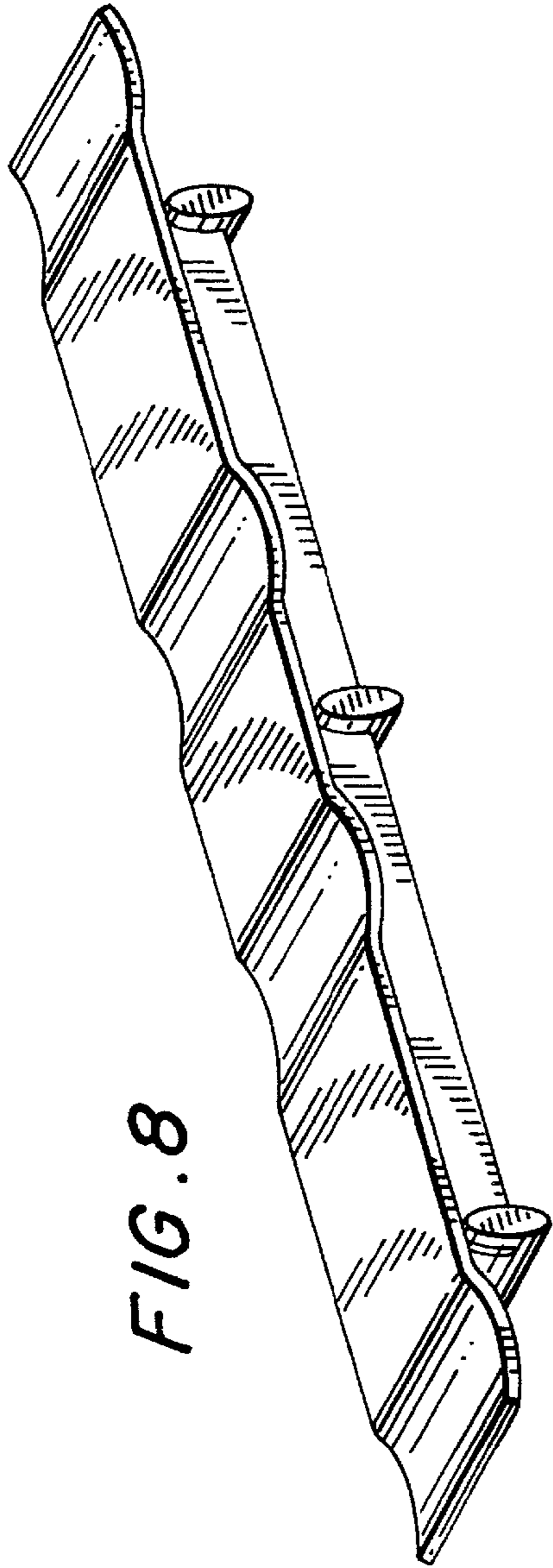

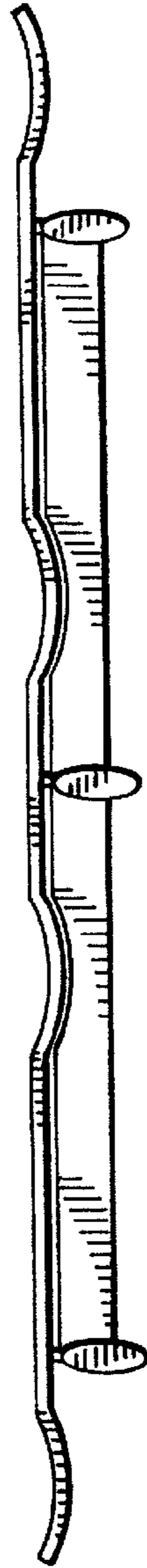
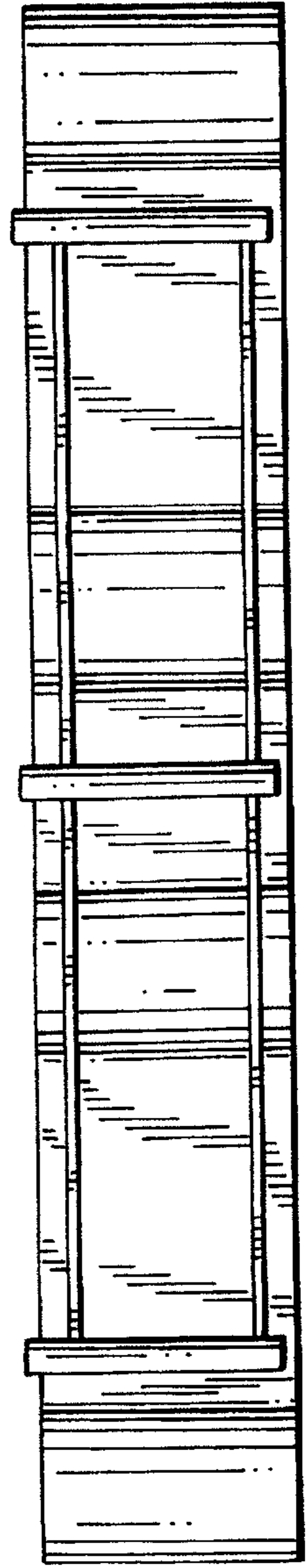

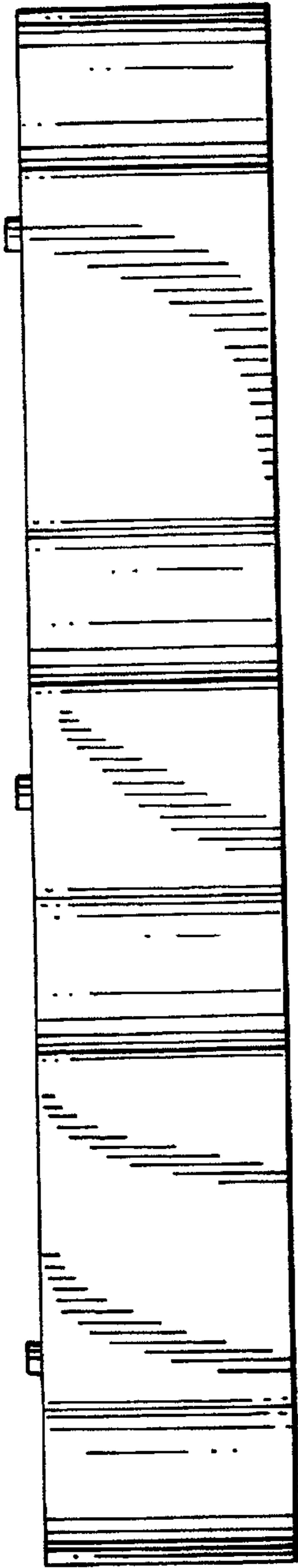
