**DESCRIPTION**

FIG. 1 is a perspective view of utensil handle showing my new design;

FIG. 2 is a front elevational view of utensil handle of FIG. 1;

FIG. 3 is a rear elevational view of utensil handle of FIG. 1;

FIG. 4 is a left side view of utensil handle of FIG. 1;

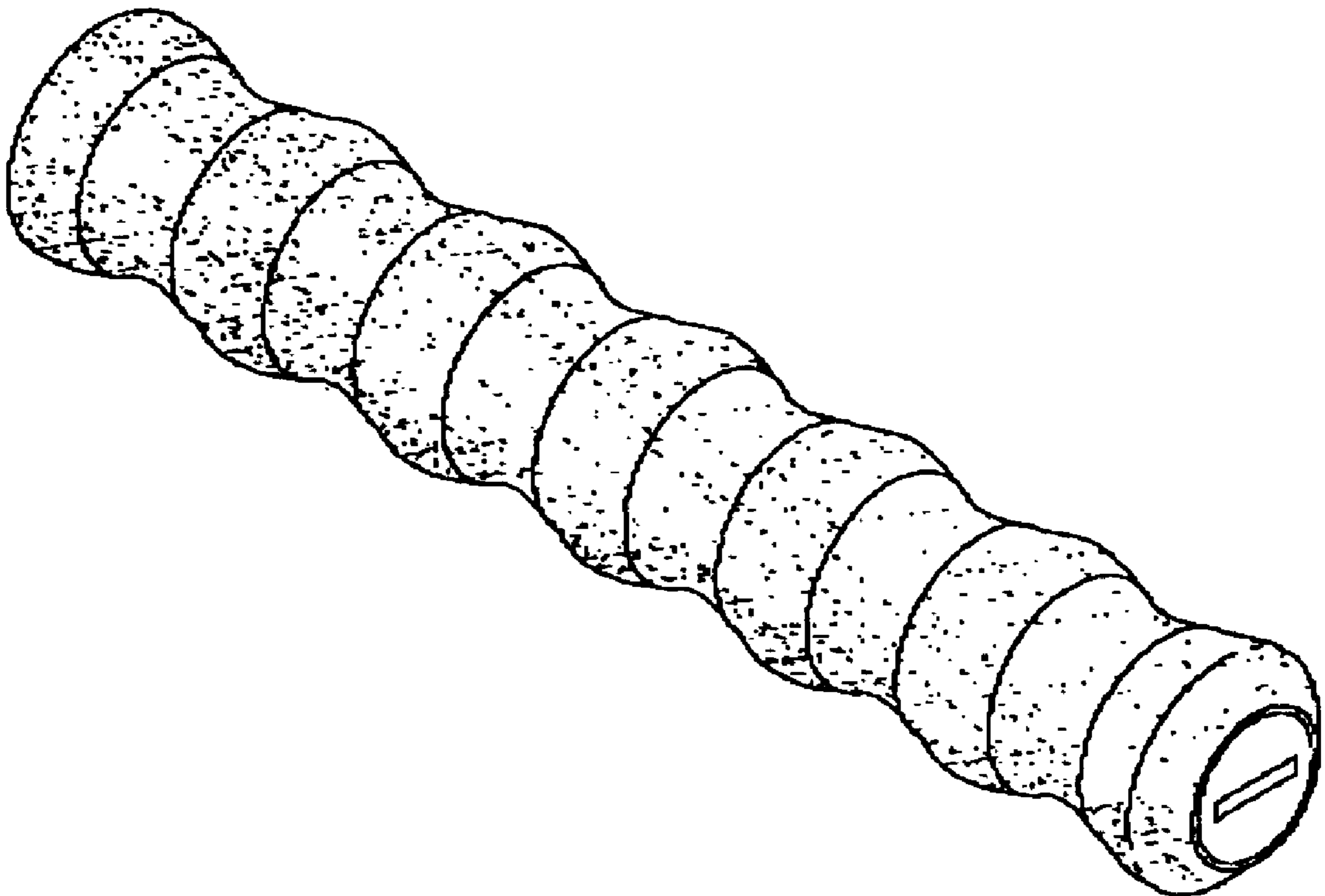
FIG. 5 is a right side view of utensil handle of FIG. 1;

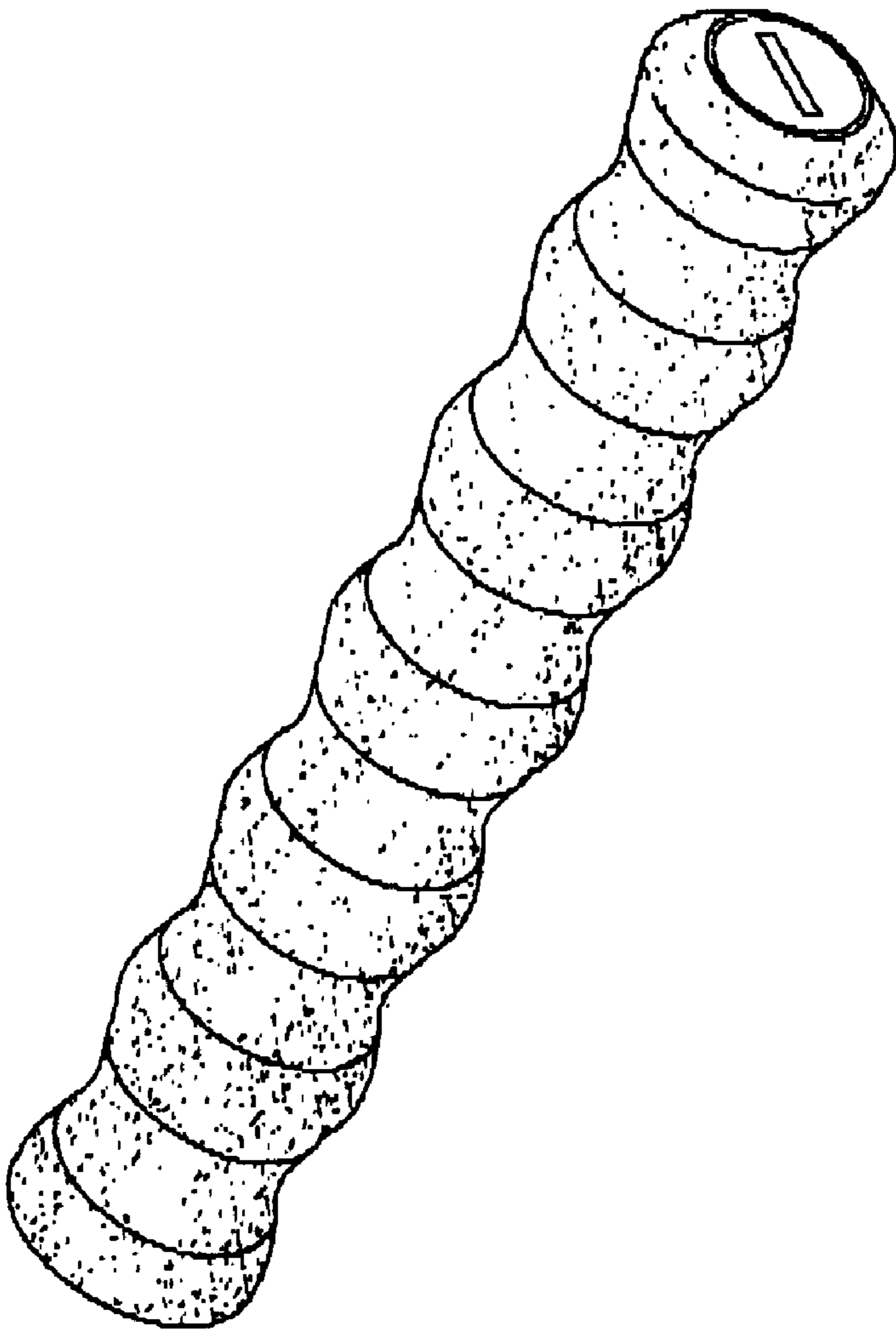

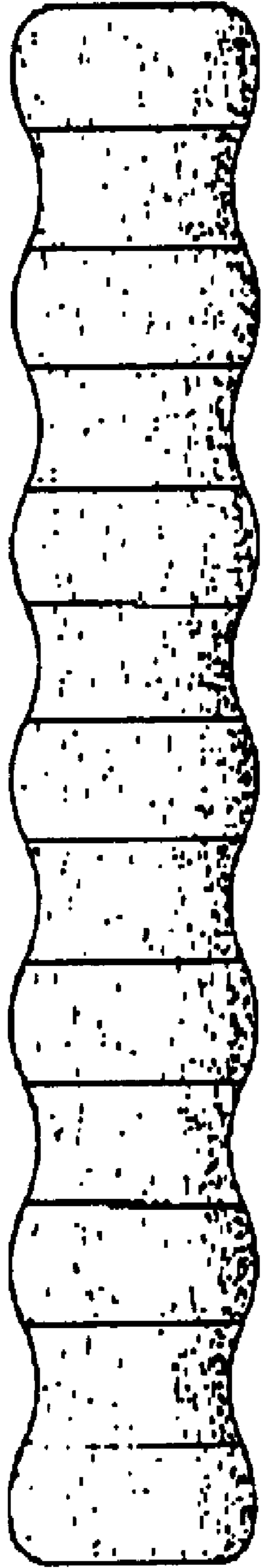

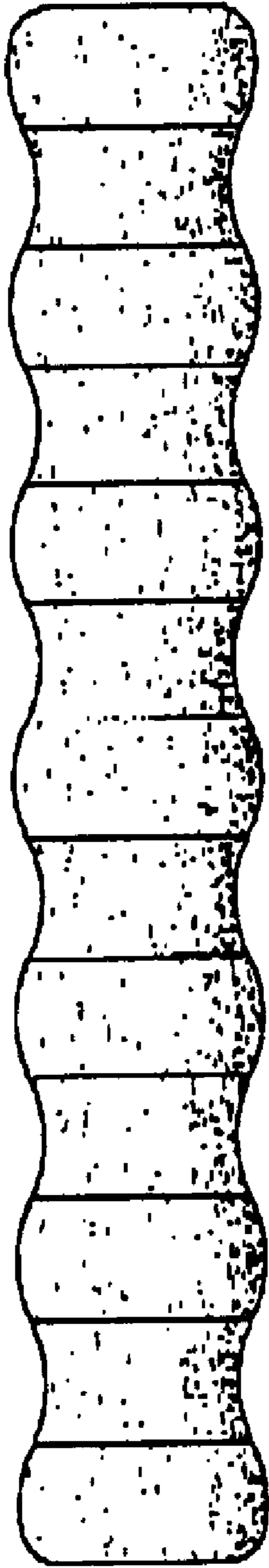

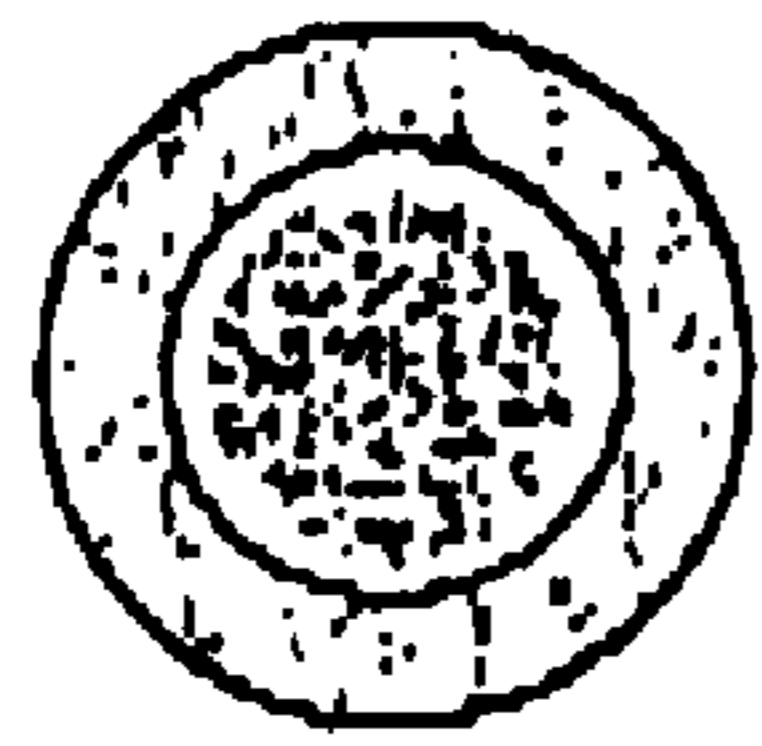
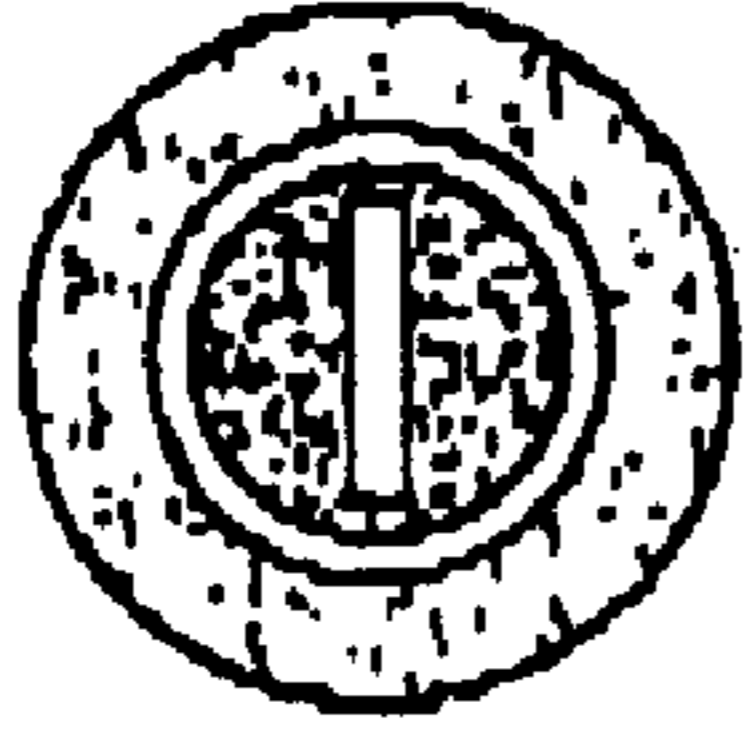

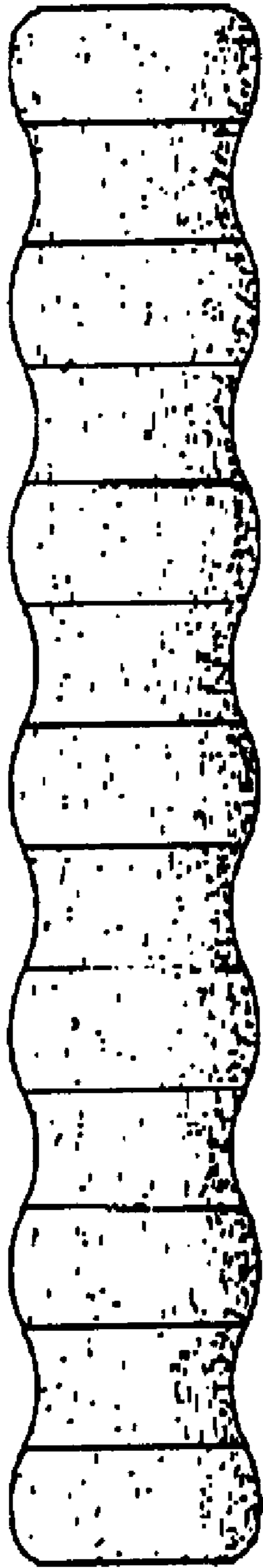

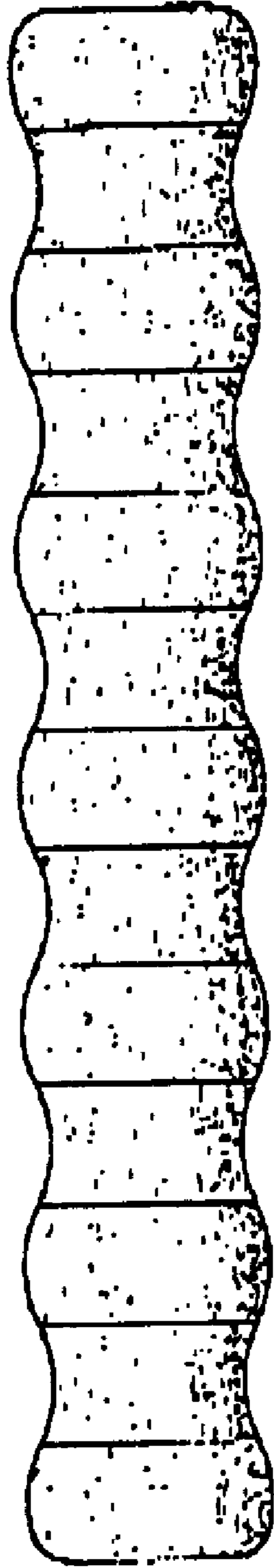

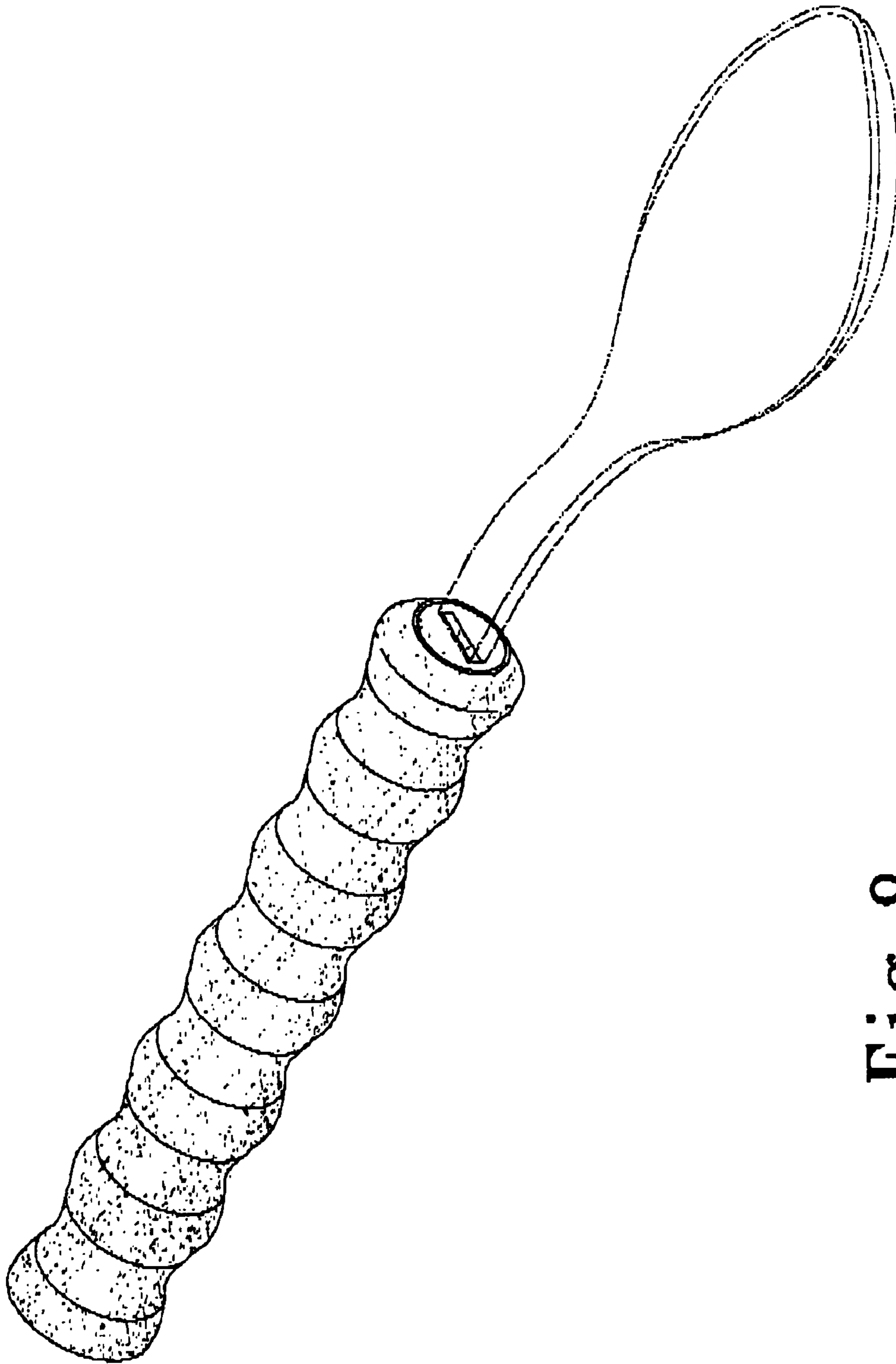
