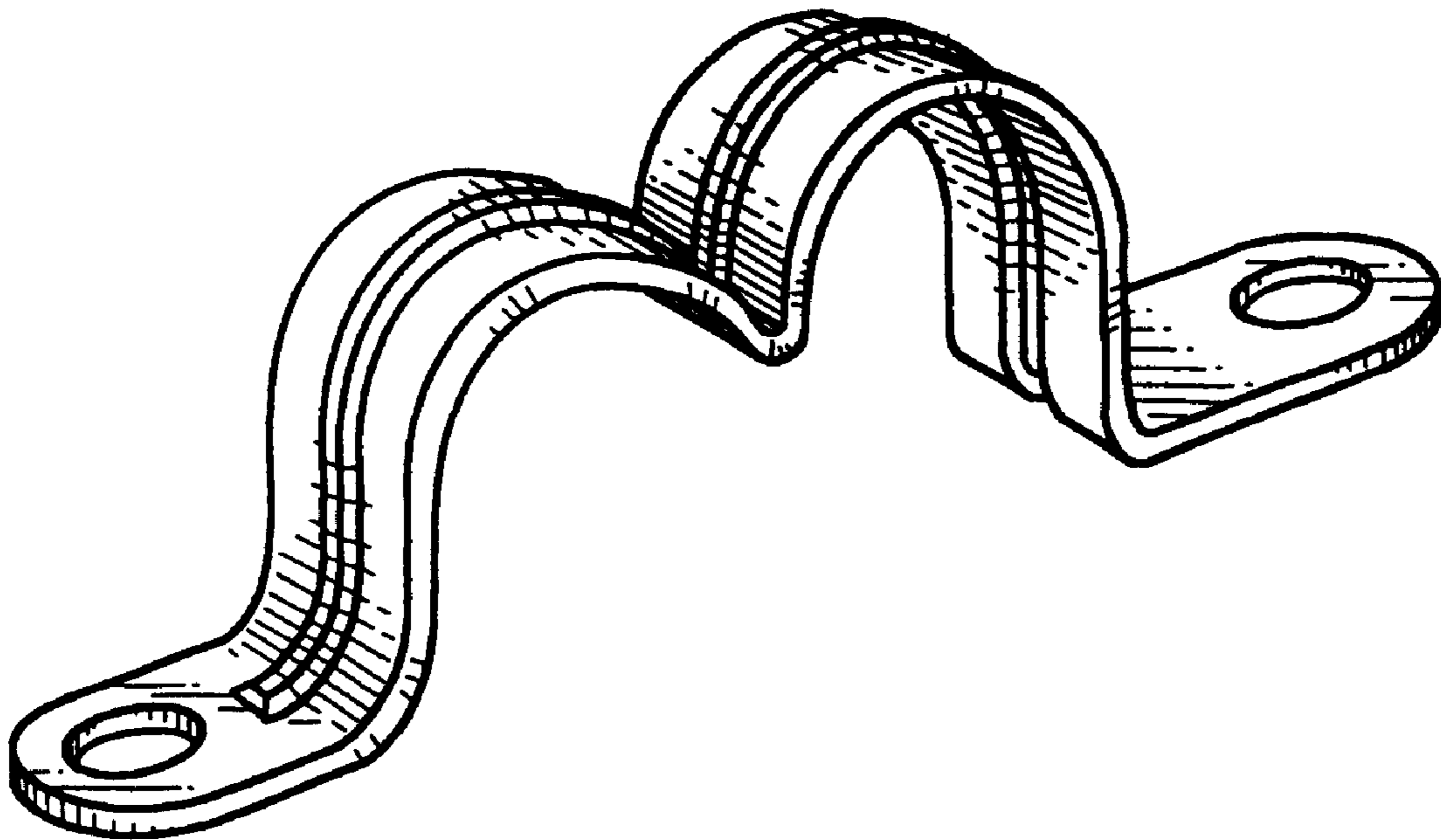
FIG. 6 is a rear elevational view of the electrical and aluminum tubing clamp shown in FIG. 1; and,

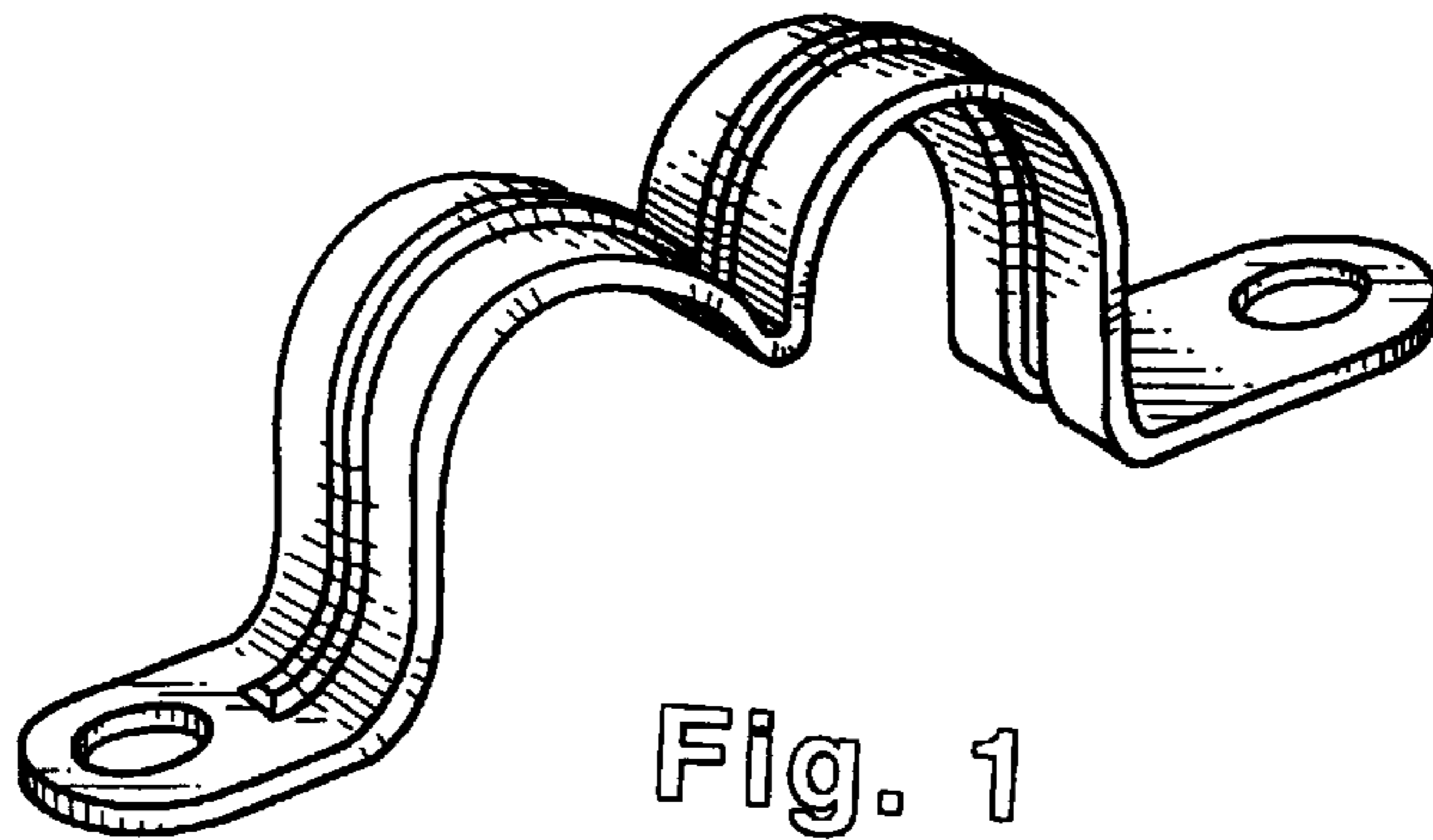

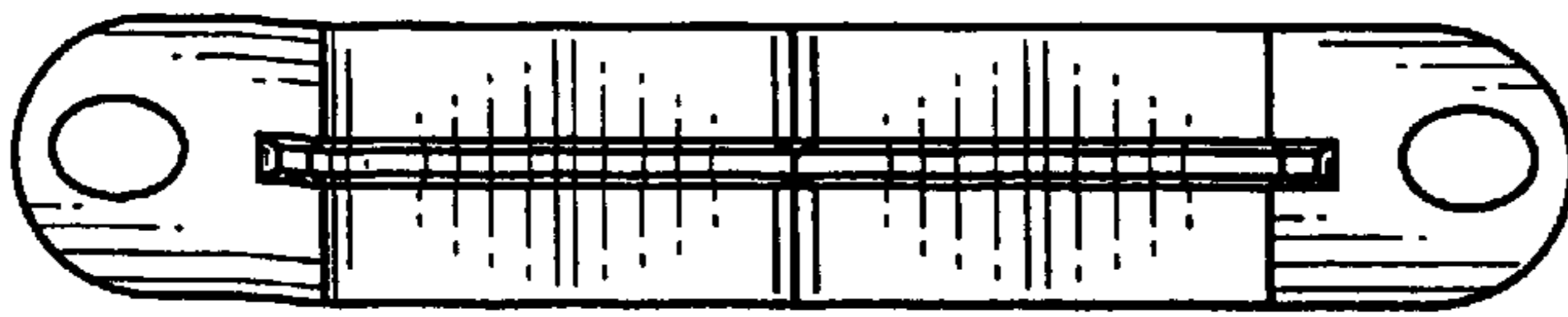

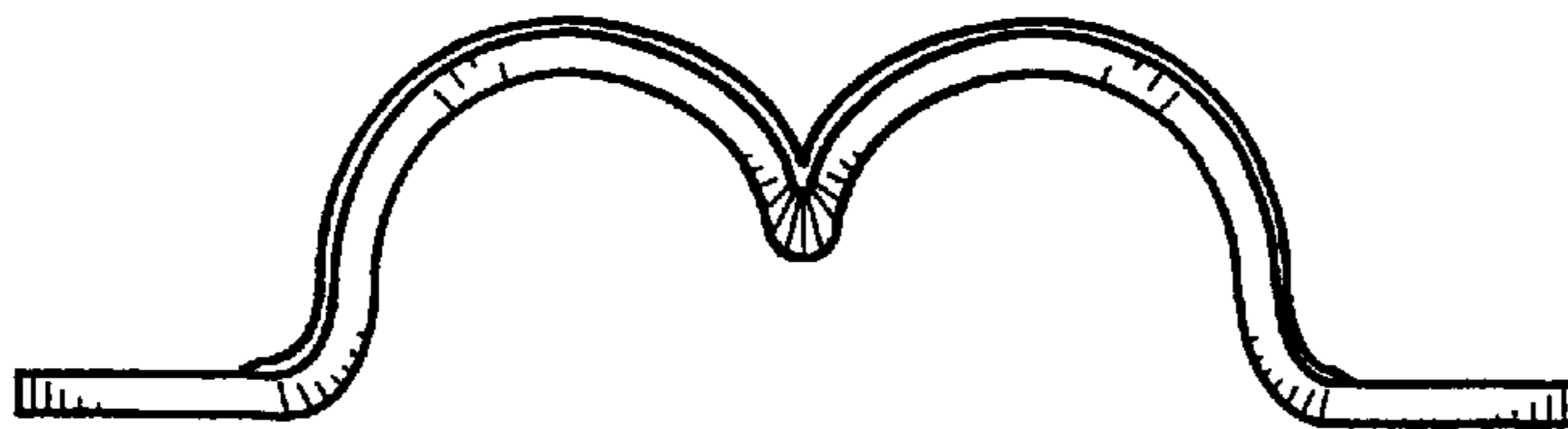

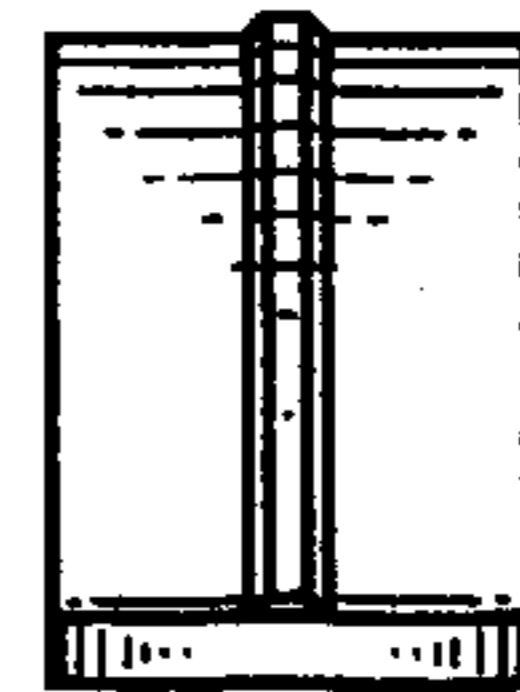

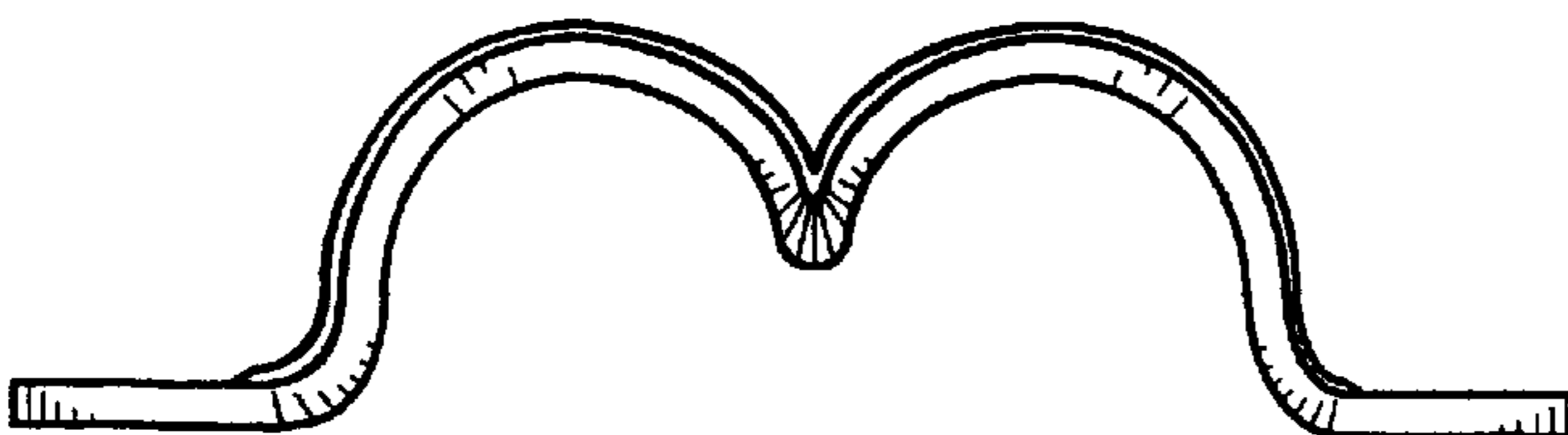

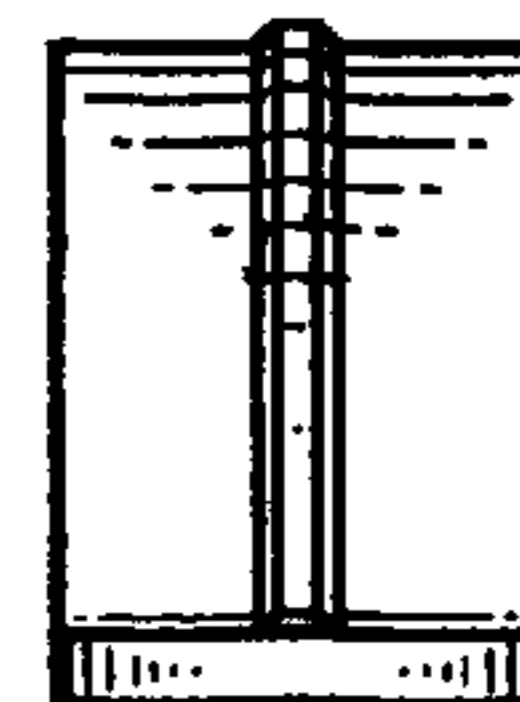
