FIG. 1 is a perspective view of a molded pulp tray showing new my design;

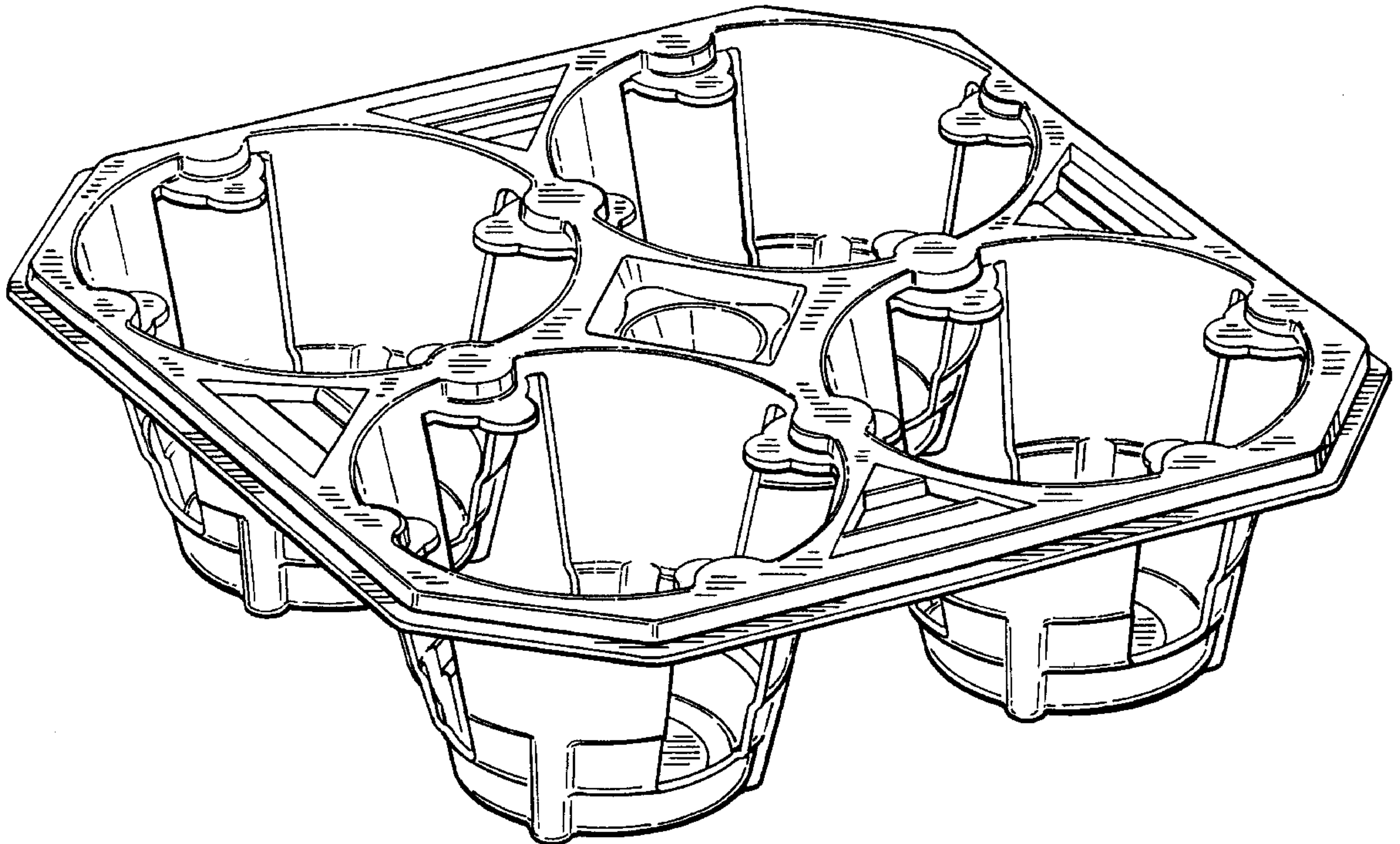
FIG. 2 is a top plan view thereof;

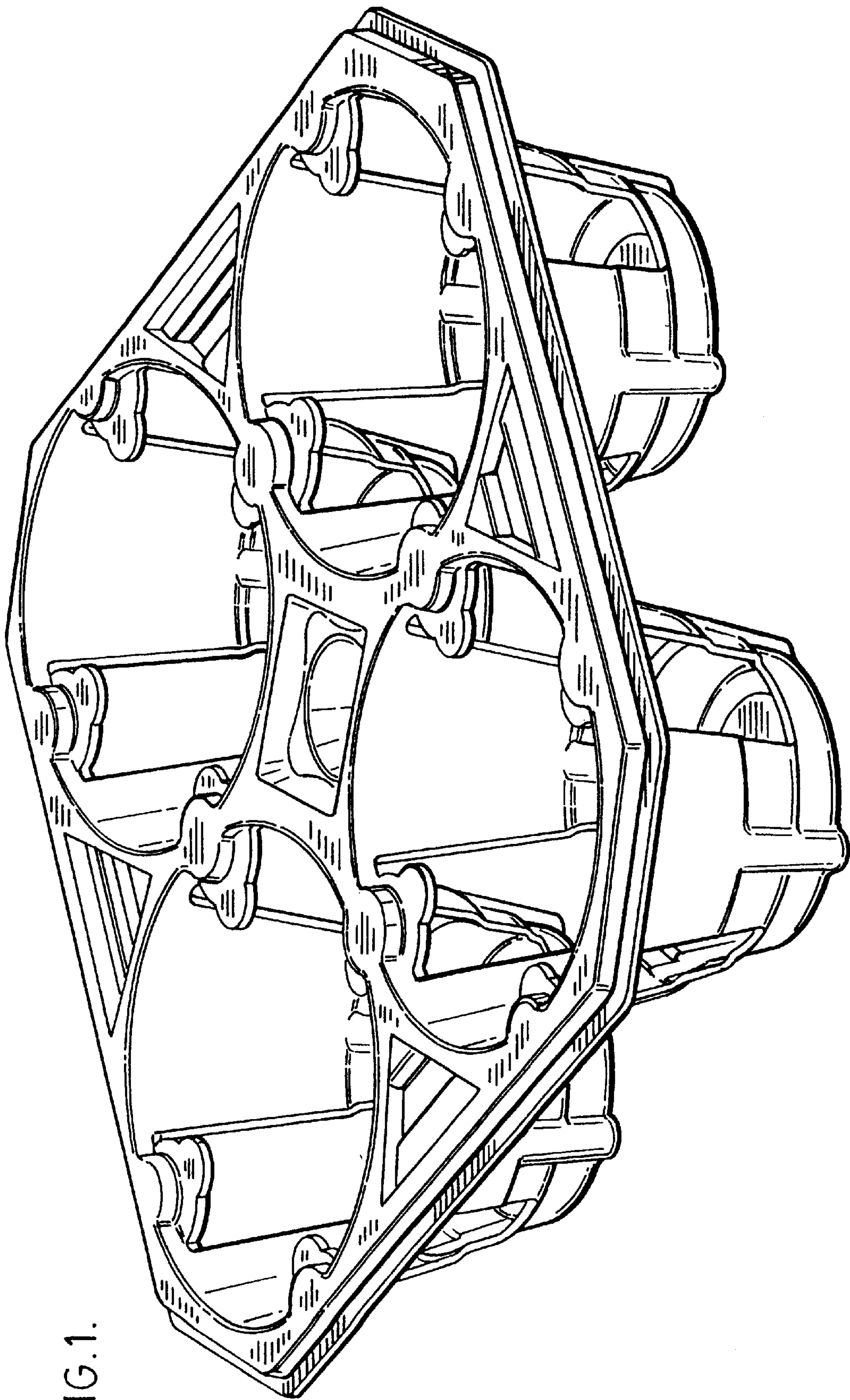

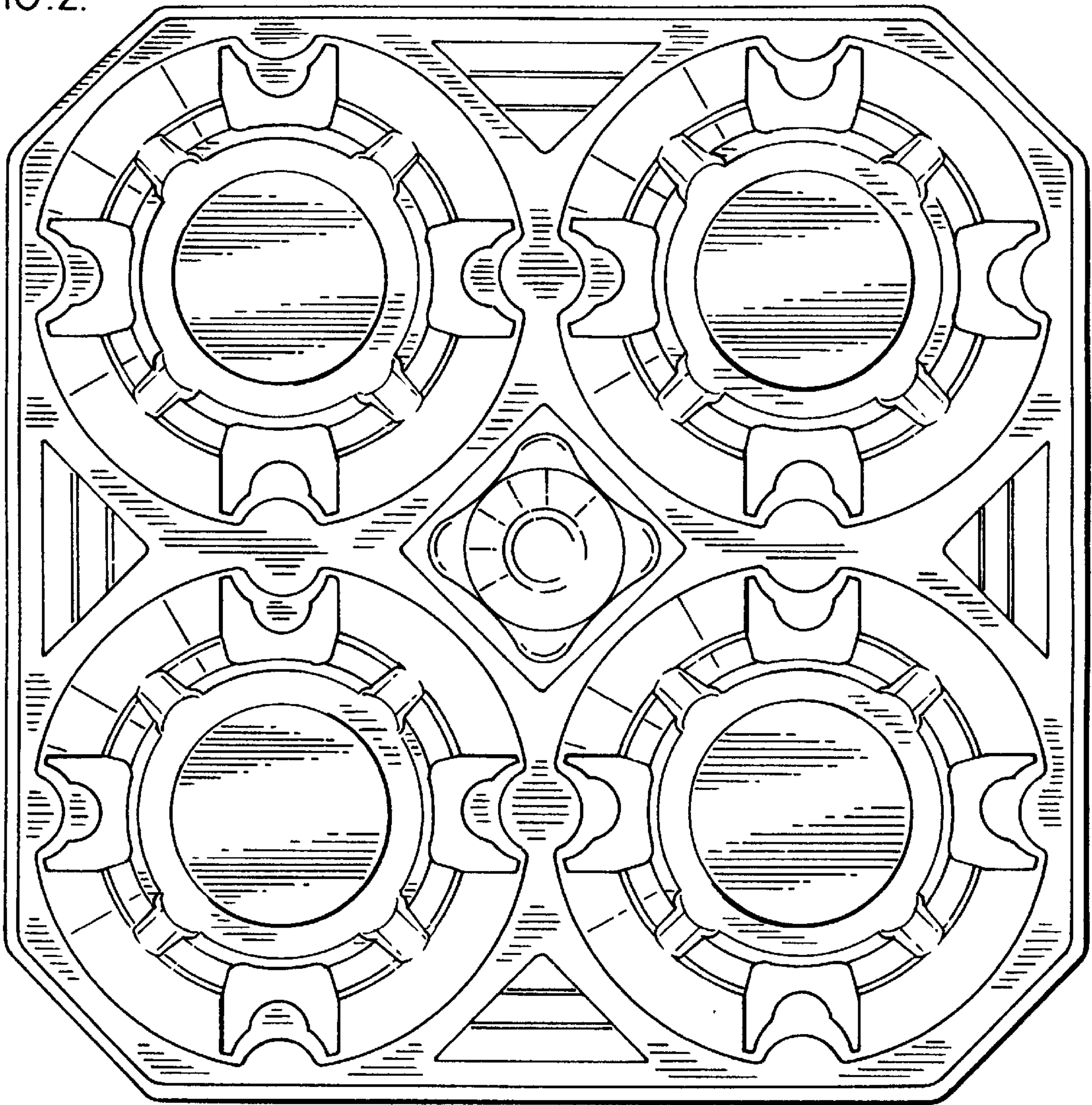

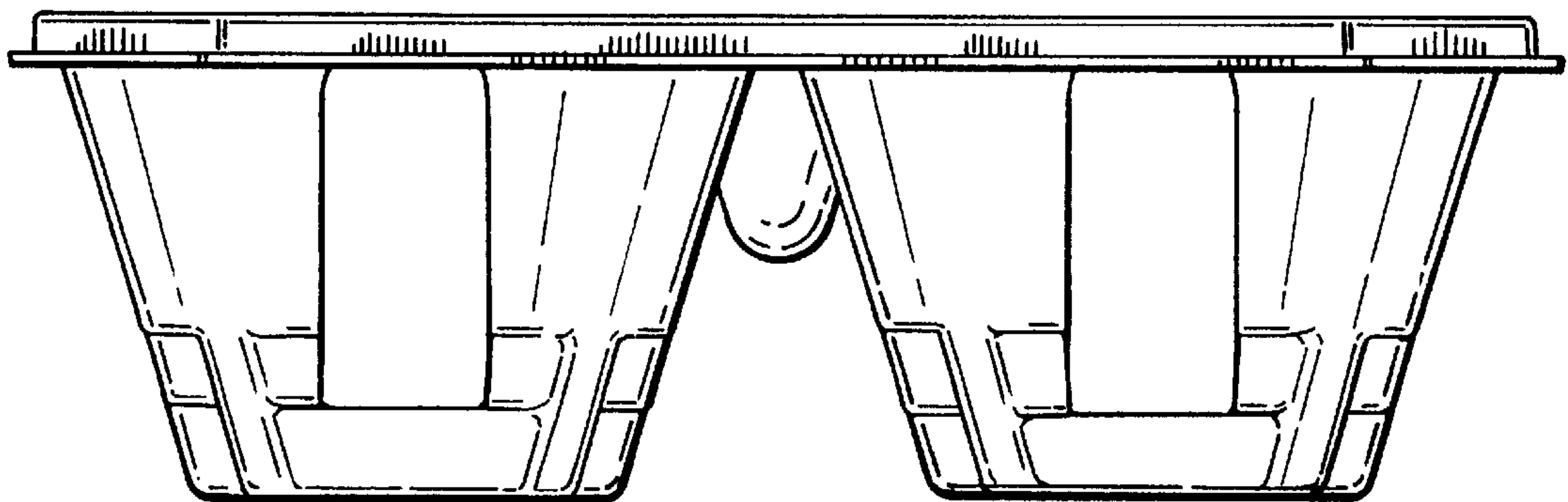
