**DESCRIPTION**

FIG. 1 is a perspective view of a dispenser head showing my new design;

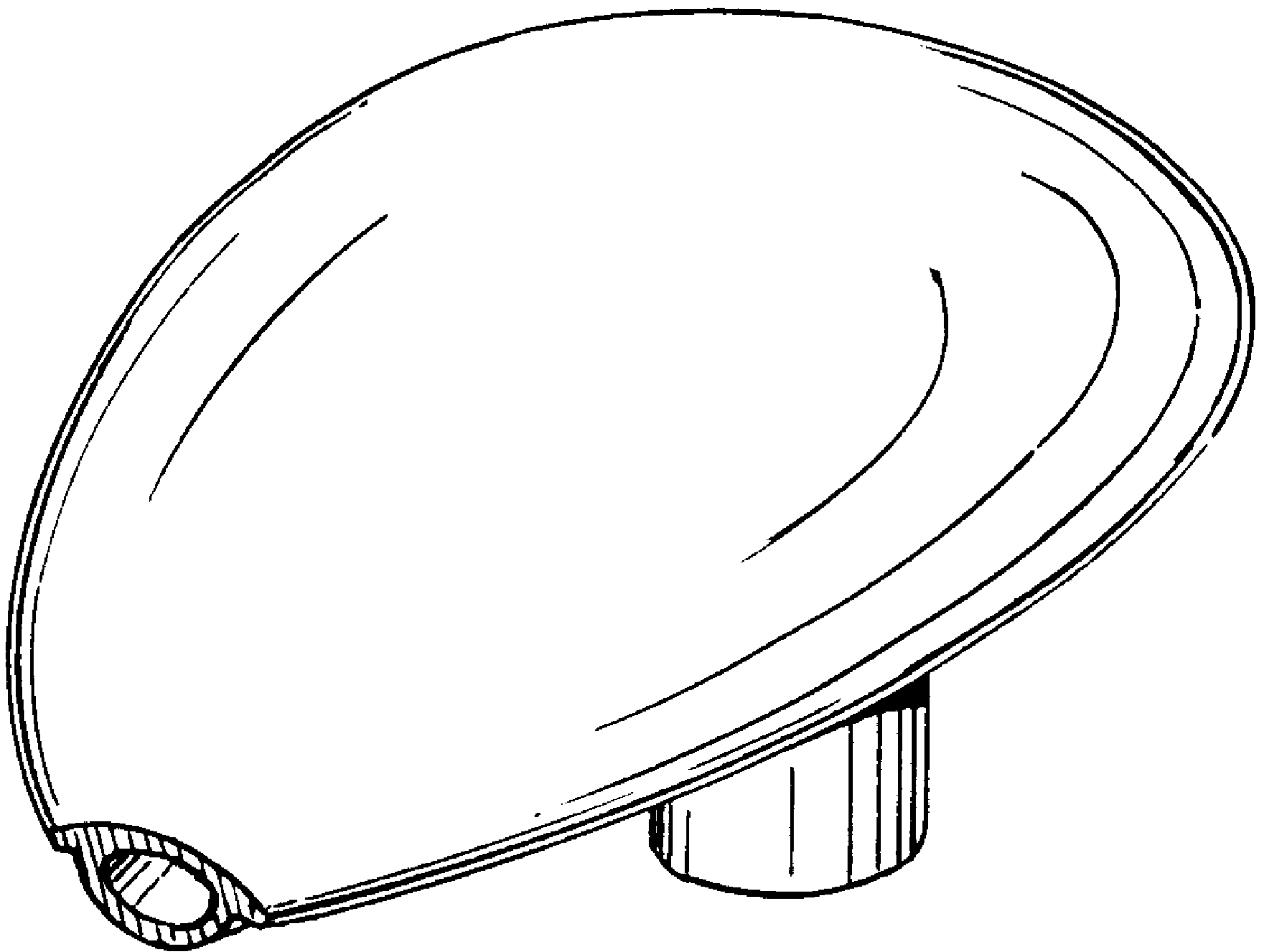

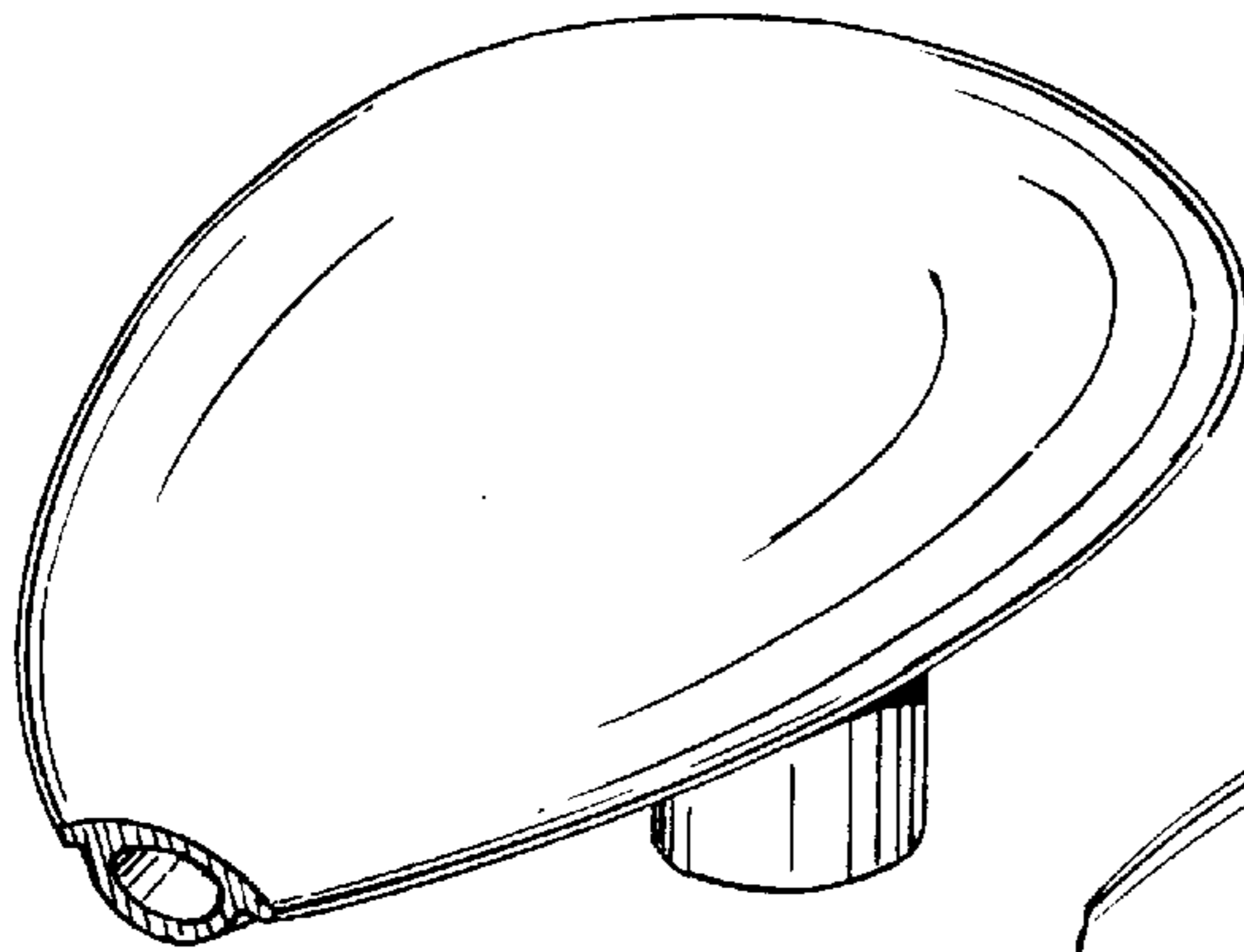

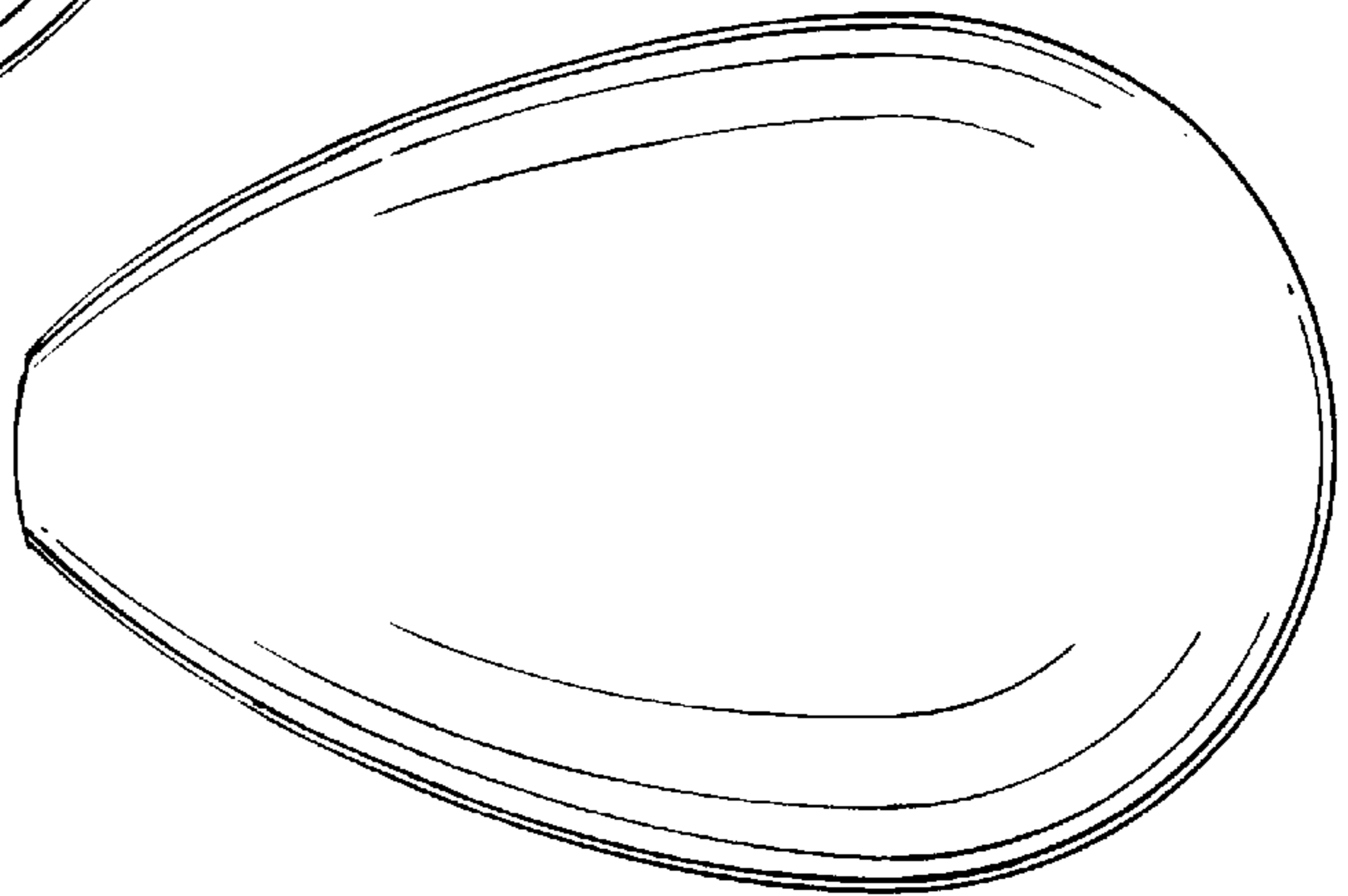

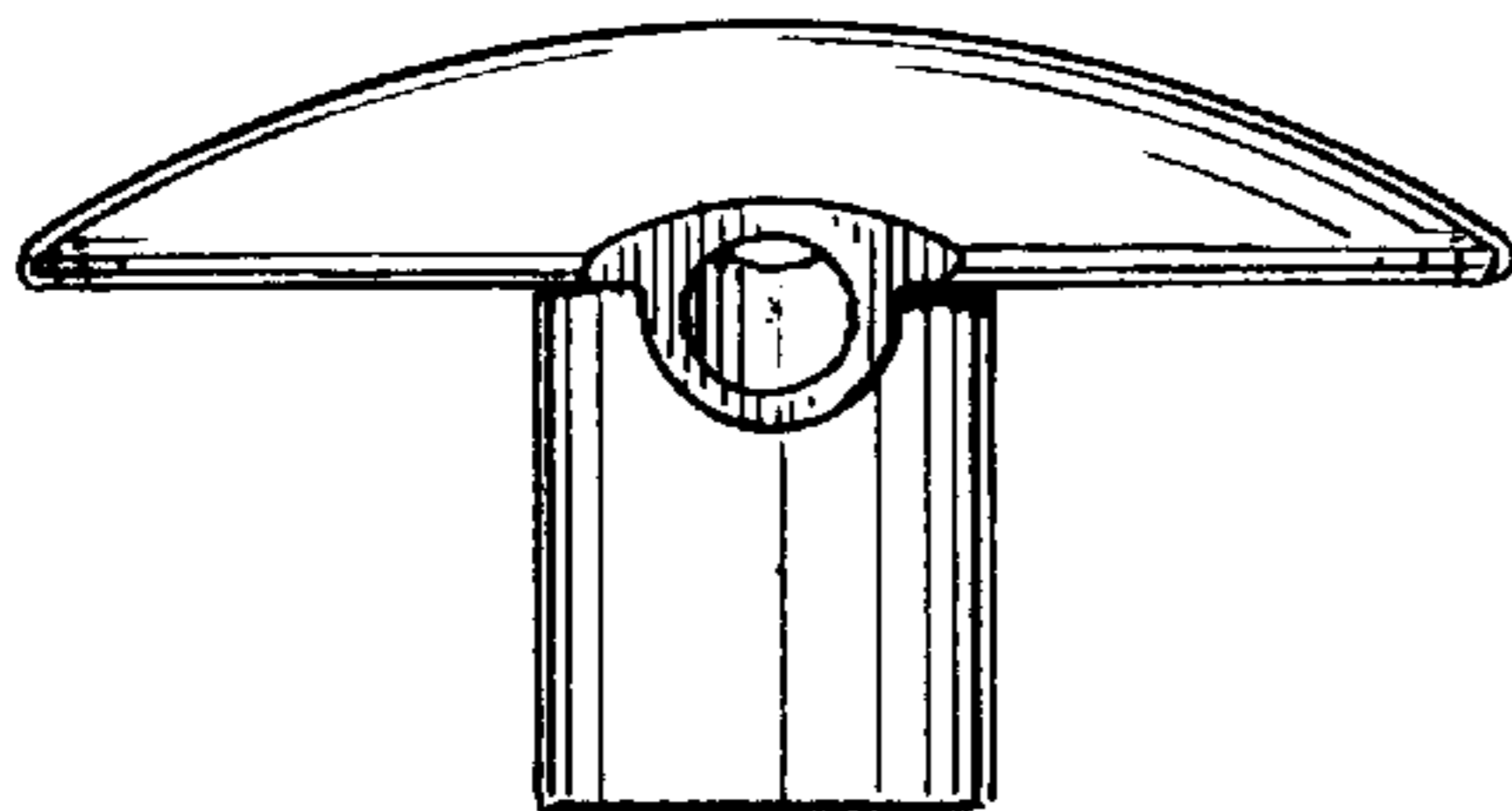

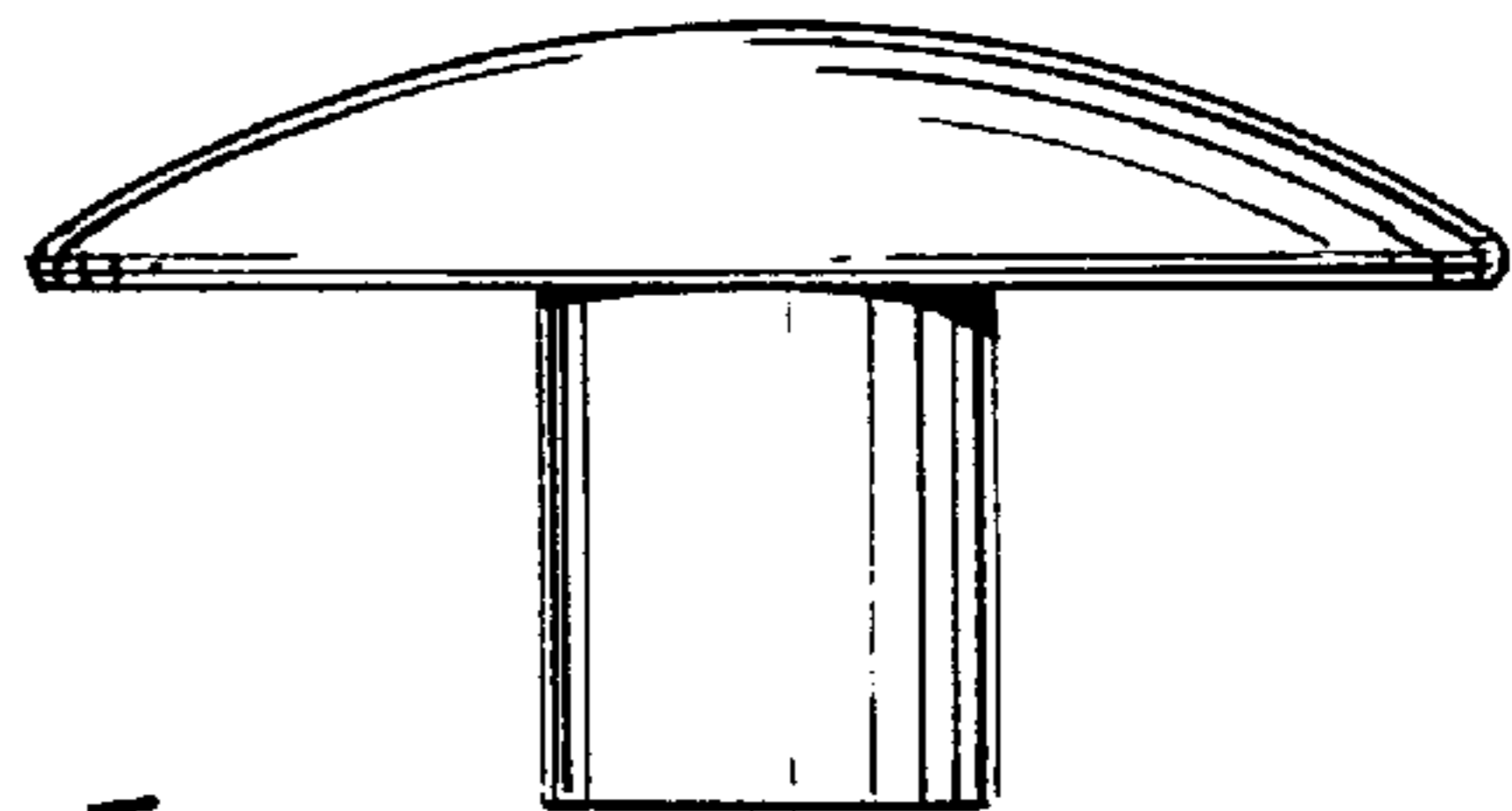

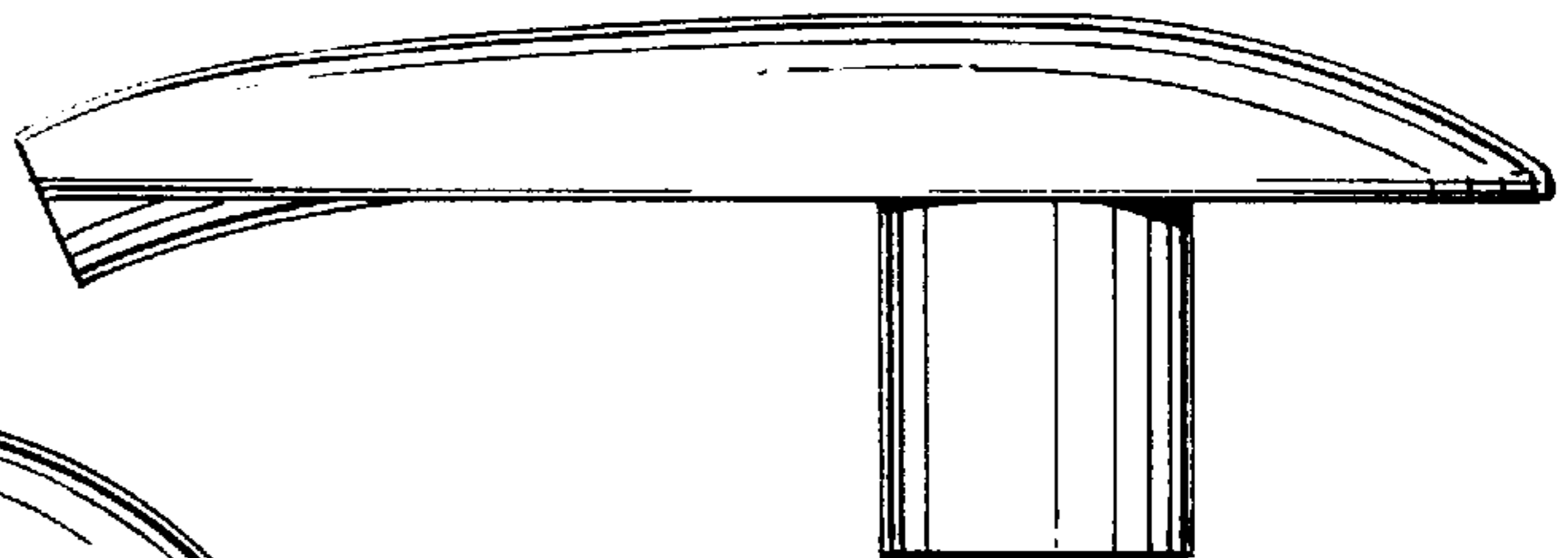
