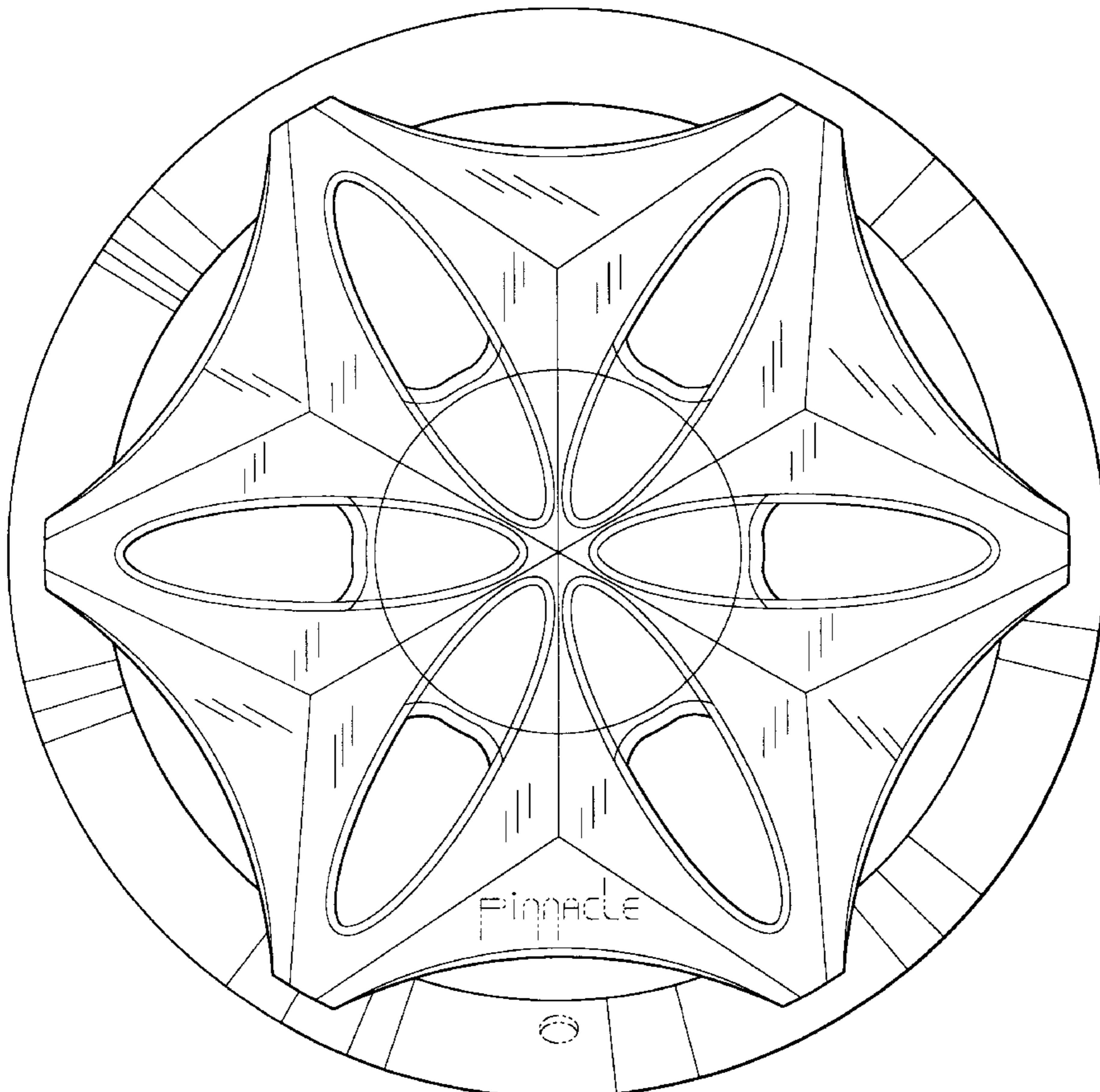

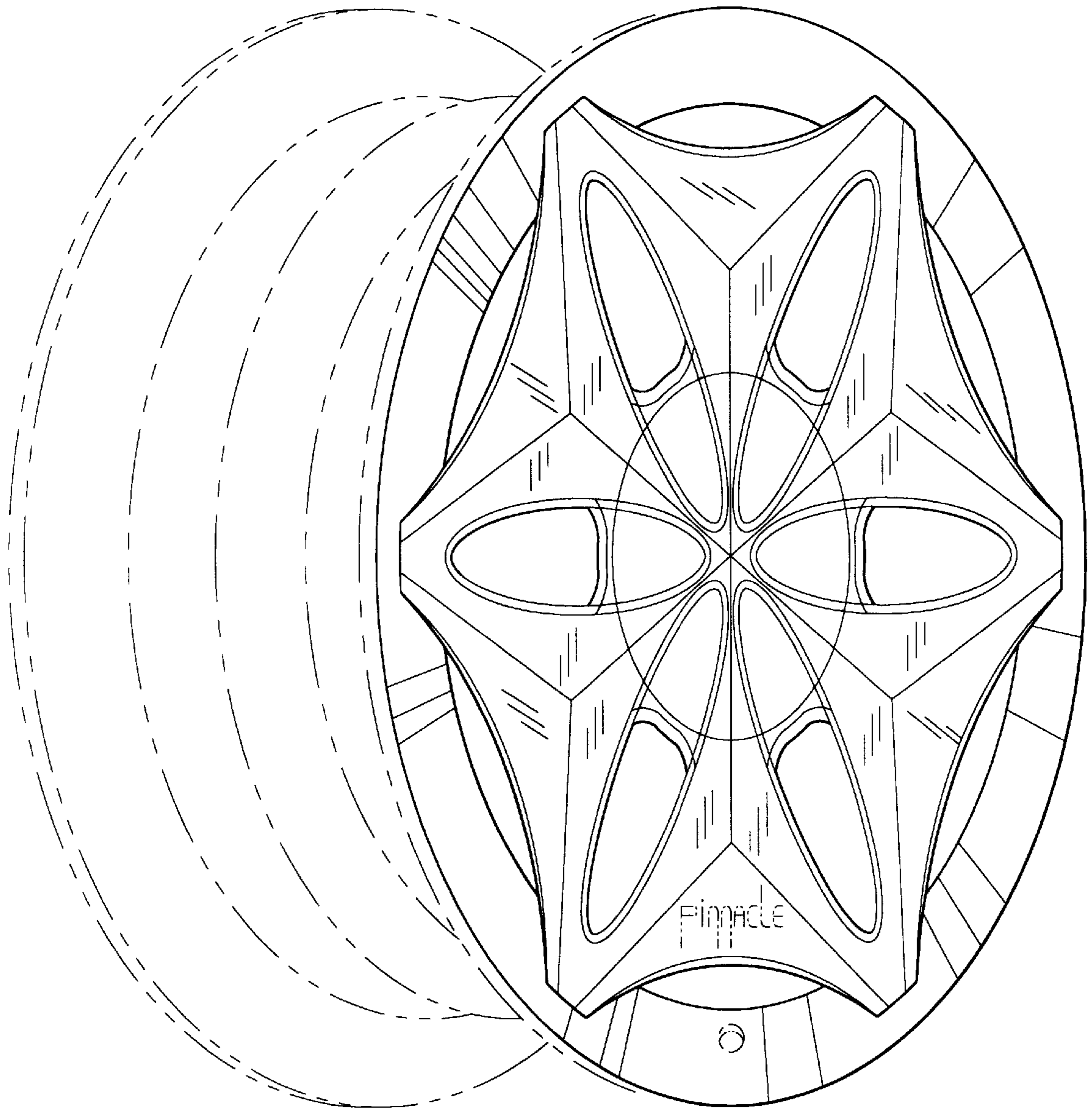

**DESCRIPTION**

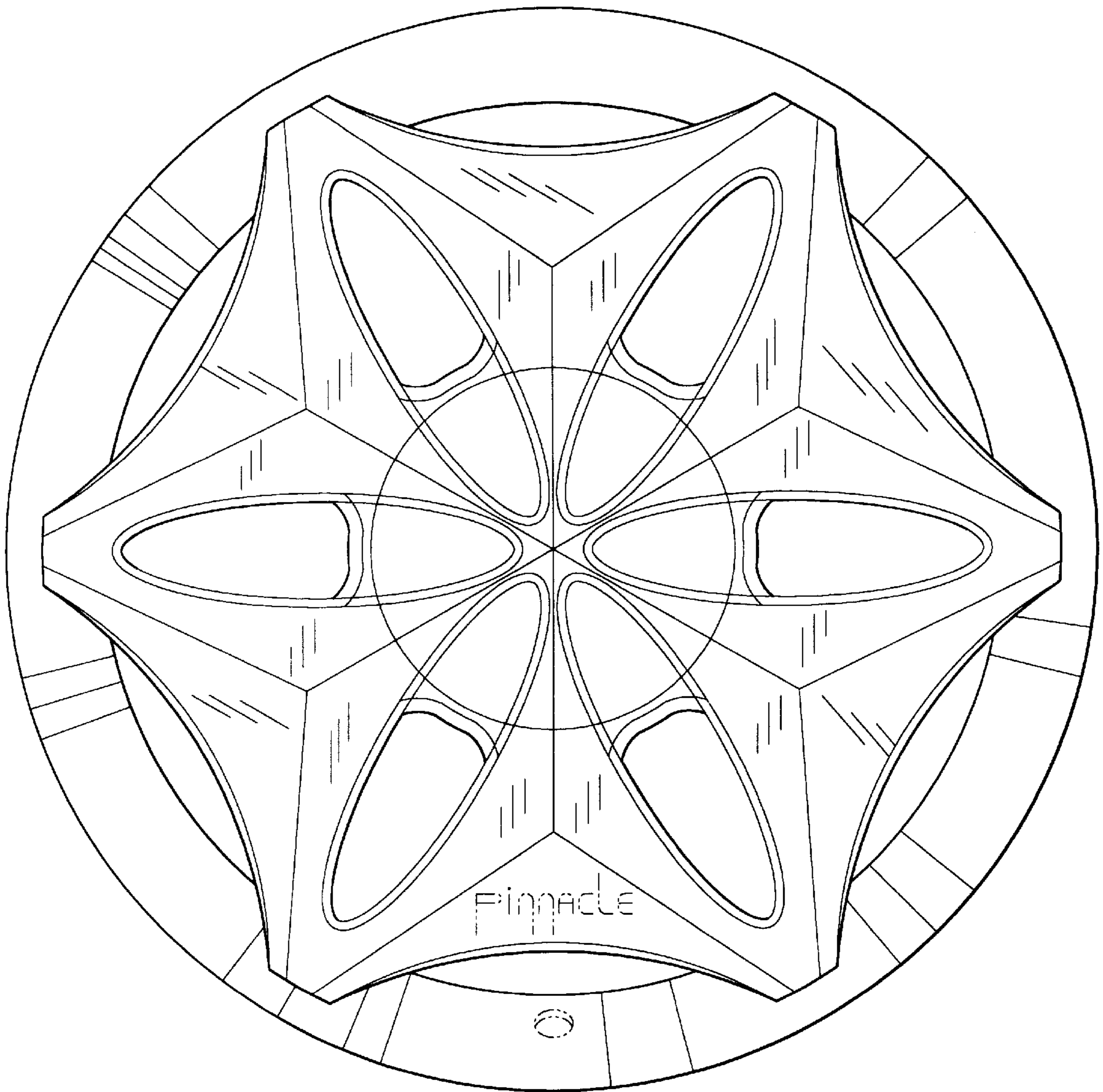
