(57) **CLAIM**

The ornamental design for a TV receiver, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of TV receiver showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a left side elevational view thereof;
 FIG. 6 is a rear elevational view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a view similar to FIG. 2 but showing the lid of an operating section in an open position.

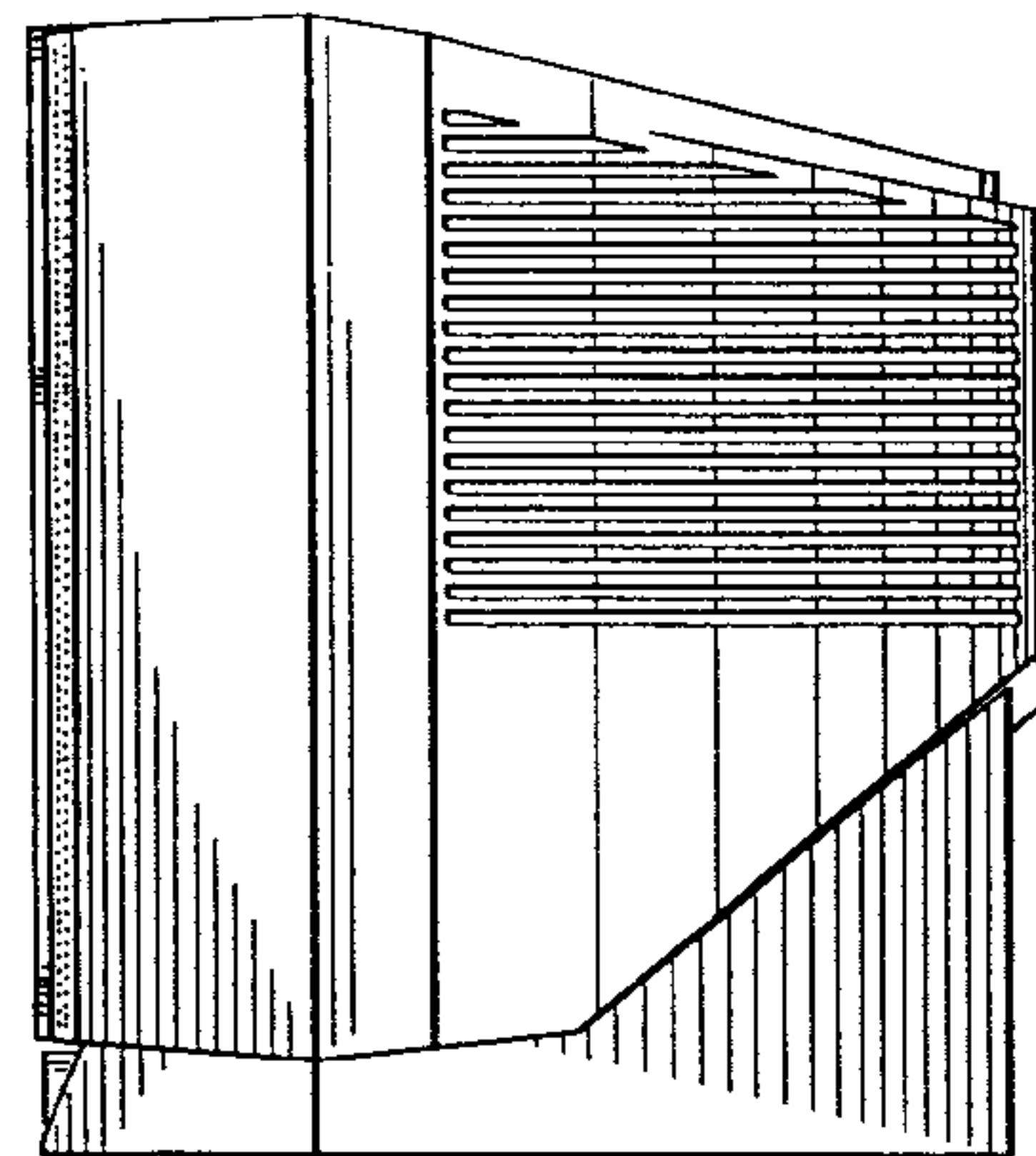
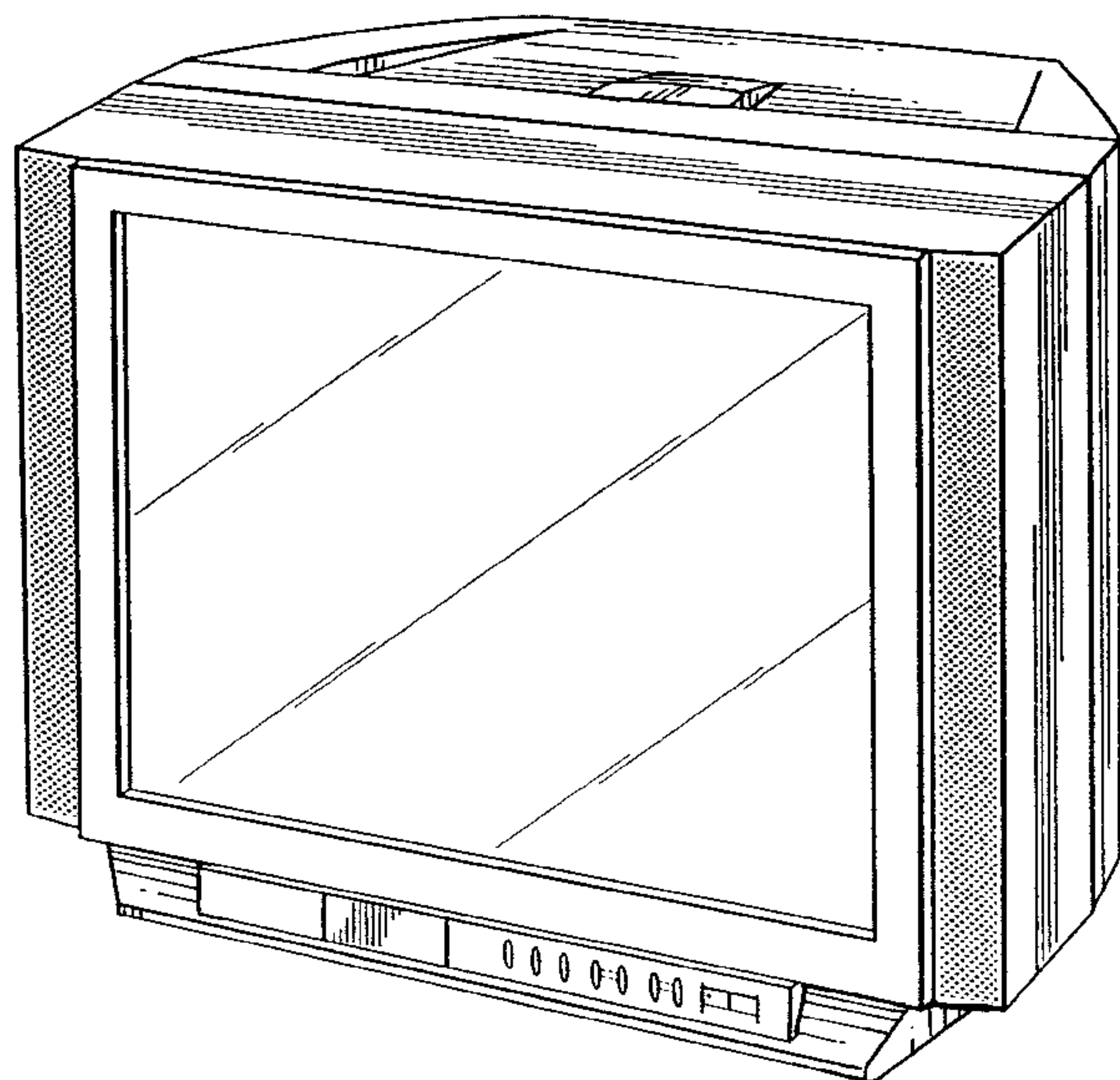

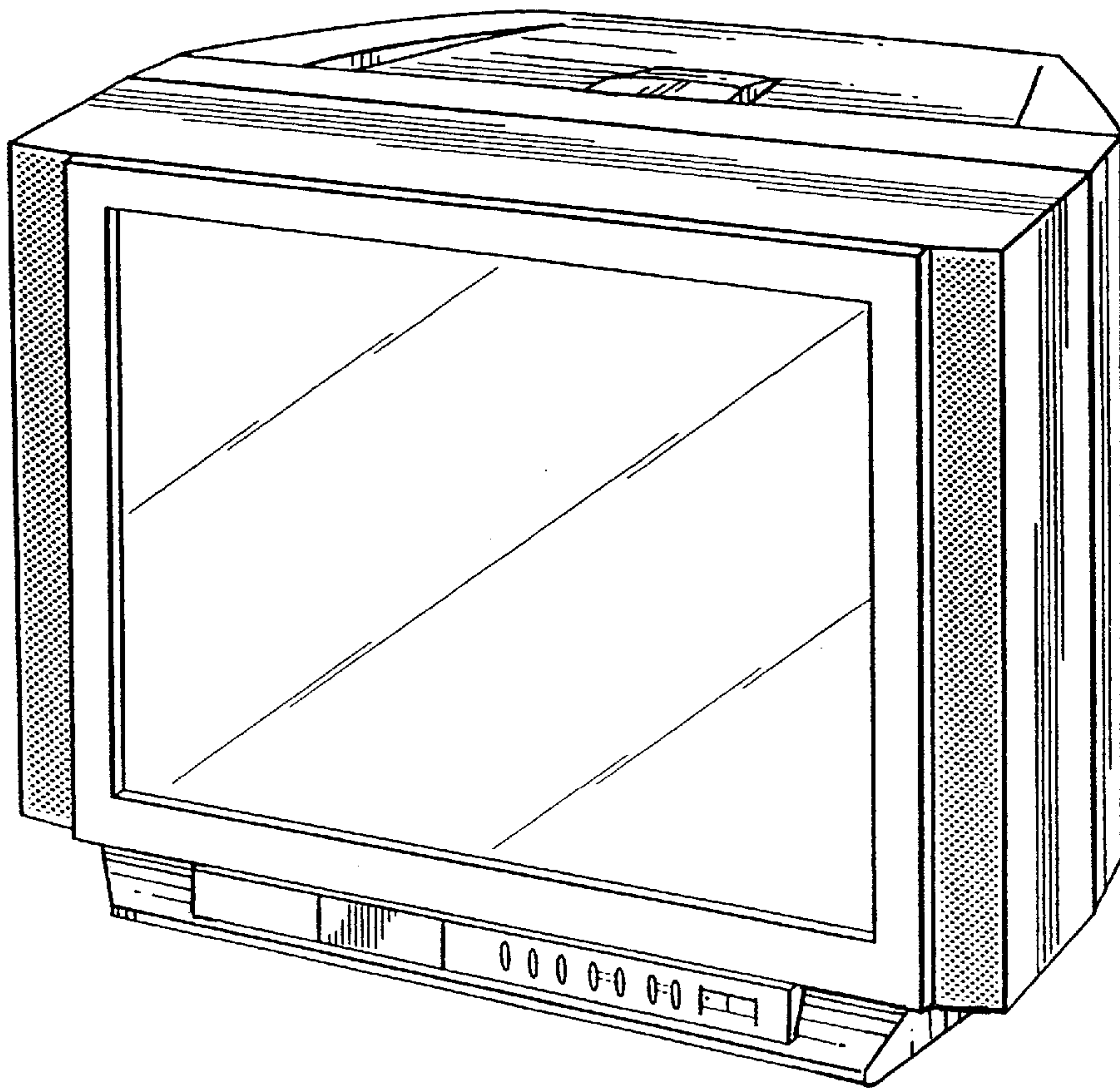

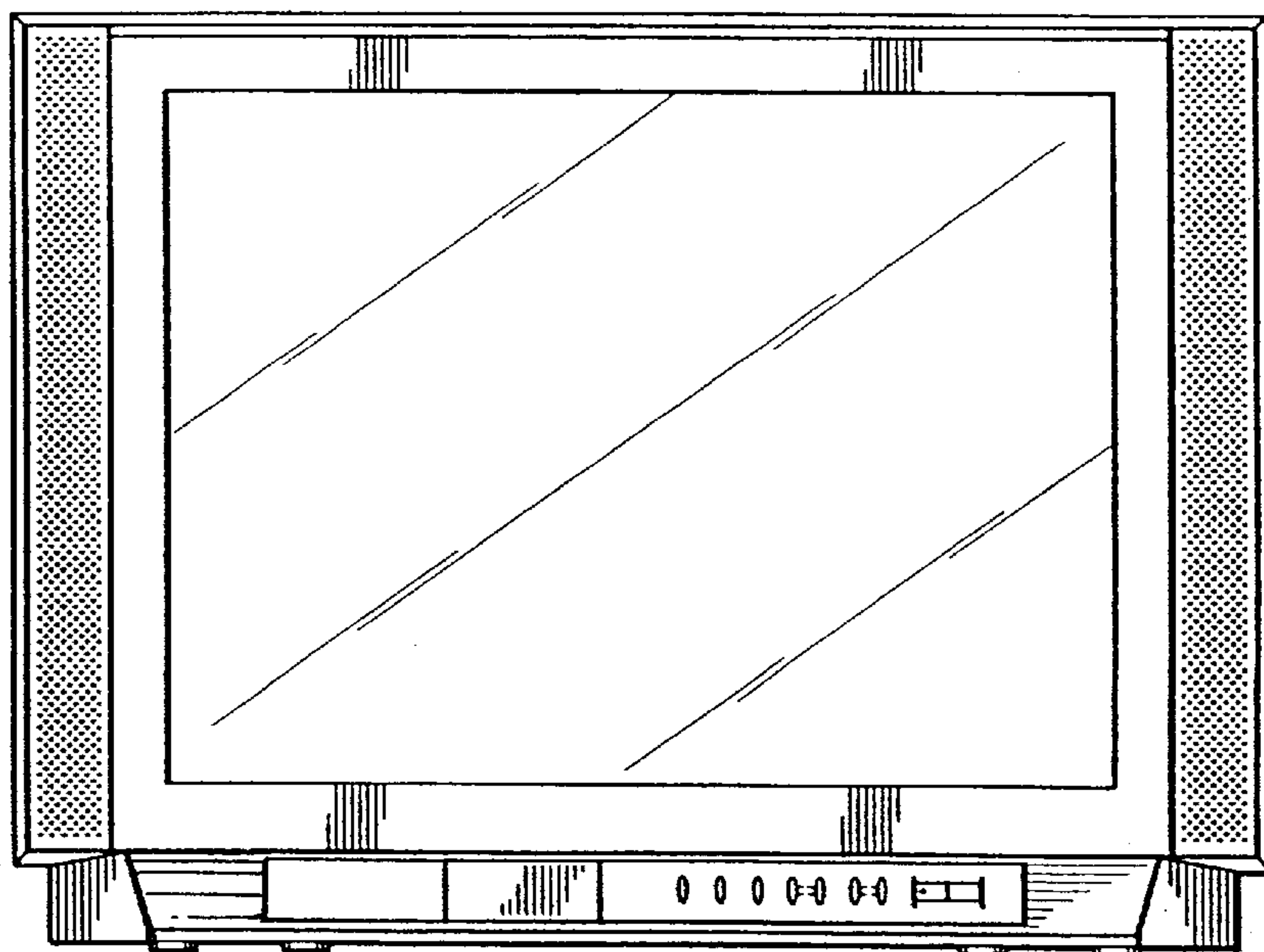

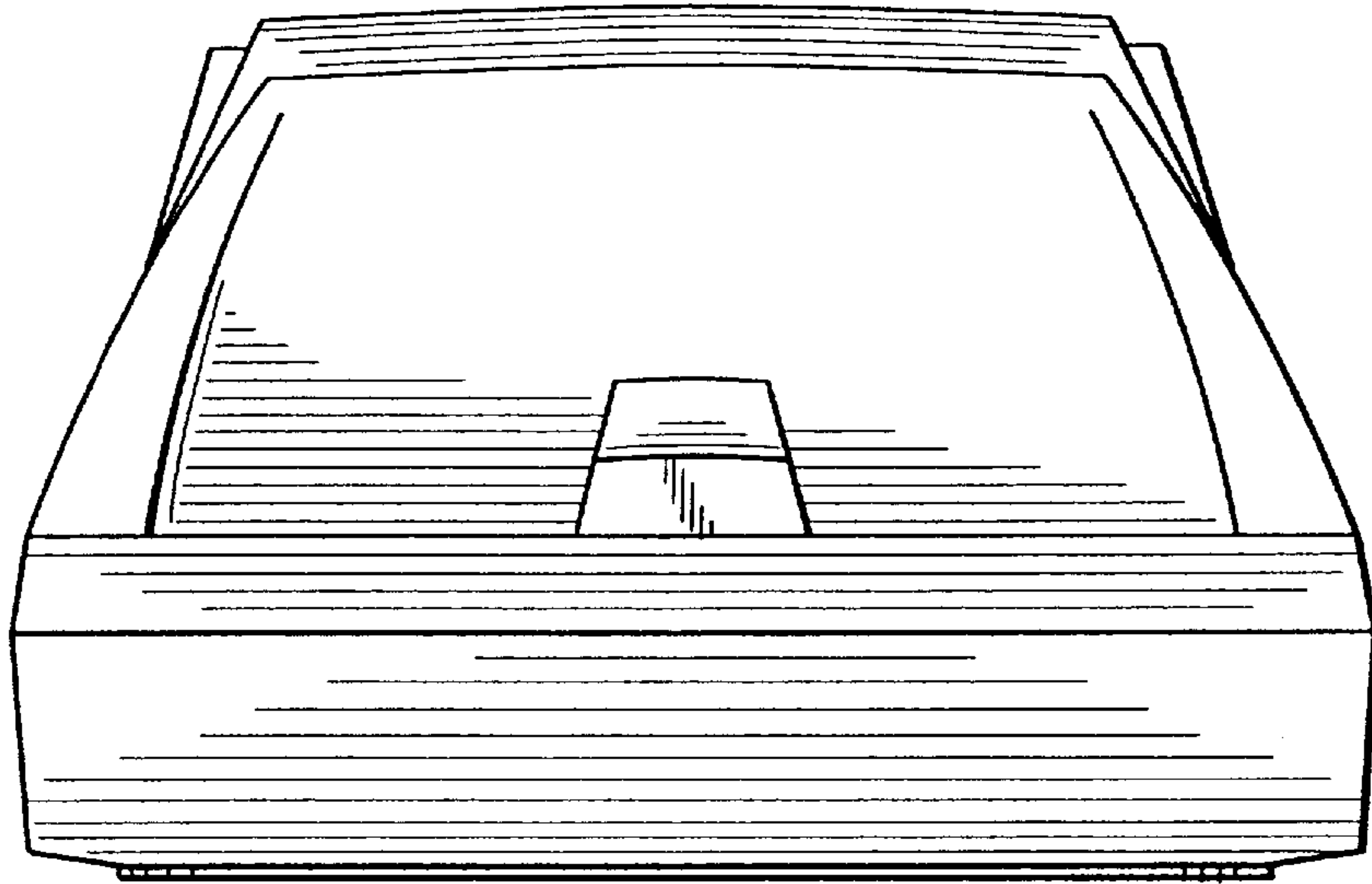

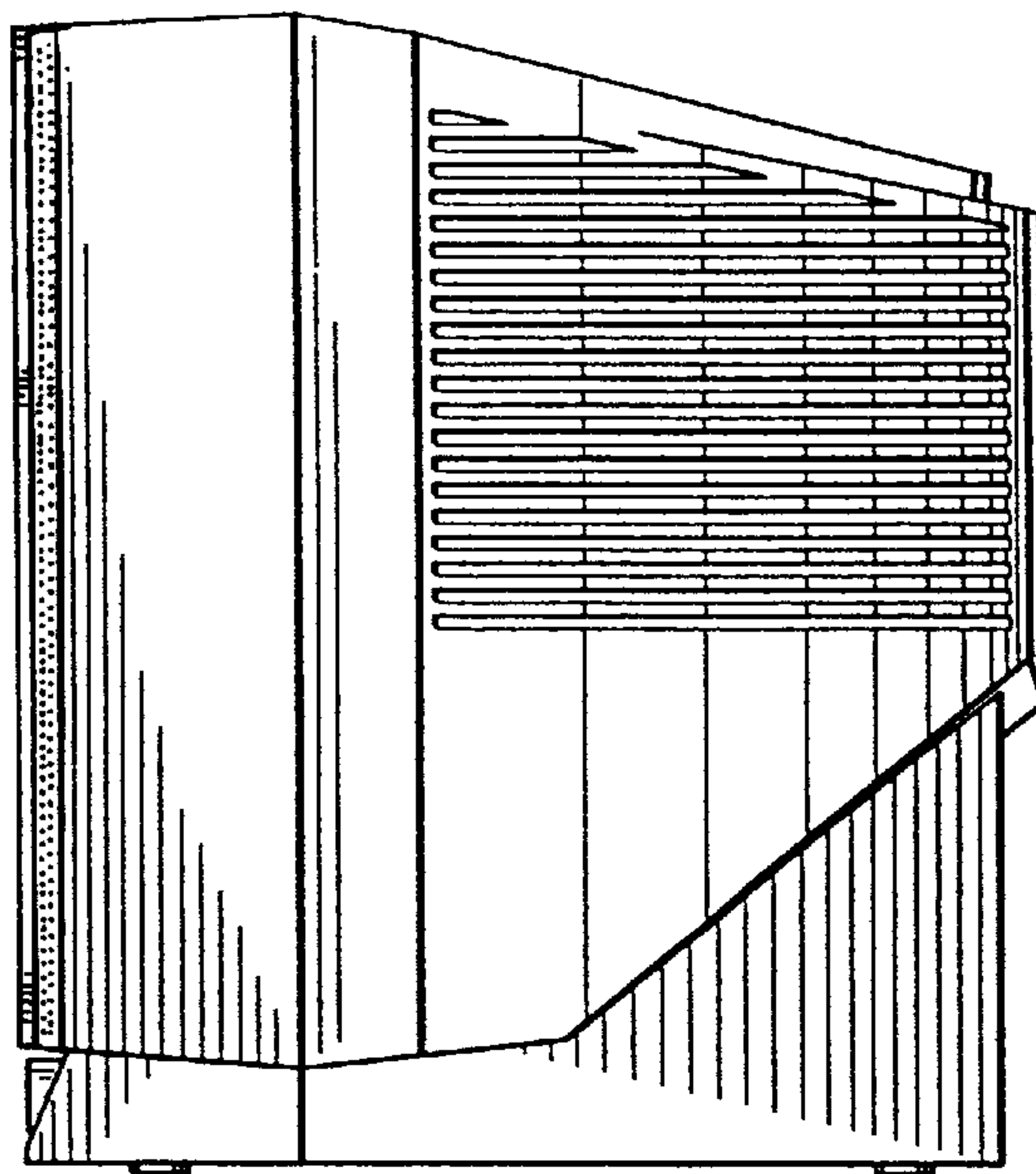

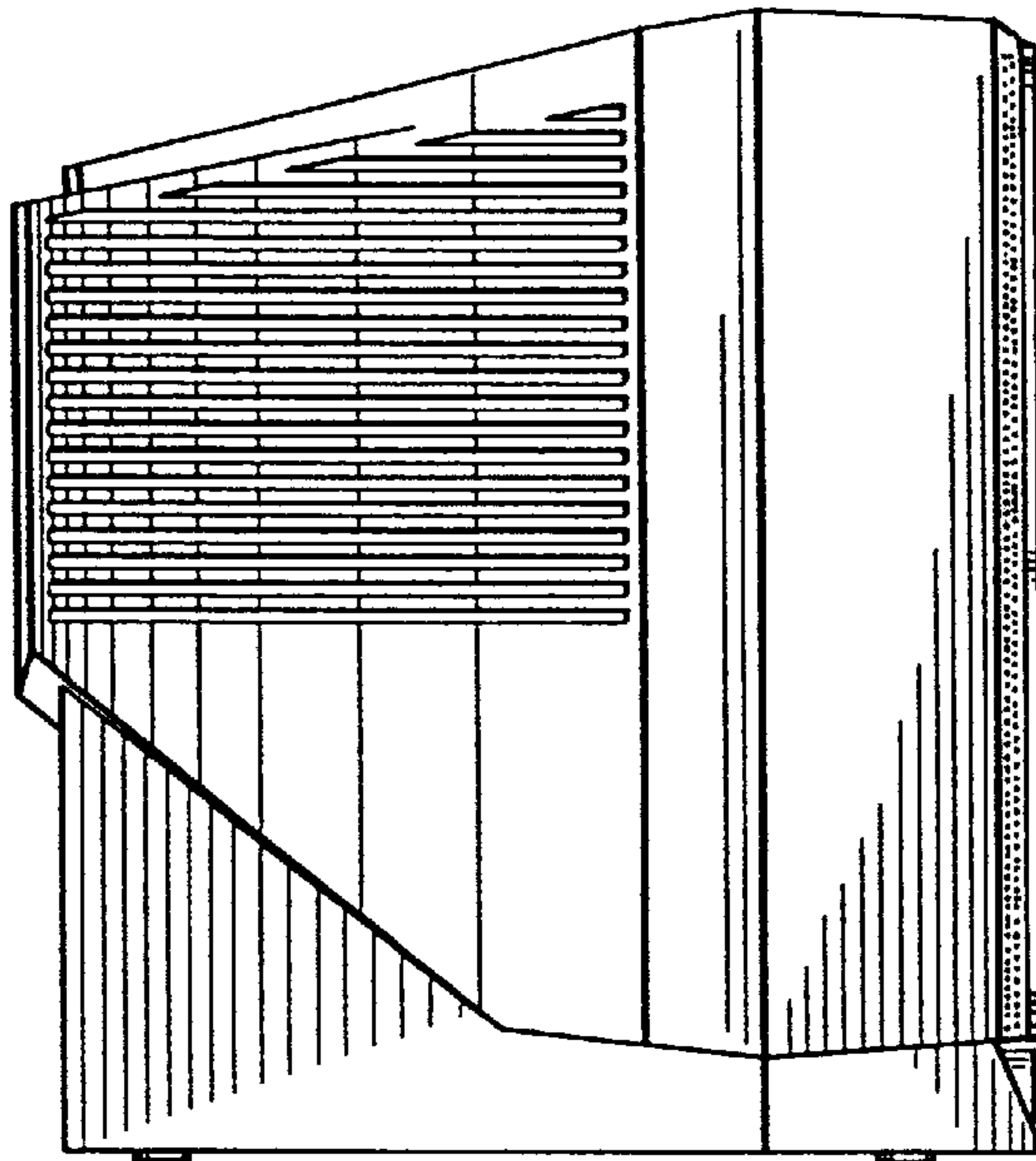

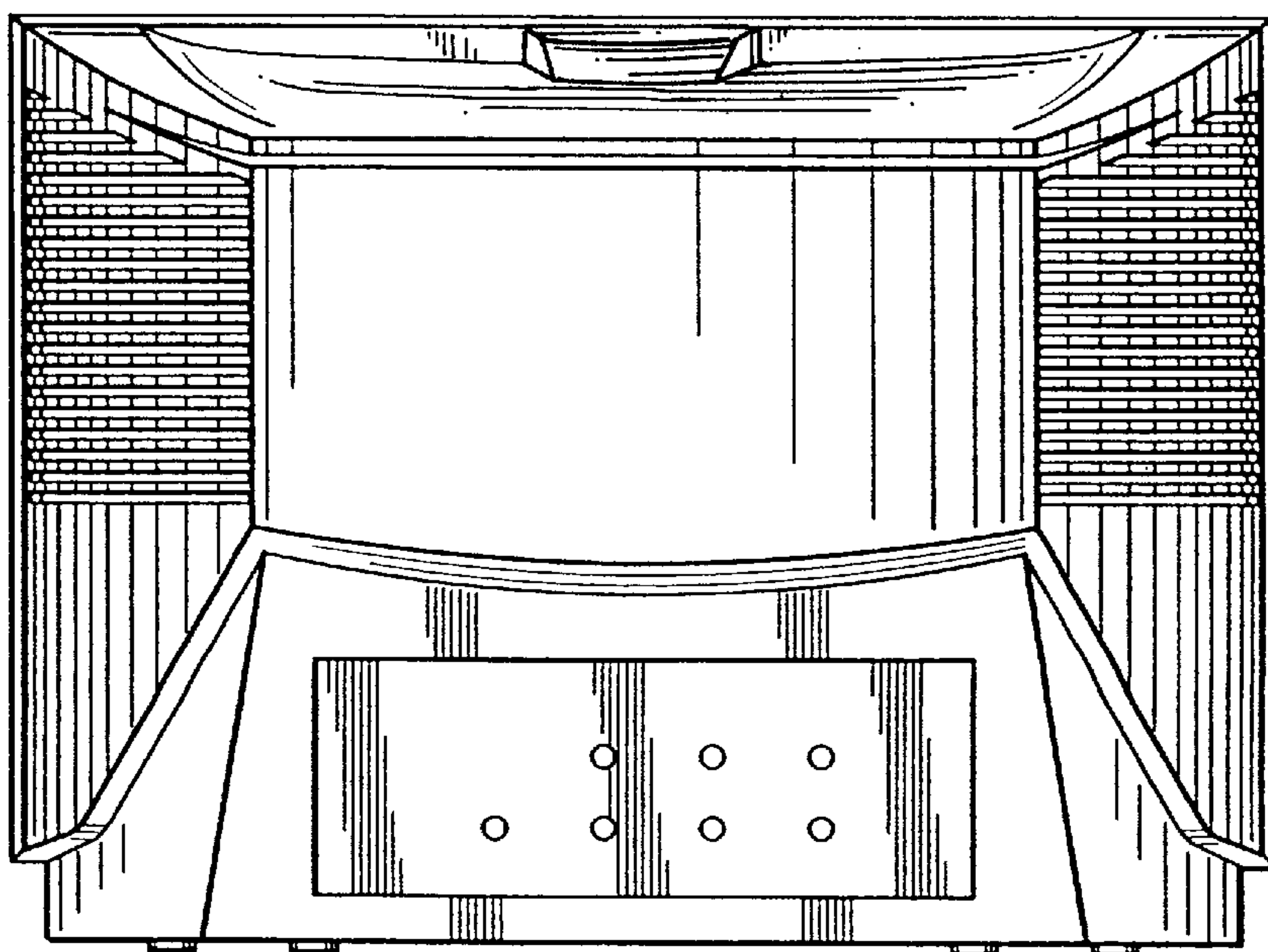

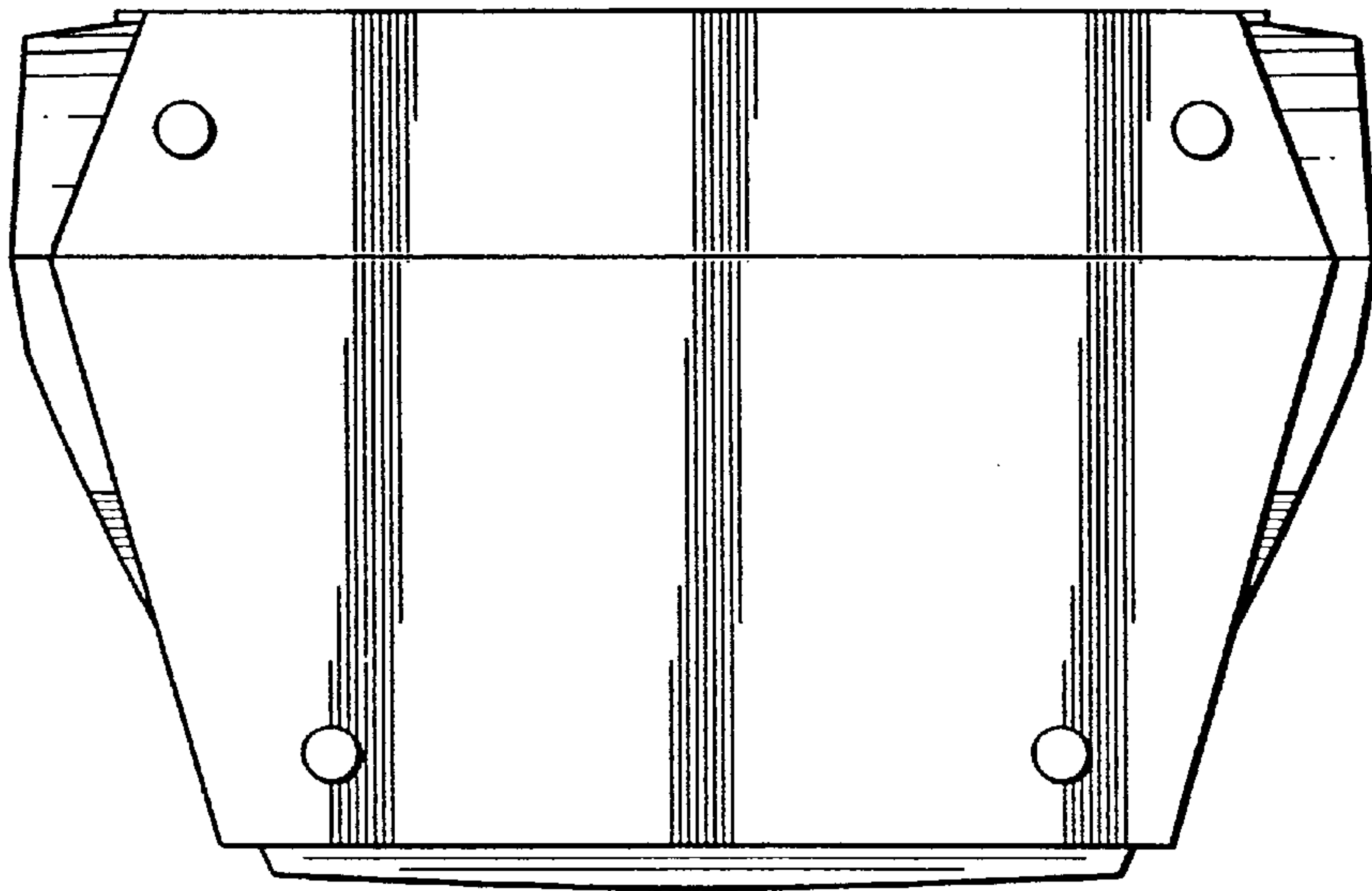
