DESCRIPTION

FIG. 1 is a front perspective view of an ink cartridge for printer showing our new design;

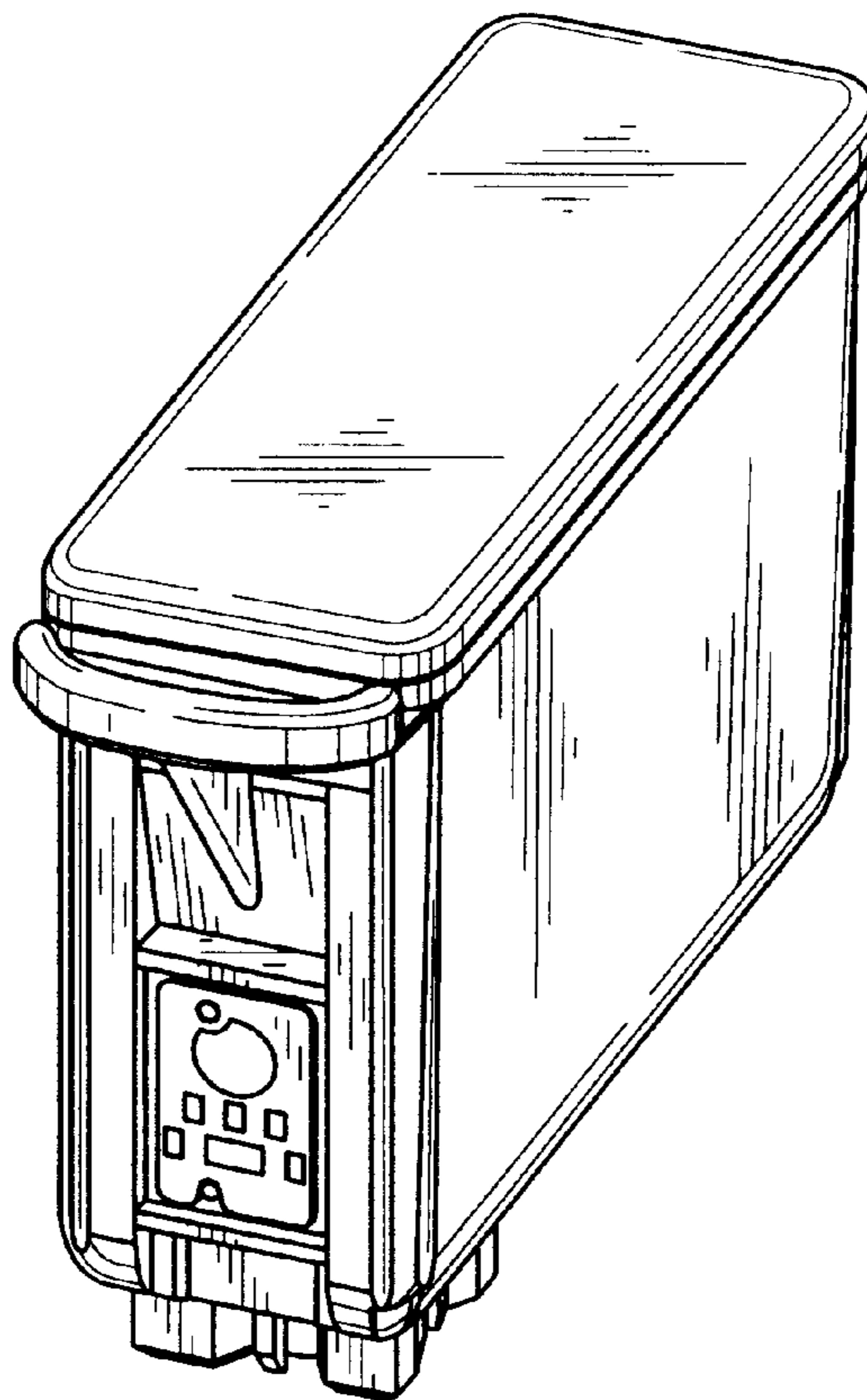

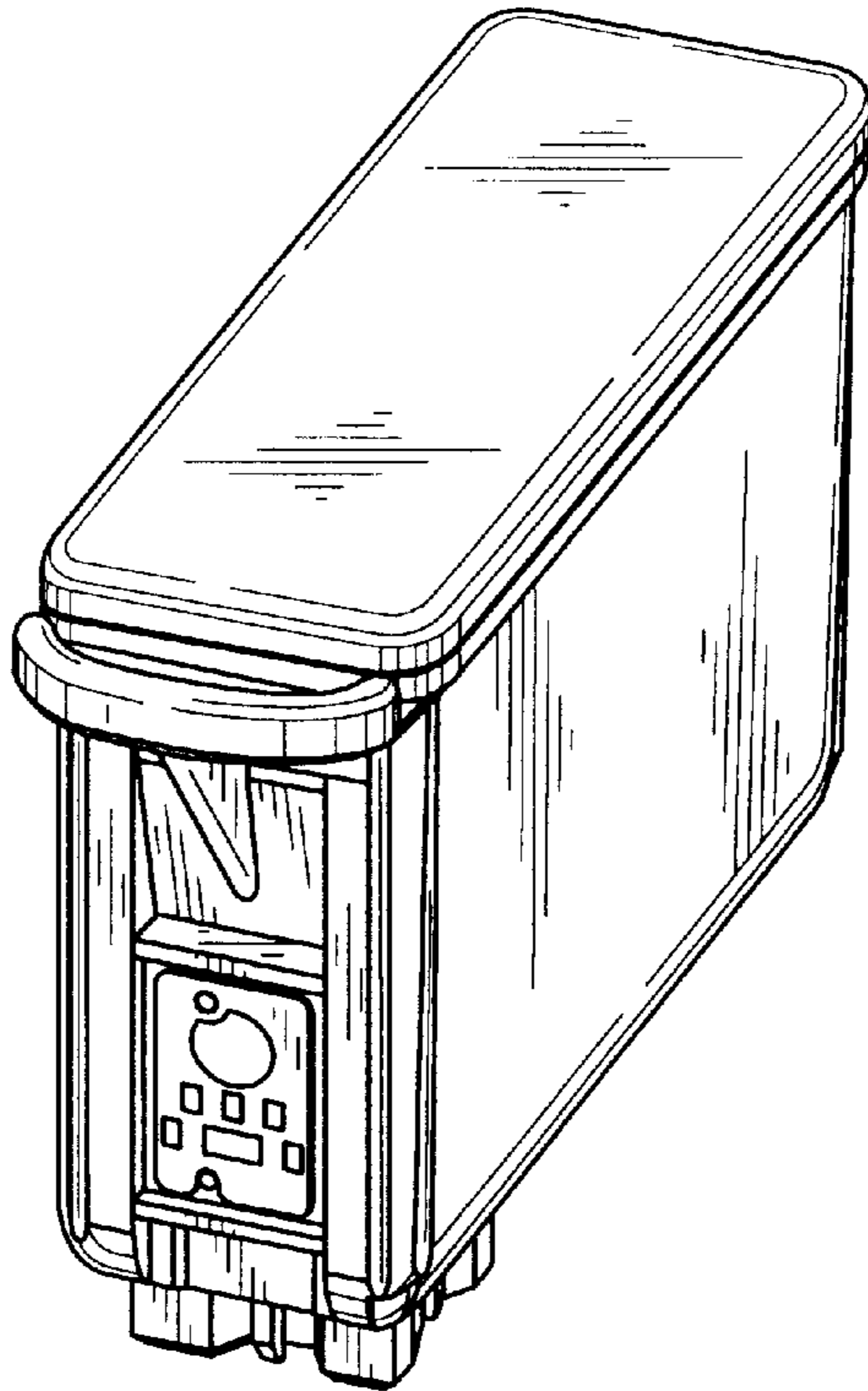

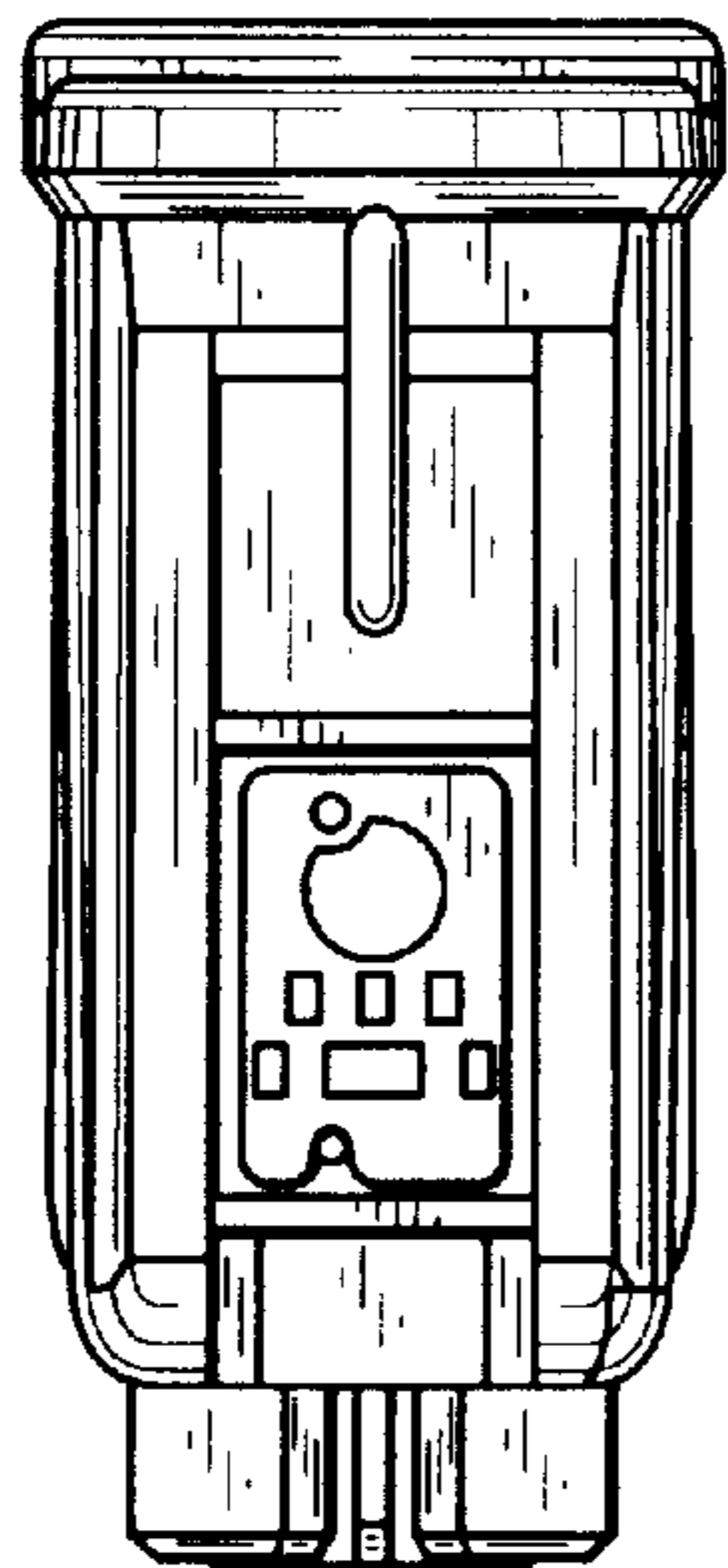

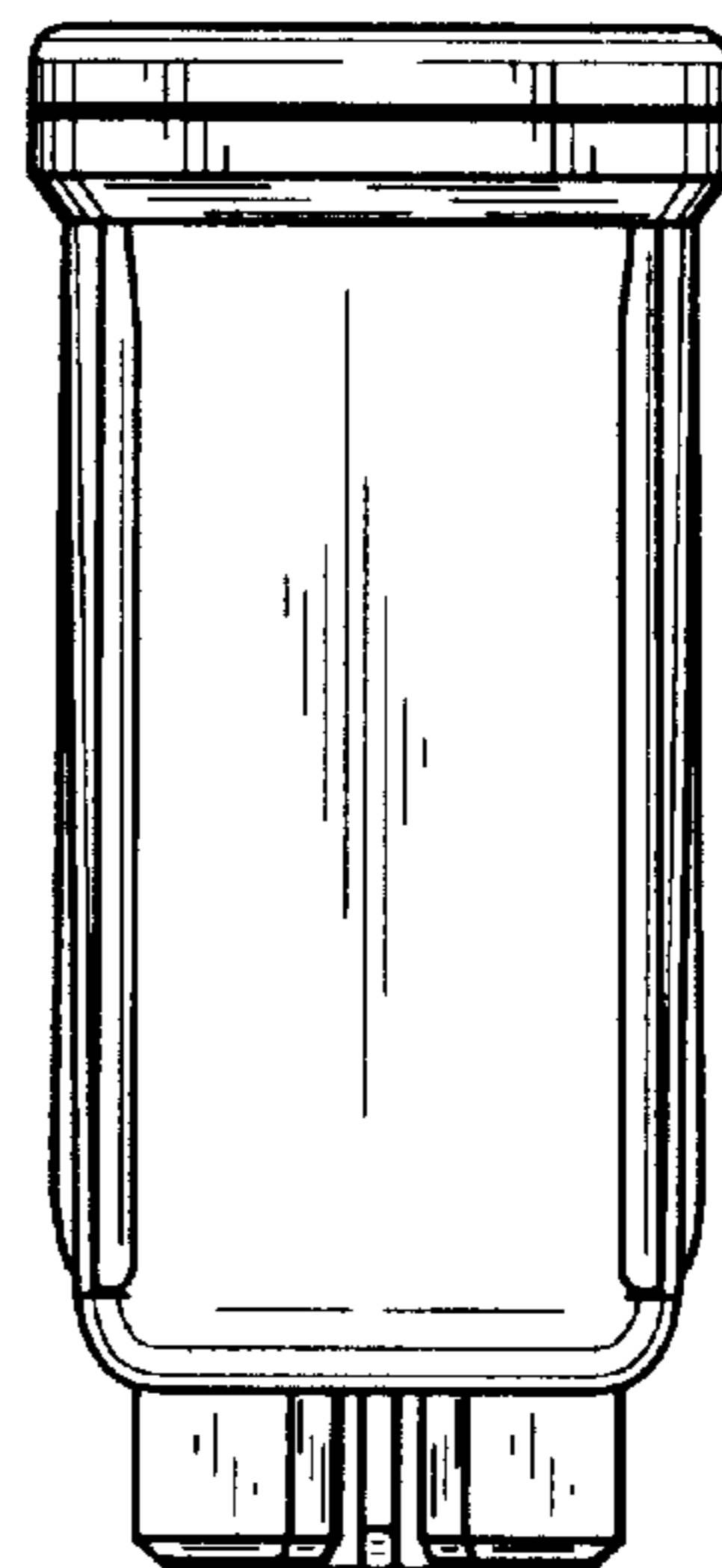

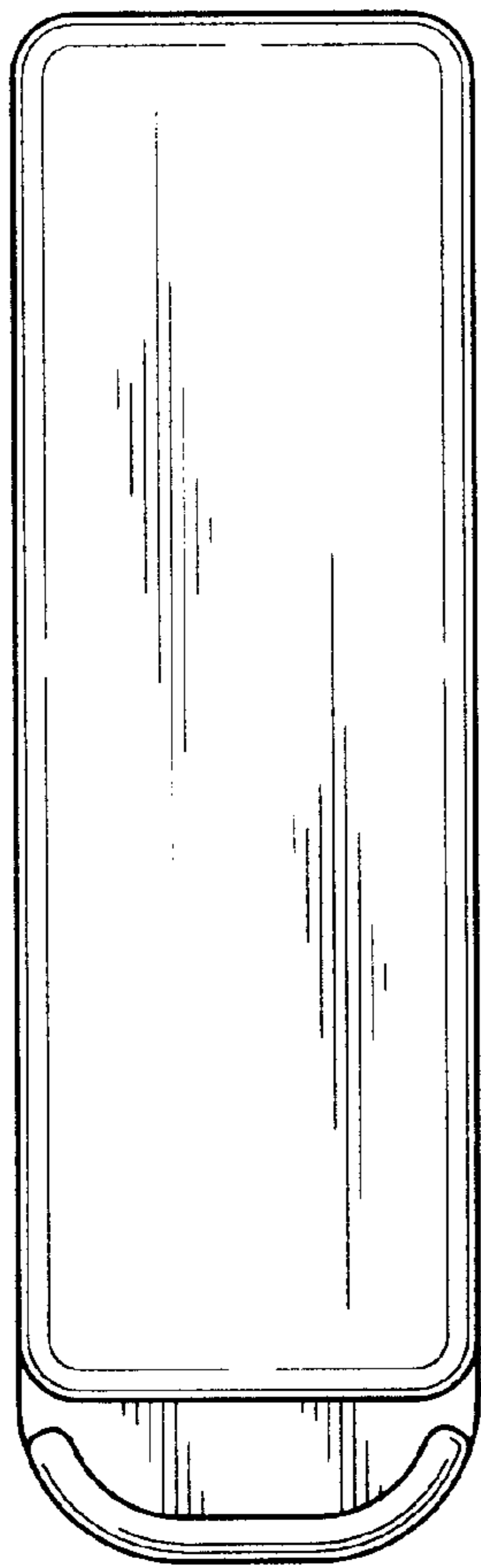

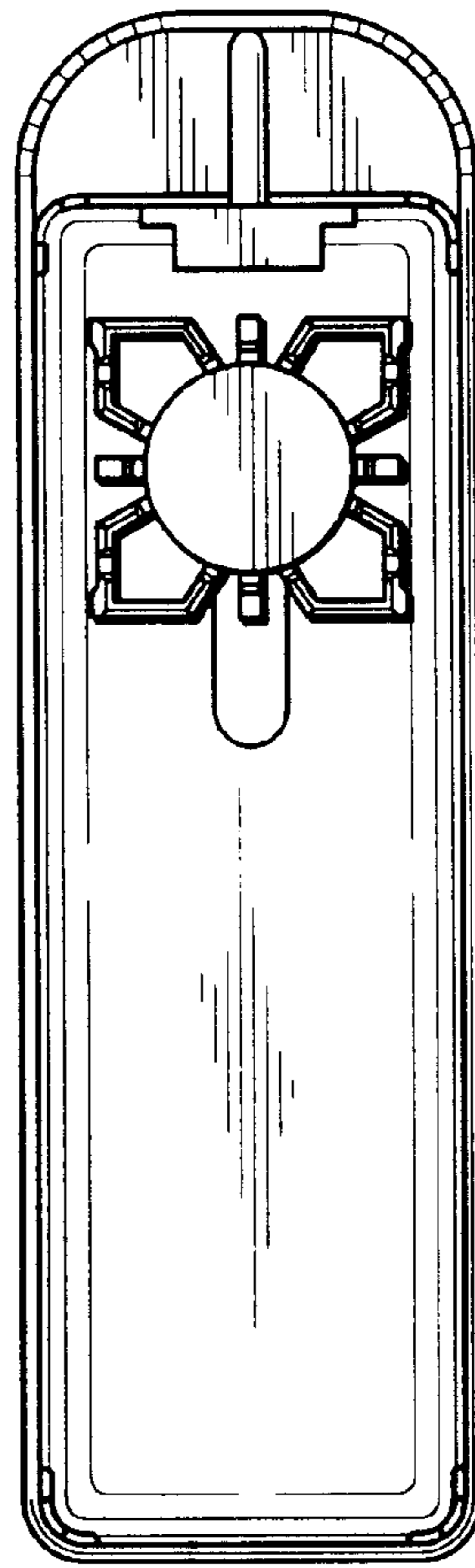

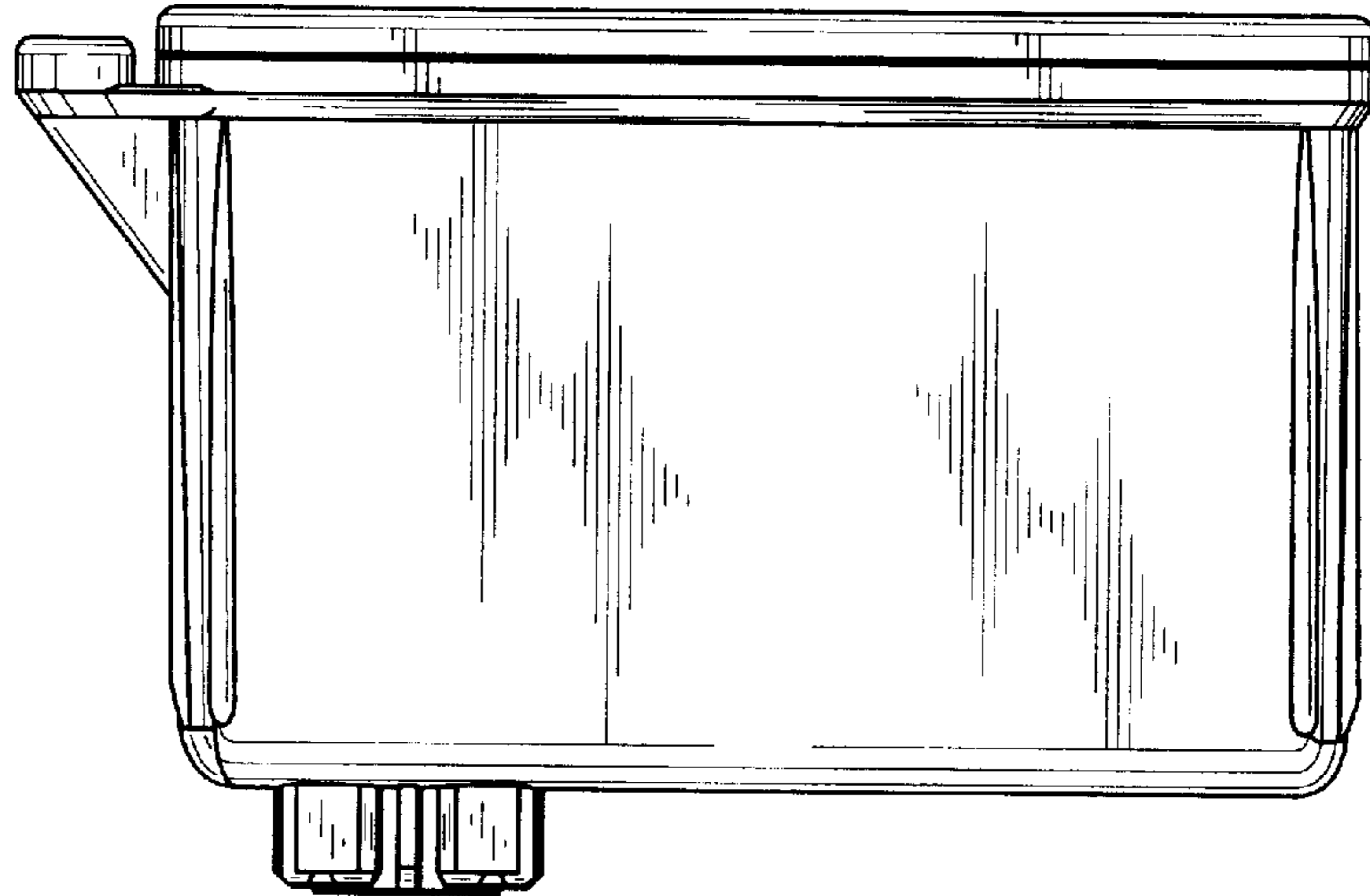
