The ornamental design for a doll, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the doll of the present invention;

FIG. 2 is a left side elevational view of the doll of FIG. 1;

FIG. 3 is a rear elevational view of the doll of FIG. 1;

FIG. 4 is a top plan view of the doll of FIG. 1;

FIG. 5 is a bottom plan view of the doll of FIG. 1;

FIG. 6 is a right side view of the doll of FIG. 1; and,

FIG. 7 is a front elevational view of the doll of FIG. 1 in an alternate position and with the wrist band shown on the opposite wrist.

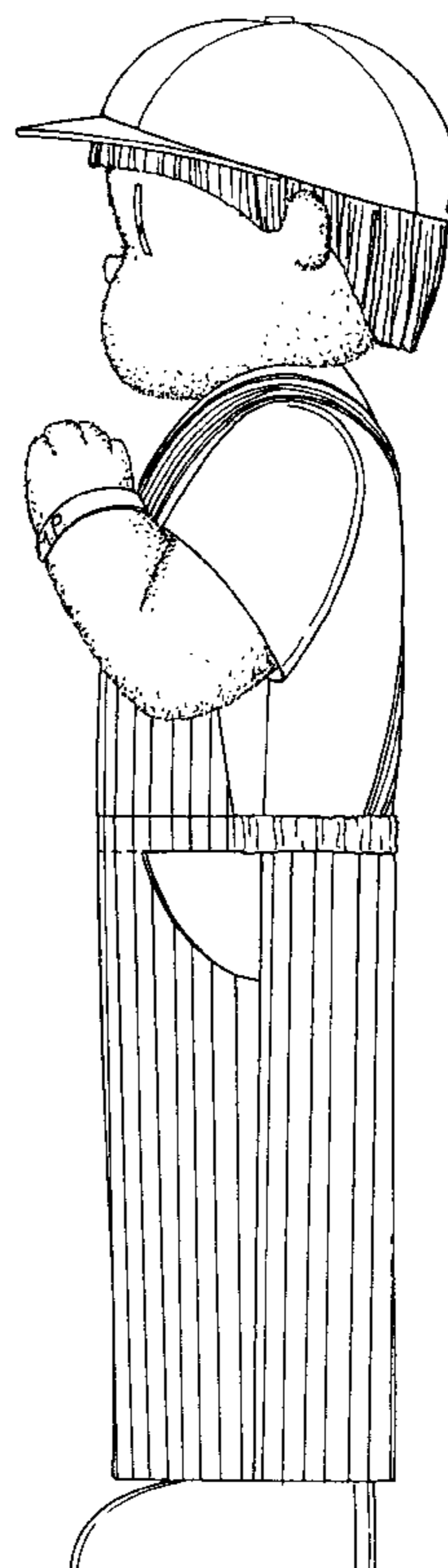
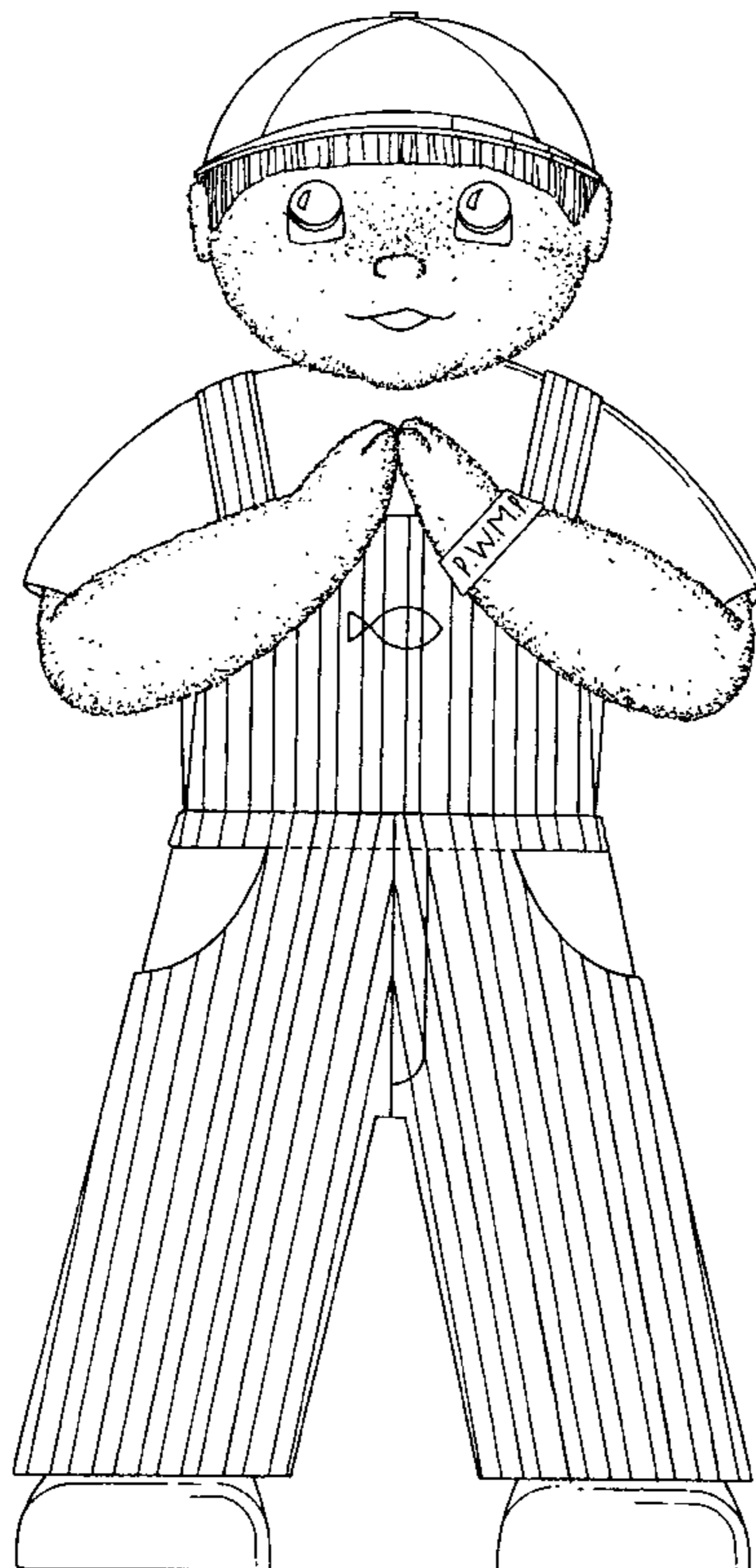

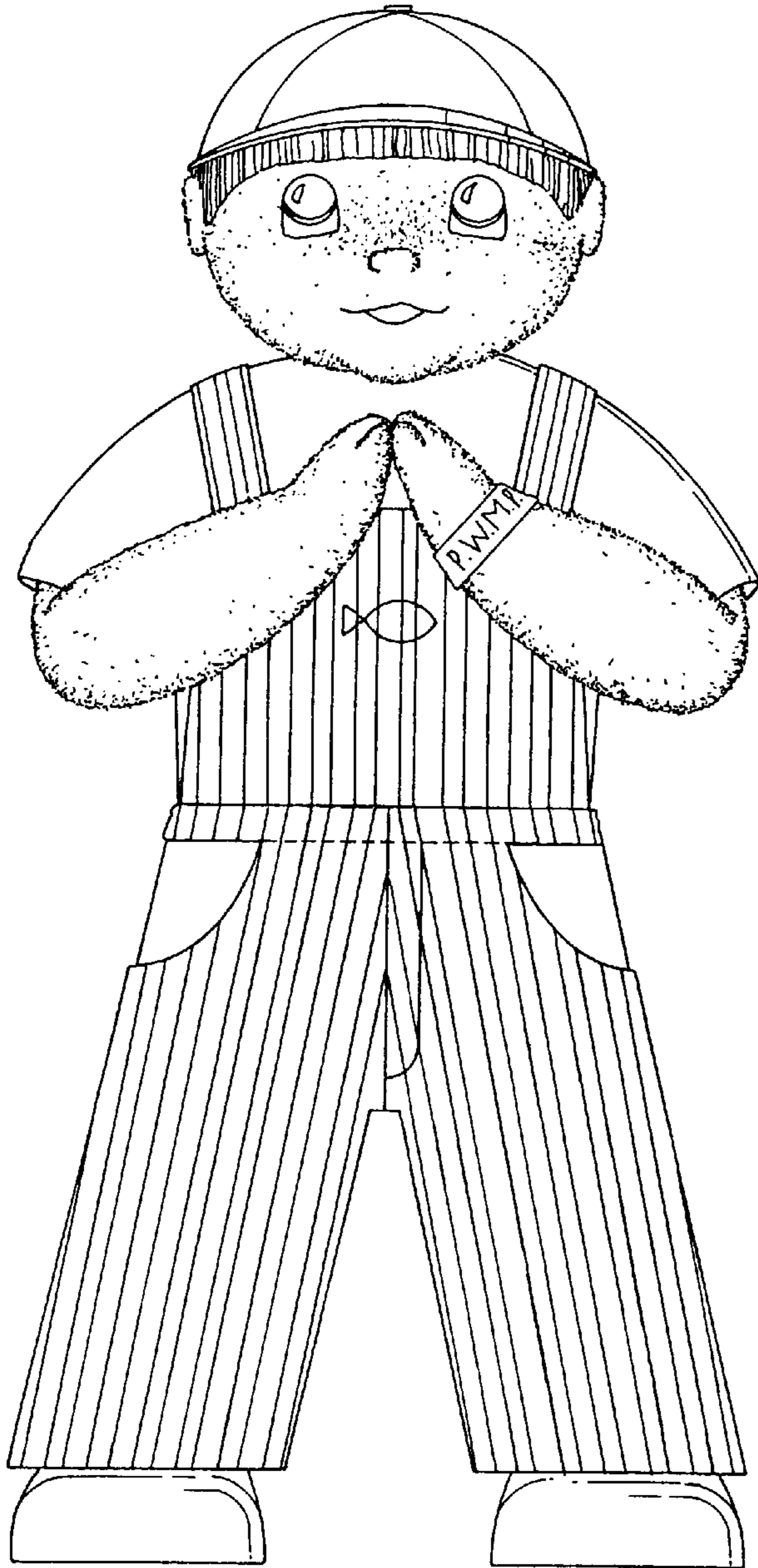

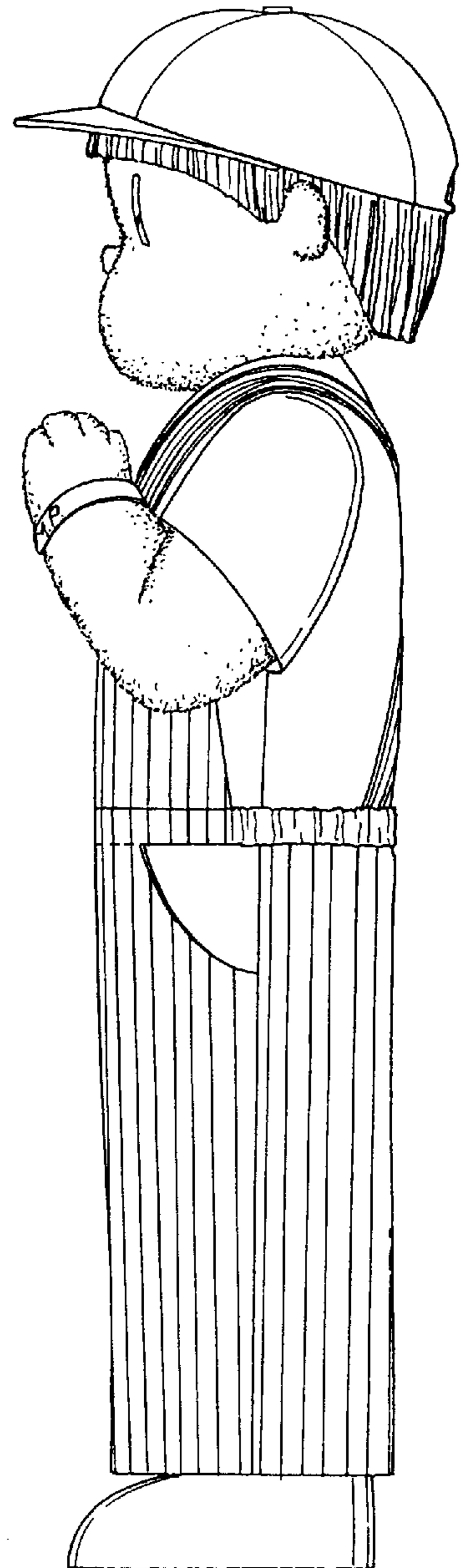

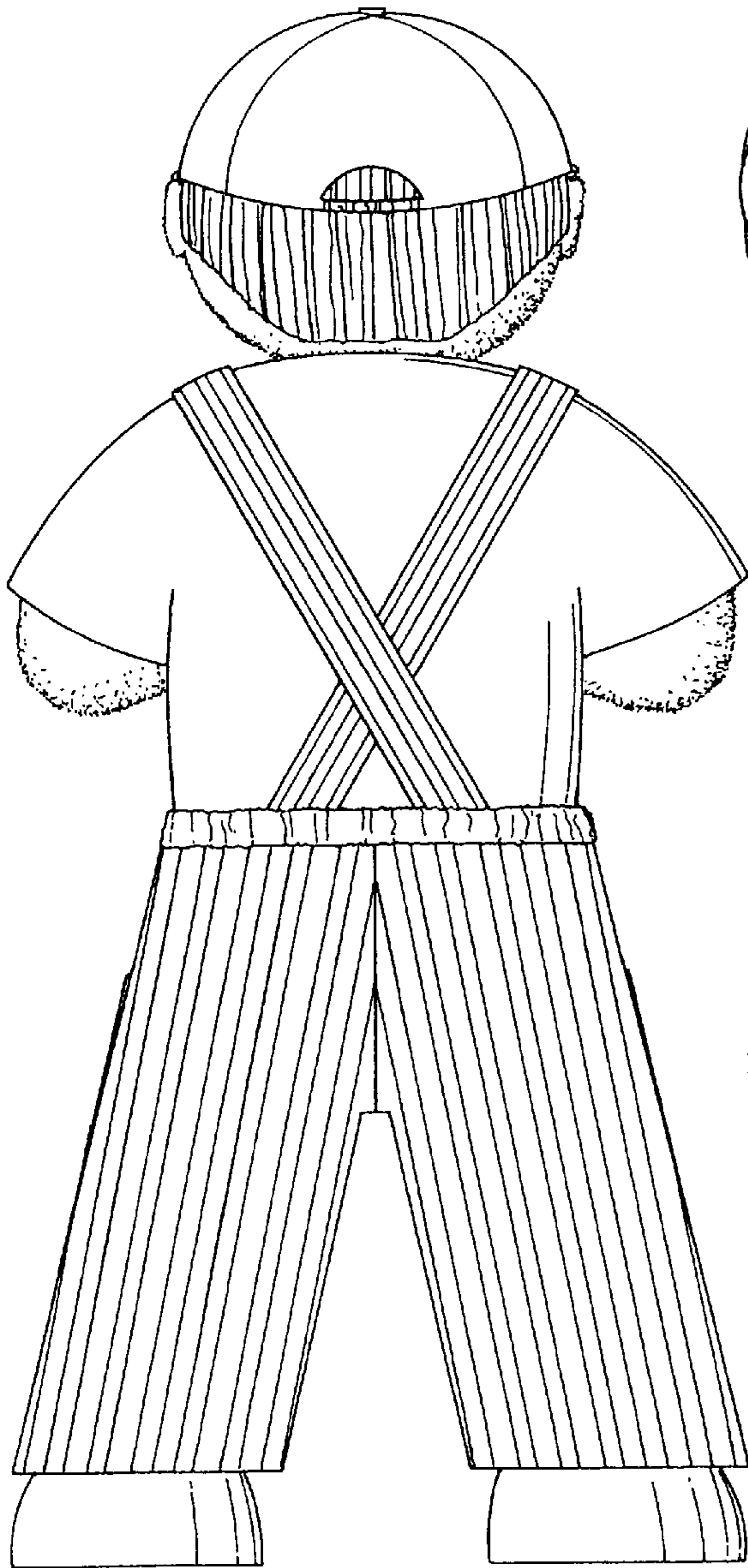

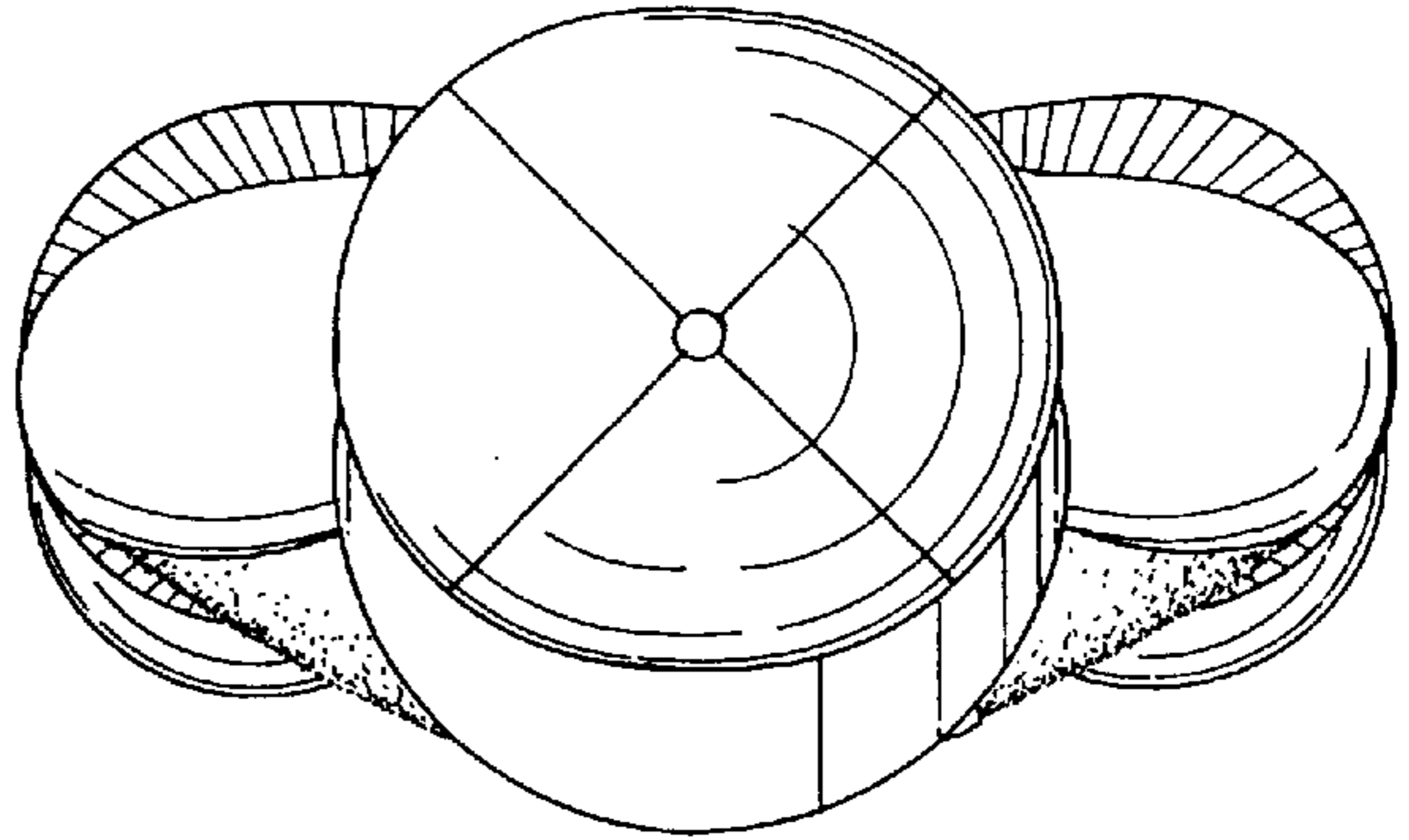

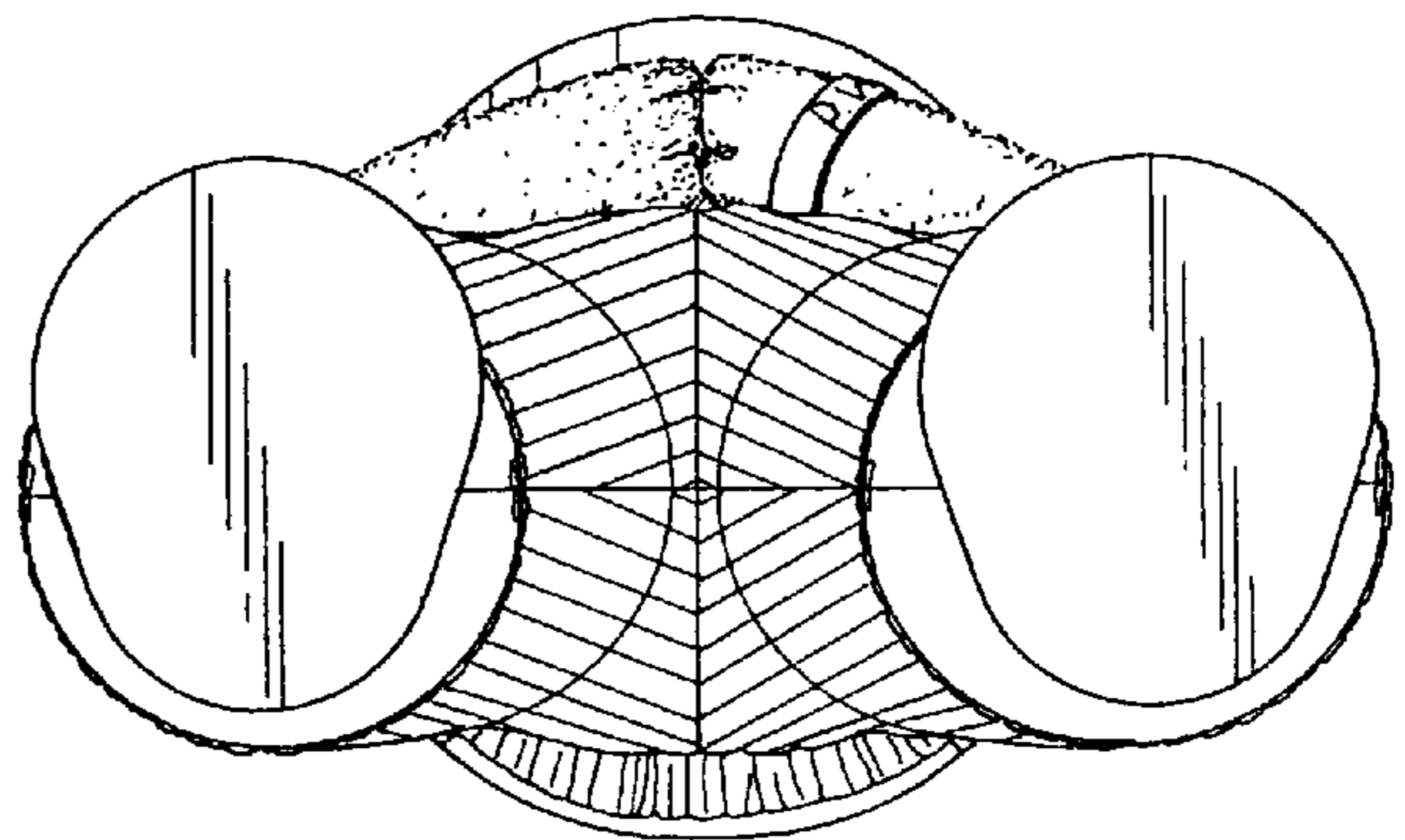

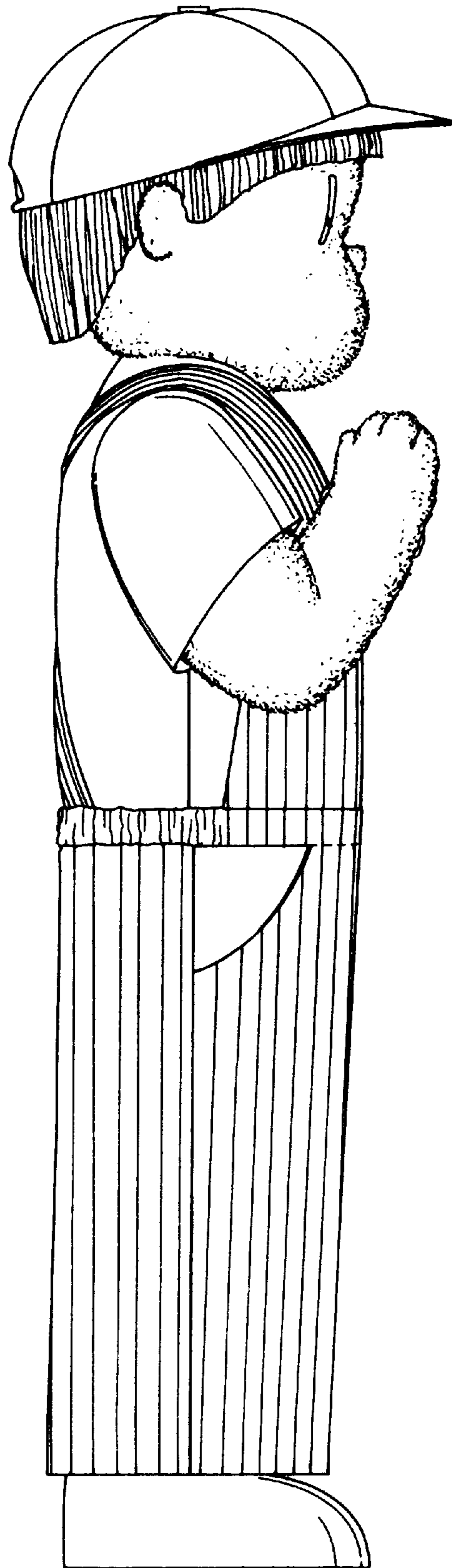
