**DESCRIPTION**

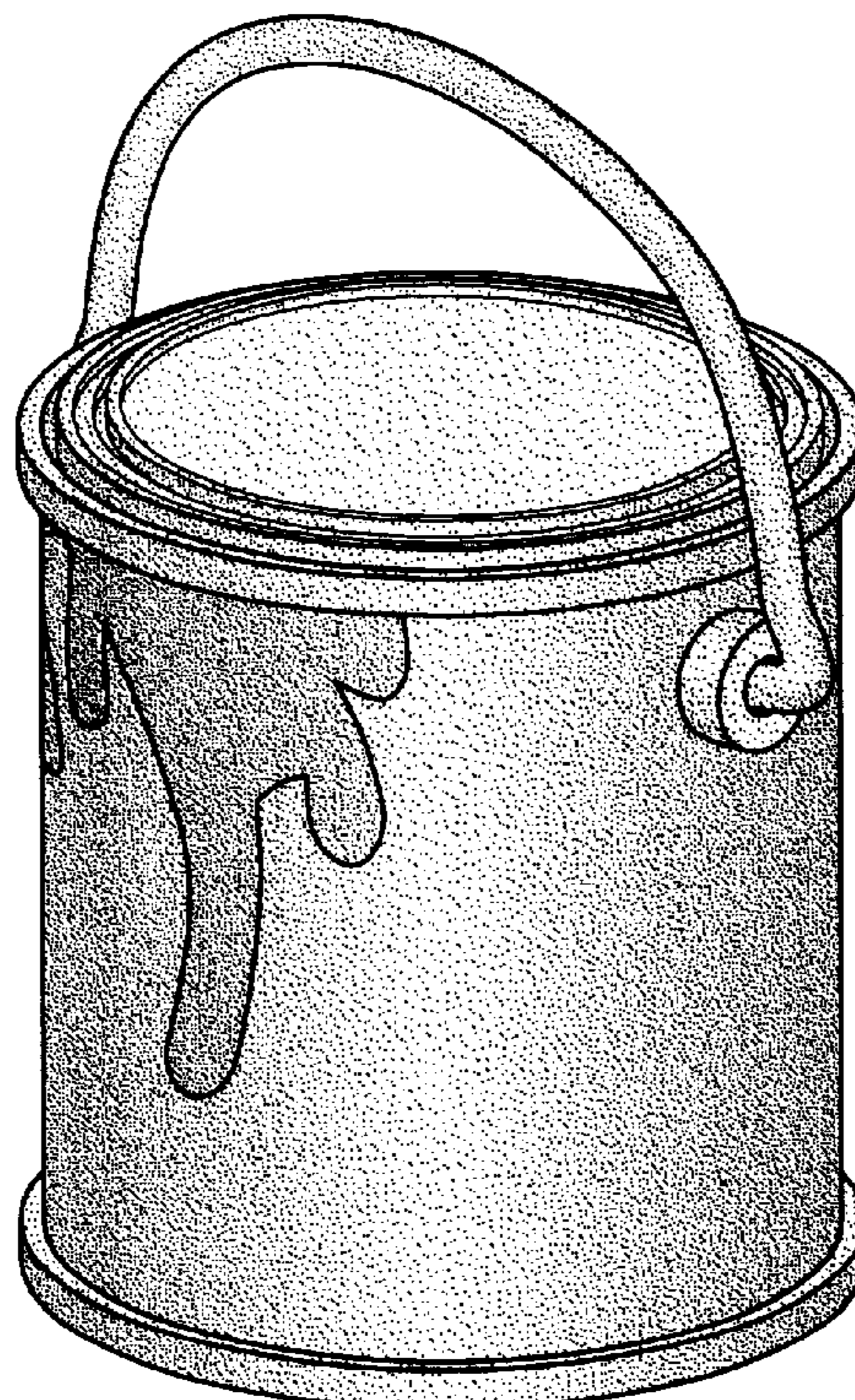
FIG. 1 is a perspective view of my cosmetics container;

FIG. 7 is a bottom plan view of FIG. 1.

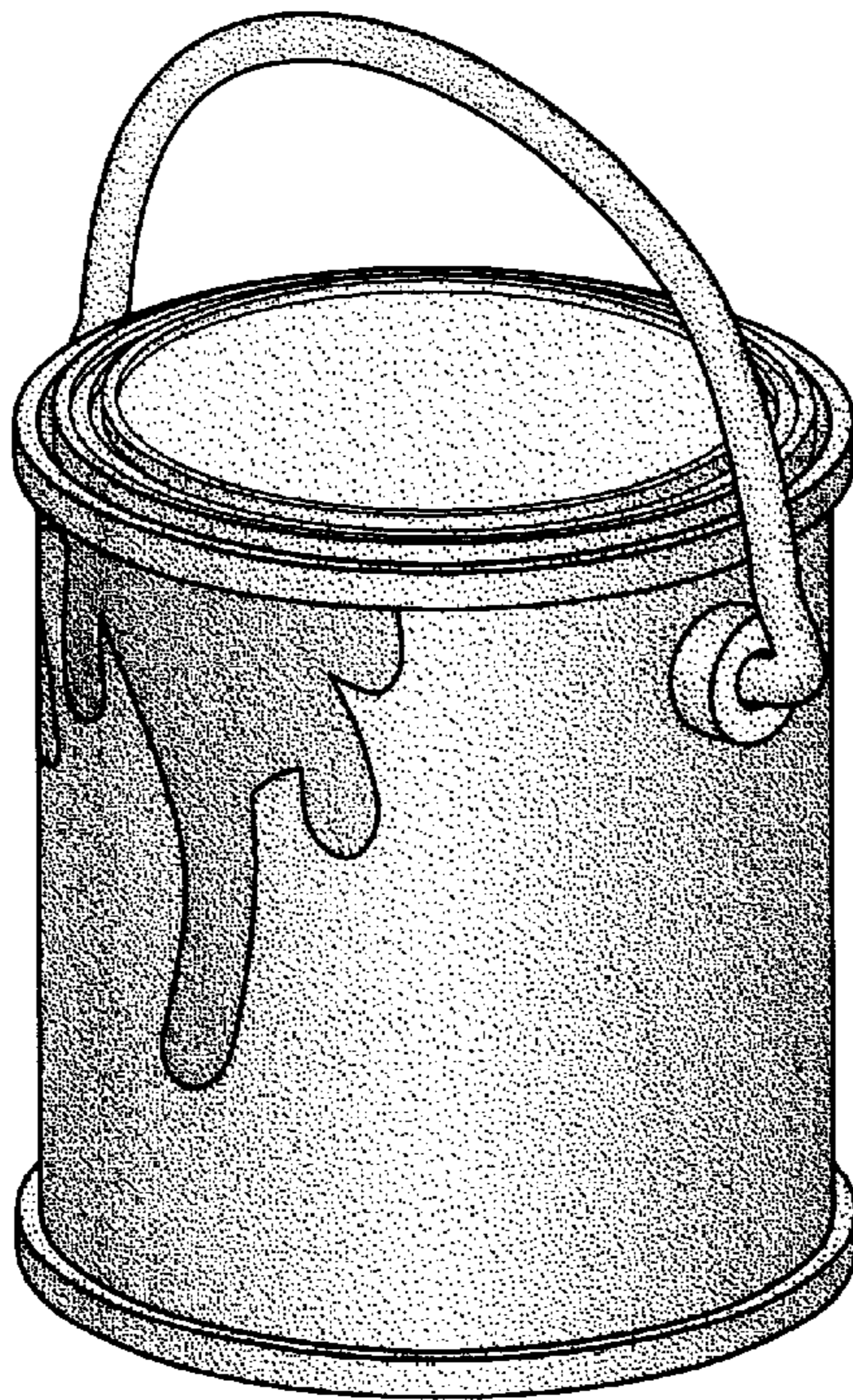

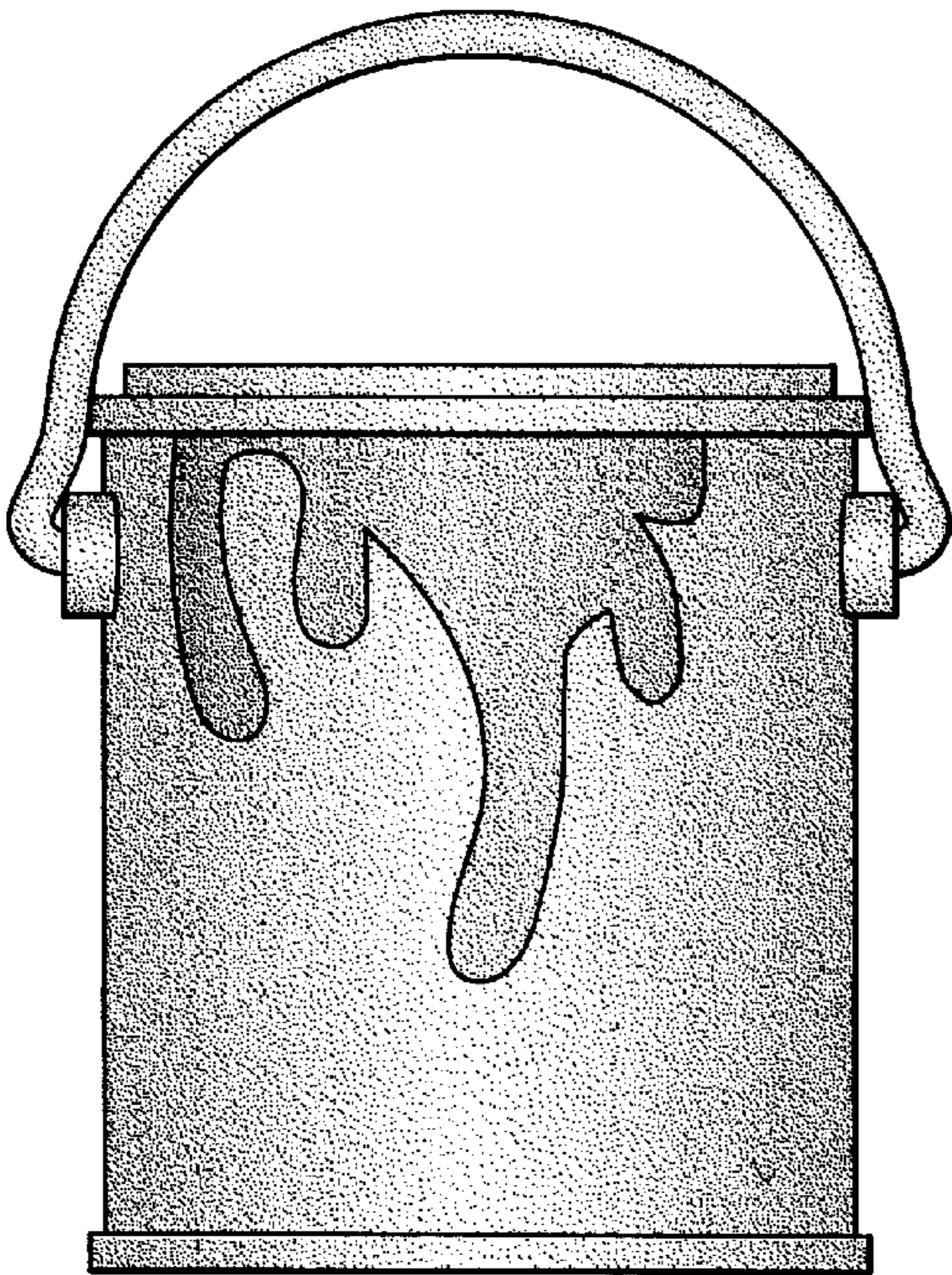

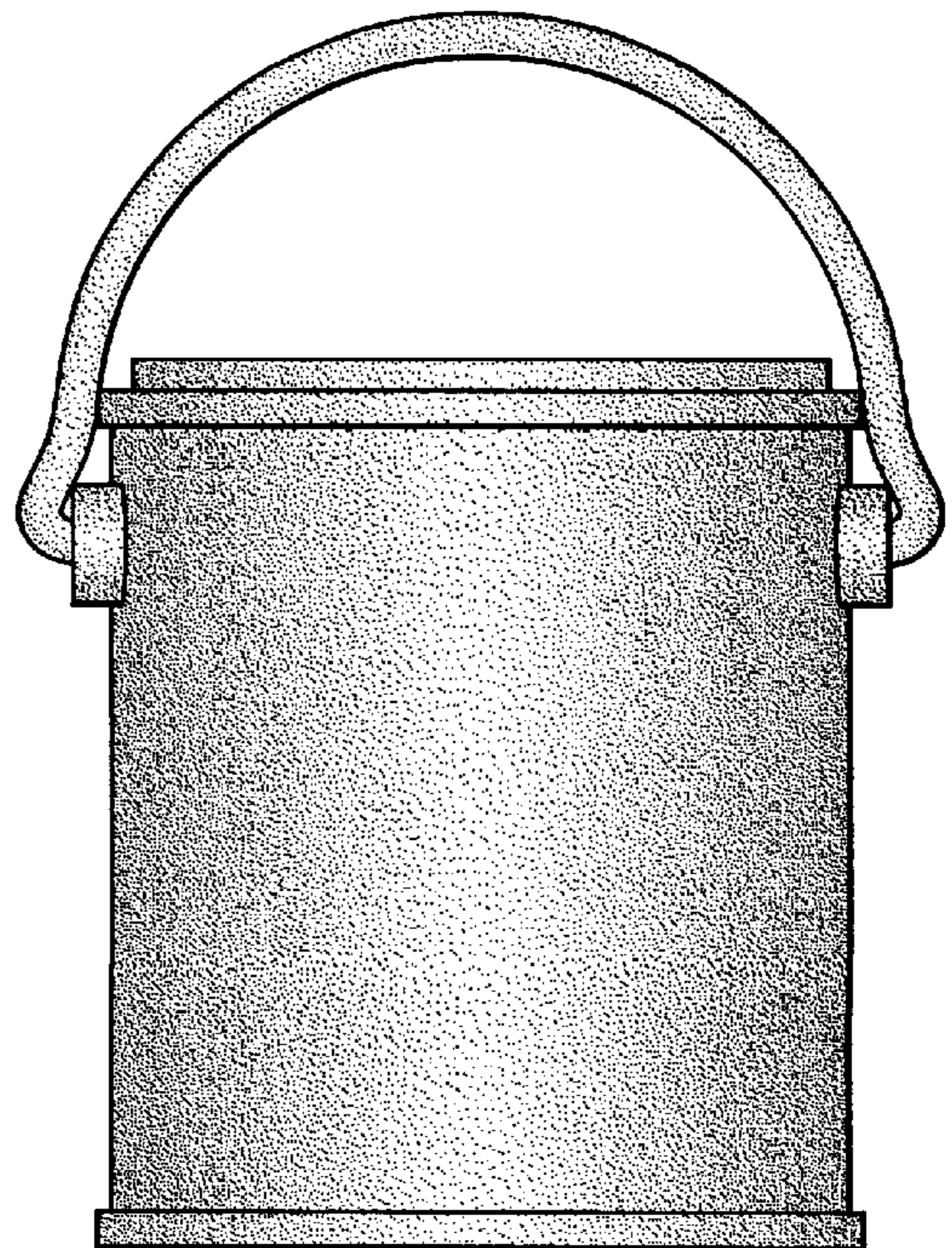




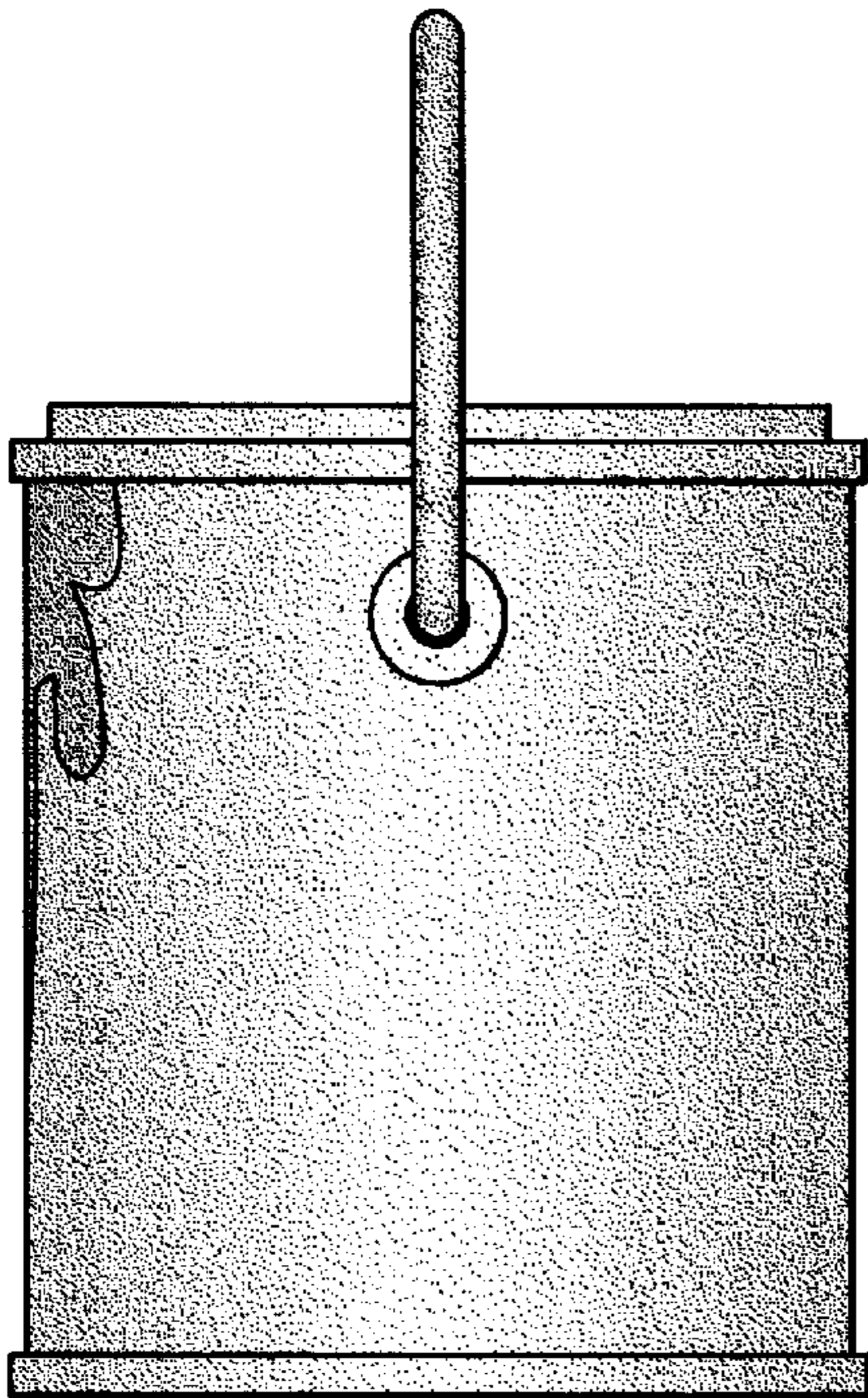

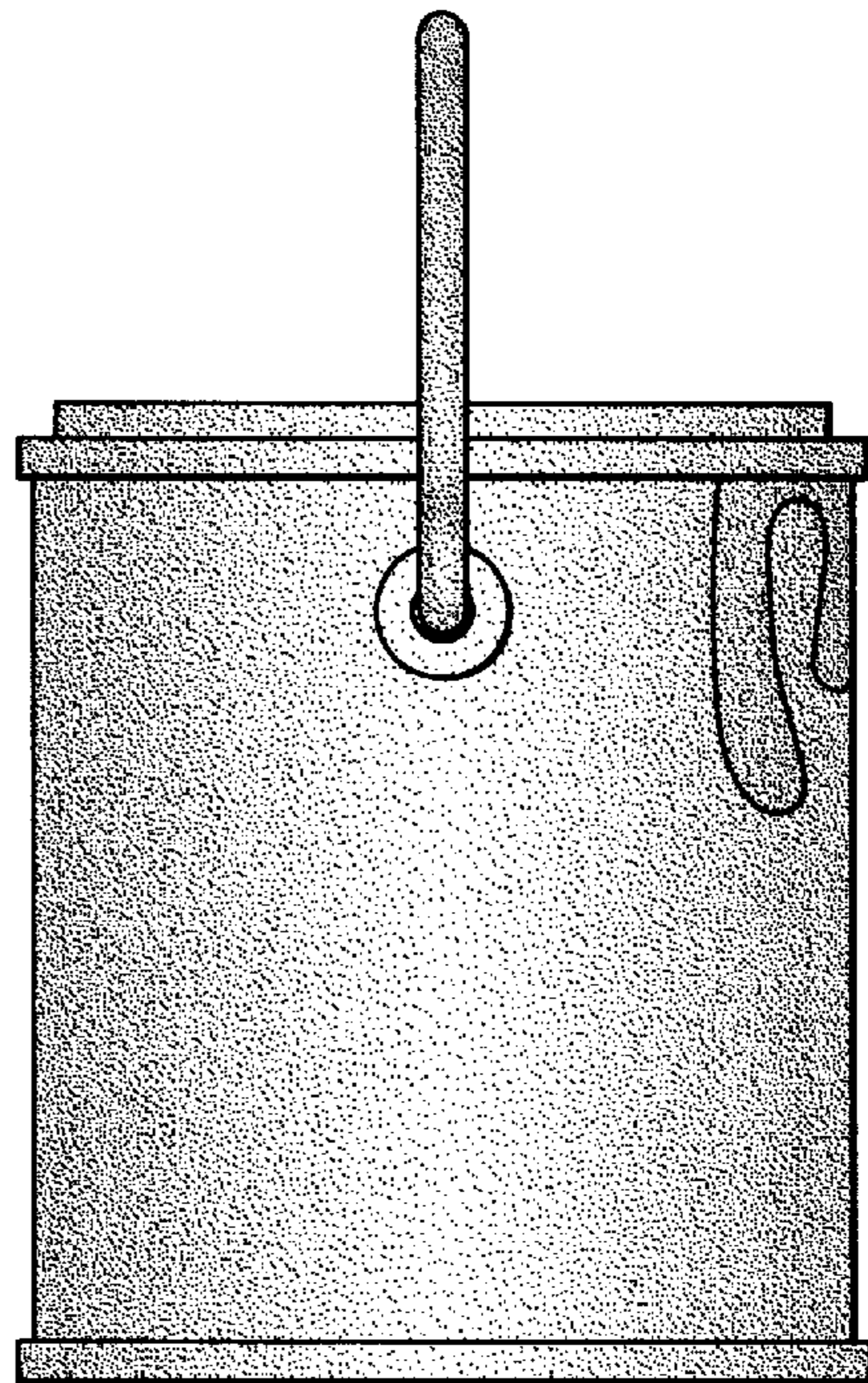

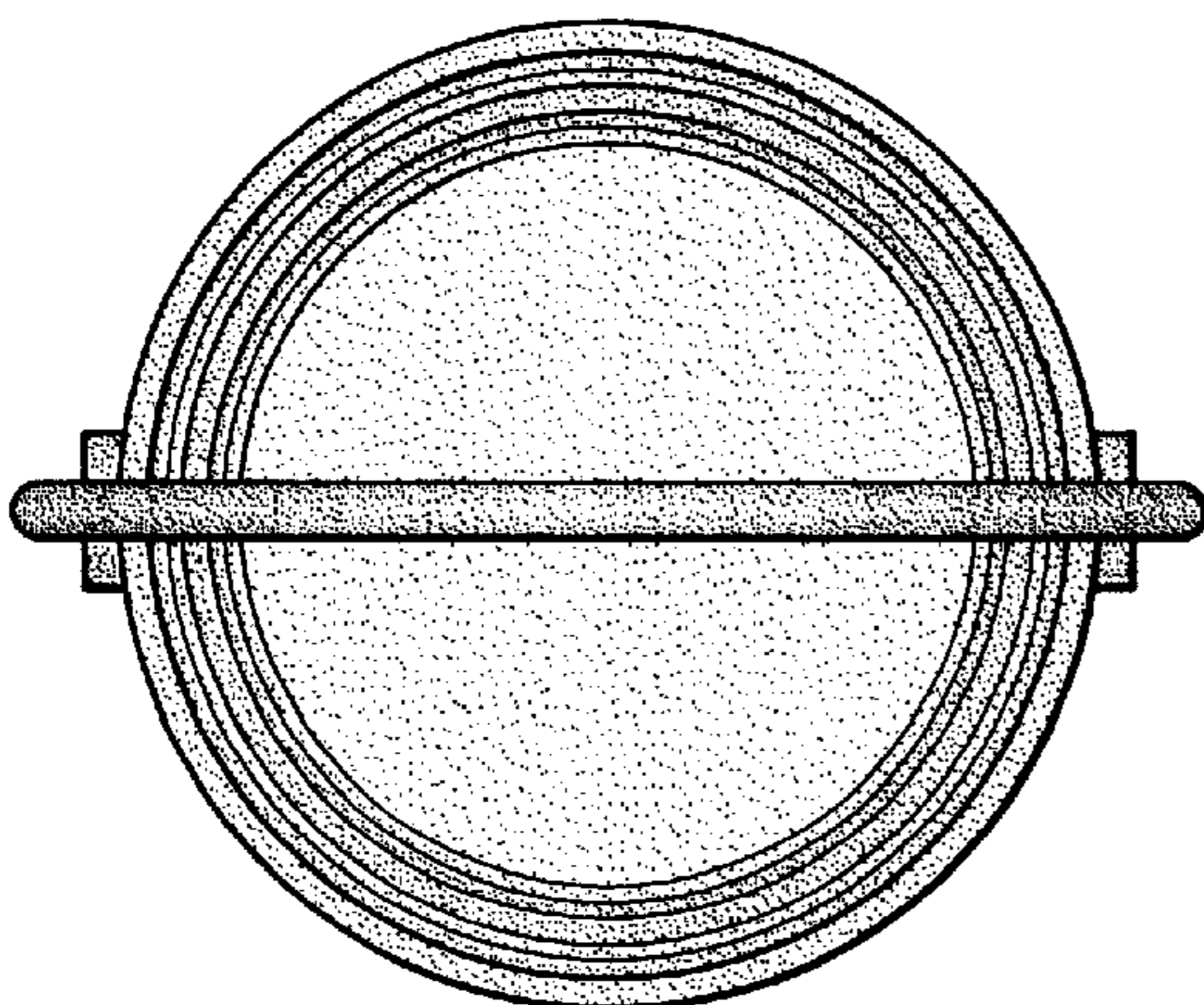

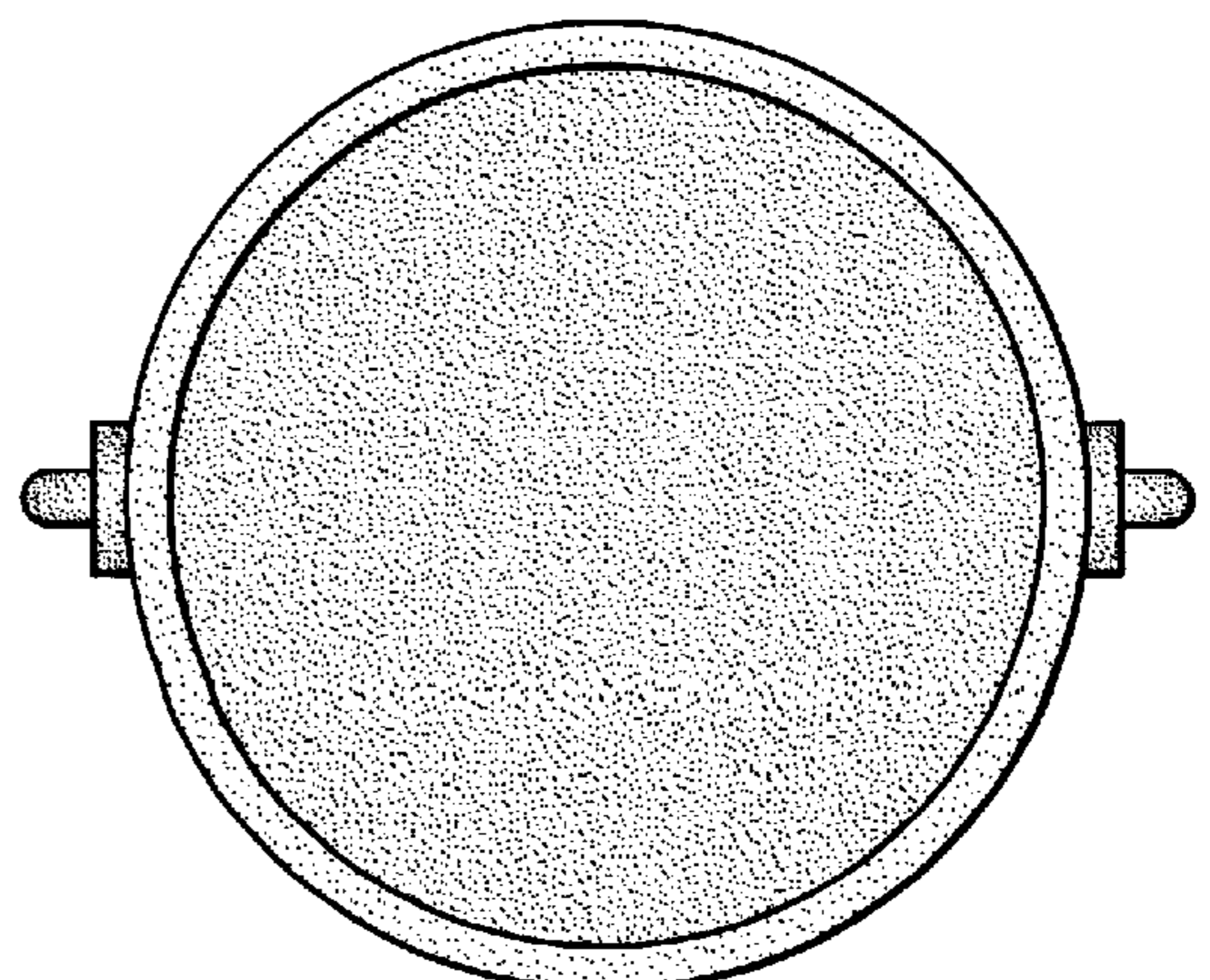
