(57) **CLAIM**

The ornamental design for an urn, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the urn of the present invention;

FIG. 2 is a front elevation of the urn;

FIG. 3 is a side elevation looking at the urn from the right side of FIG. 2. The opposite side elevation of the urn is the mirror image of FIG. 3.

FIG. 4 is a rear elevation of the urn;

FIG. 5 is a top plan view of the urn;

FIG. 6 is a bottom plan view of the urn;

FIG. 7 is a perspective view of a second embodiment of the present invention;

FIG. 8 is a front elevational view of the urn;

FIG. 9 is a side elevation looking at the urn from the right side of FIG. 8, the opposite side is a mirror image;

FIG. 10 is a rear elevation of the urn;

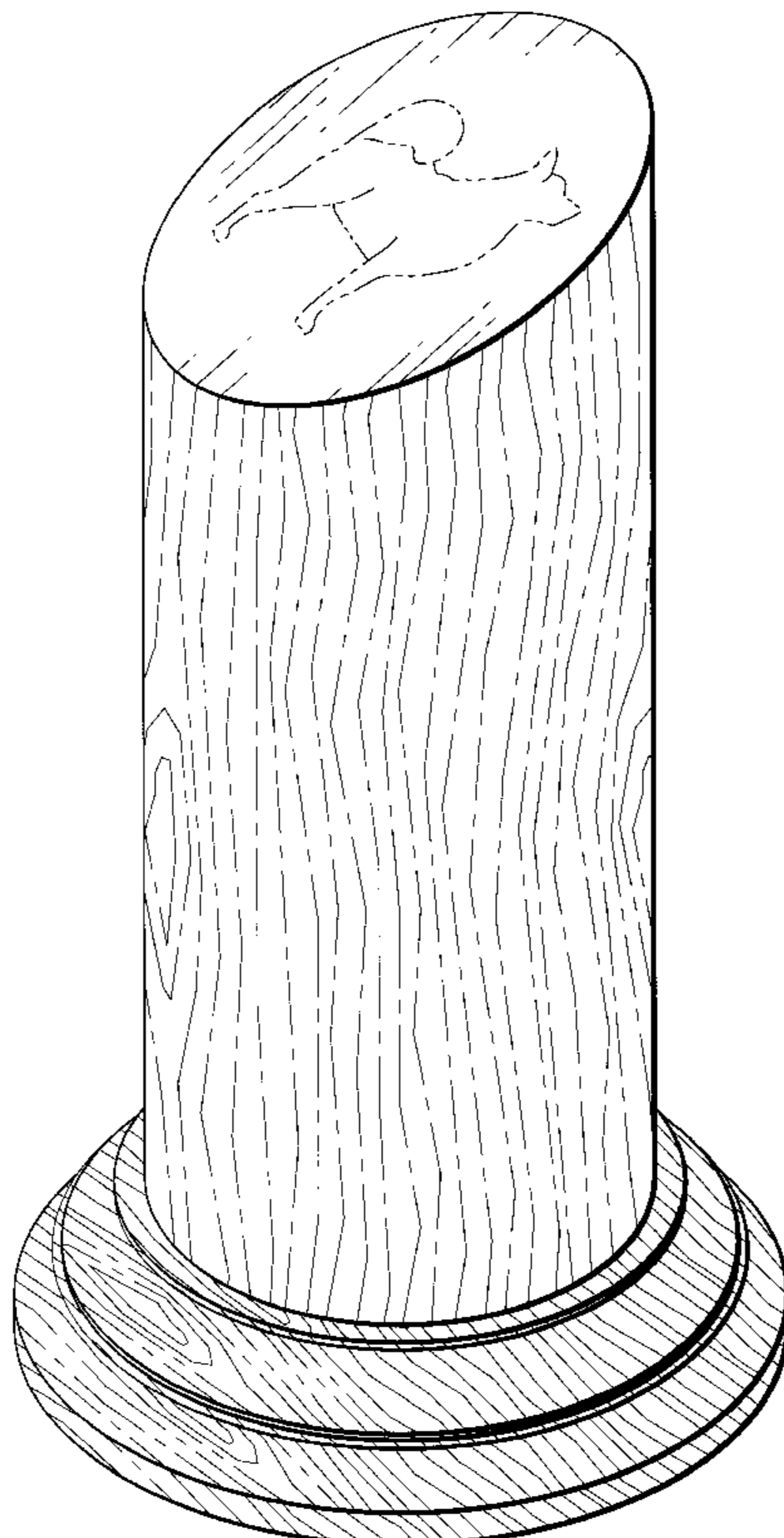
FIG. 11 is a top plan view of the urn; and,

FIG. 12 is a bottom plan view of the urn.

The urn design shown in FIGS. 1–6 as being wood with the bottom attached by screws. However the urn design may also be made of natural stone with the bottom glued in place after the ashes are inside as shown in FIGS. 7–12.

The broken line showing of the dog in FIGS. 1,2,5,7,8, and 11 is for illustrative purposes only and forms no part of the claimed design.

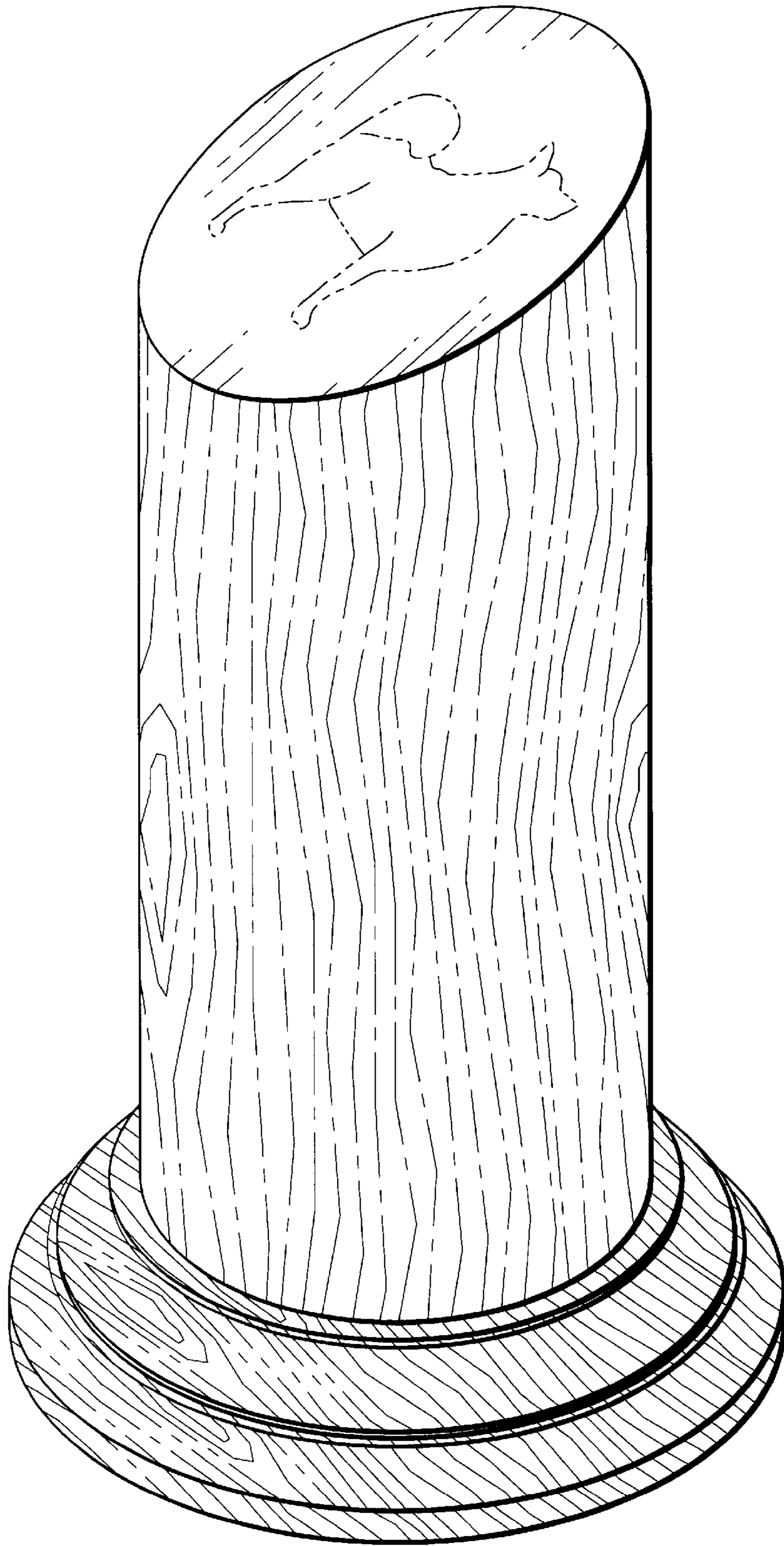

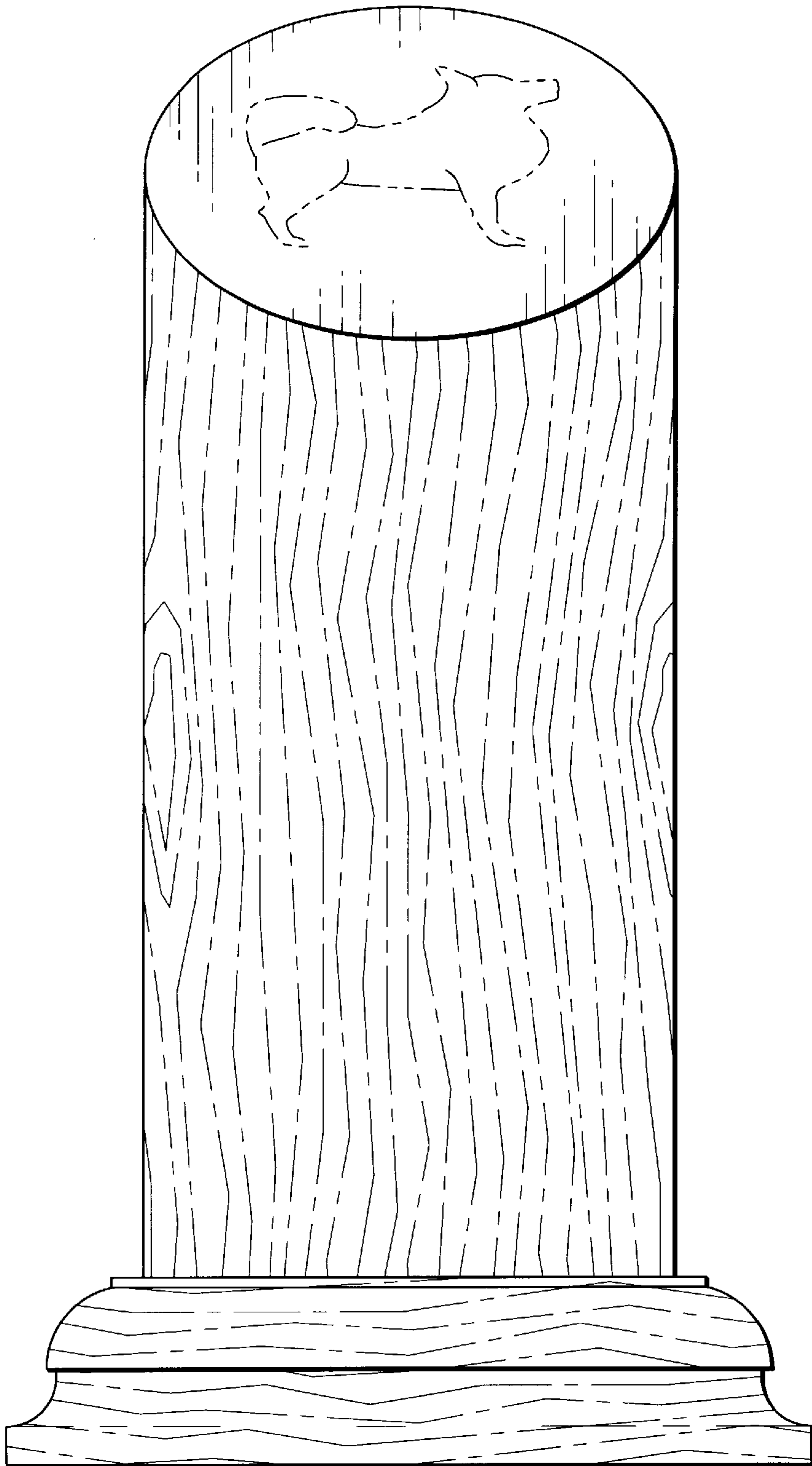

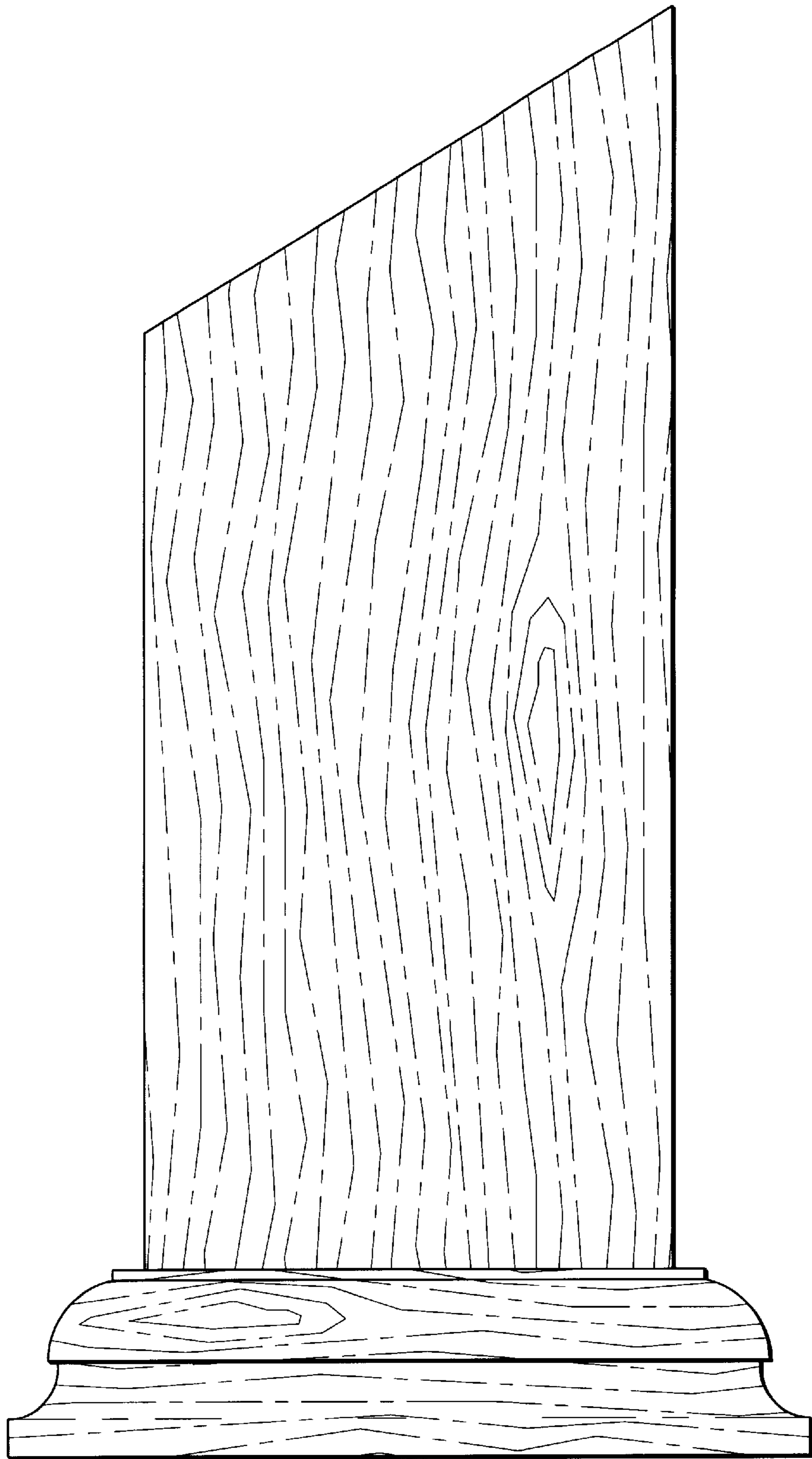

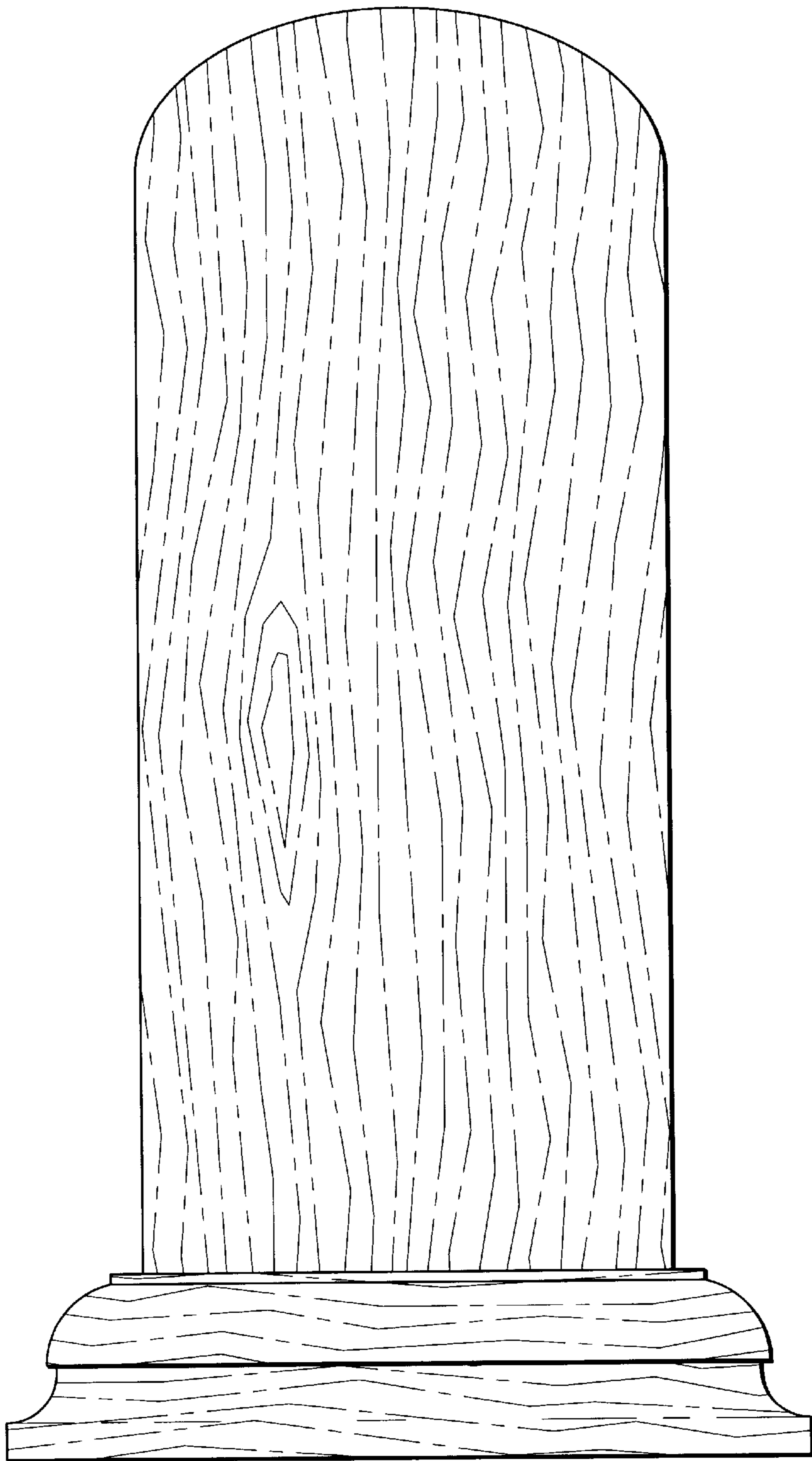

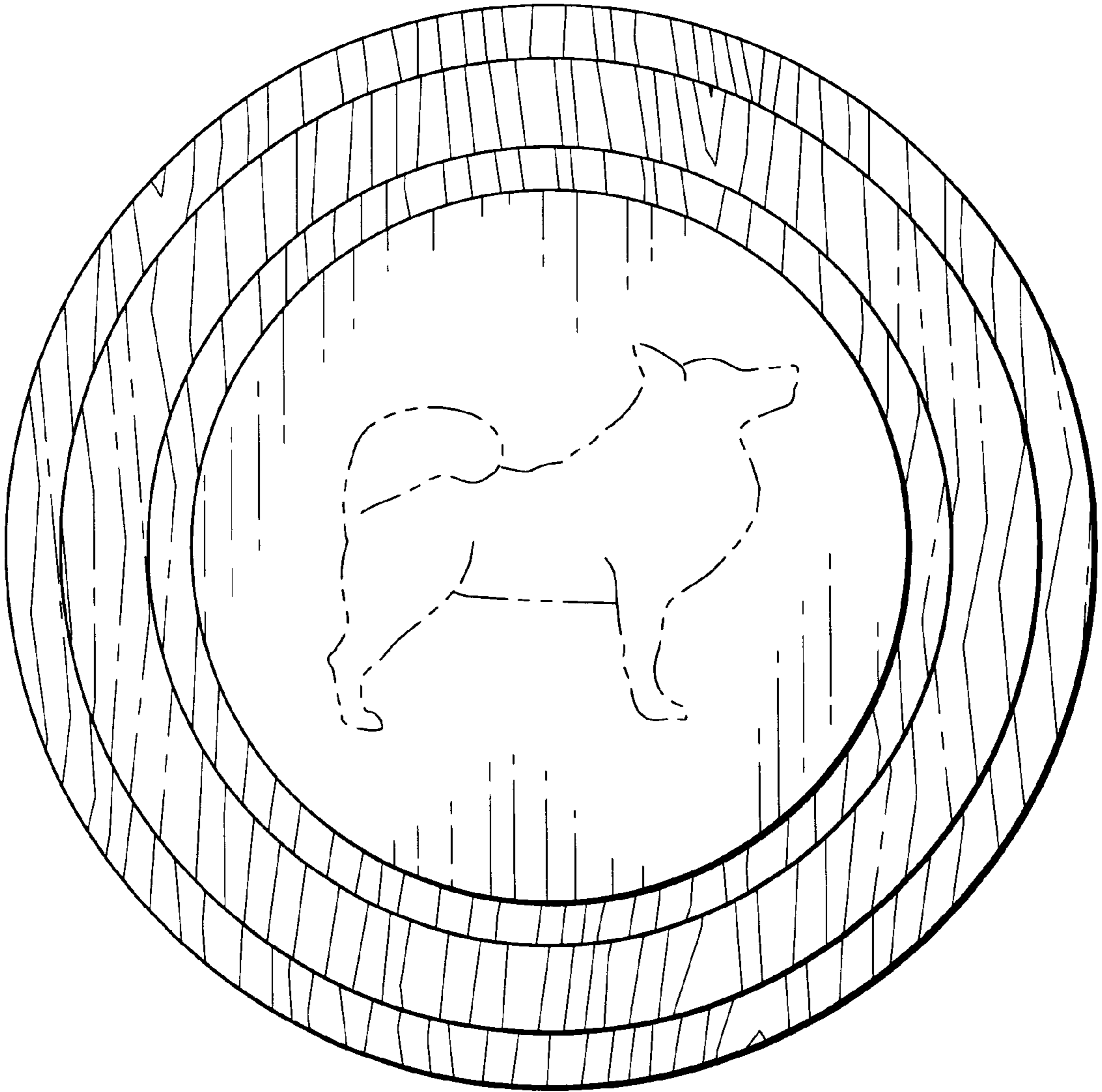

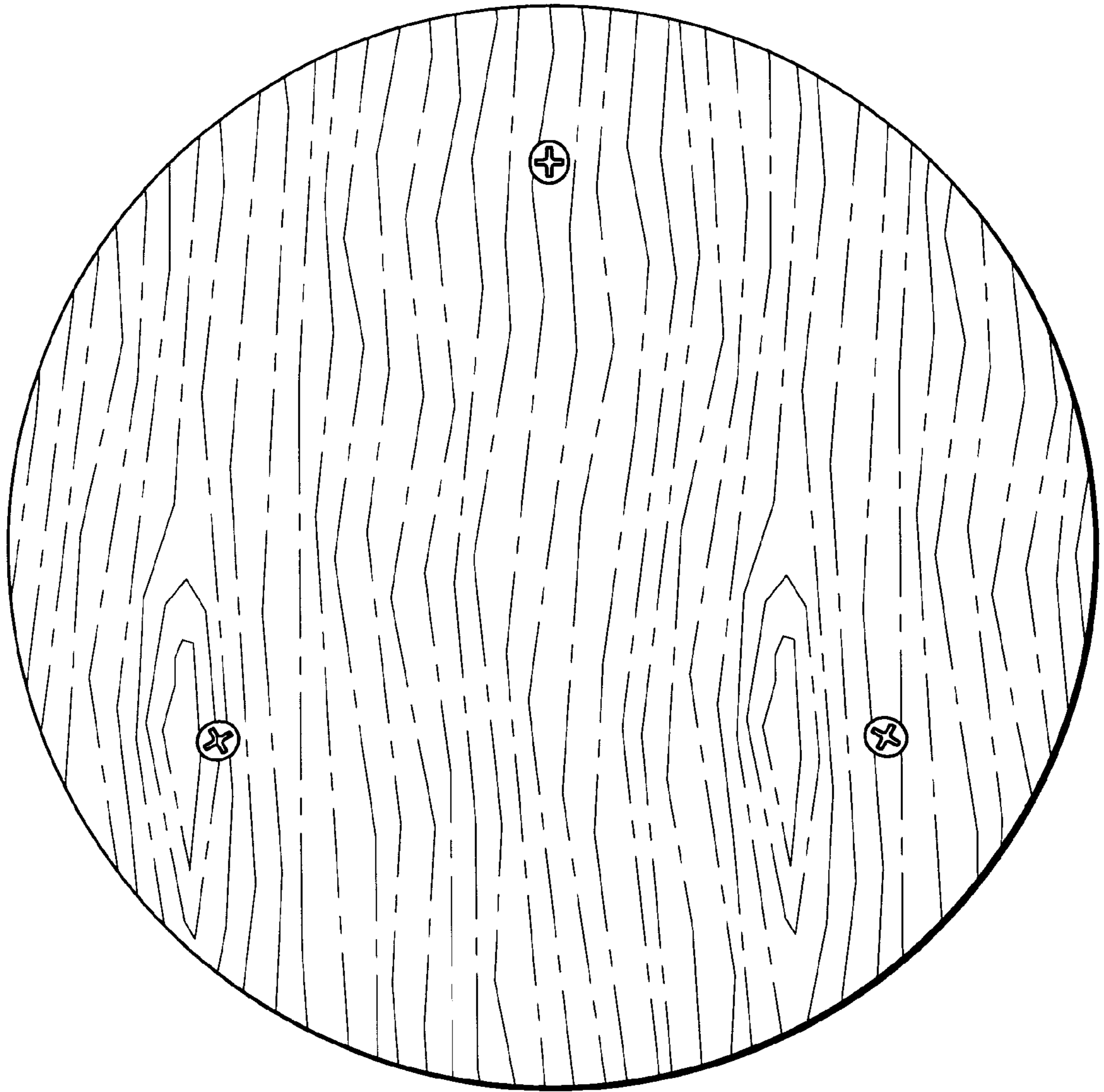

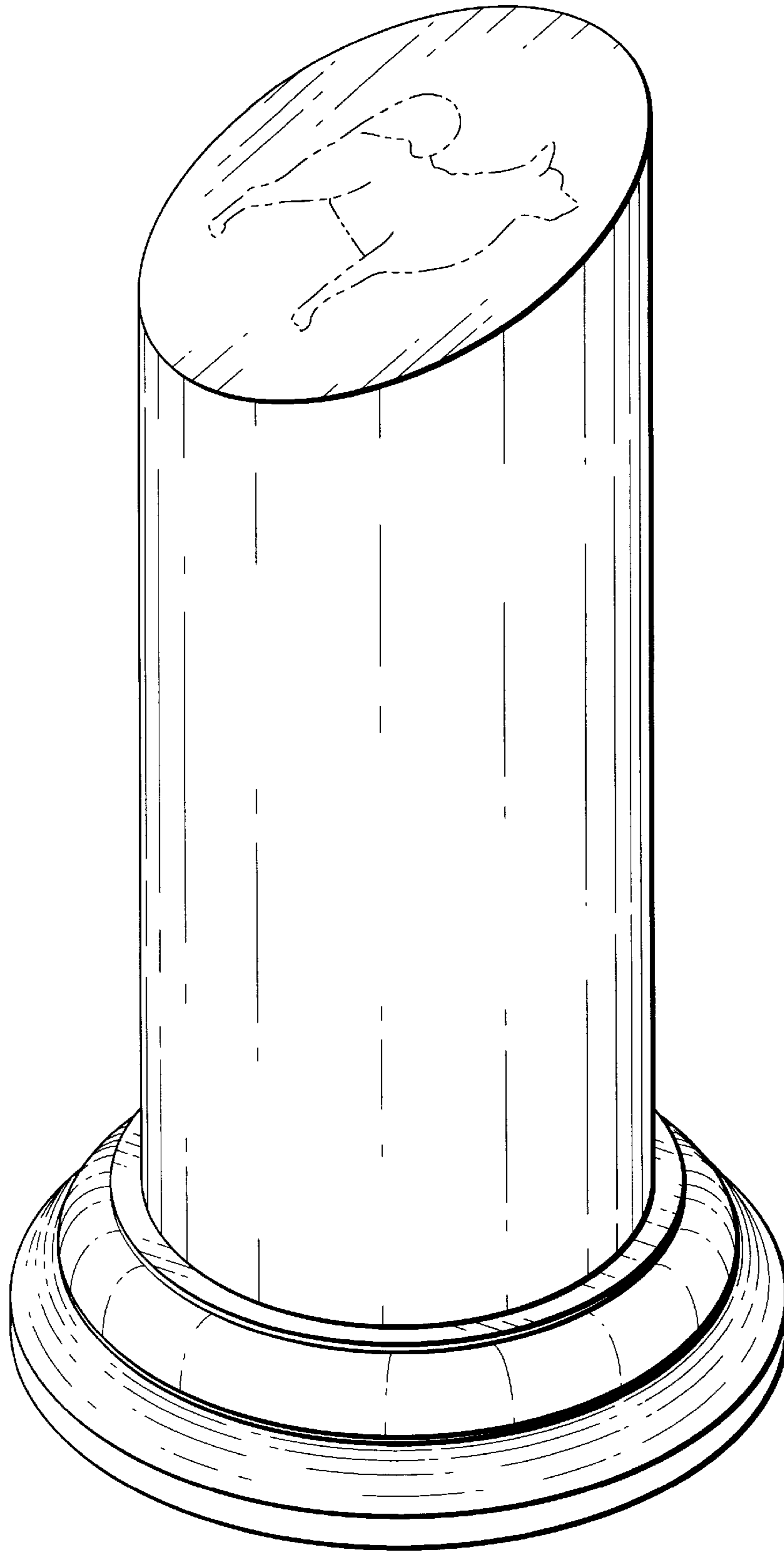

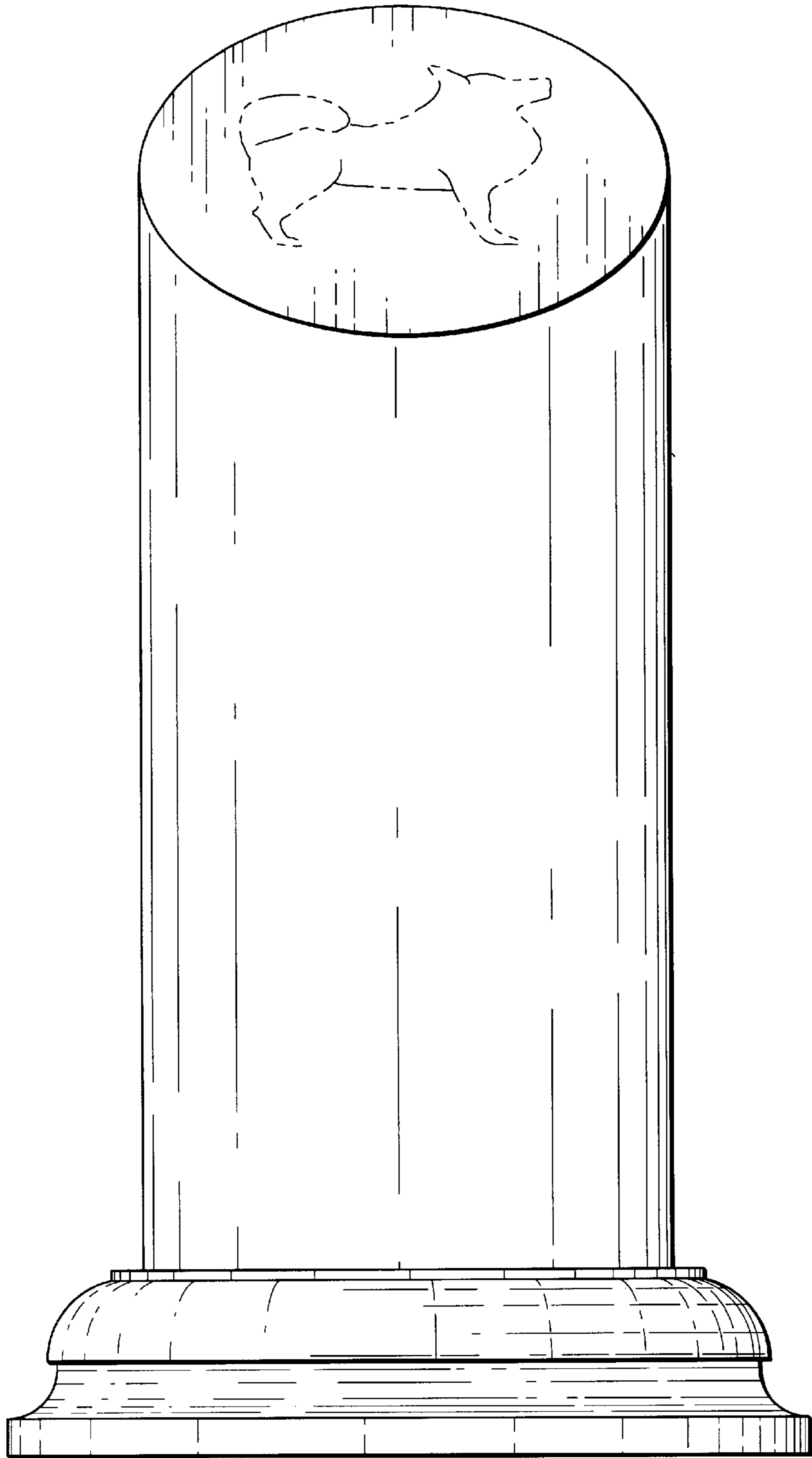

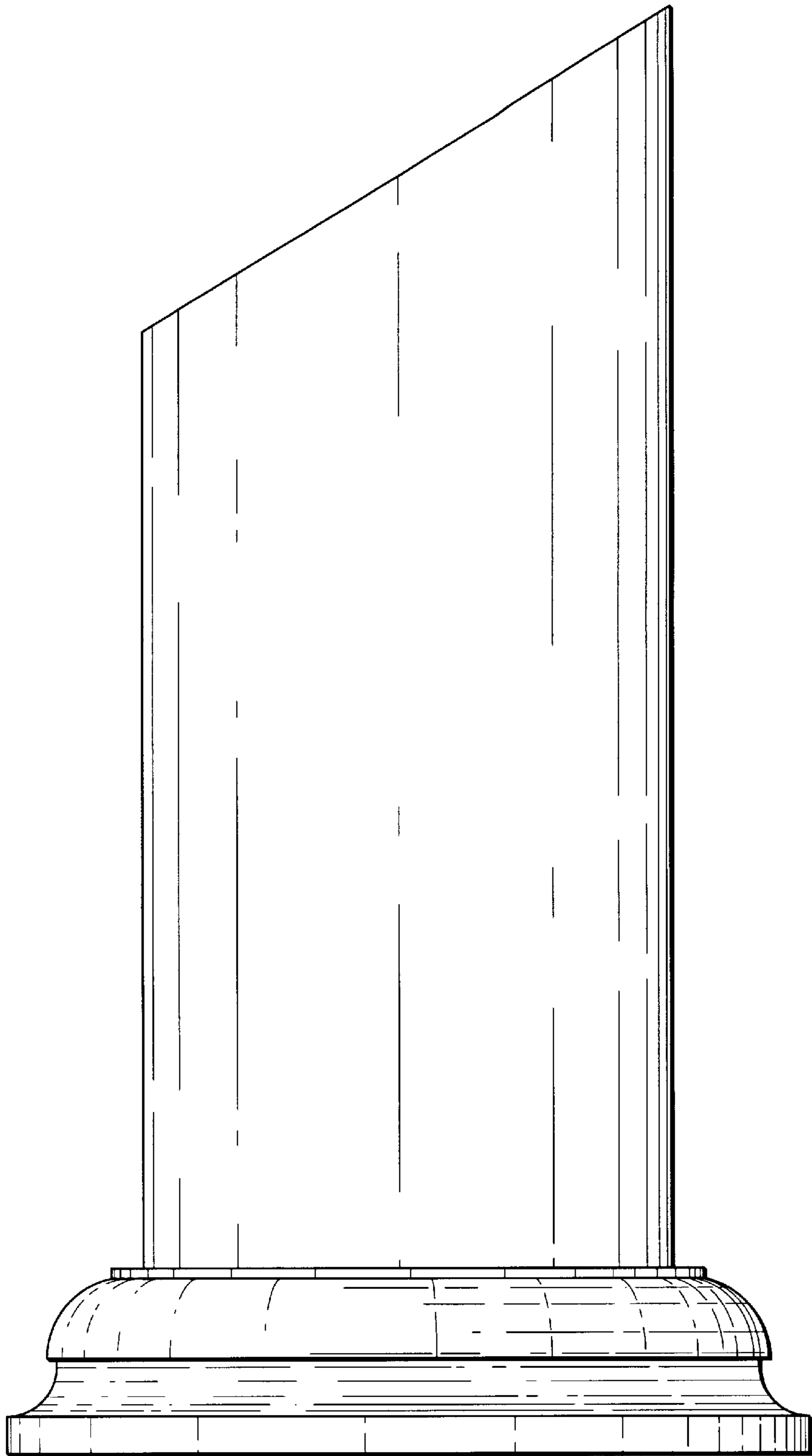

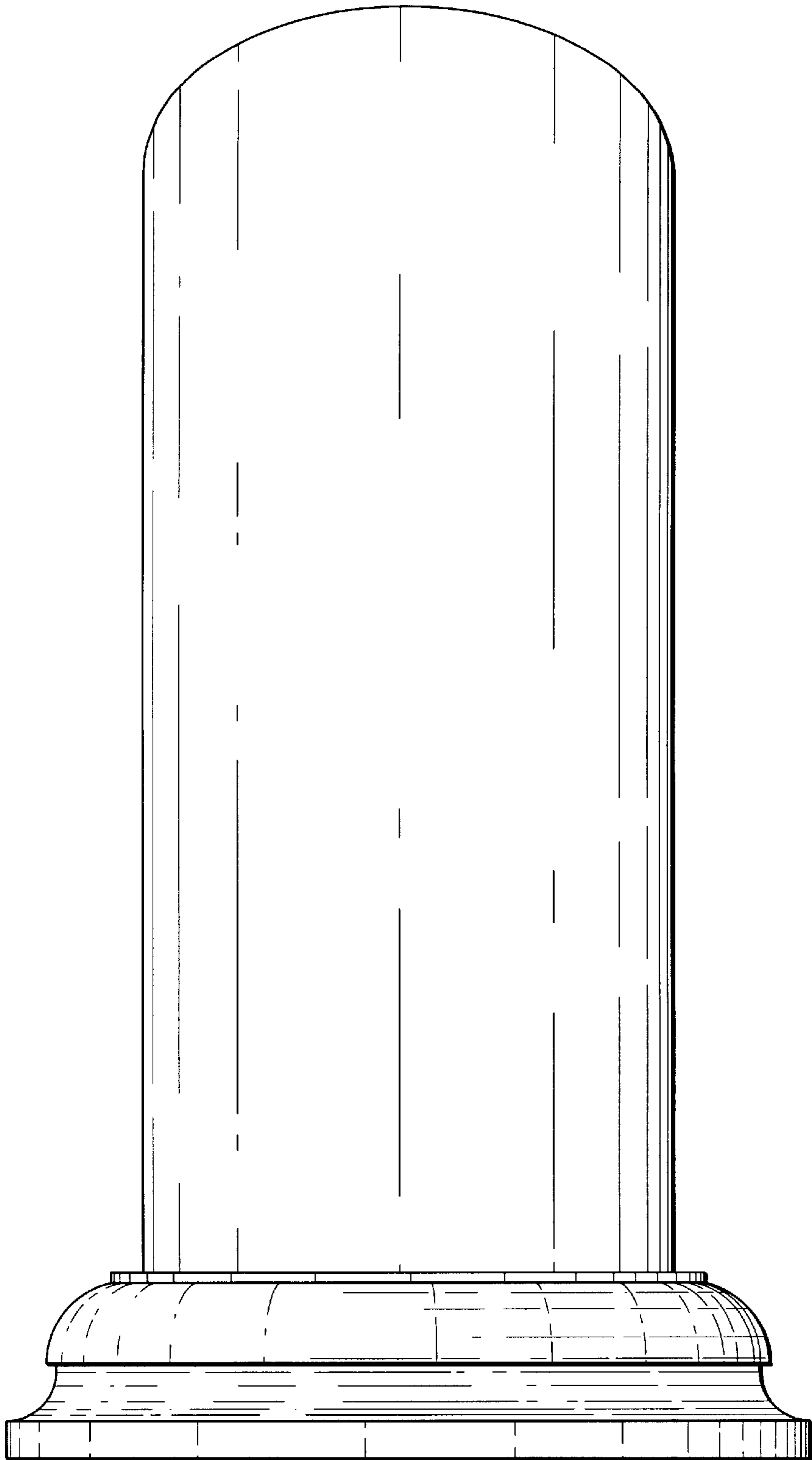

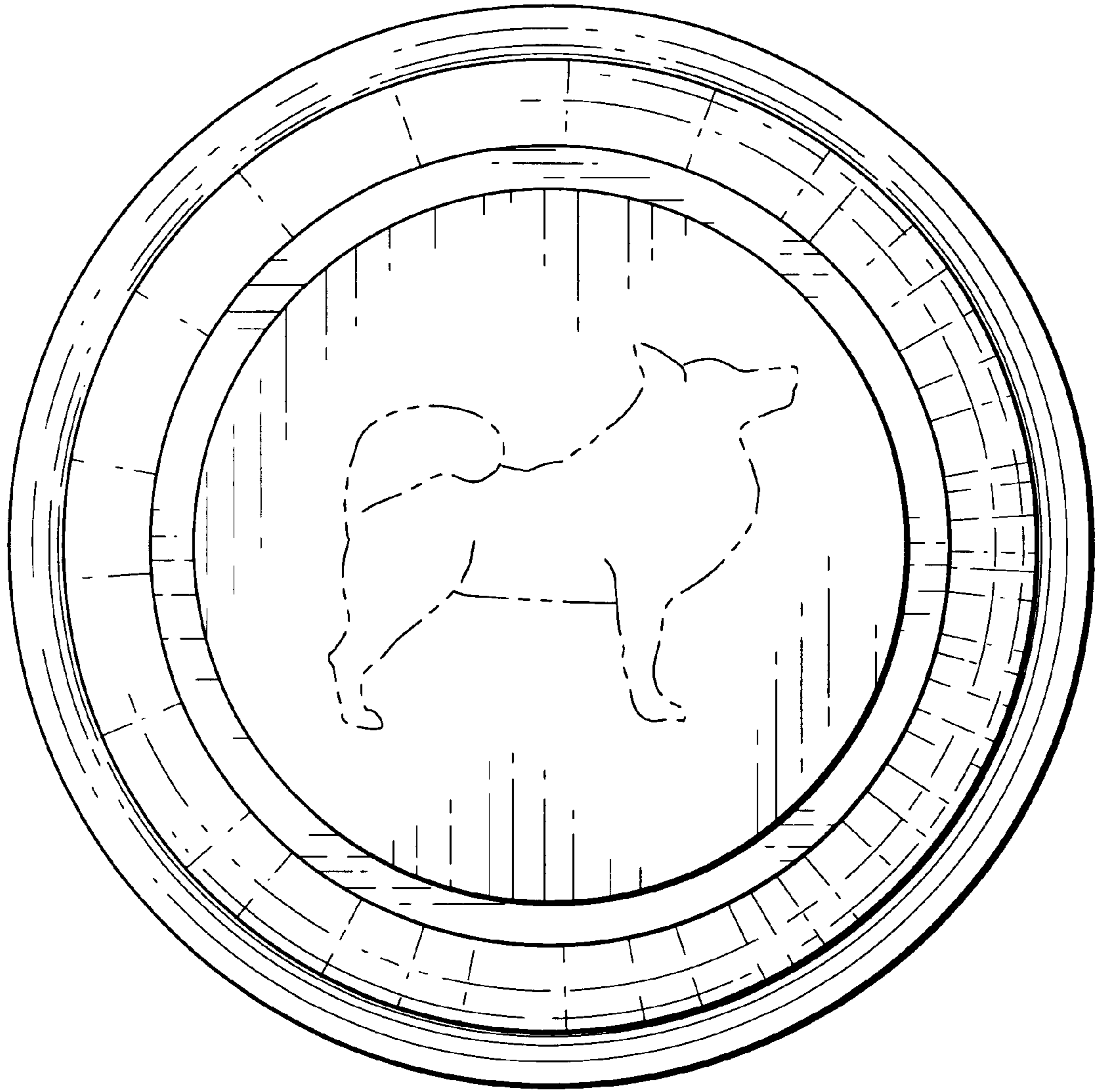

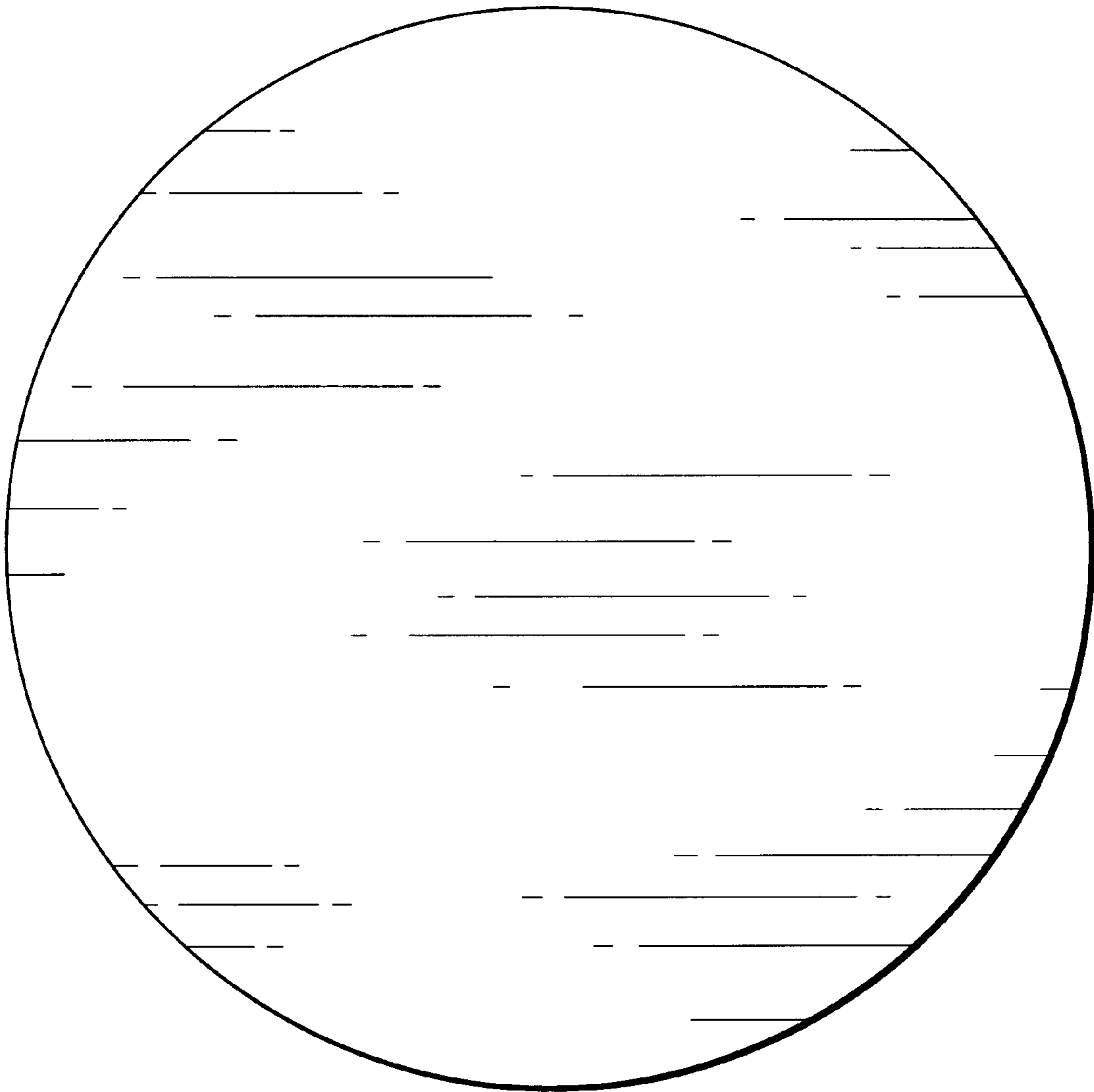
