The ornamental design for an electronic gas lighter, as shown and described.

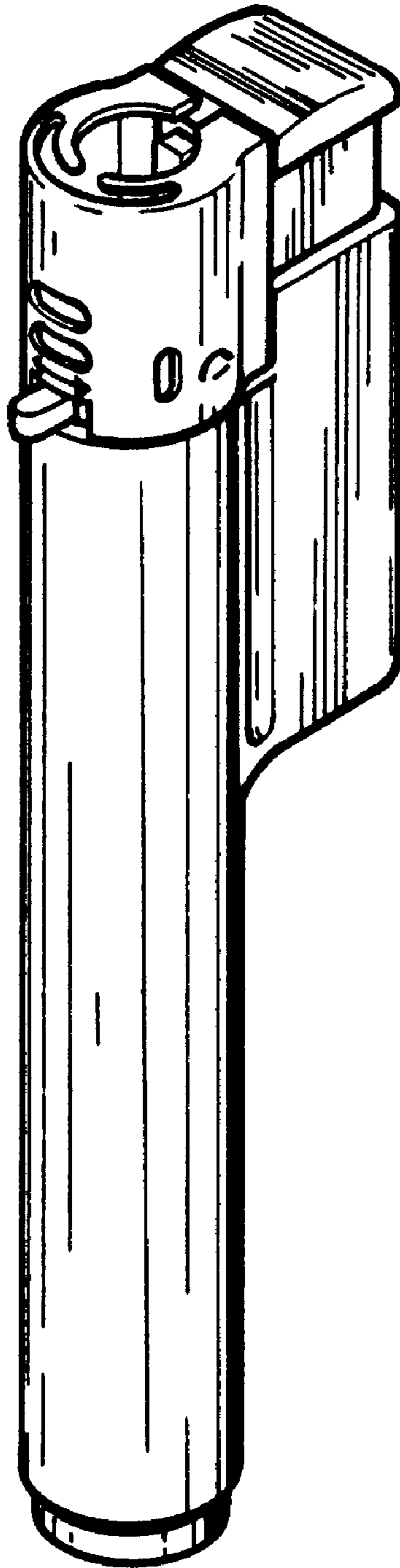
**DESCRIPTION**

 FIG. 6 is a bottom plan view thereof.

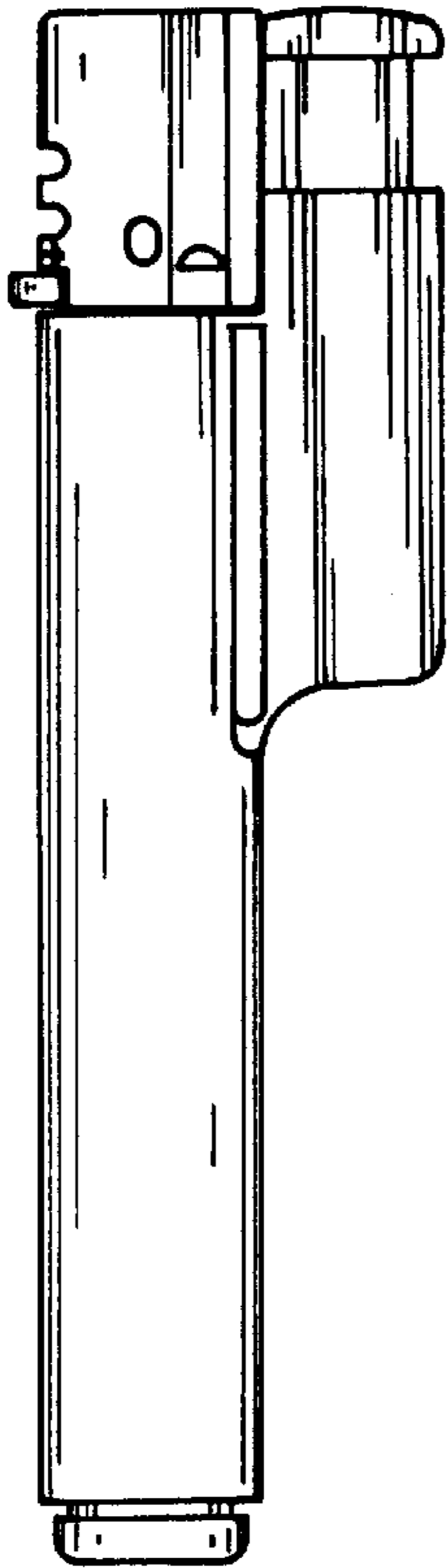

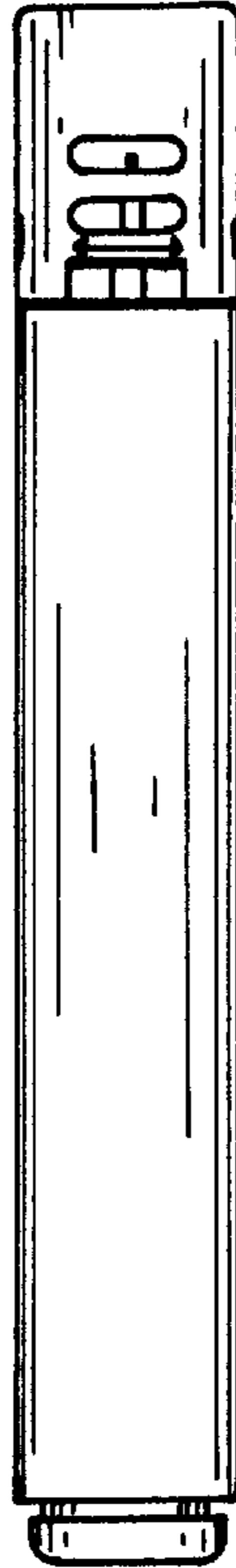

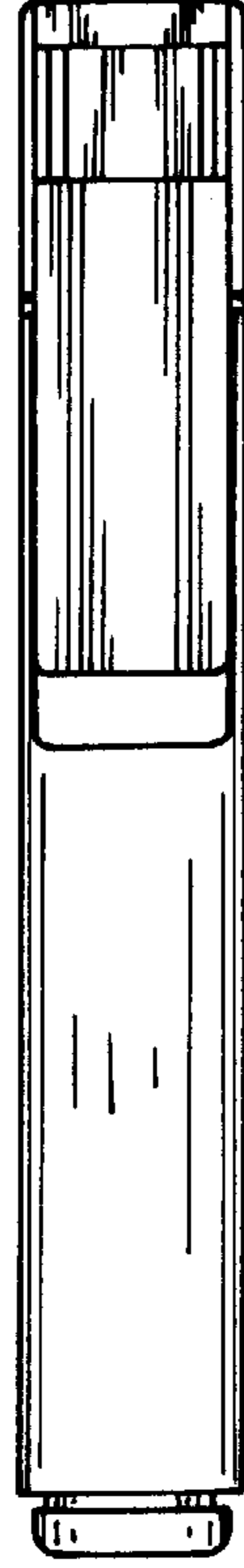

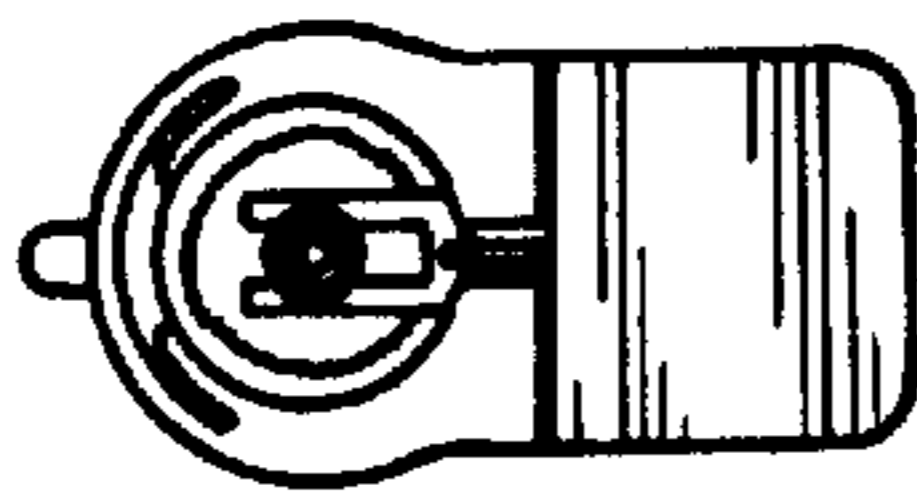
