The ornamental design for a computer console end, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a computer console end showing our new design;

FIG. 9 is a rear elevational view thereof;

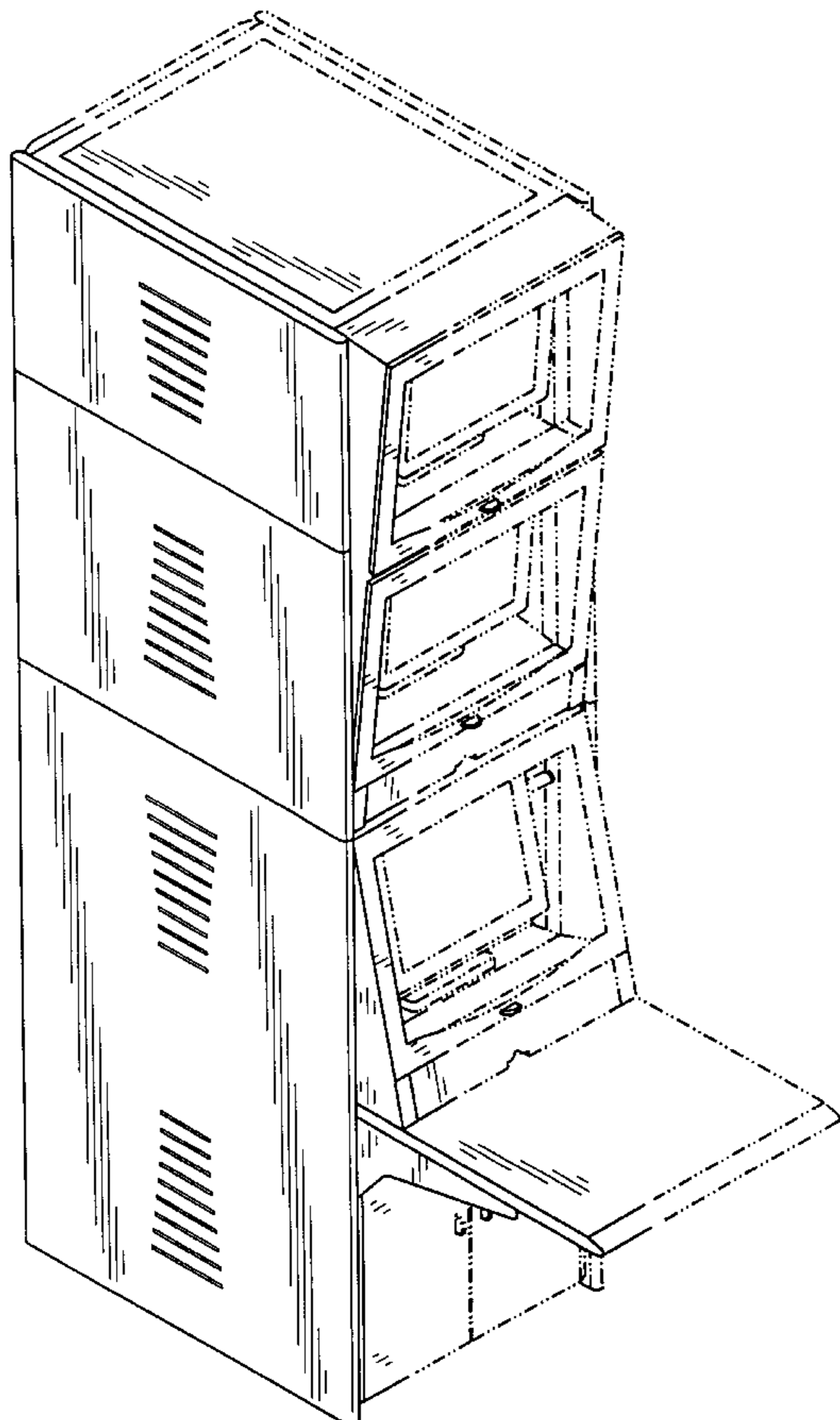
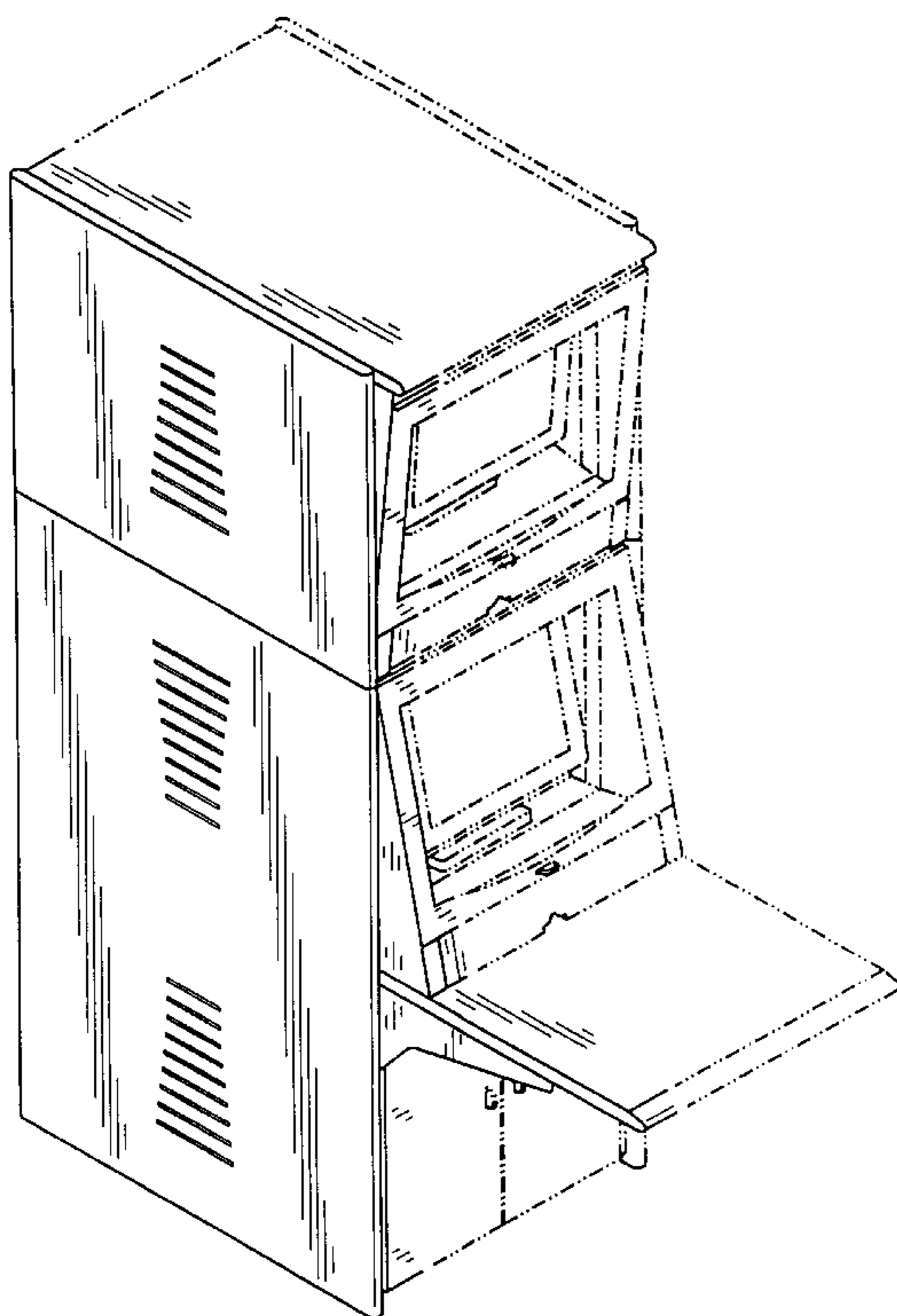
FIG. 10 is a top view thereof;

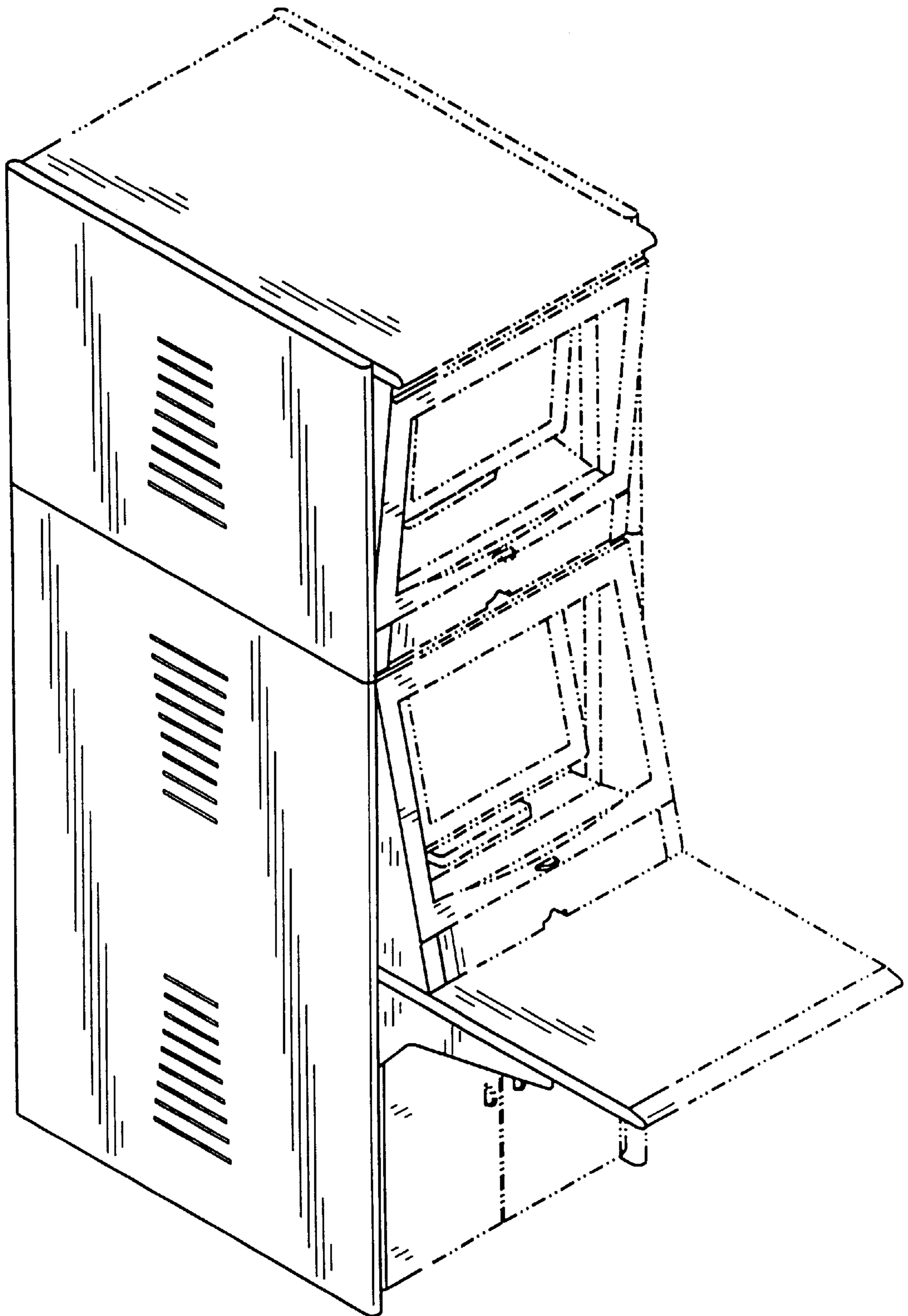

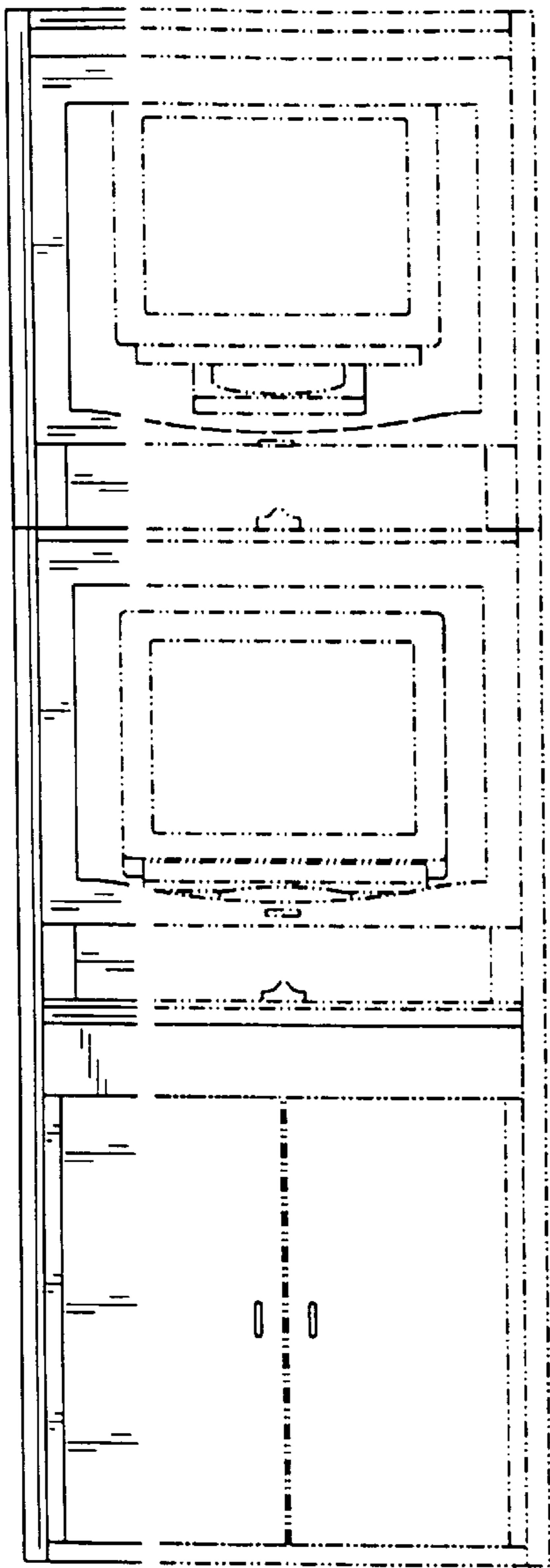

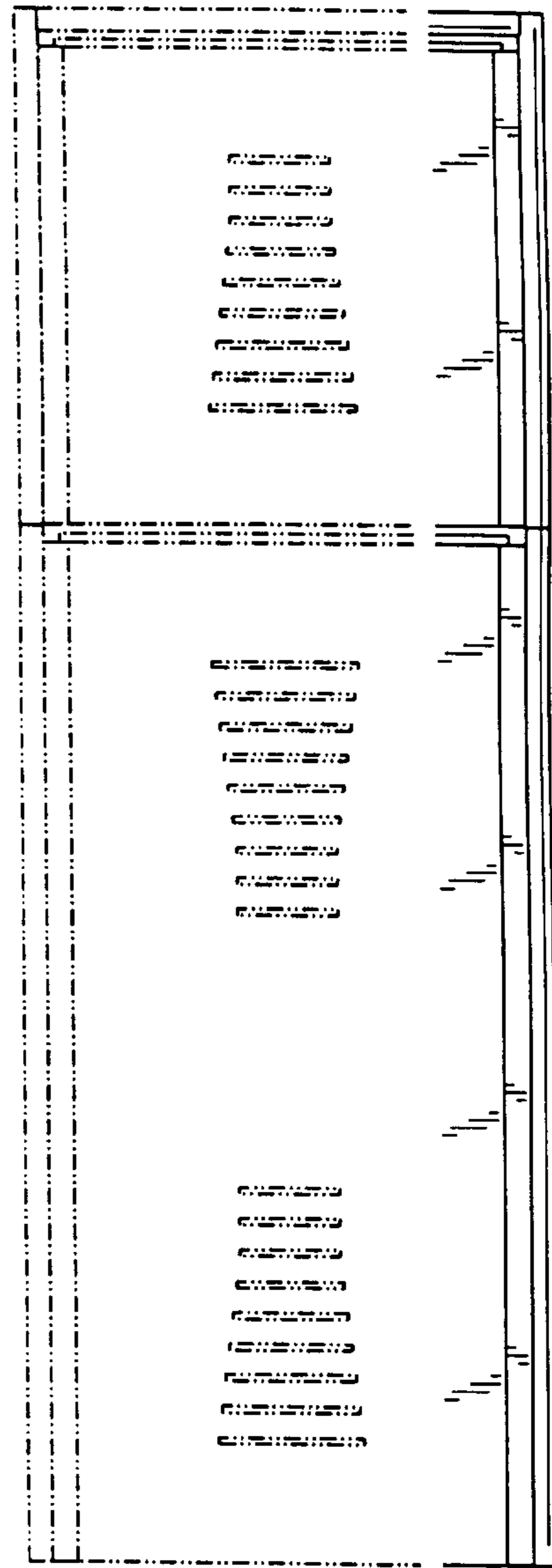

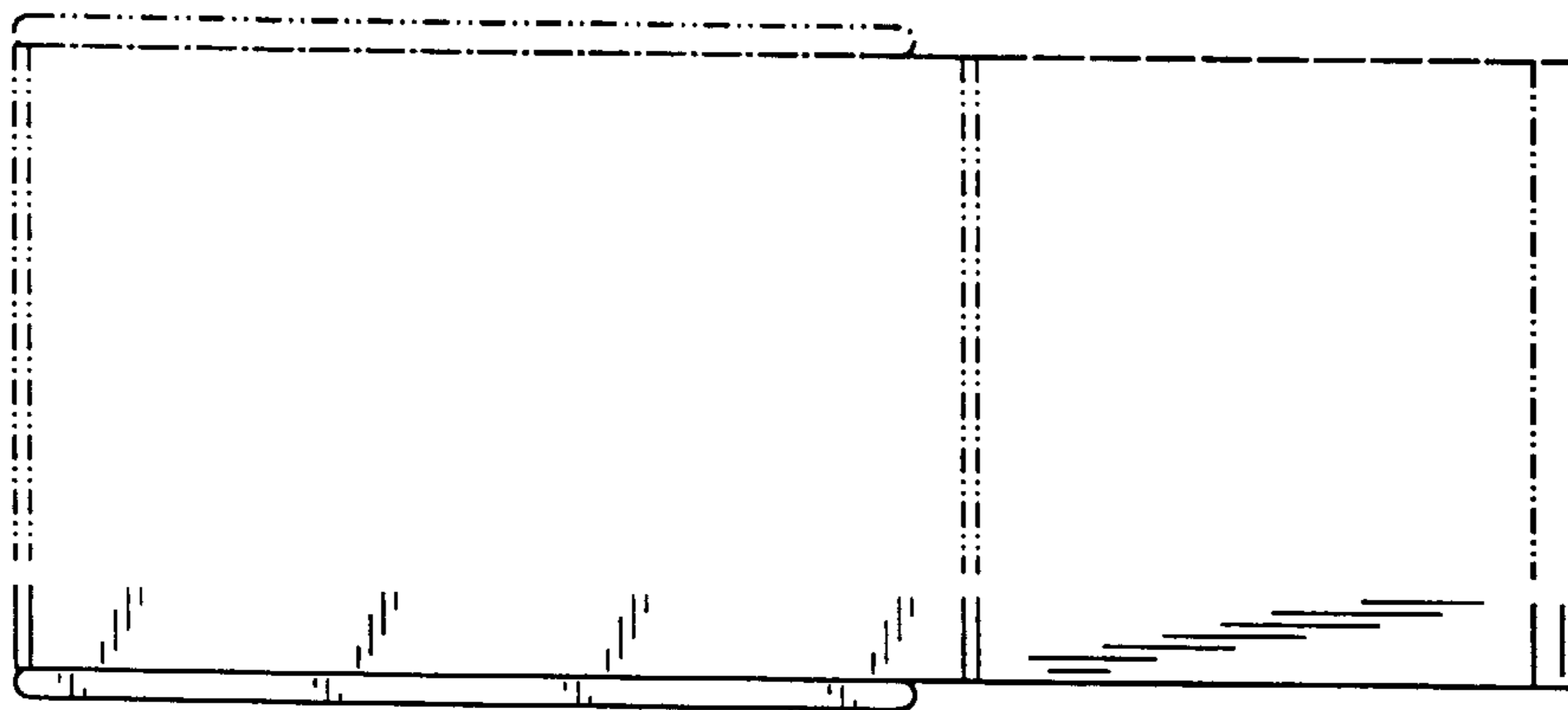

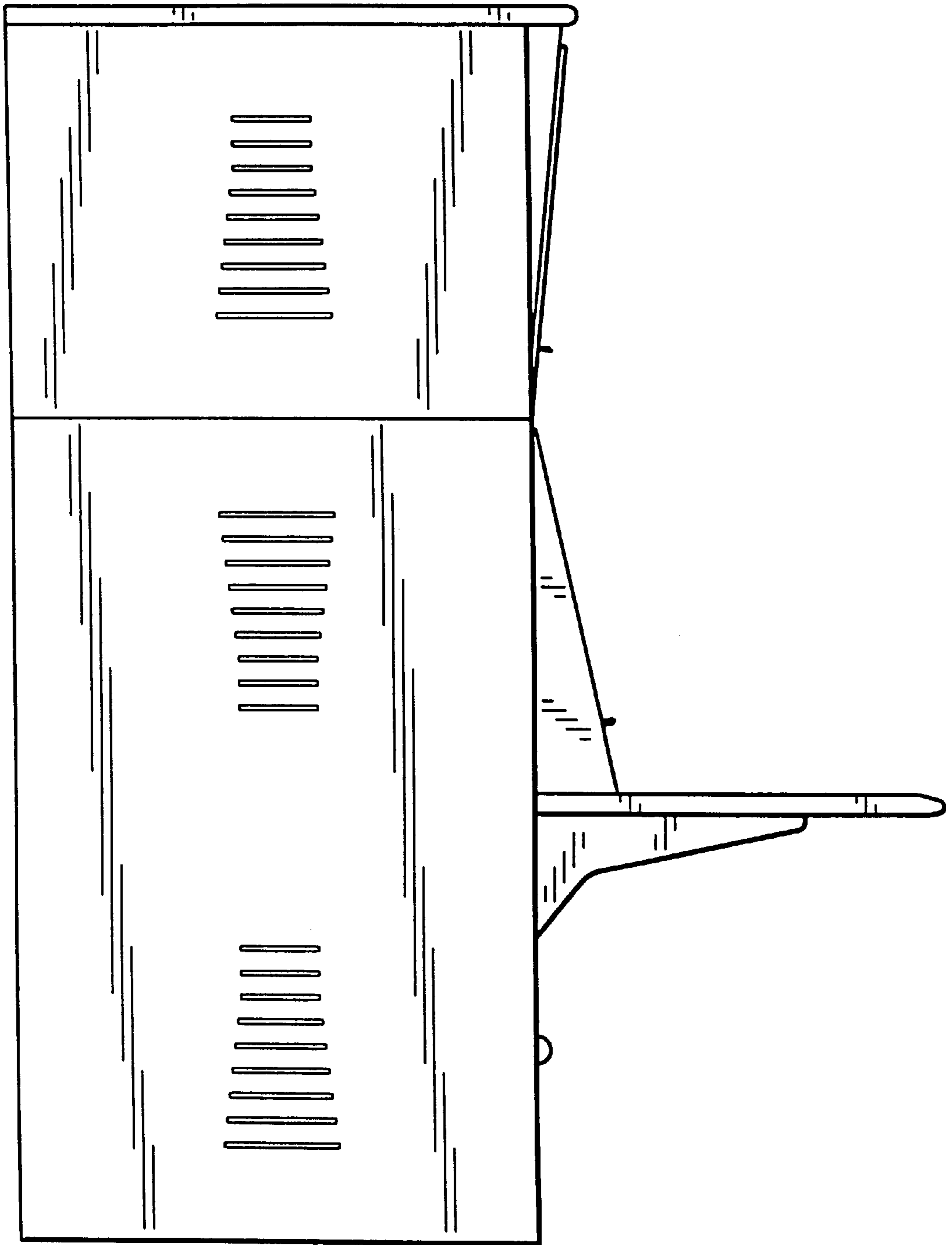

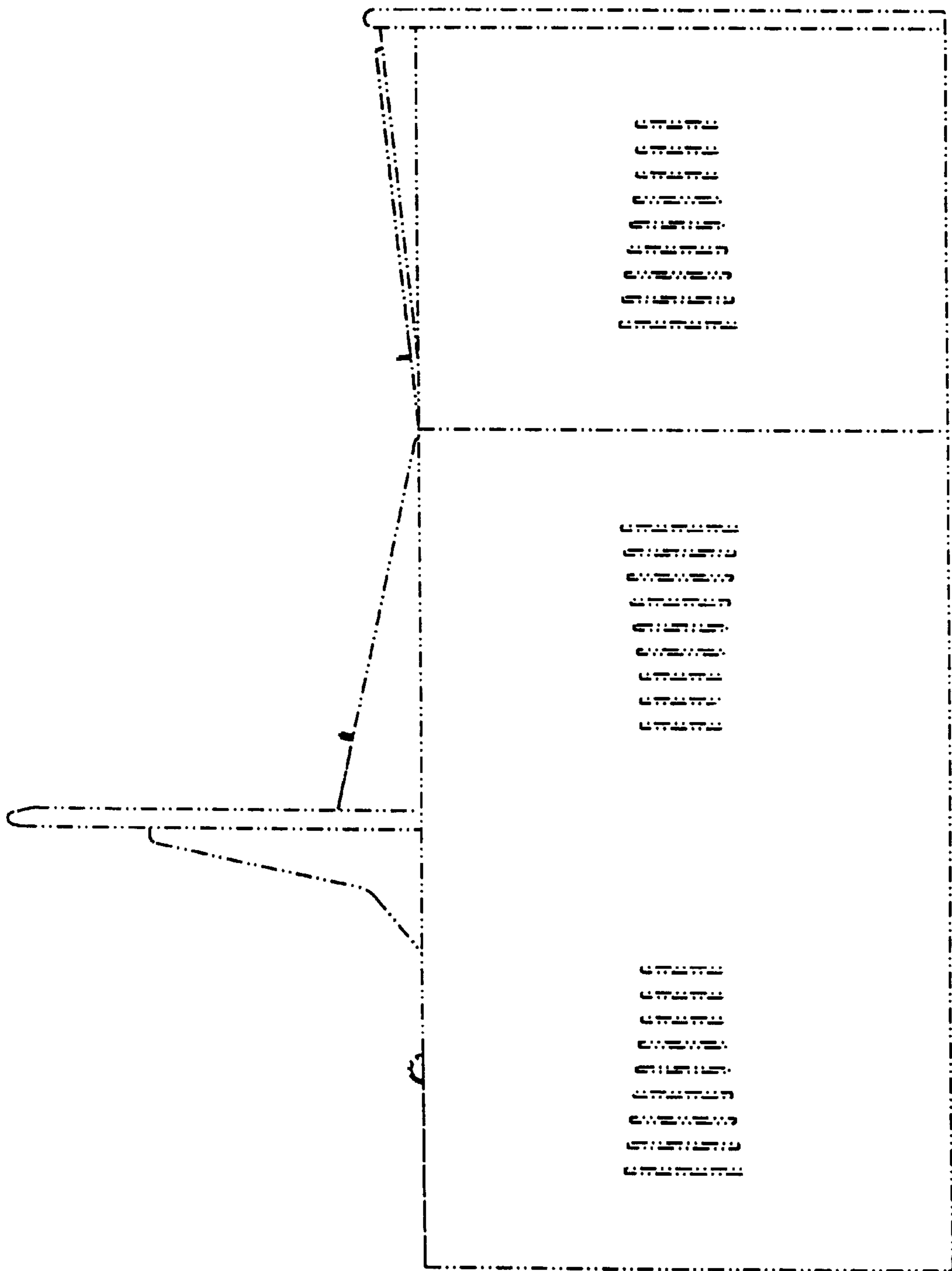

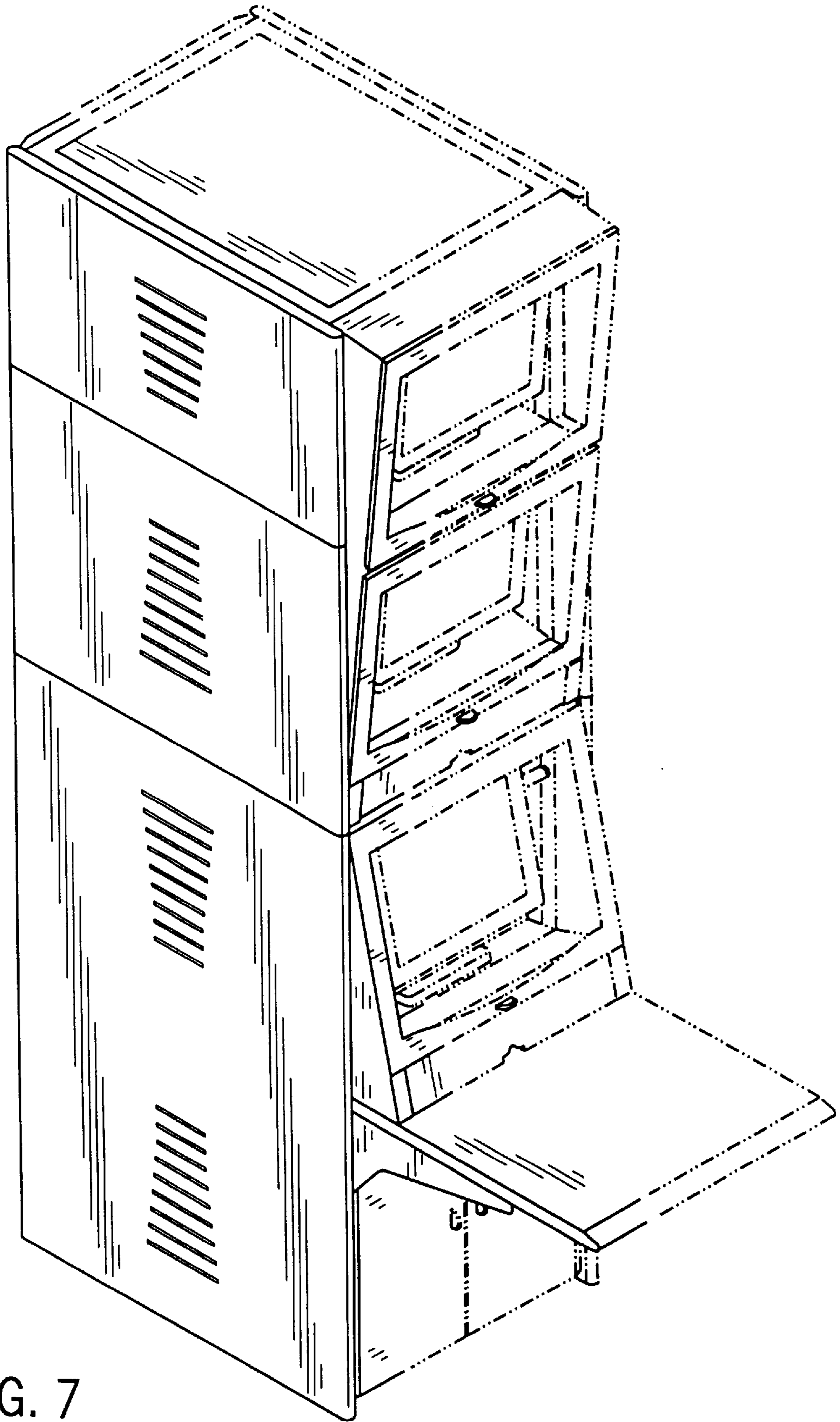

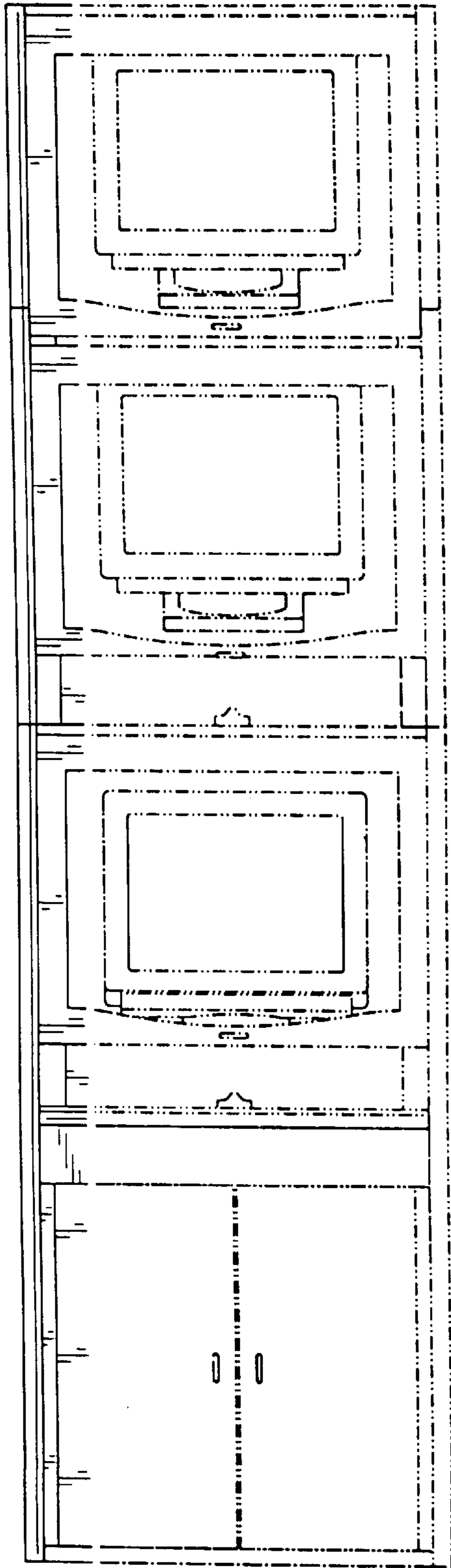

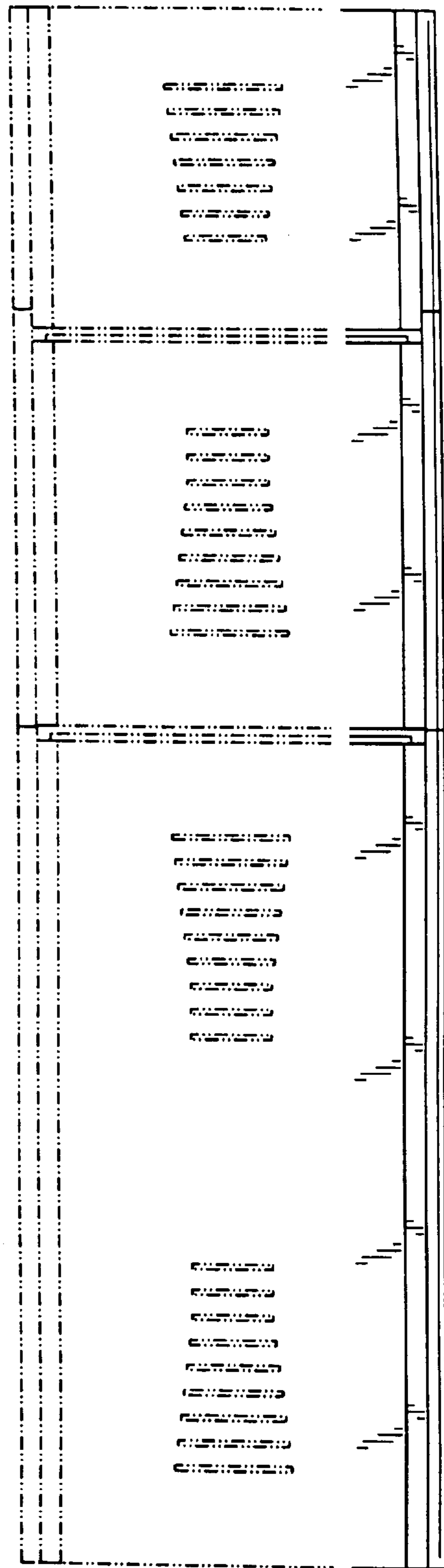

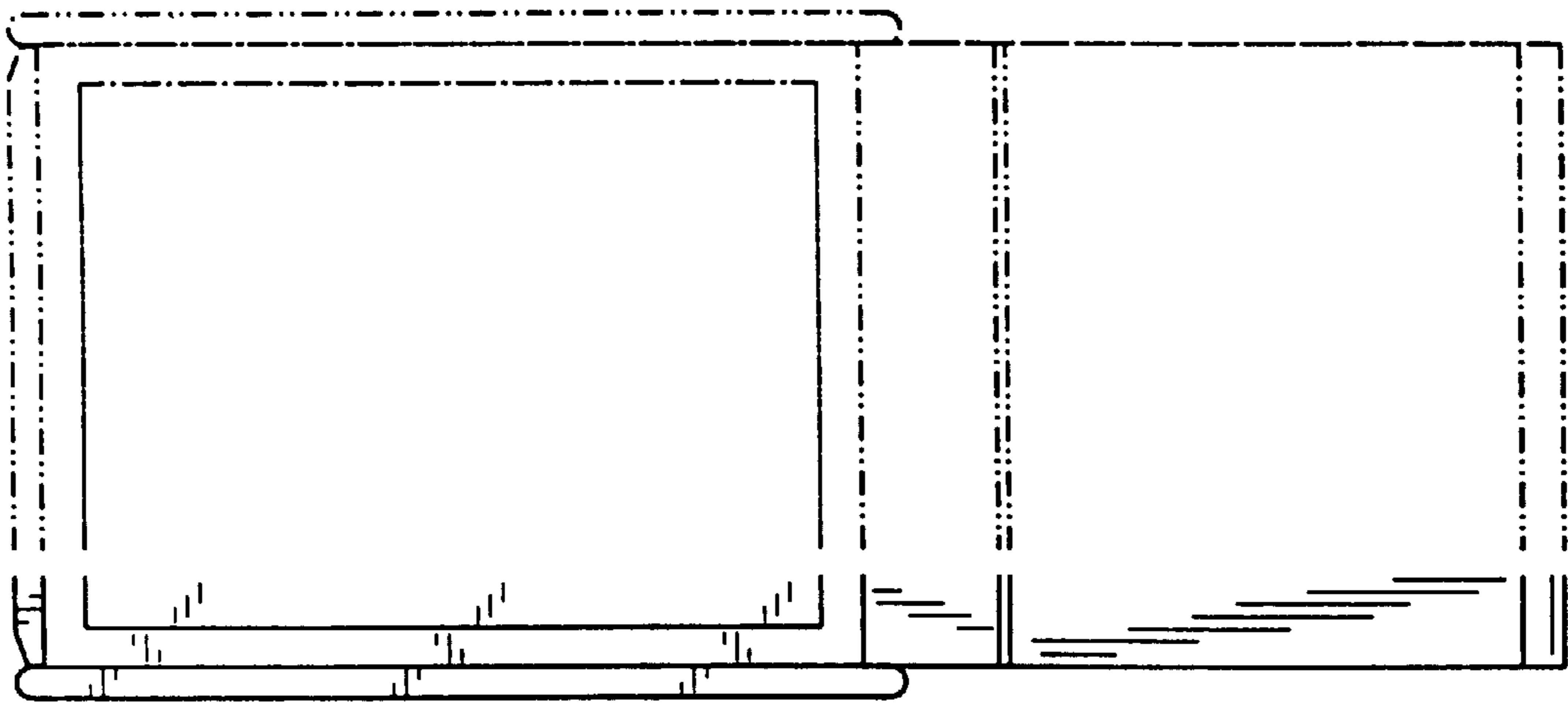

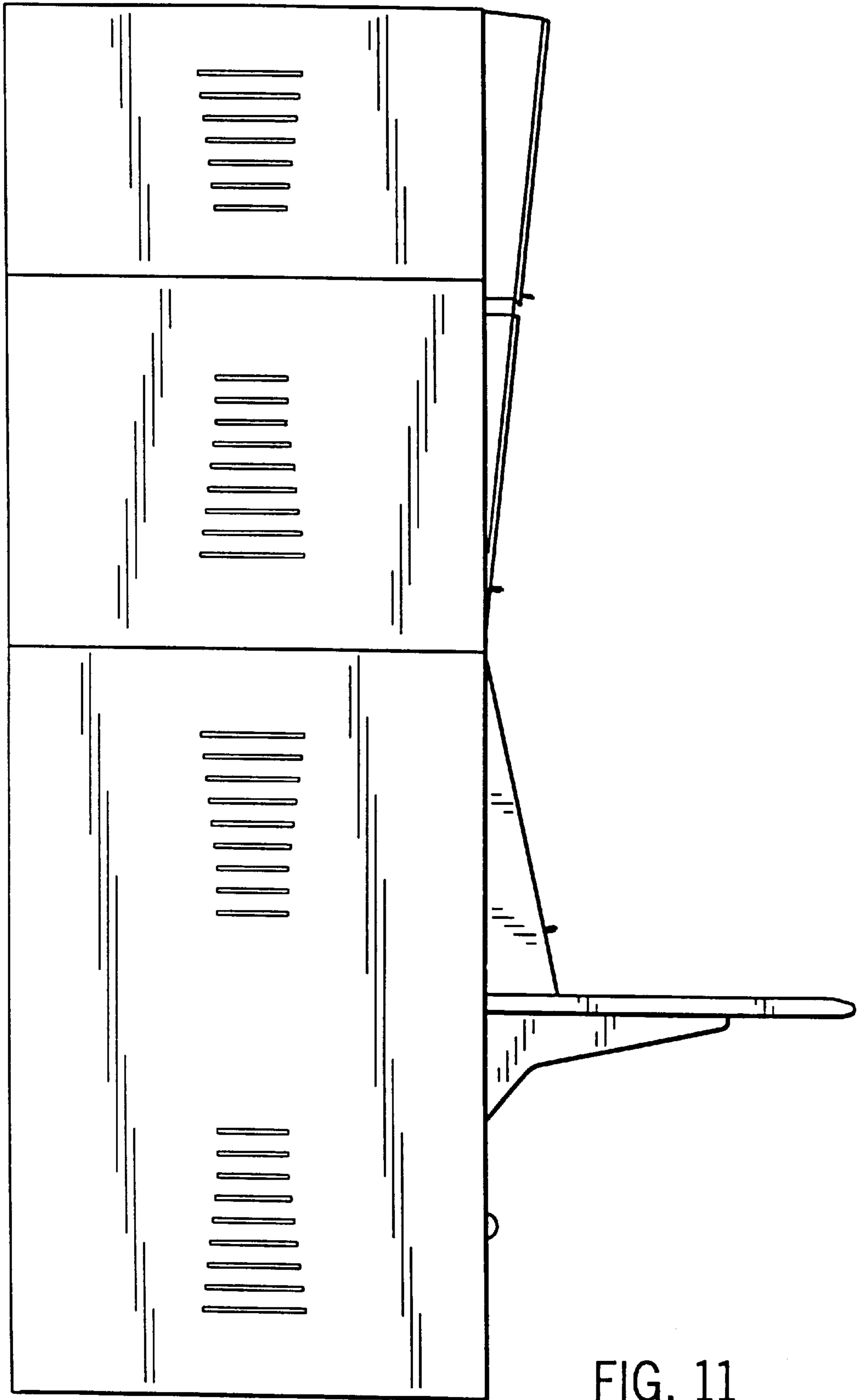

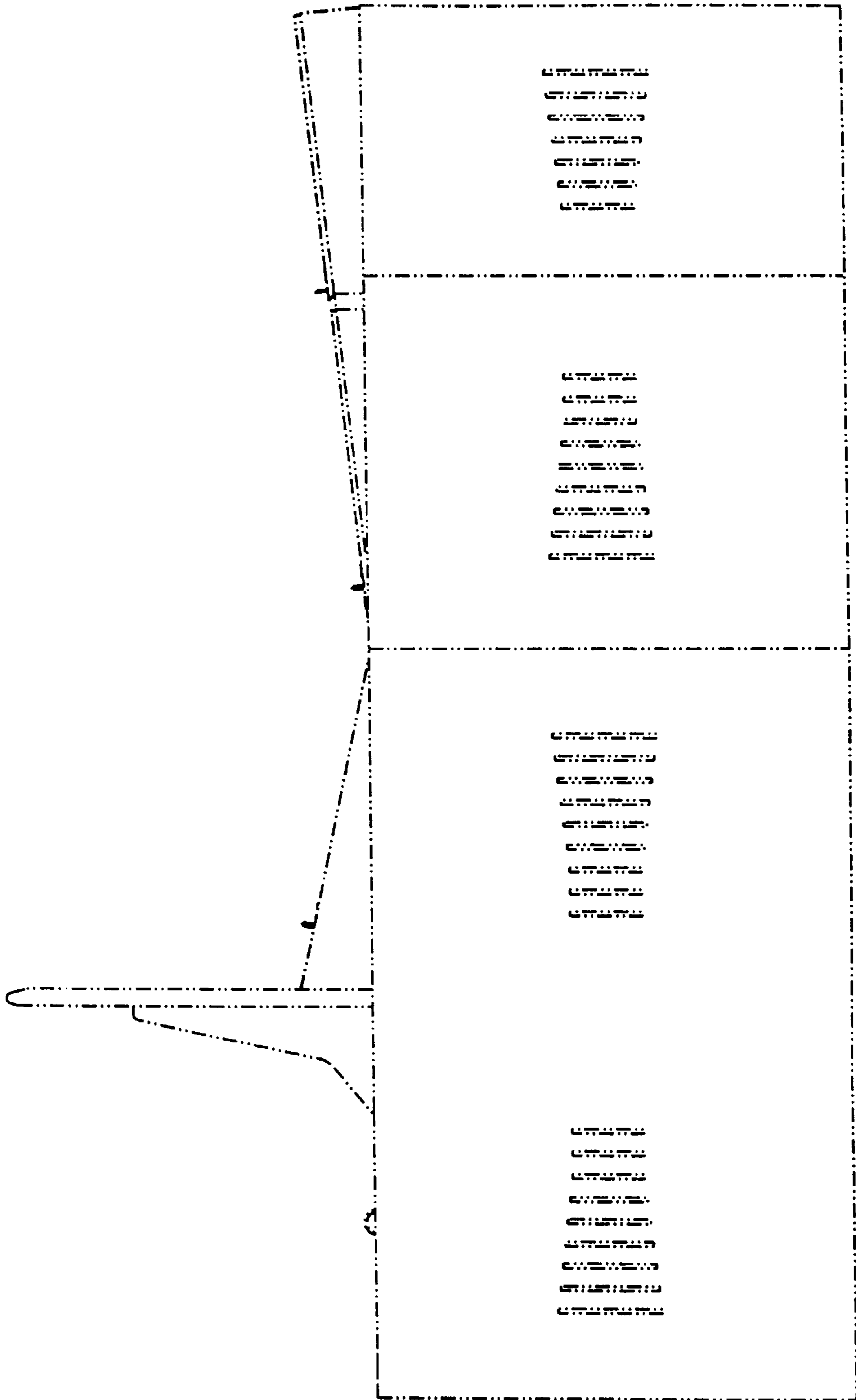
