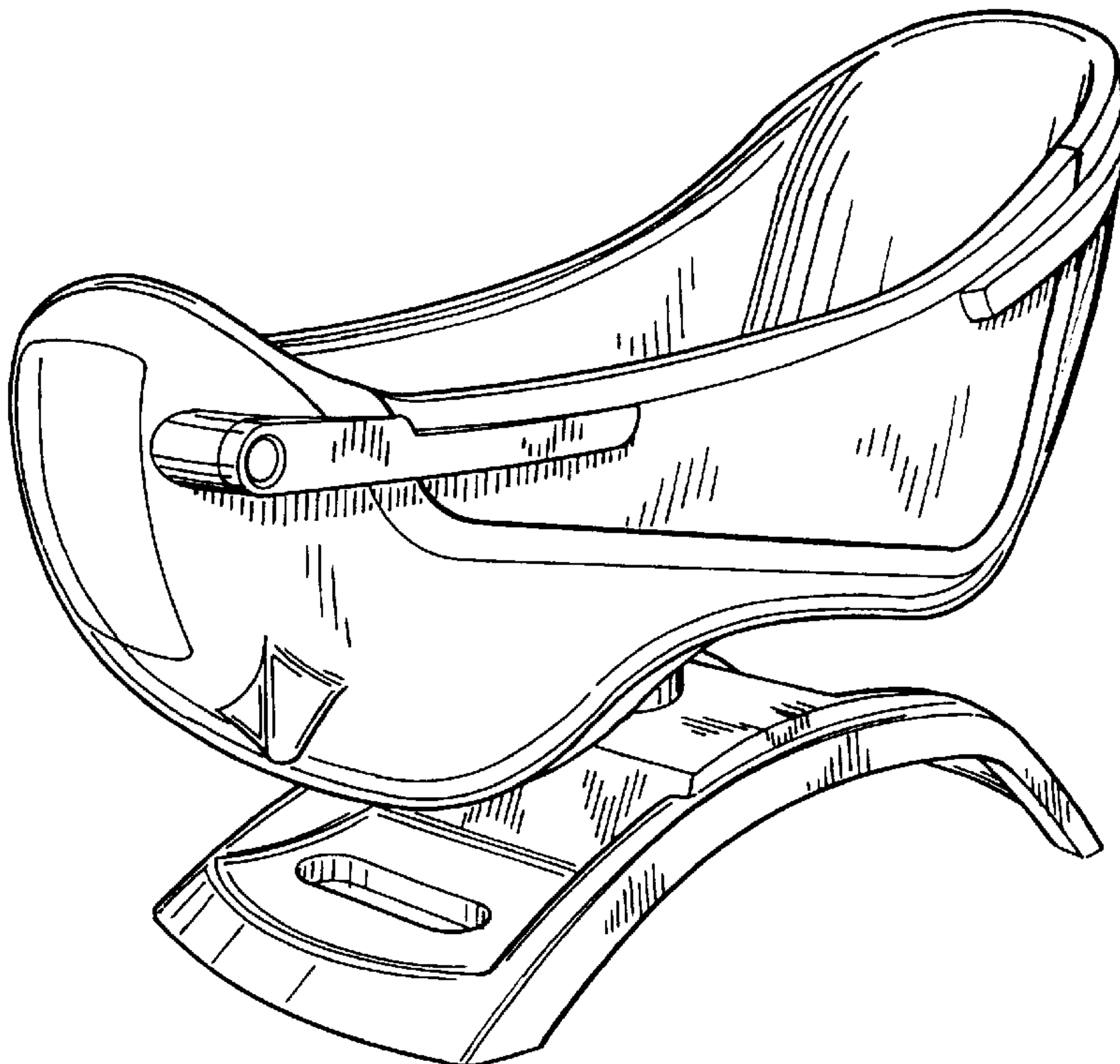
(57) **CLAIM**

The ornamental design for a bath, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bath showing our new design as viewed from the front and left side;
FIG. 2 is a perspective view thereof as viewed from the front and right side;
FIG. 3 is a perspective view thereof as viewed from the rear and left side;
FIG. 4 is a perspective view thereof as viewed from the rear and right side;
FIG. 5 is a perspective view thereof with part of the left side of the bath in a first position;
FIG. 6 is a perspective view thereof with part of the left side of the bath in an alternative position;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is a right side elevational view thereof;
FIG. 9 is a front view thereof;
FIG. 10 is a rear view thereof;
FIG. 11 is a top view thereof;
FIG. 12 is a bottom view thereof;
FIG. 13 is a left side elevational view of another embodiment of the bath;
FIG. 14 is a right side elevational view of the bath shown in FIG. 13;
FIG. 15 is a front view of the bath shown in FIG. 13;
FIG. 16 is a rear view of the bath shown in FIG. 13;
FIG. 17 is a top view of the bath shown in FIG. 13; and,
FIG. 18 is a bottom view of the bath shown in FIG. 13.

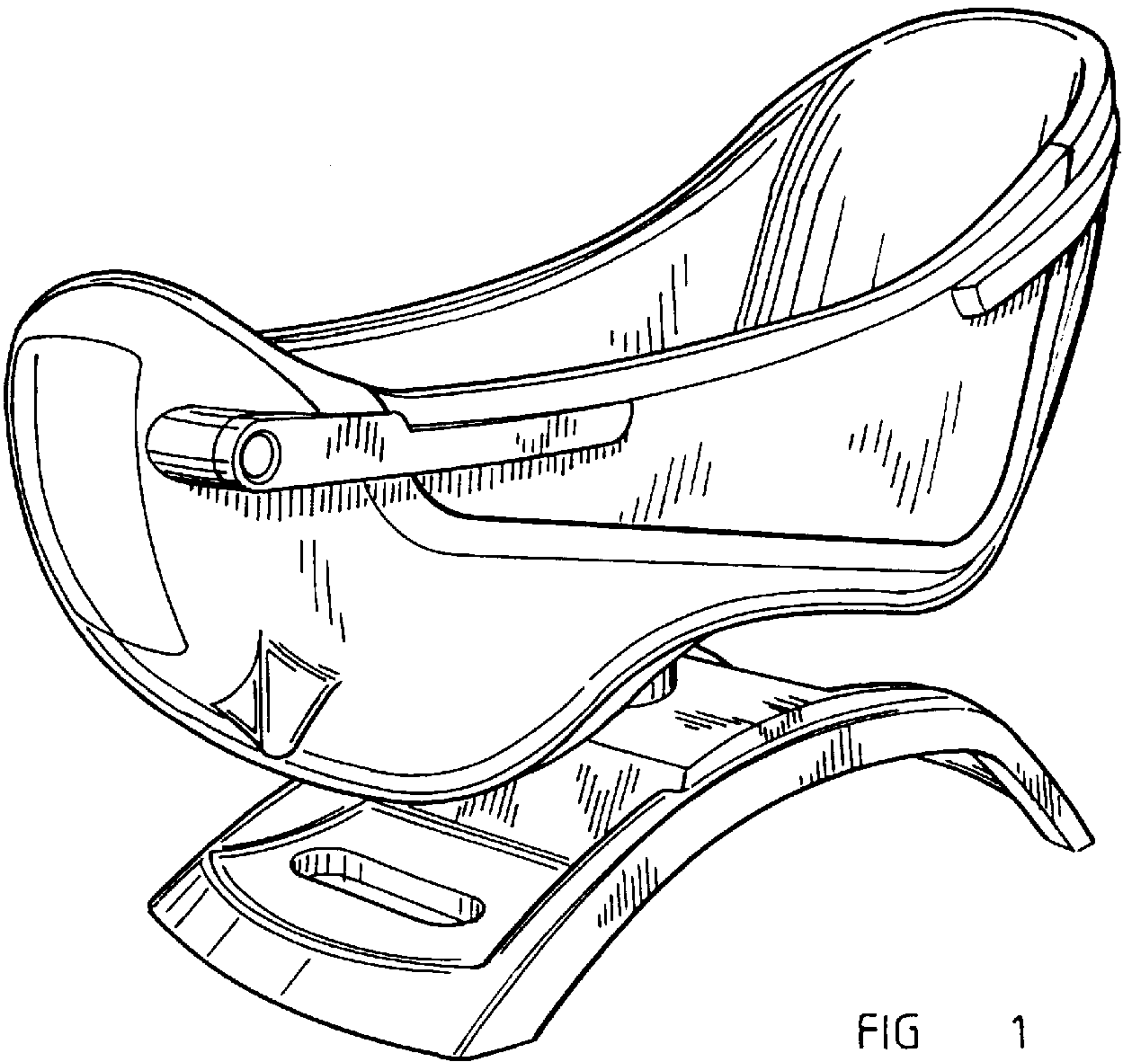

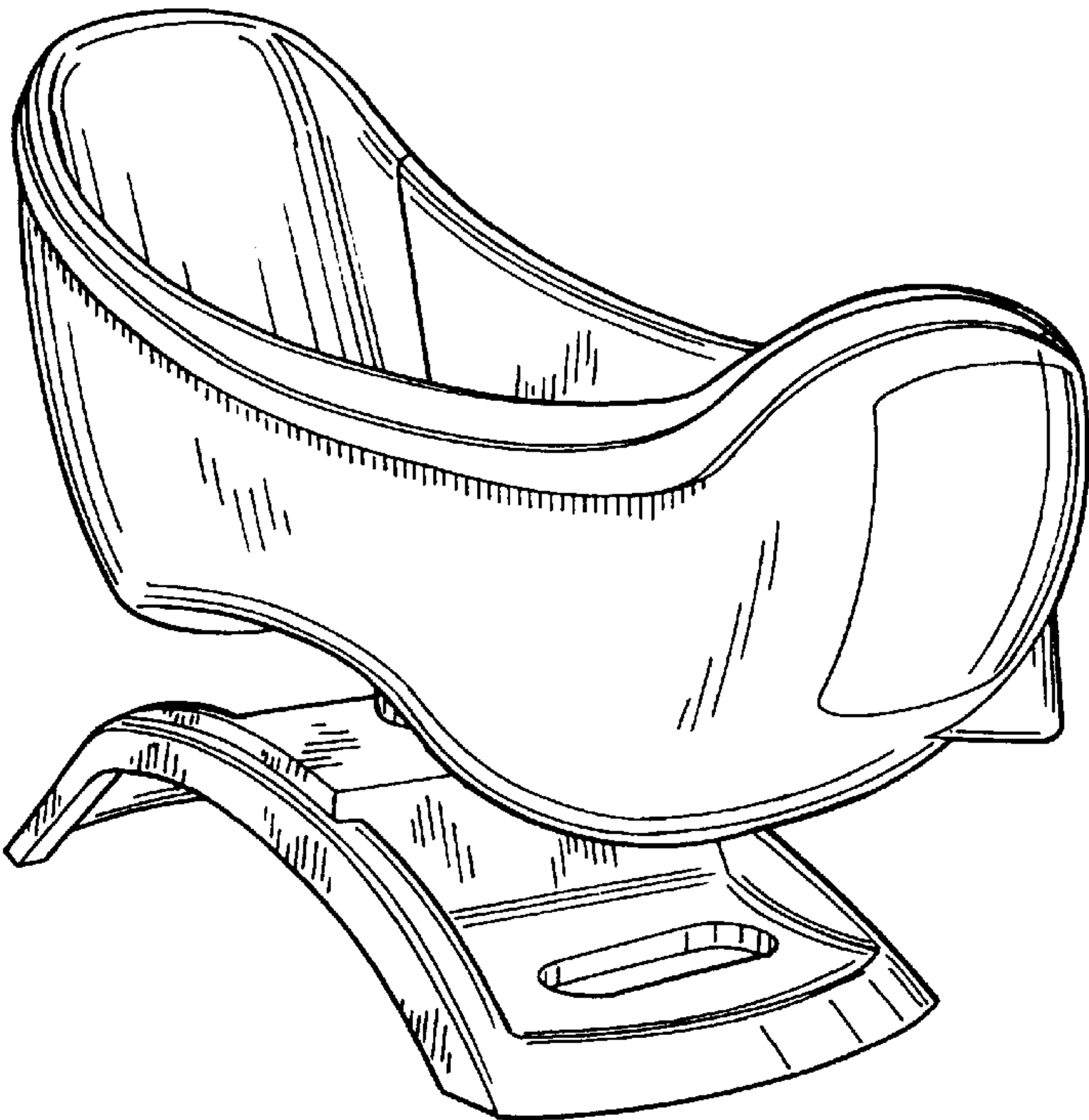

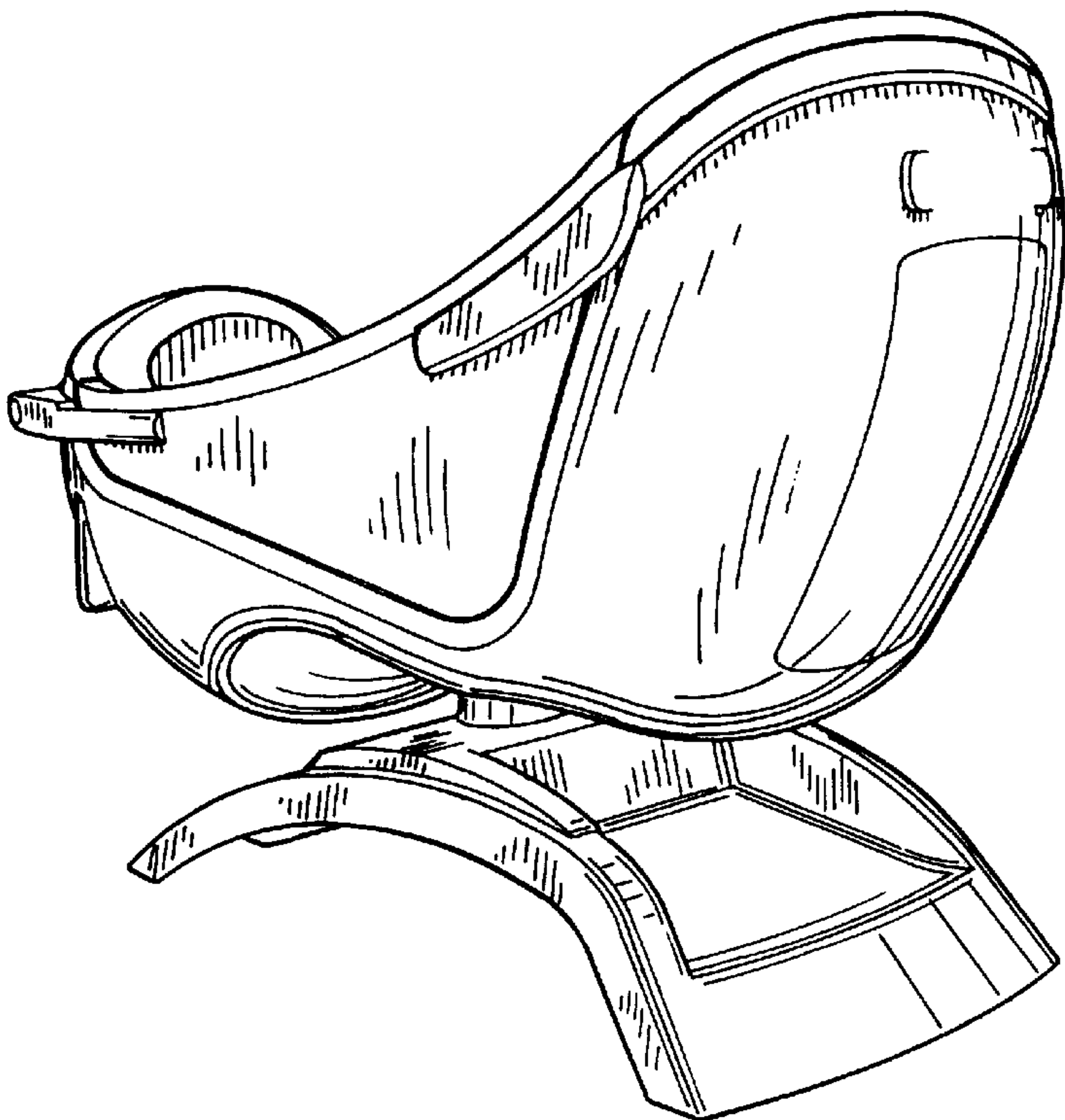

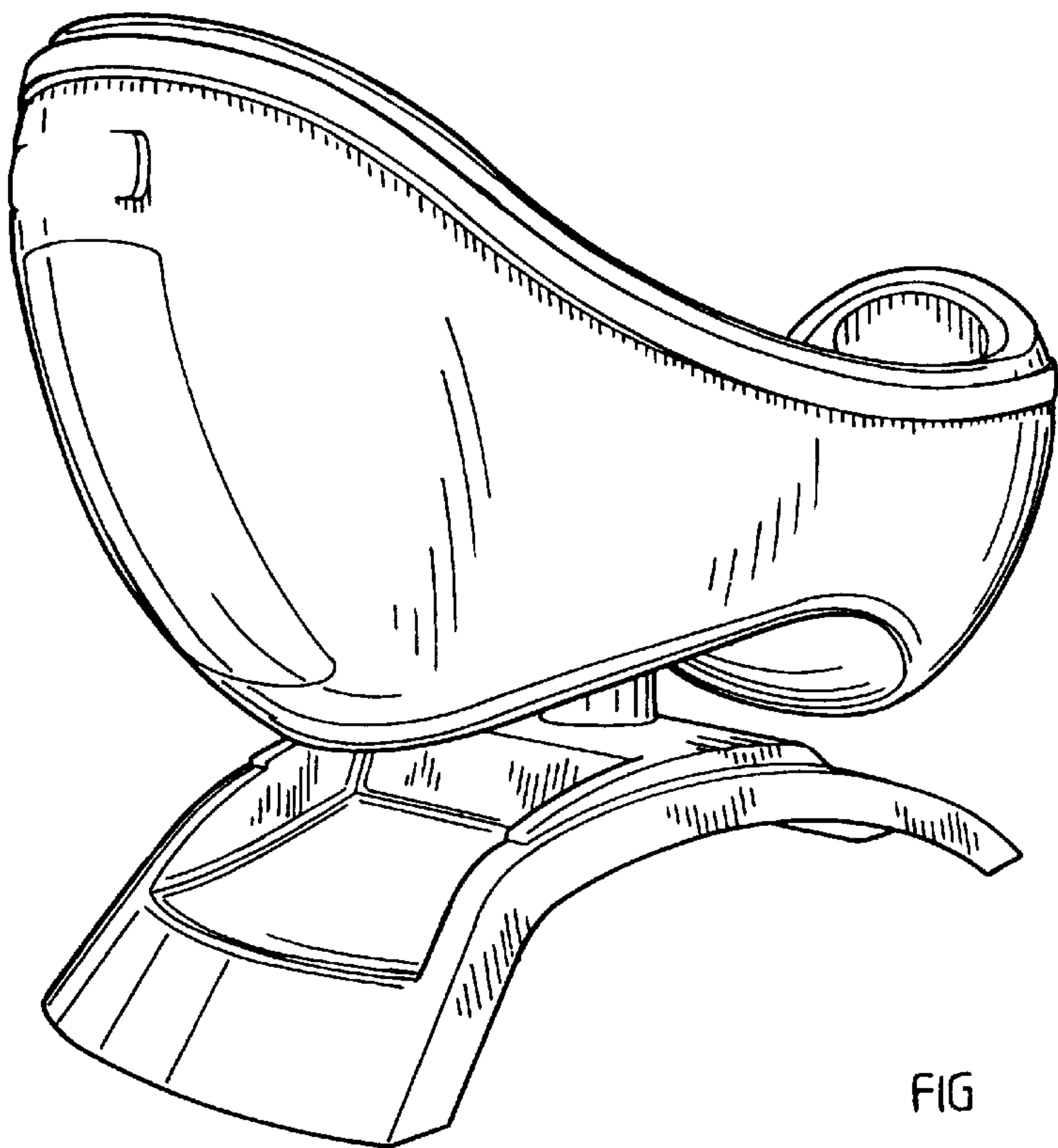

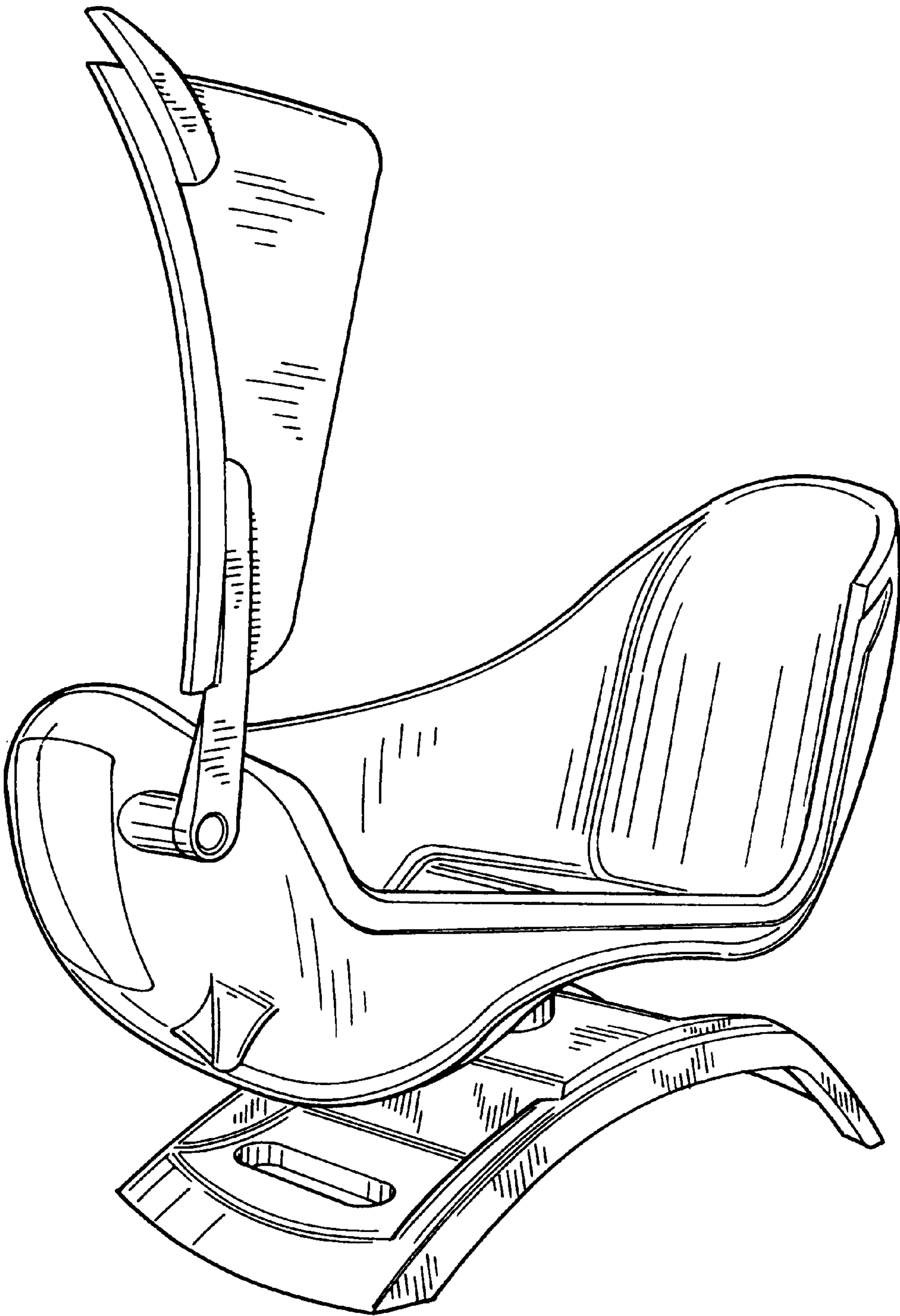

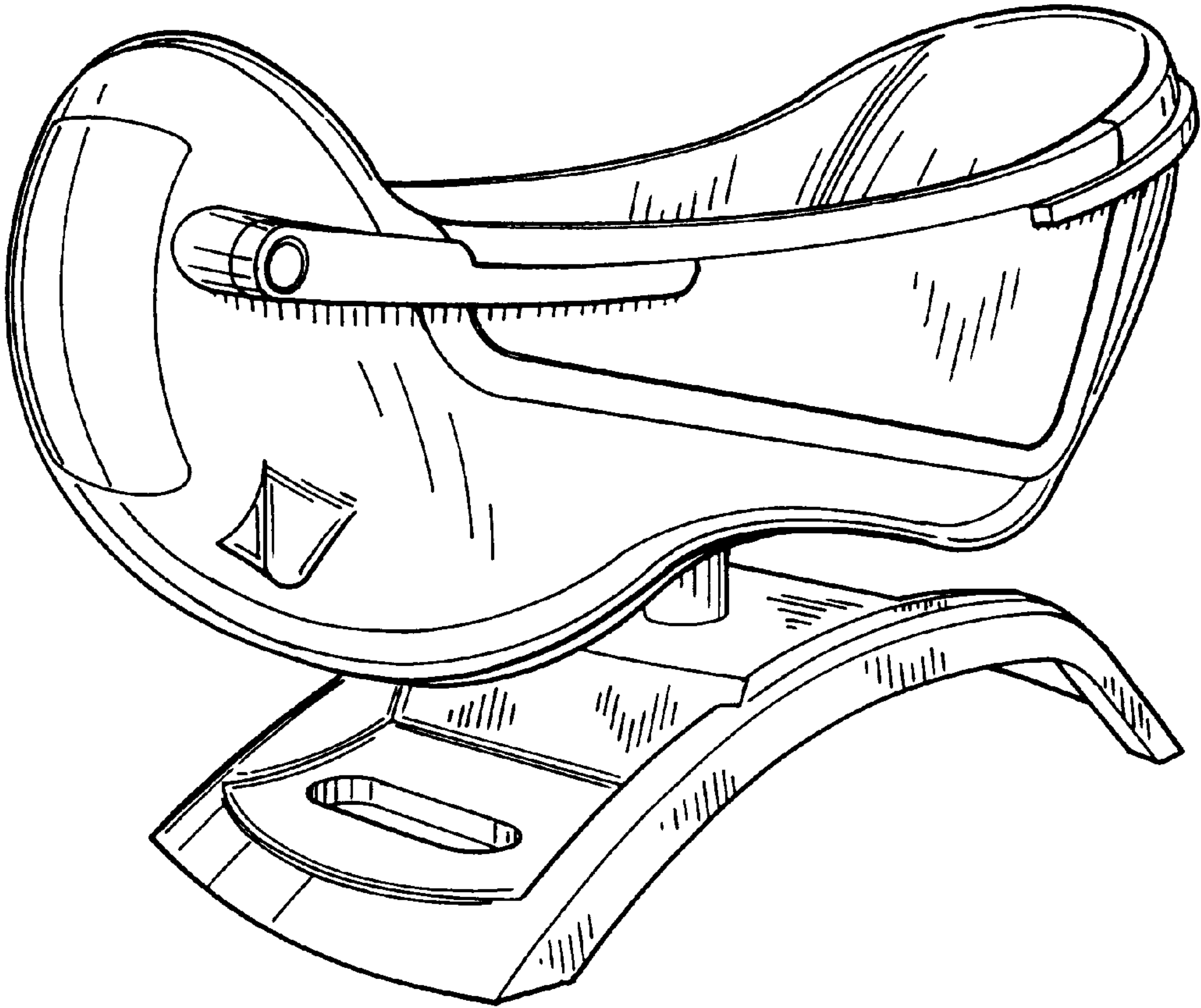

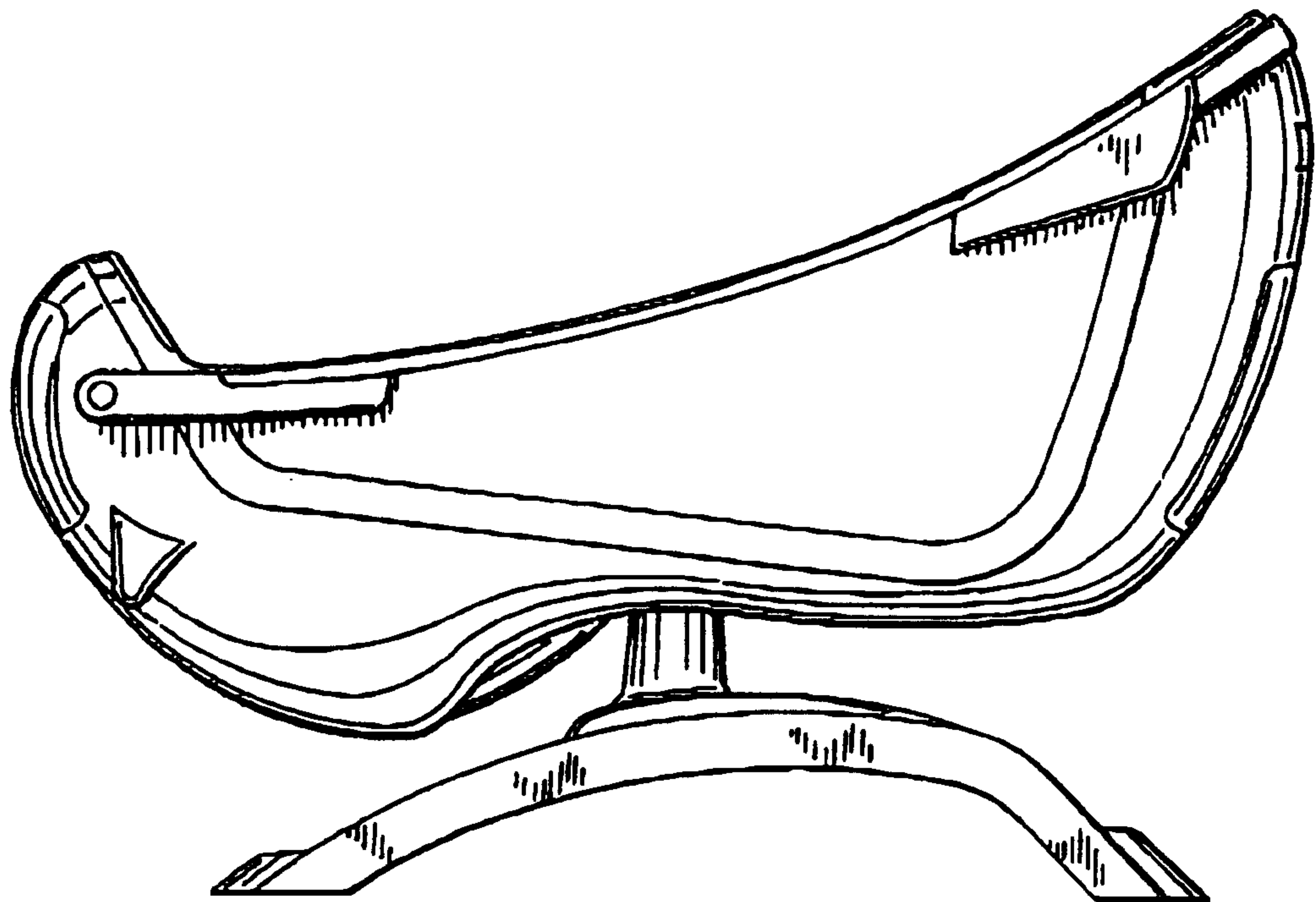

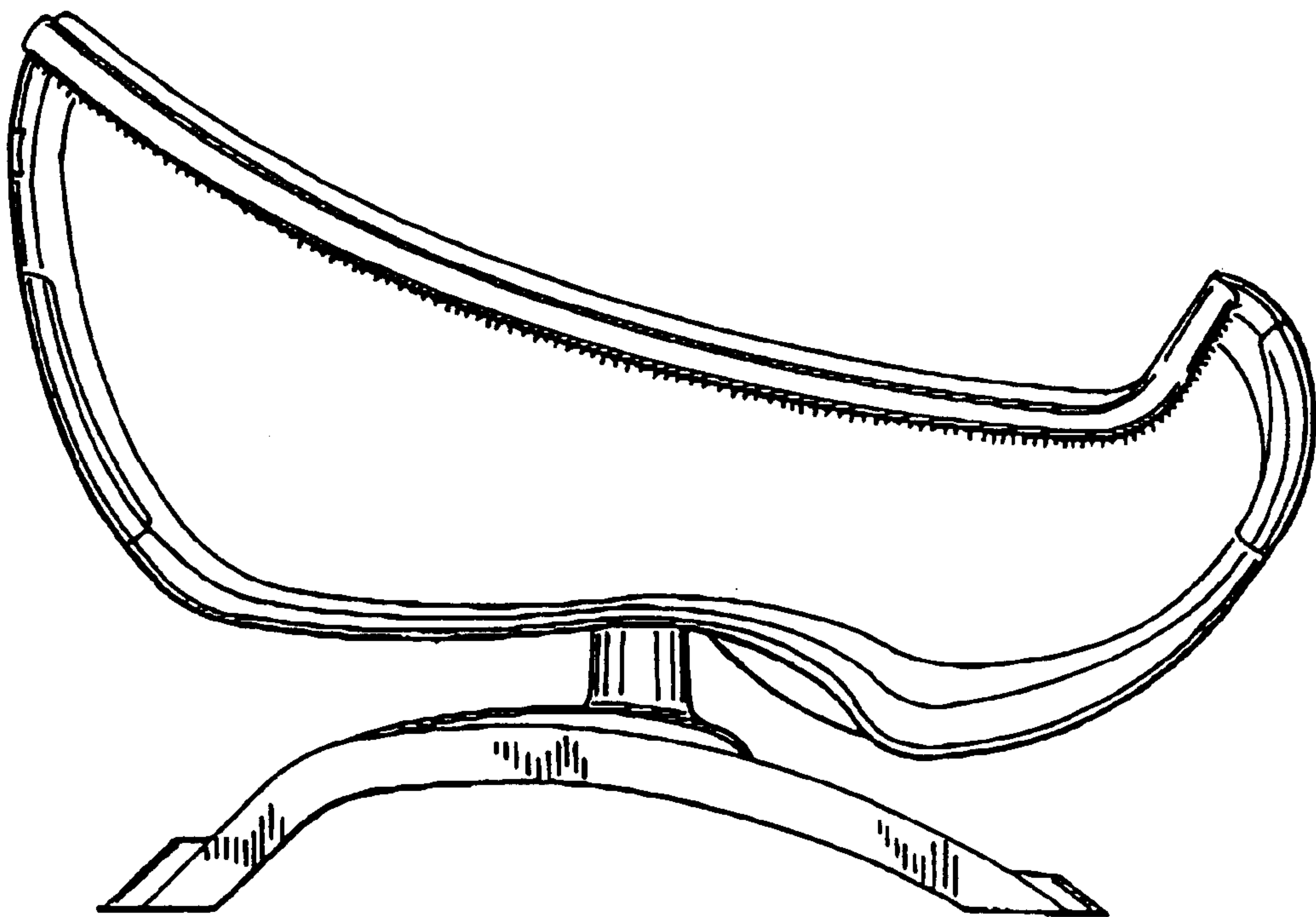

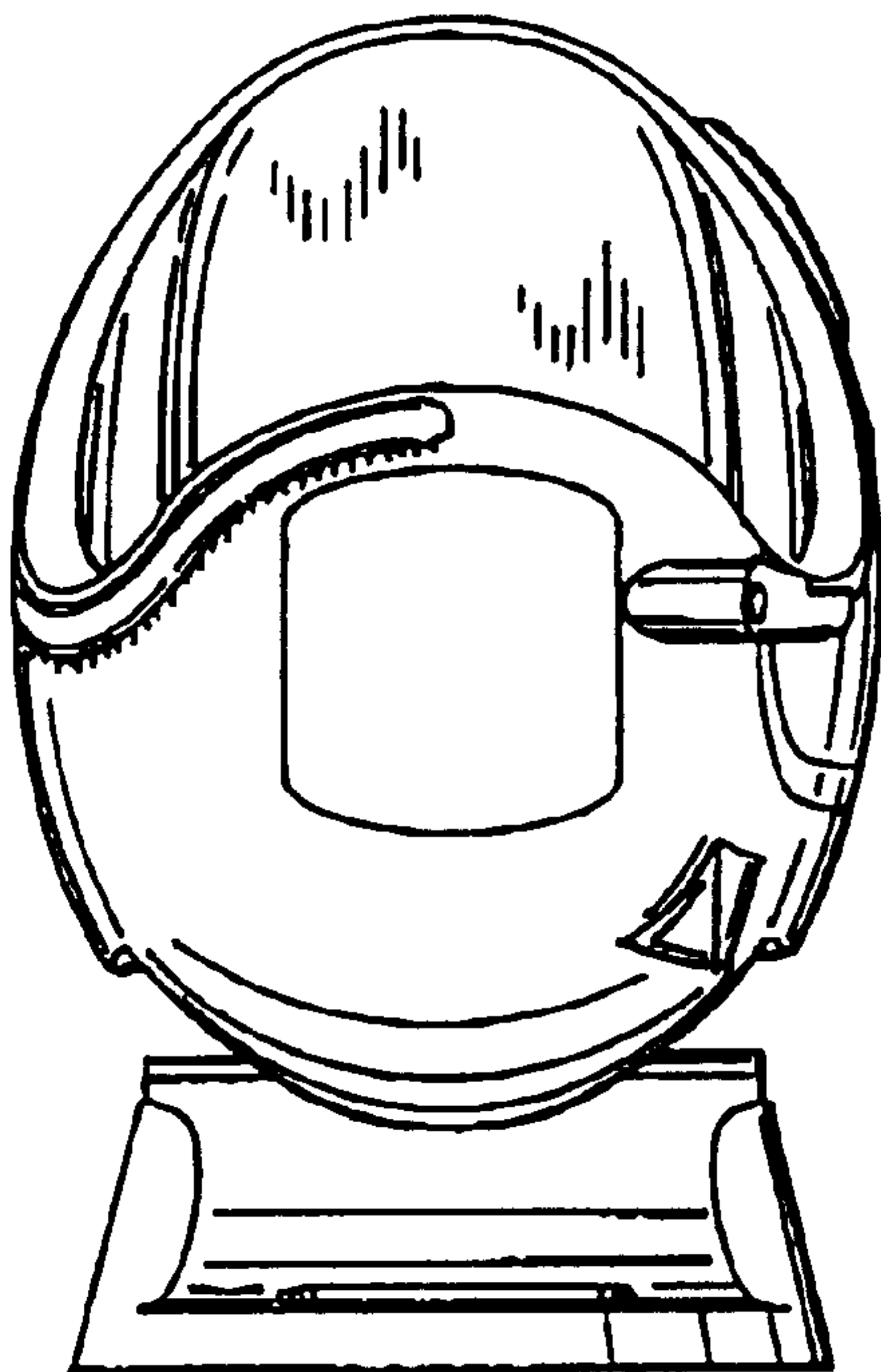

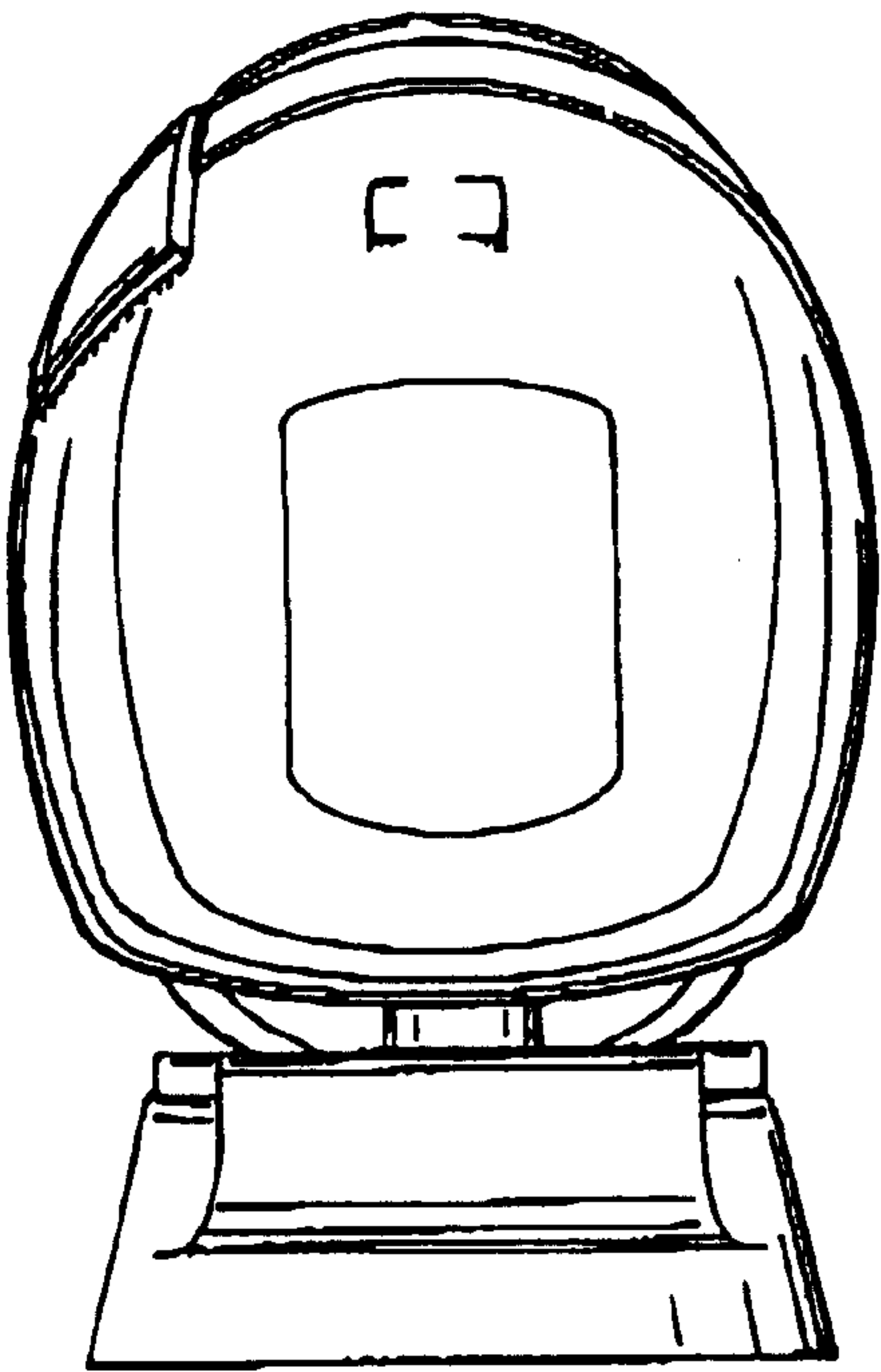

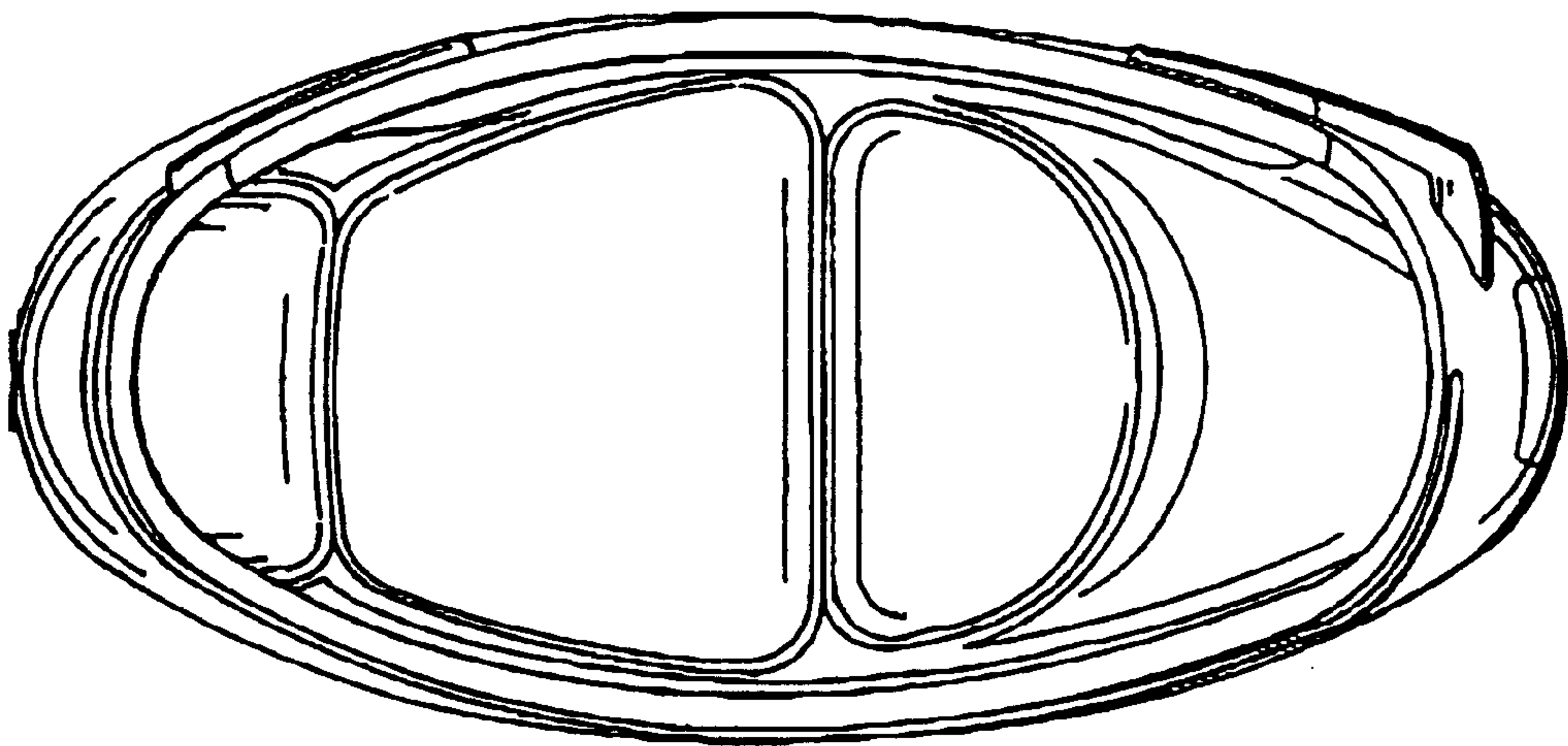

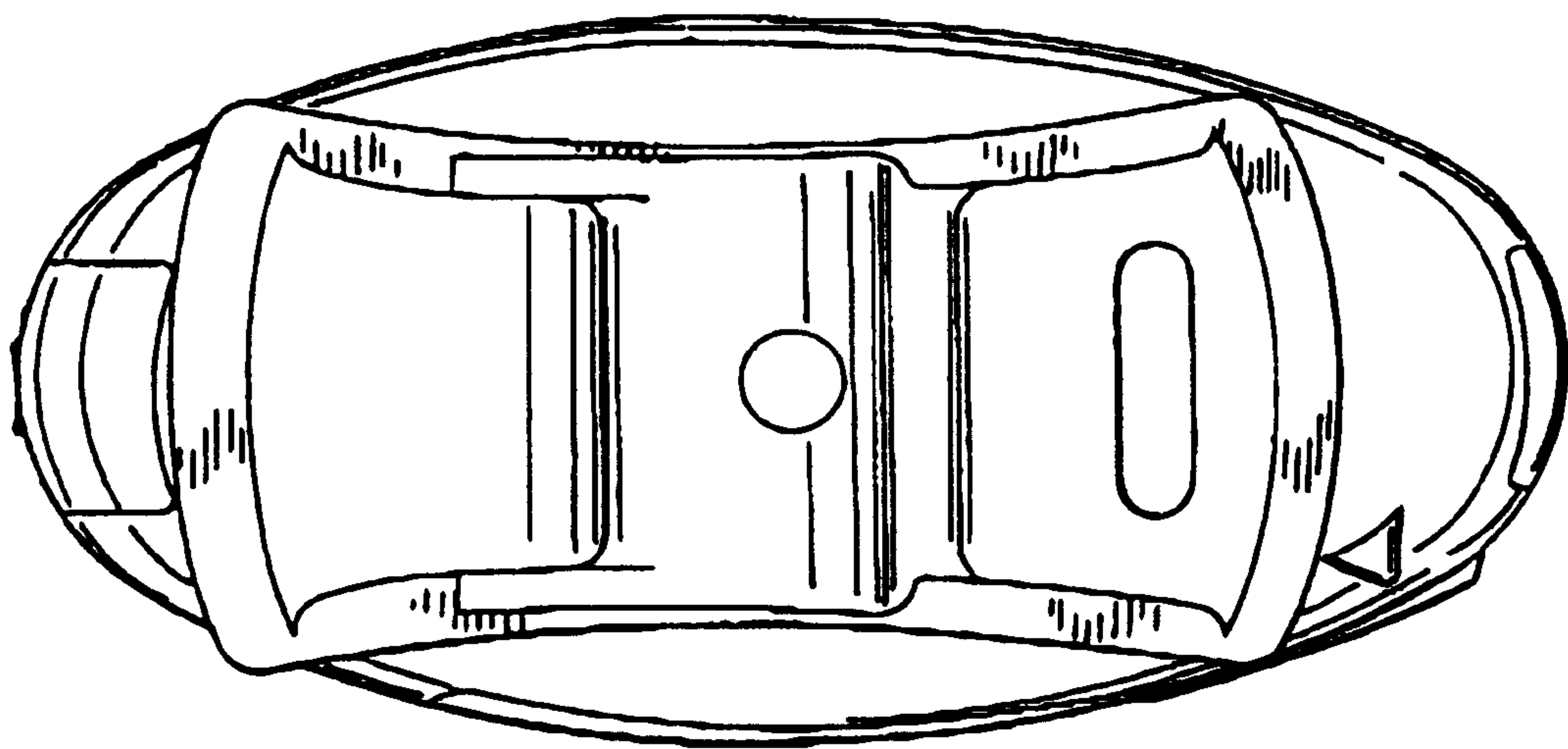

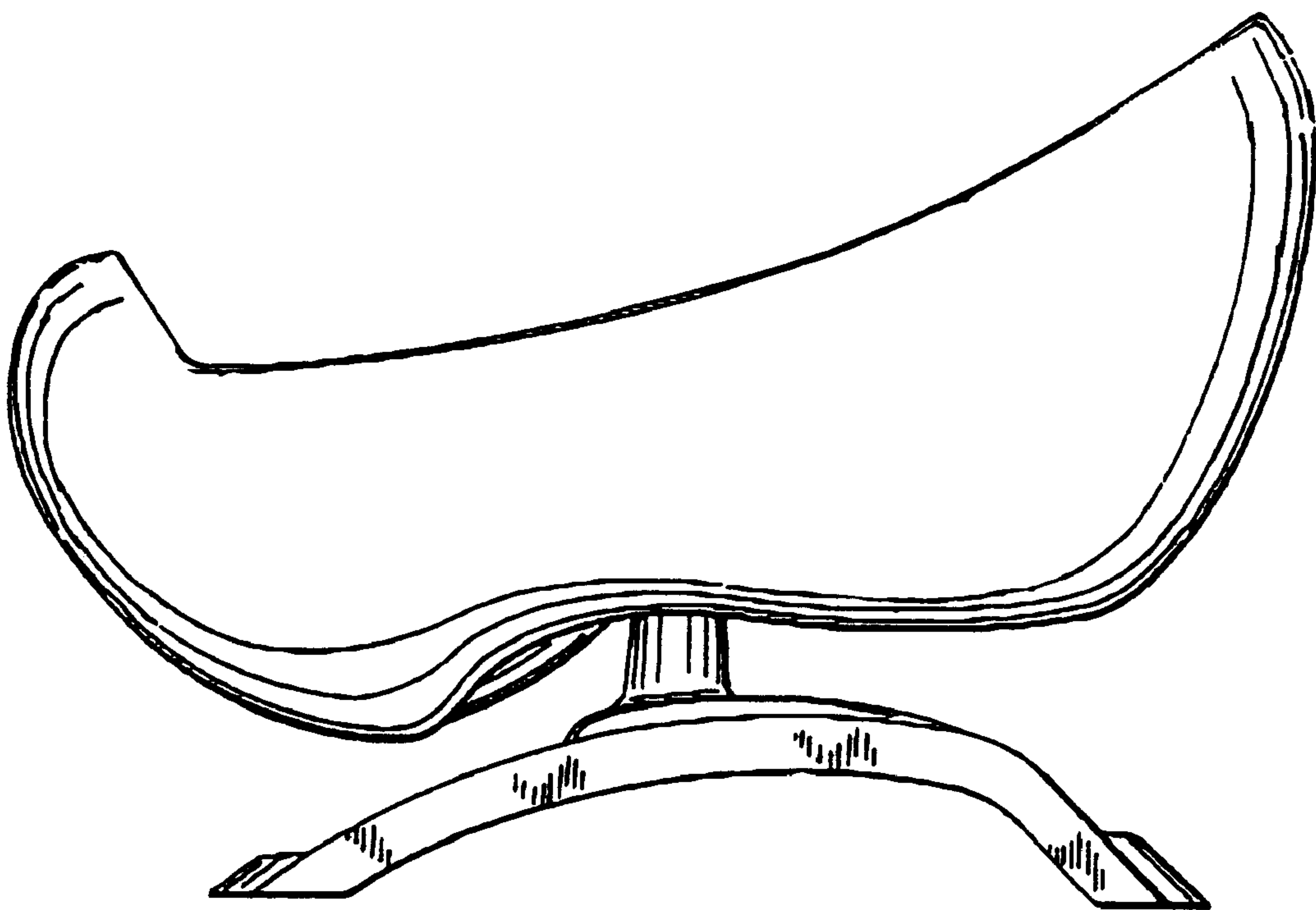

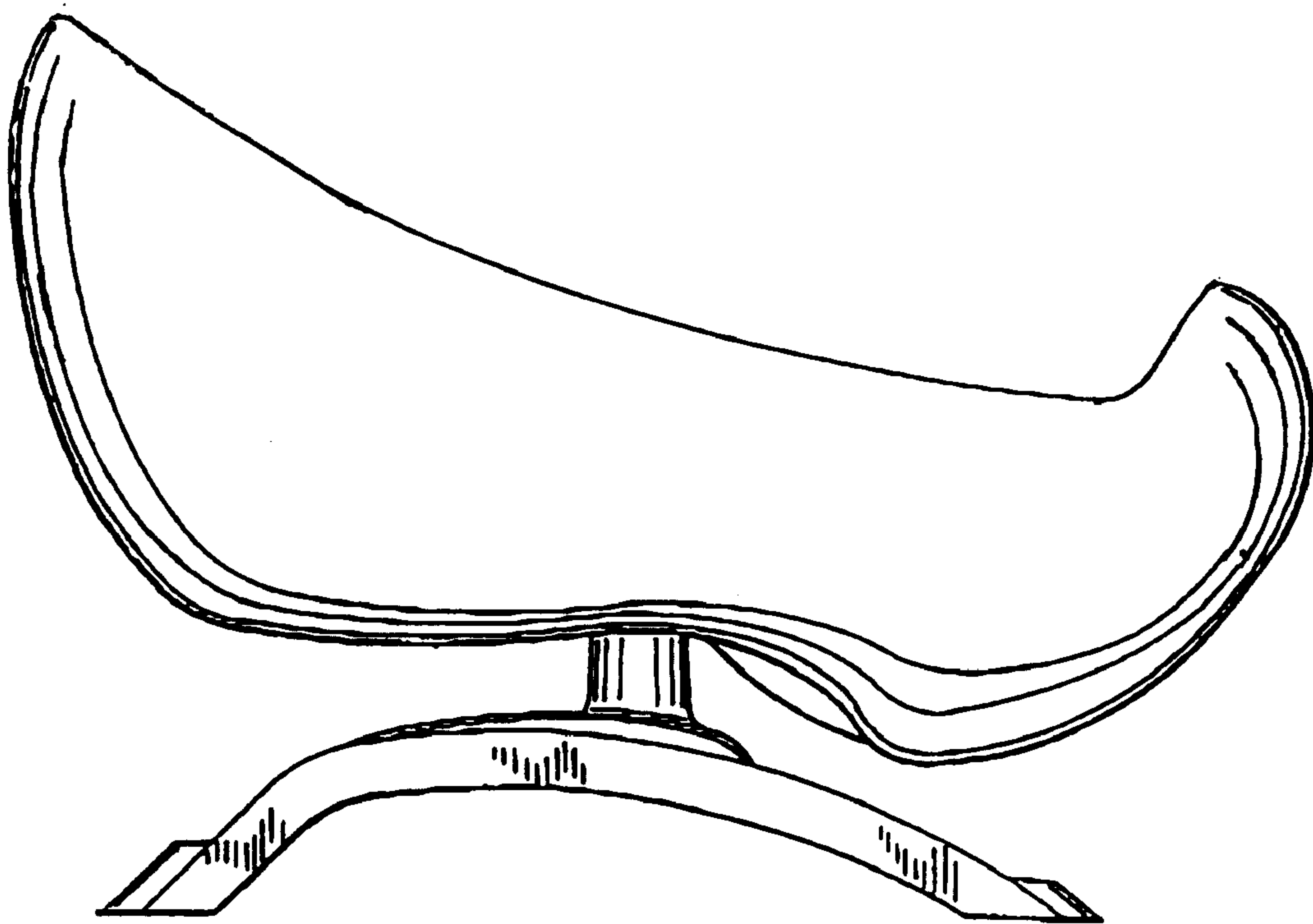

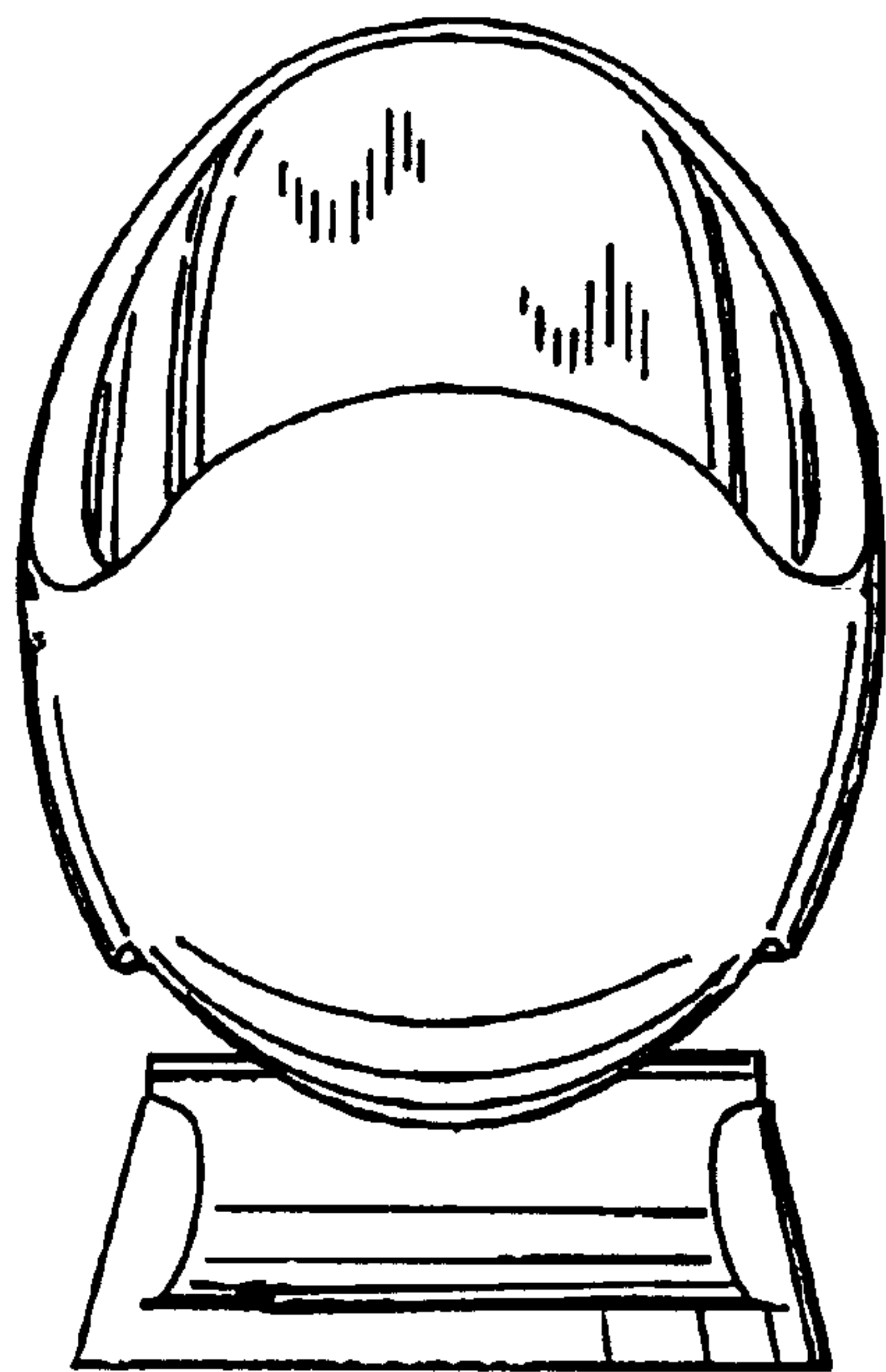

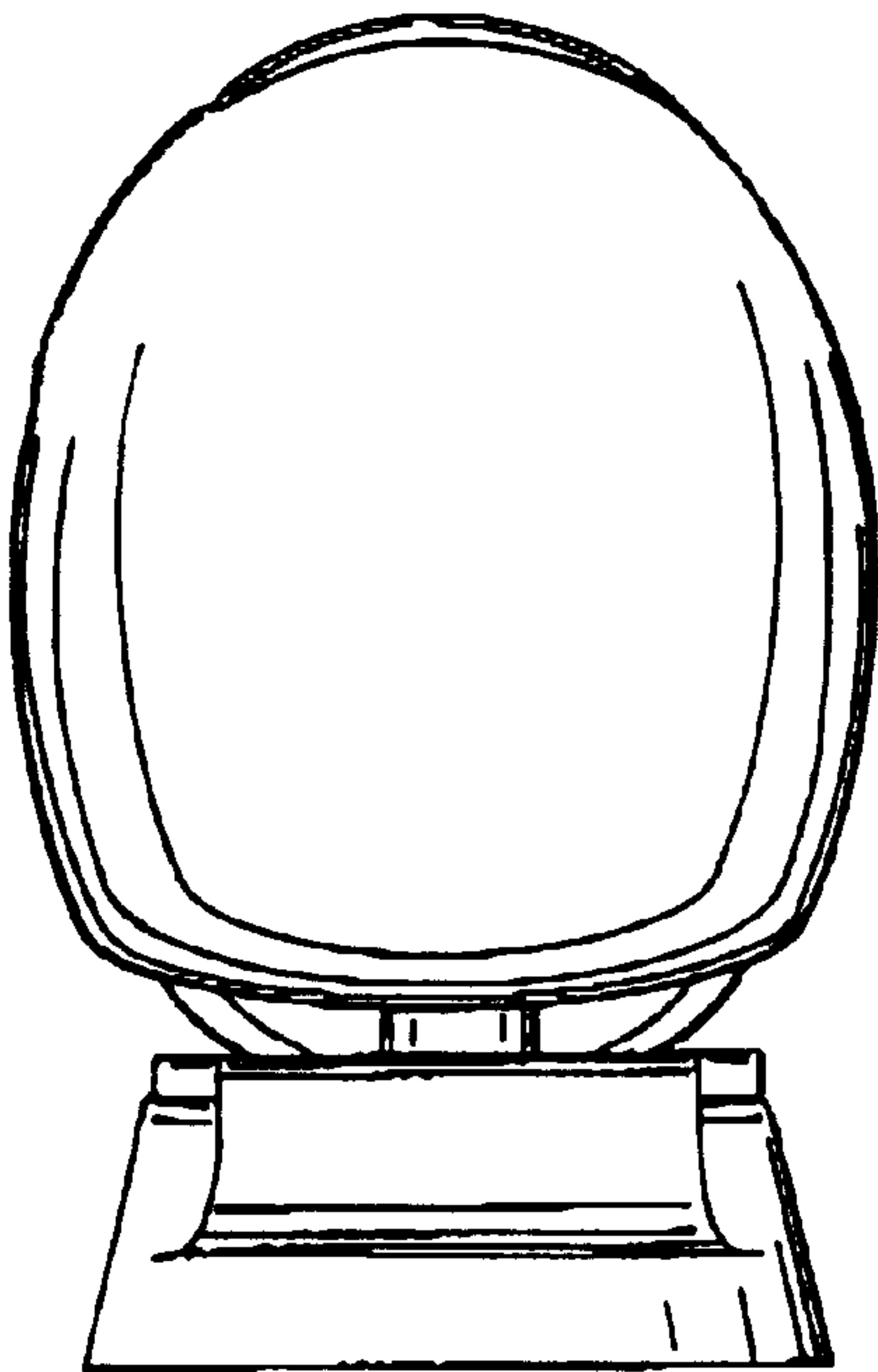

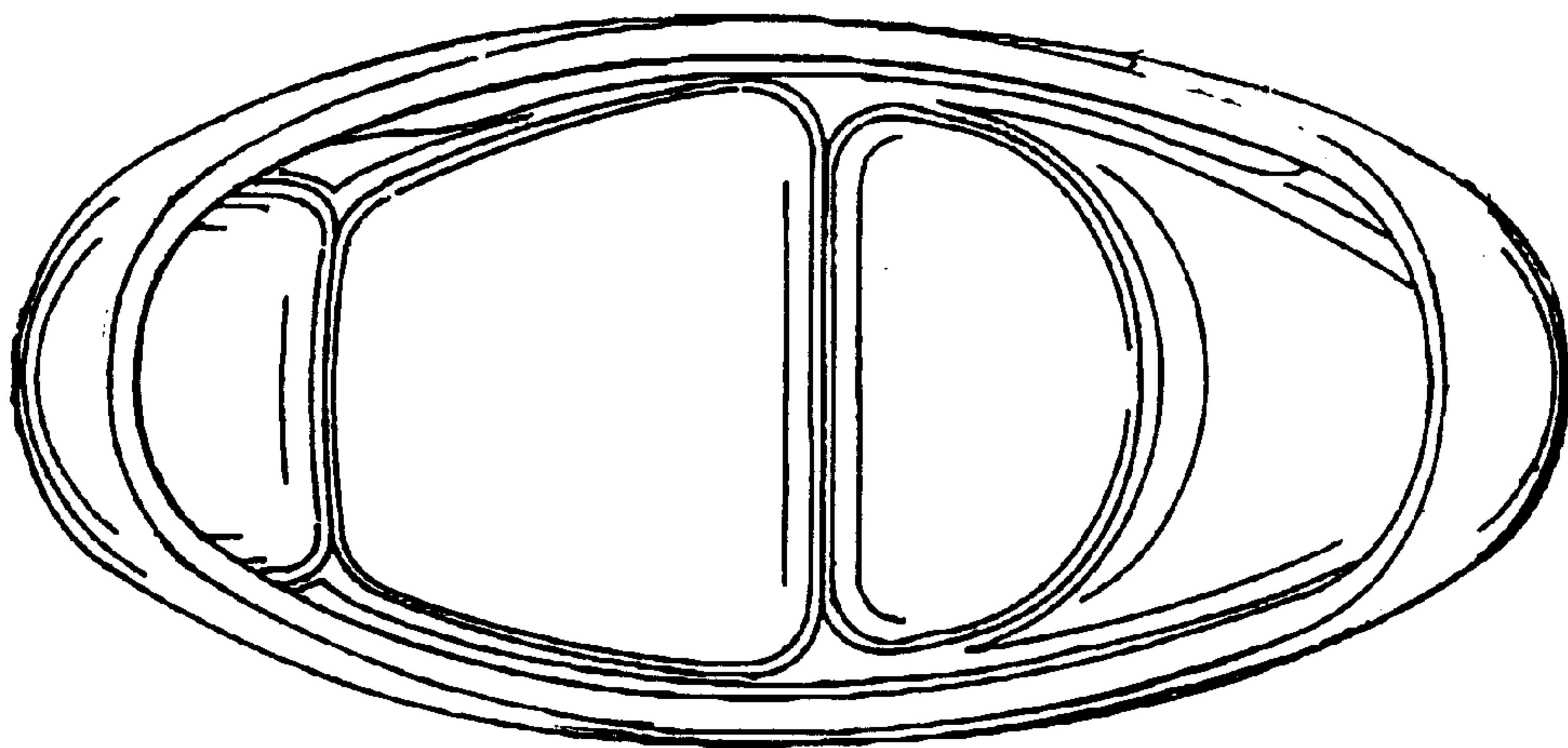

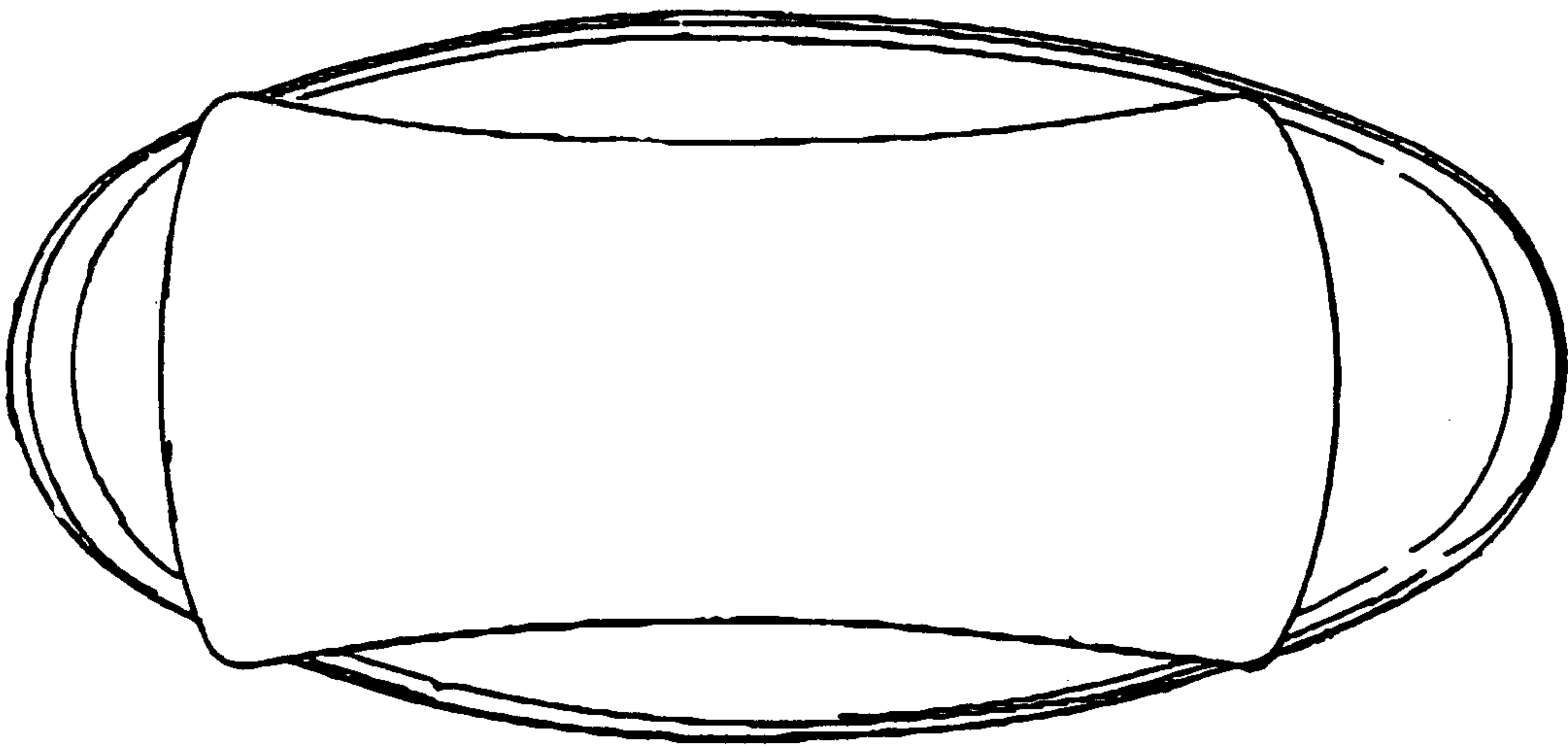
