(57) **CLAIM**

The ornamental design for a bath toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bath toy depicting our new design;

FIG. 2 is a front elevational view of the embodiment shown in FIG. 1;

FIG. 3 is a rear elevational view of the embodiment shown in FIGS. 1-2;

FIG. 4 is a first side elevational view of the embodiment shown in FIGS. 1-3;

FIG. 5 is a second side elevational view of the embodiment shown in FIGS. 1-4;

FIG. 6 is a top plan view of the embodiment shown in FIGS. 1-5; and,

FIG. 7 is a bottom plan view of the embodiment shown in FIGS. 1-6.

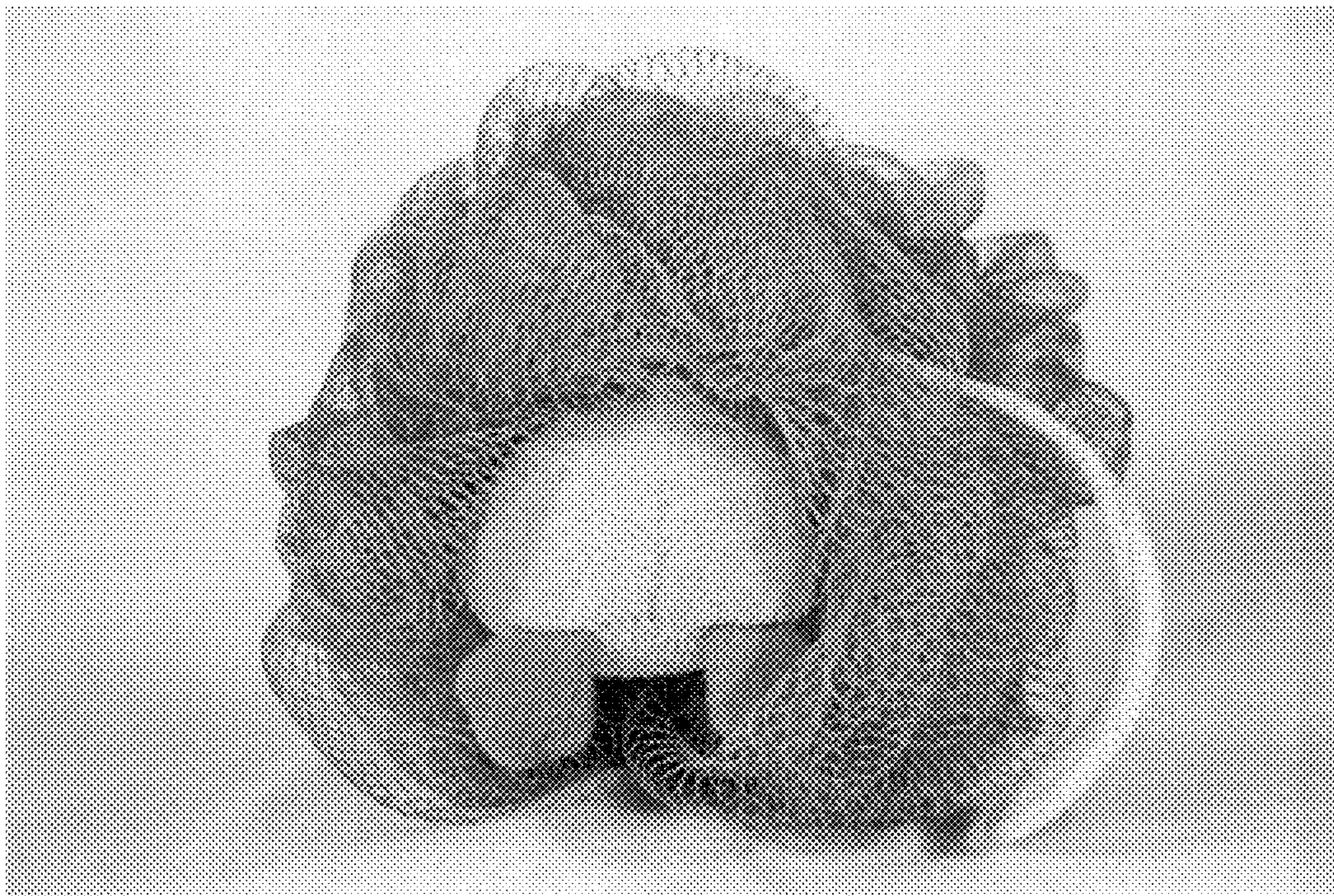

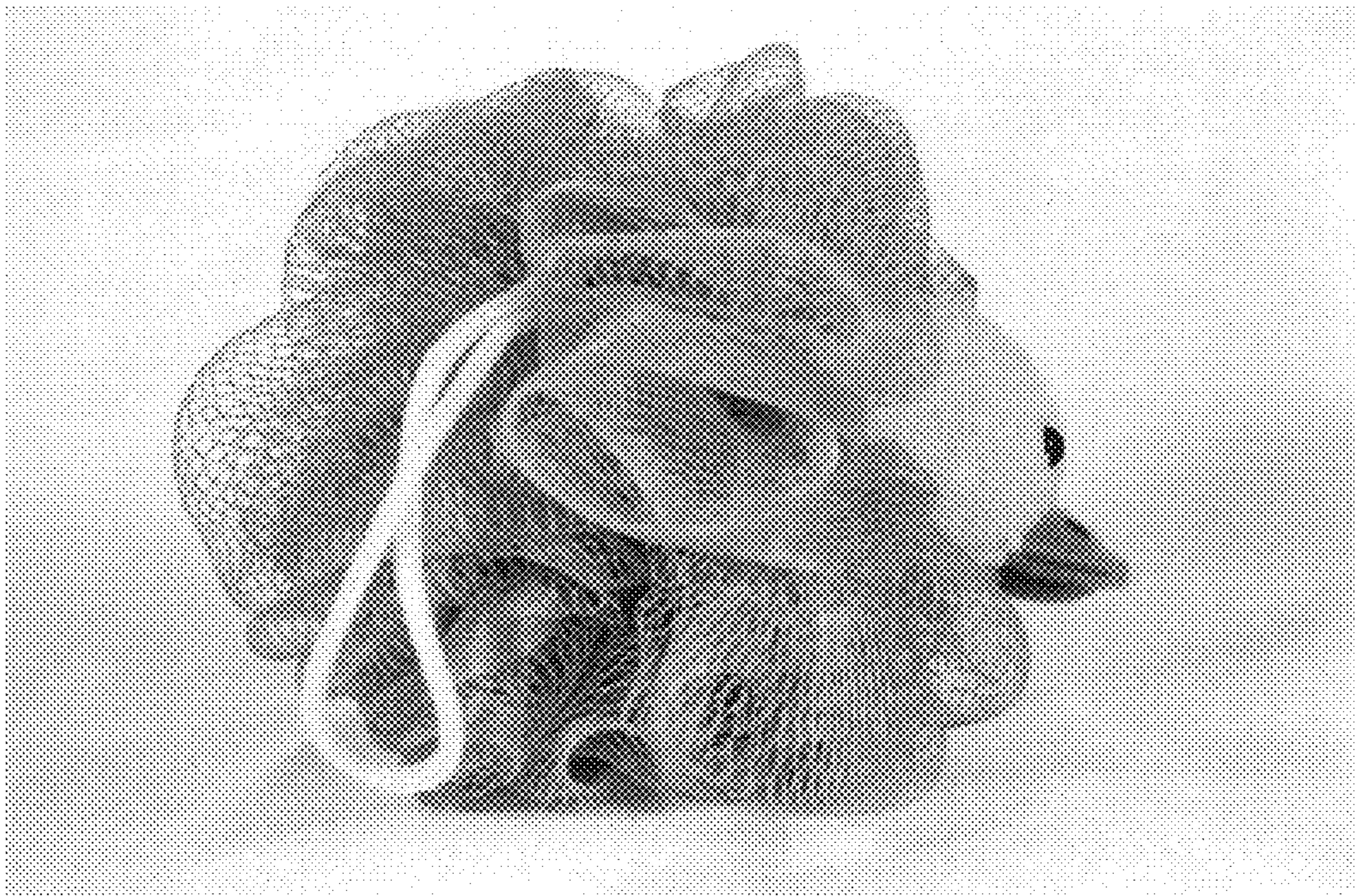

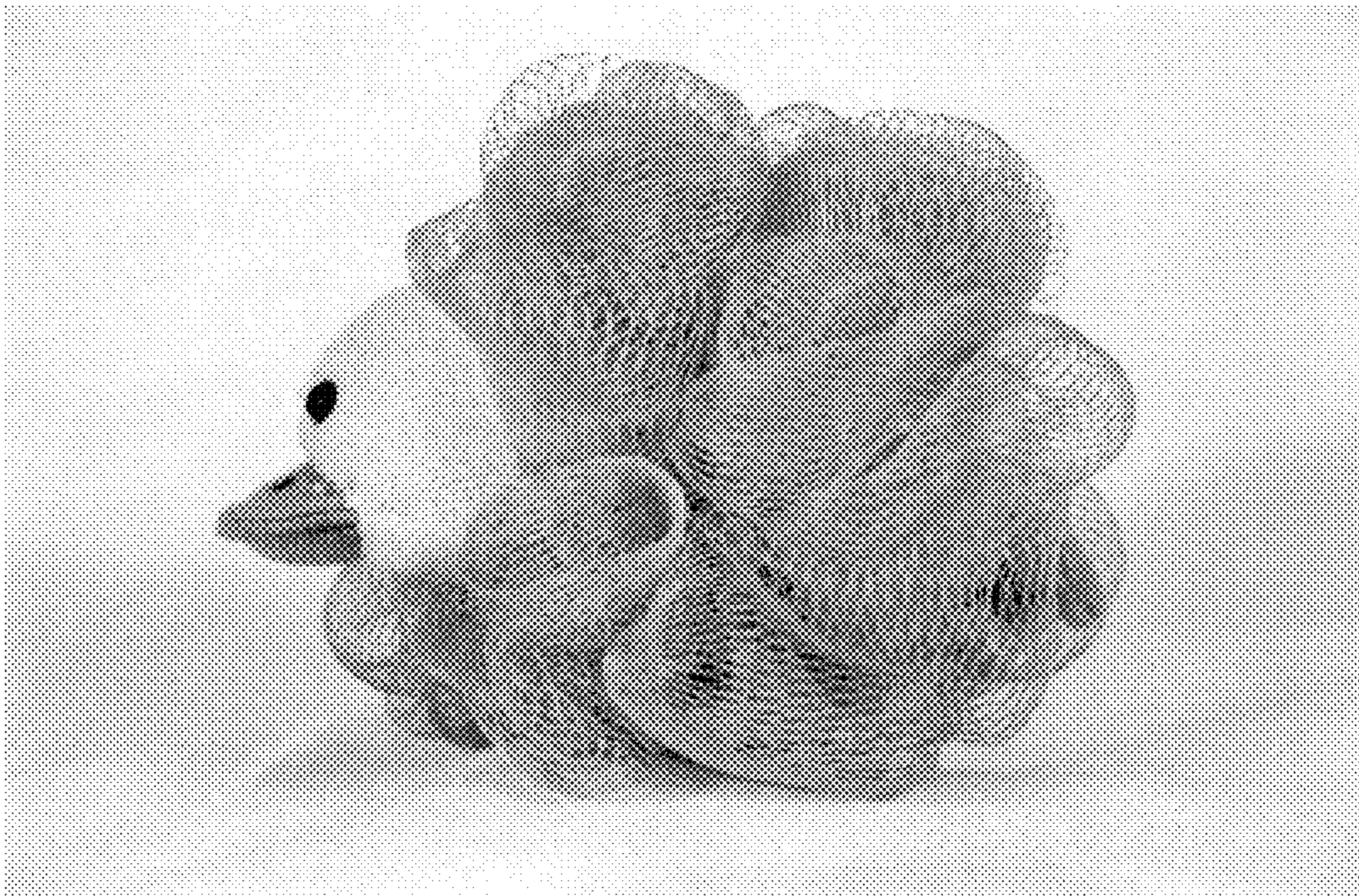

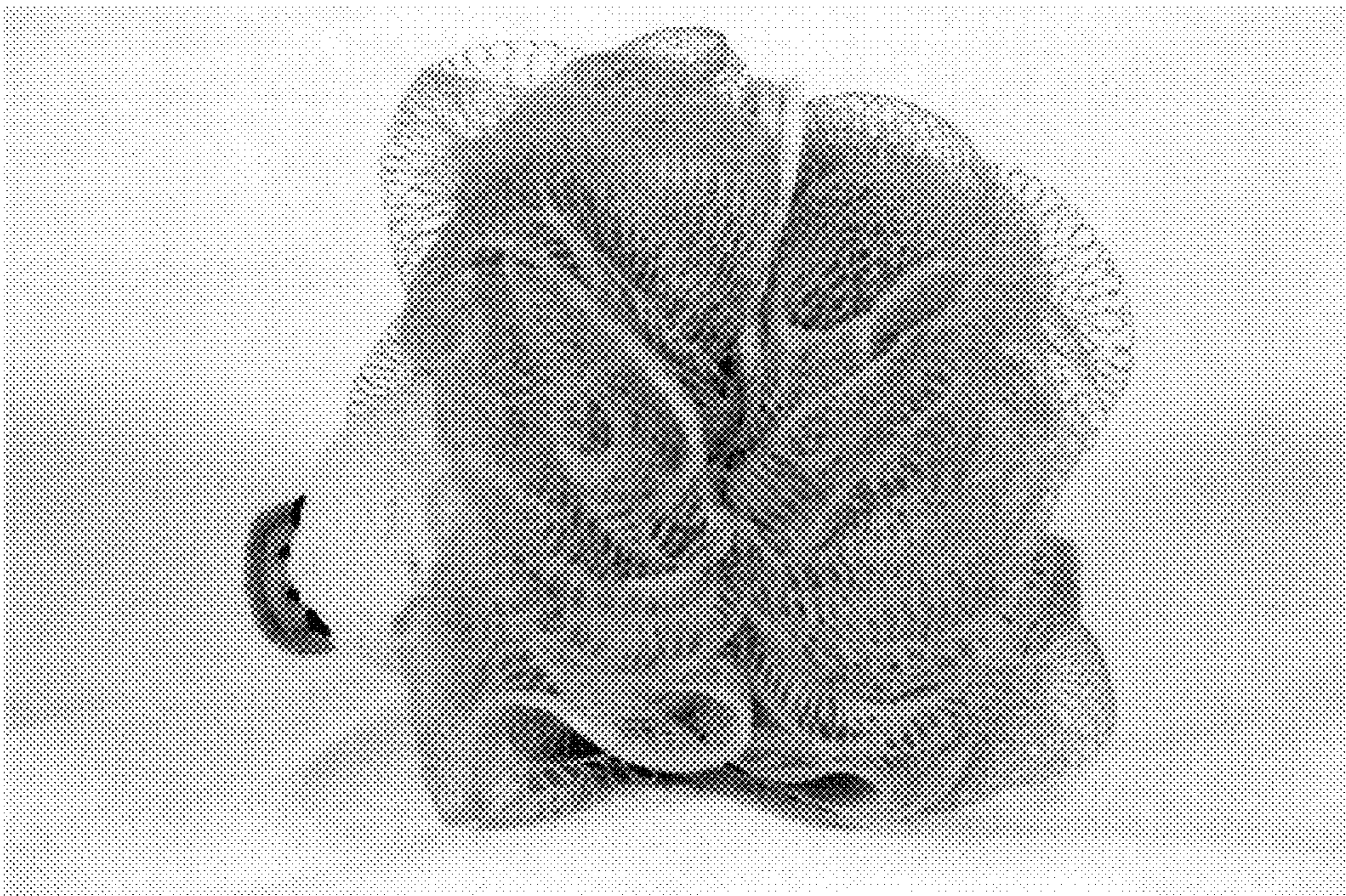
