FIG. 3 is a left side elevational view thereof;

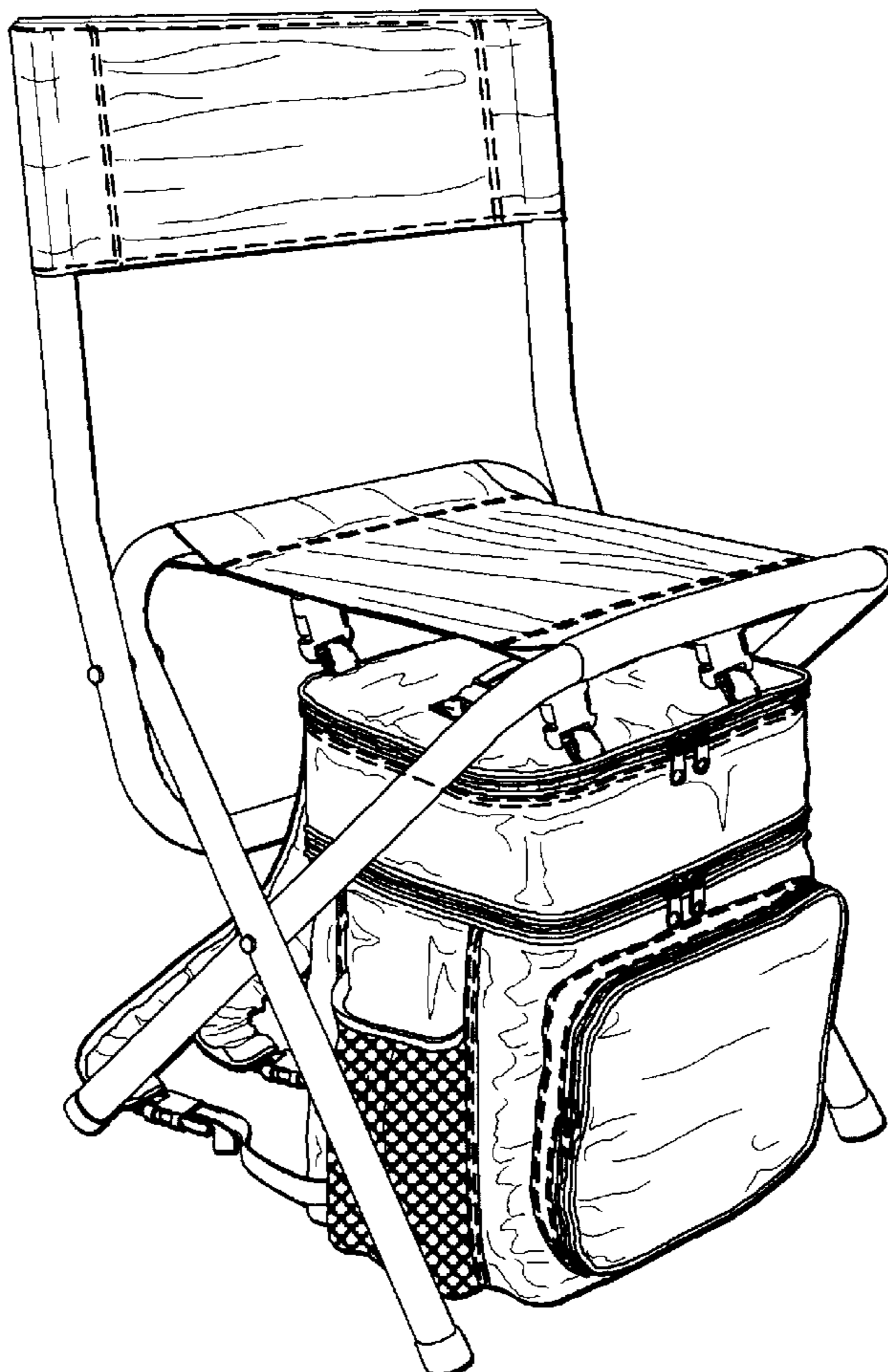
FIG. 4 a right side elevational view thereof;

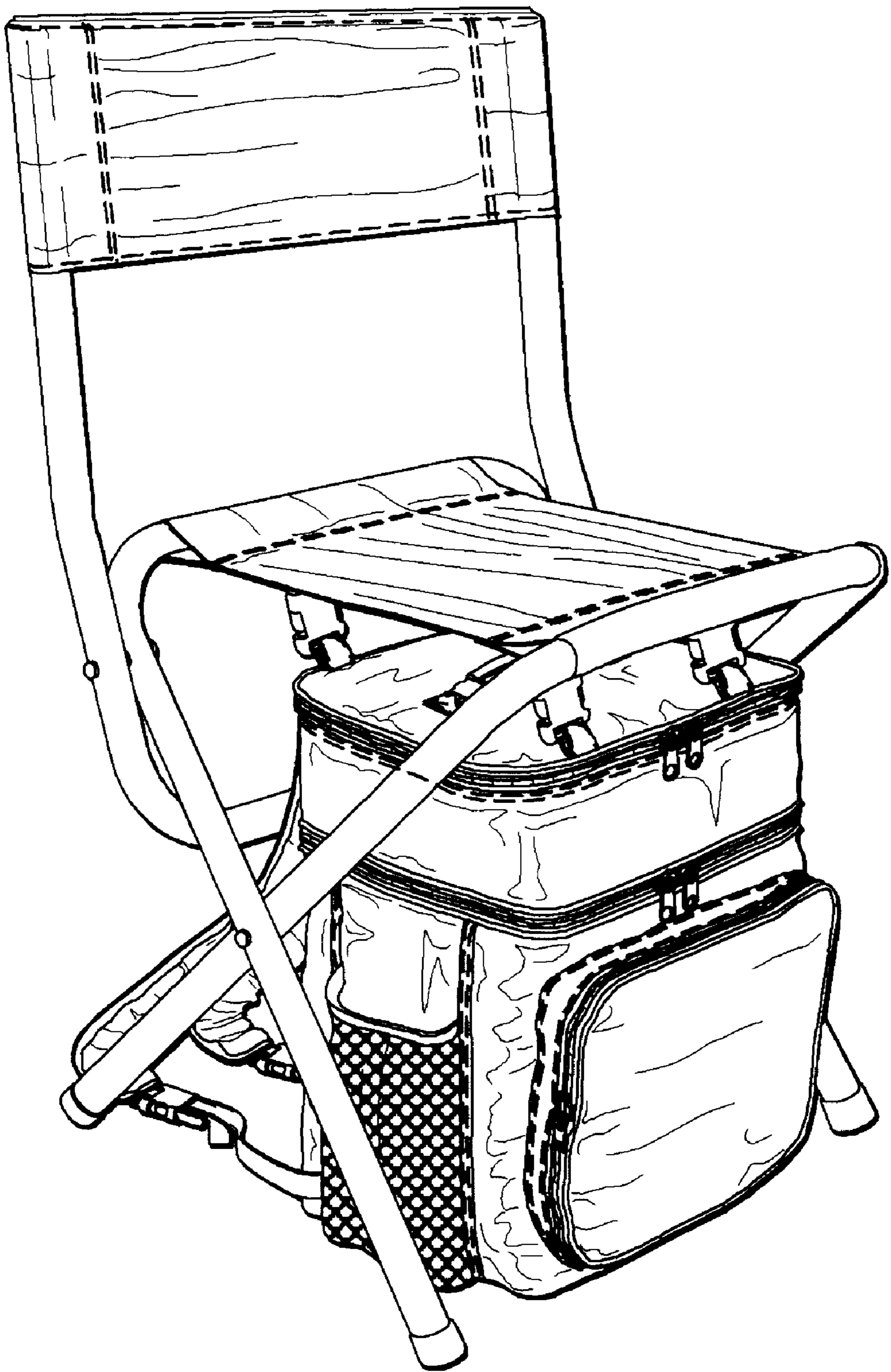
FIG. 5 a rear elevational view thereof;

FIG. 6 a top plan view thereof; and,

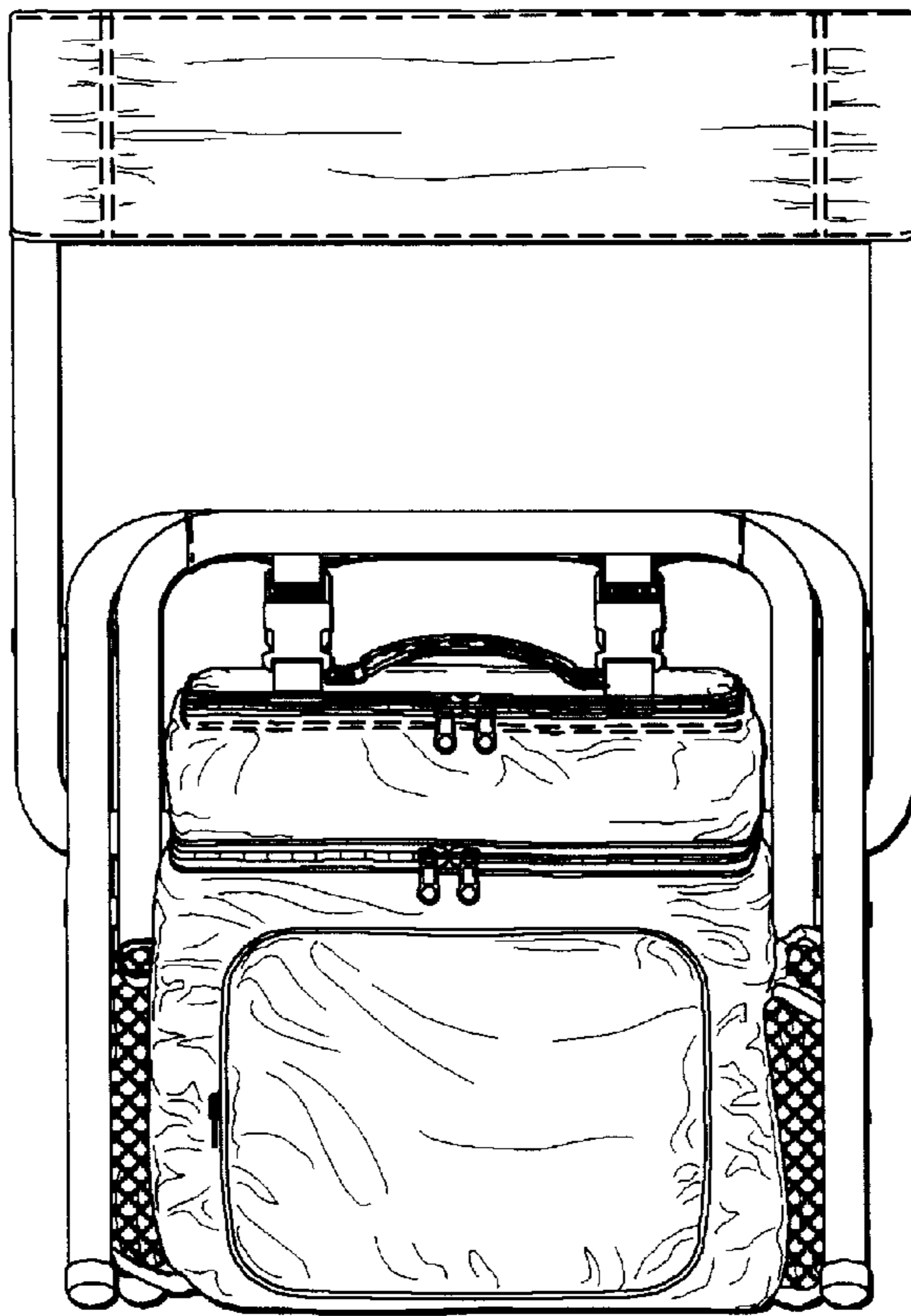
FIG. 7 a bottom plan view thereof.

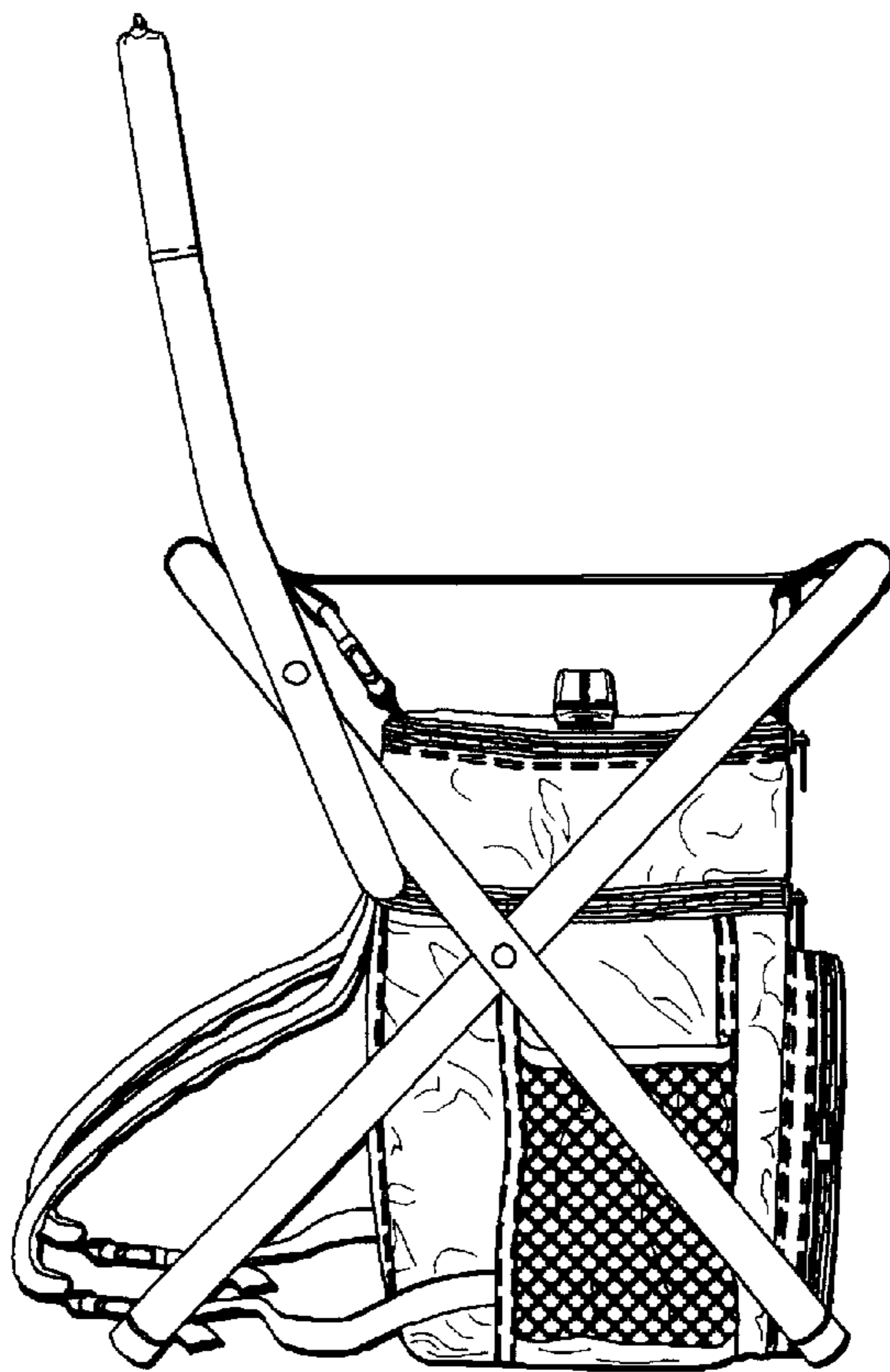




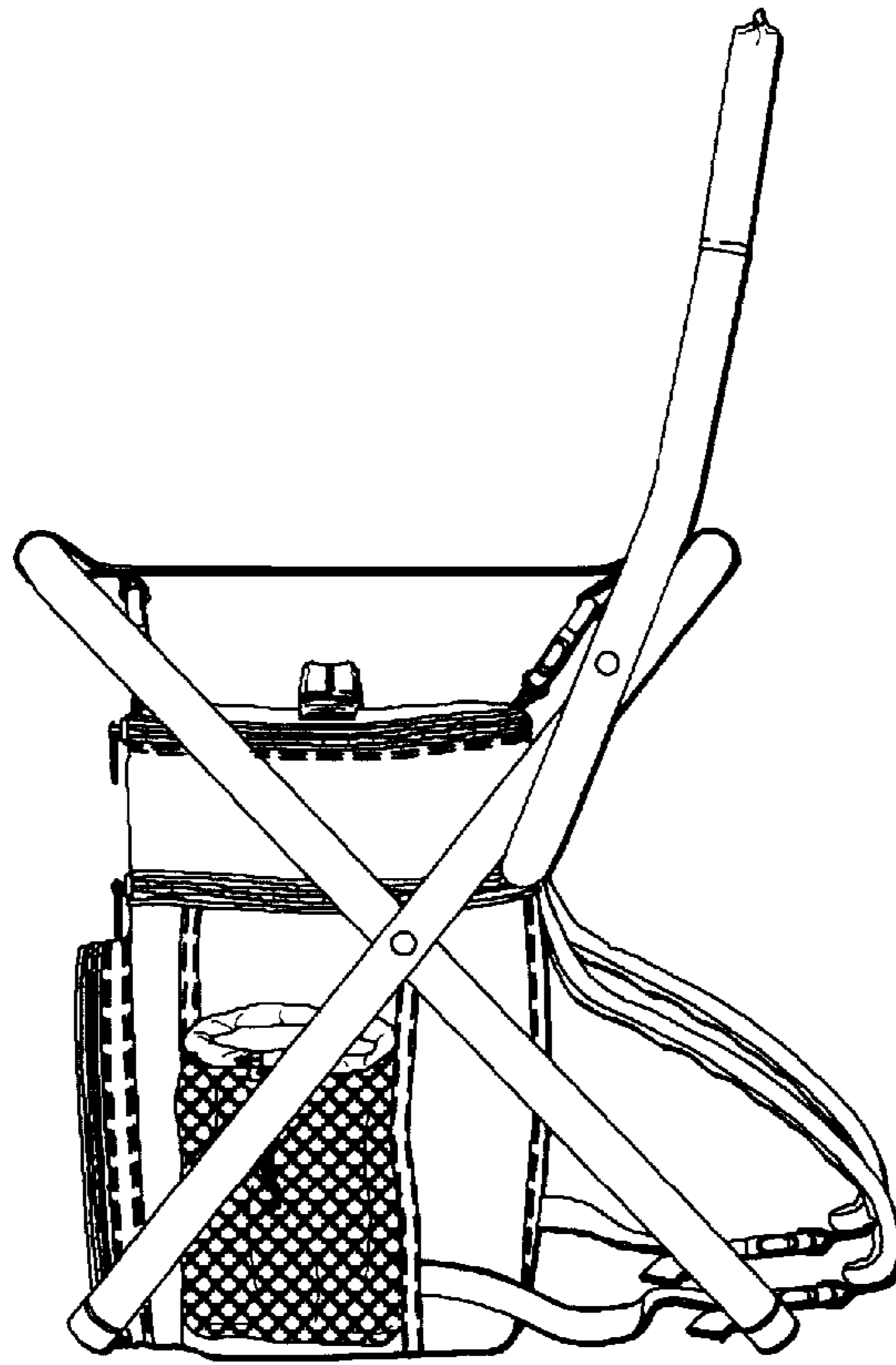

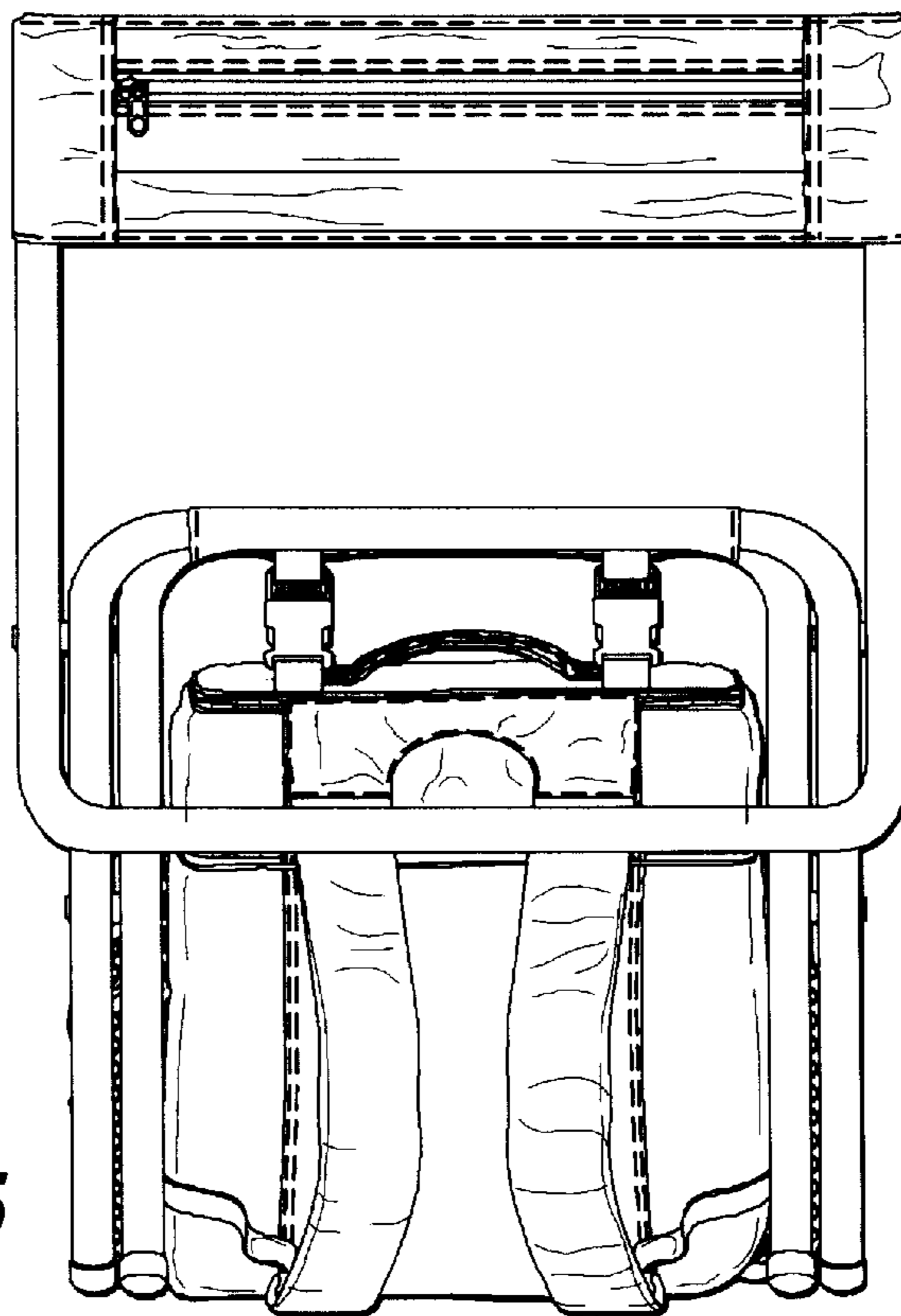

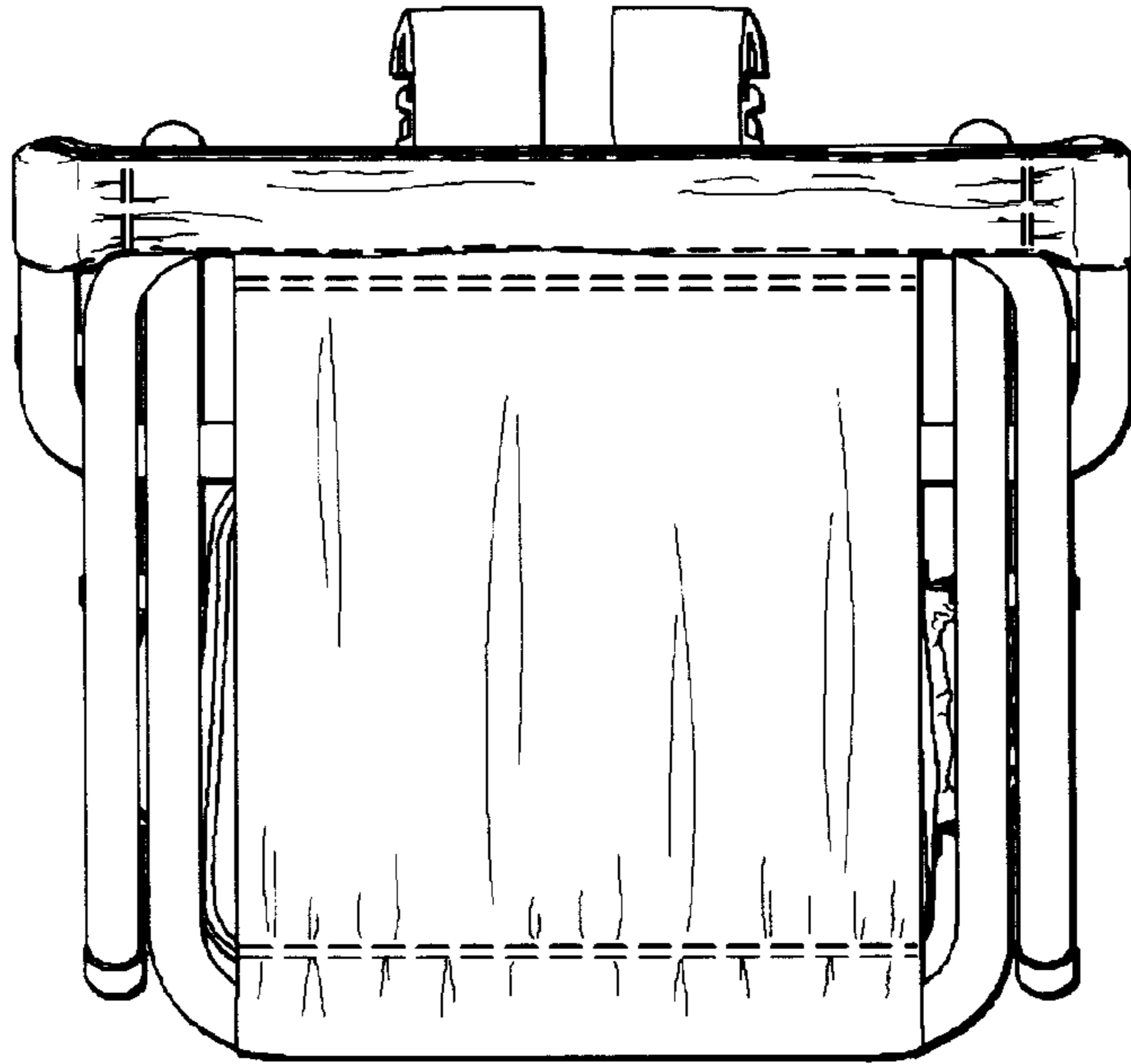

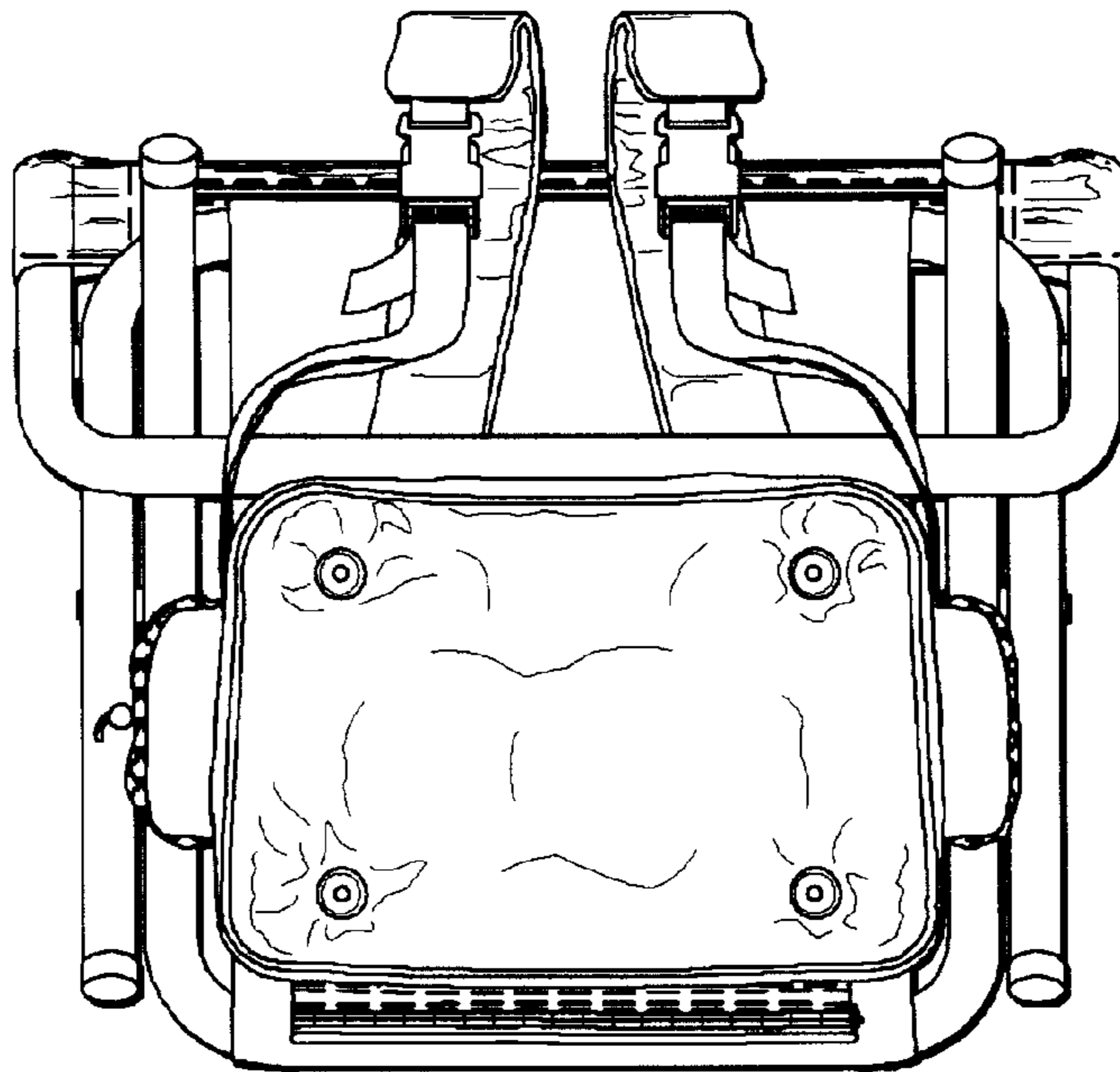
