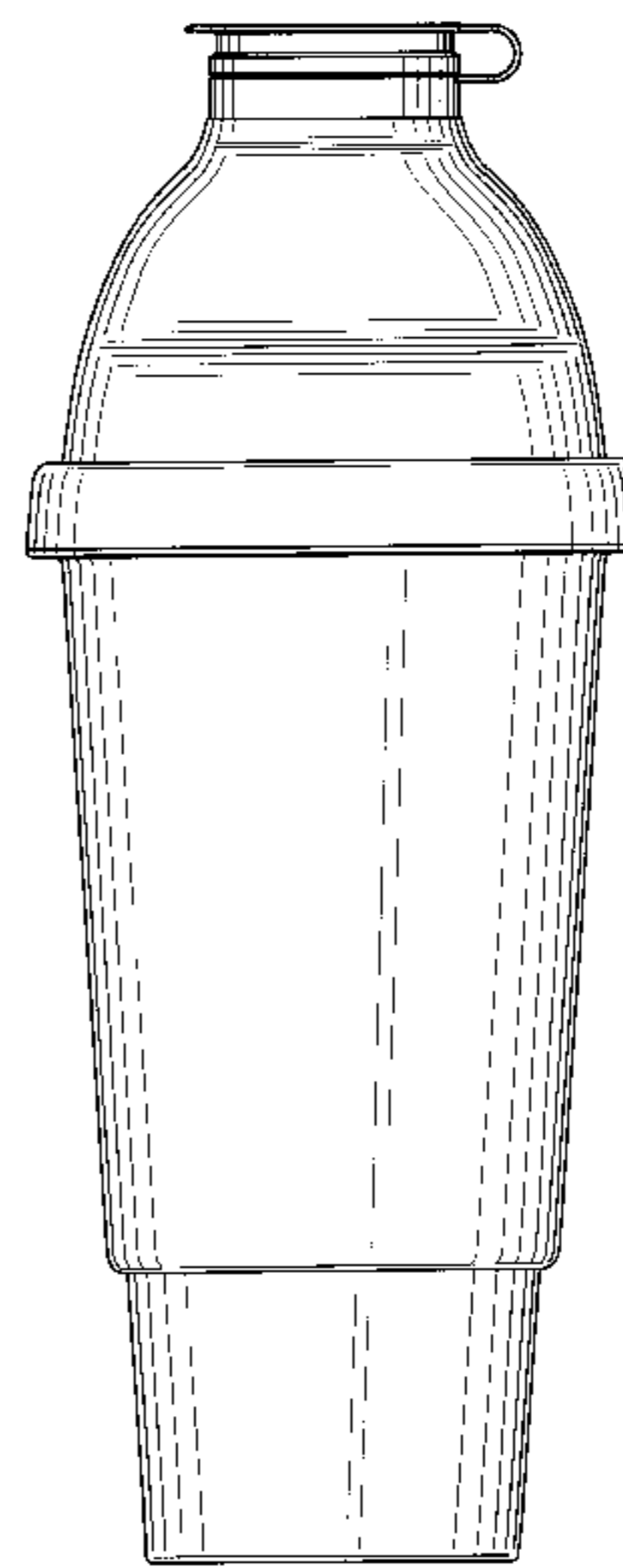
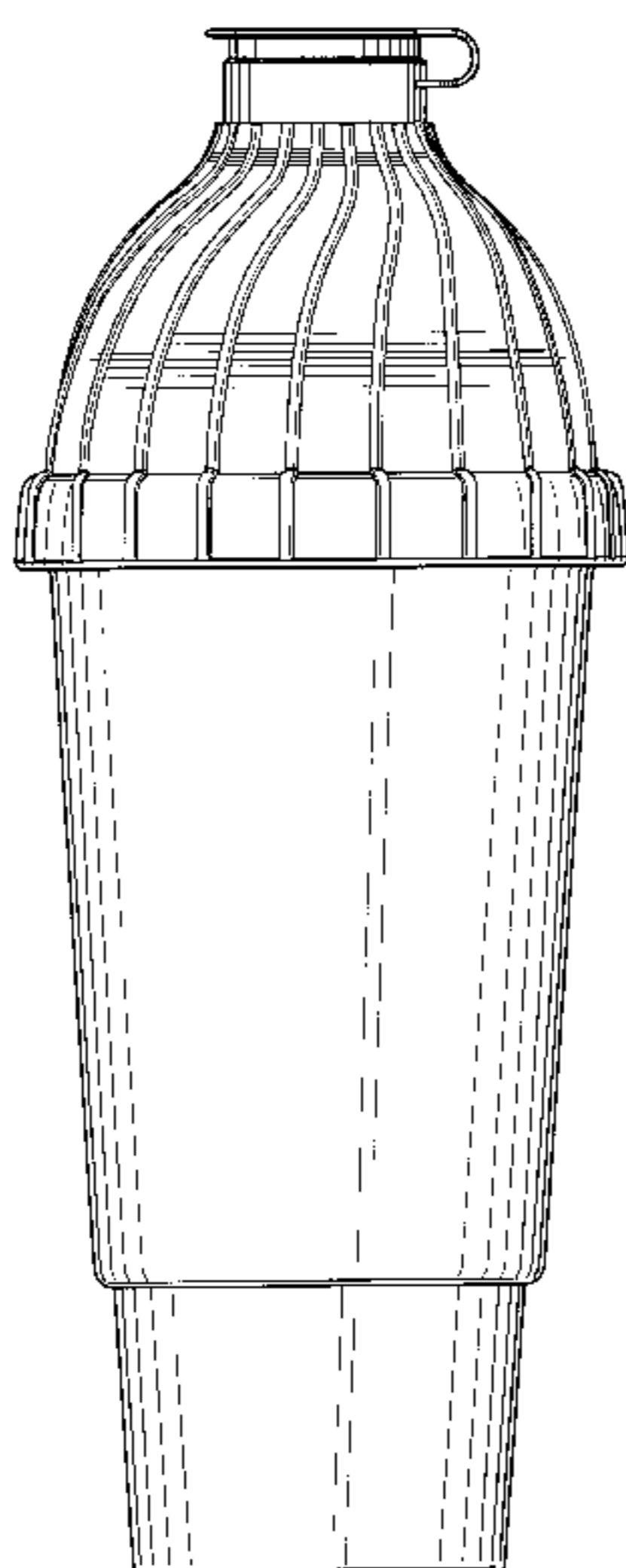
The ornamental design for a cup, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cup design of the present invention;

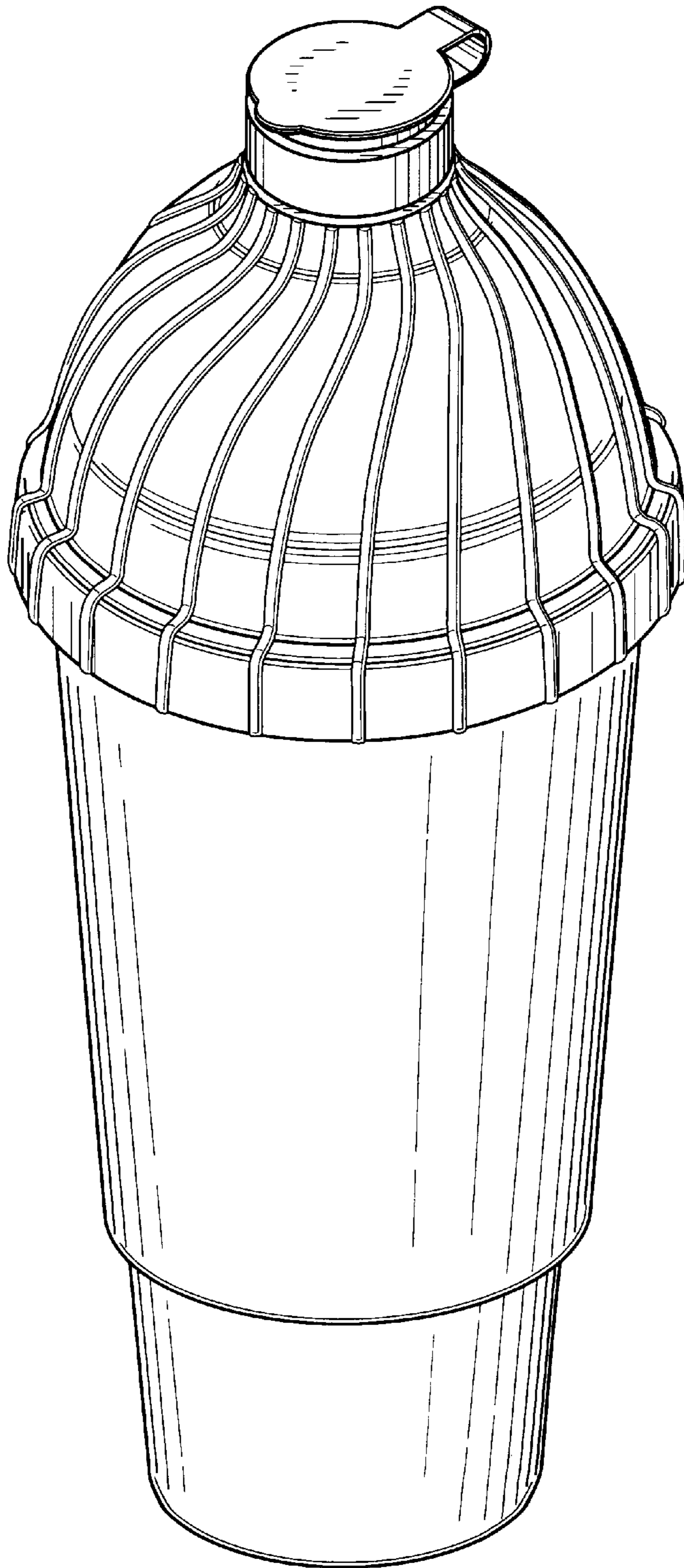

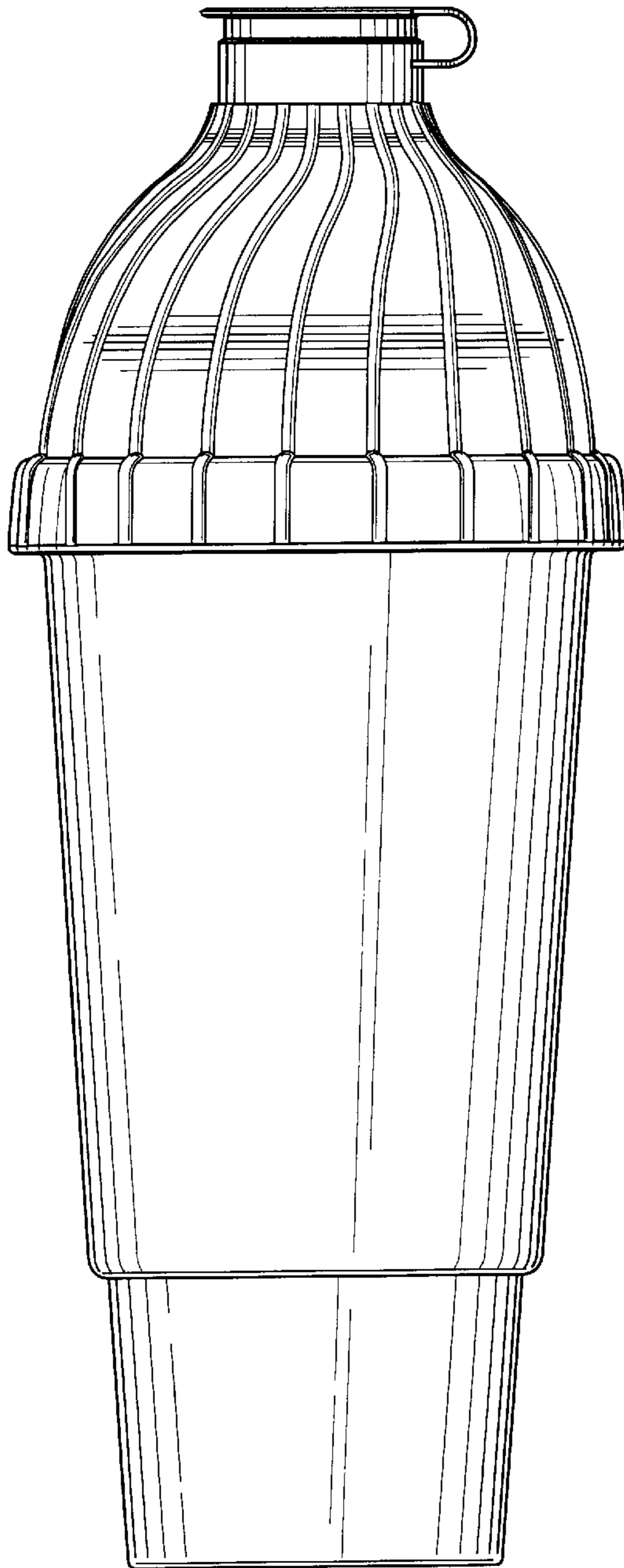

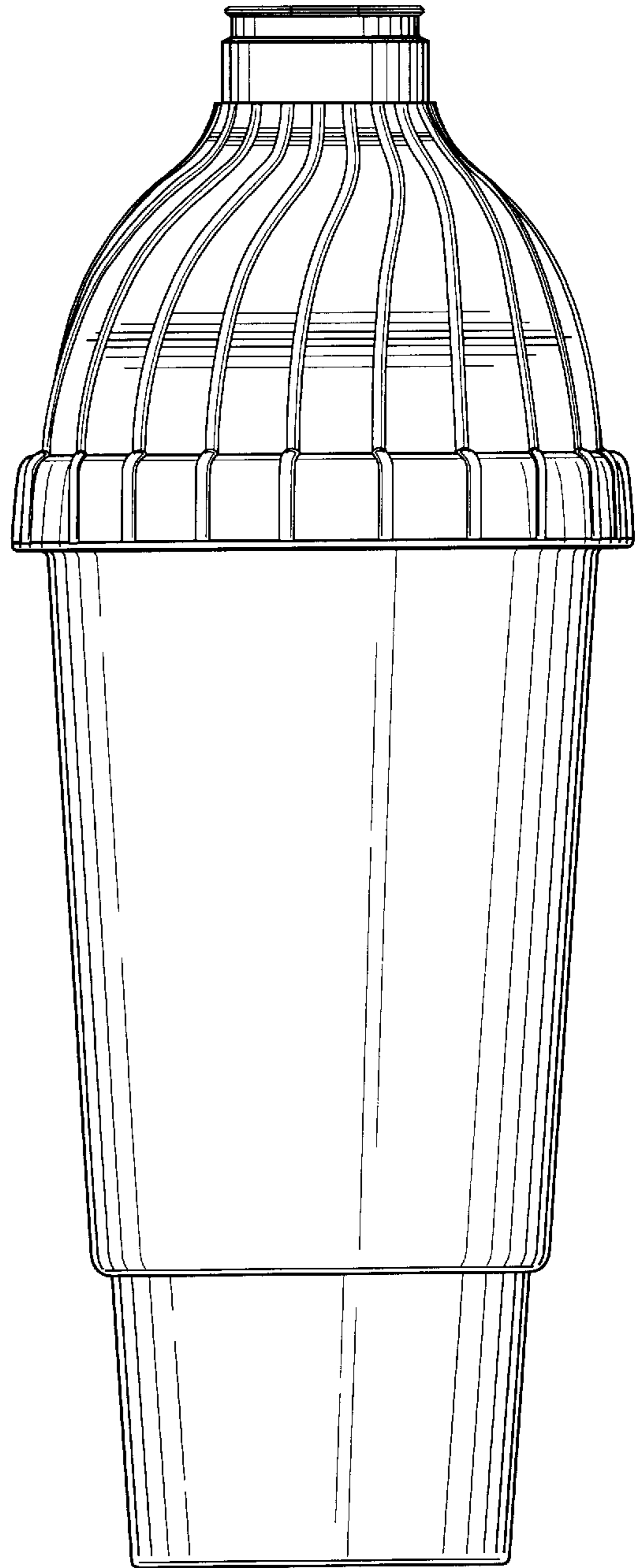

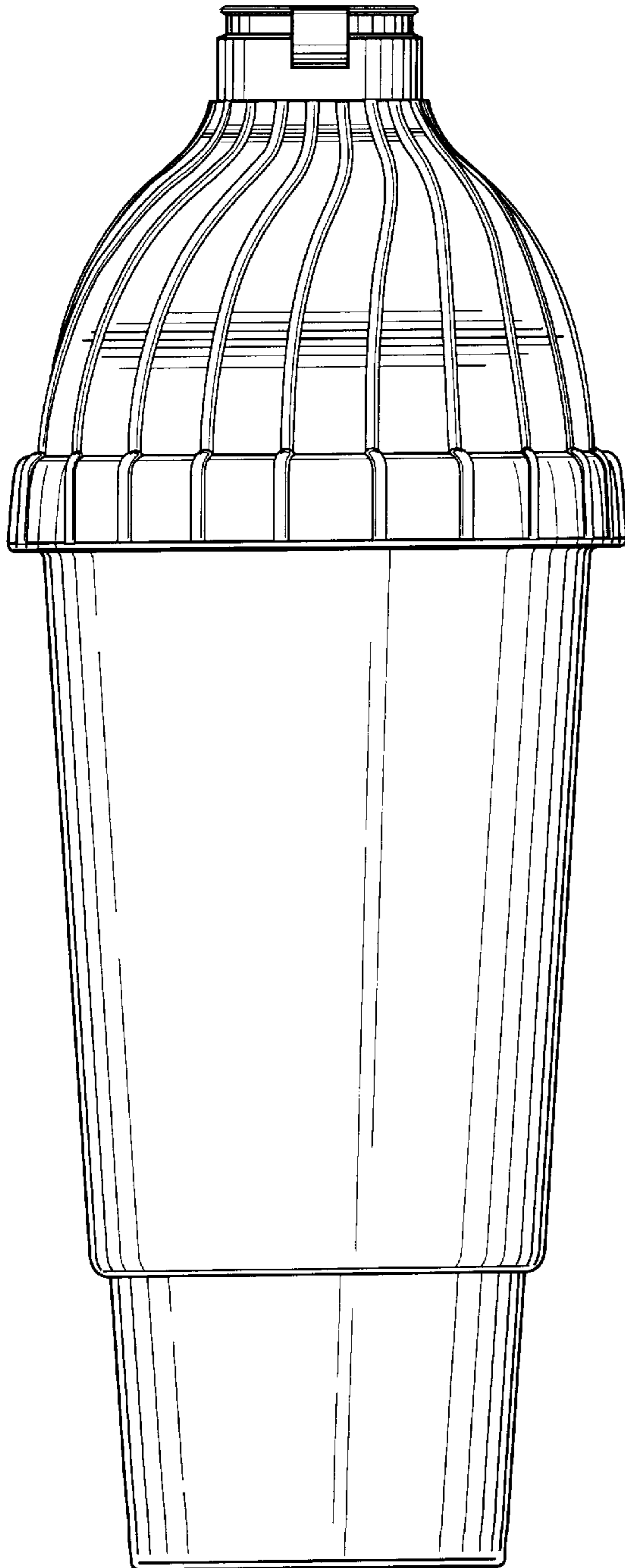

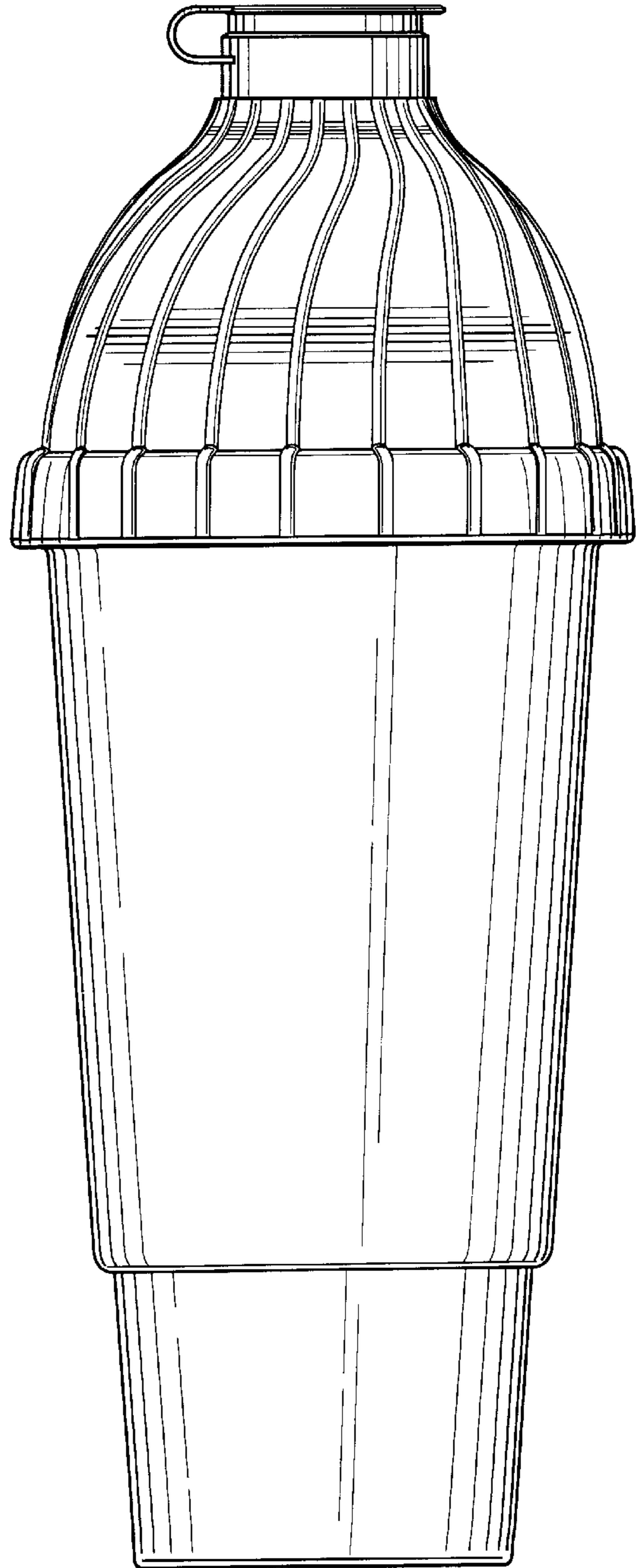

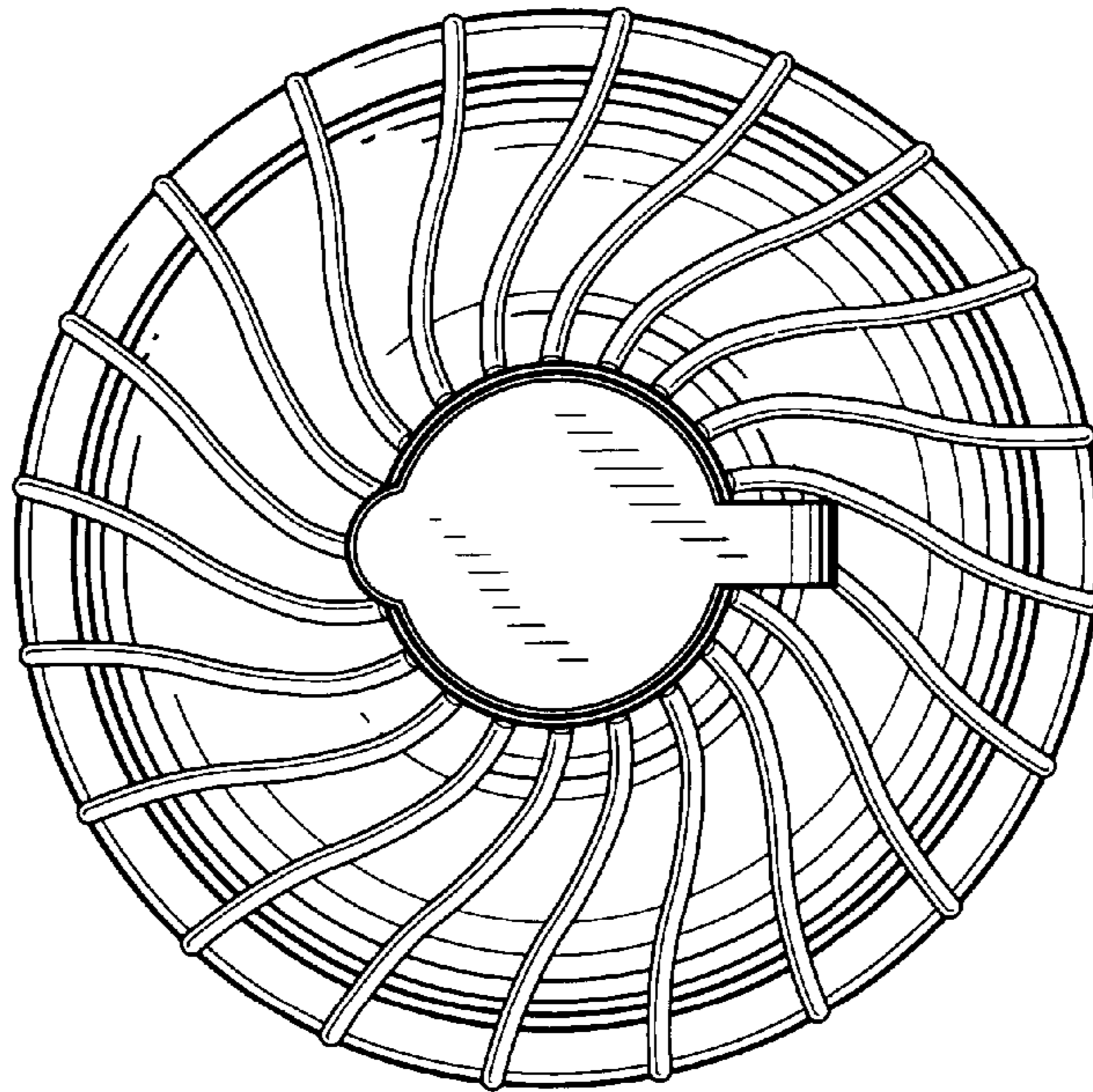

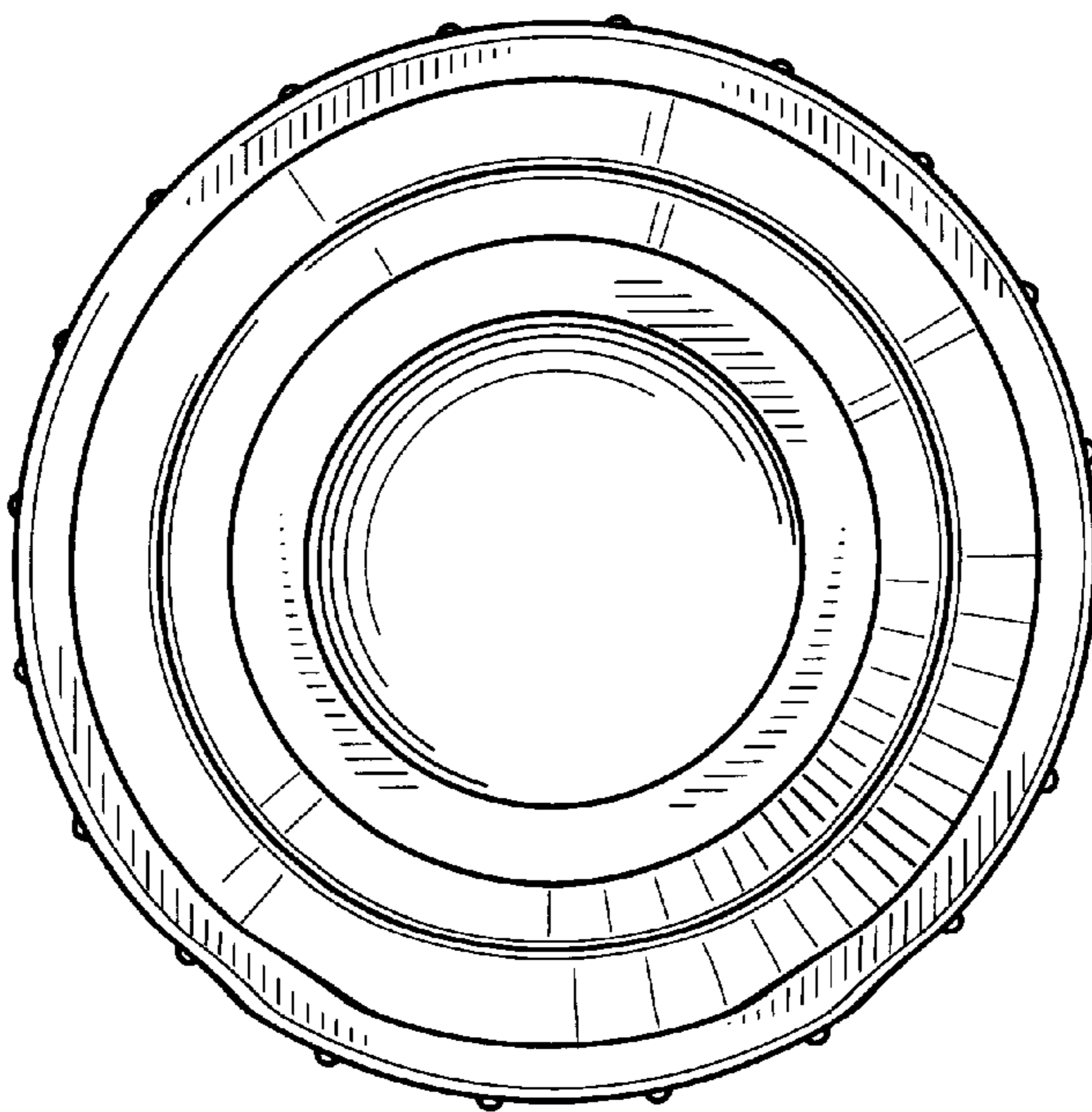

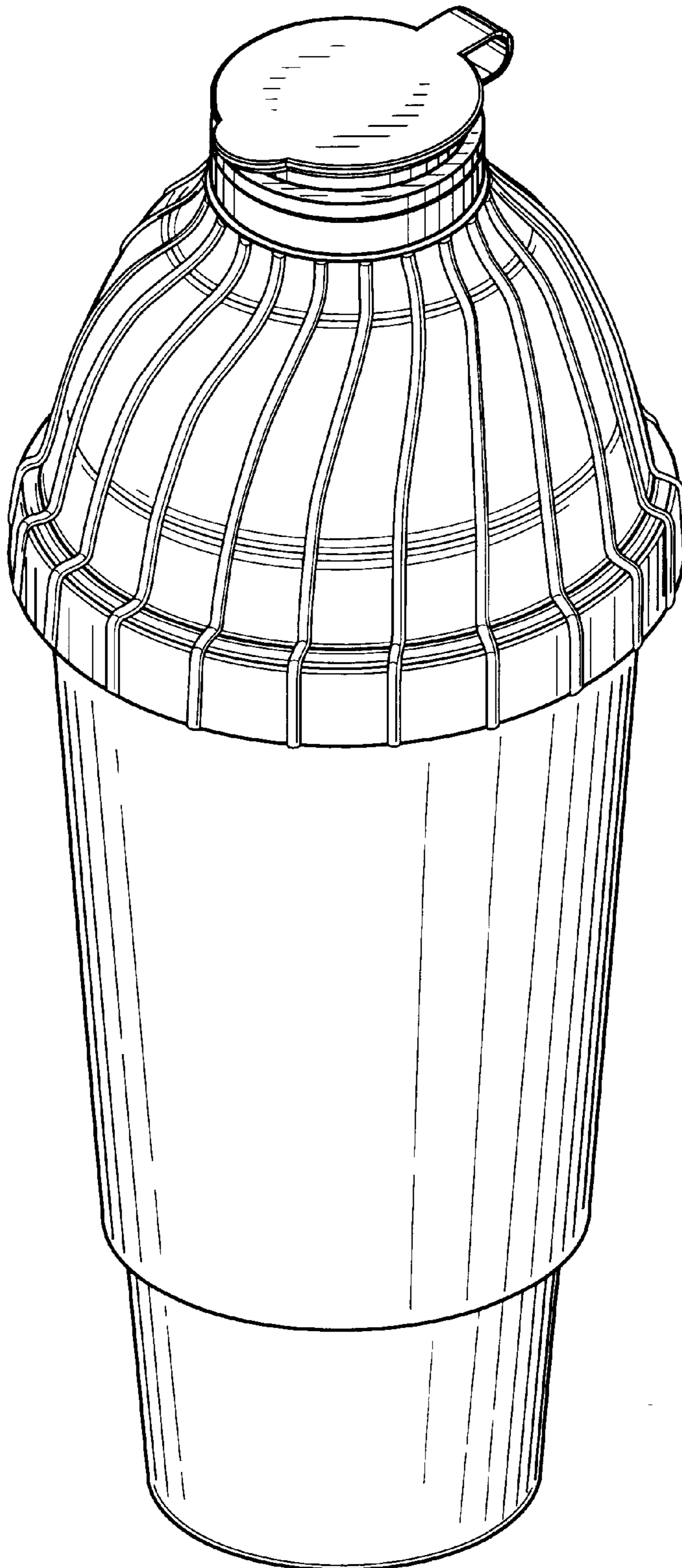

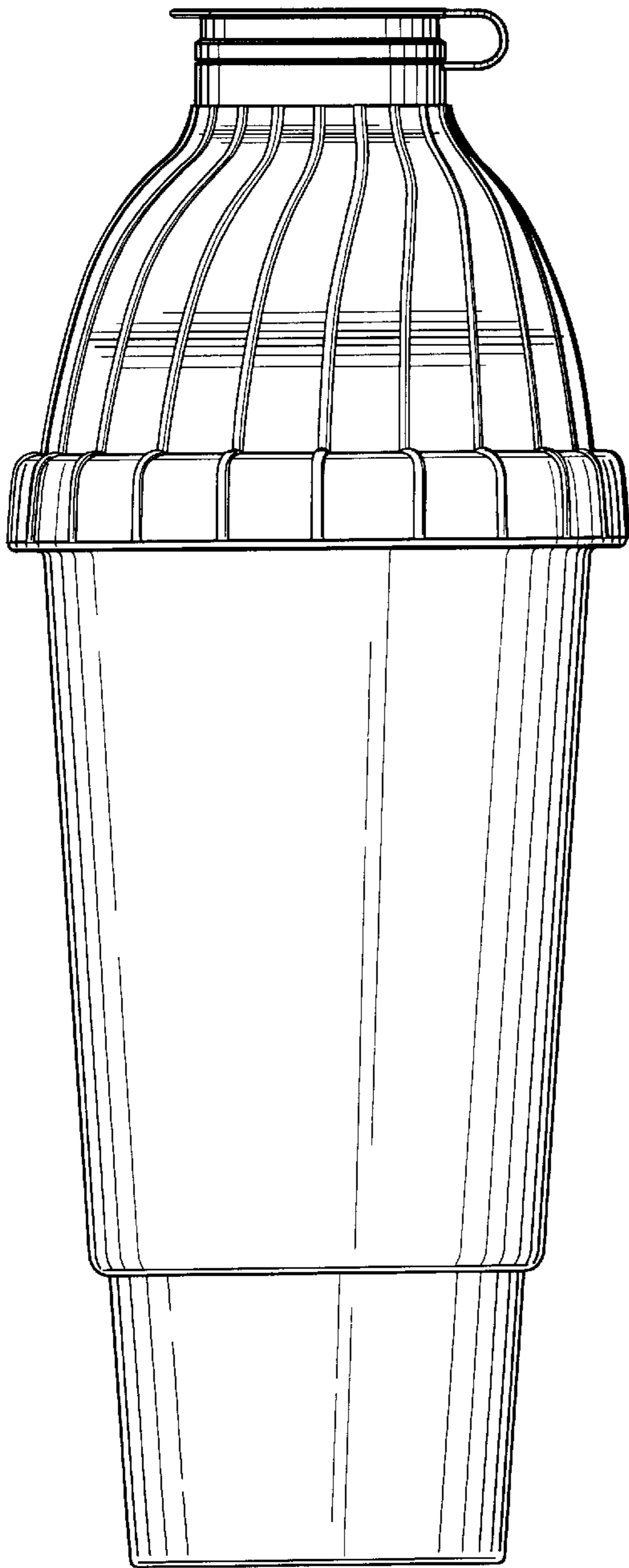

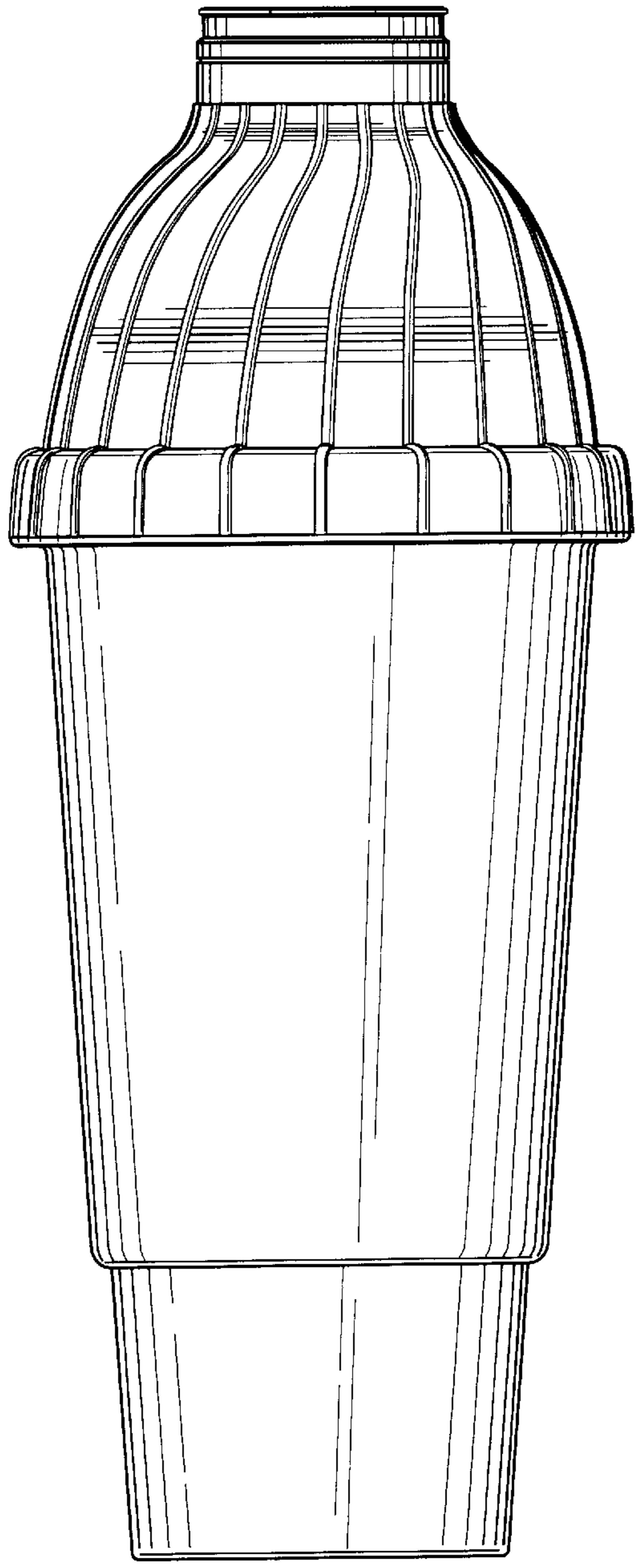

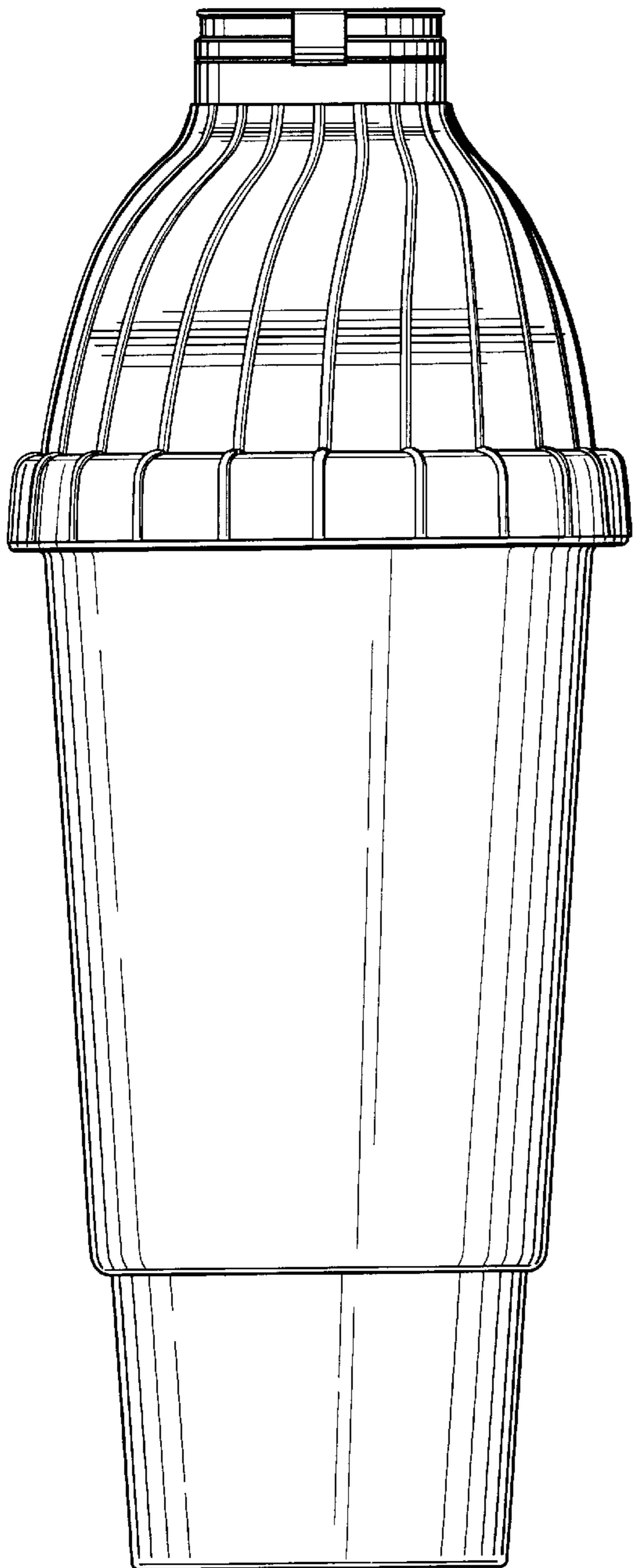

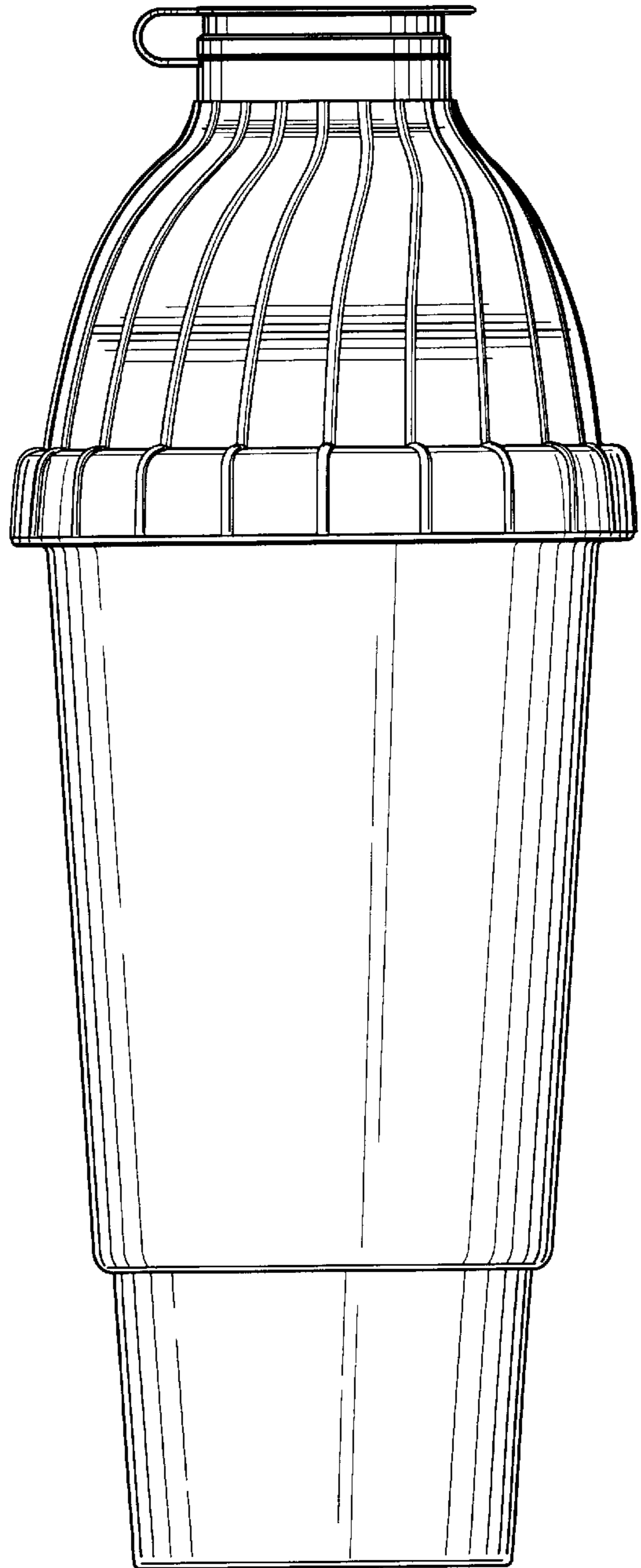

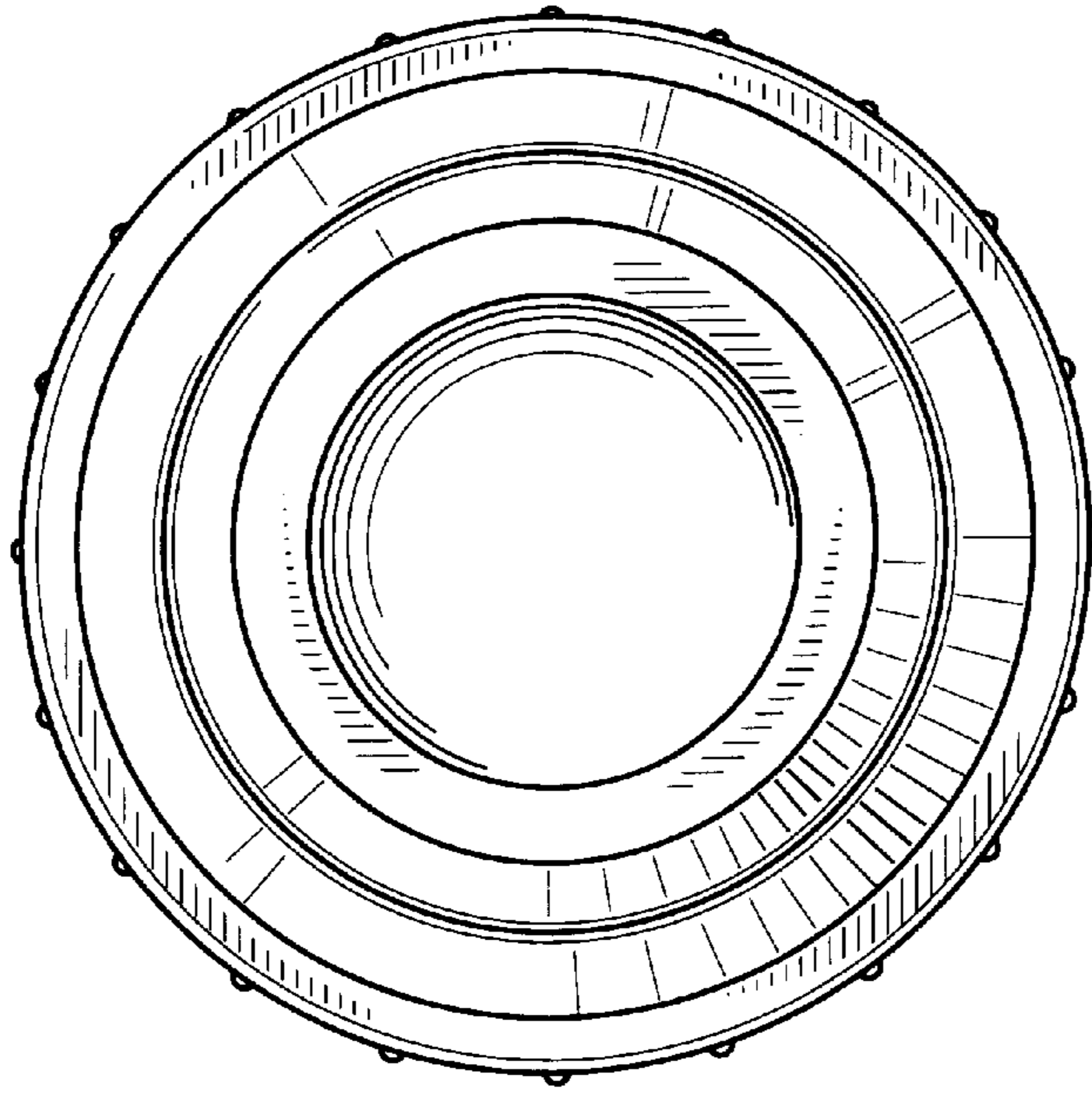

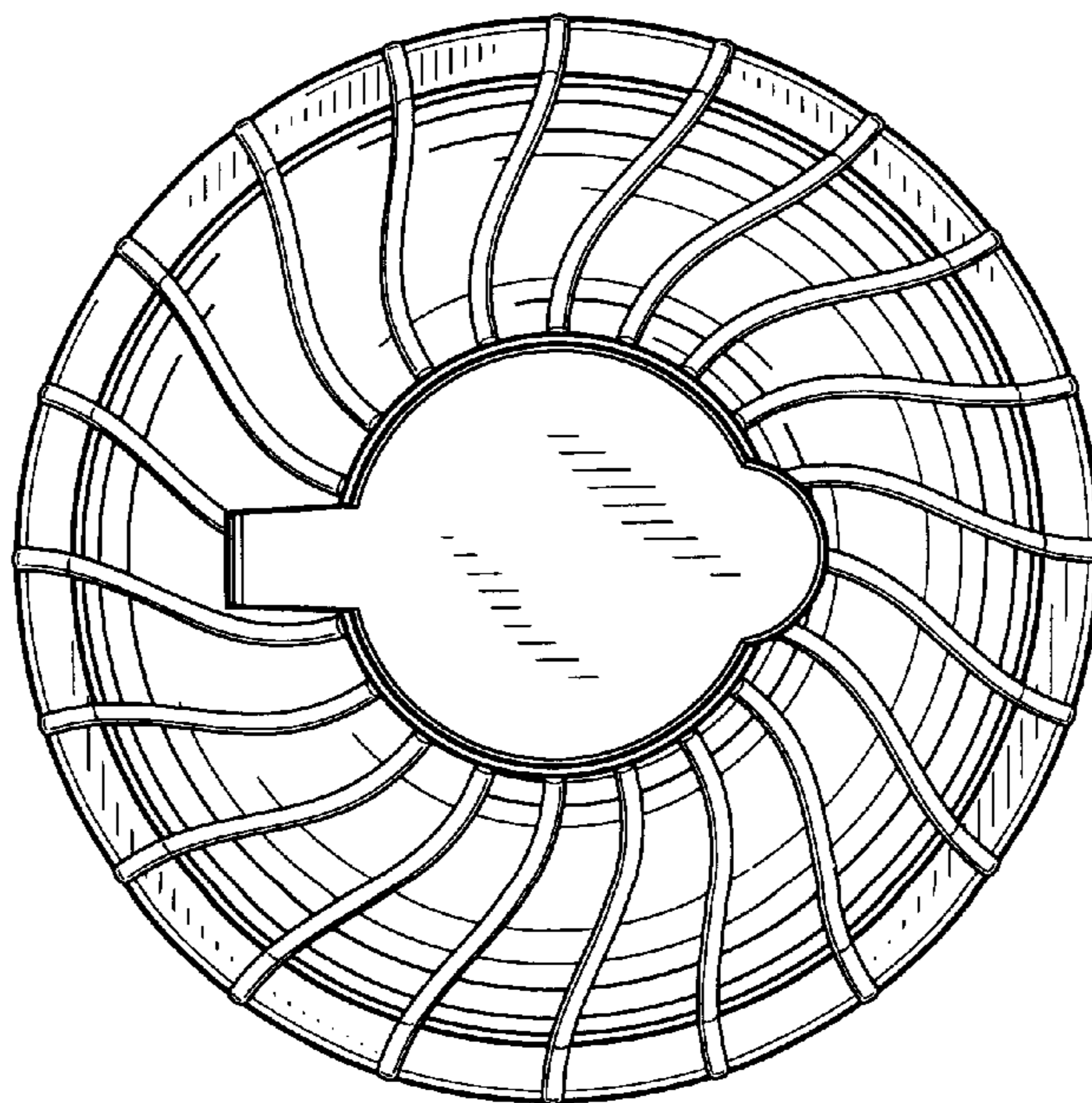

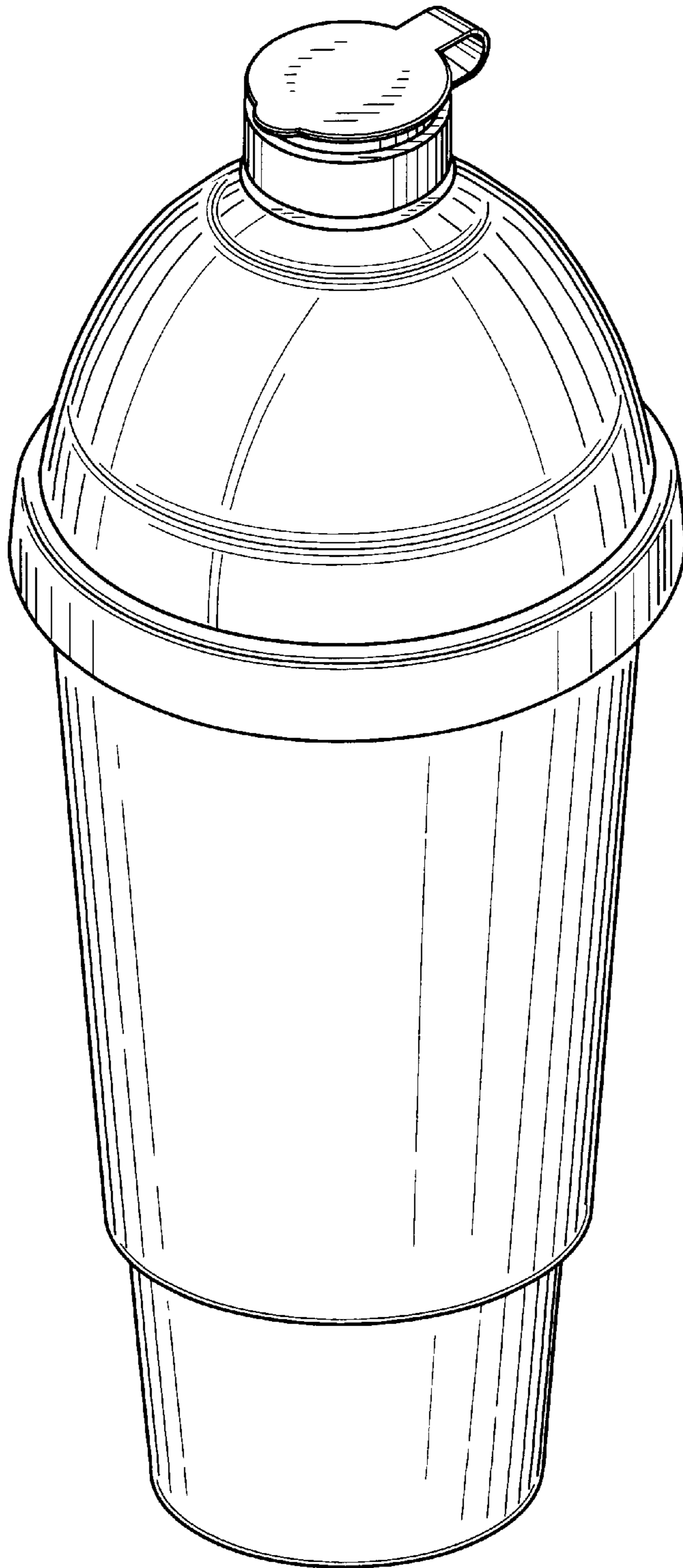

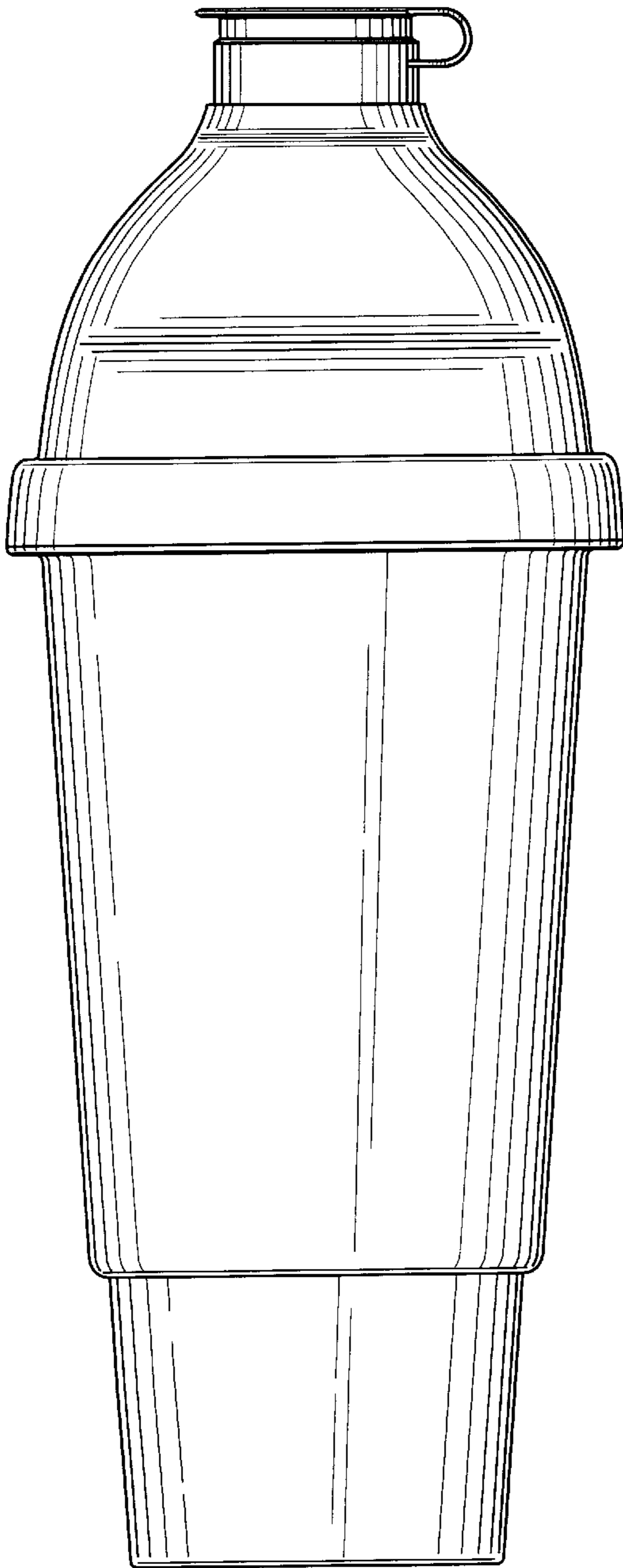

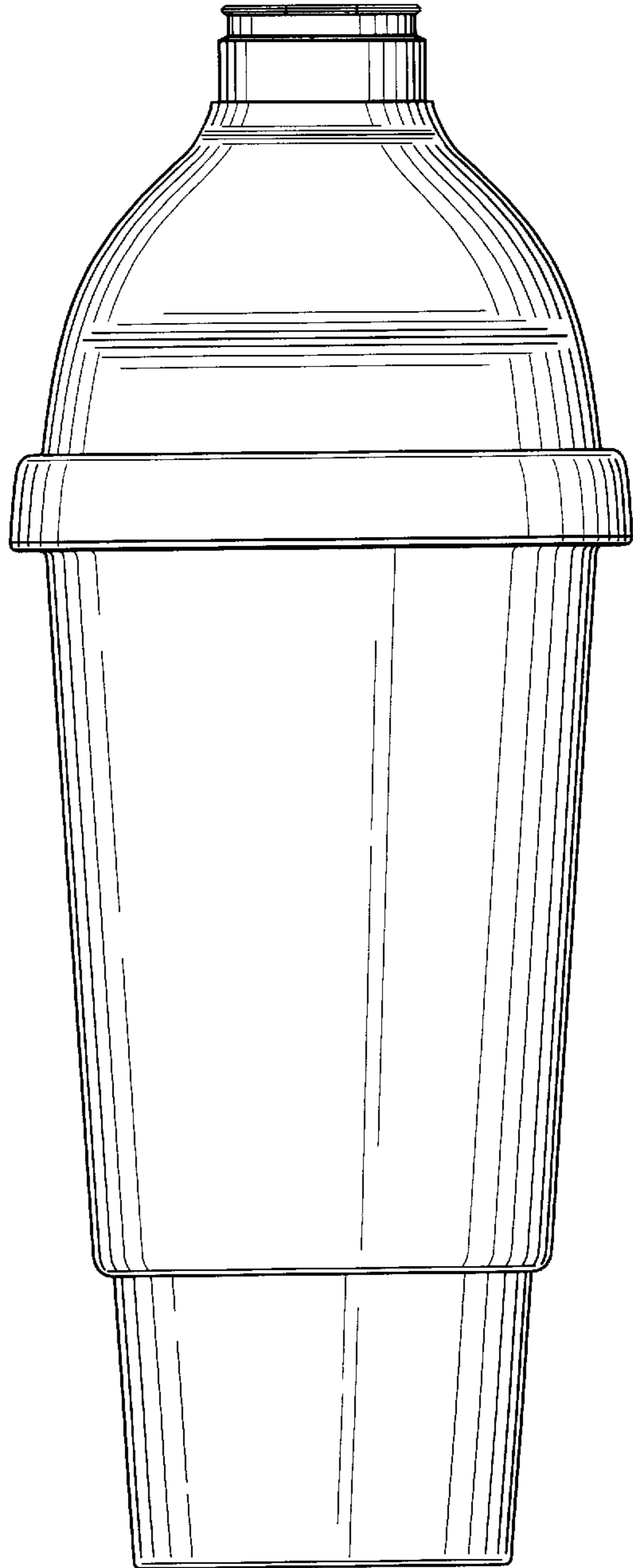

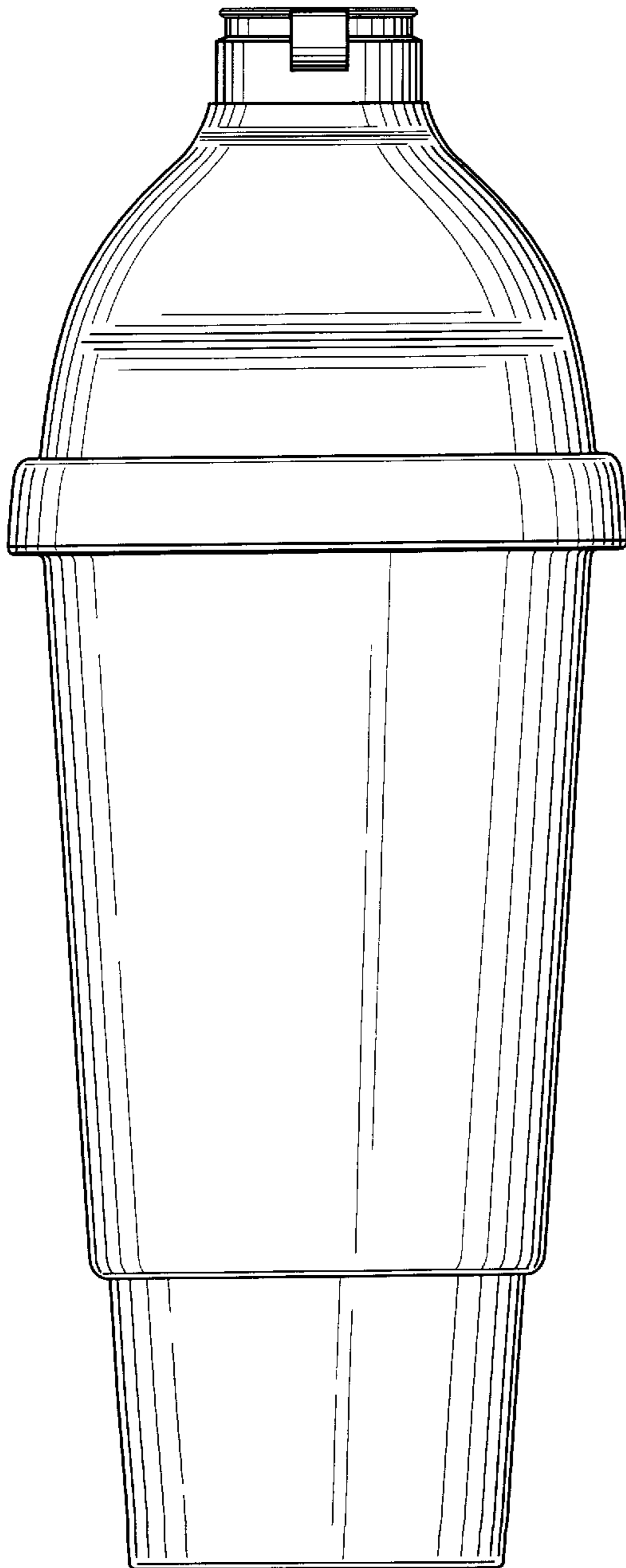

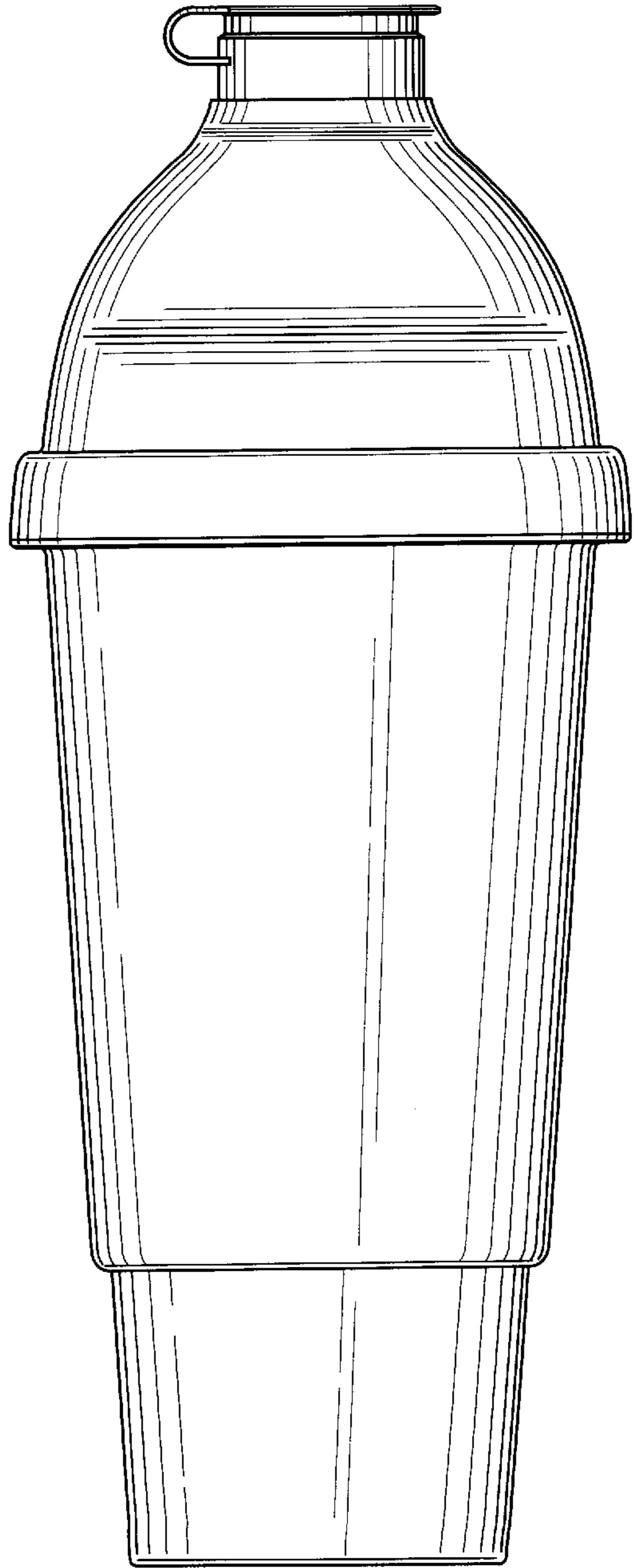

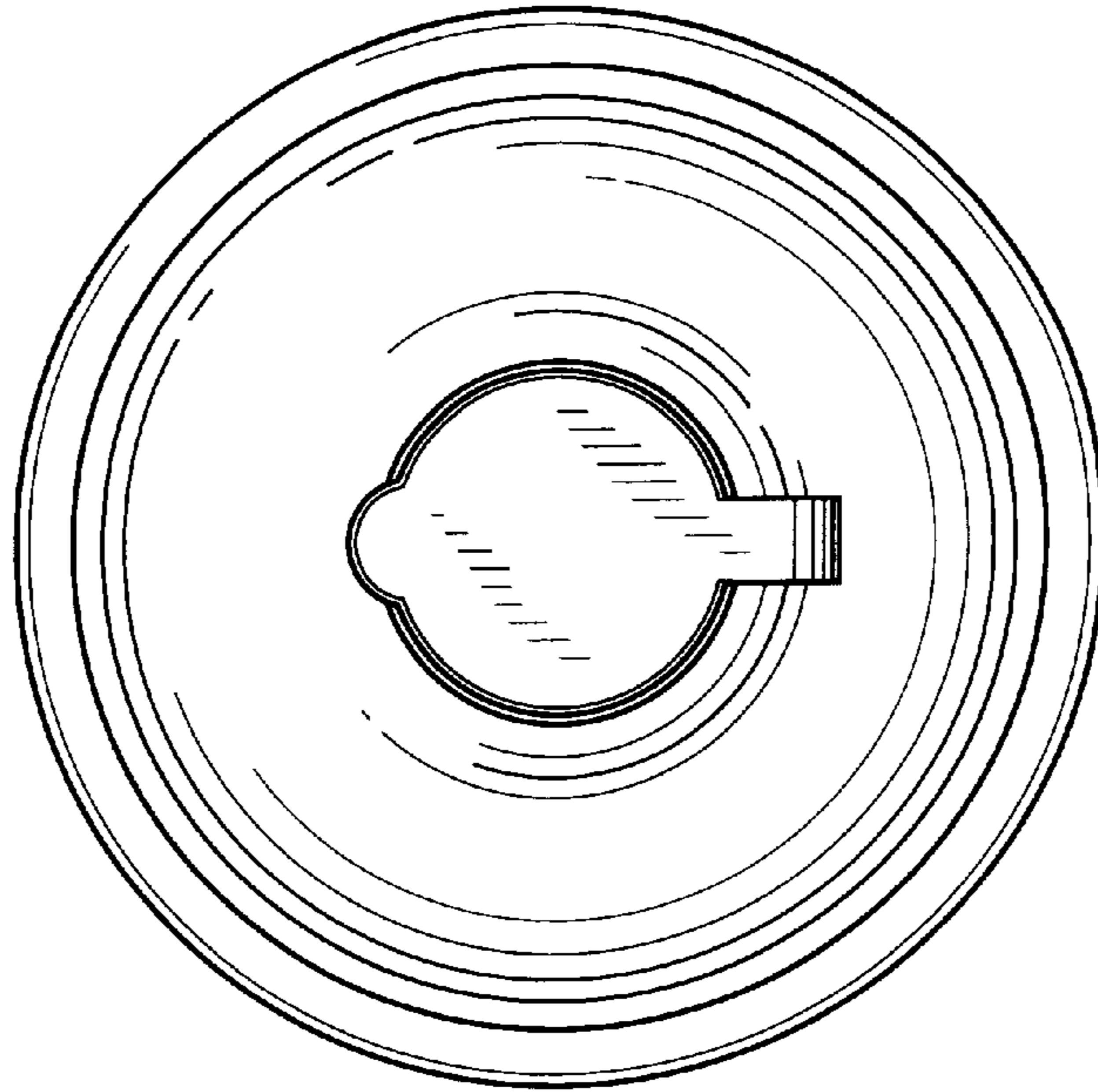

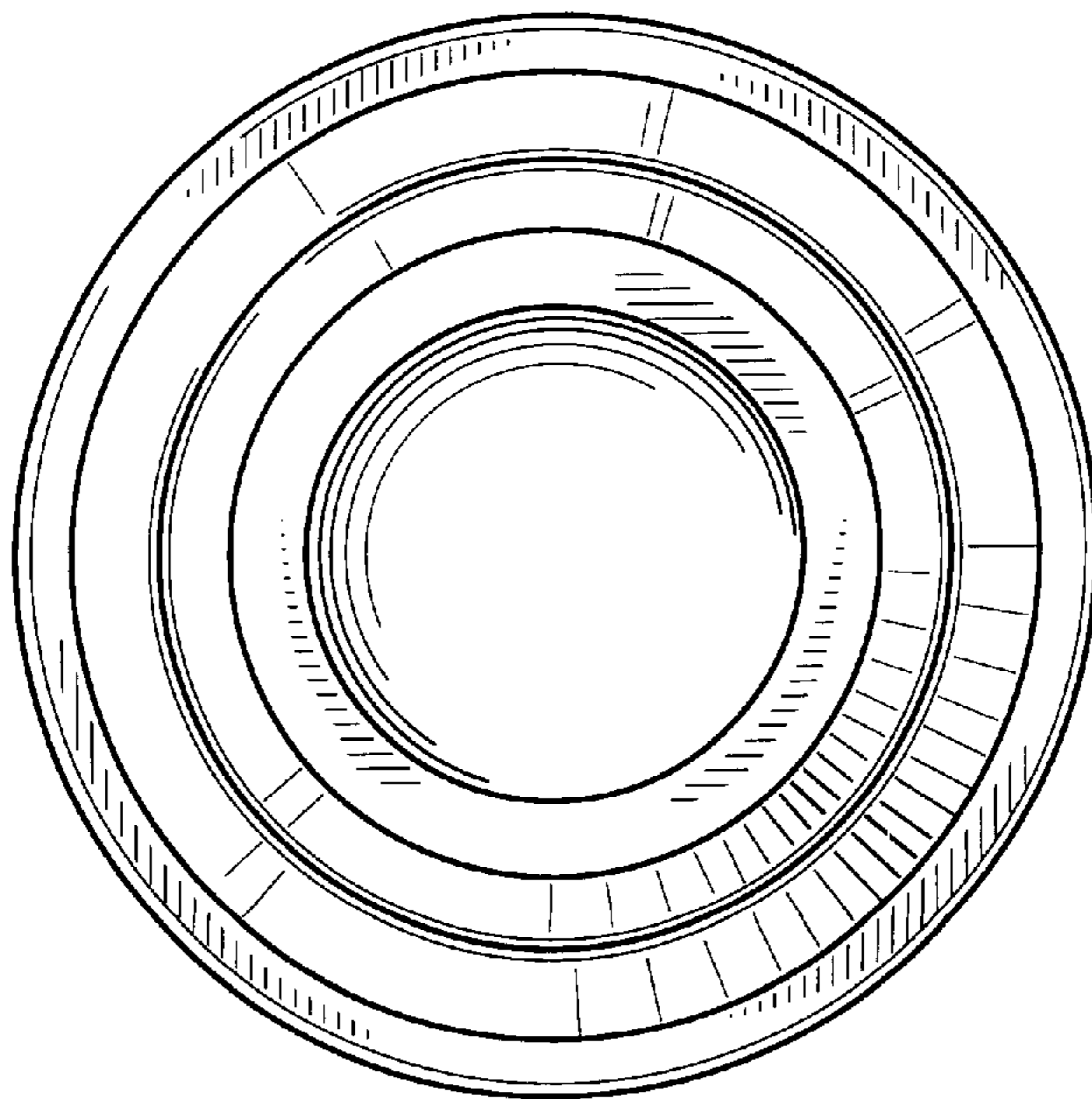

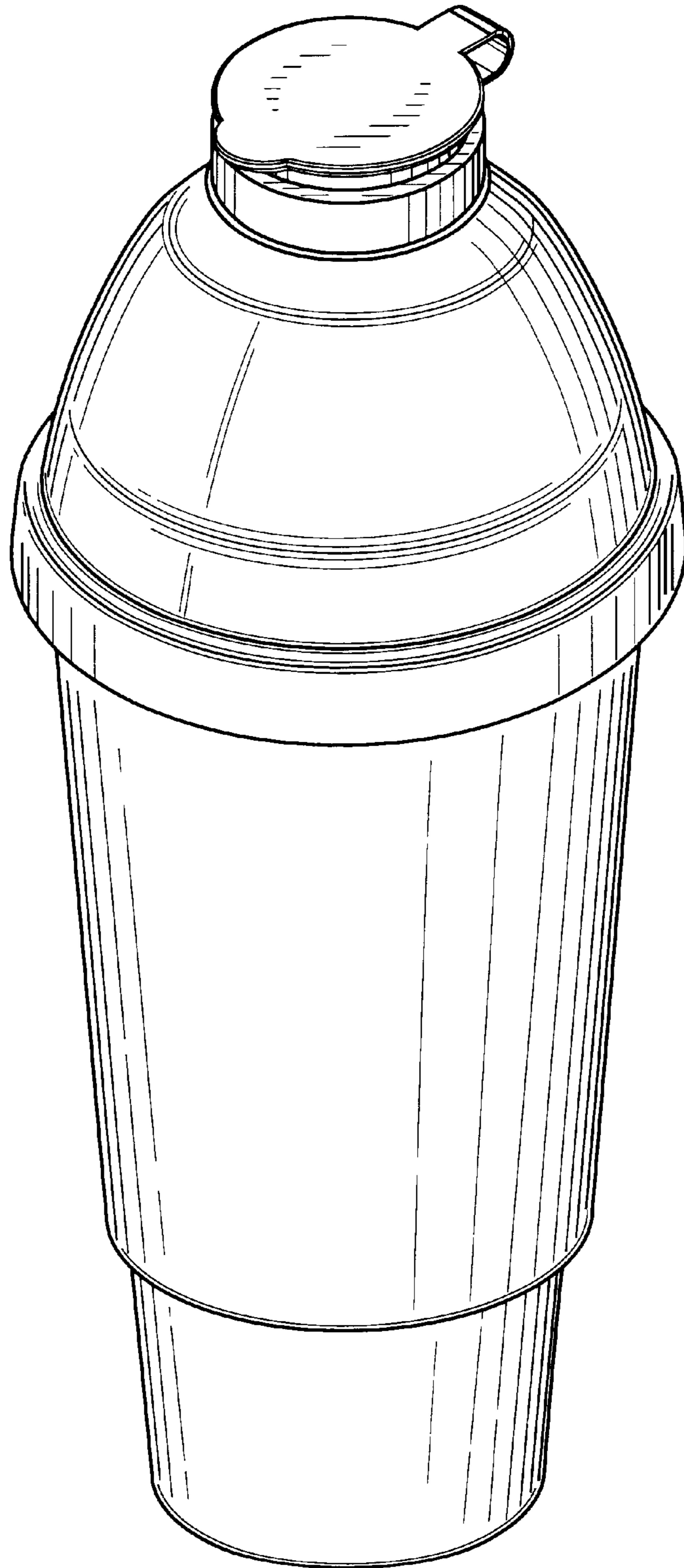

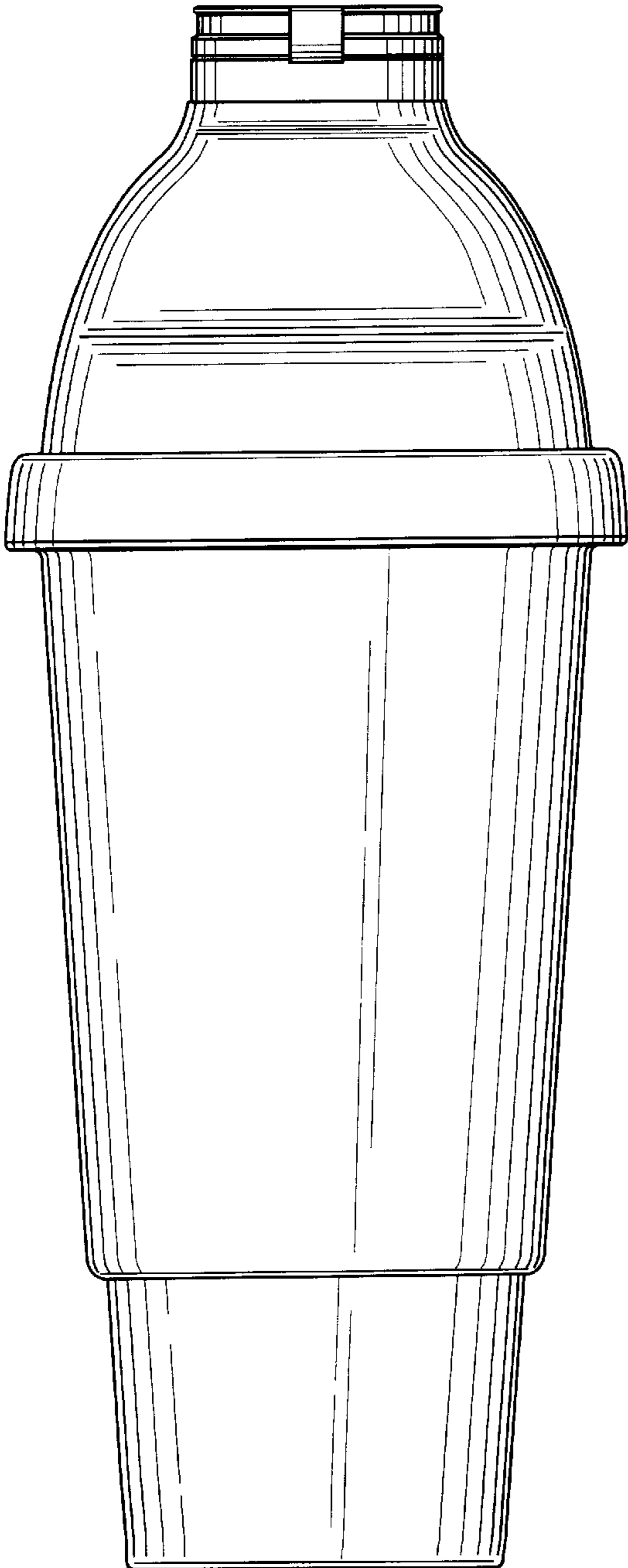

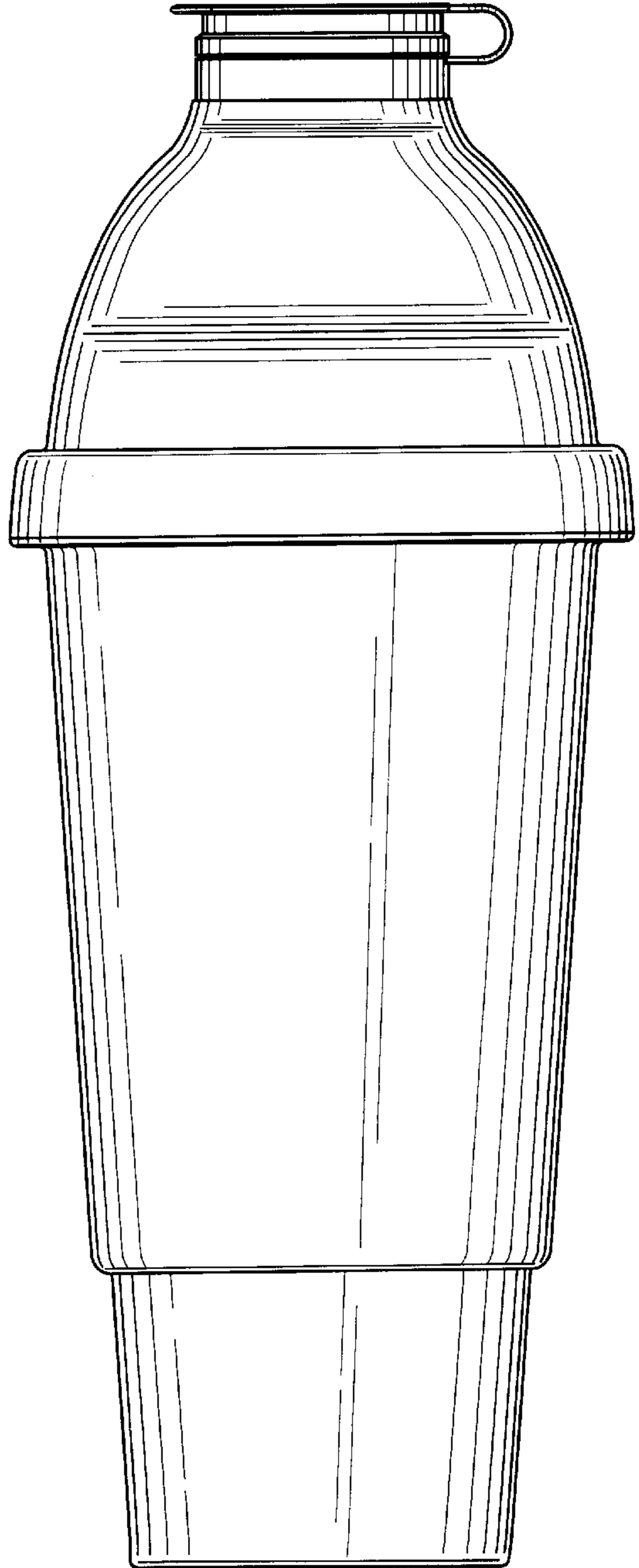

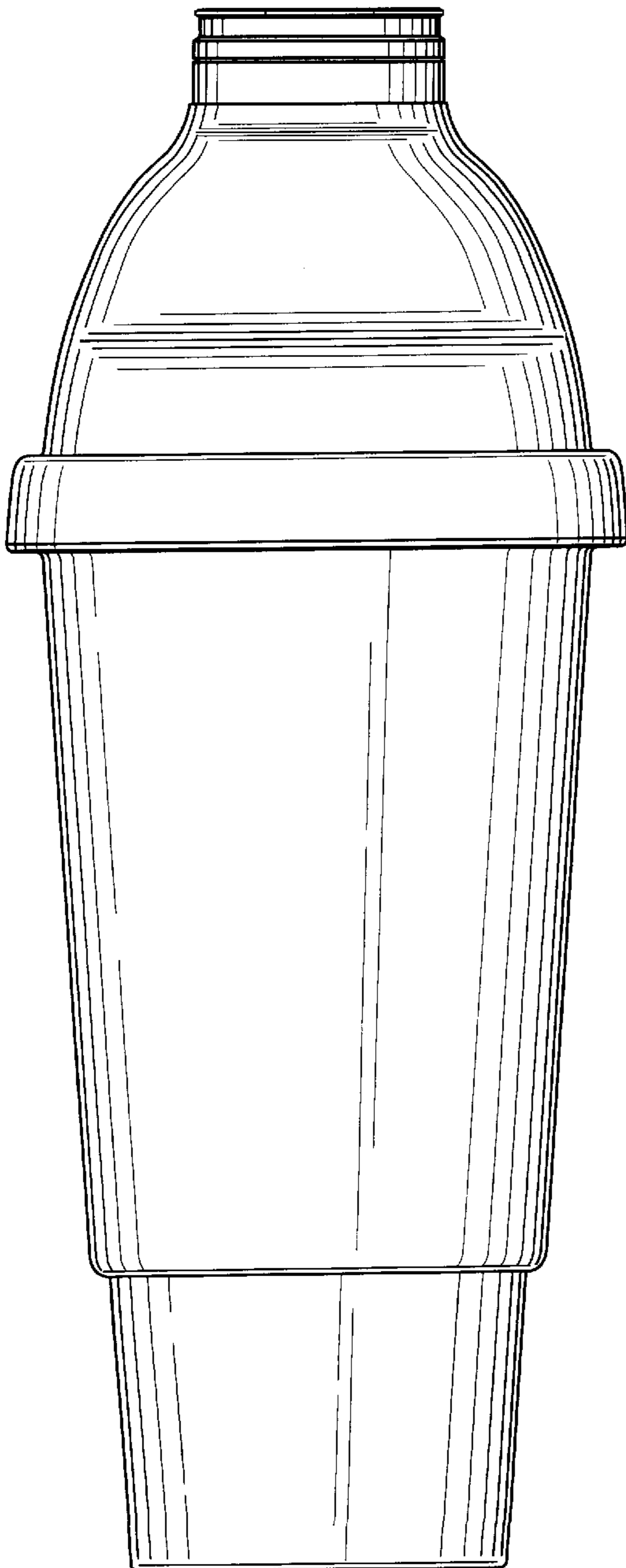

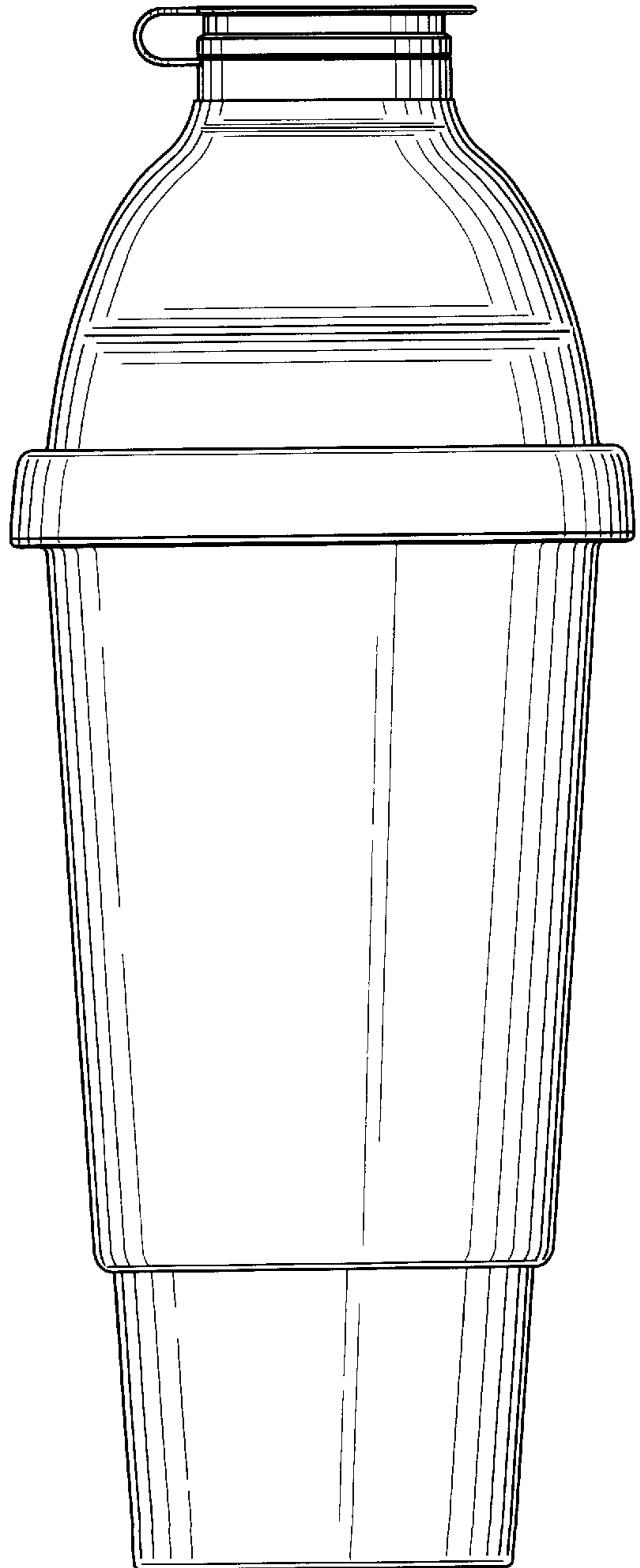

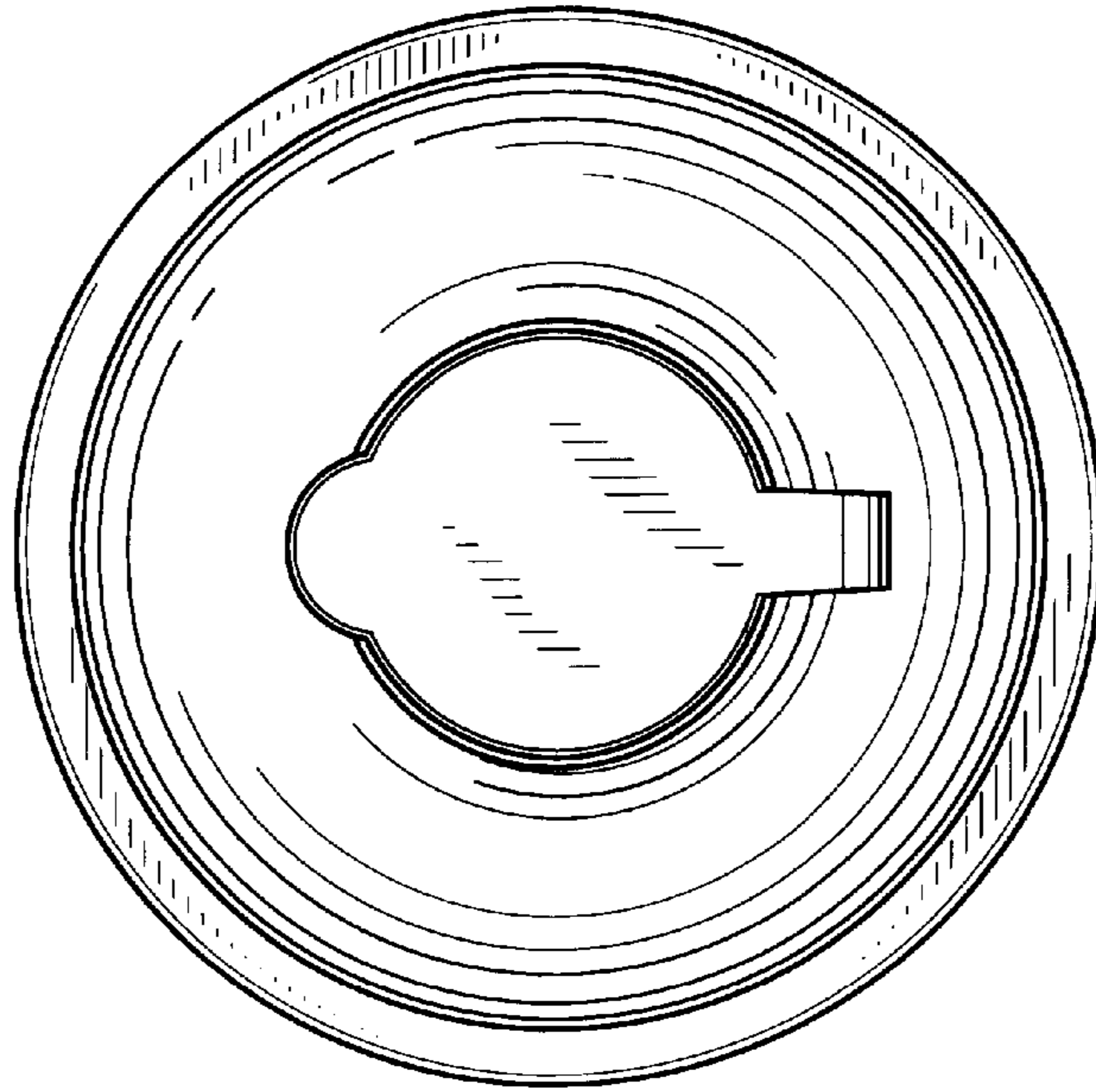
