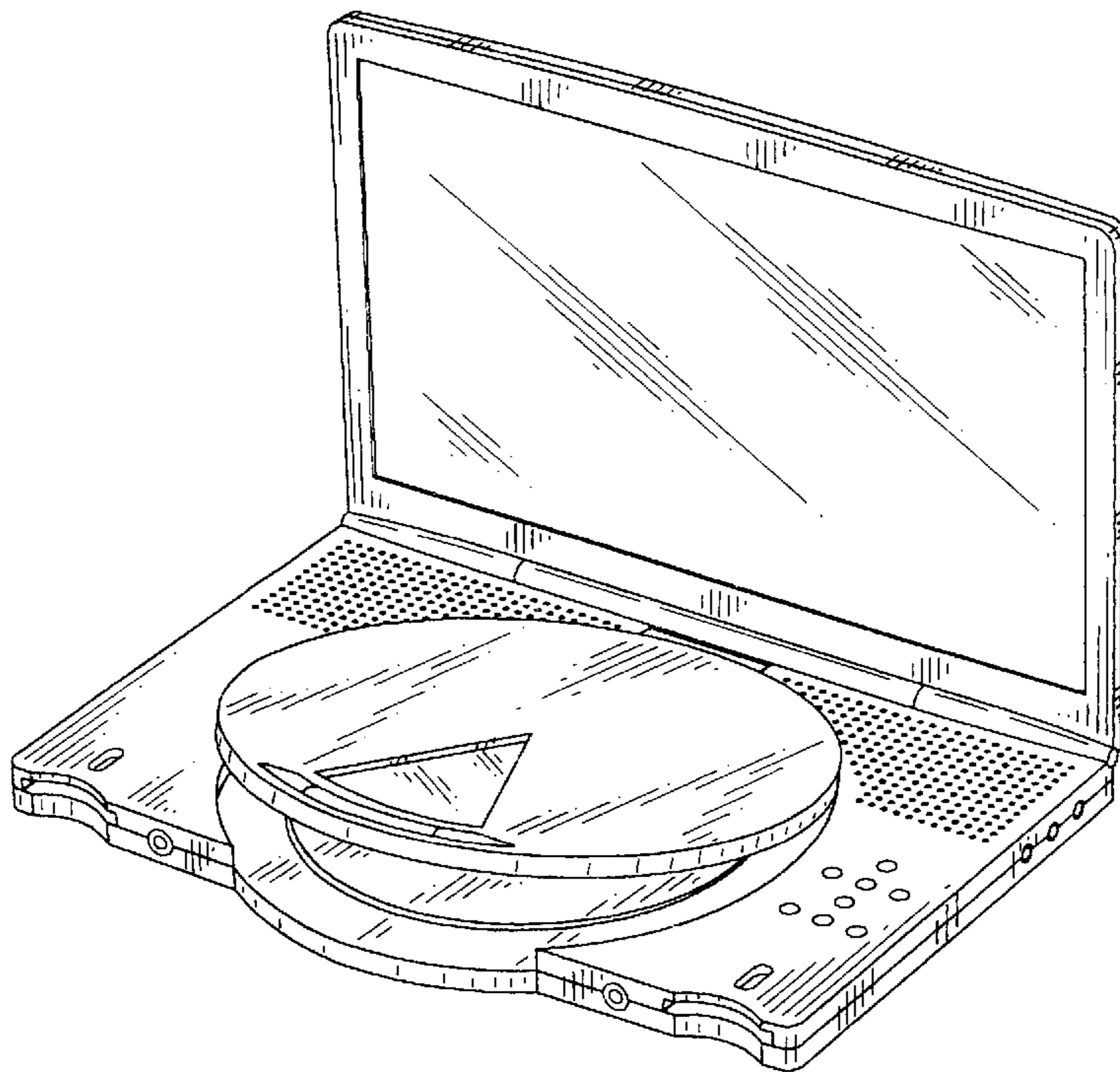

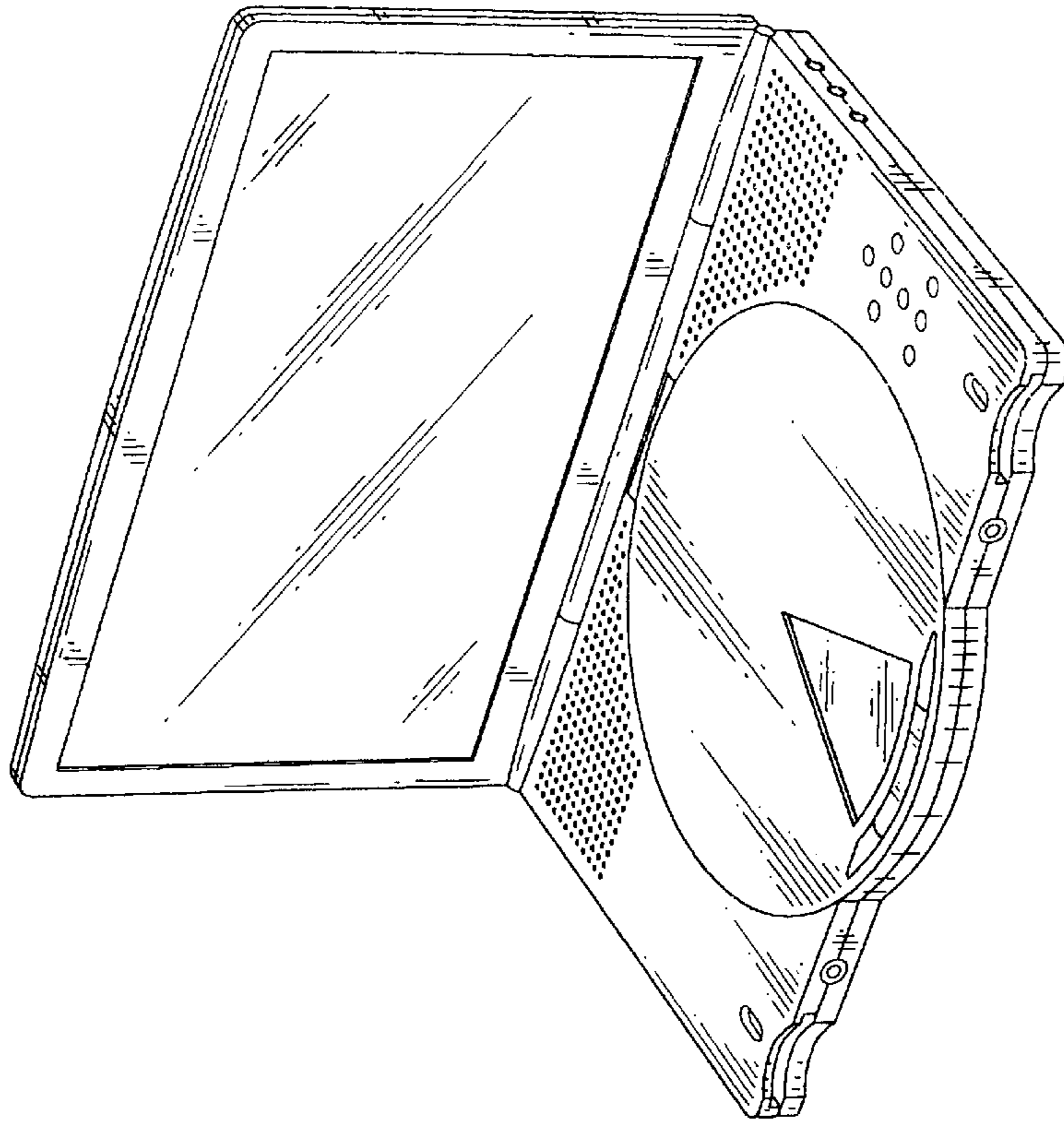
The ornamental design for a digital videodisk player, as shown and described.

**DESCRIPTION**

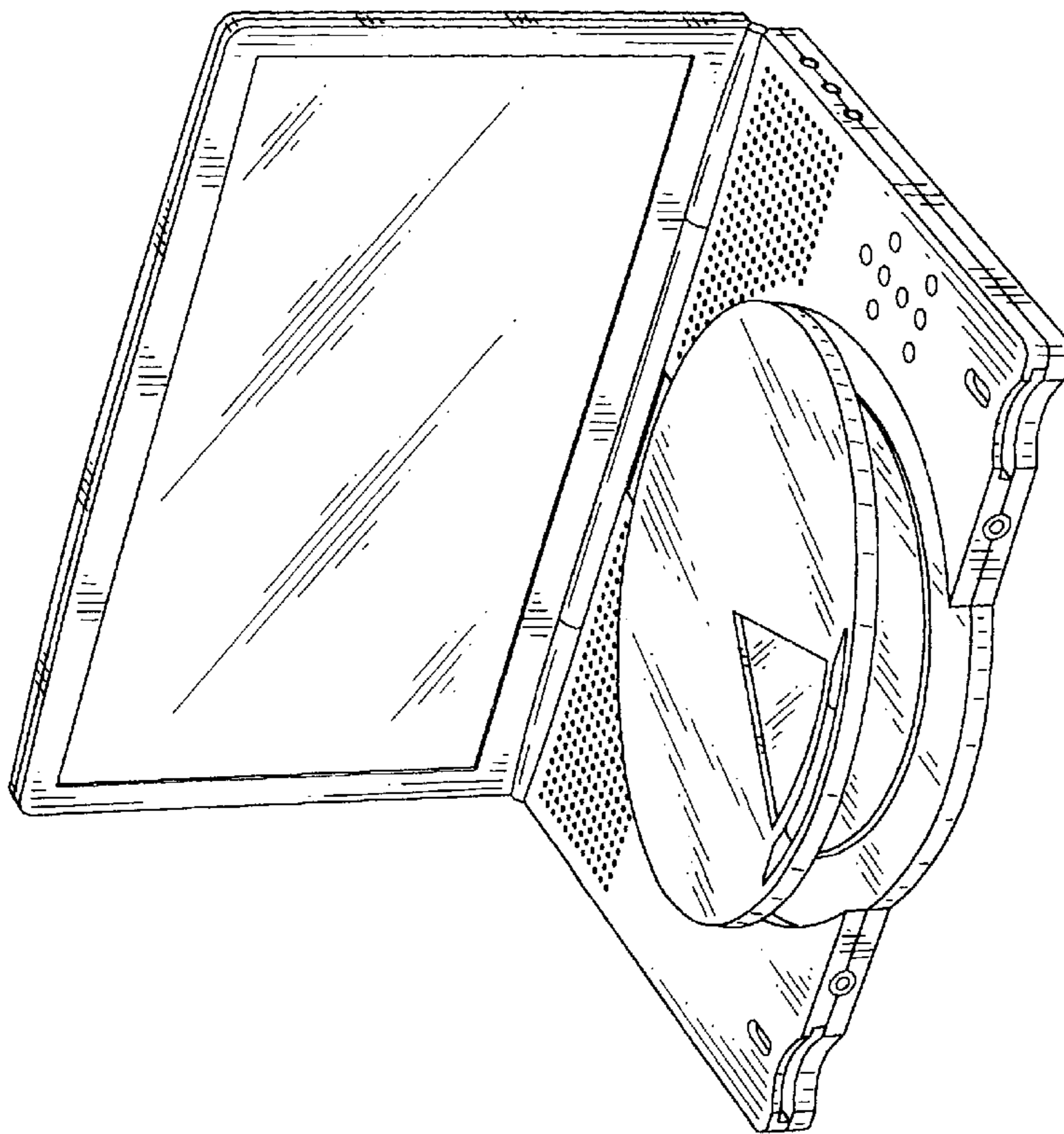
FIG. 1 is a front, top and right side perspective view of a digital videodisk player, showing my new design;

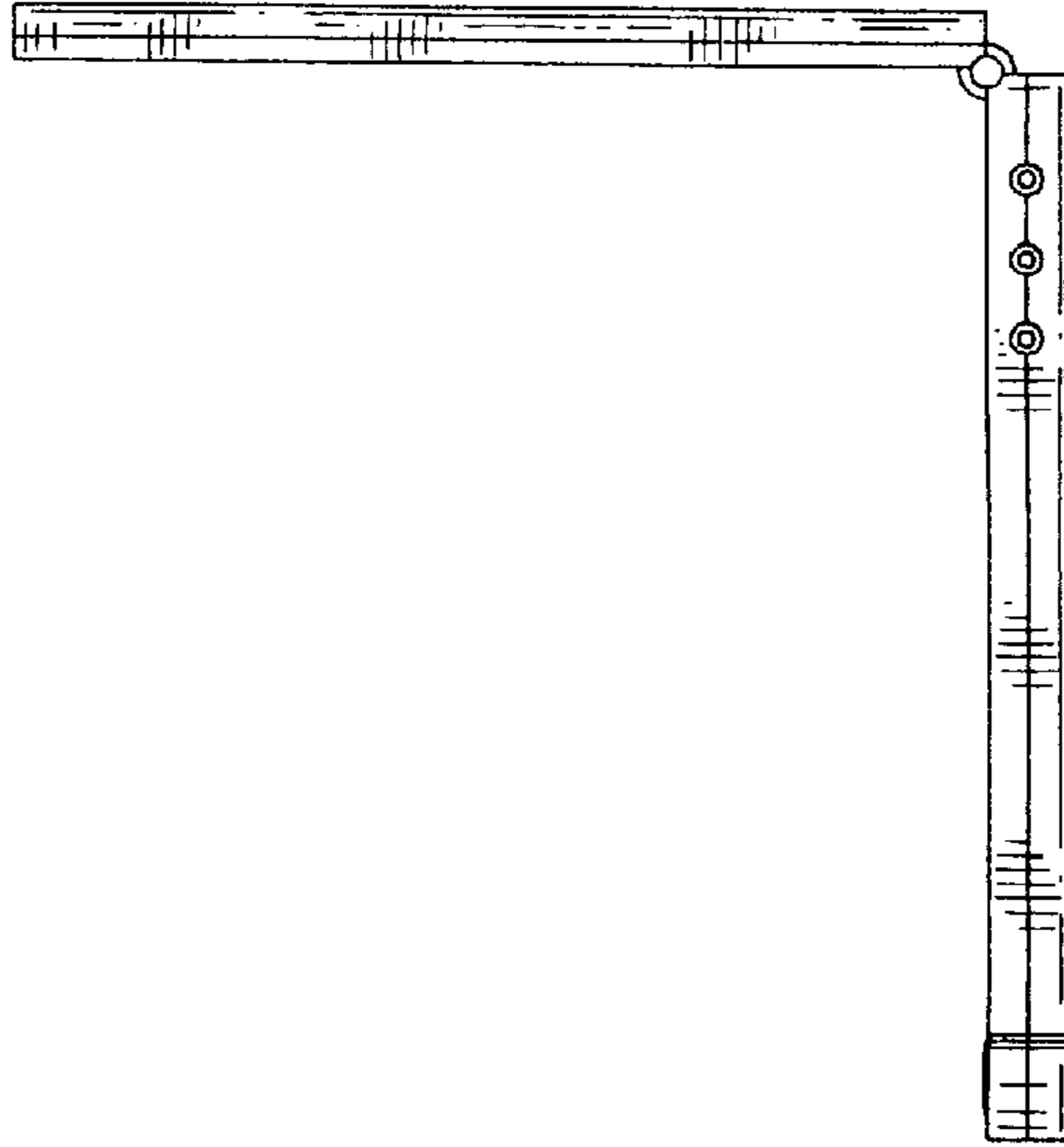




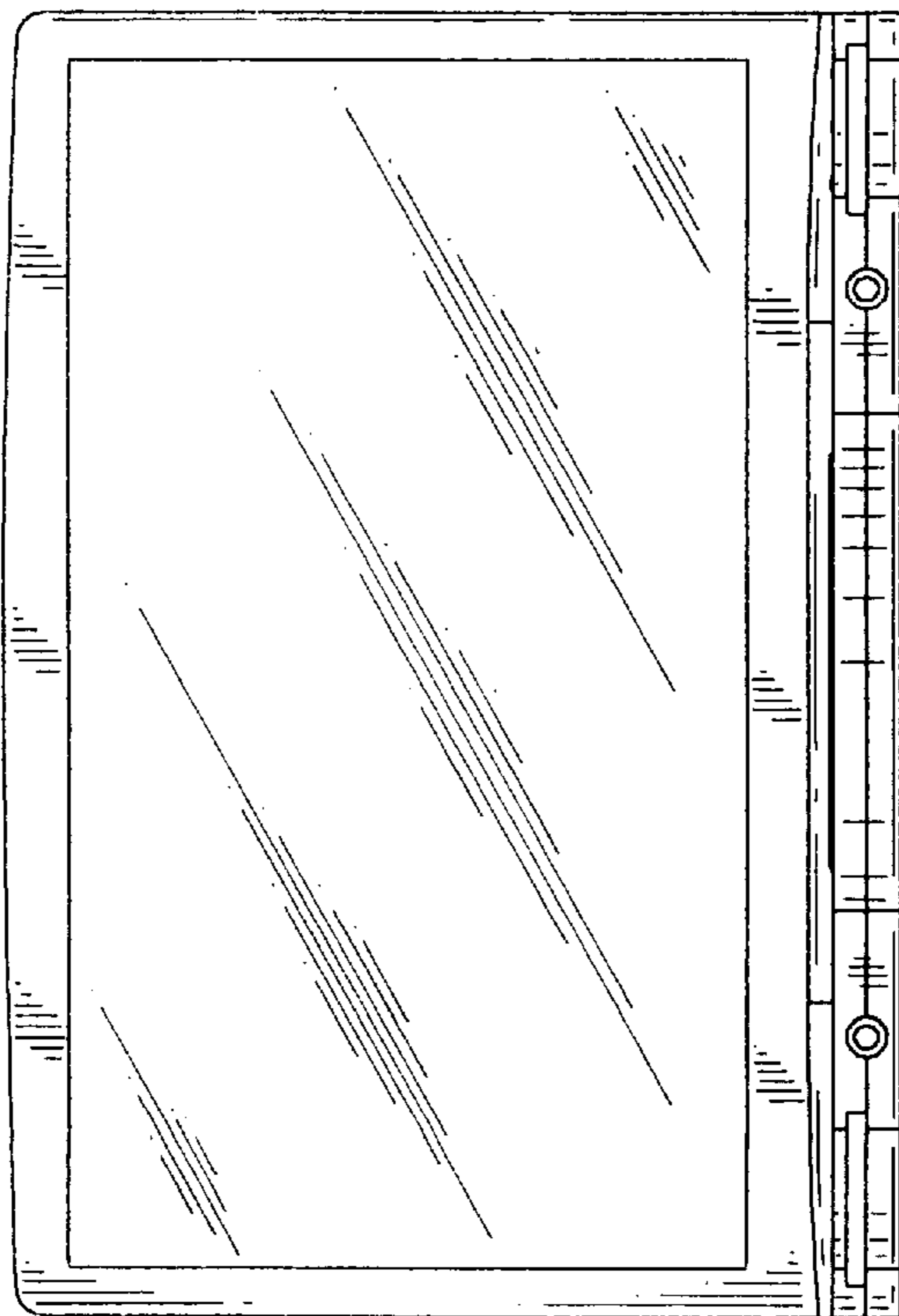

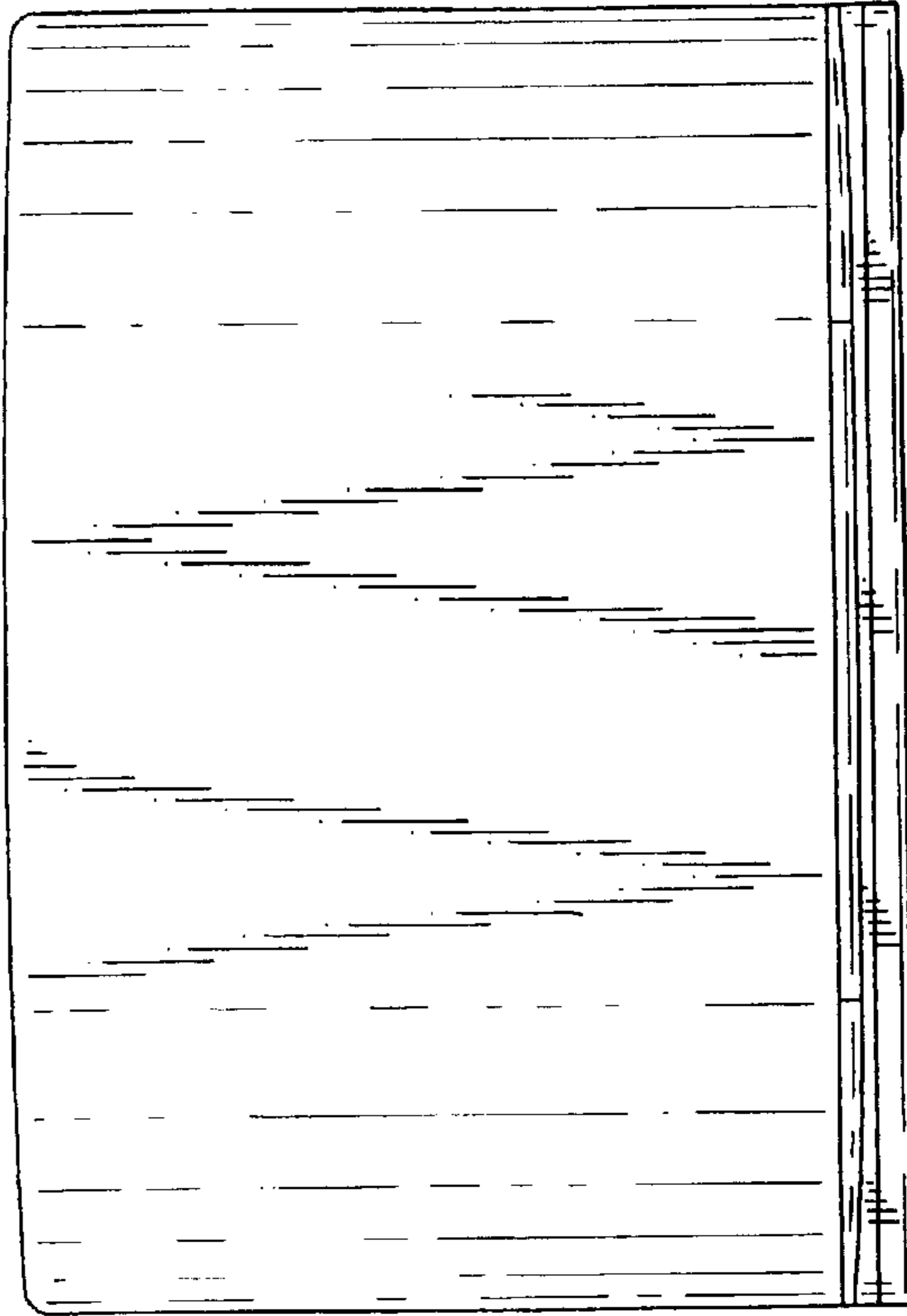

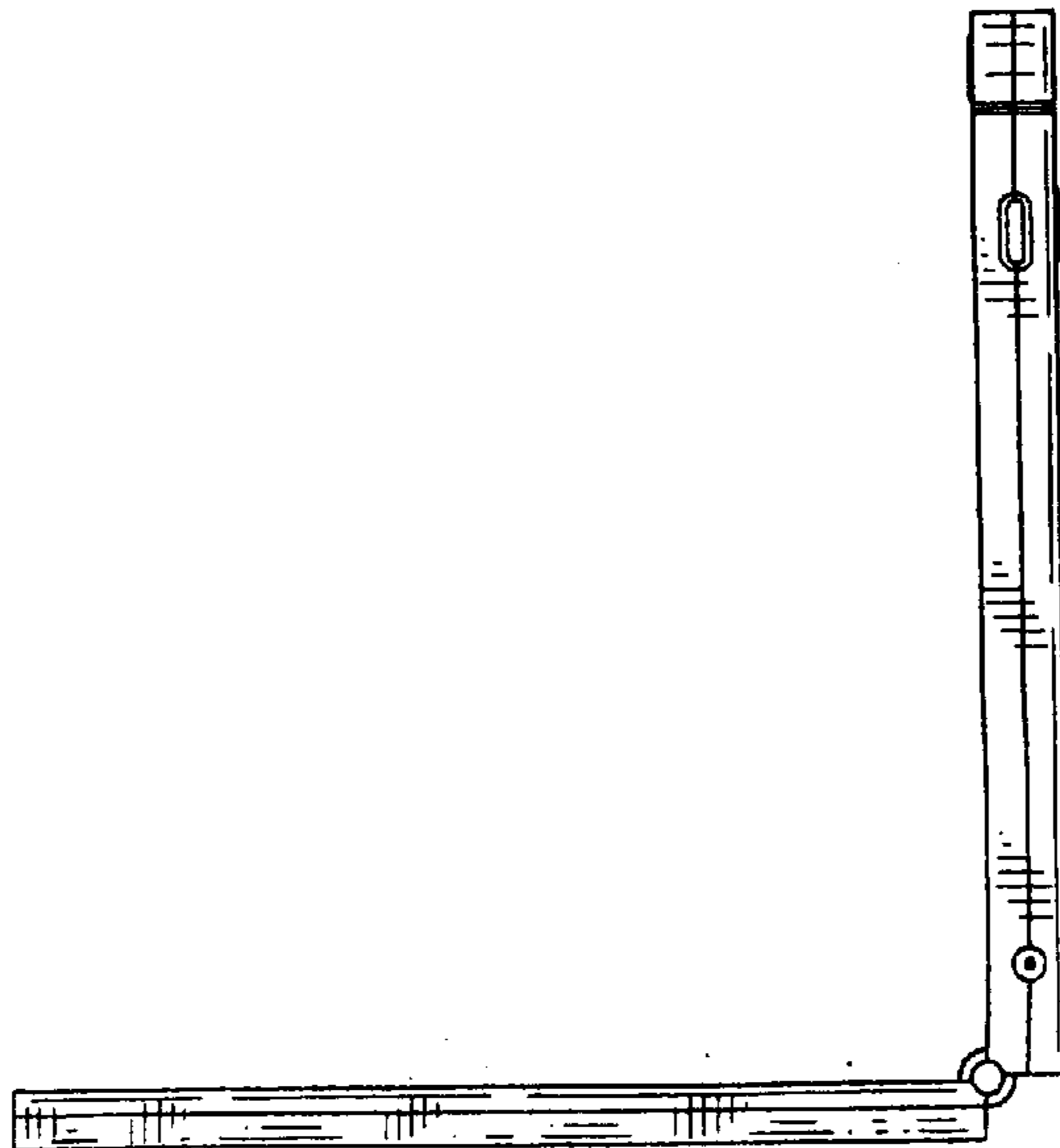

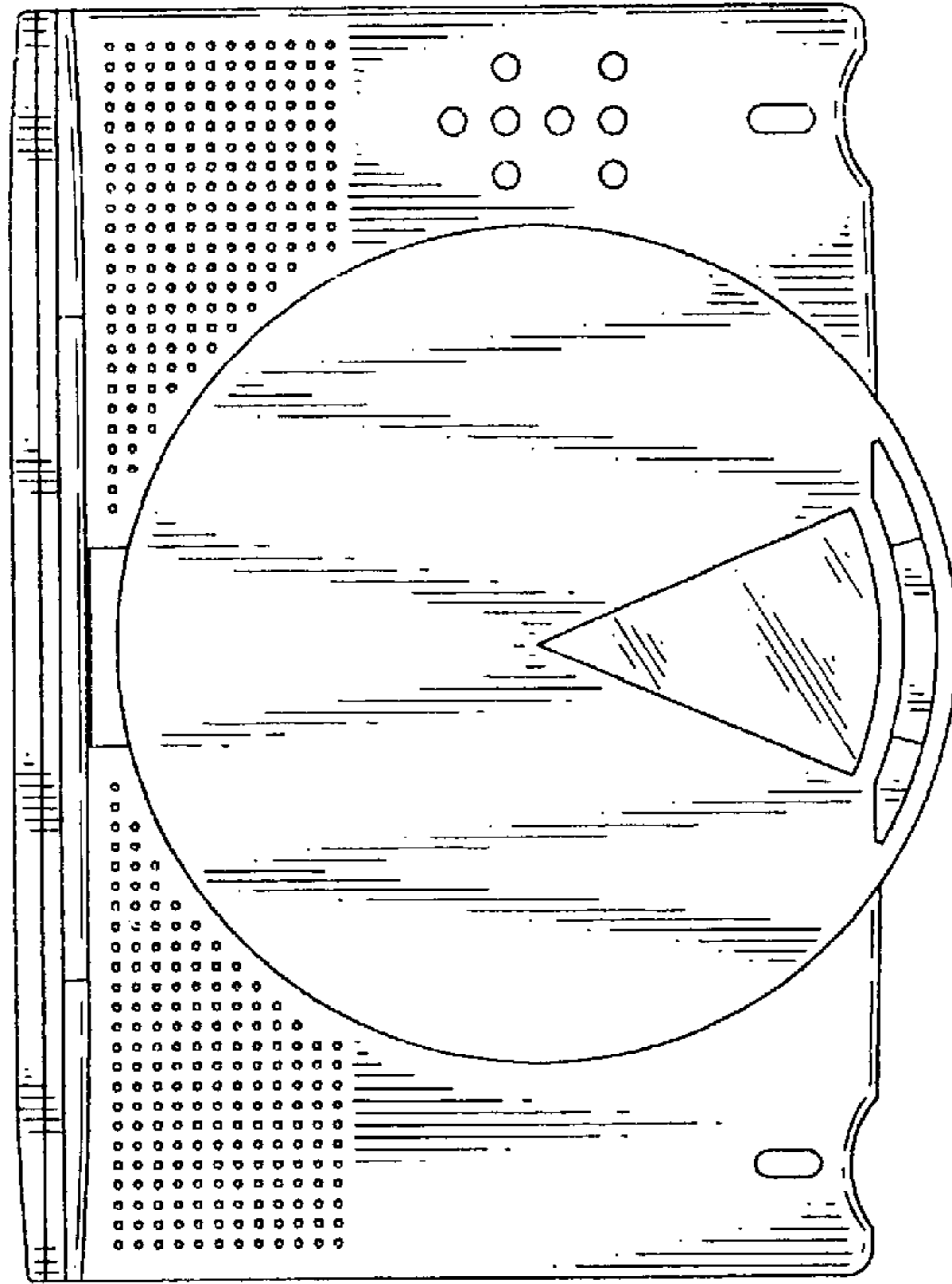

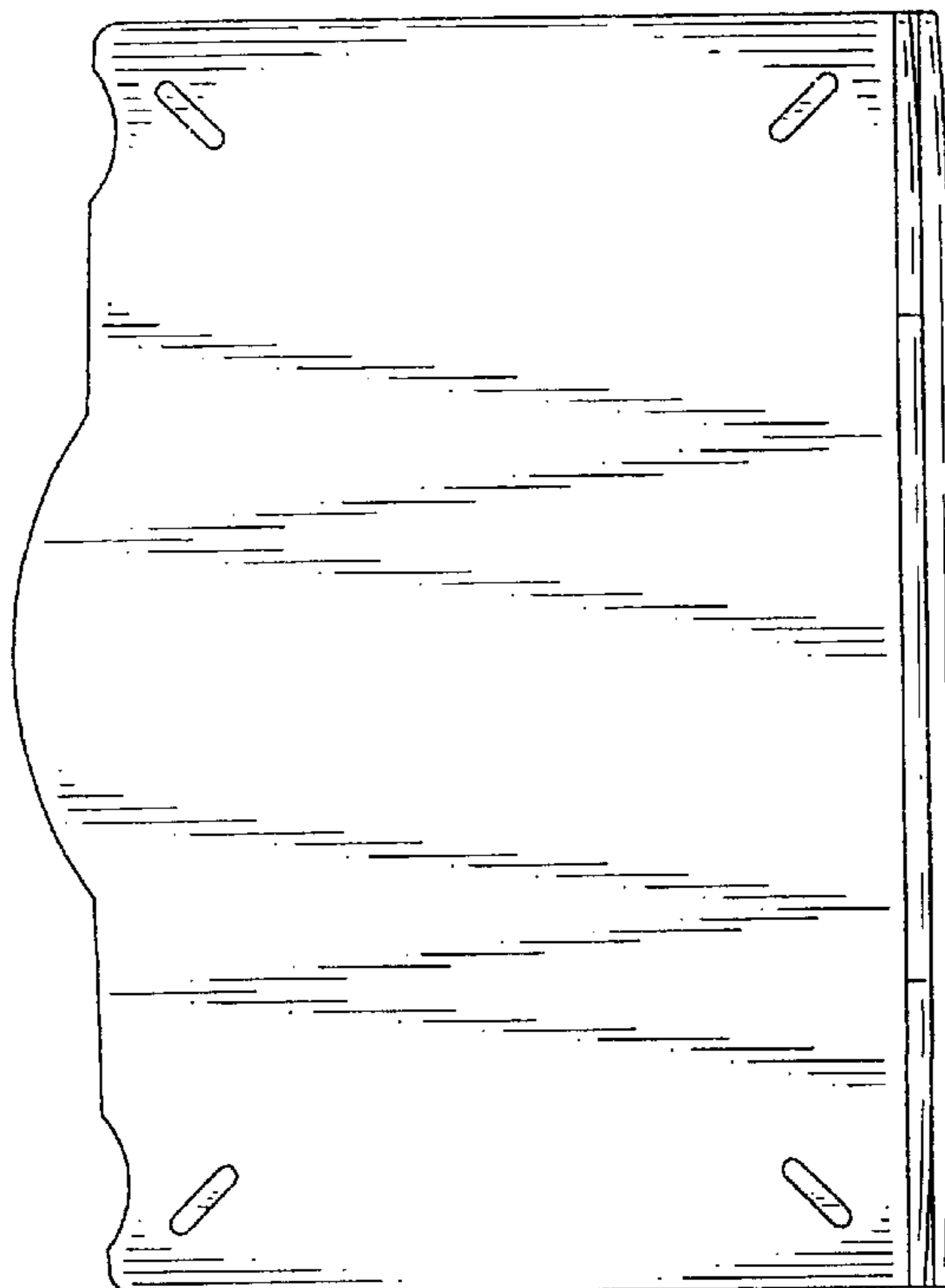

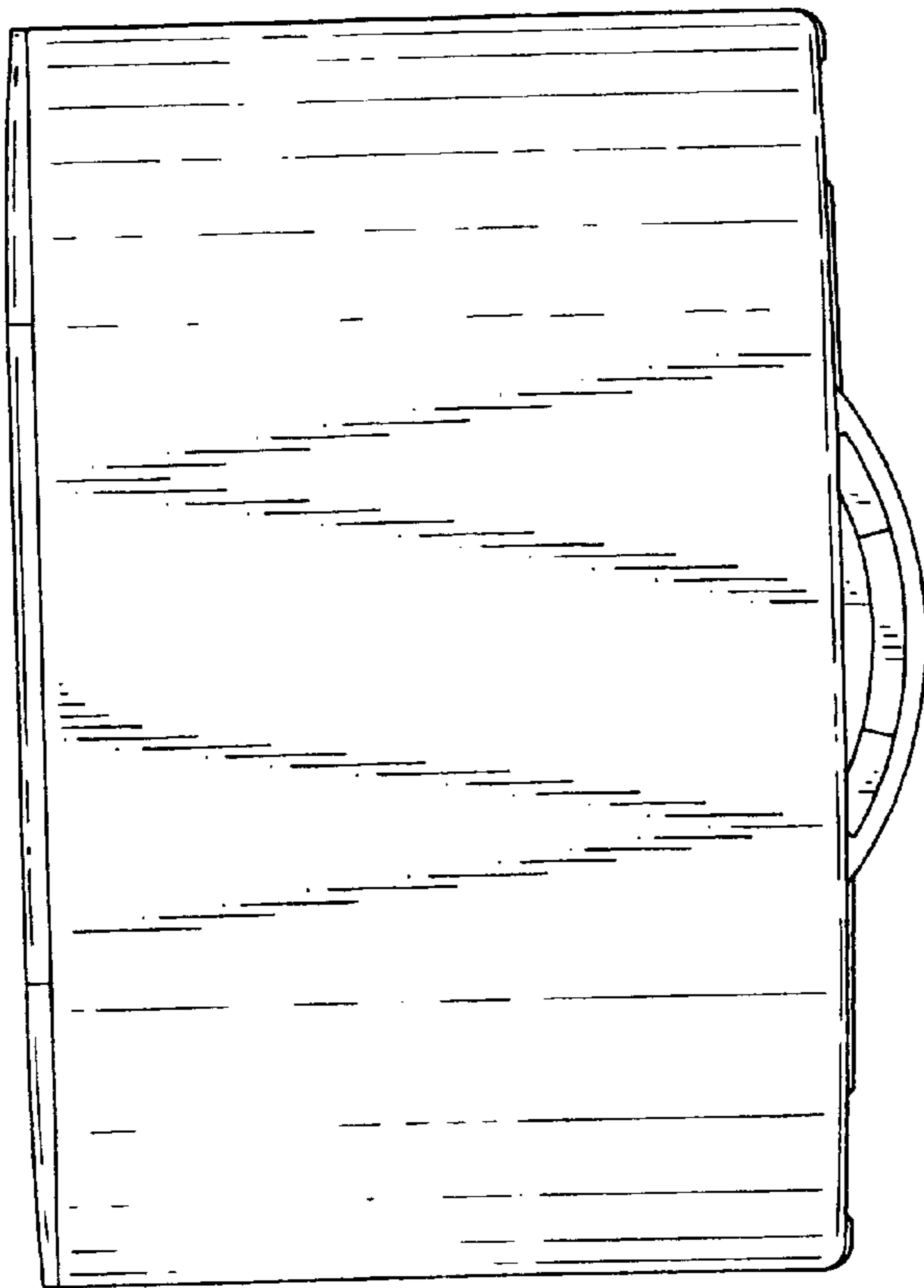

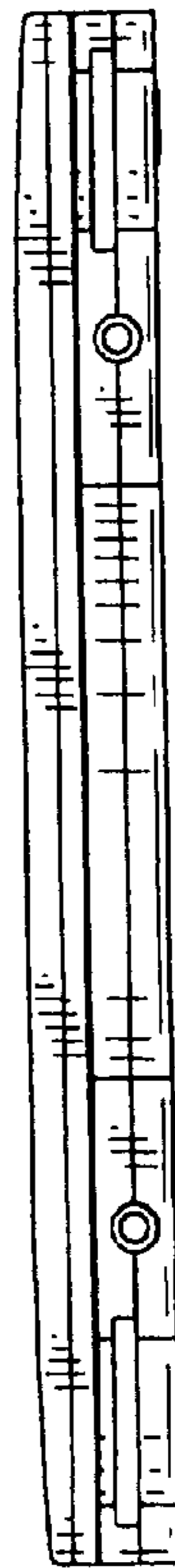
