The ornamental design for a bubble covered brassiere, as shown and described.

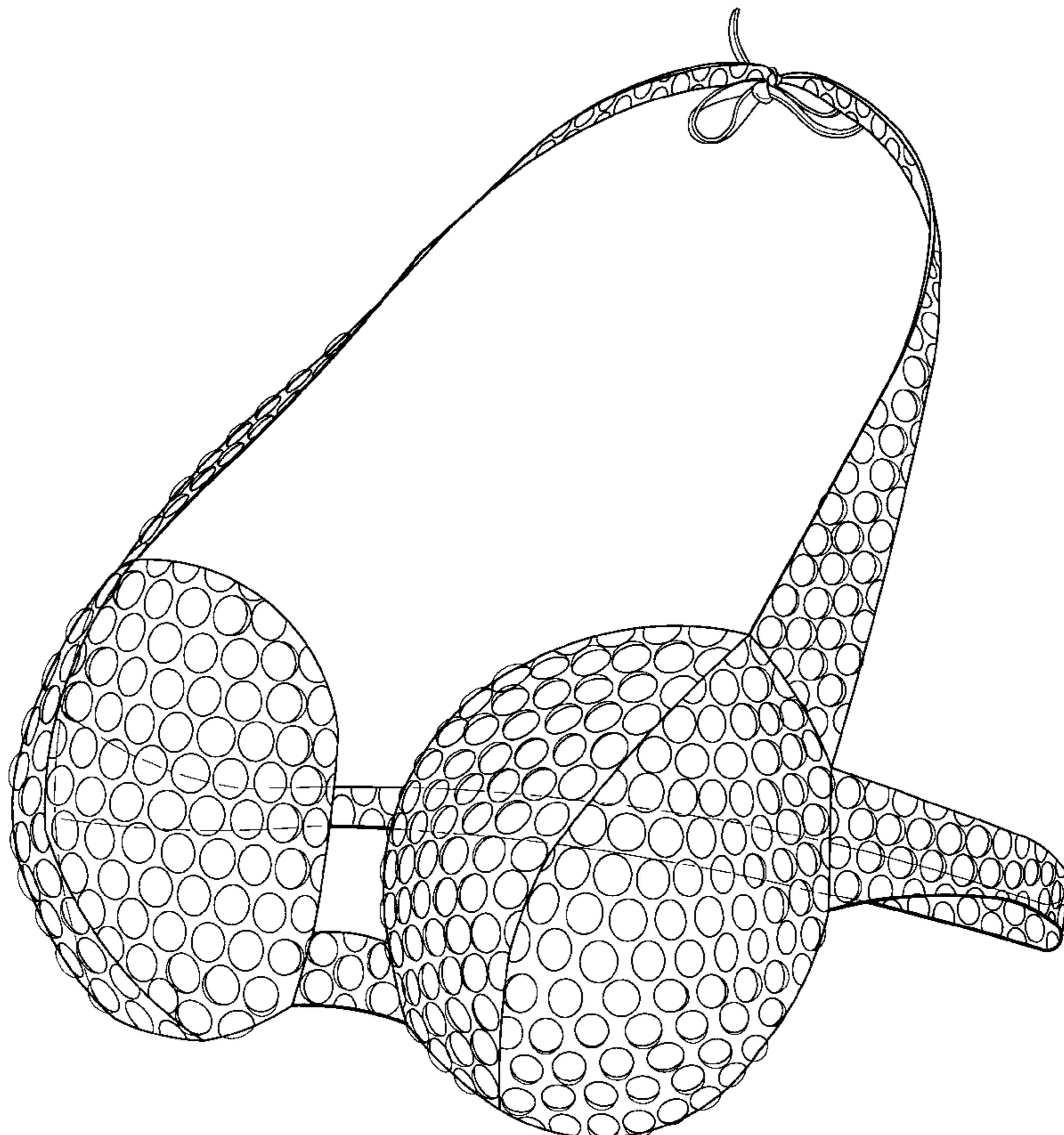

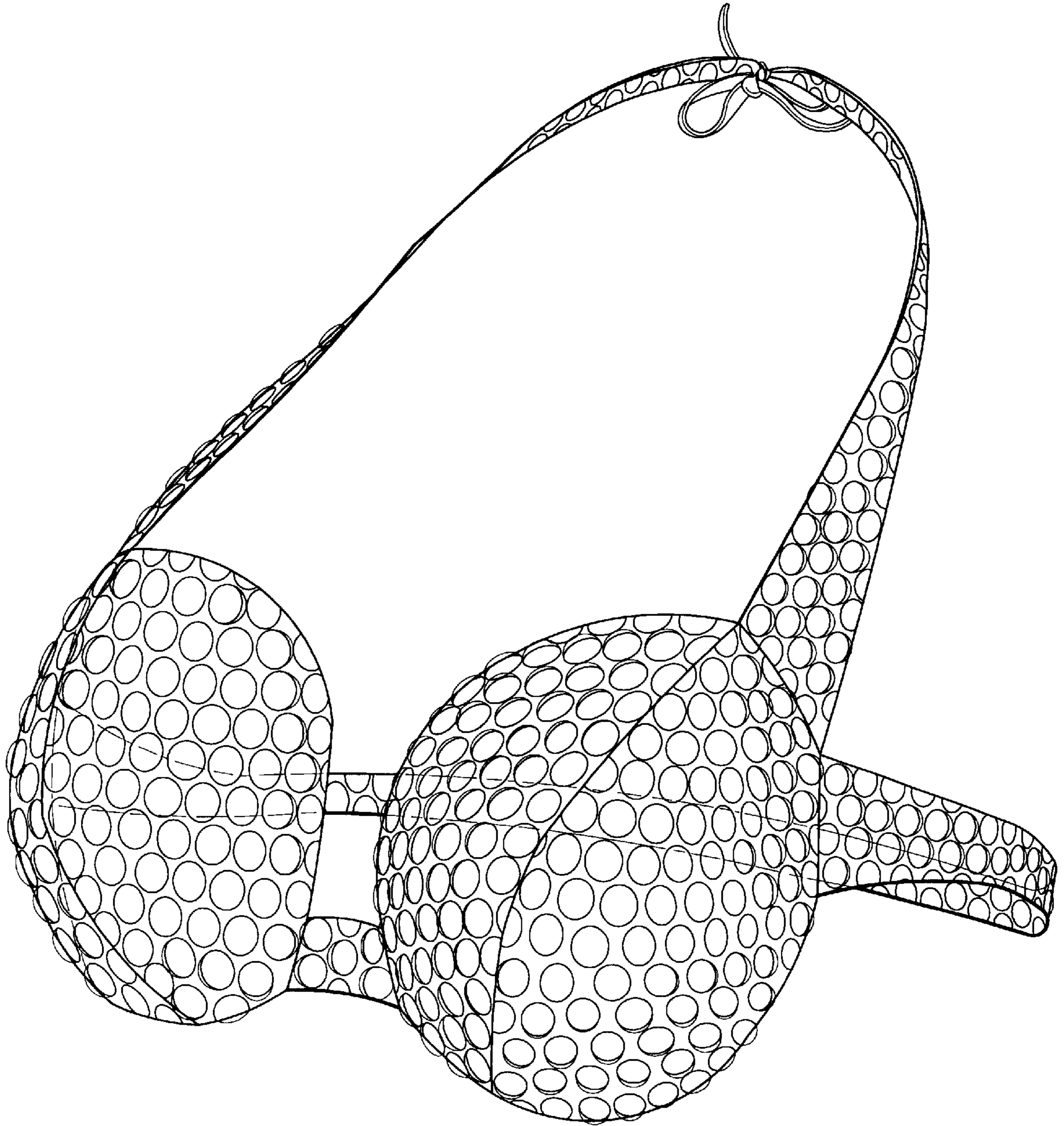

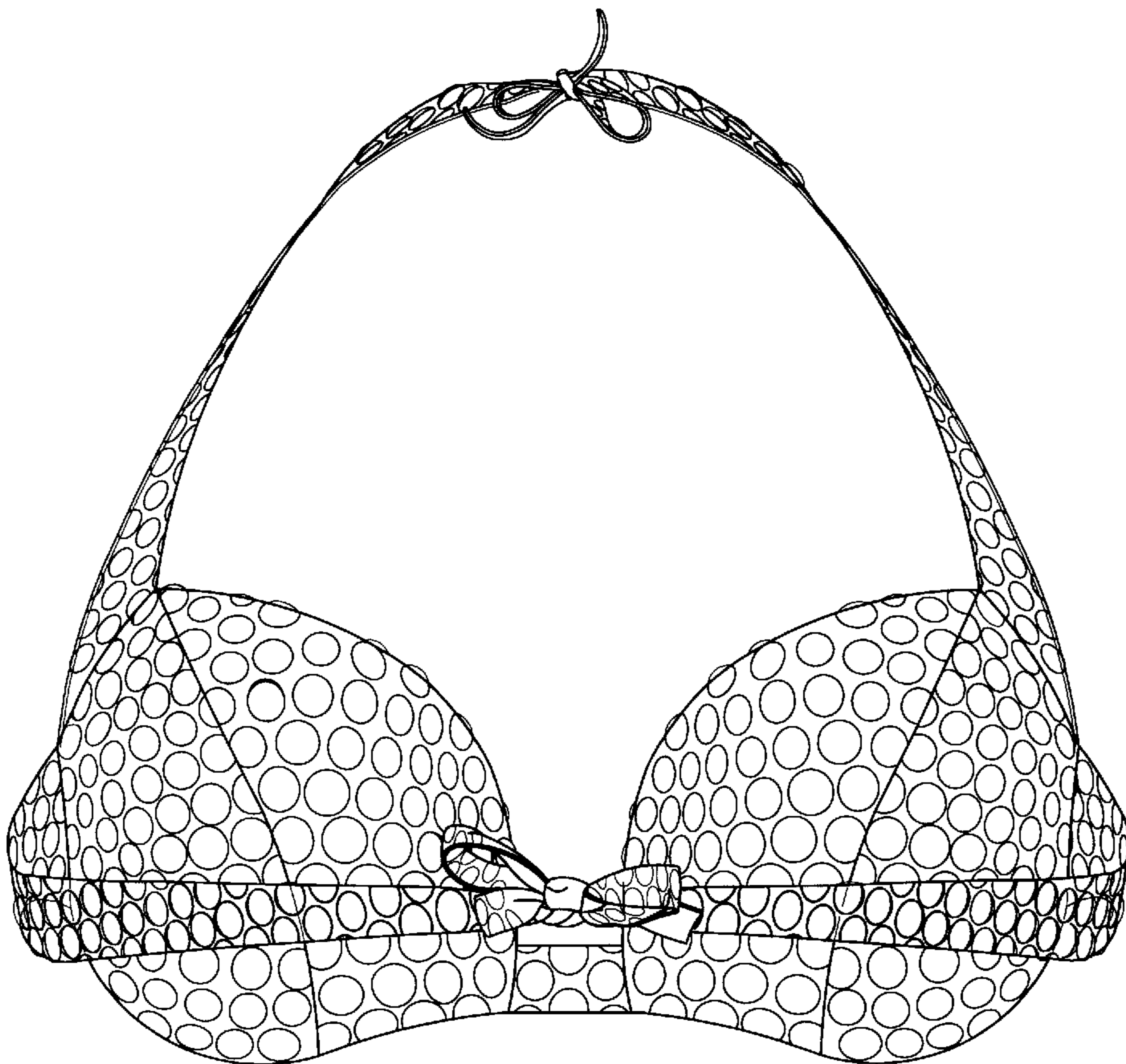

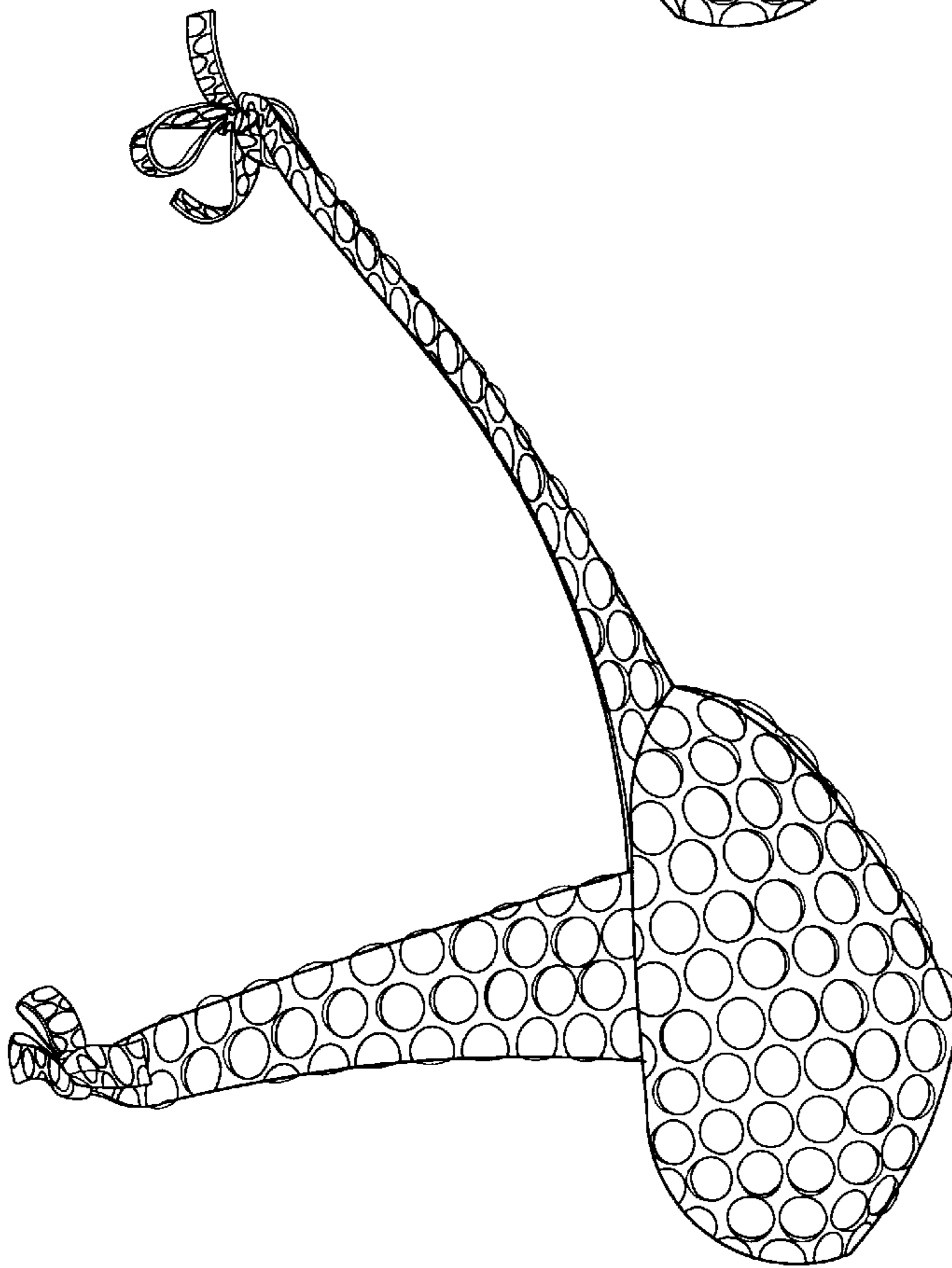
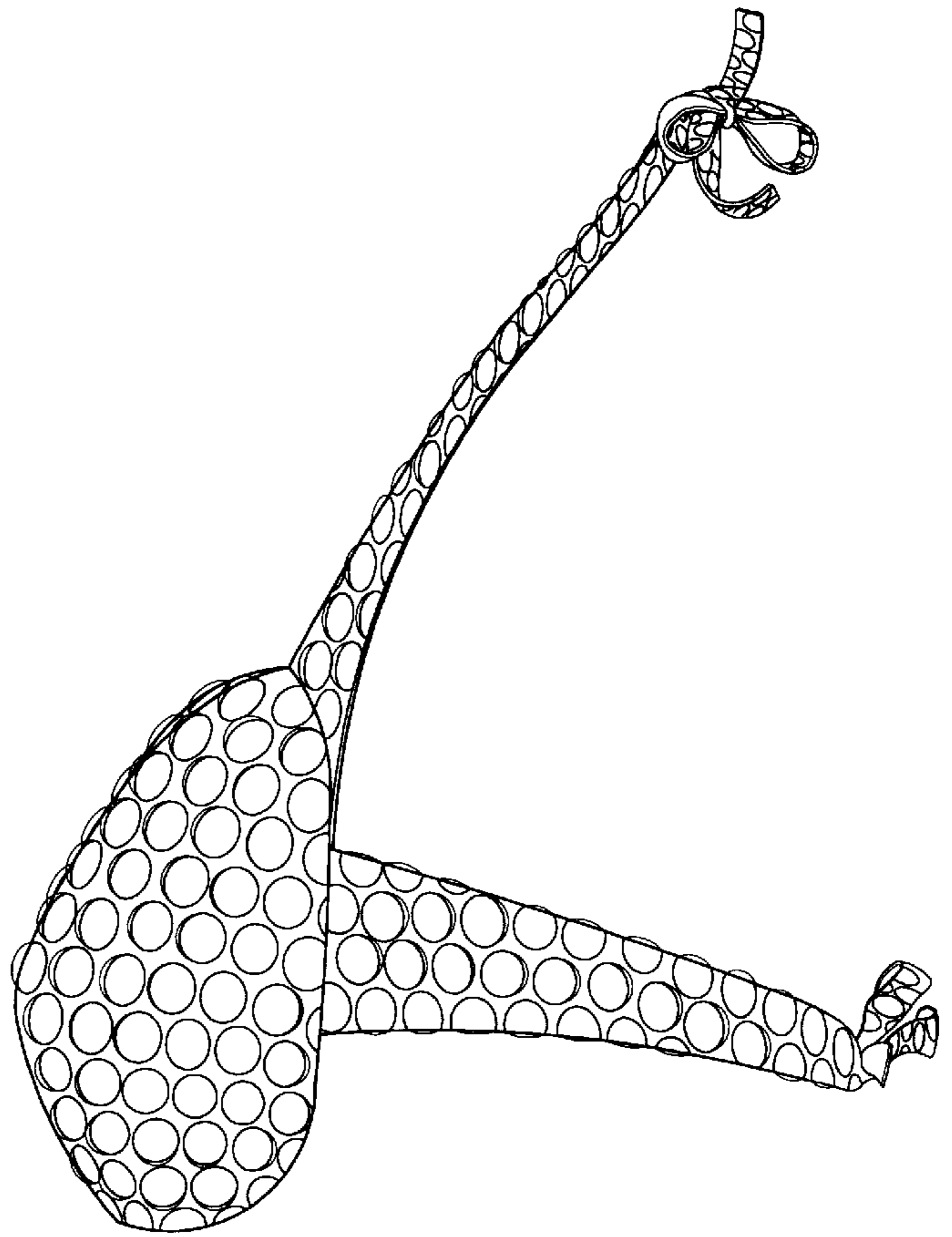

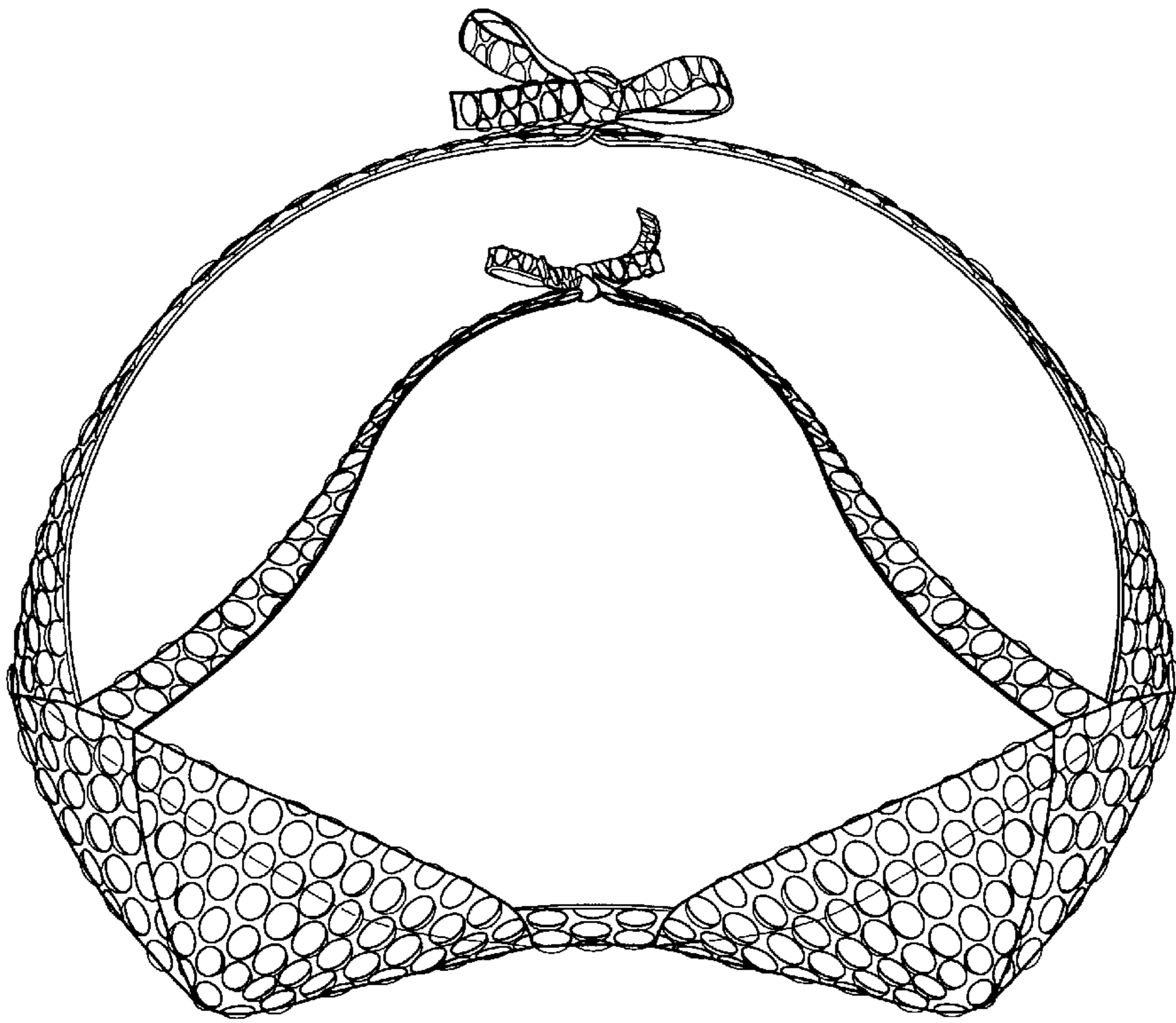

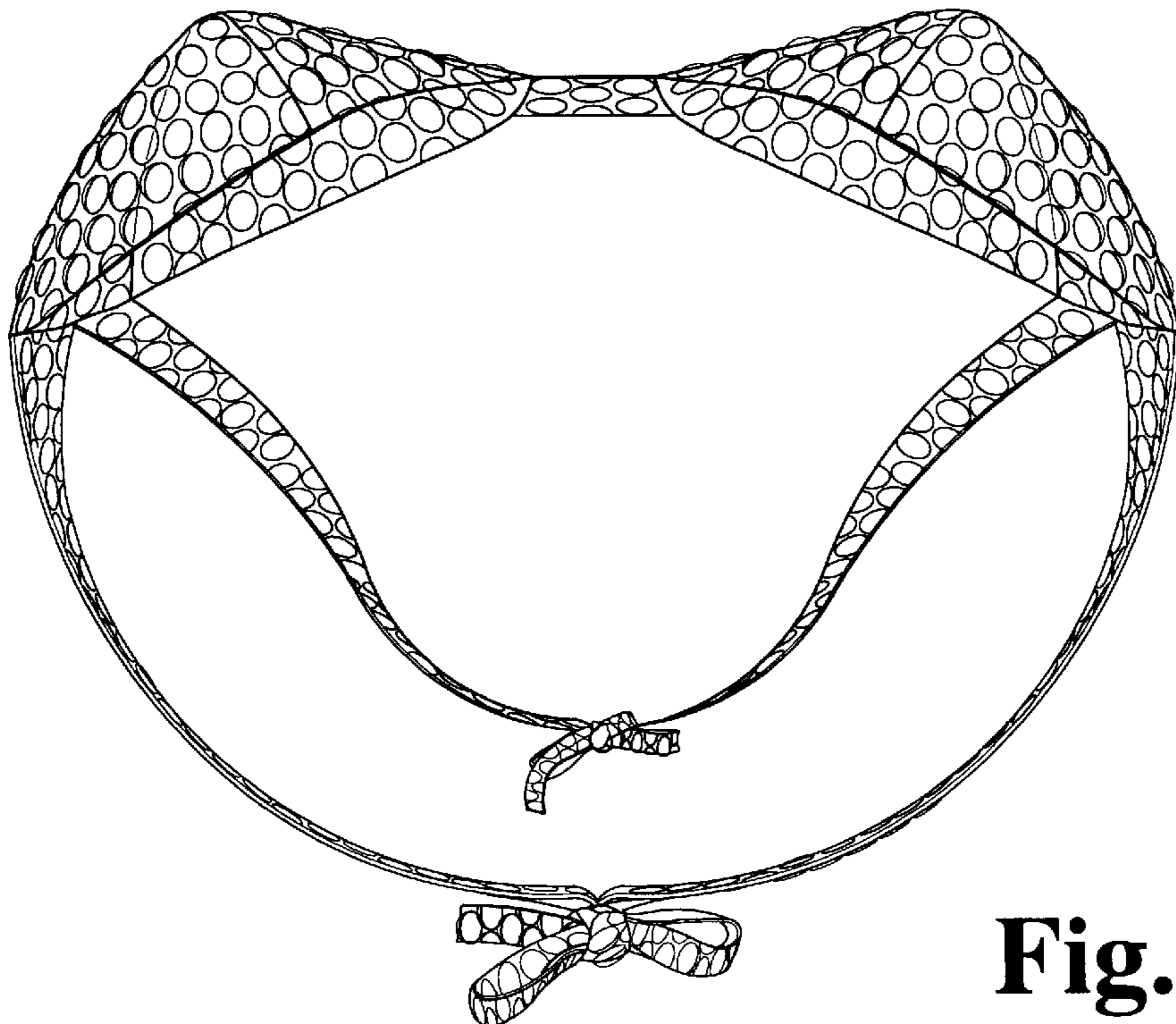
