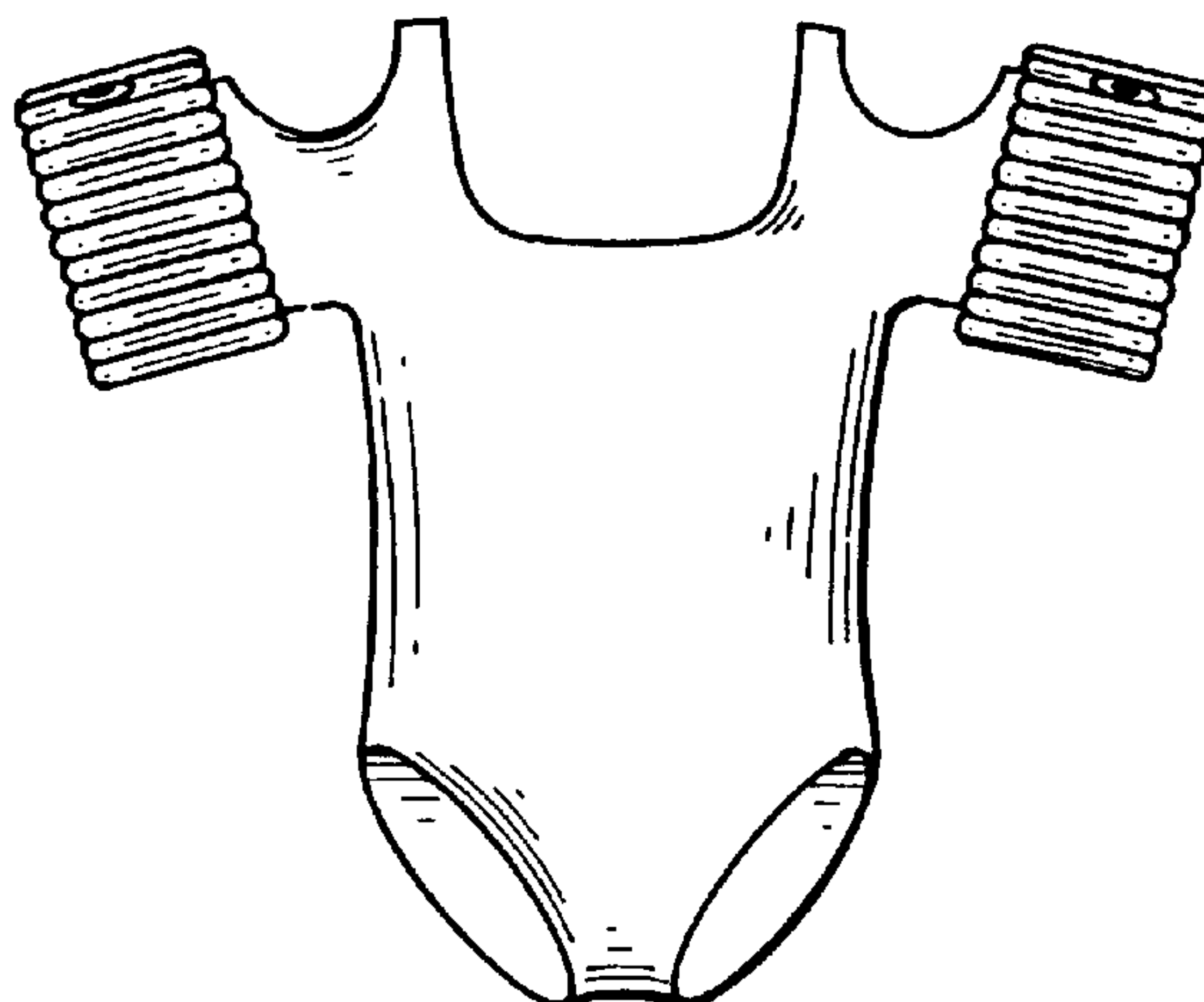

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a swimsuit with arm flotation members showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a side elevational view, with the opposite side being a mirror image thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a perspective view of an alternate embodiment of the design shown in FIG. 1, the opposite side being a mirror image.  
The broken line showing of environment in FIGS. 1 and 8 is for illustrative purposes only and forms no part of the claimed design.

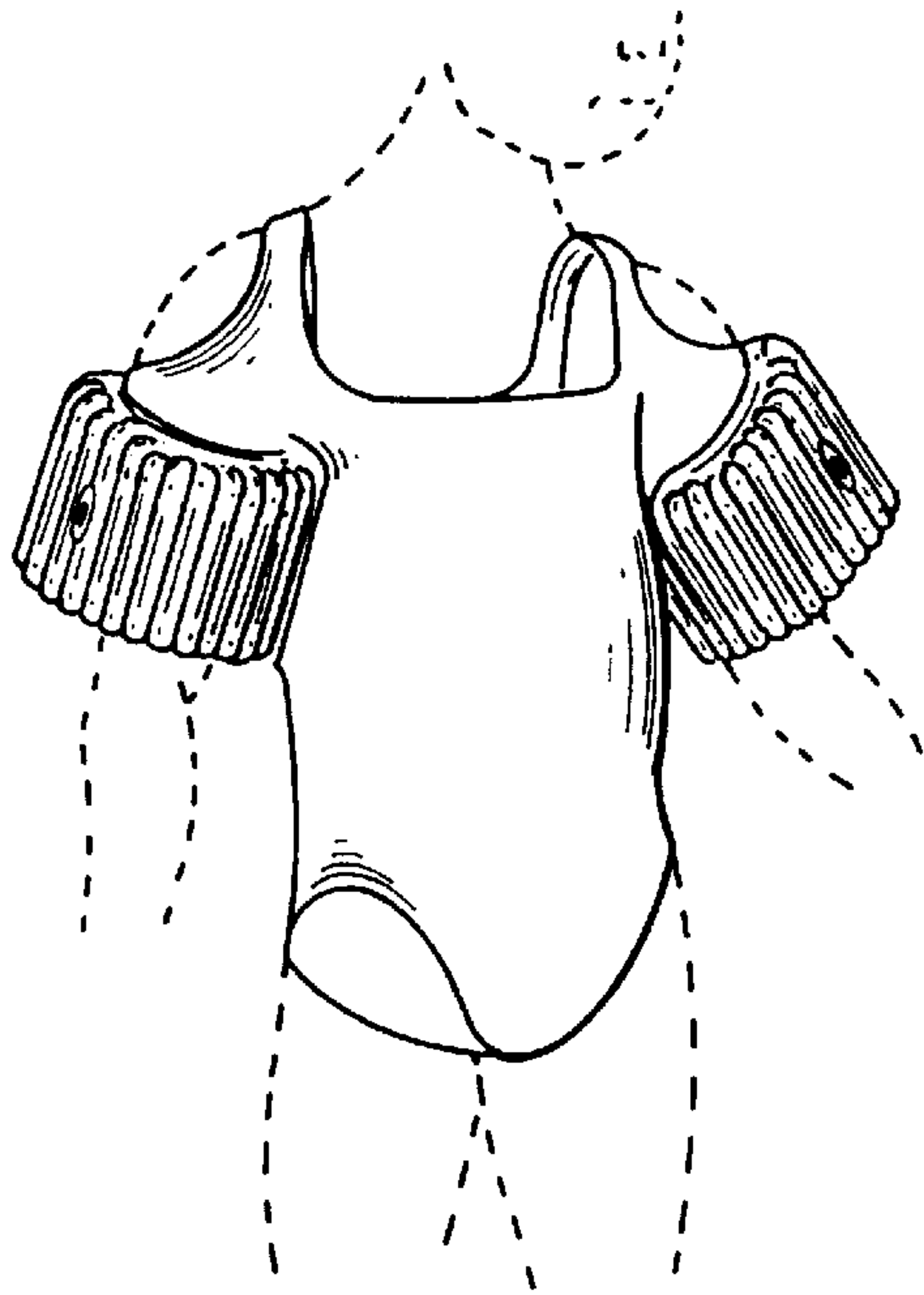

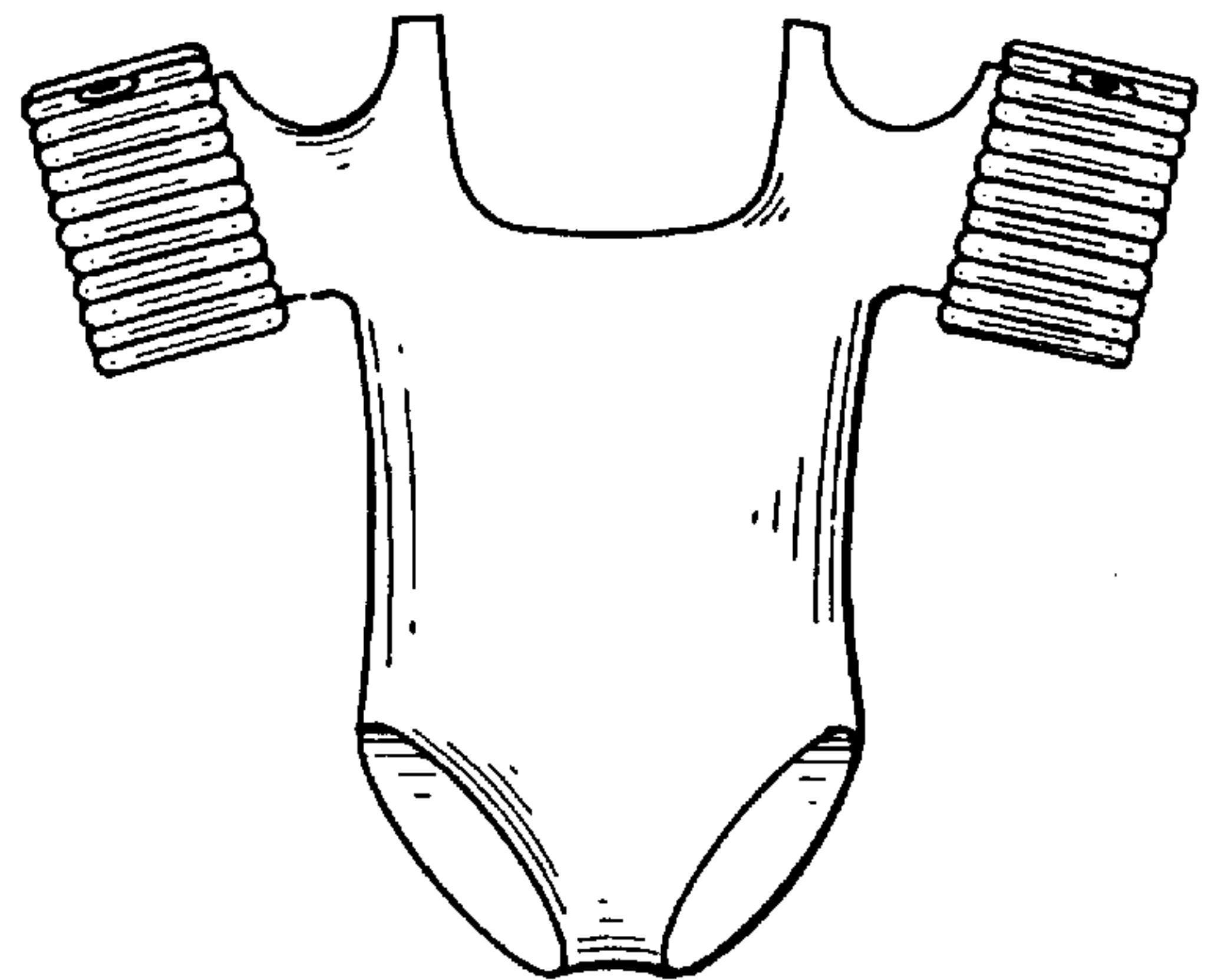

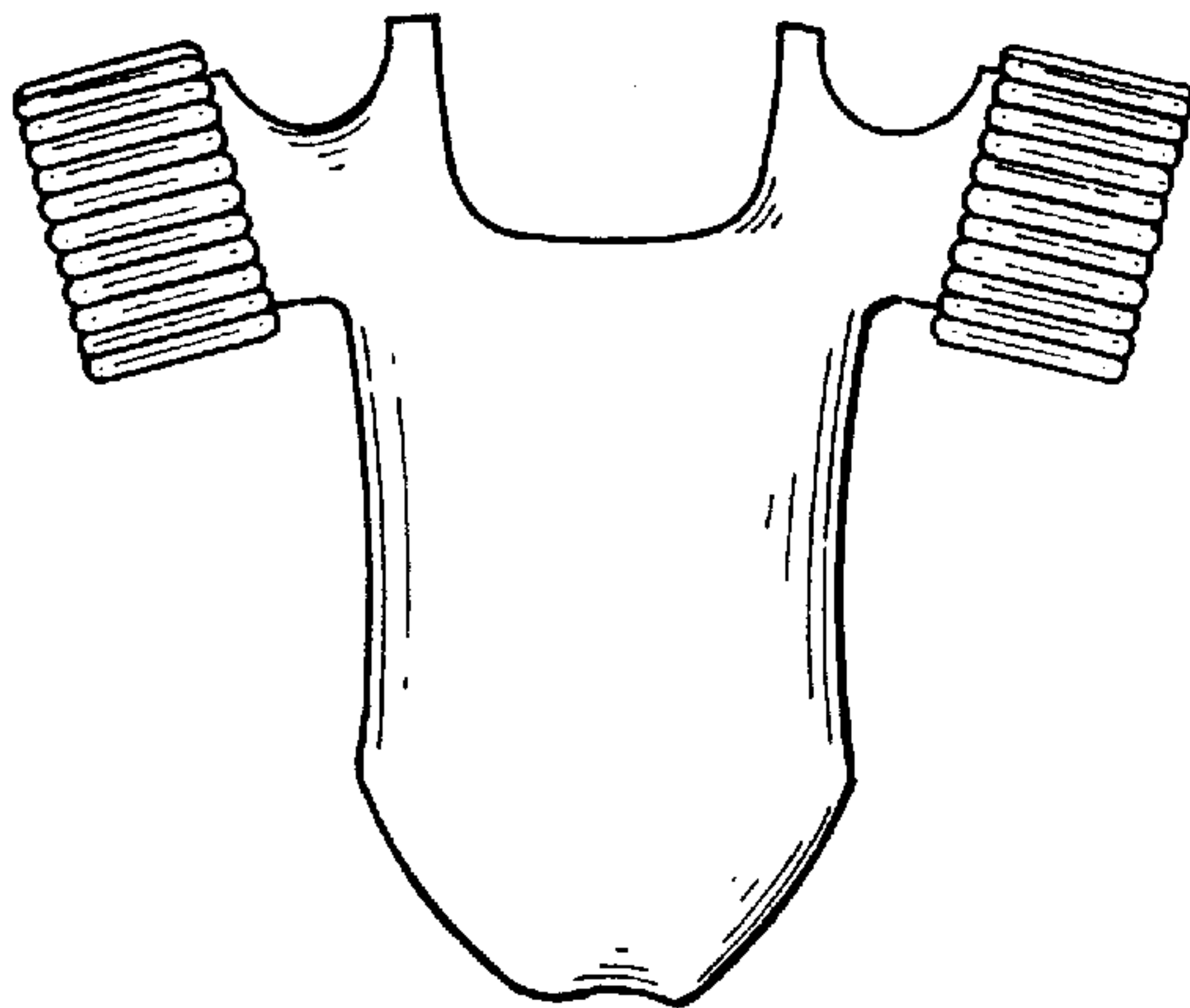
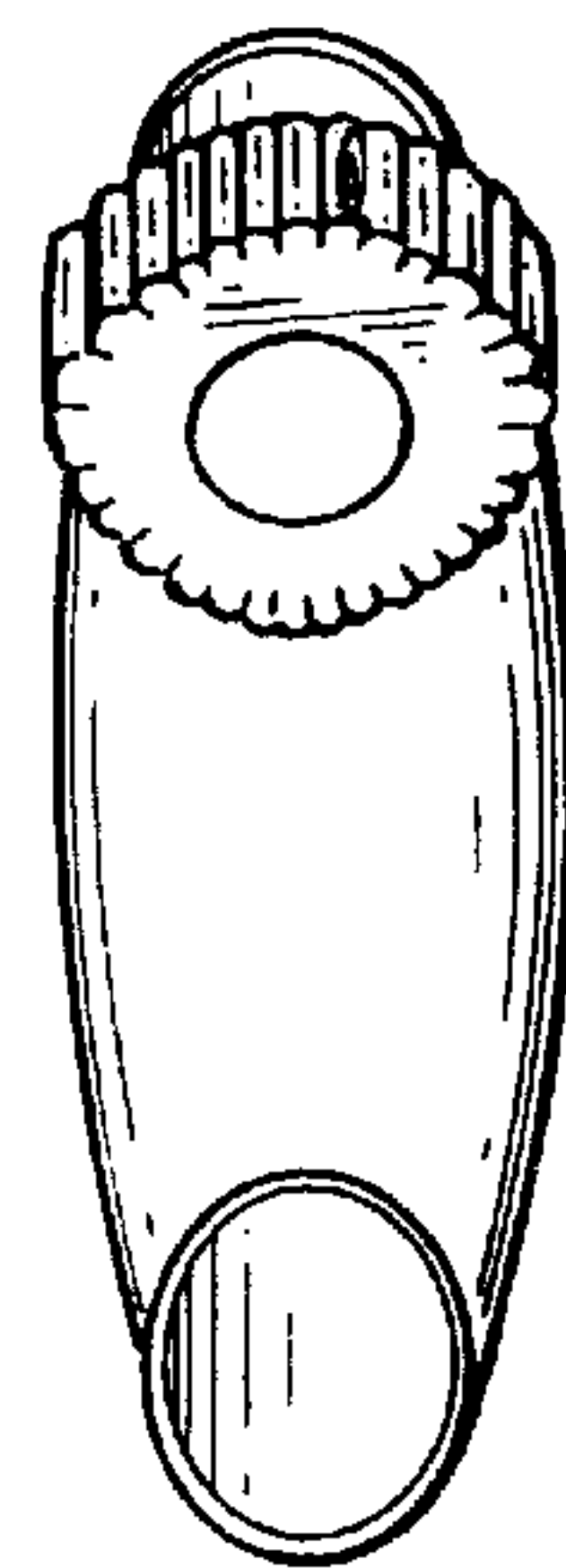

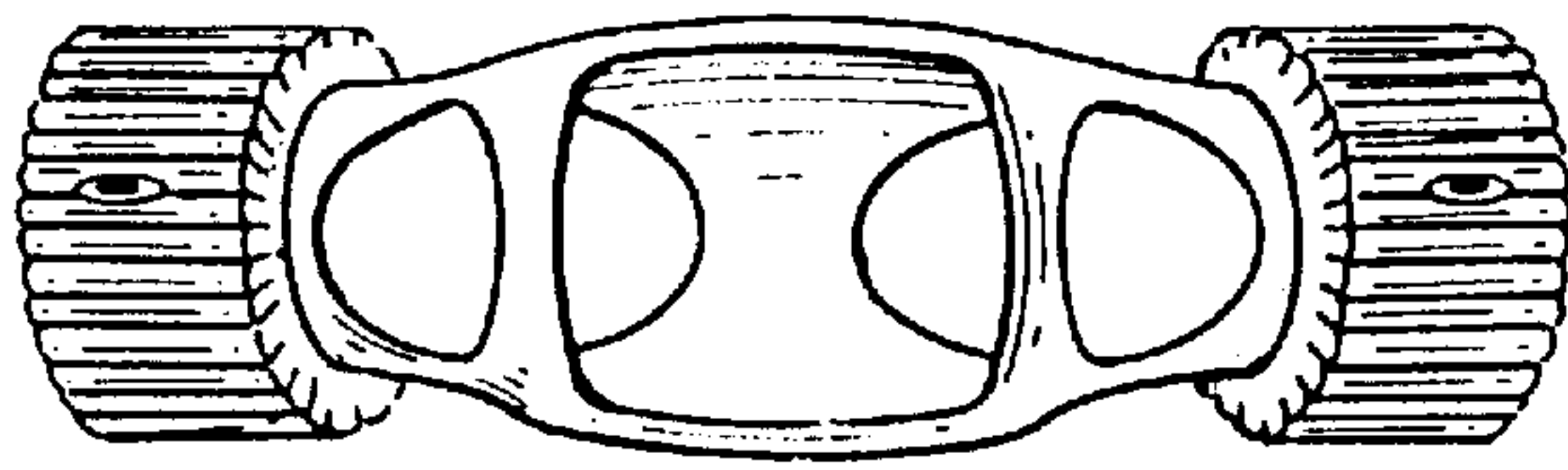

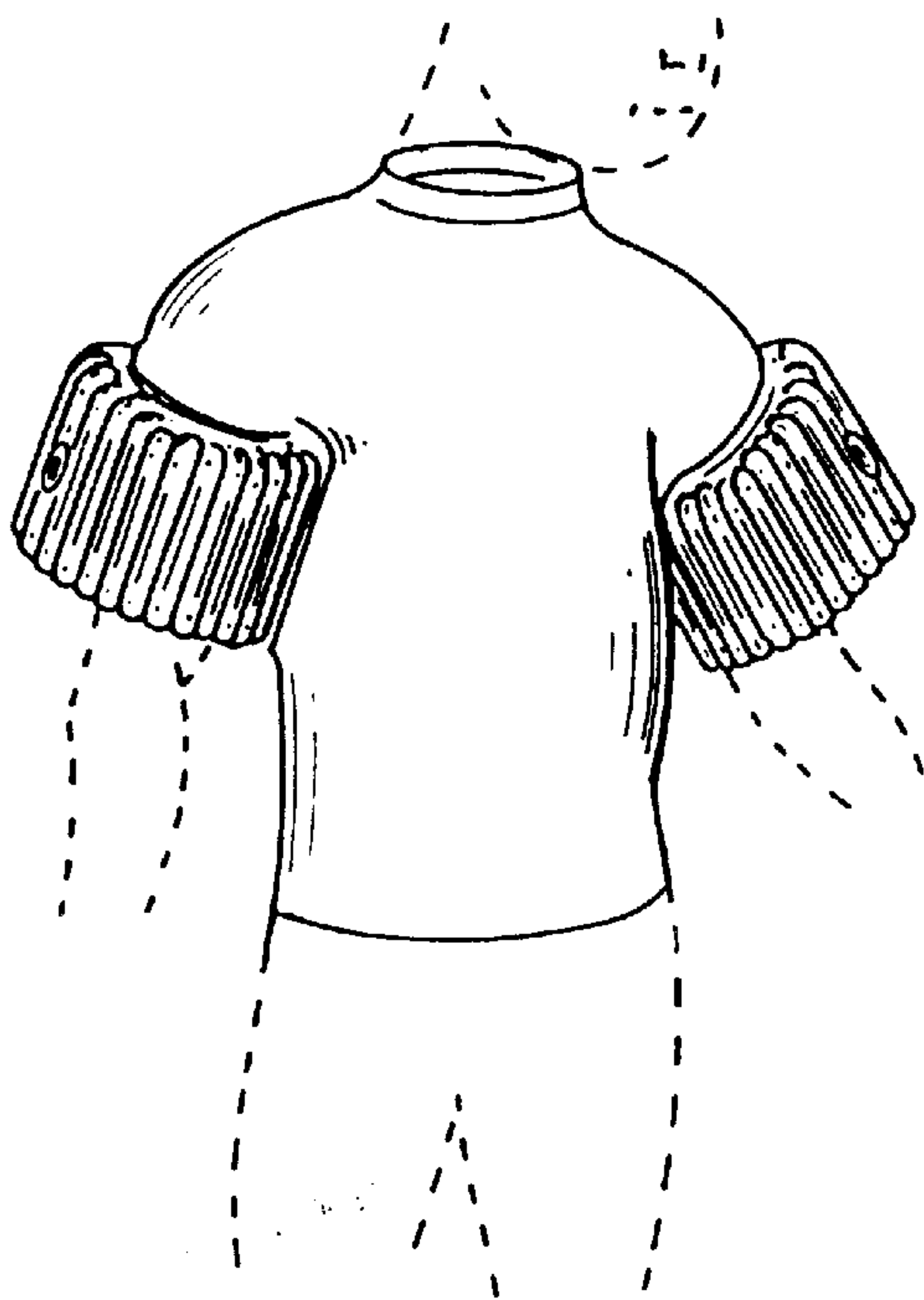
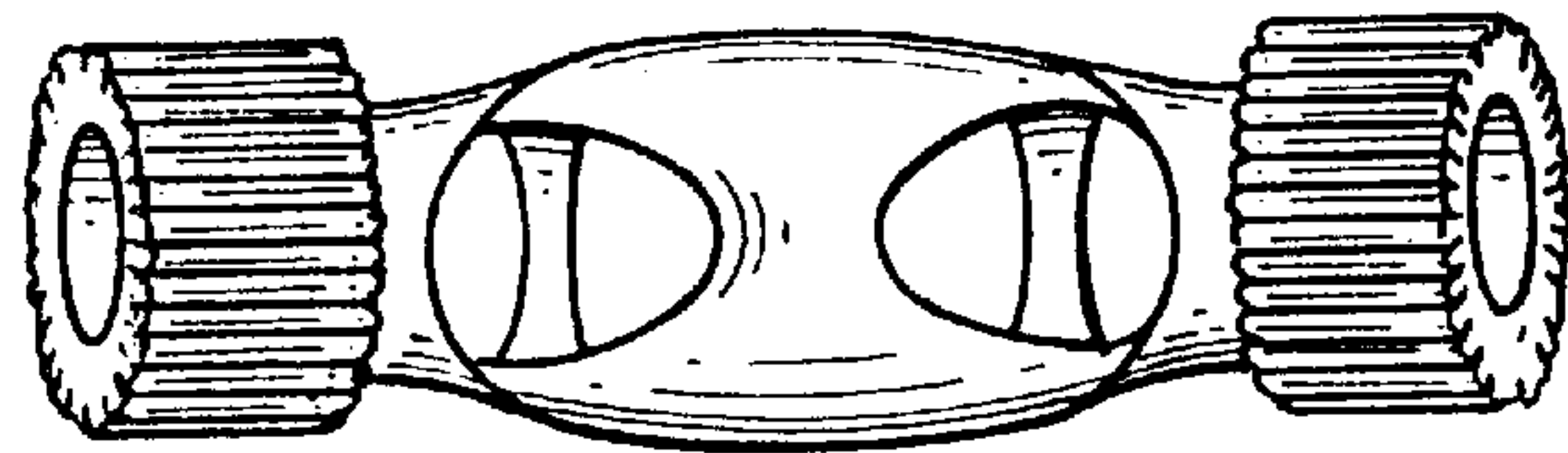
