The ornamental design for a key tag, as shown and described.

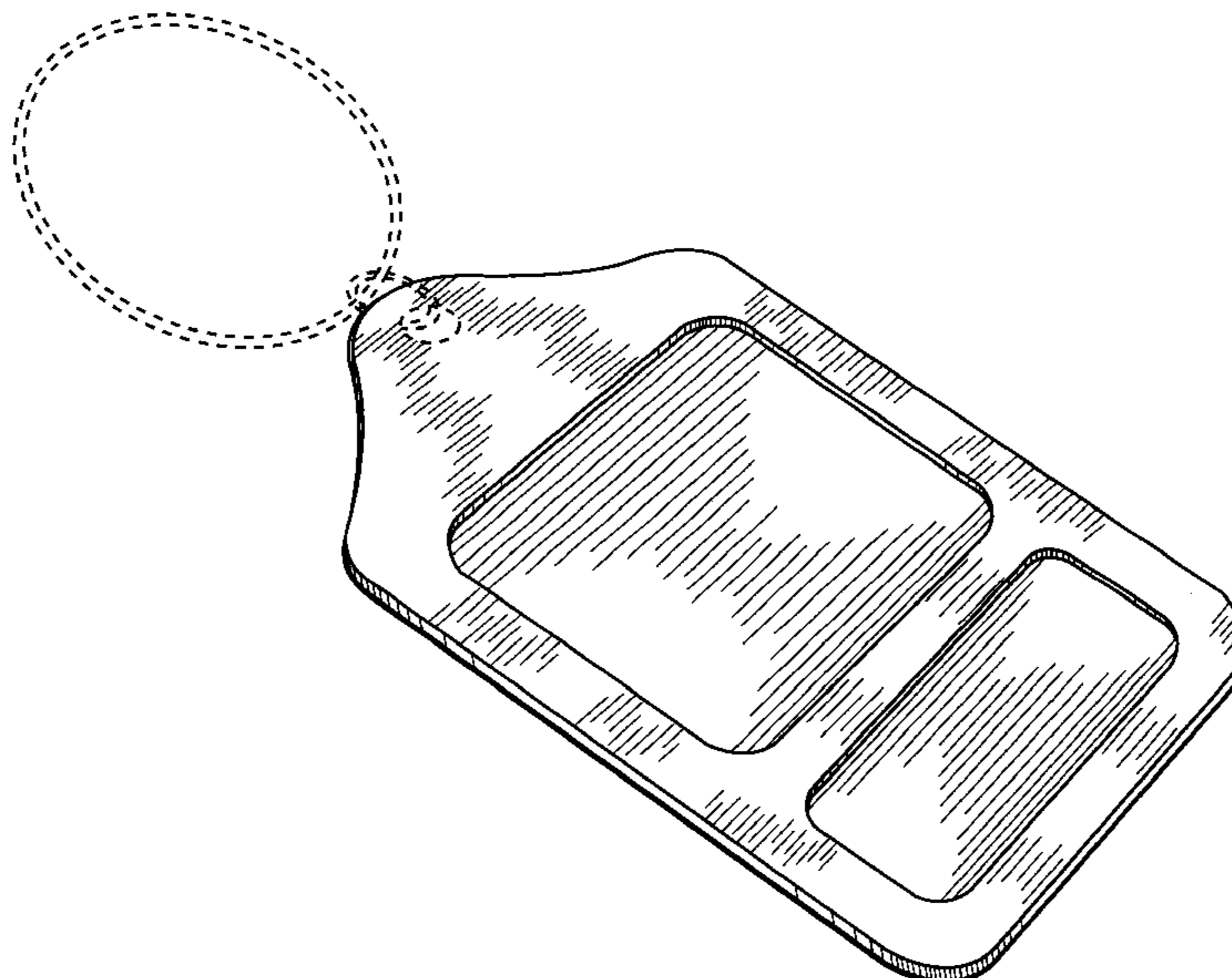
DESCRIPTION

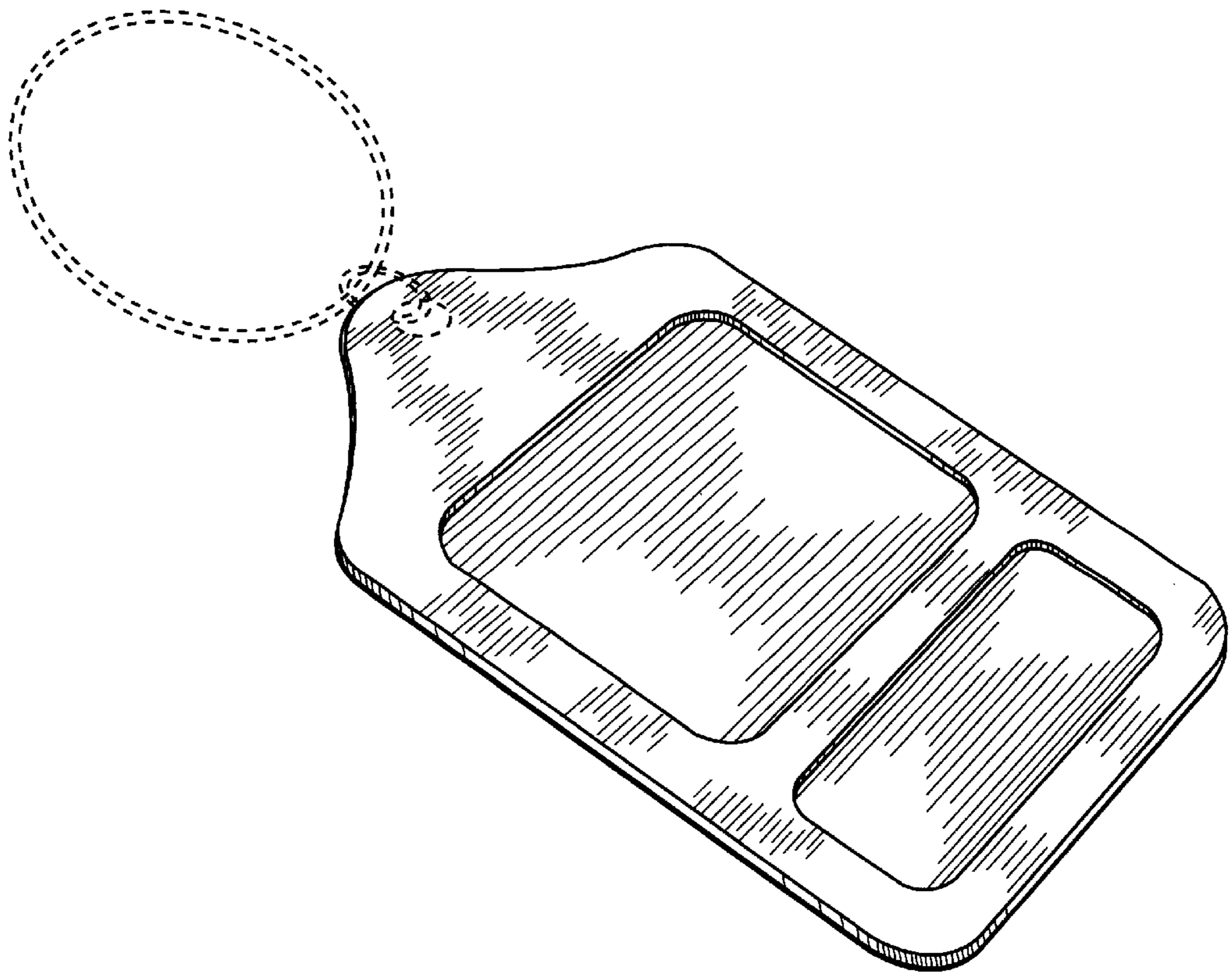

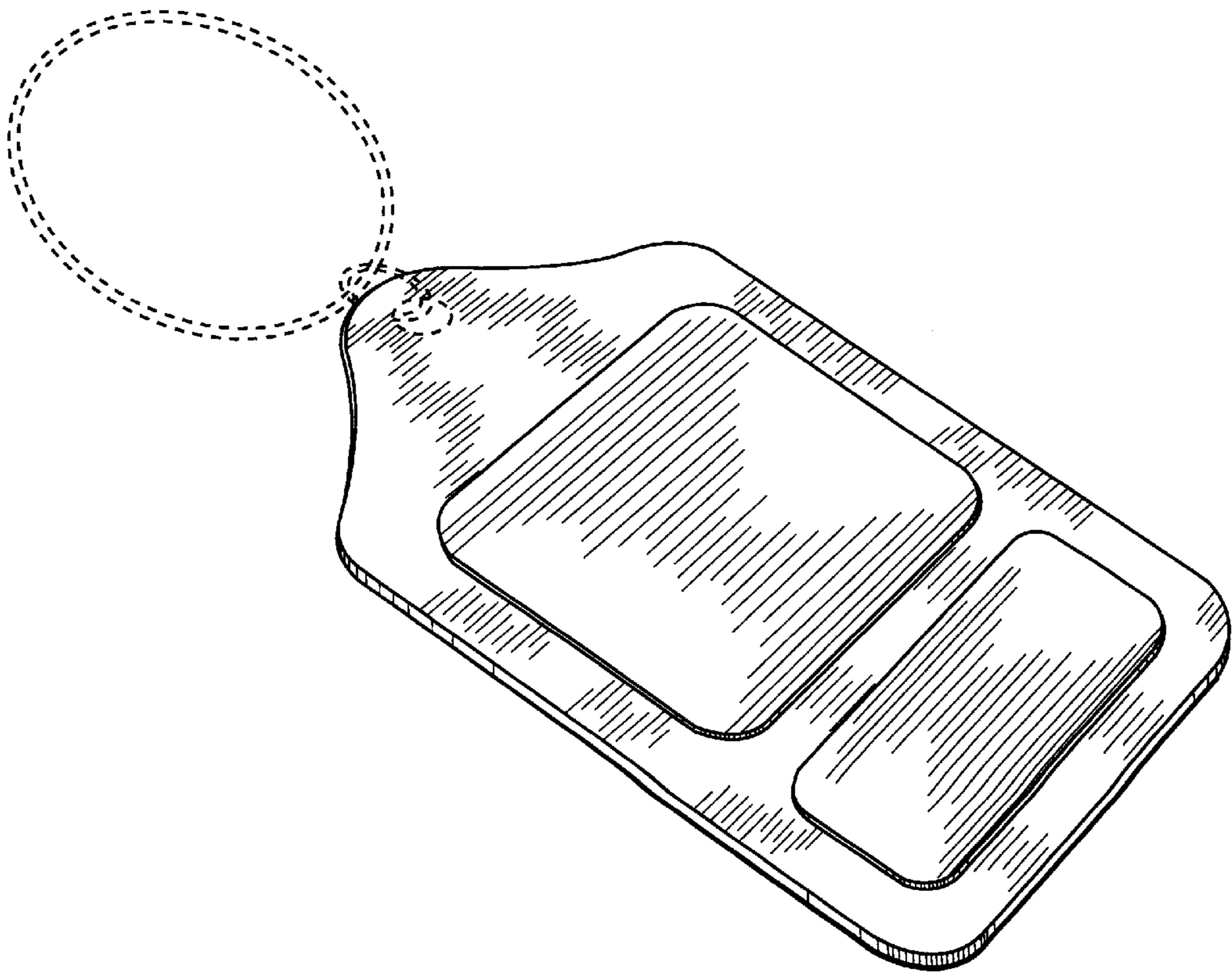

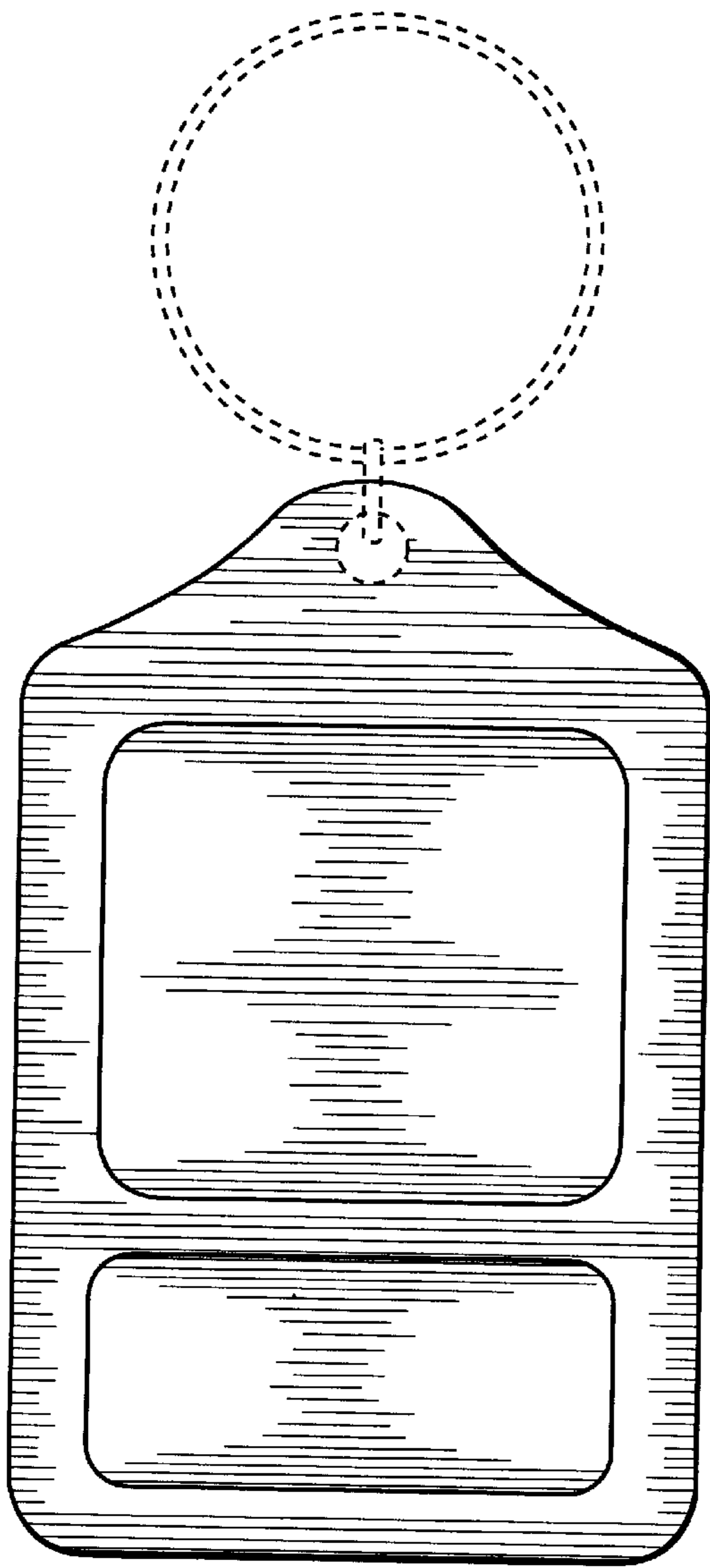

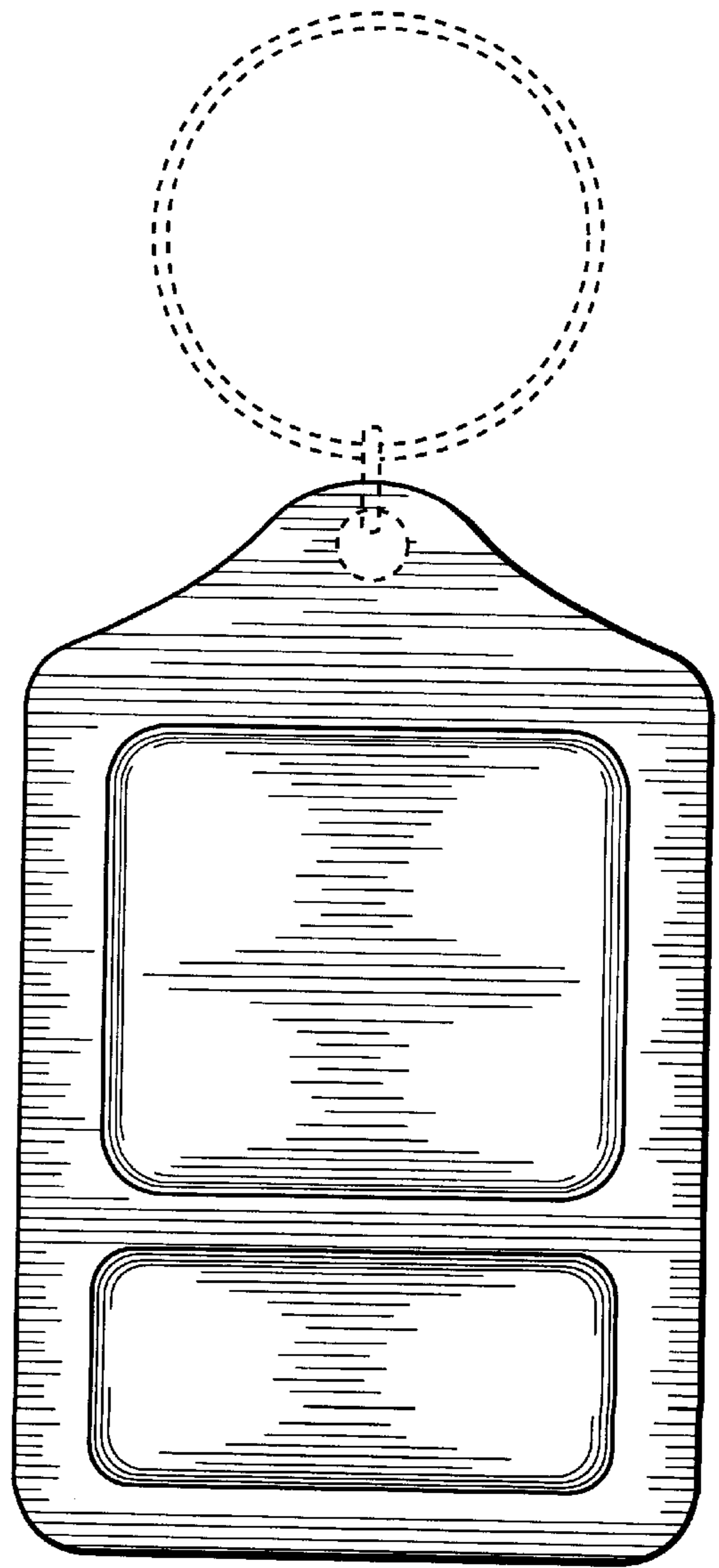

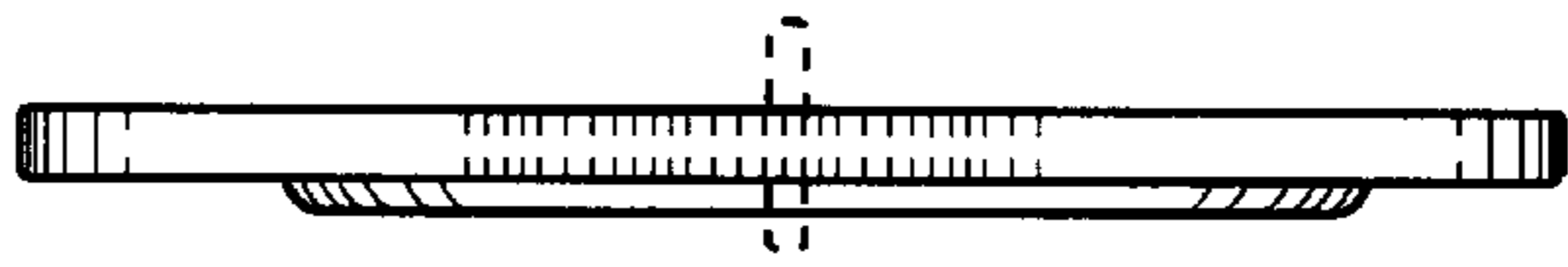

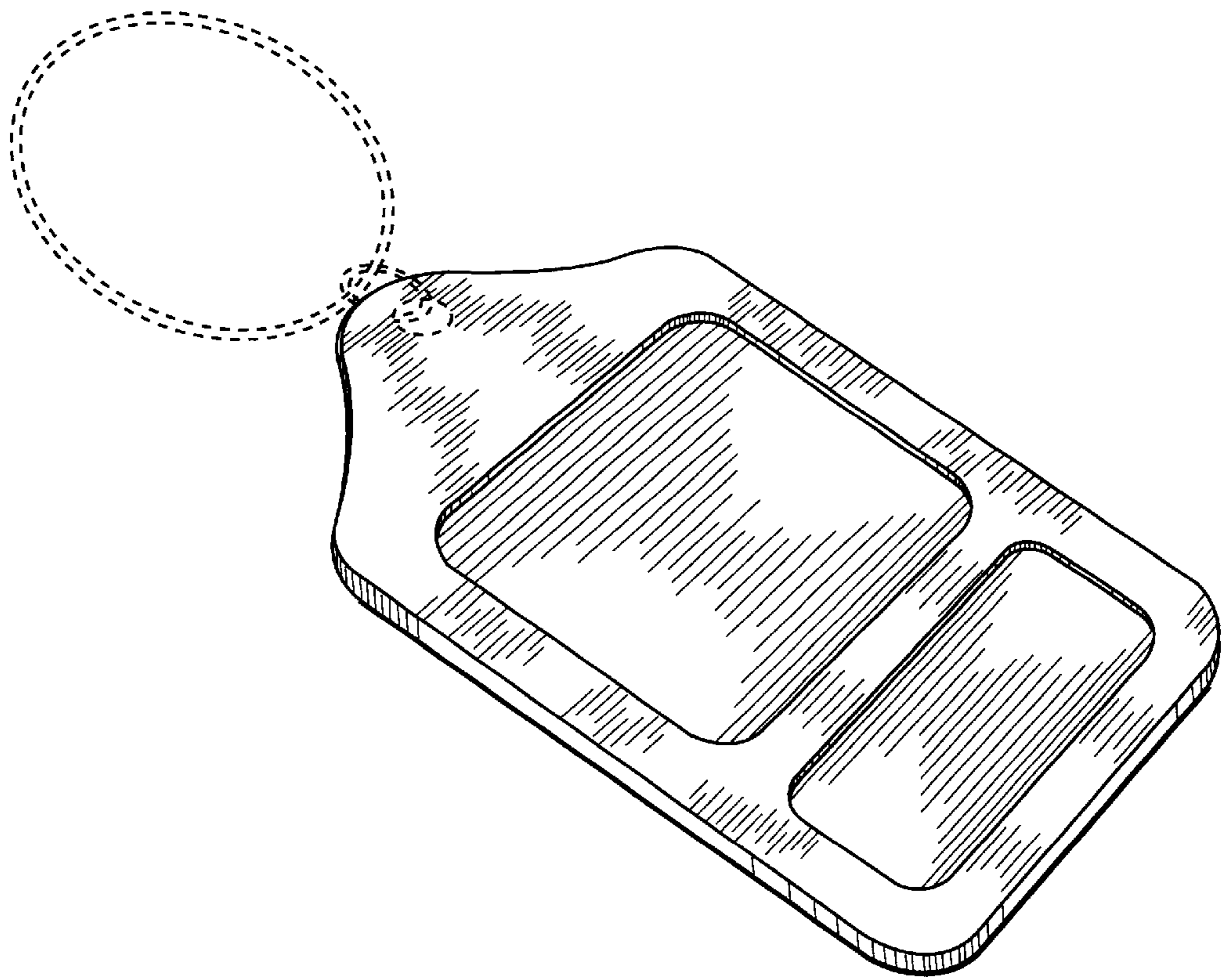

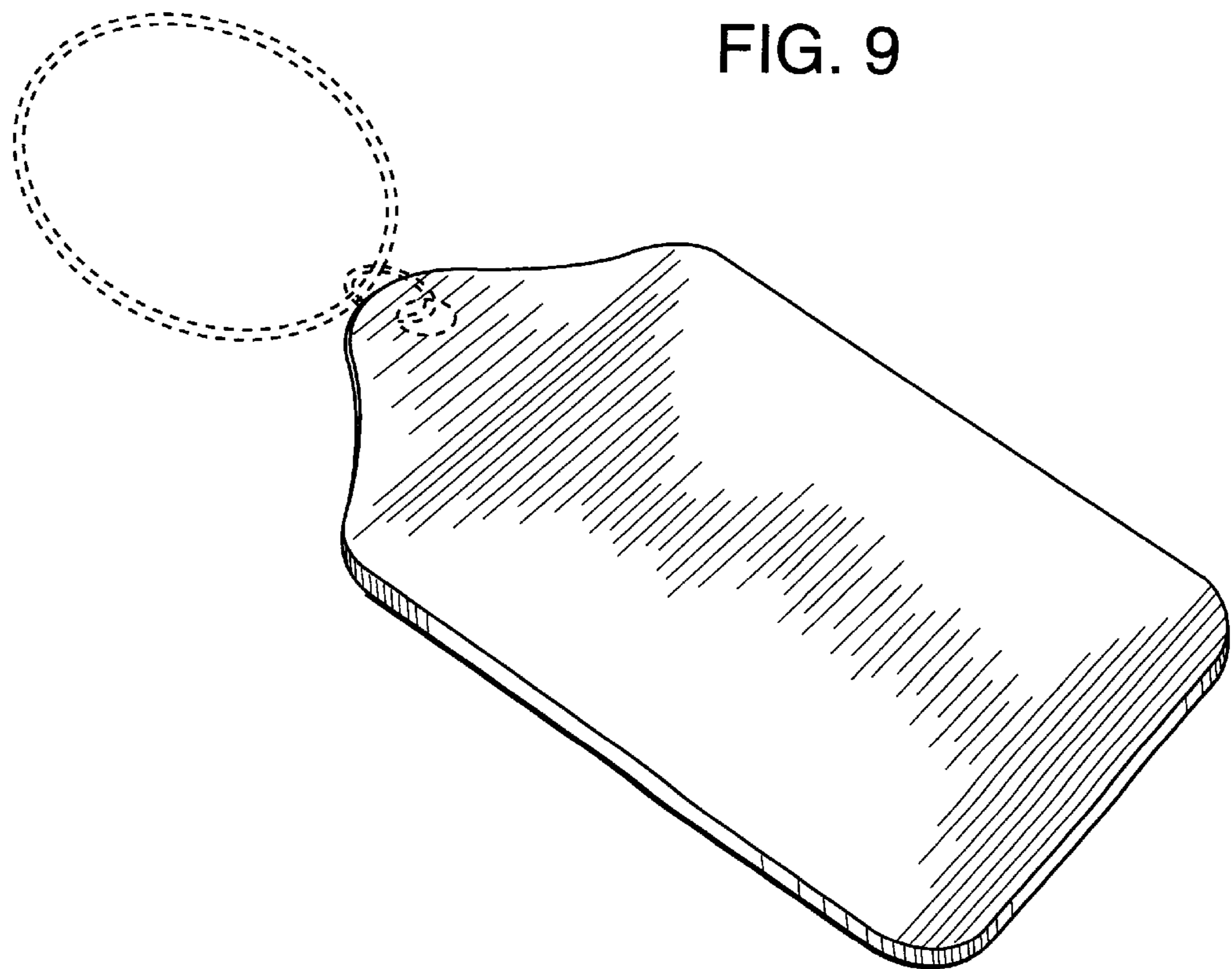

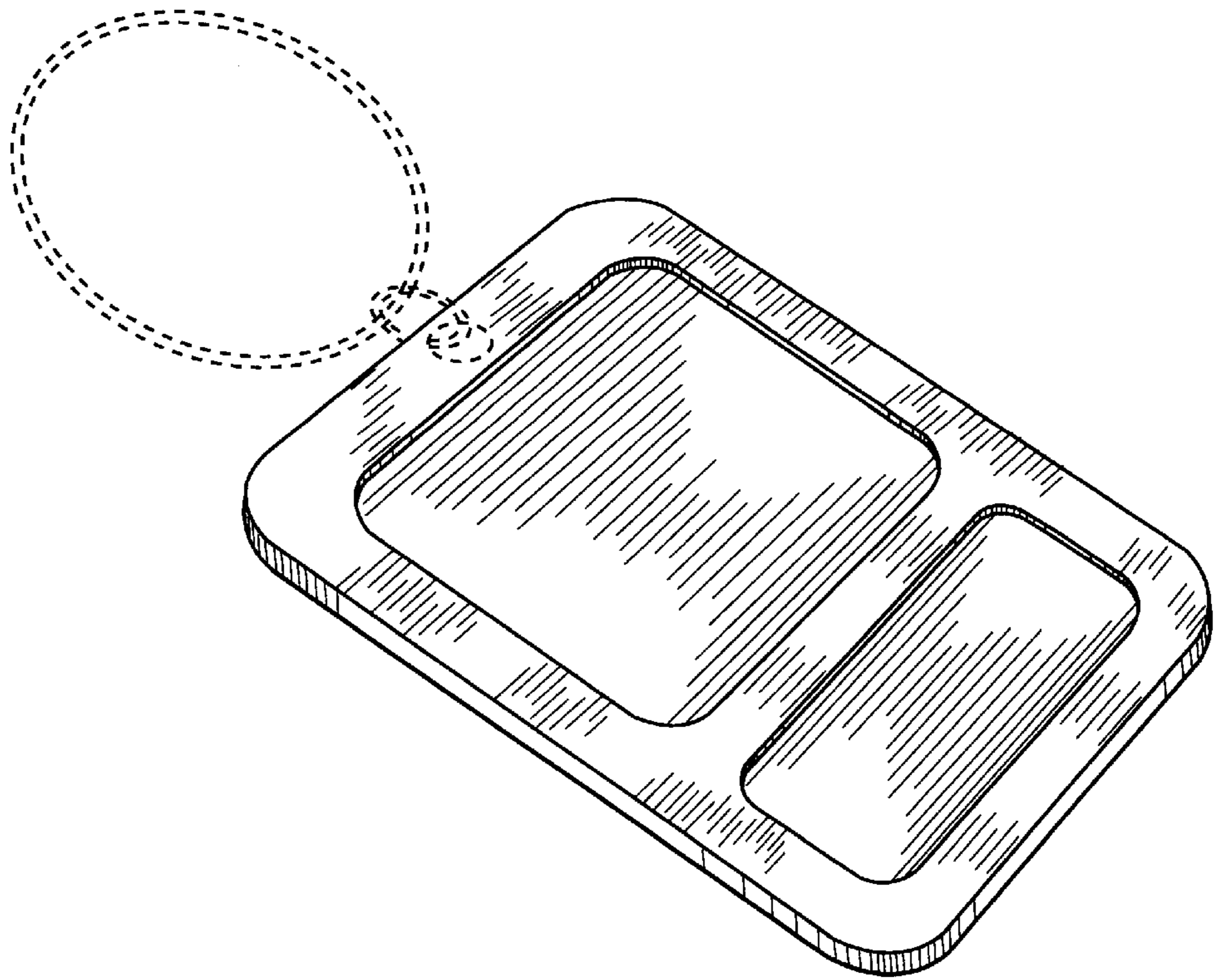

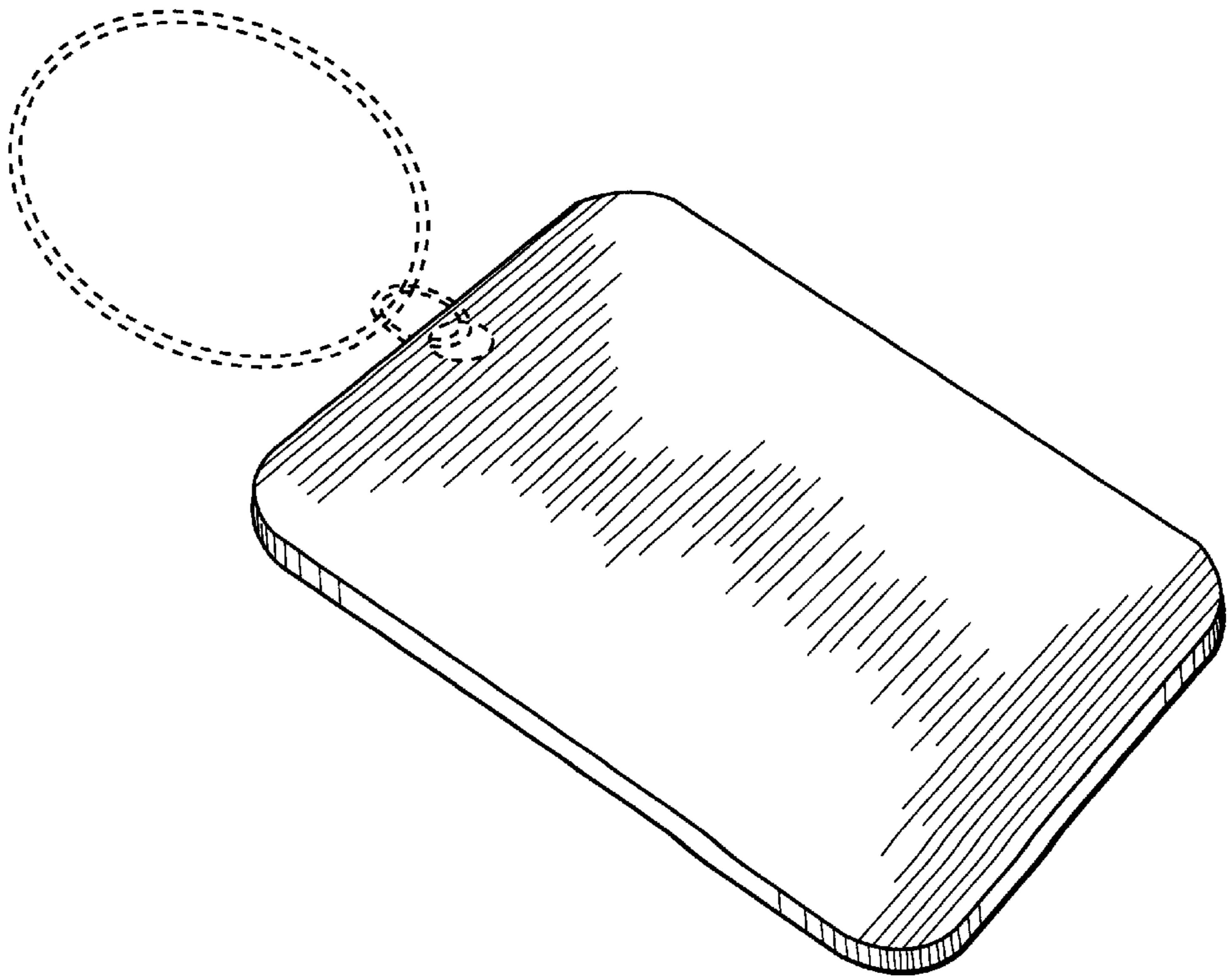

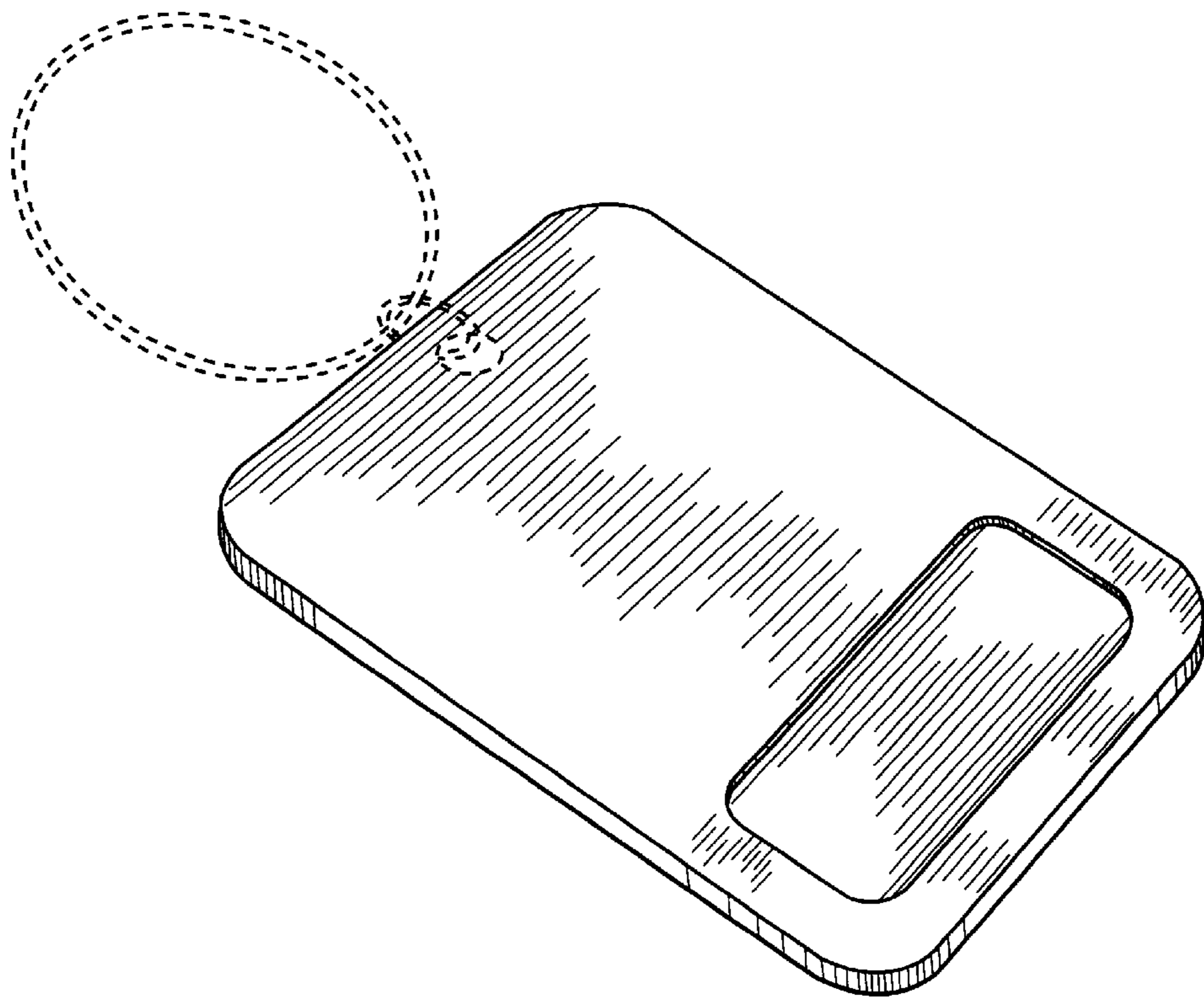

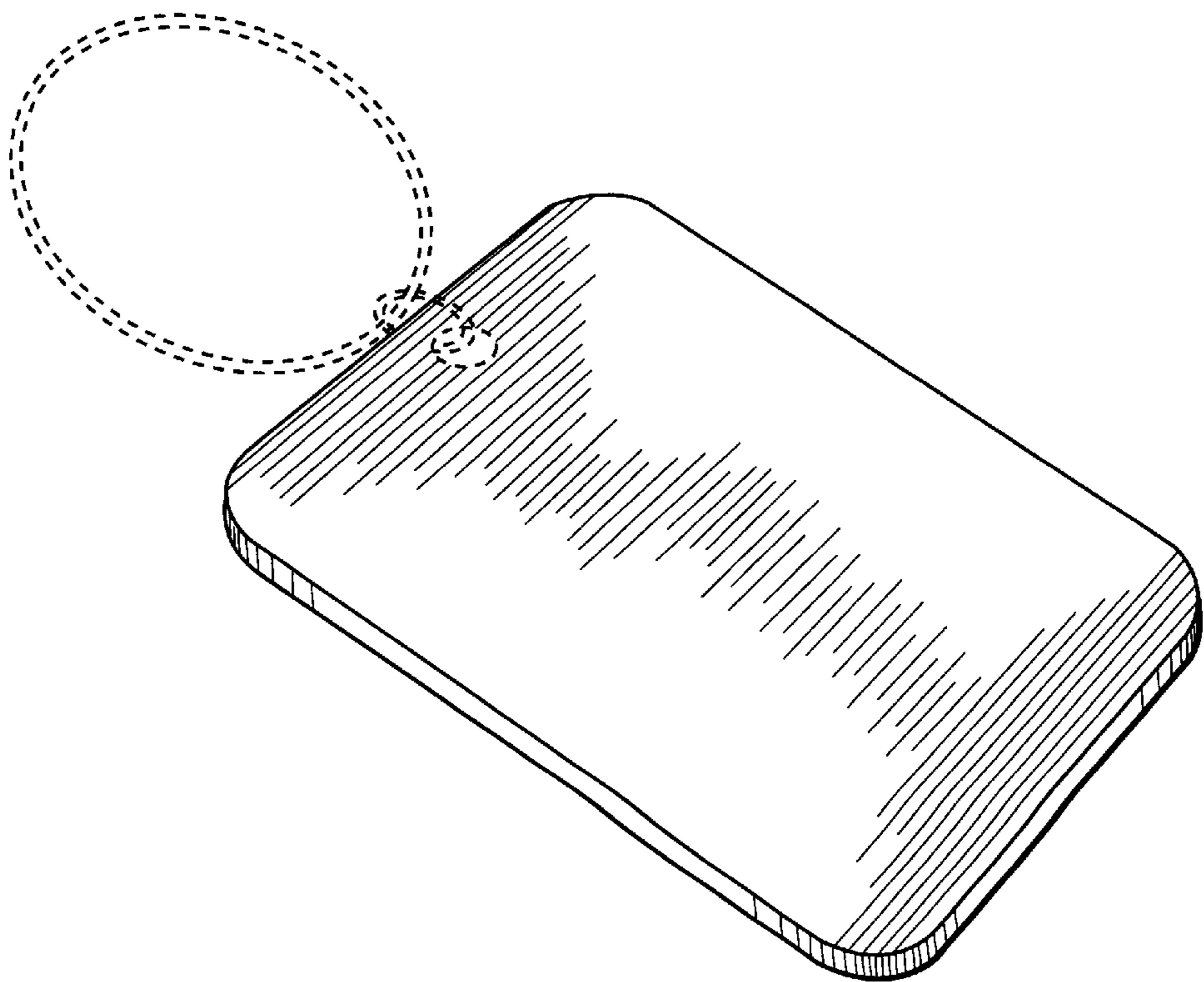

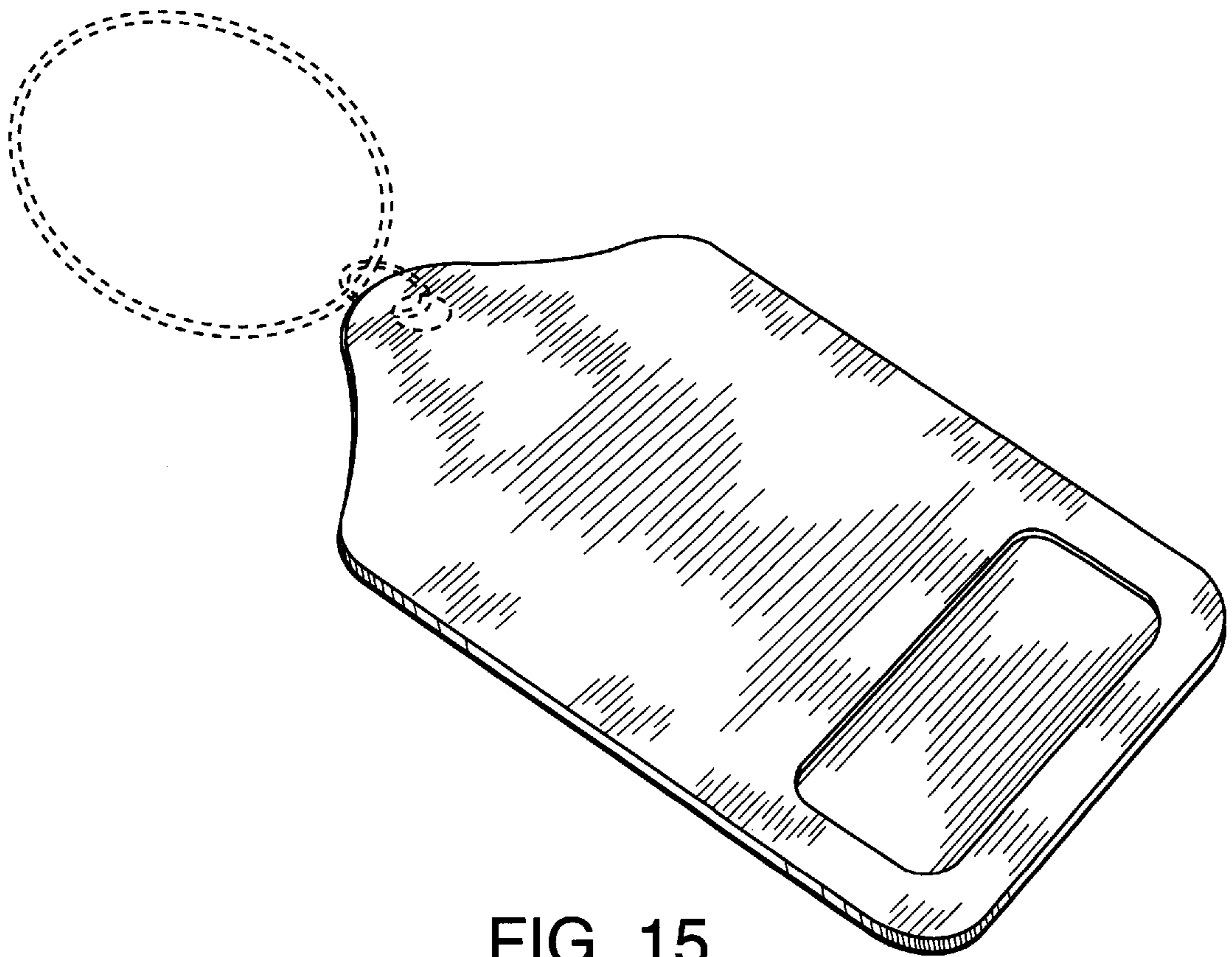

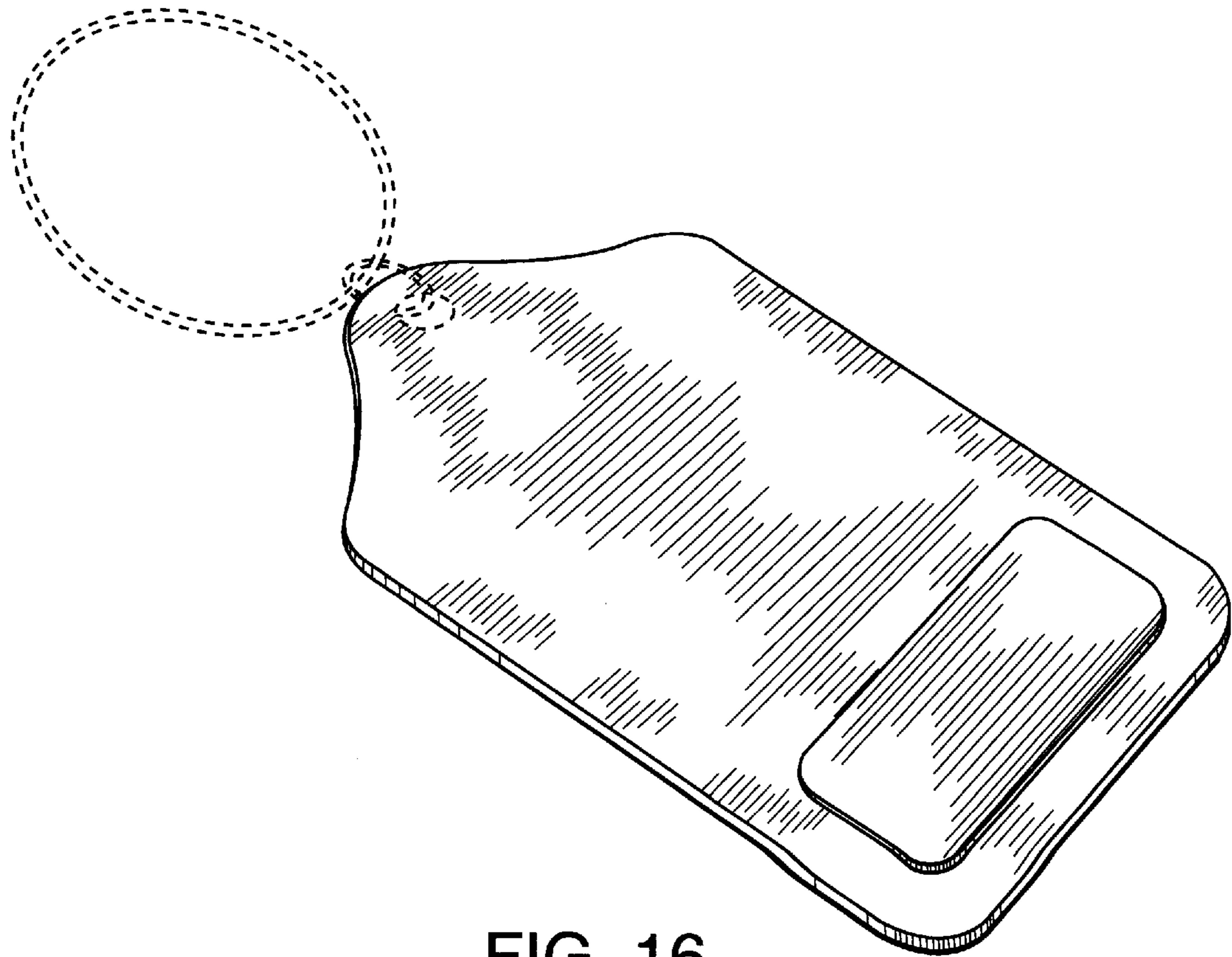

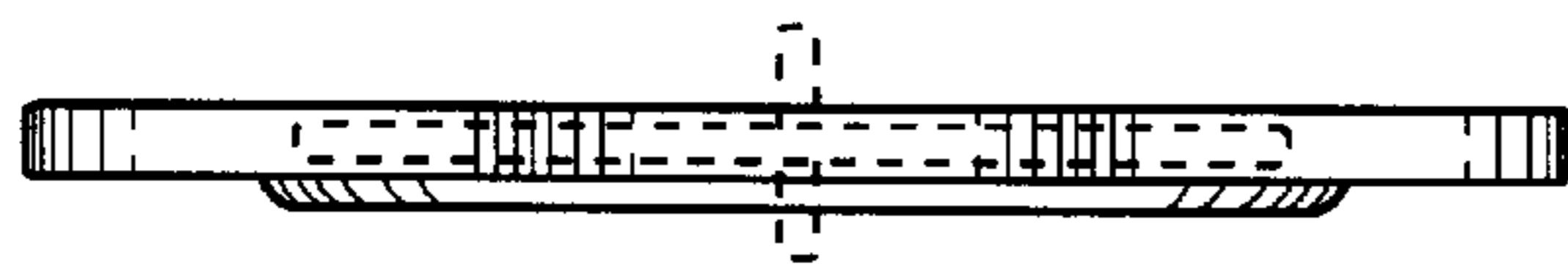

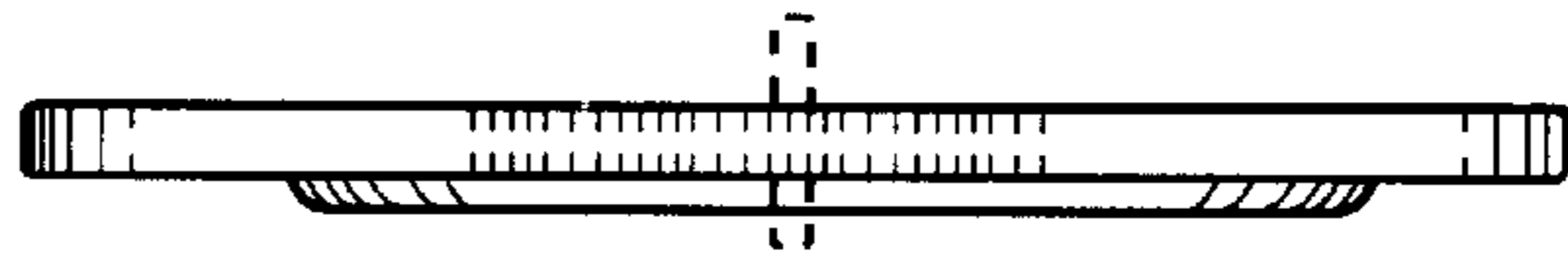

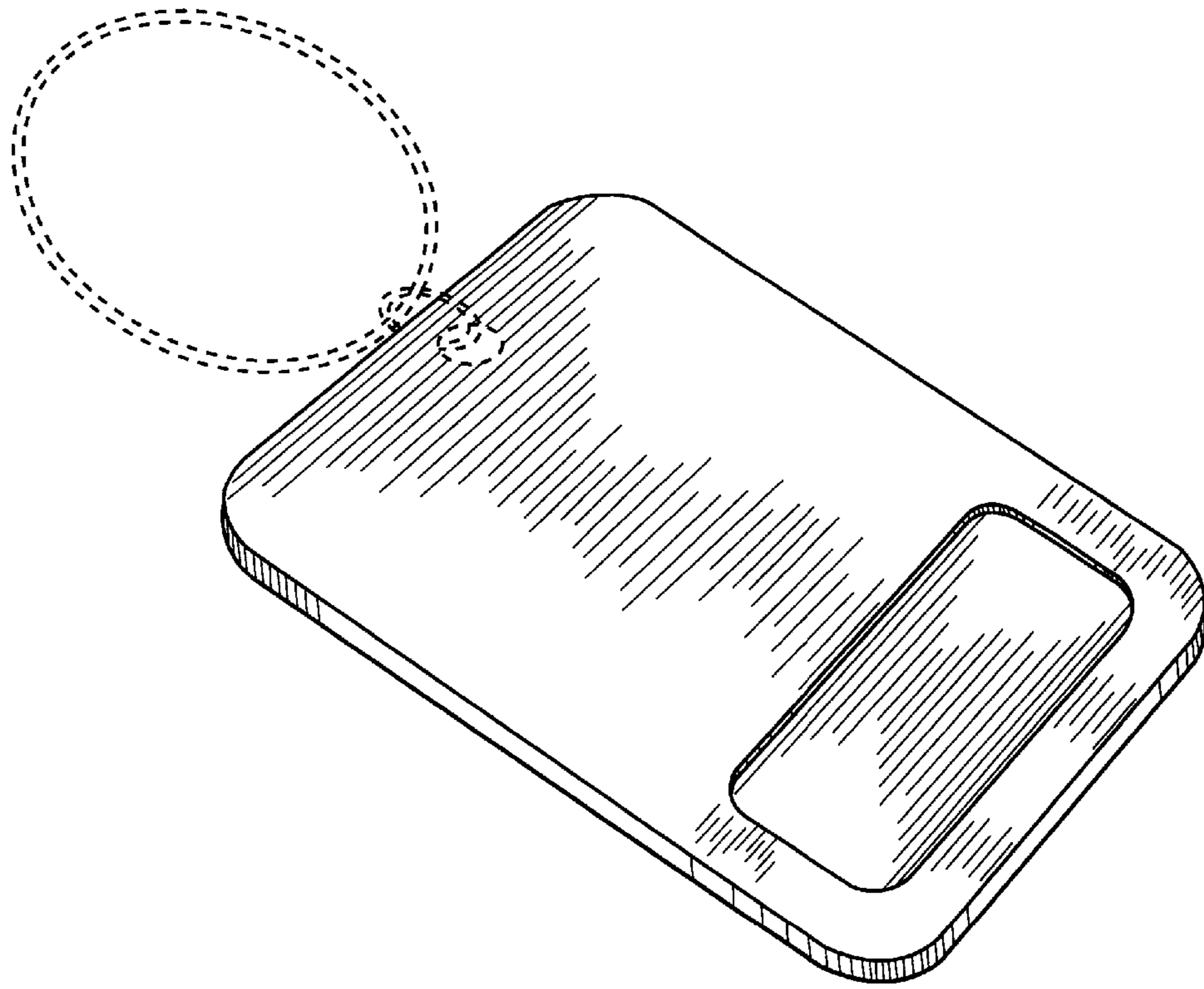

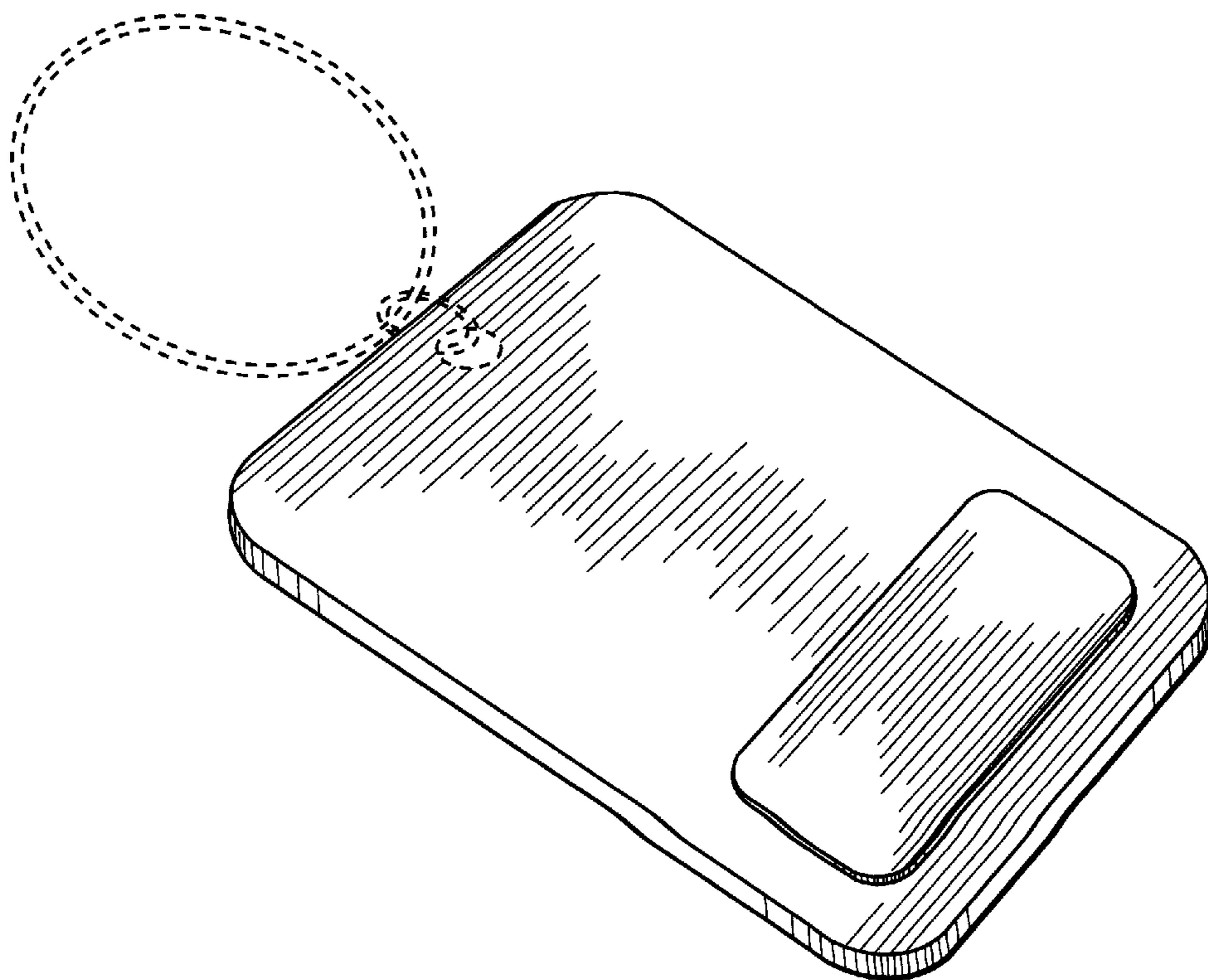
