FIG. 2 is a front elevational view thereof;

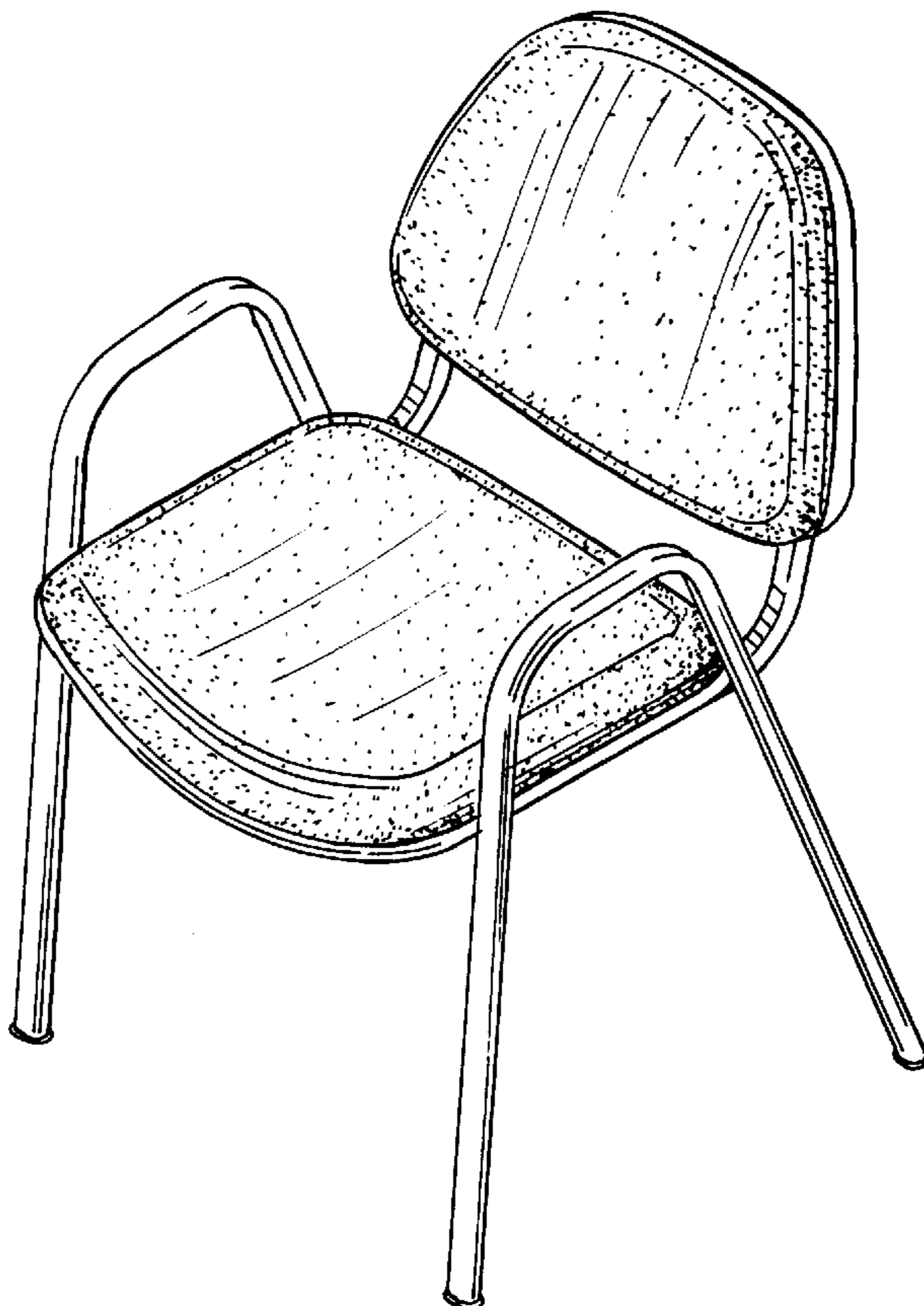
FIG. 3 is a right-side elevational view thereof, with the left-side elevational view being a mirror image thereof;

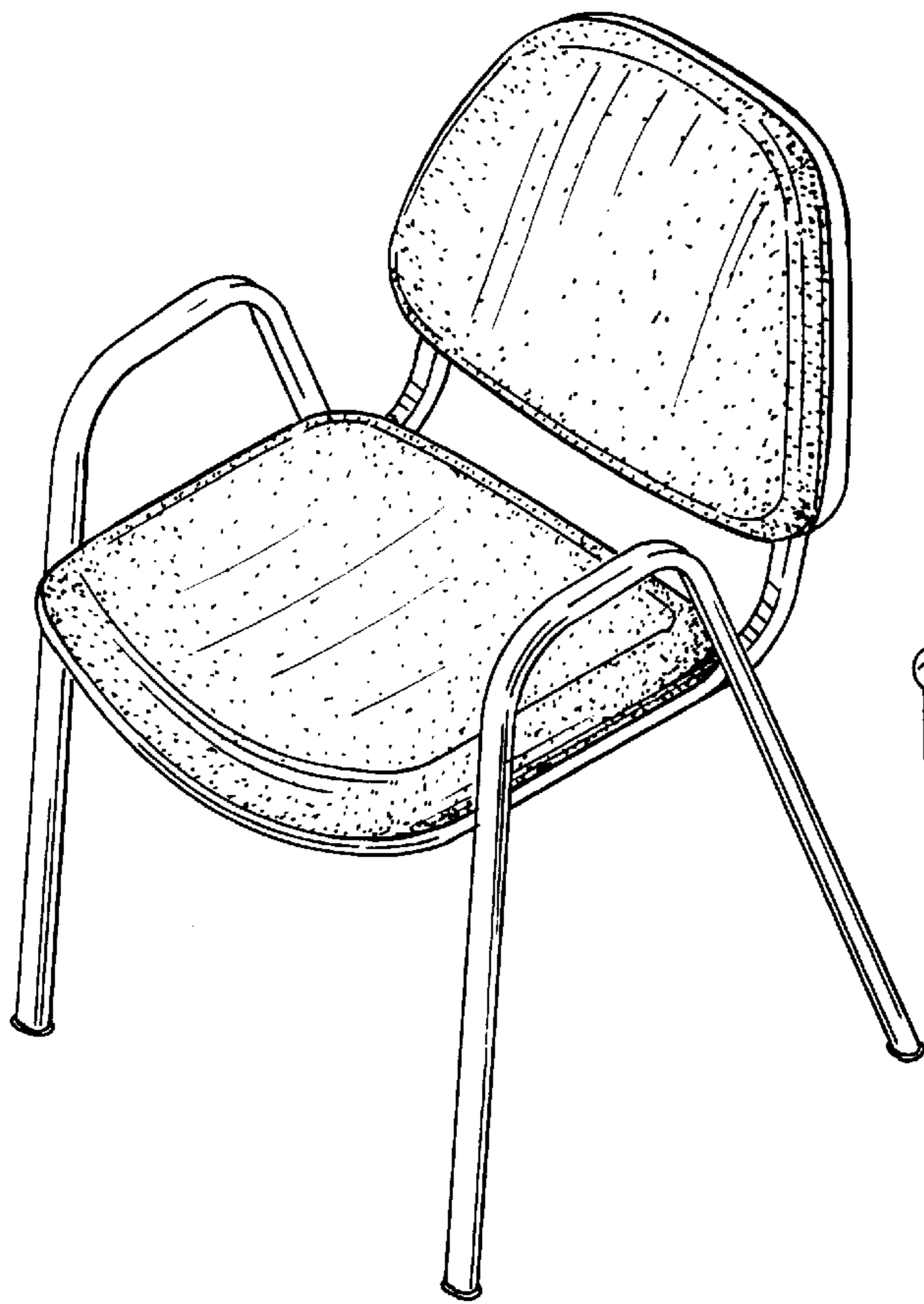

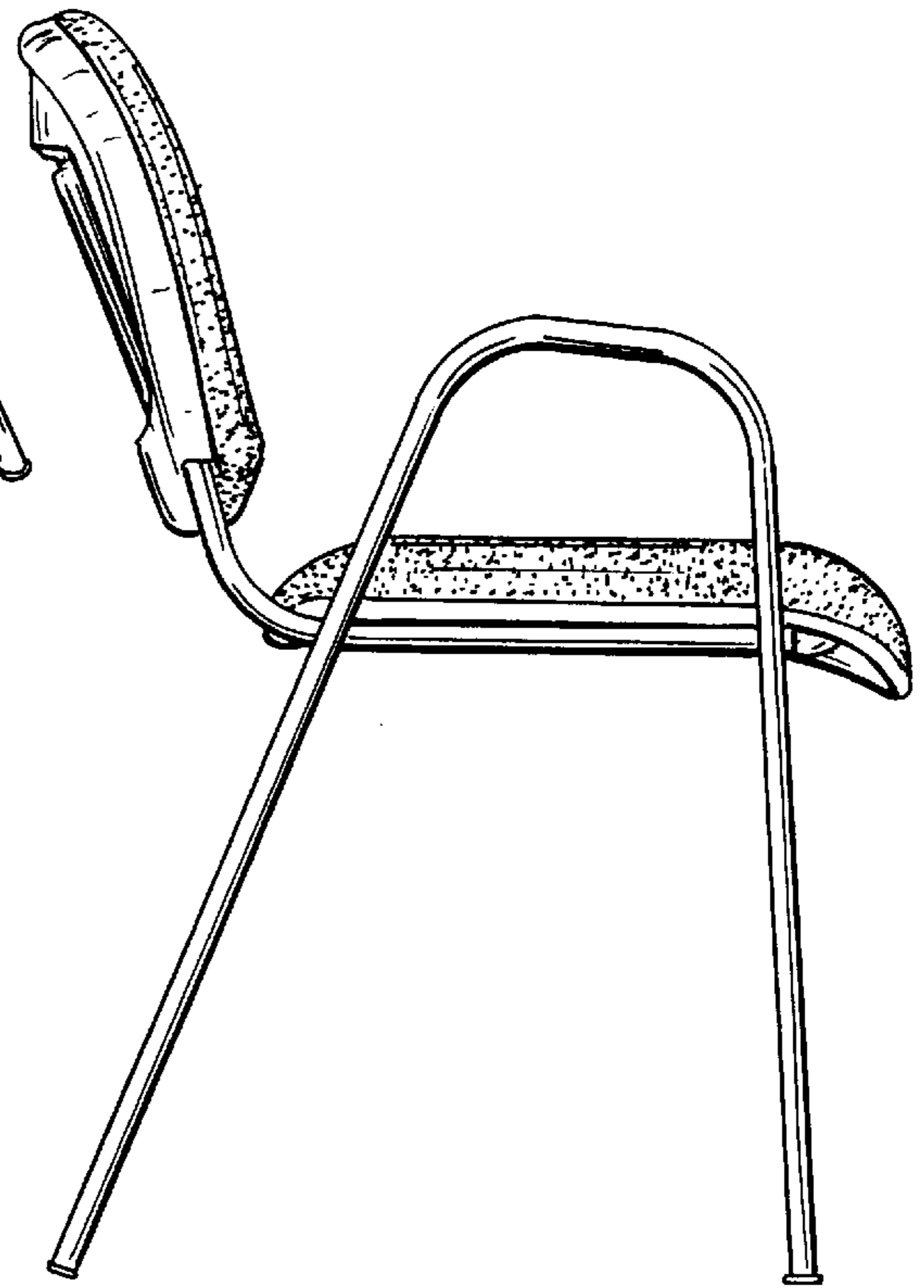

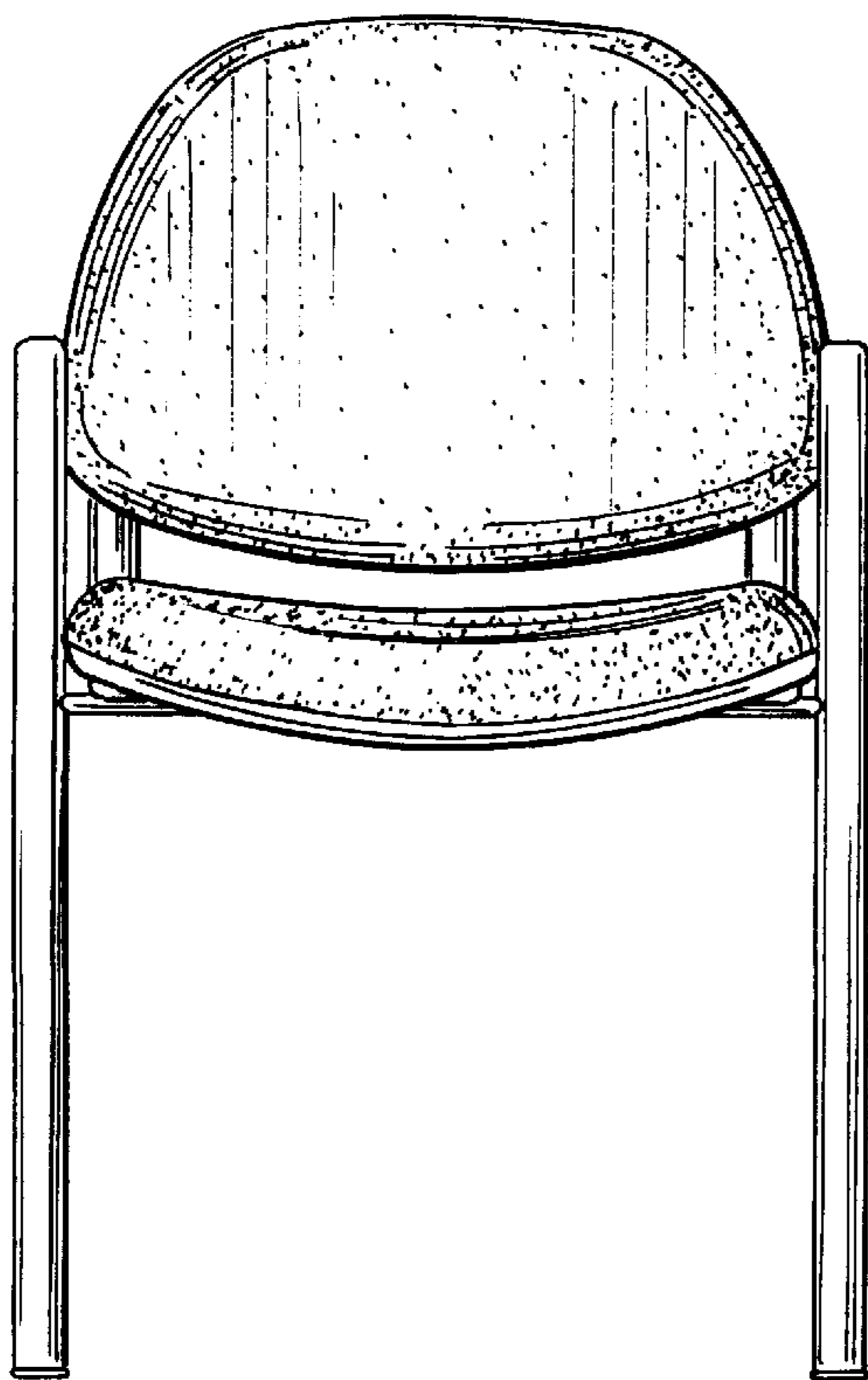

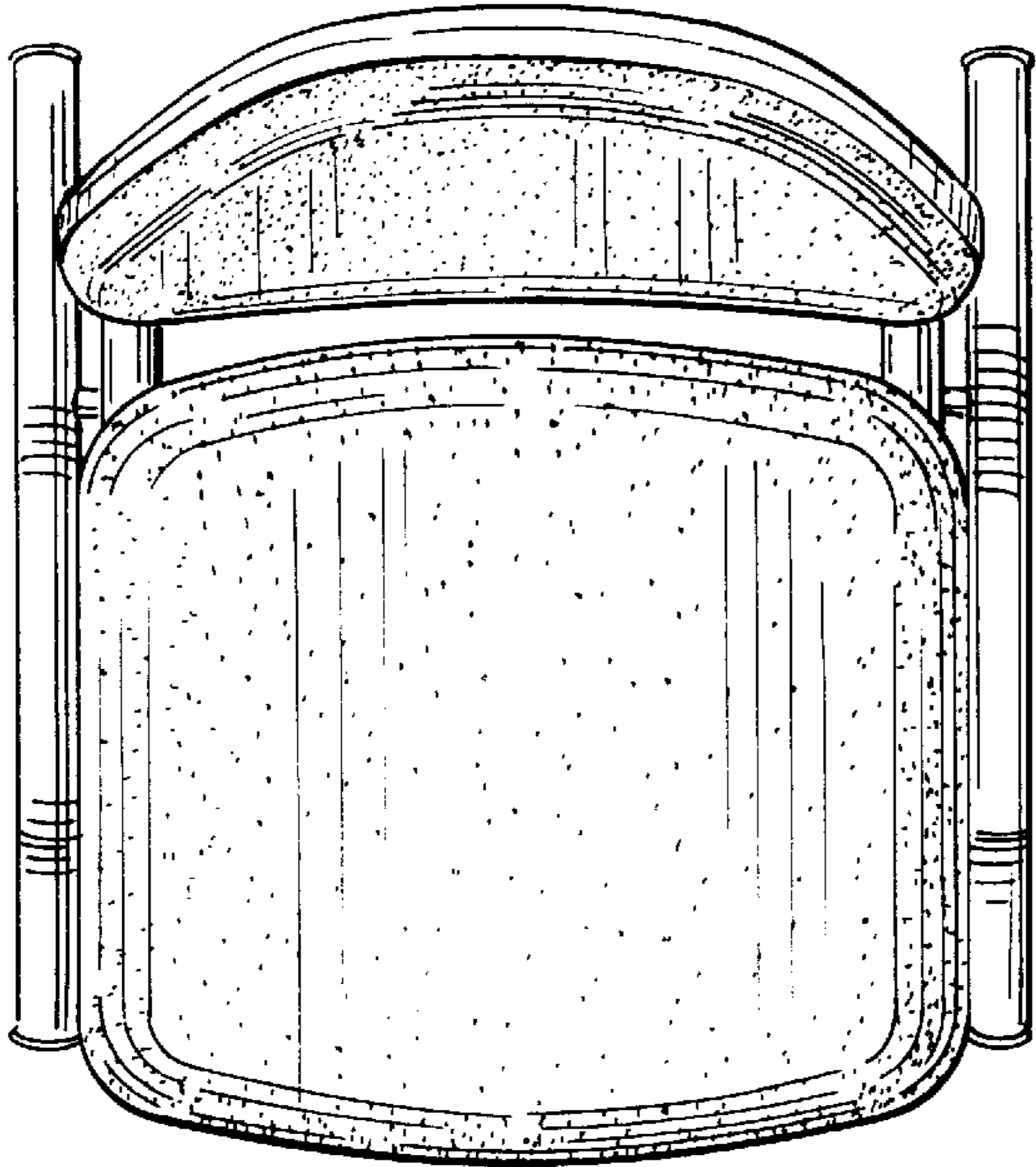

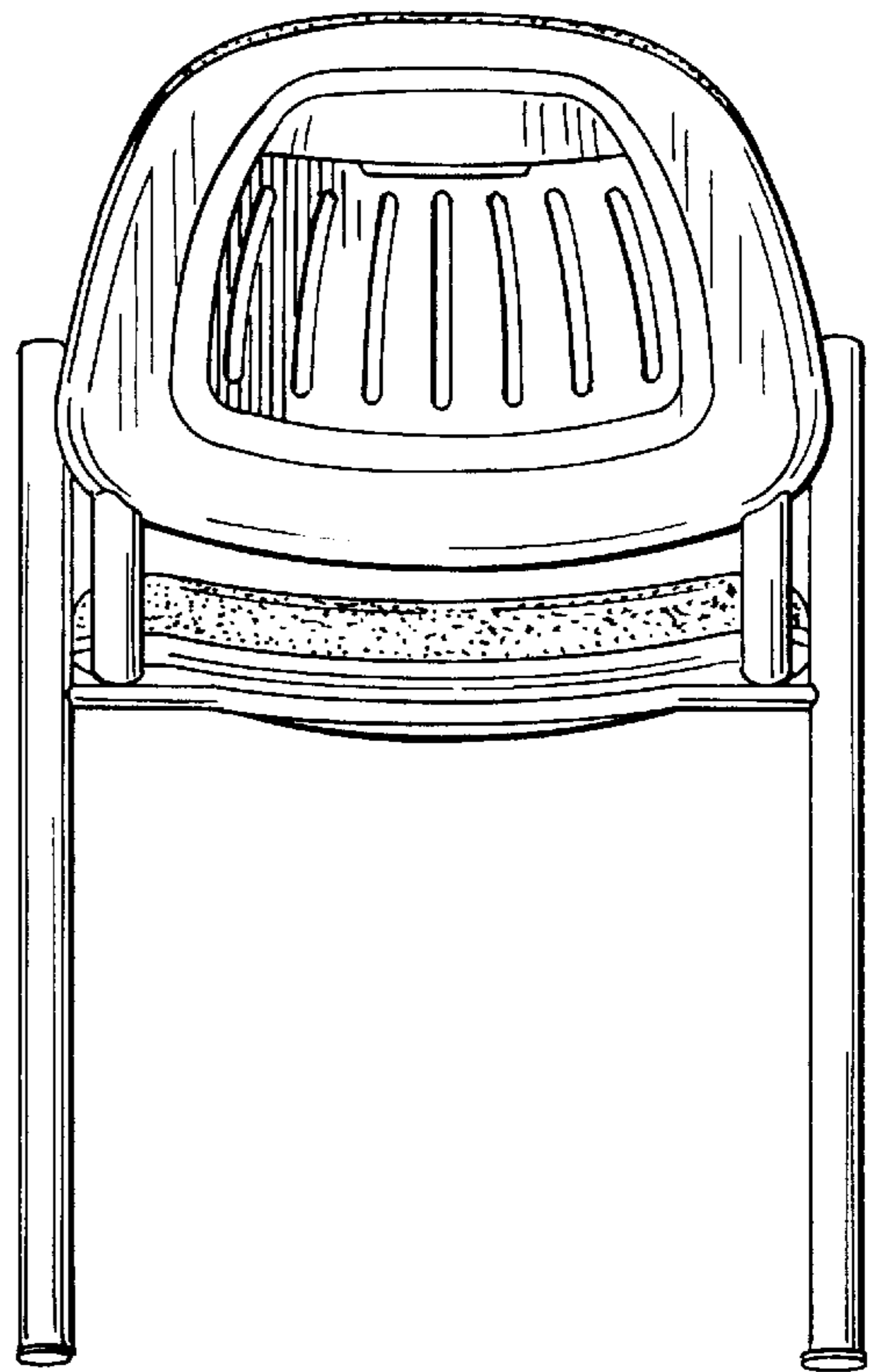

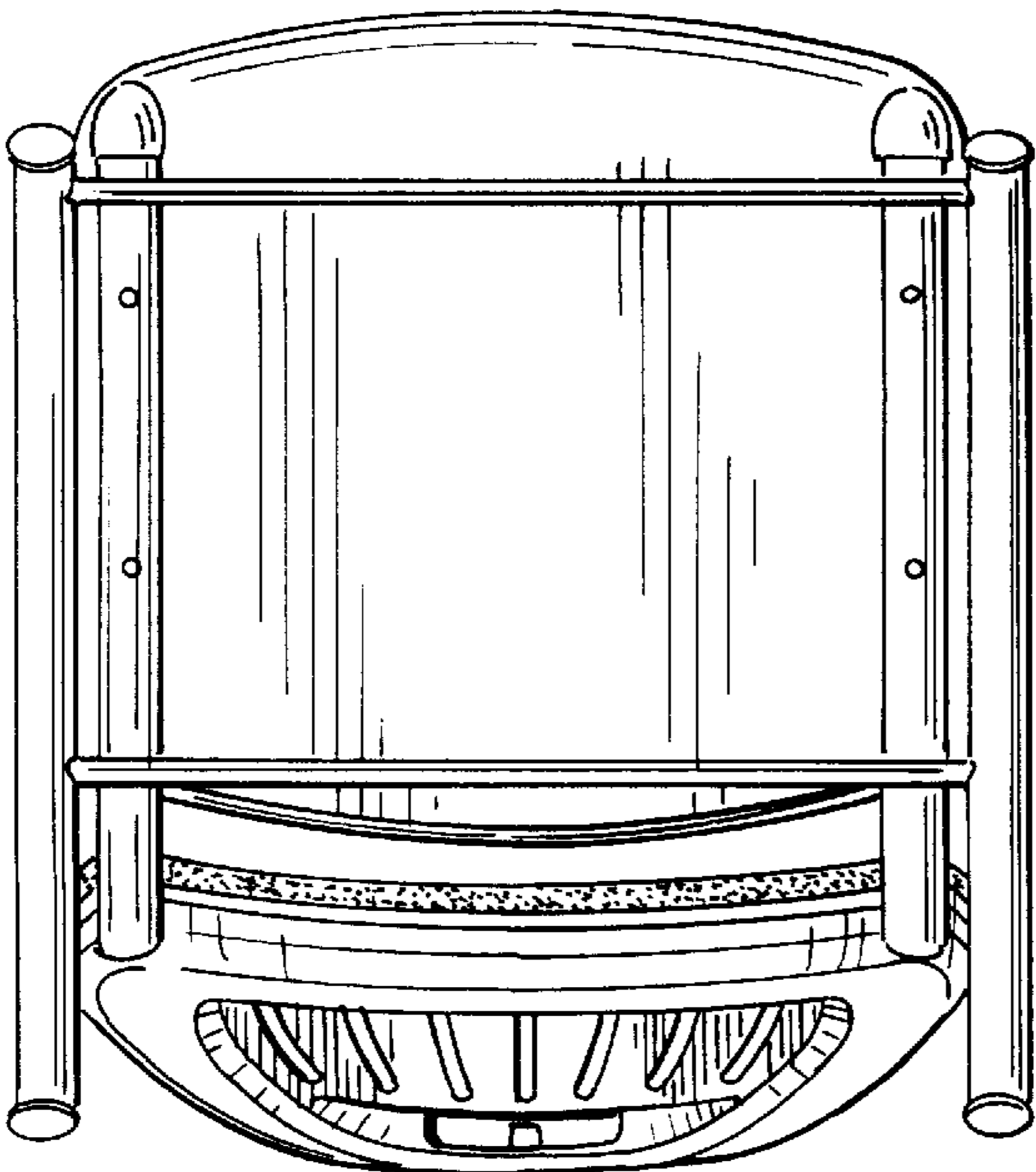
