The ornamental design for a back cover for a seating unit, as shown and described.

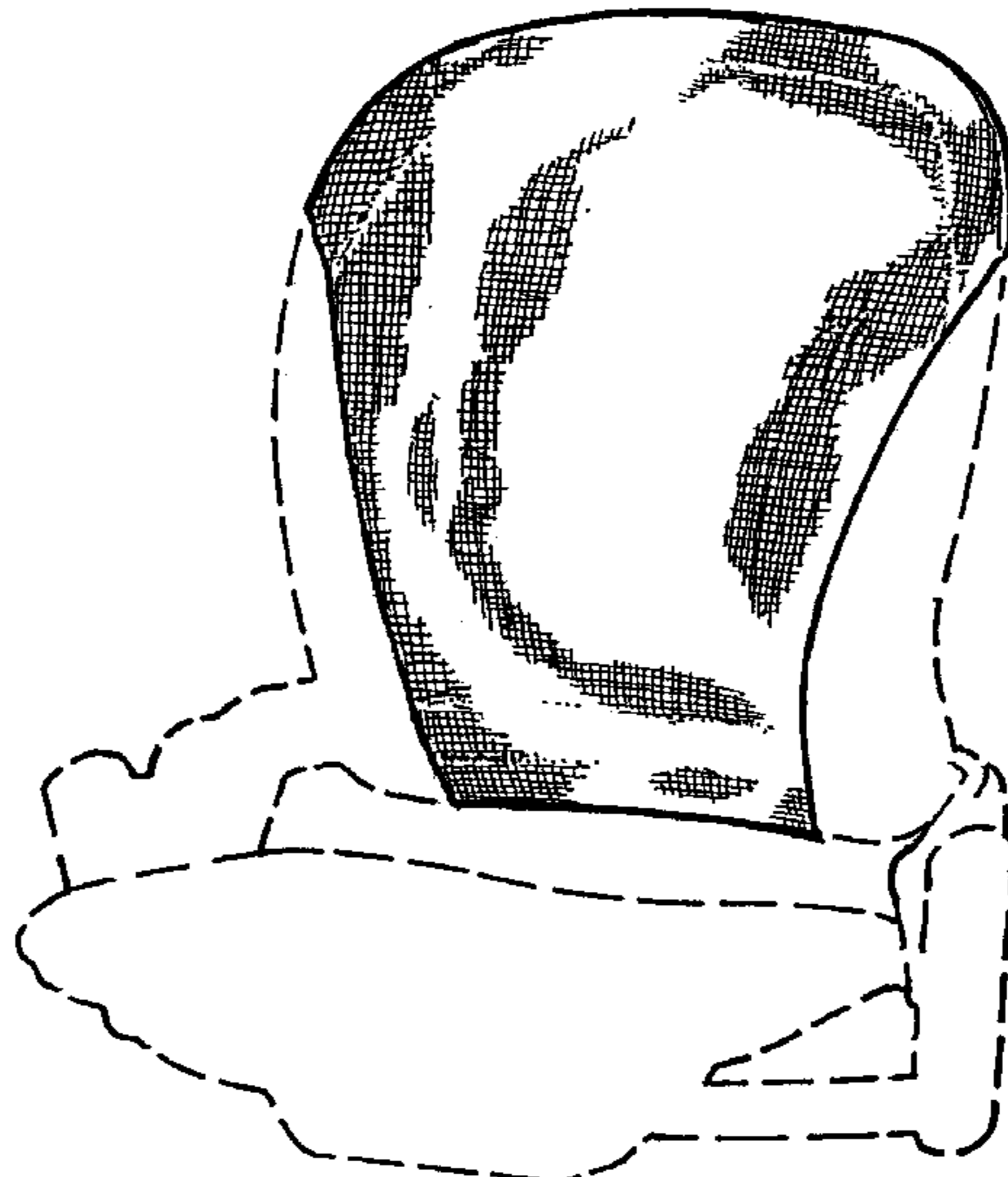
**DESCRIPTION**

FIG. 1 is a front perspective view of a back cover for a seating unit embodying the present invention; FIG. 2 is a rear perspective view thereof; FIG. 3 is a right side view thereof, the left side being a mirror image thereof; FIG. 4 is a front view thereof; FIG. 5 is rear view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The dashed lines show environmental structure and do not form a part of the design sought to be patented.

The fragmented cross-hatching shown in the drawings is understood to represent fabric and would be continuous throughout the circumscribed areas.

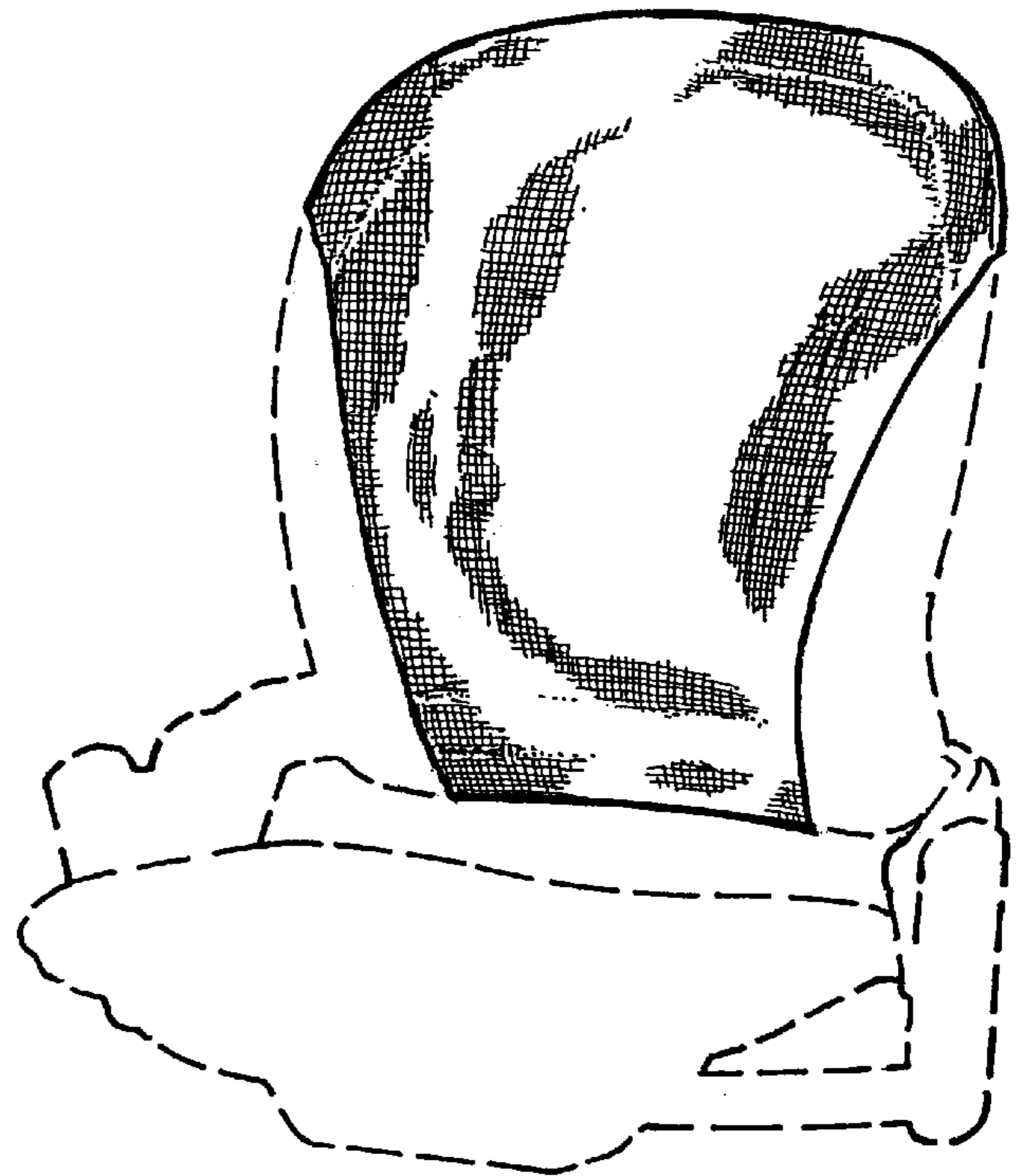

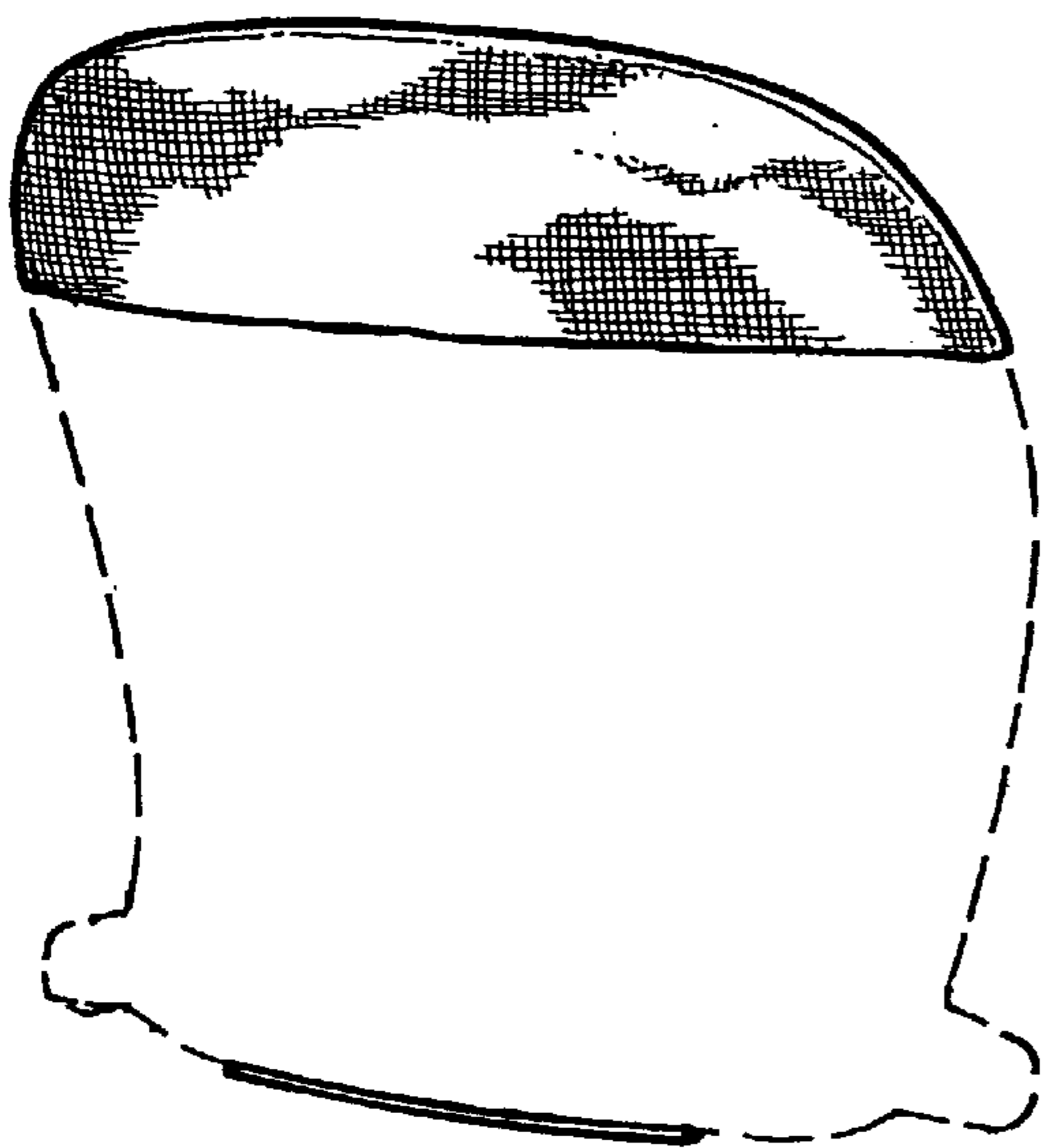

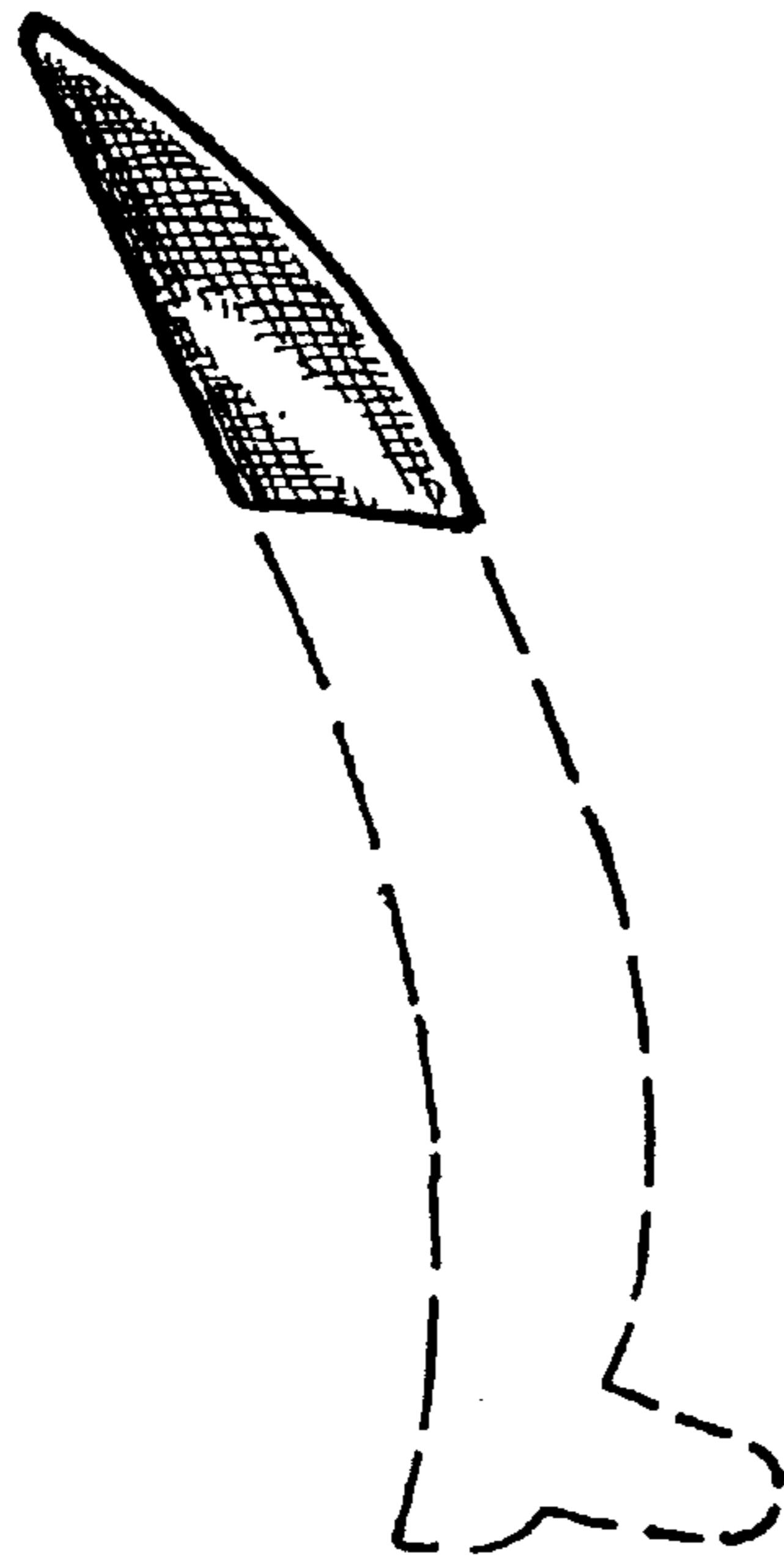

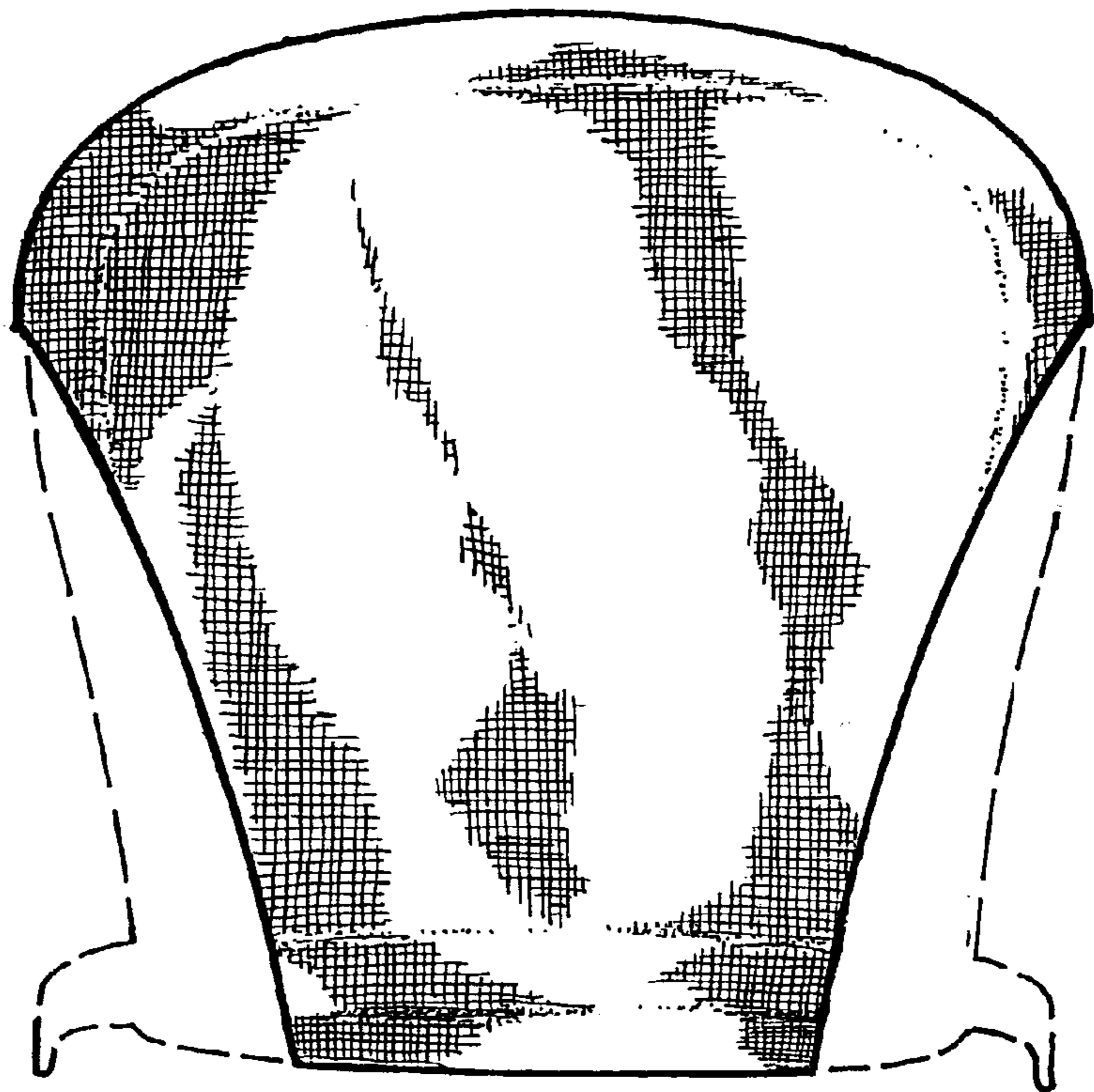

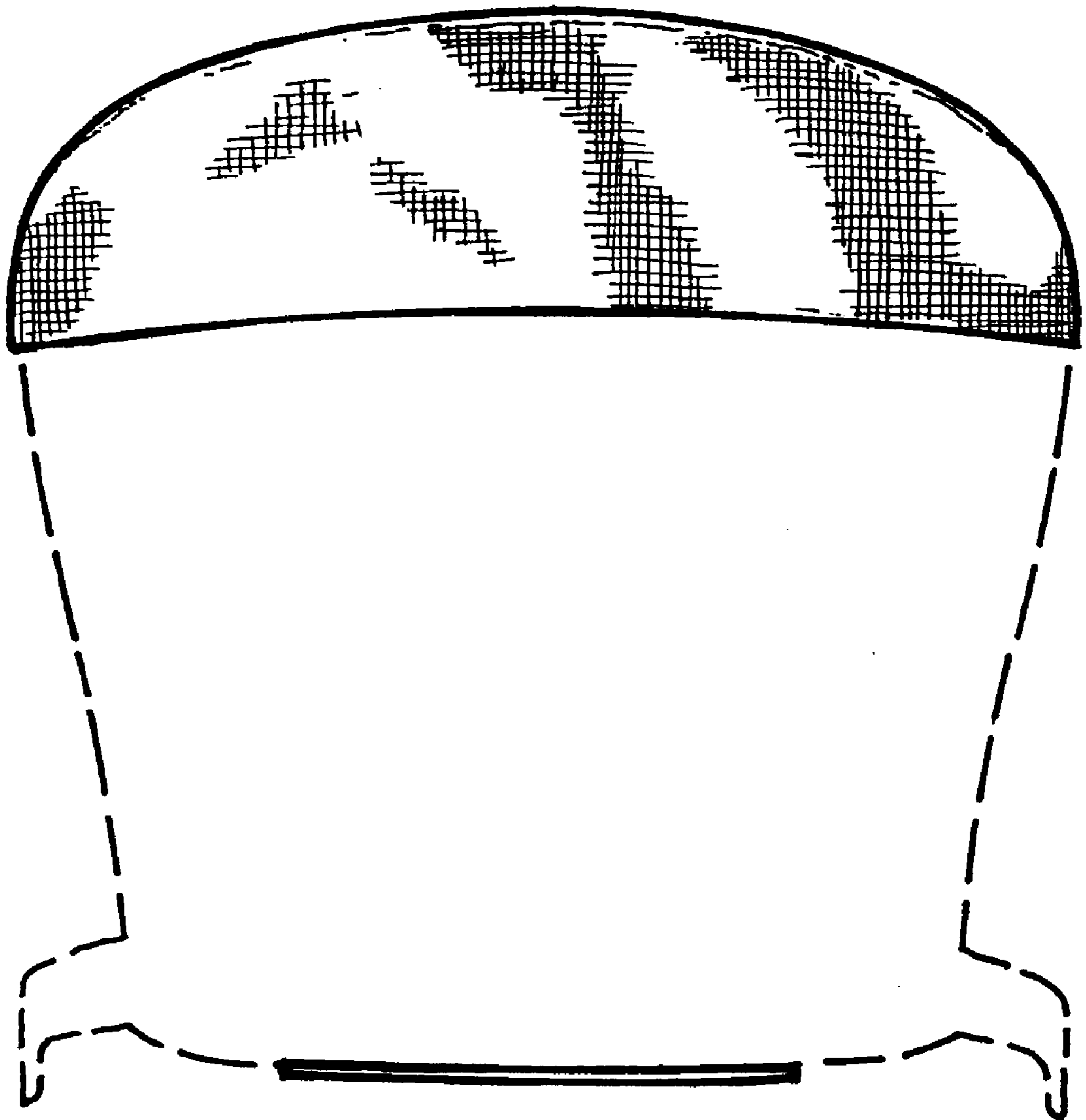

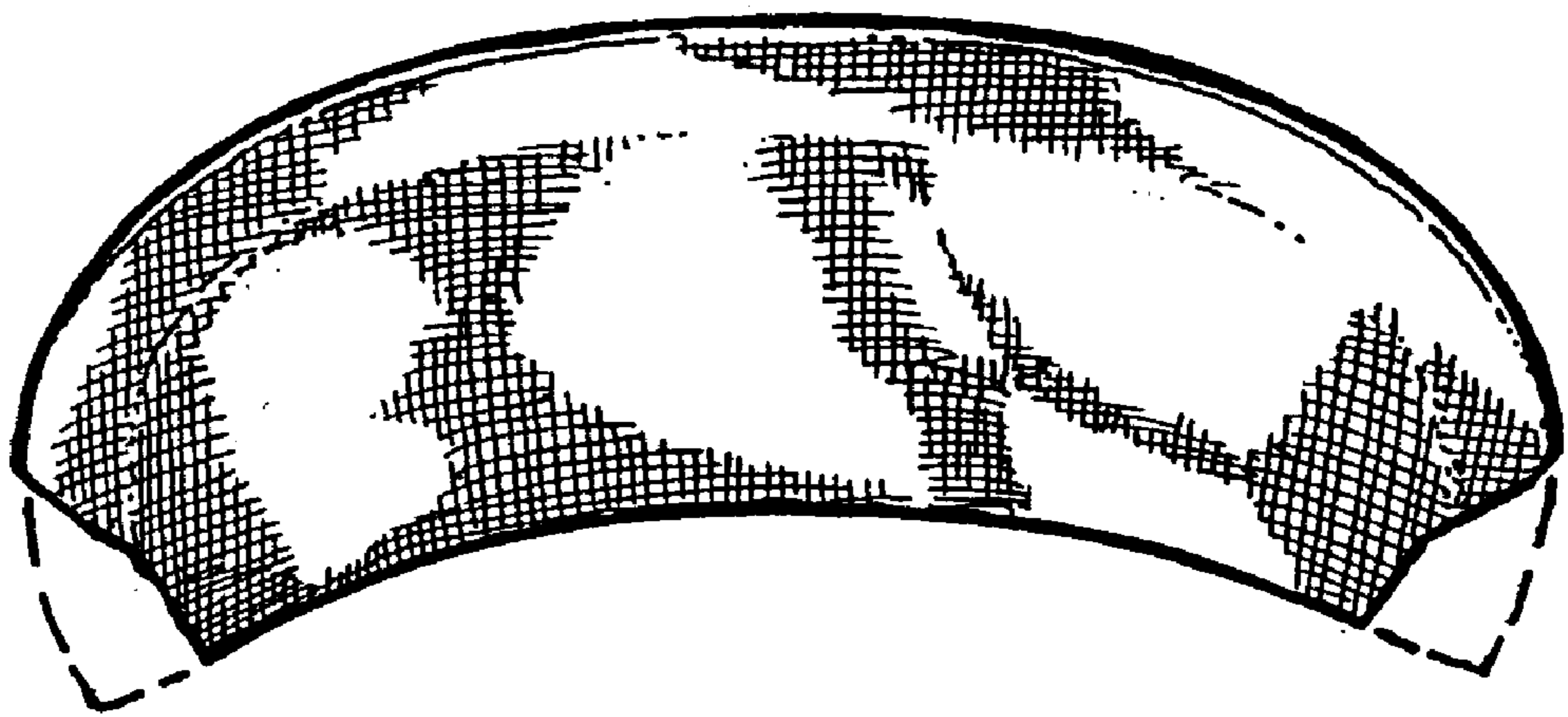

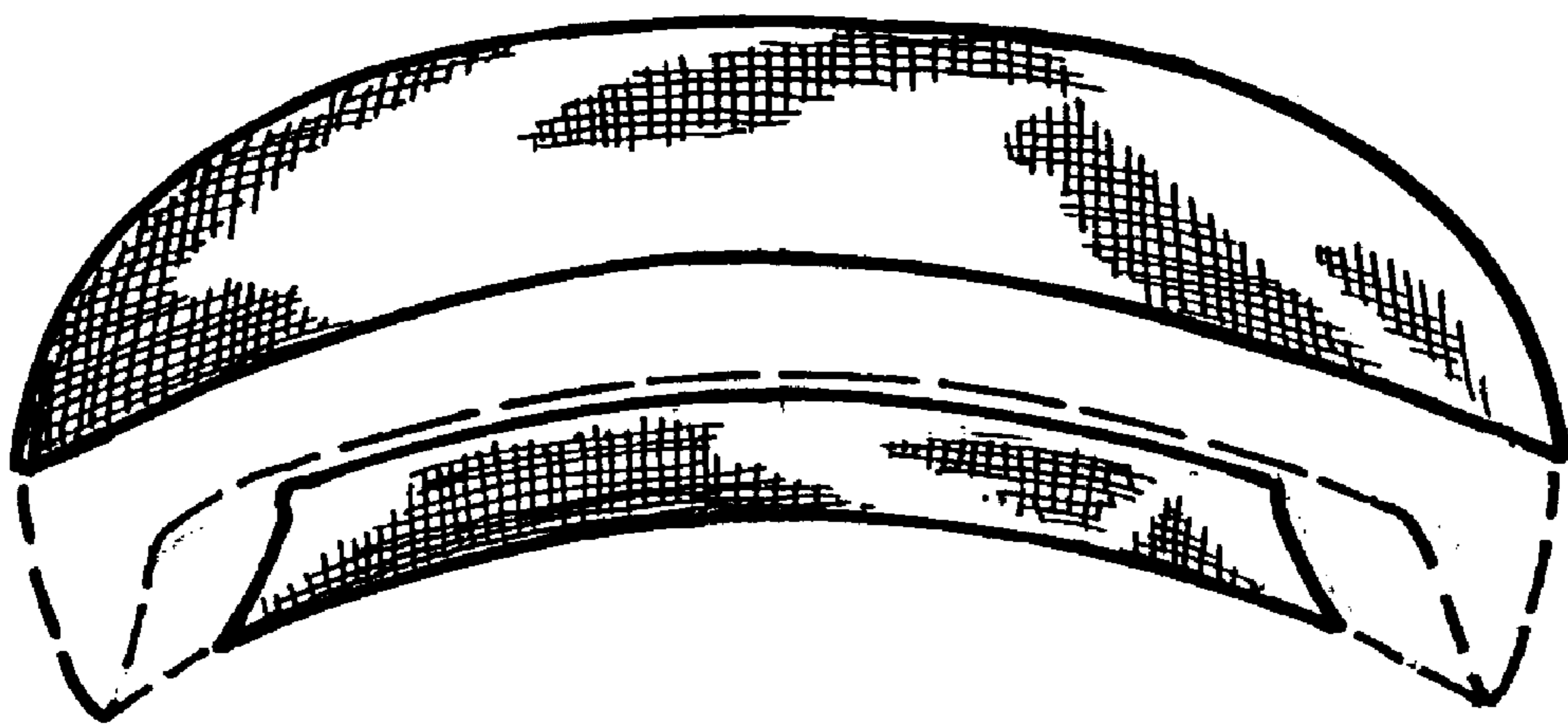
