FIG. 3 is a side elevation view of the embodiment of FIG. 1.

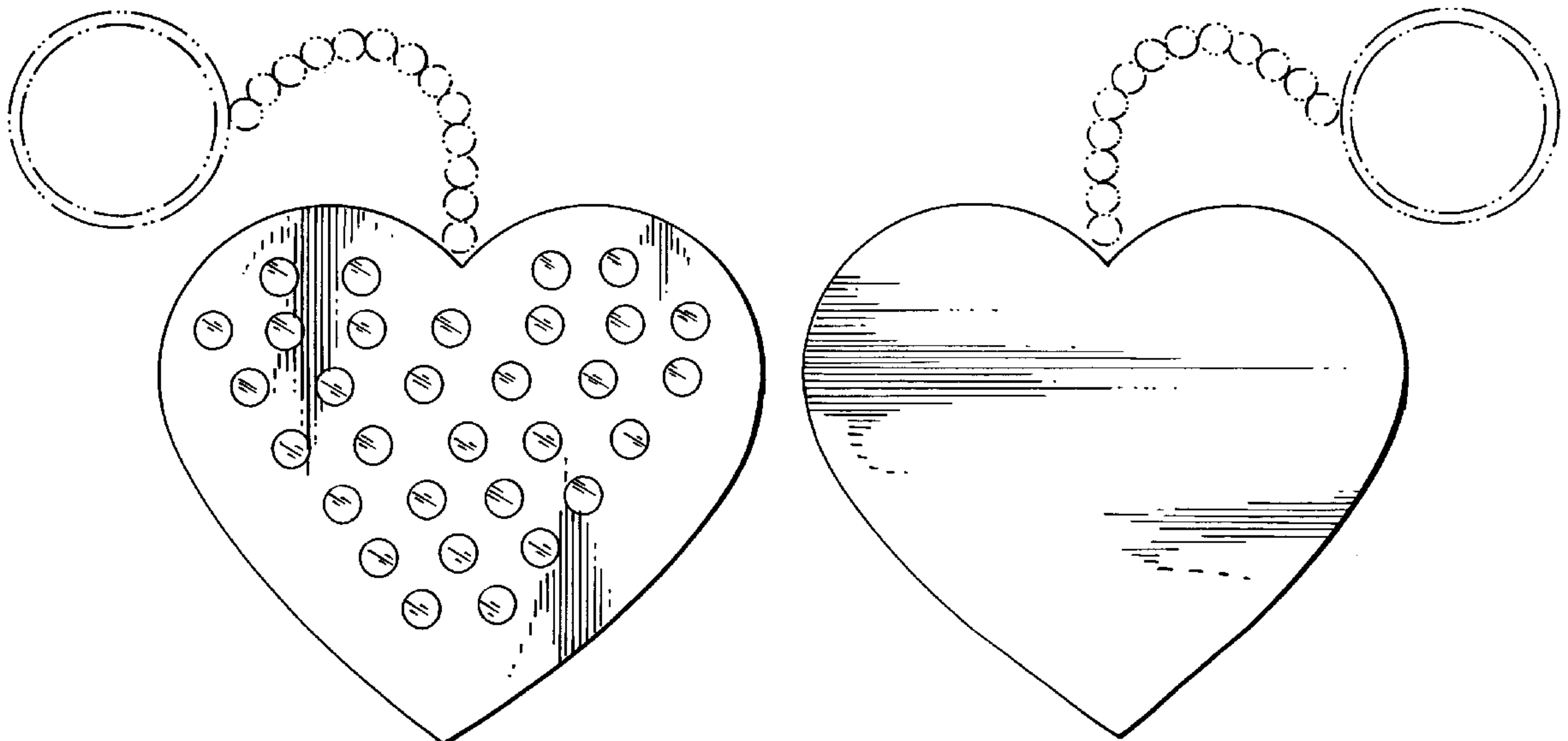
The broken line showing of the chain and ring support in FIGS. 1-3 is for illustrative purposes only and forms no part of the claimed design.

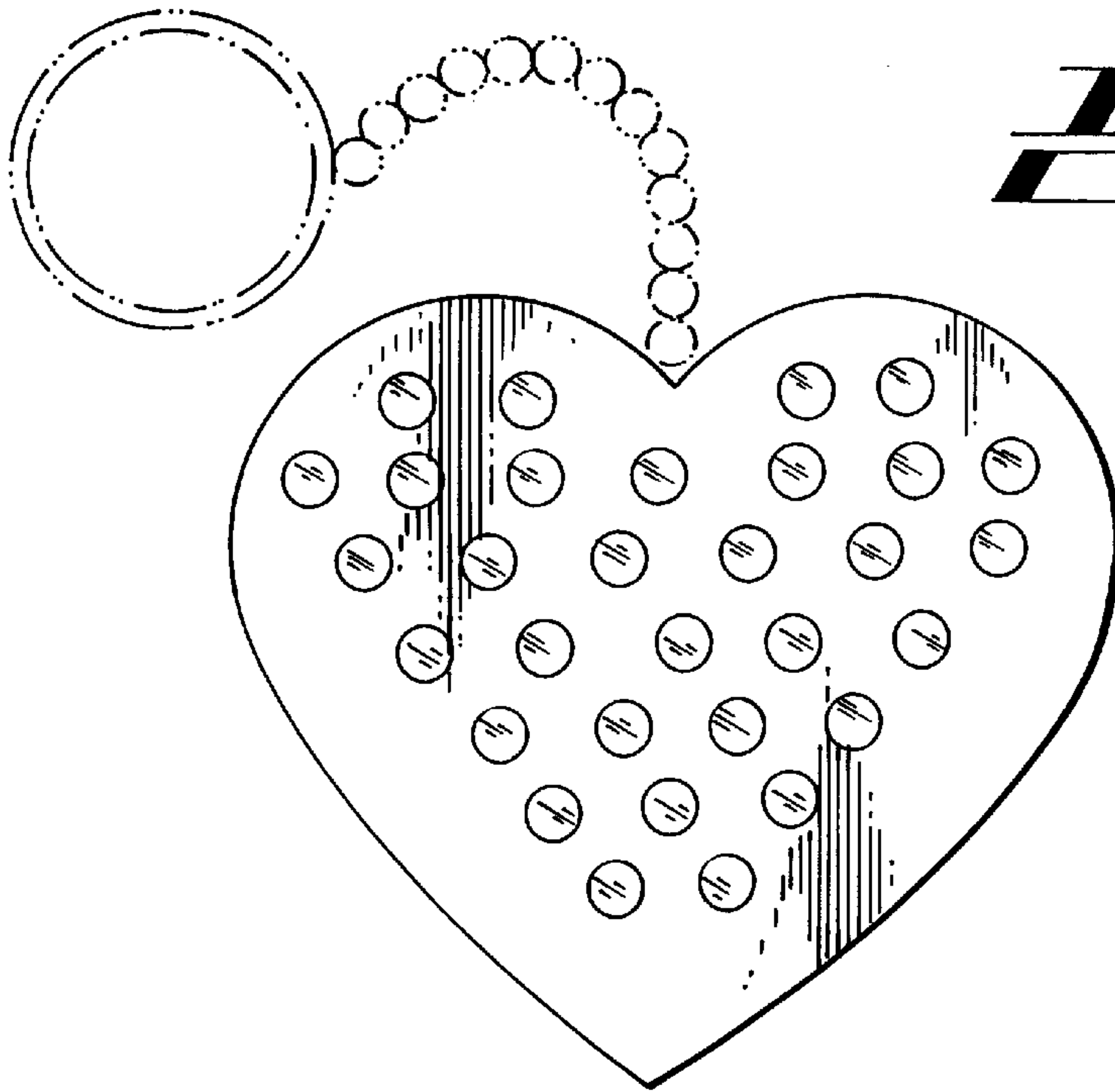

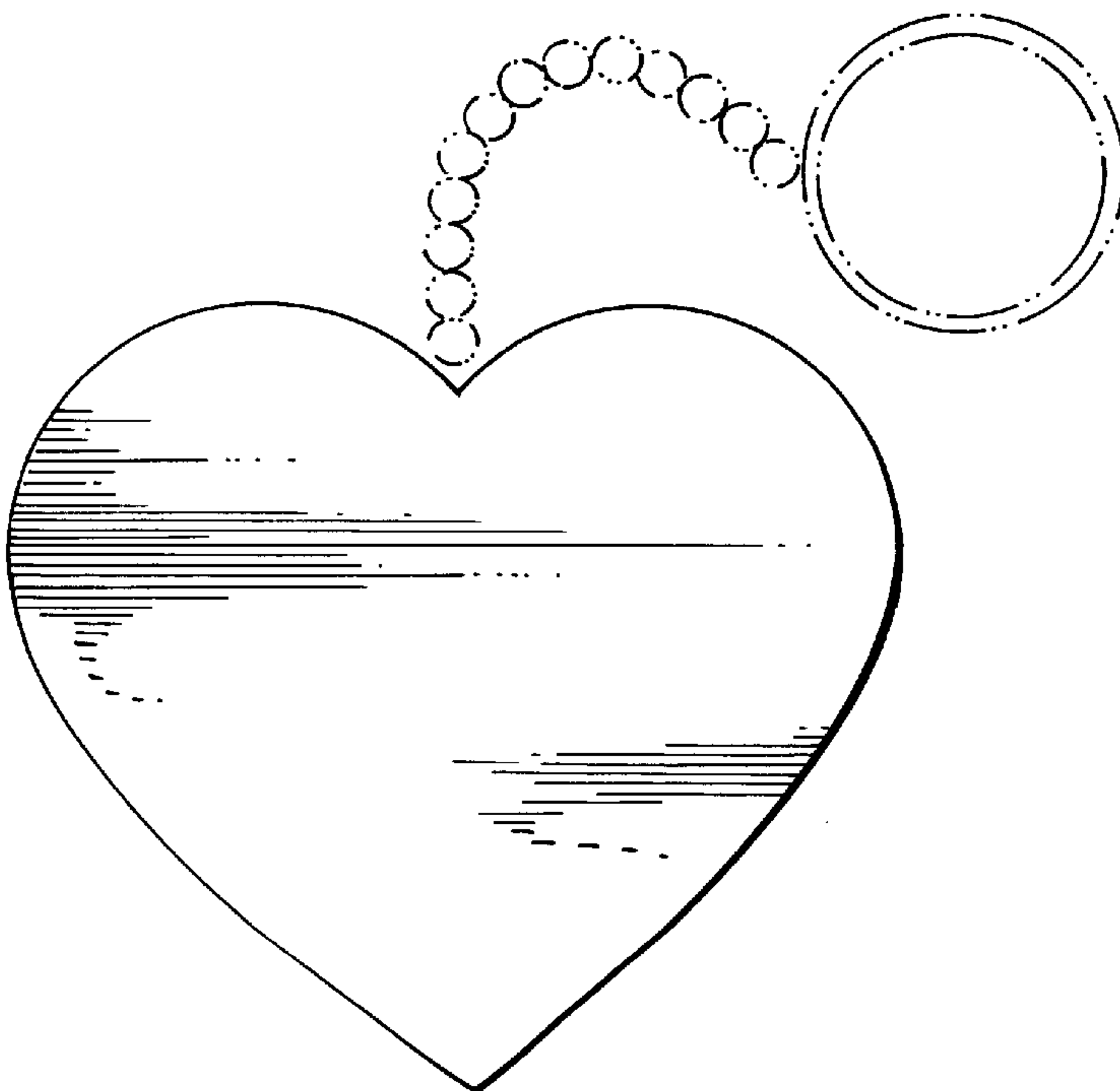
